FIG. 31 is an exploded side view thereof.

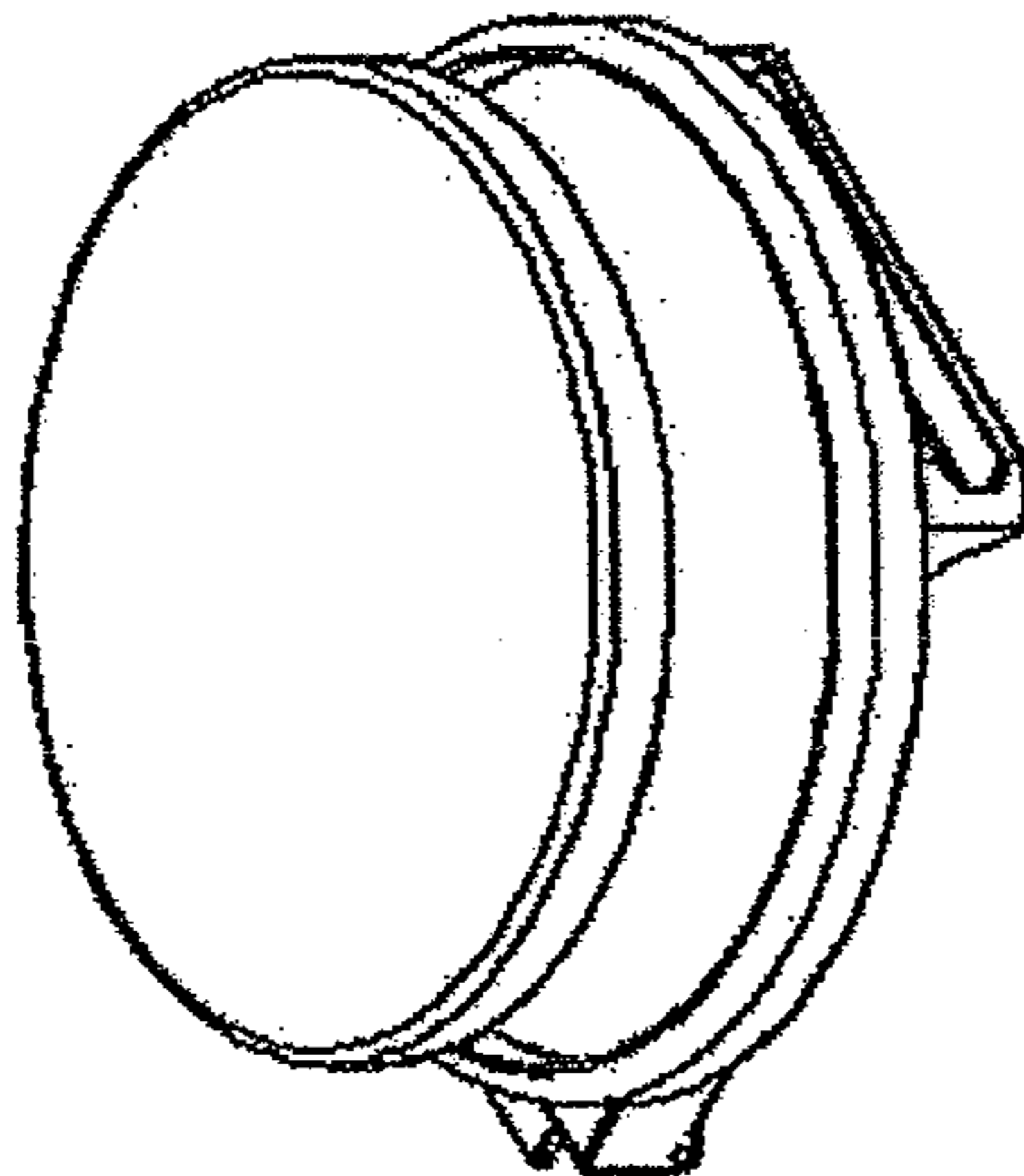
FIG. 32 is an exploded perspective top view thereof.

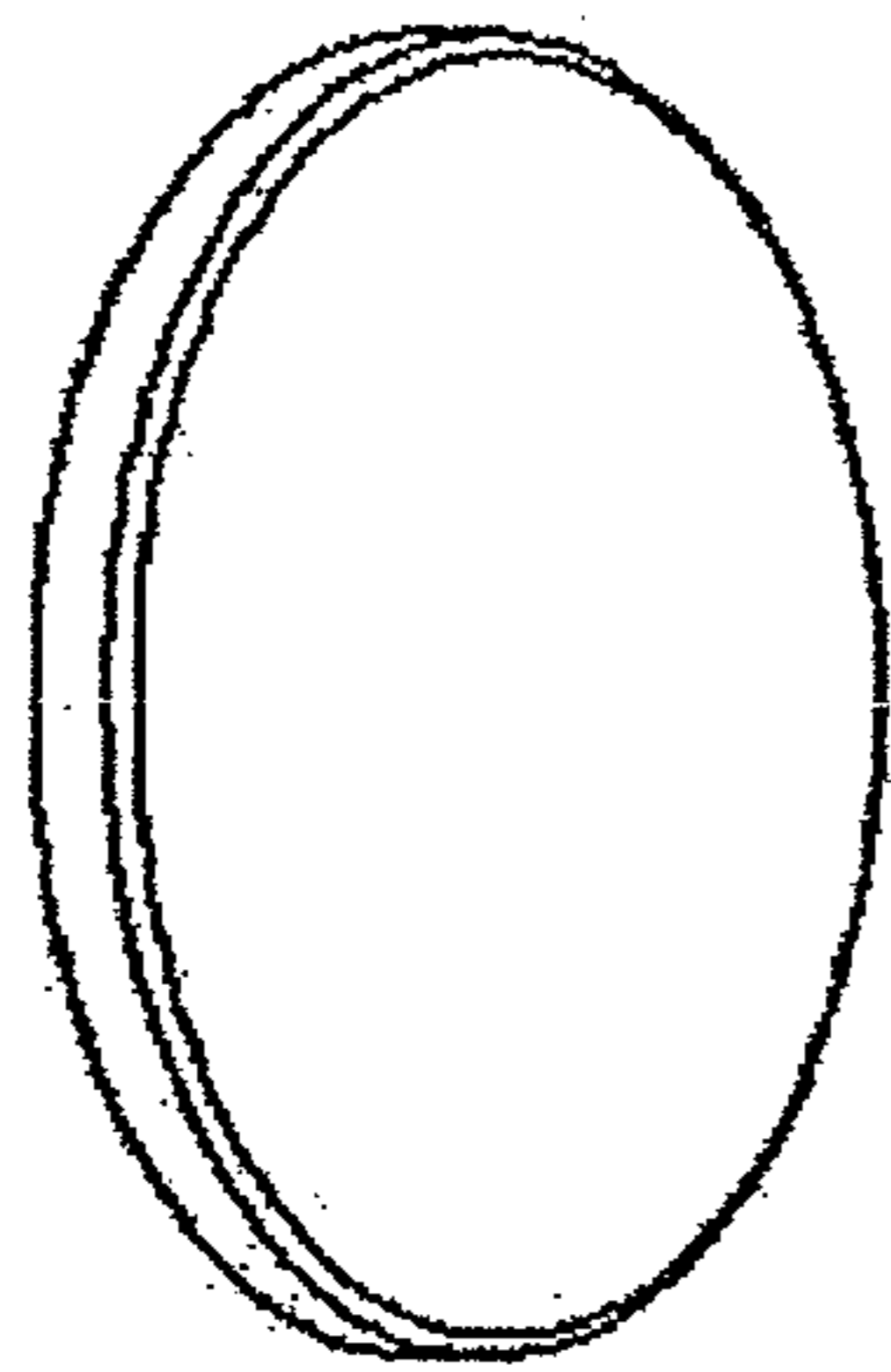

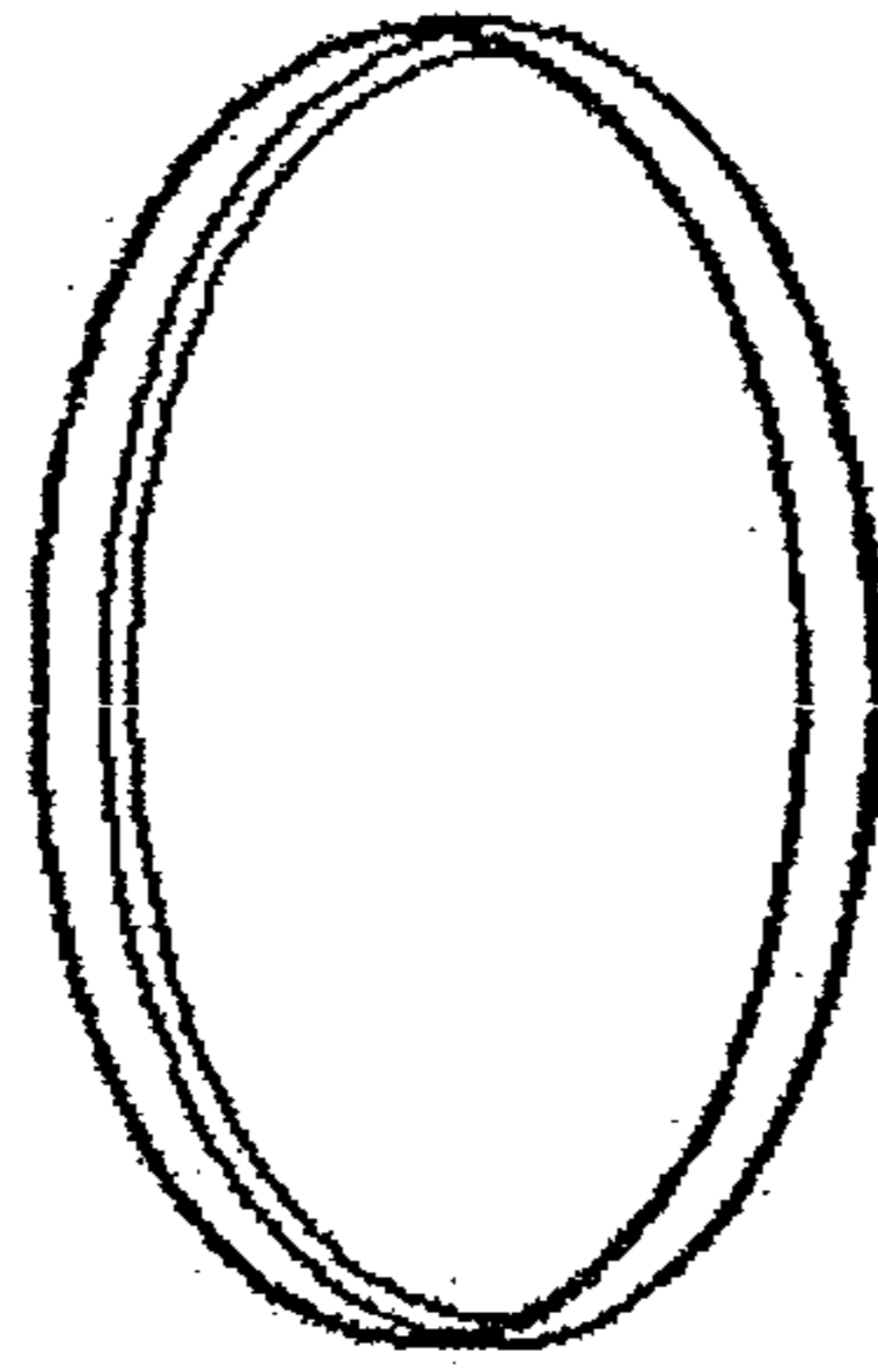

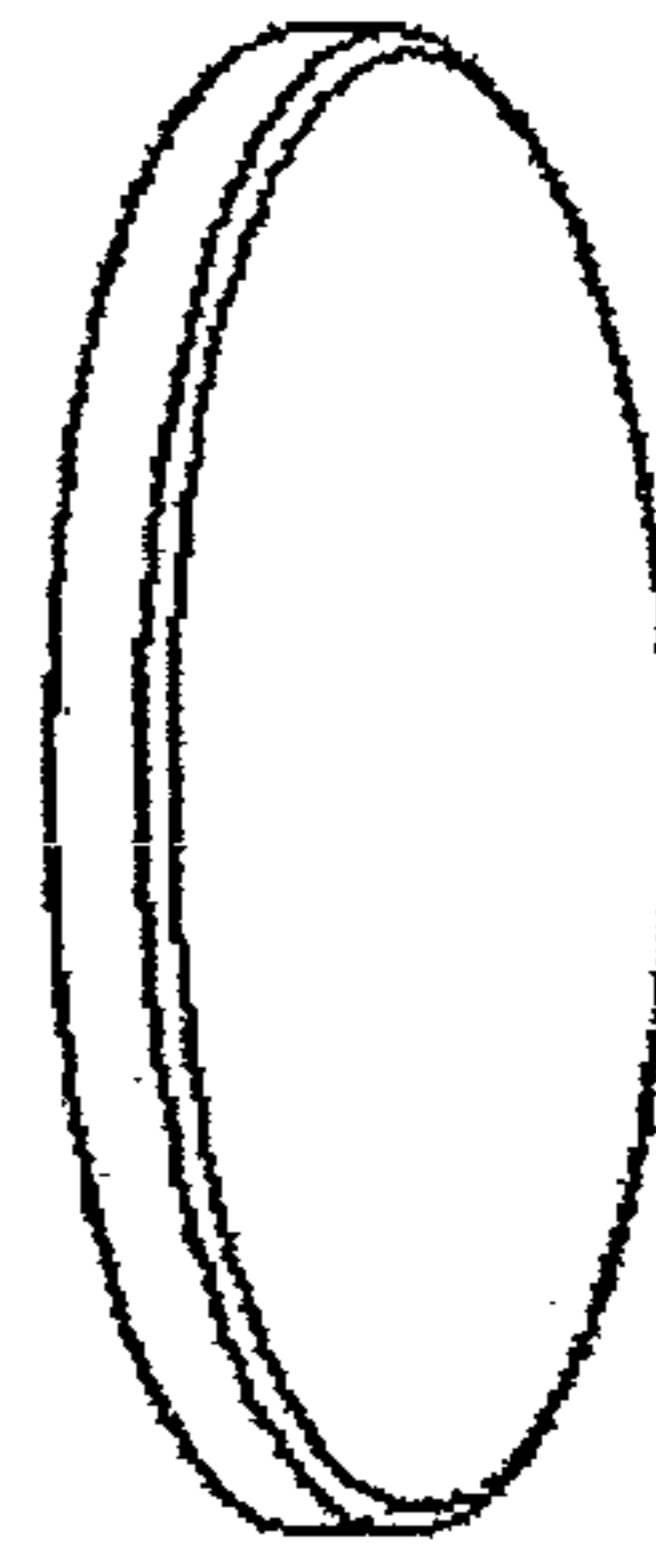

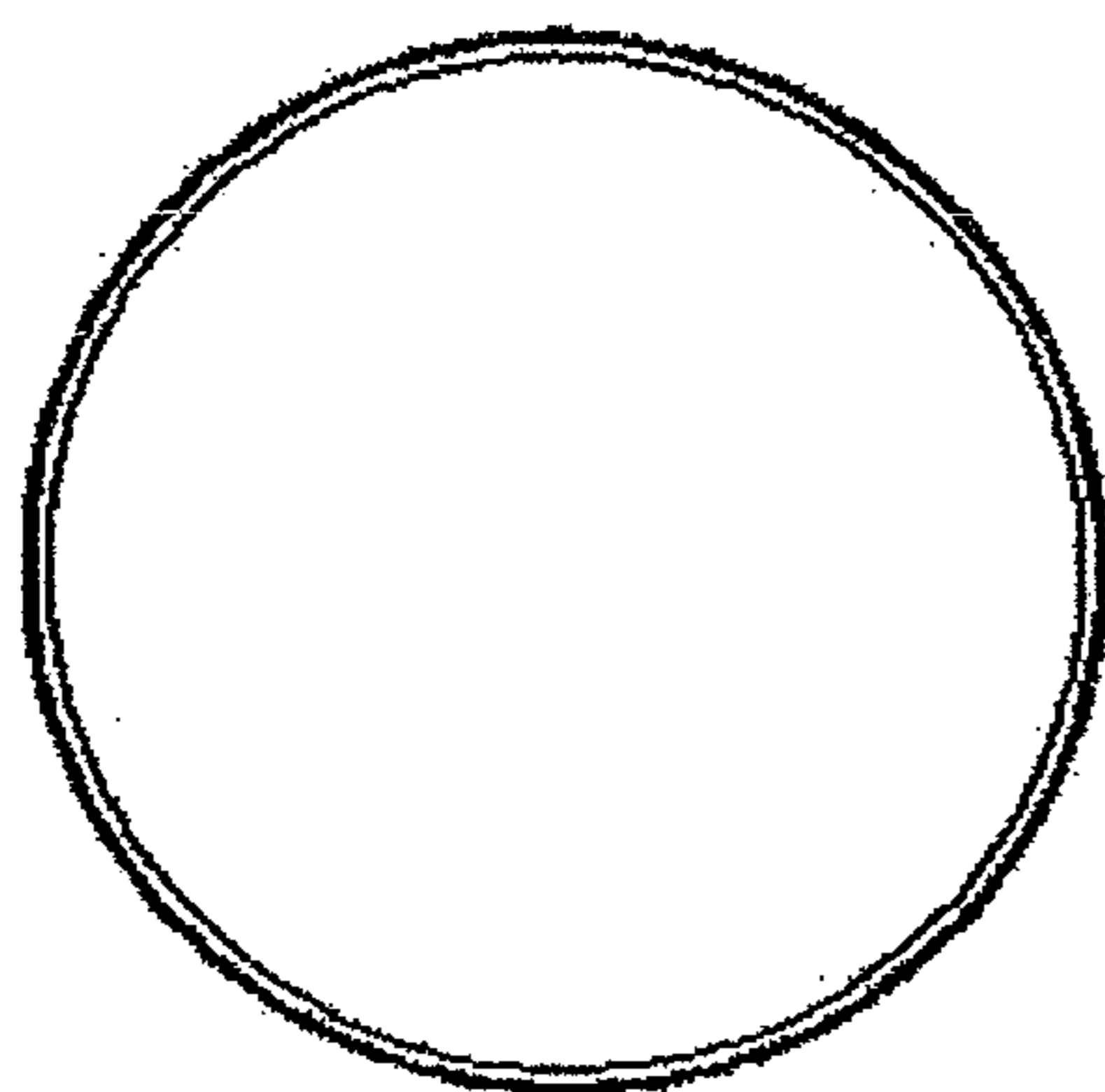

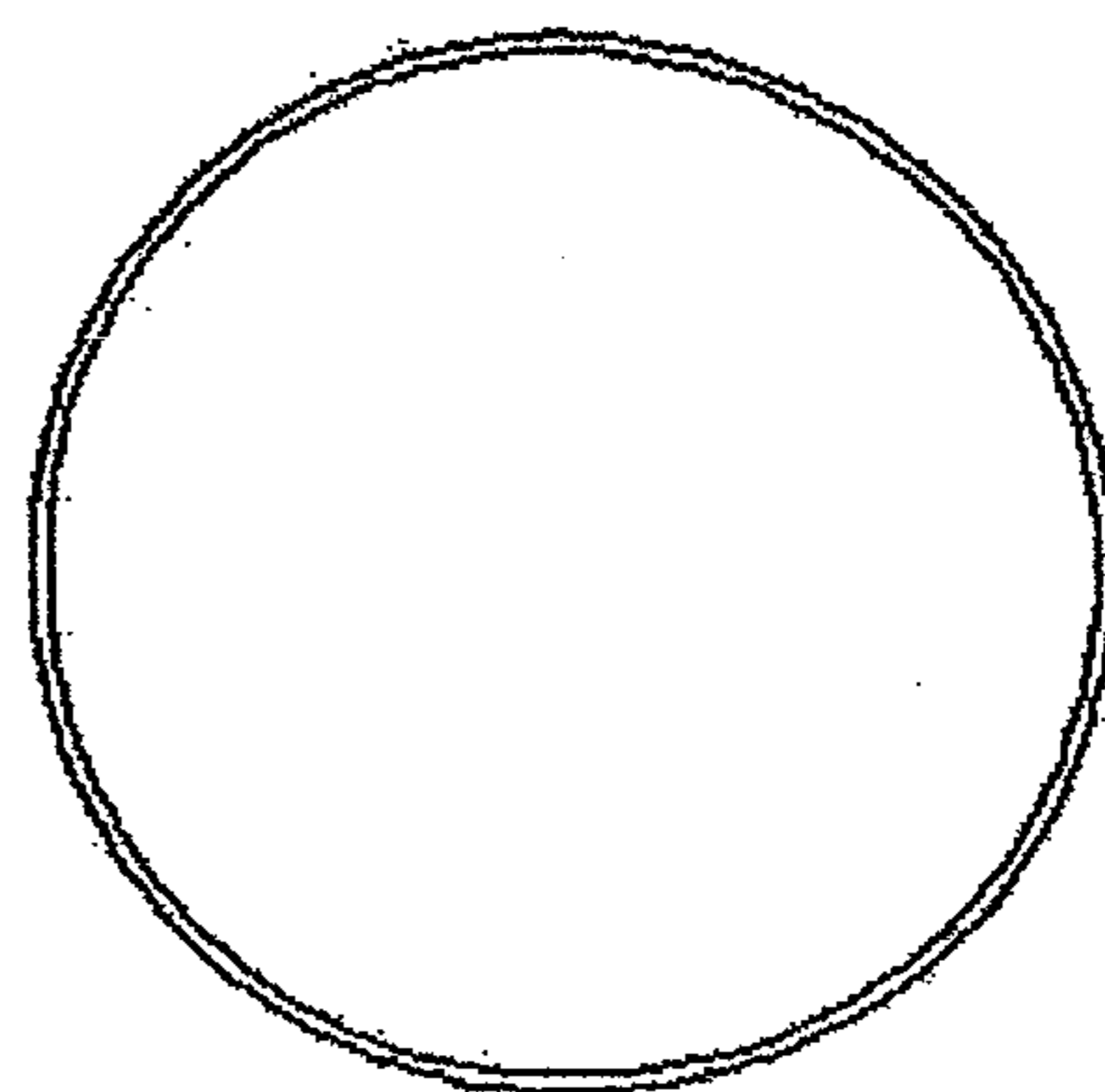

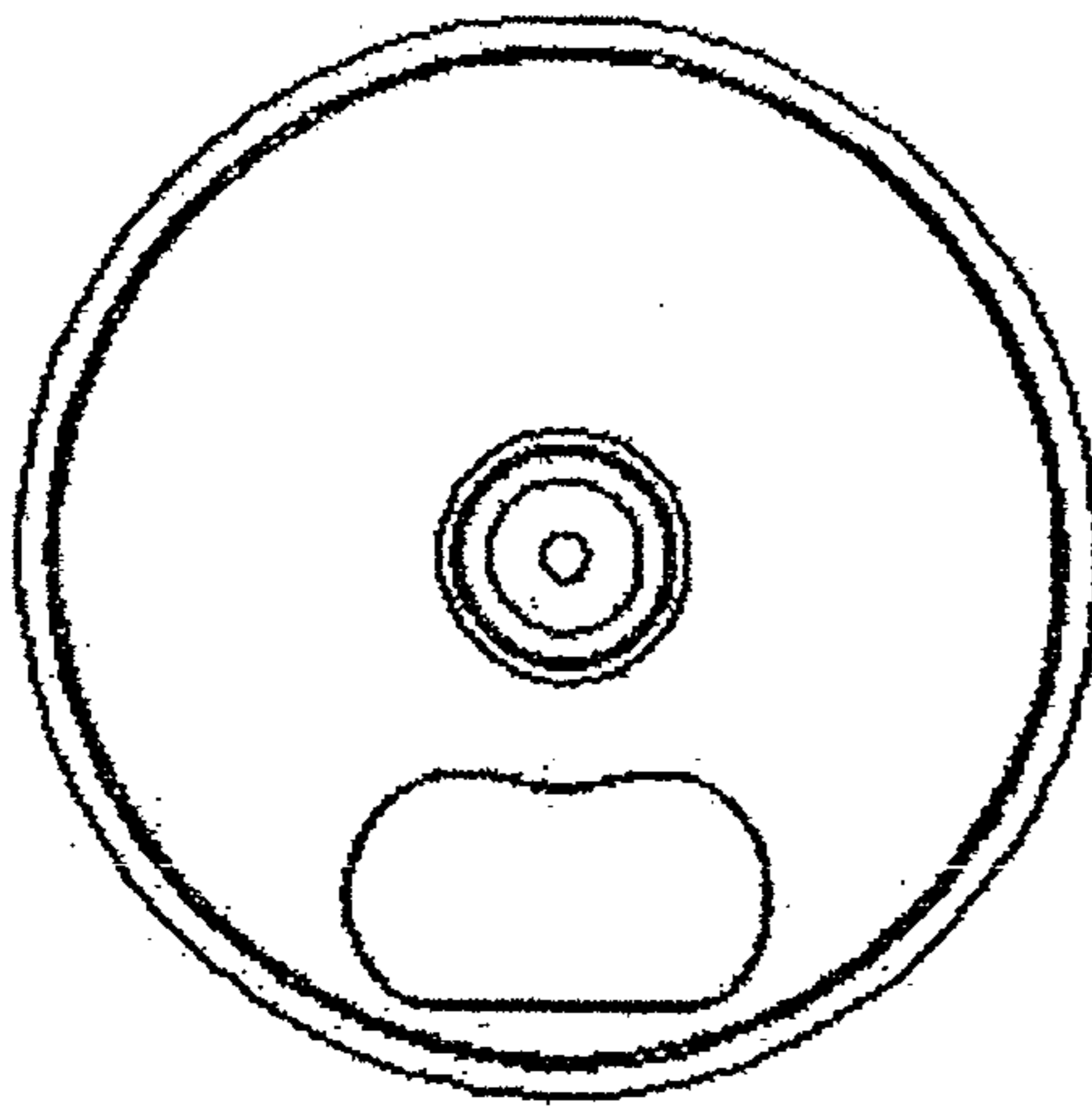

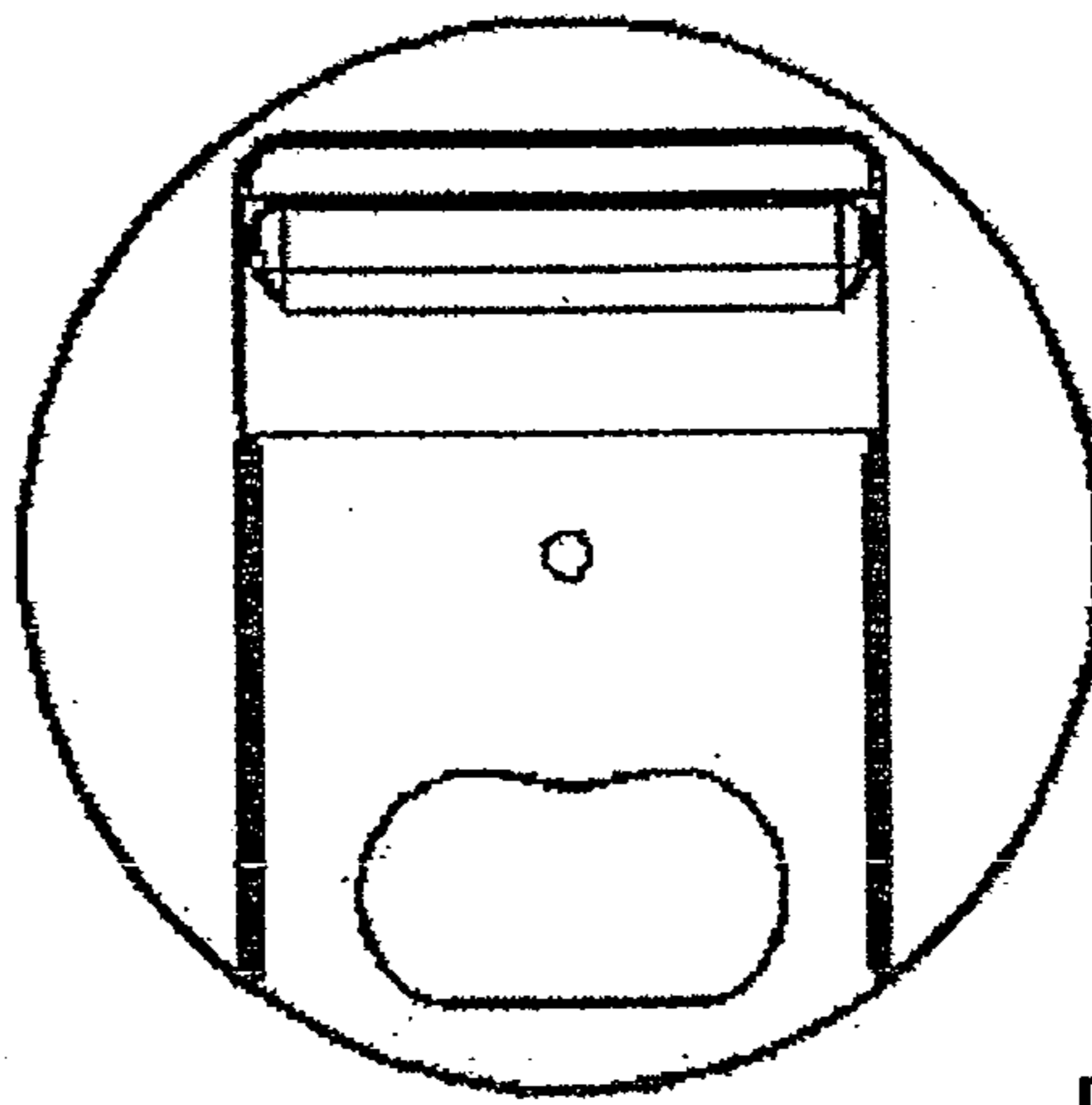

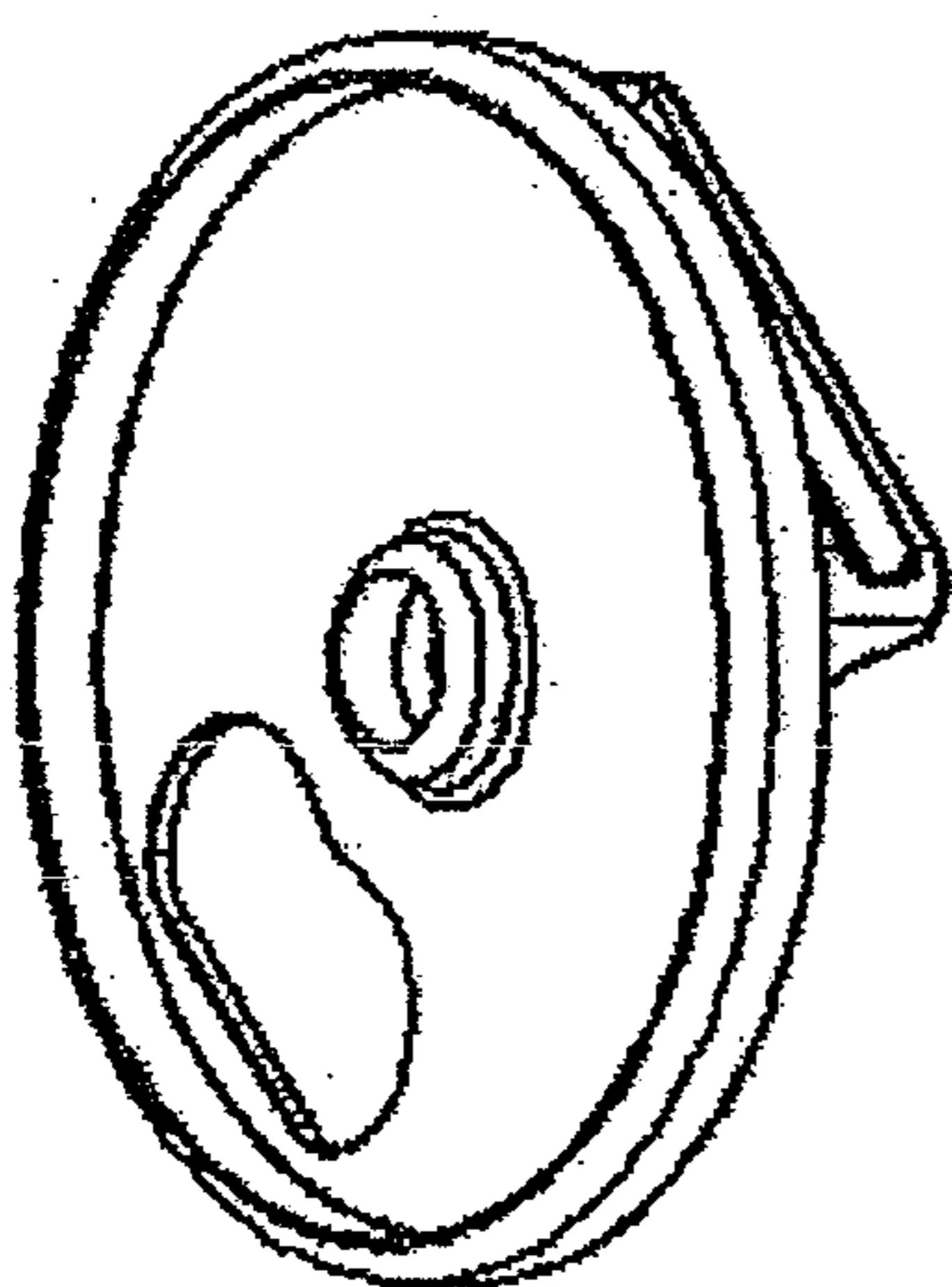

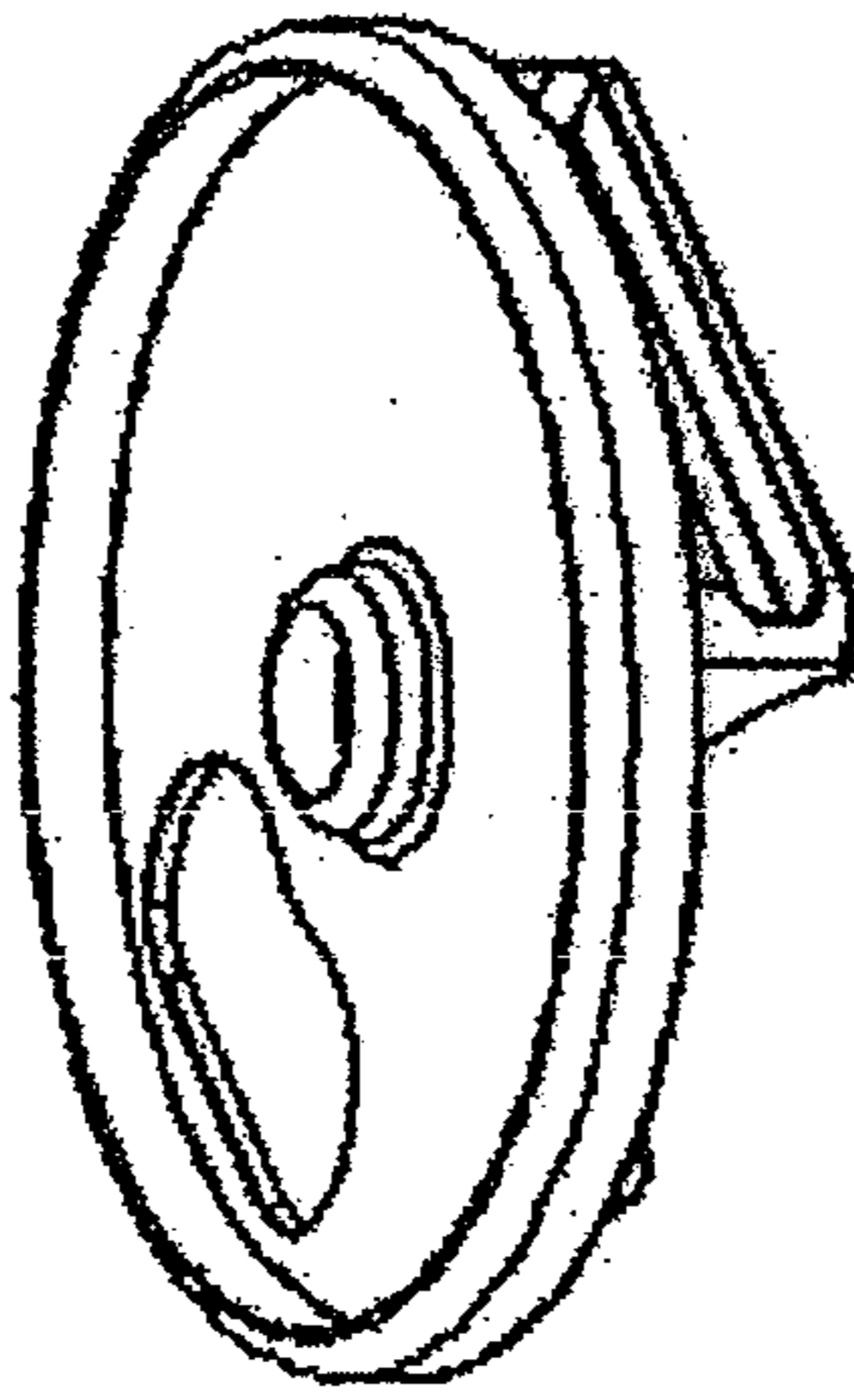

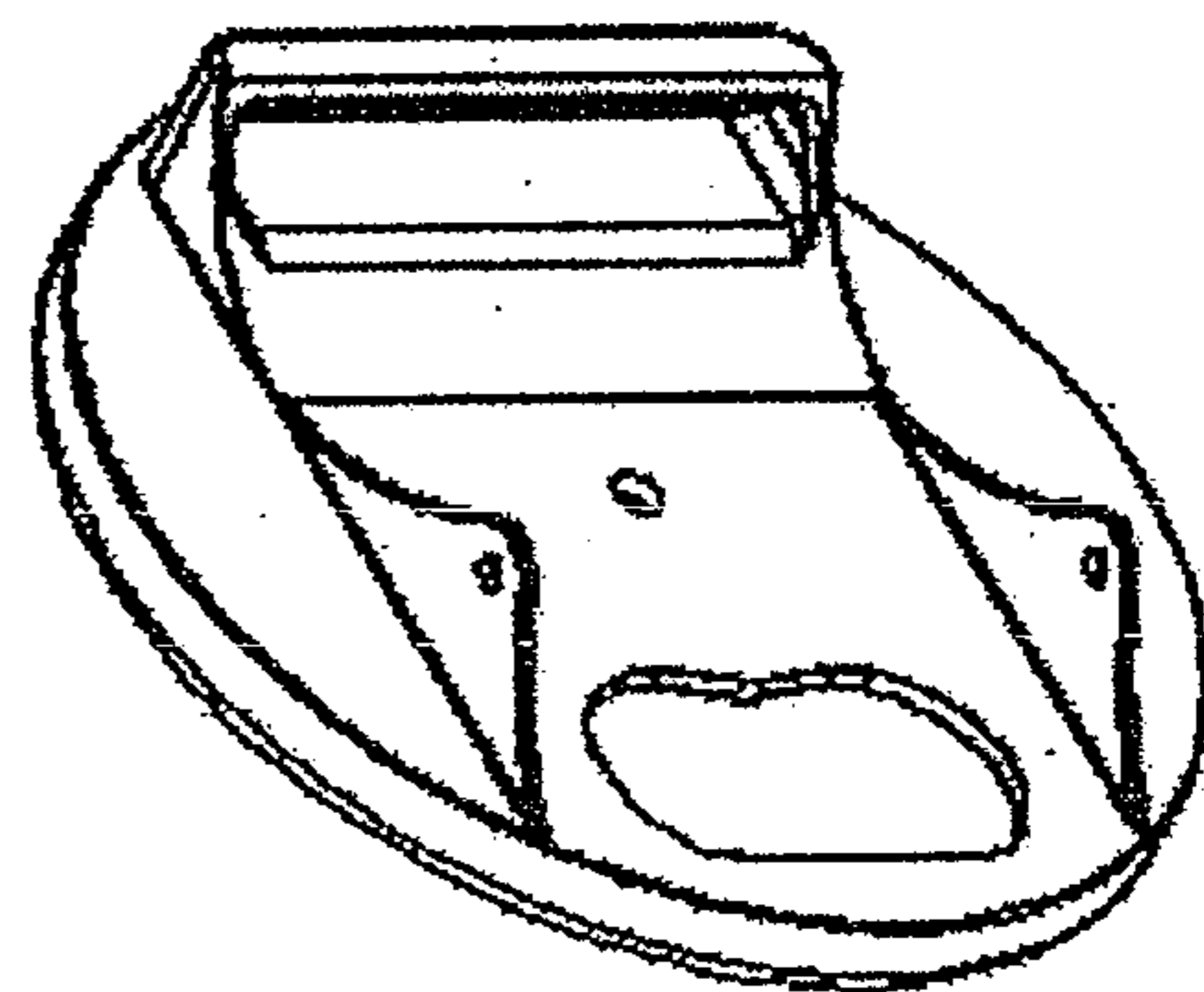

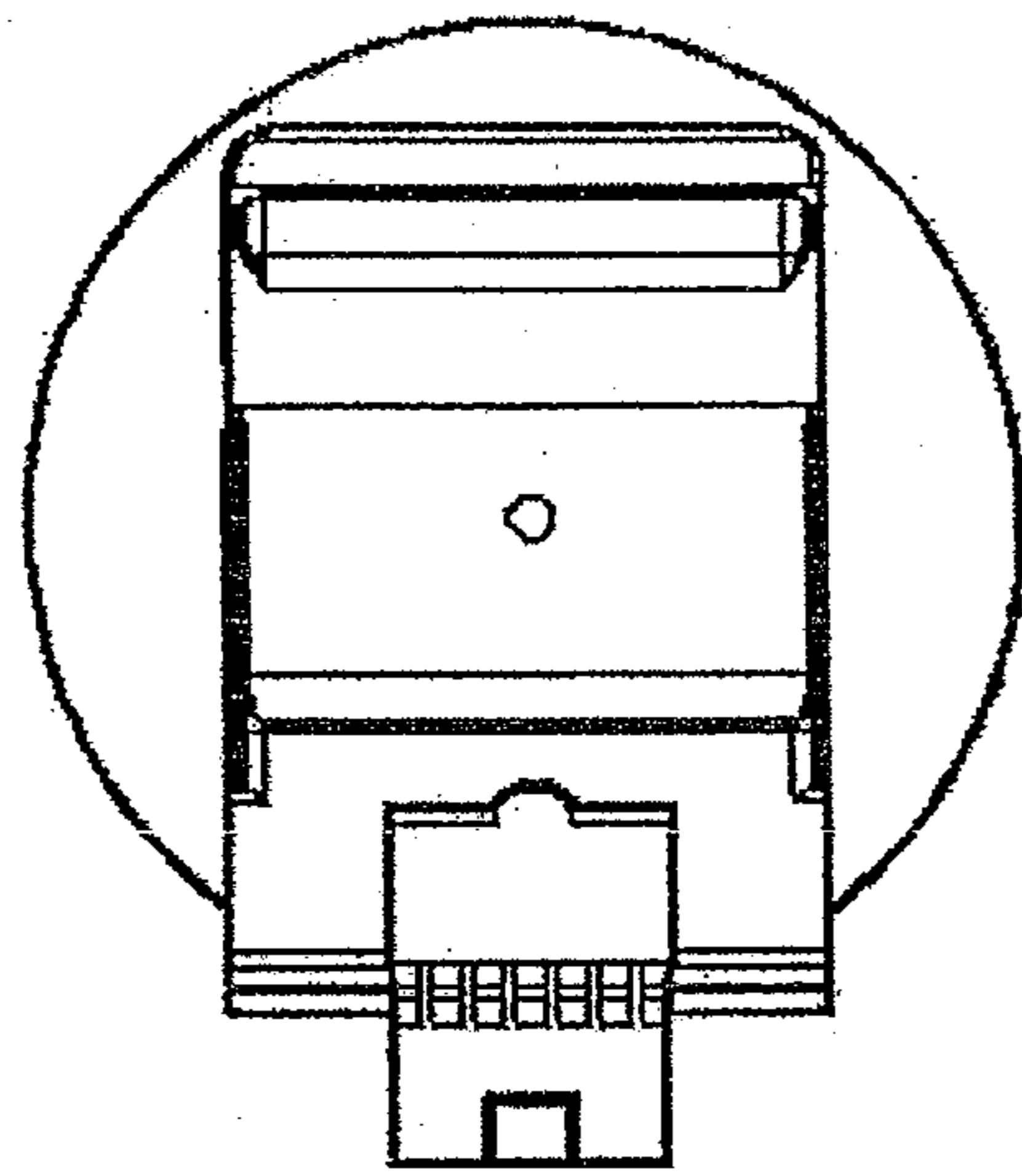

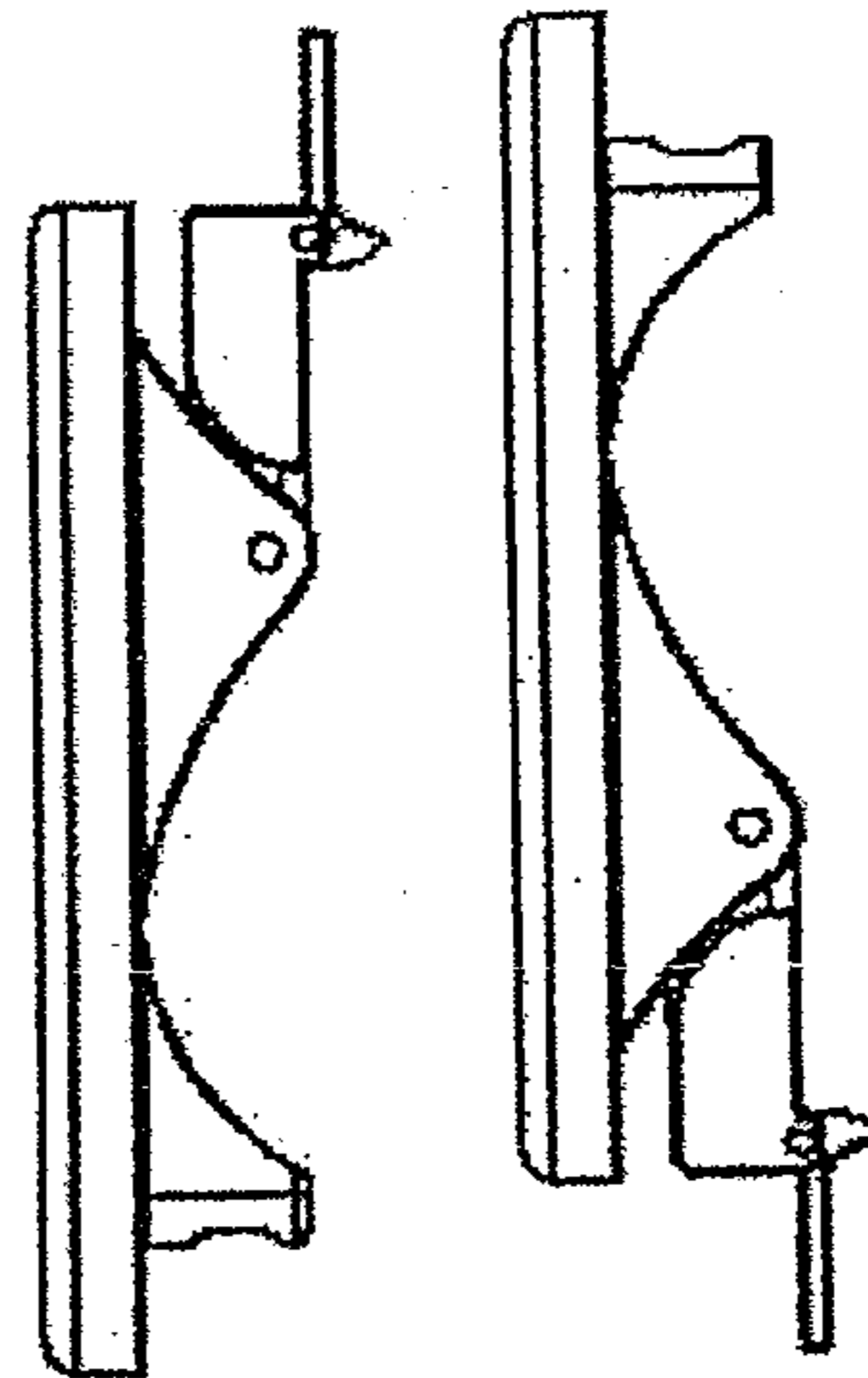

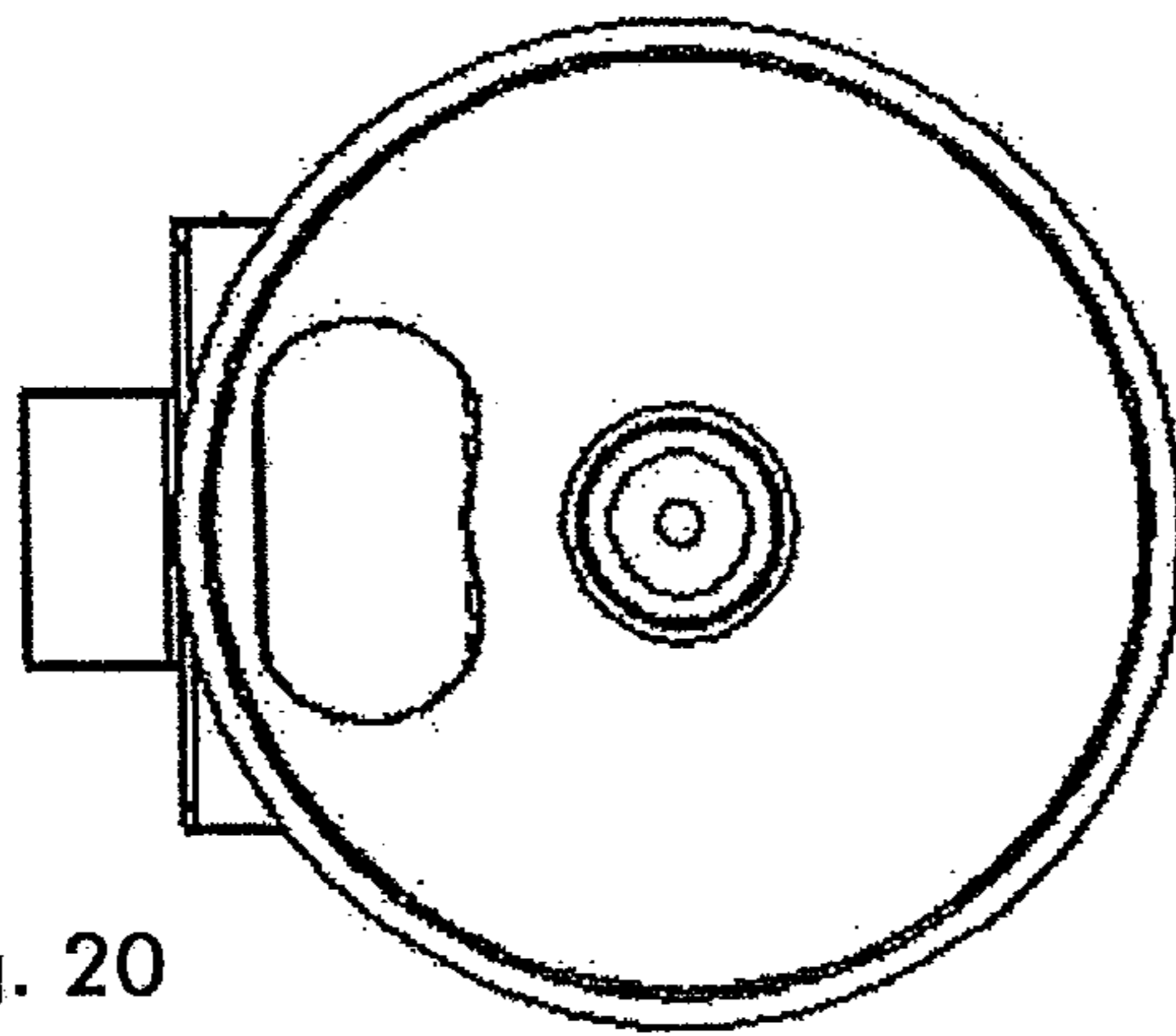

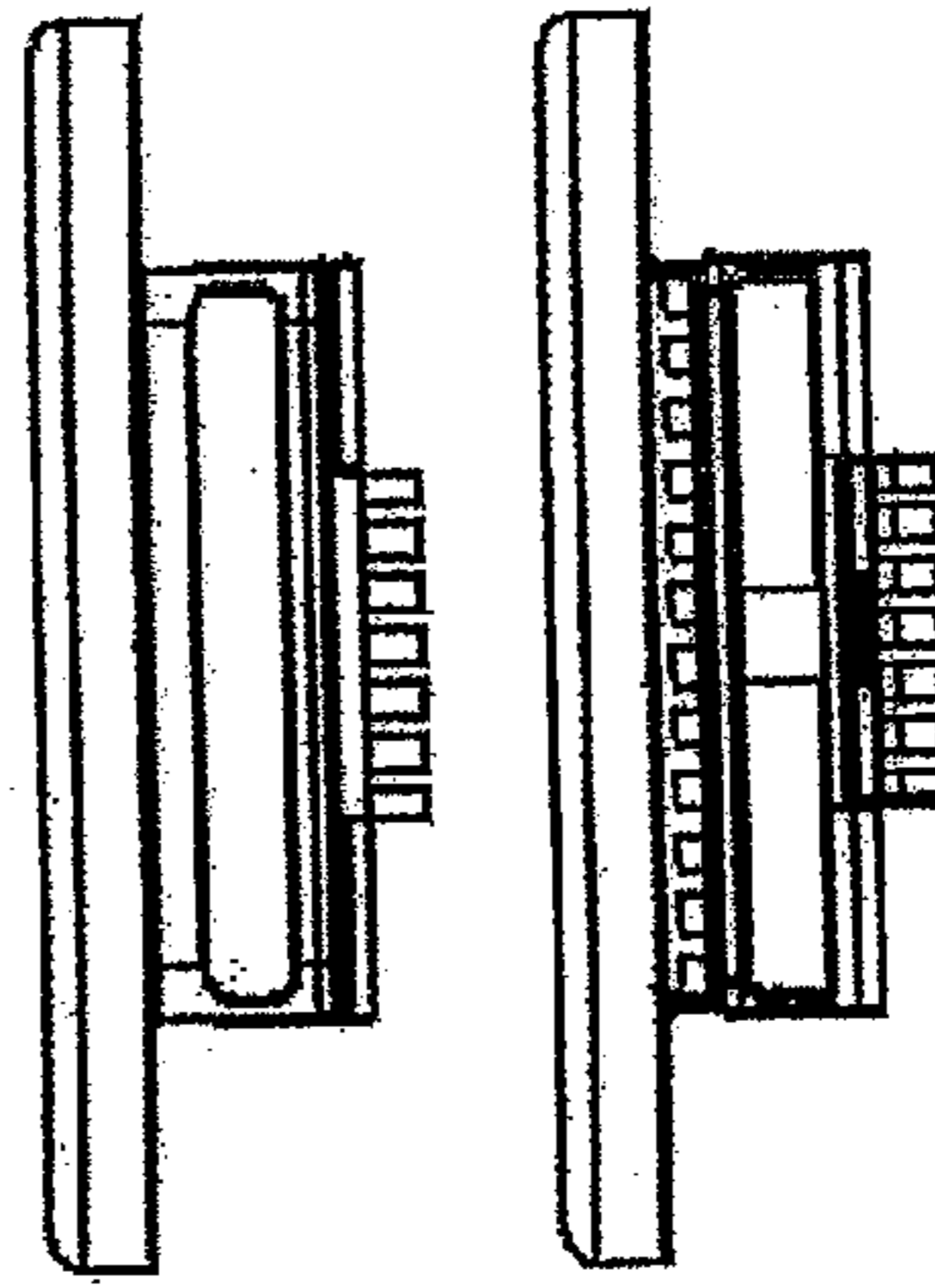

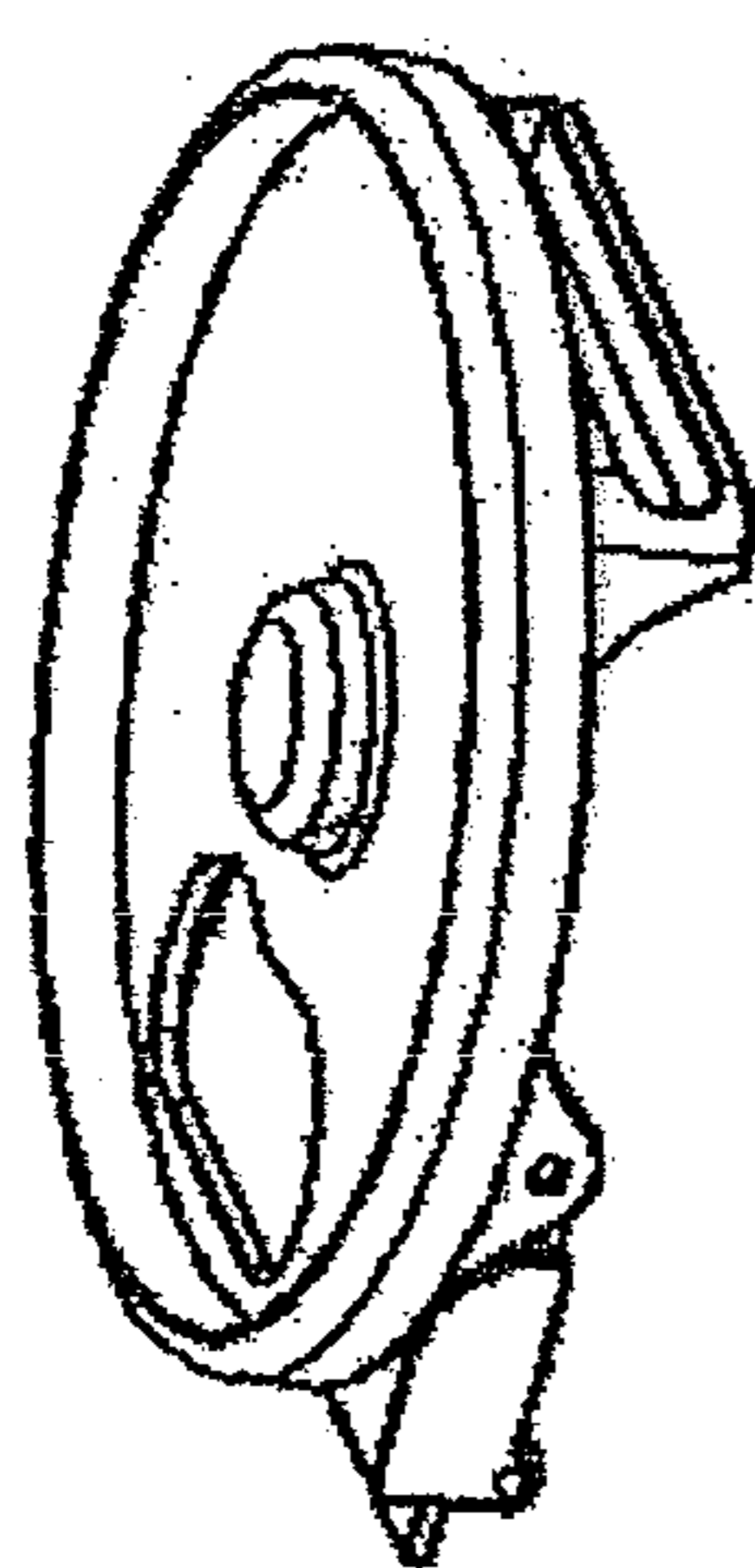

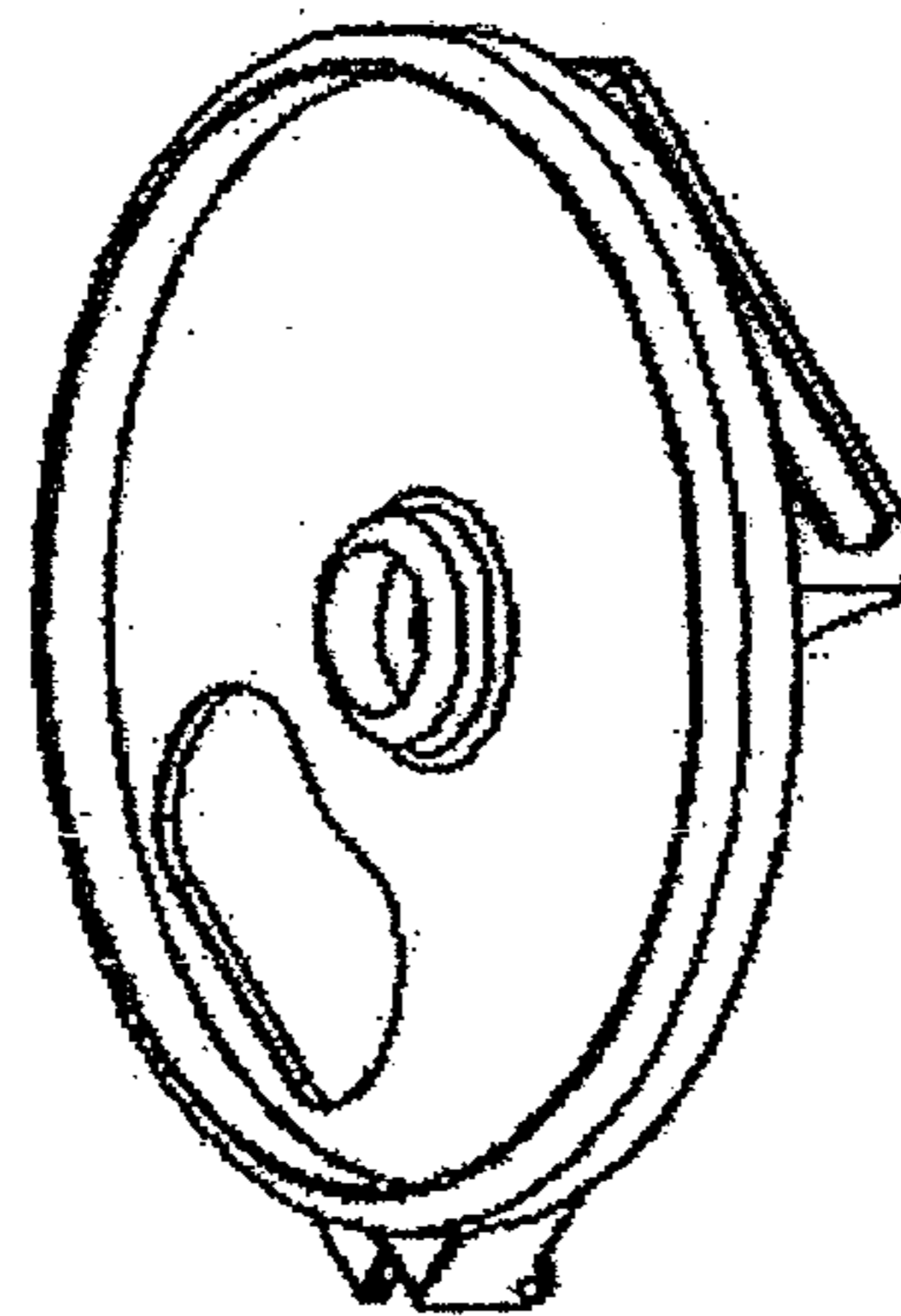

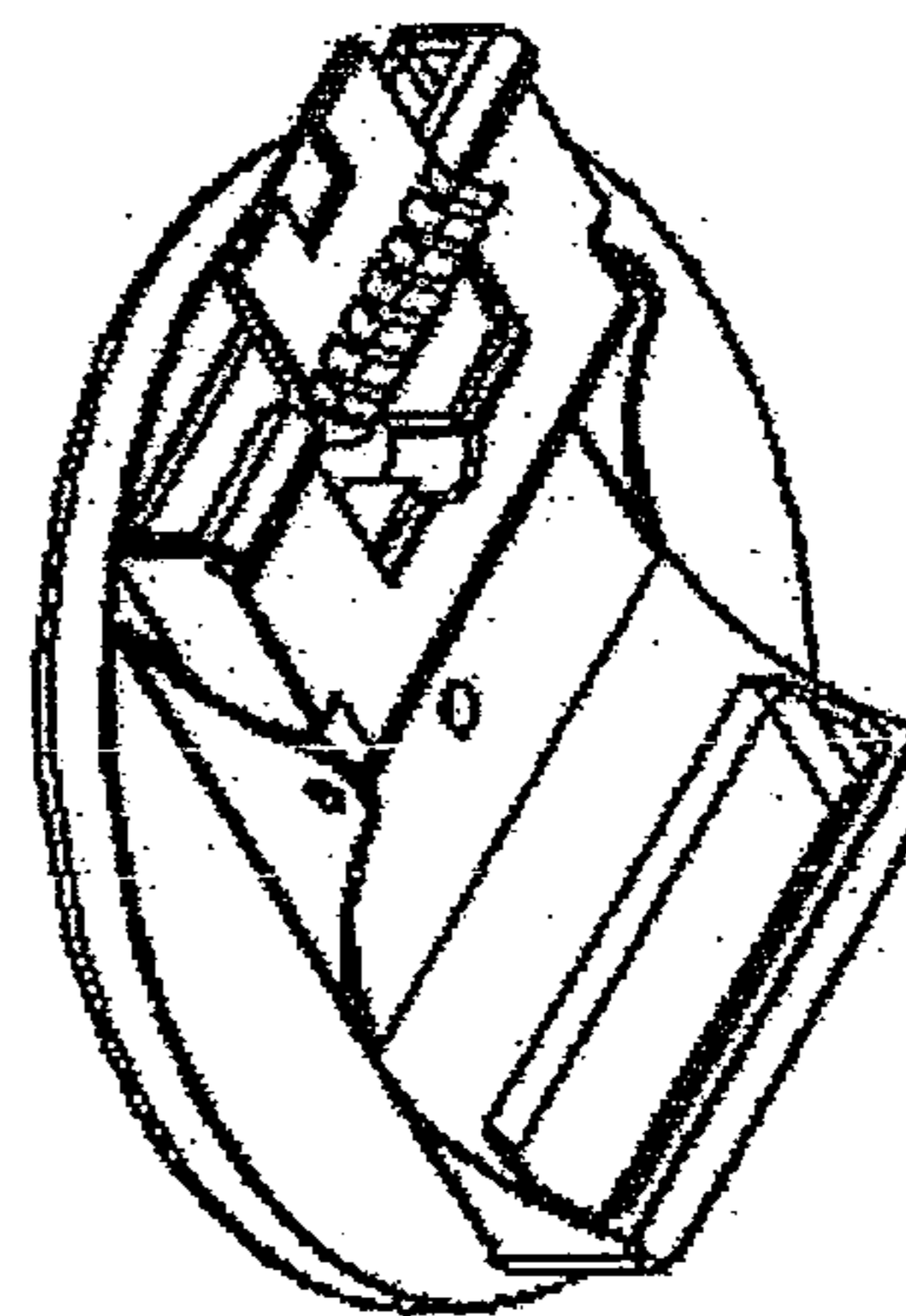

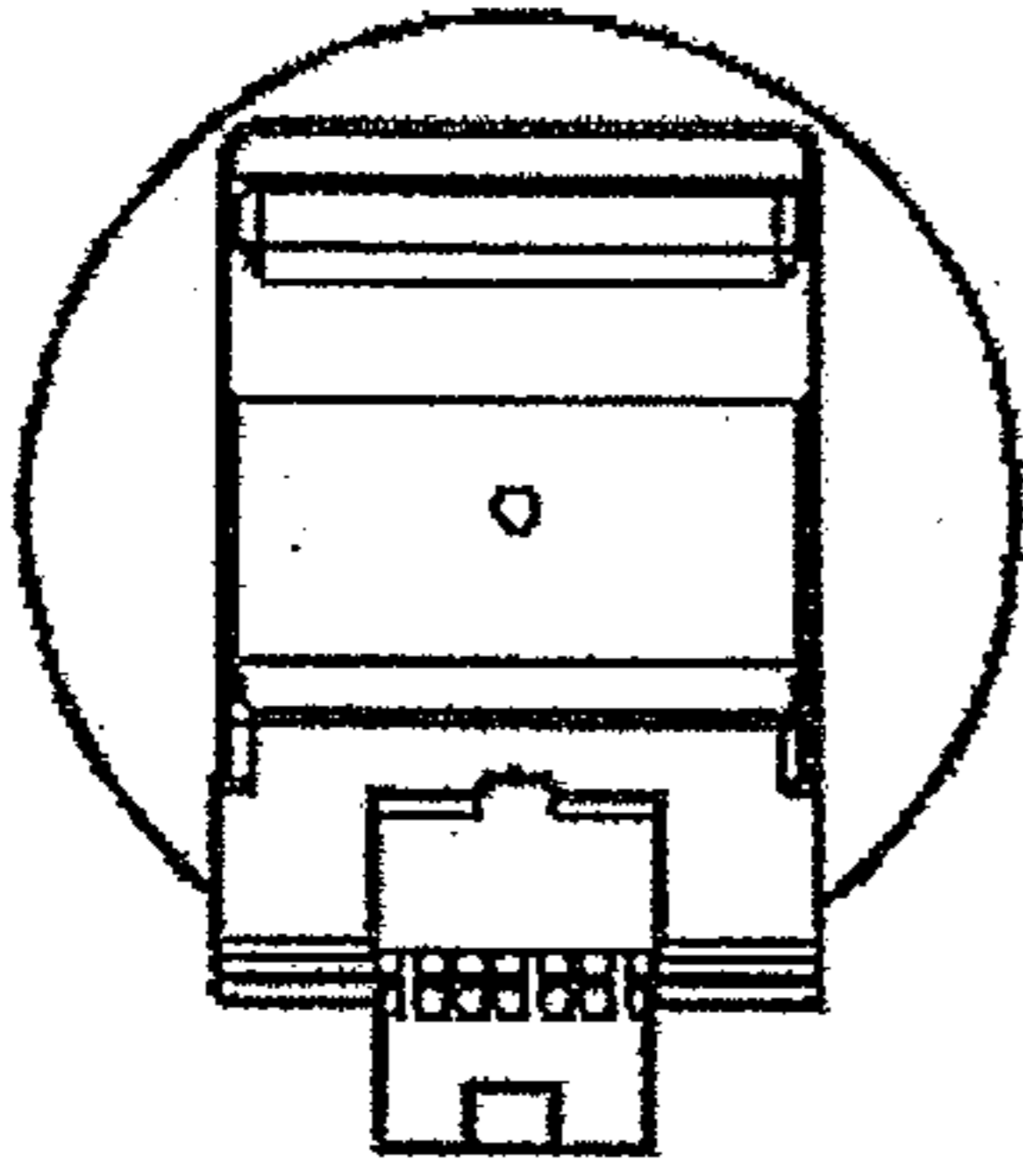

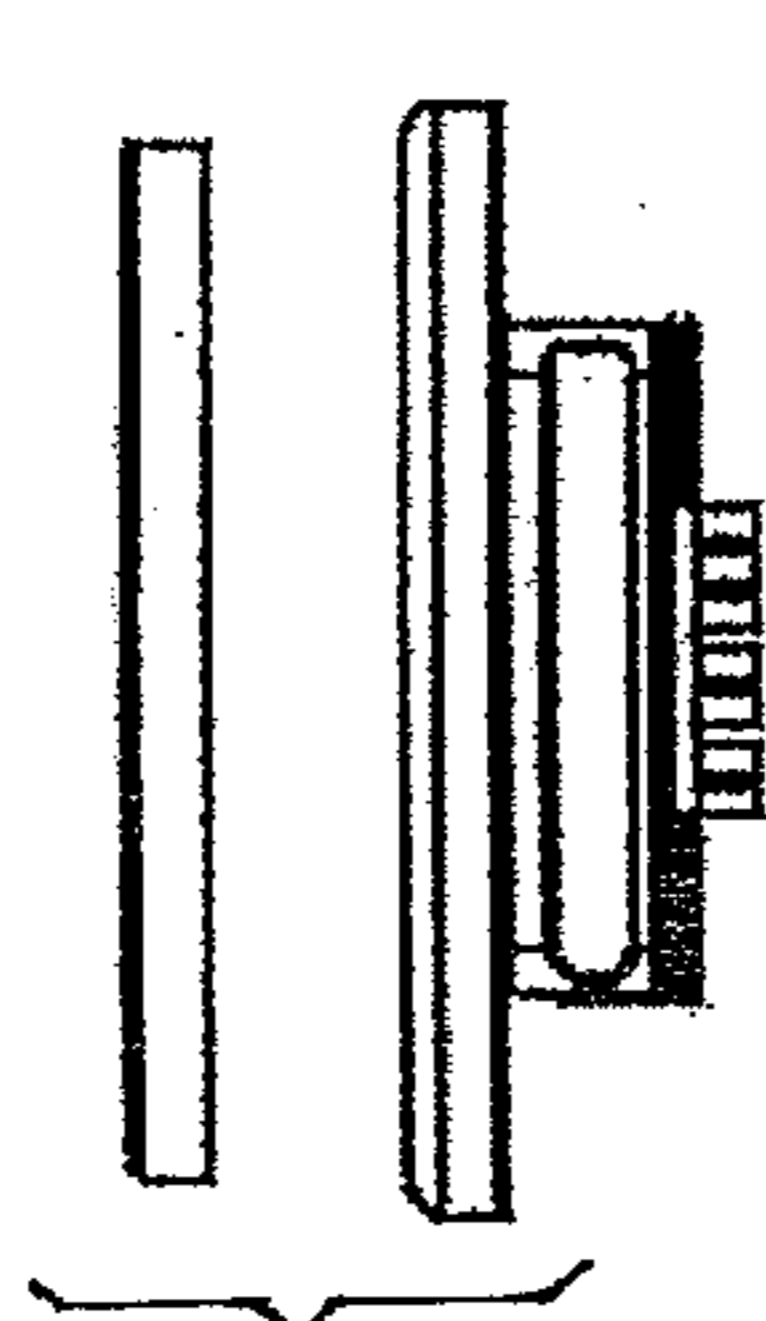

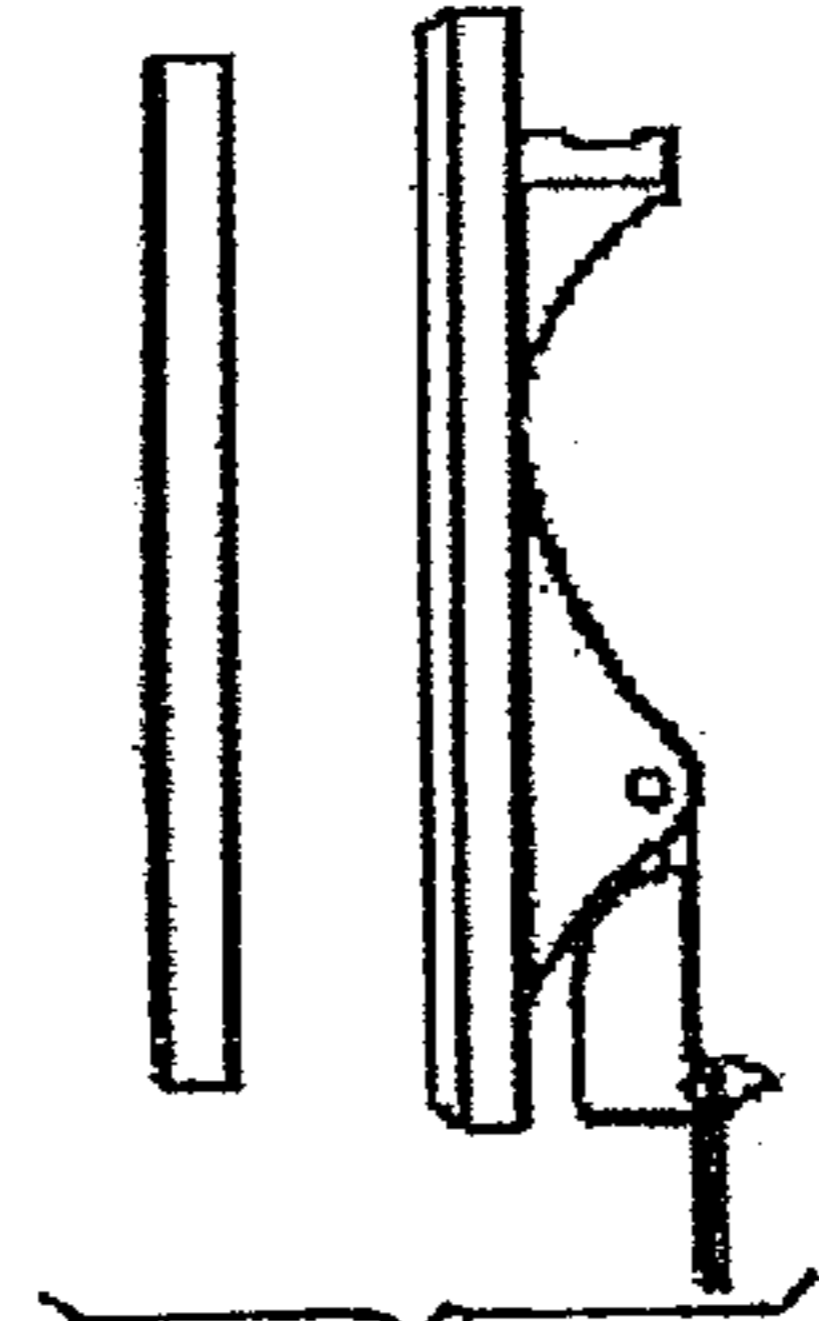

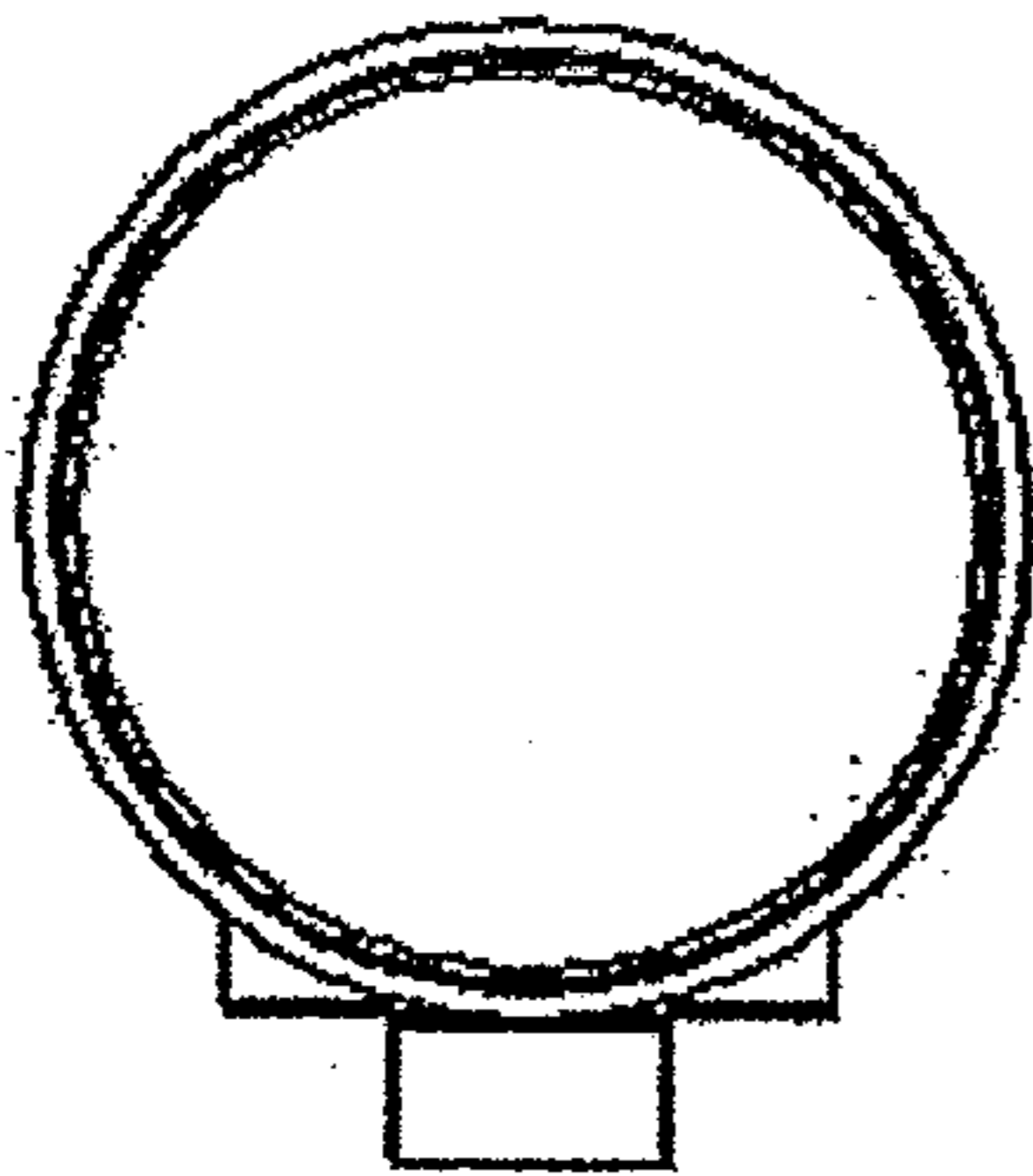

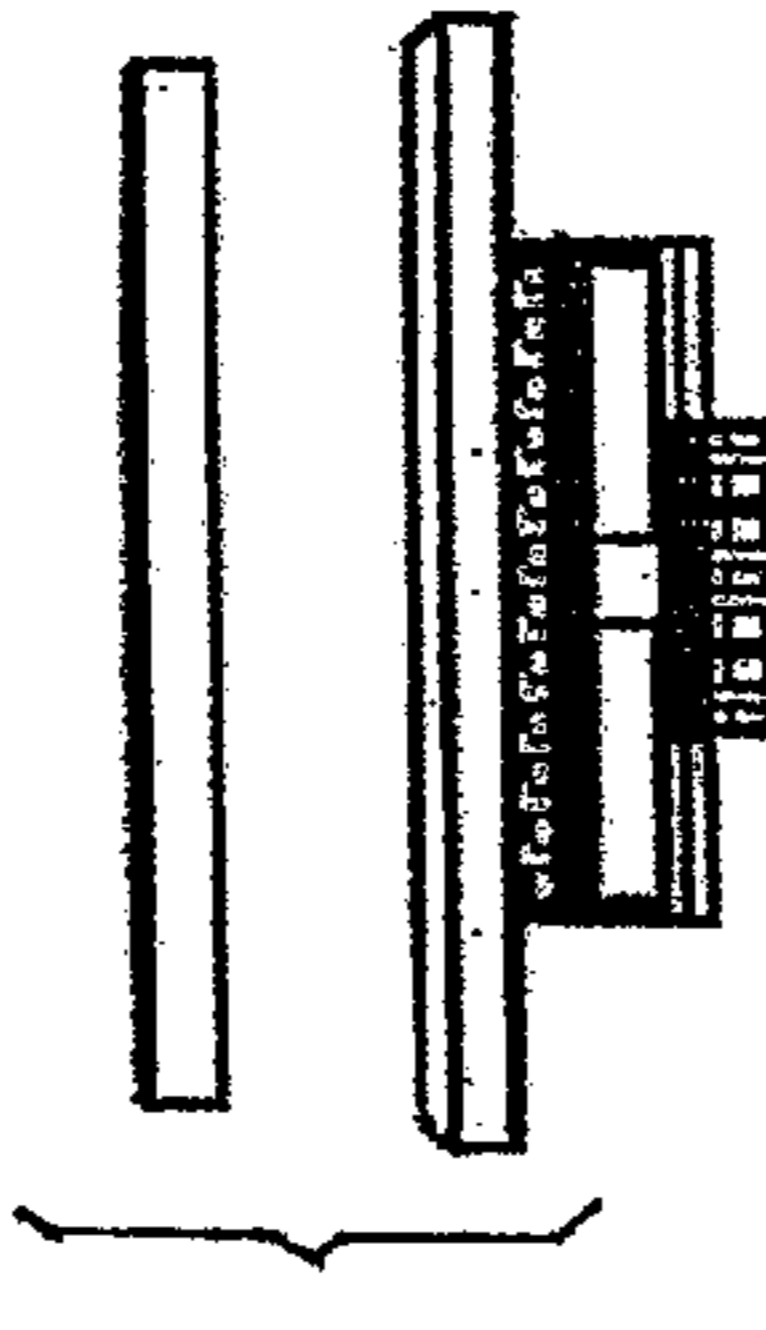

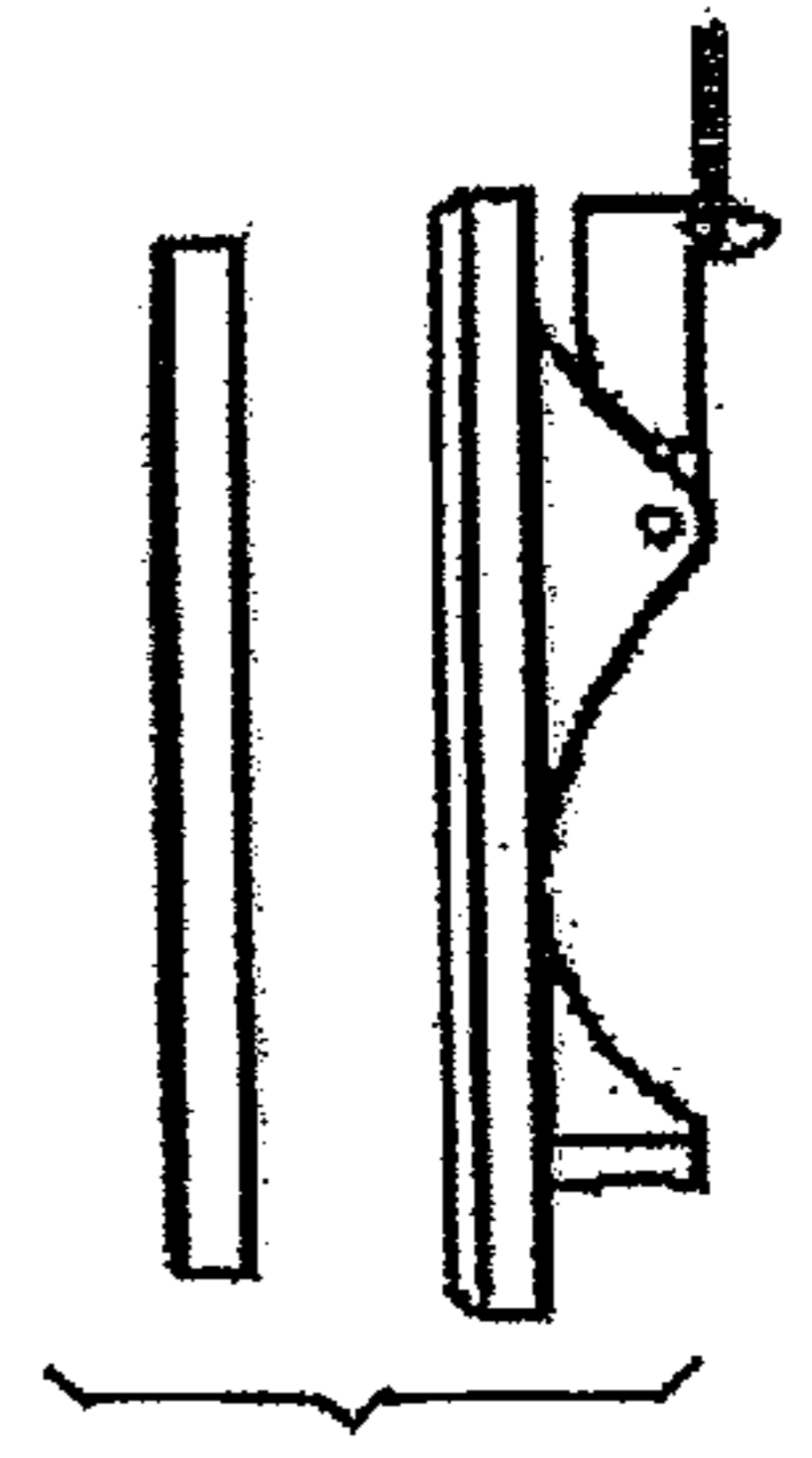

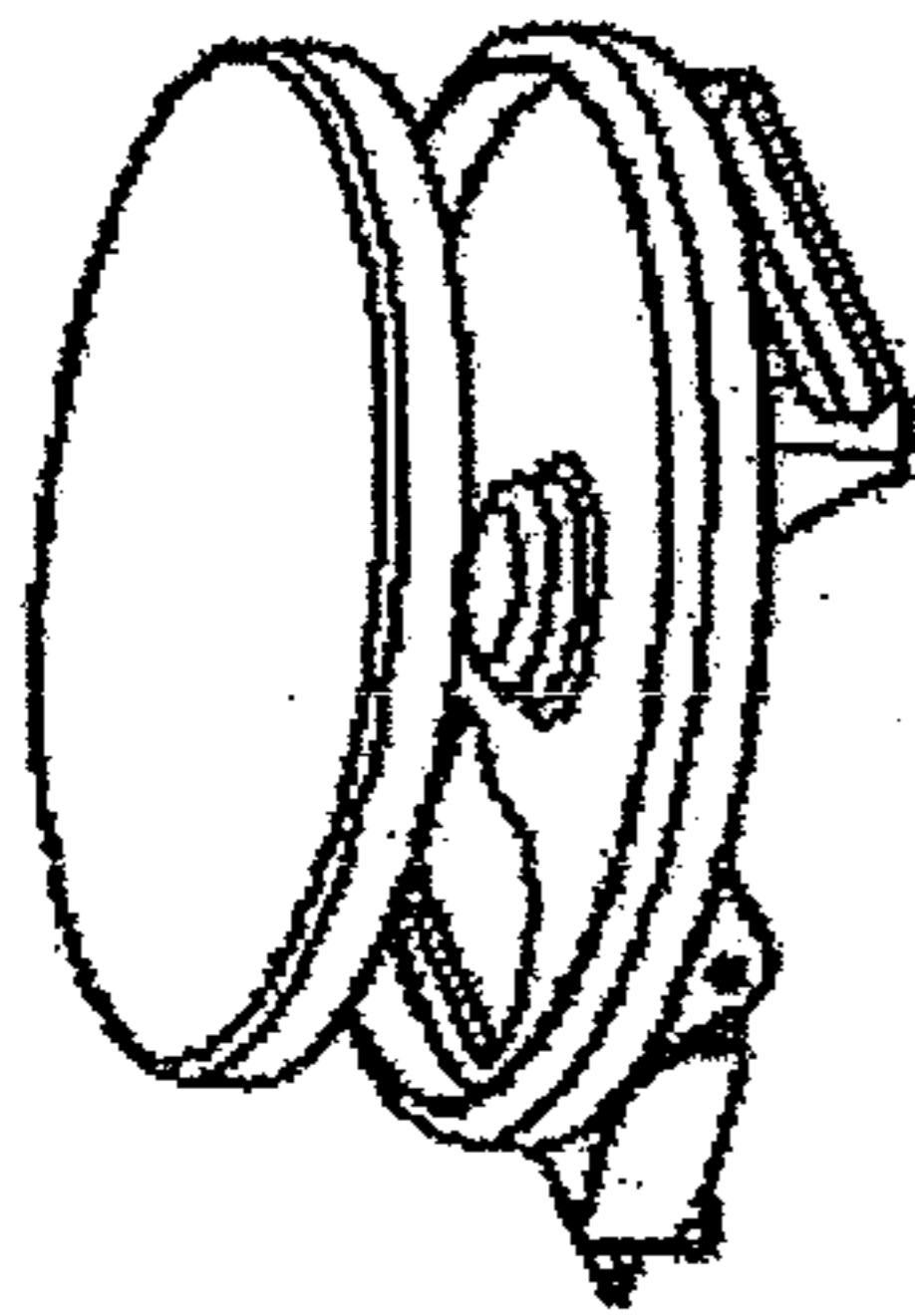

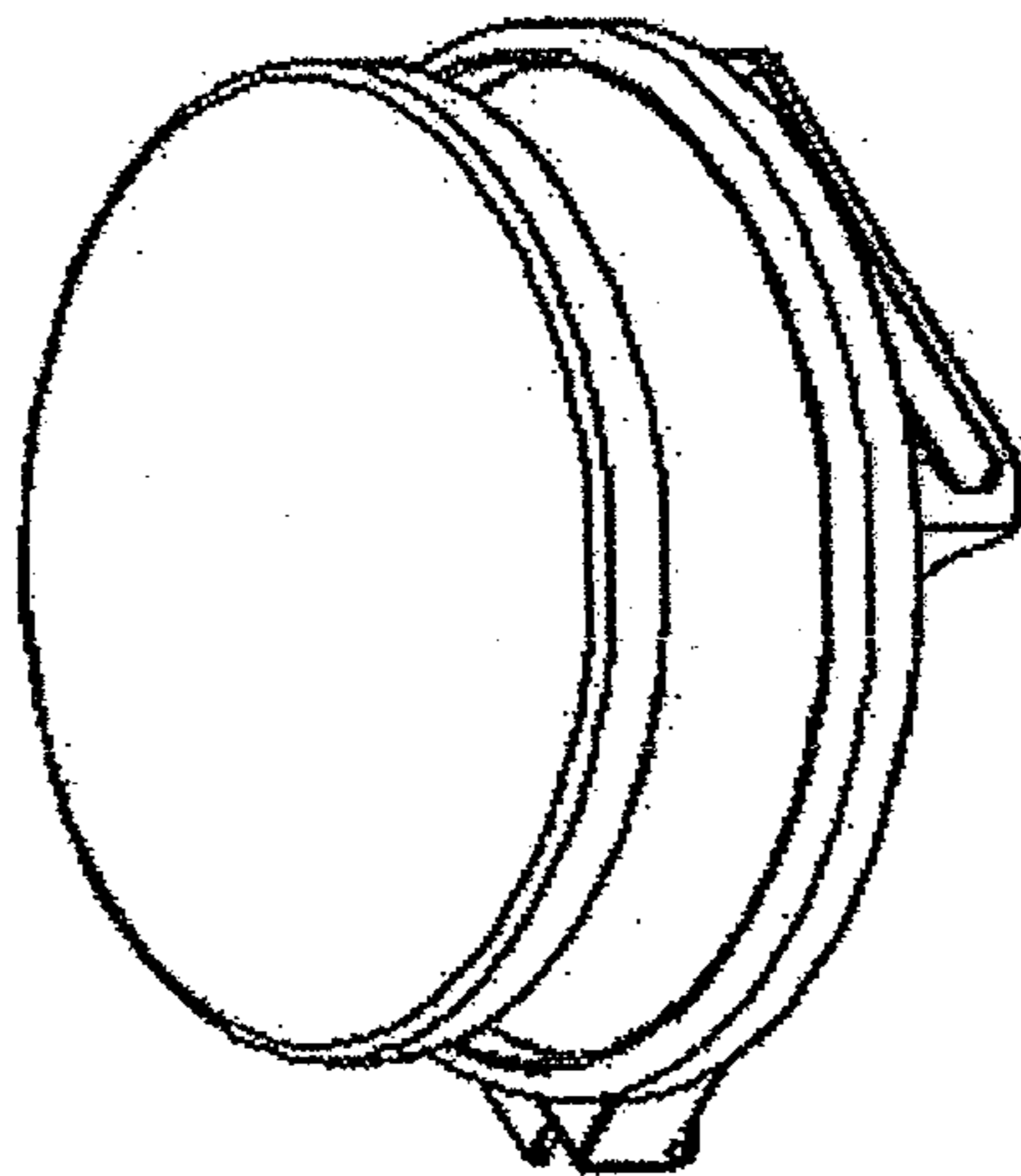

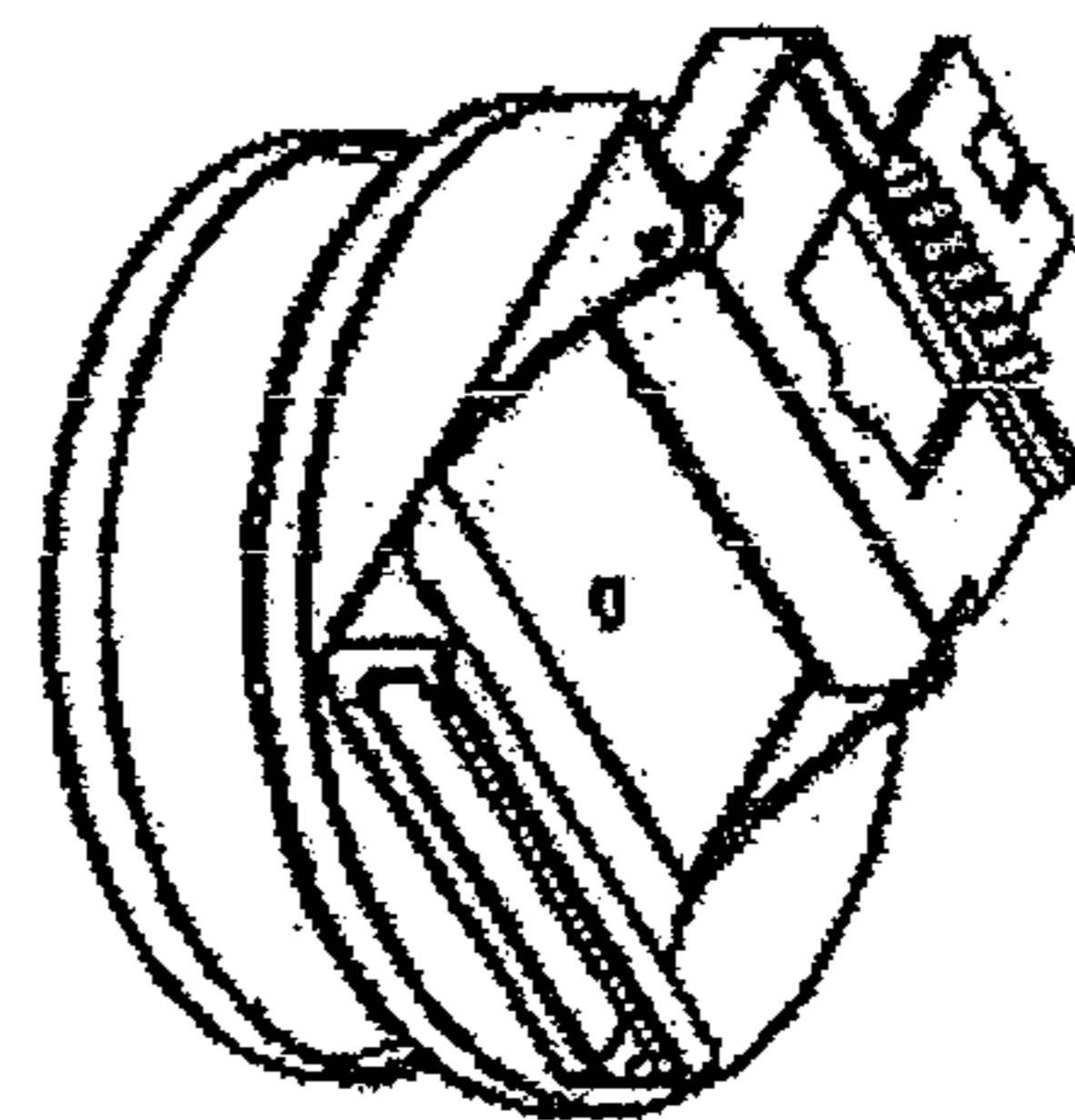
