(57) **CLAIM**

The ornamental design for a paddle, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a paddle according to my new design.

FIG. 2 is rear view thereof.

FIG. 3 is a top plan view thereof.

FIG. 4 is a bottom view thereof.

FIG. 5 is a right side view thereof.

FIG. 6 is a left side view thereof.

FIG. 7 is an enlarged view showing a portion thereof located between the lines A—A of FIG. 1.

FIG. 8 is an enlarged view showing a portion thereof located between the lines B—B of FIG. 2.

FIG. 9 is an enlarged view showing a portion thereof located between the lines C—C of FIG. 3.

FIG. 10 is a cross section view thereof viewed along Section D—D of FIG. 7.

FIG. 11 is a cross section view thereof viewed along Section E—E of FIG. 7.

FIG. 12 is a reference view thereof showing an extended configuration; and,

FIG. 13 is an exploded view thereof.

The structure of the paddle is such that the length is extendible and can be adjusted.

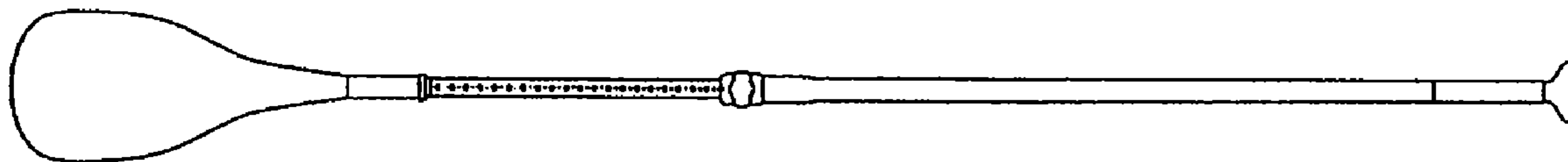

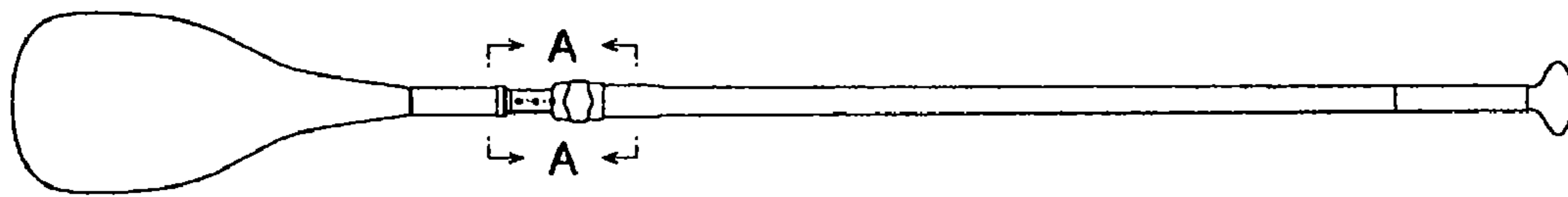

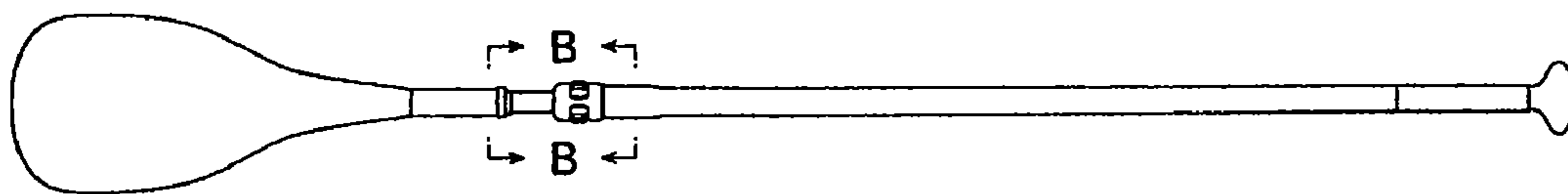

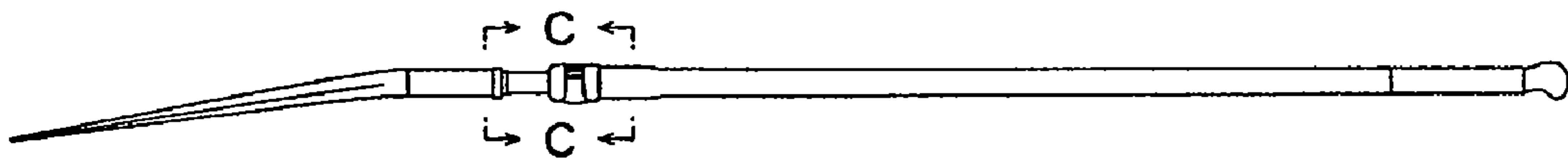

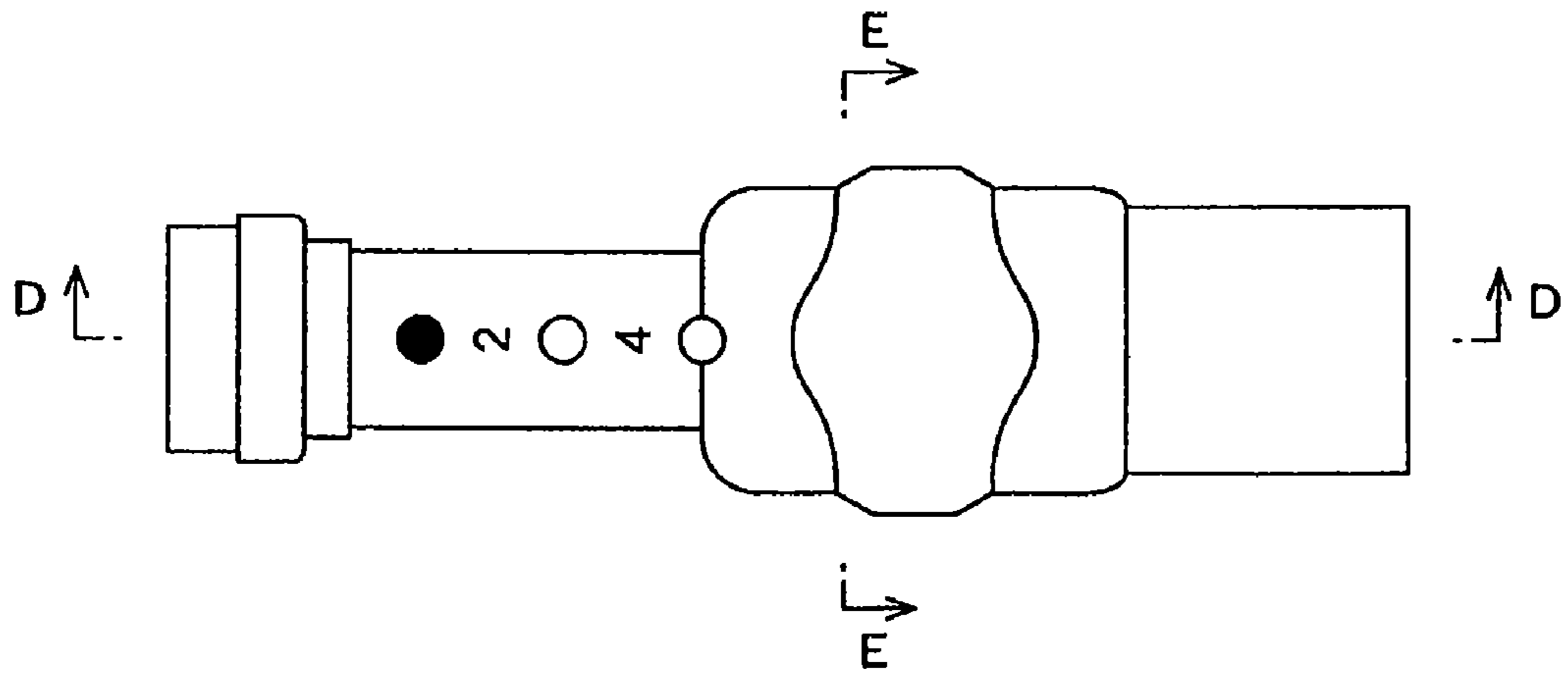

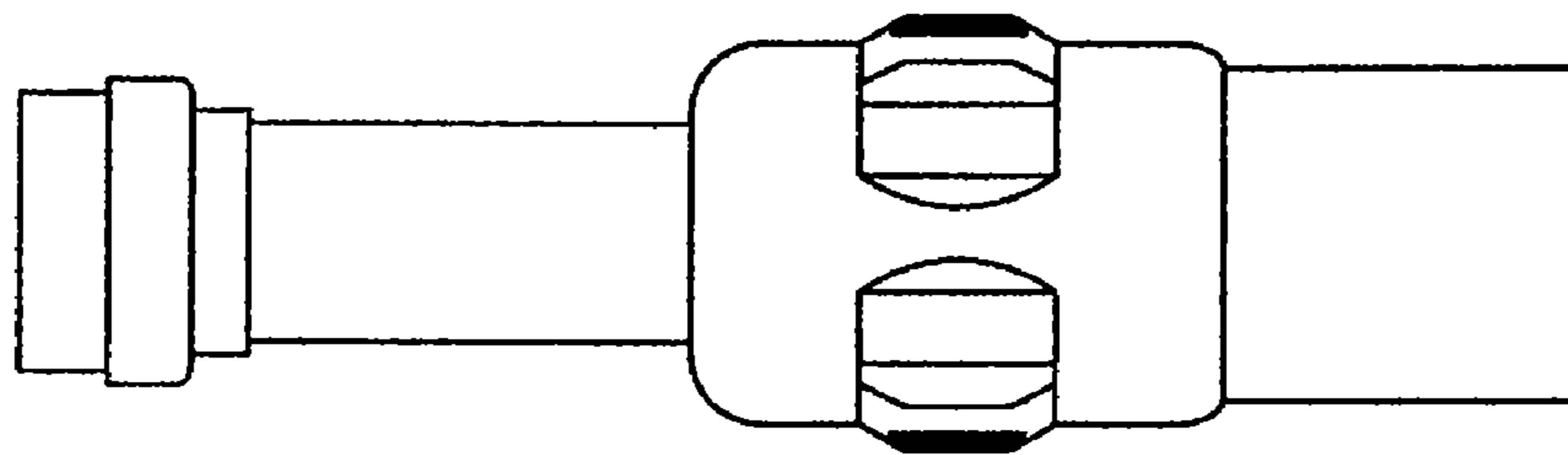

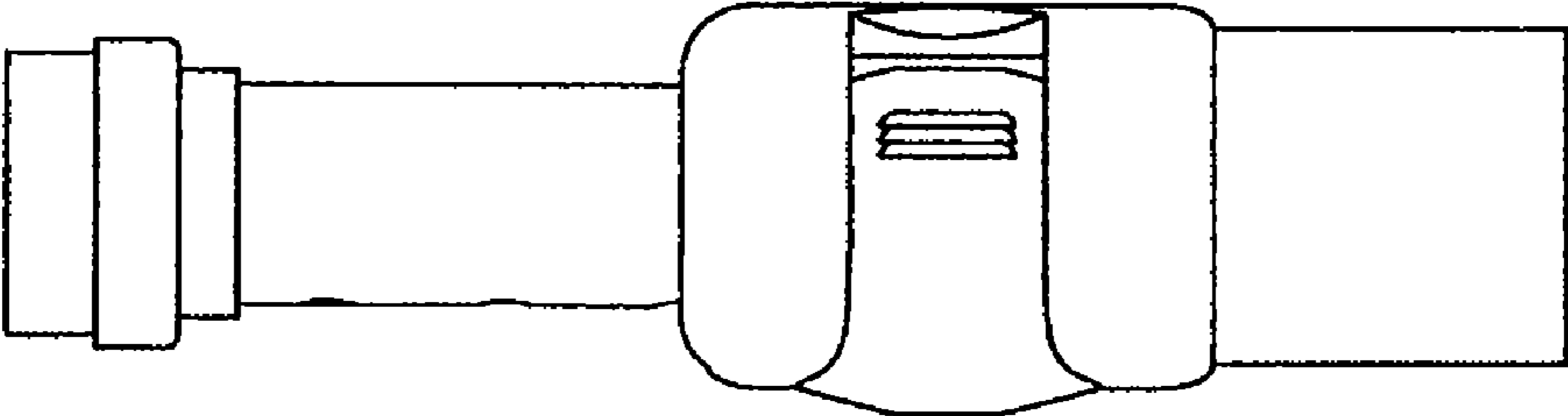

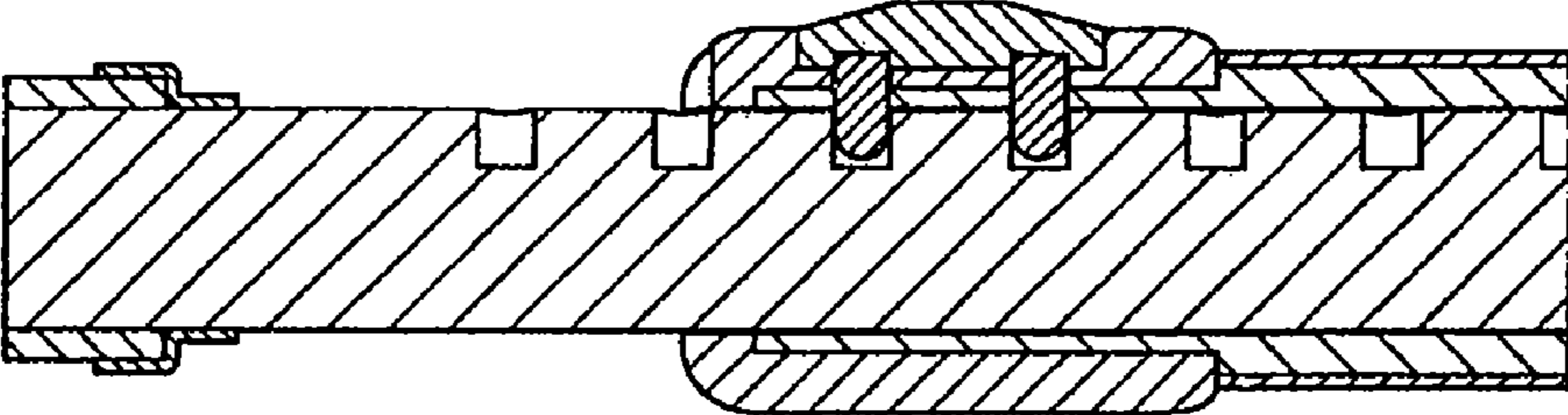

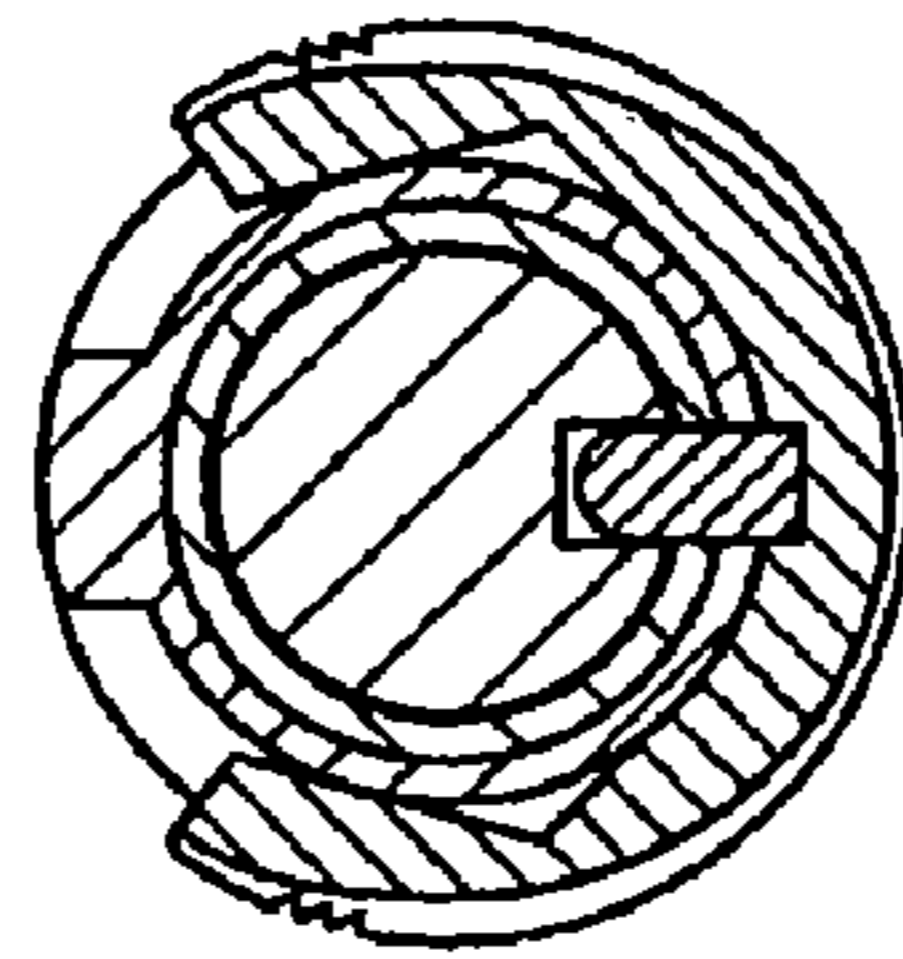

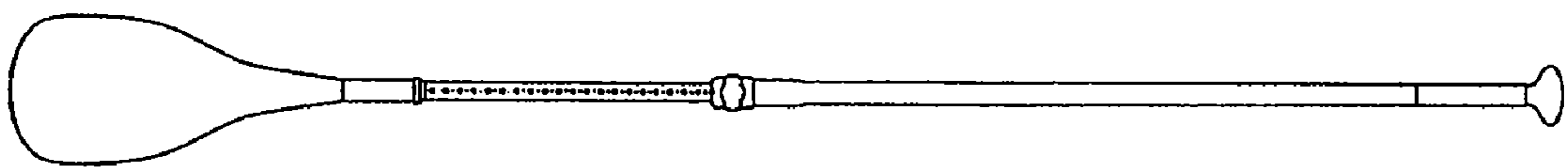
