**DESCRIPTION**

FIG. 2 is a right side view thereof.

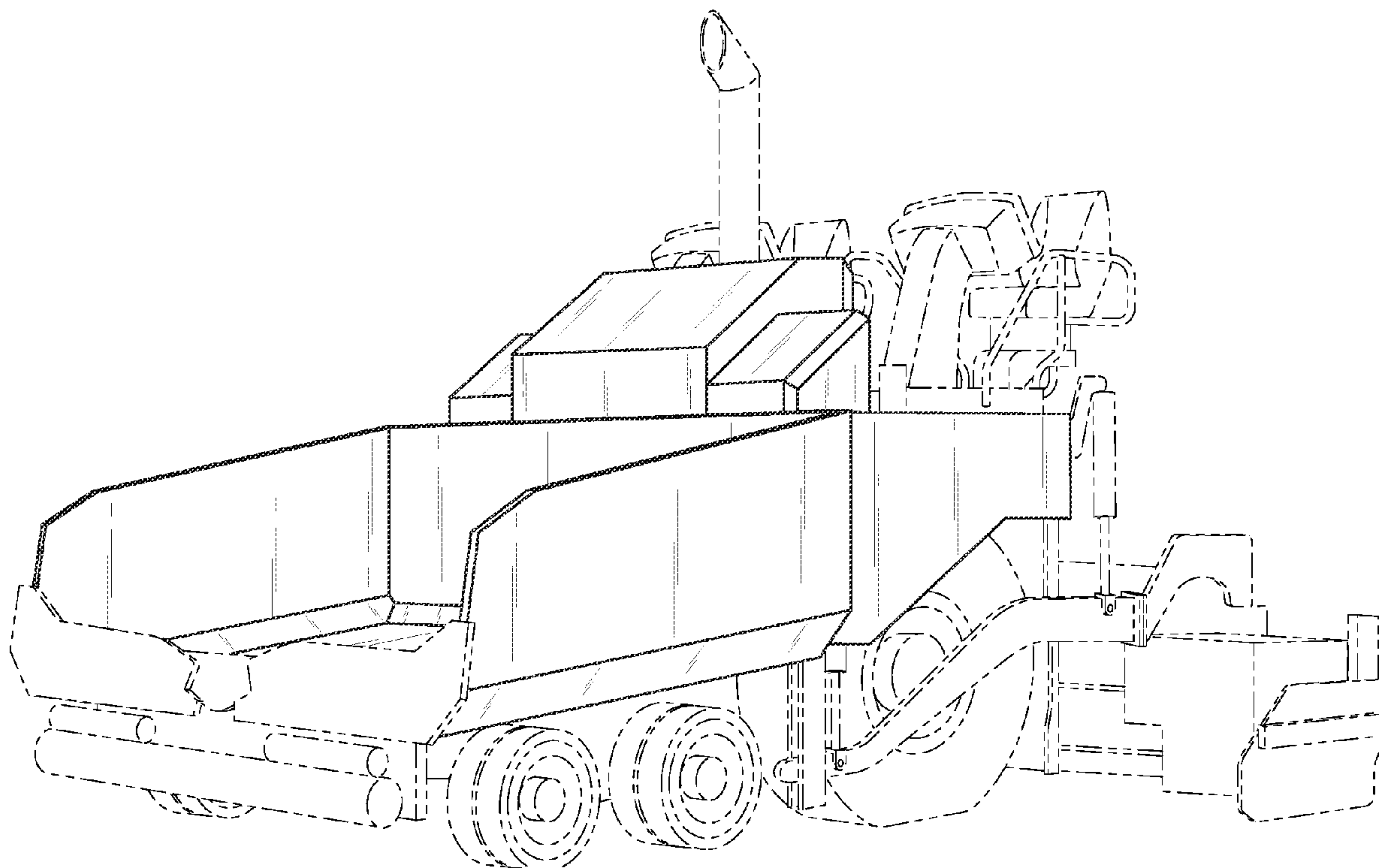
FIG. 3 is a front view thereof.

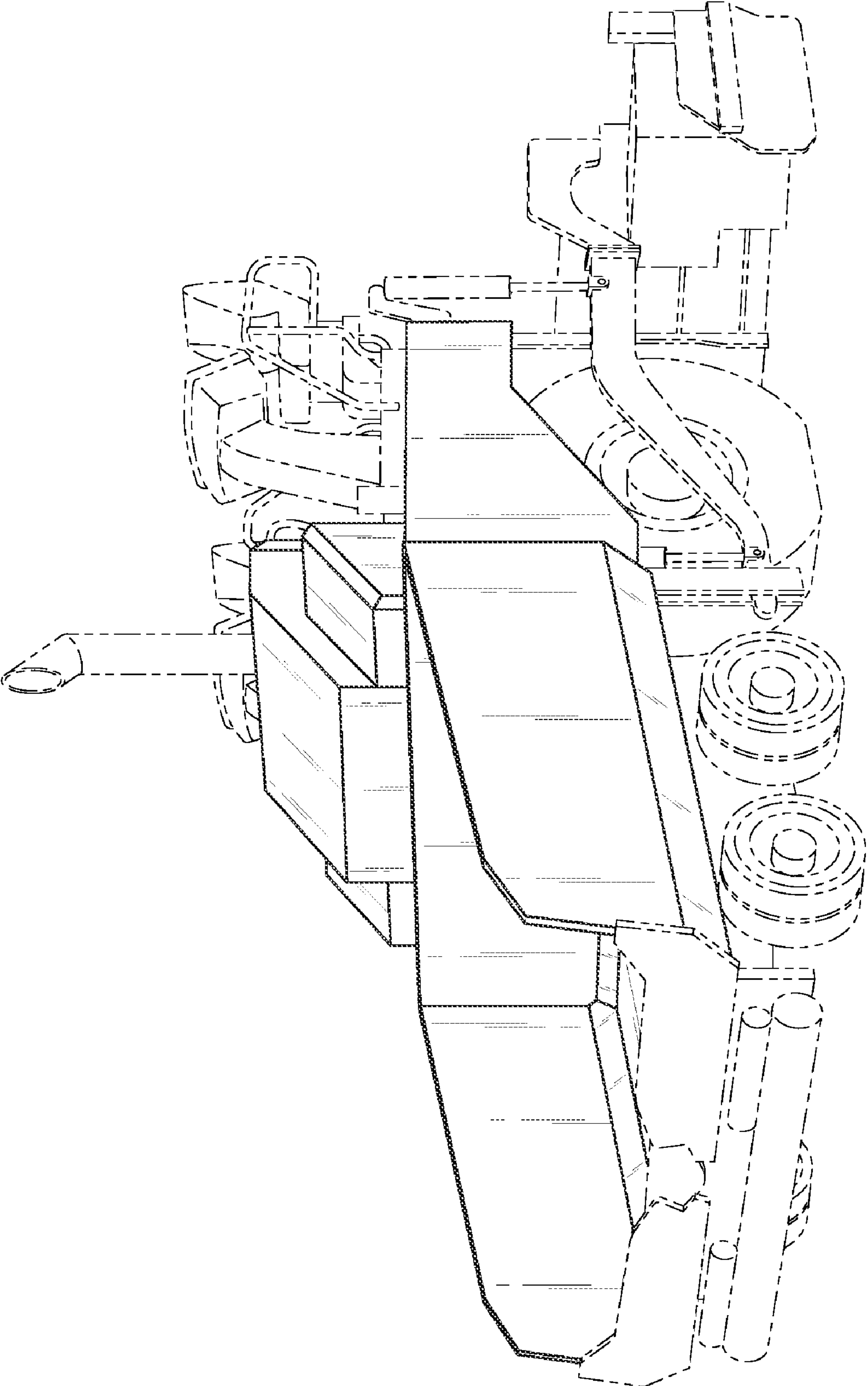

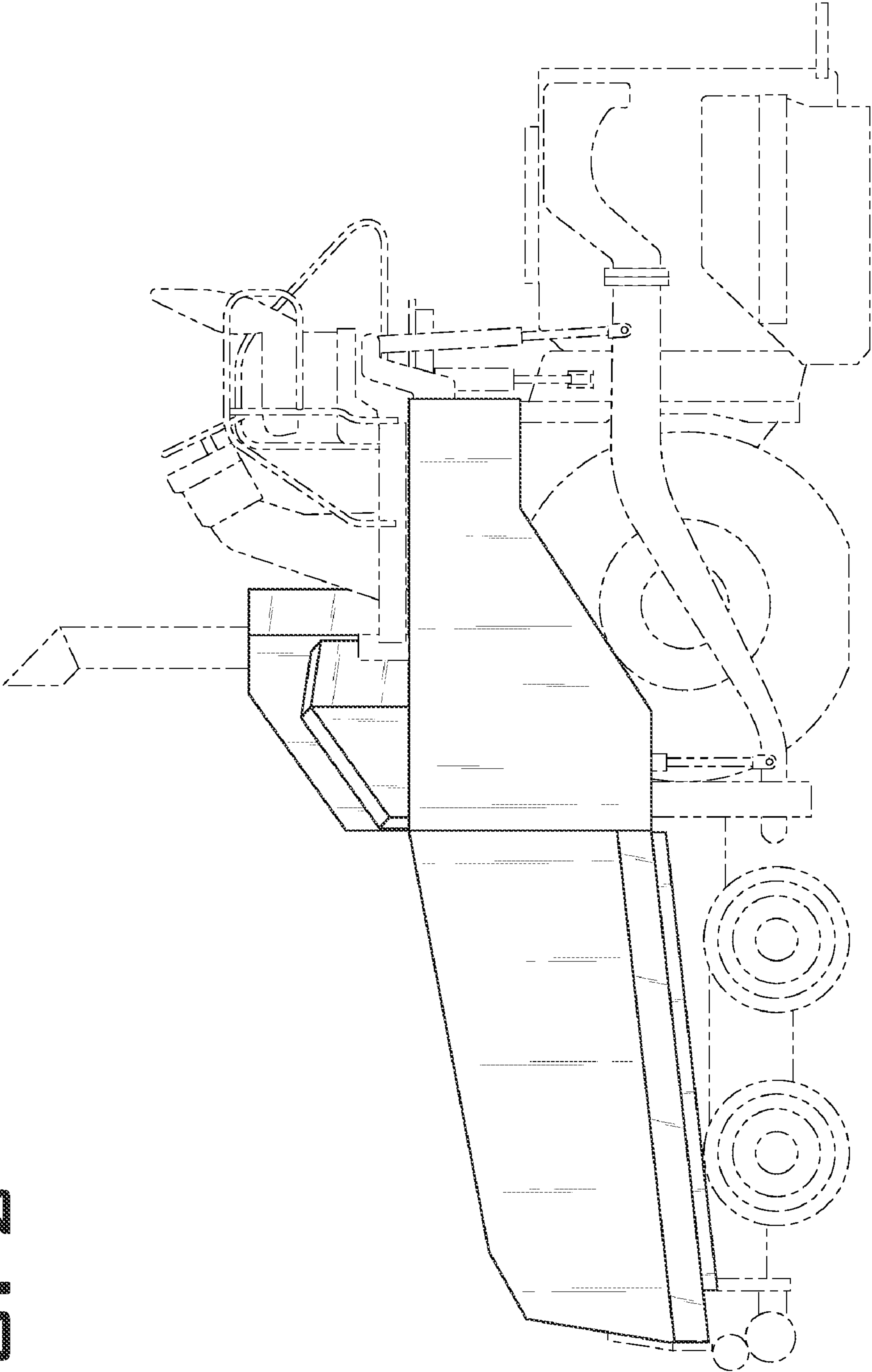

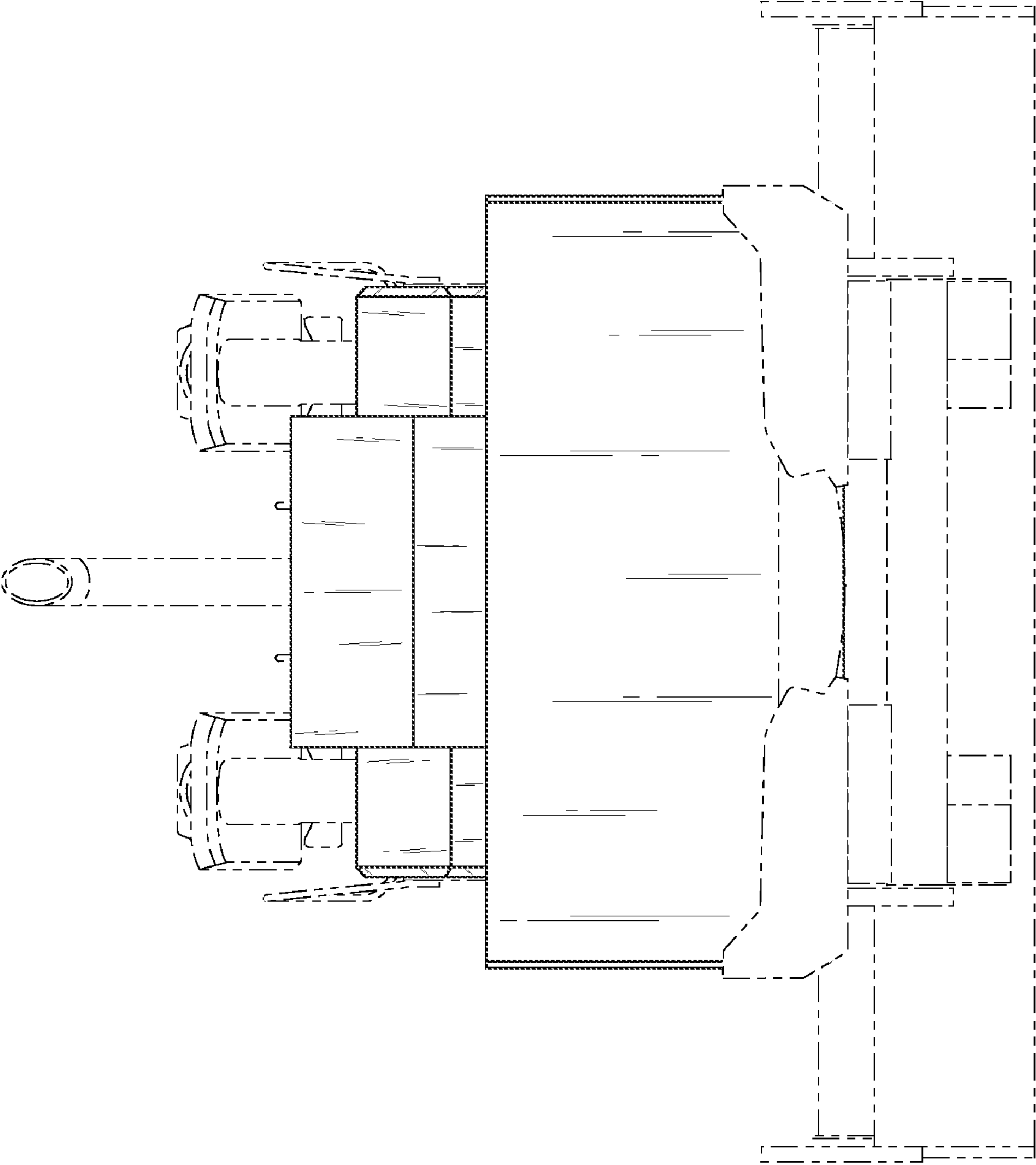
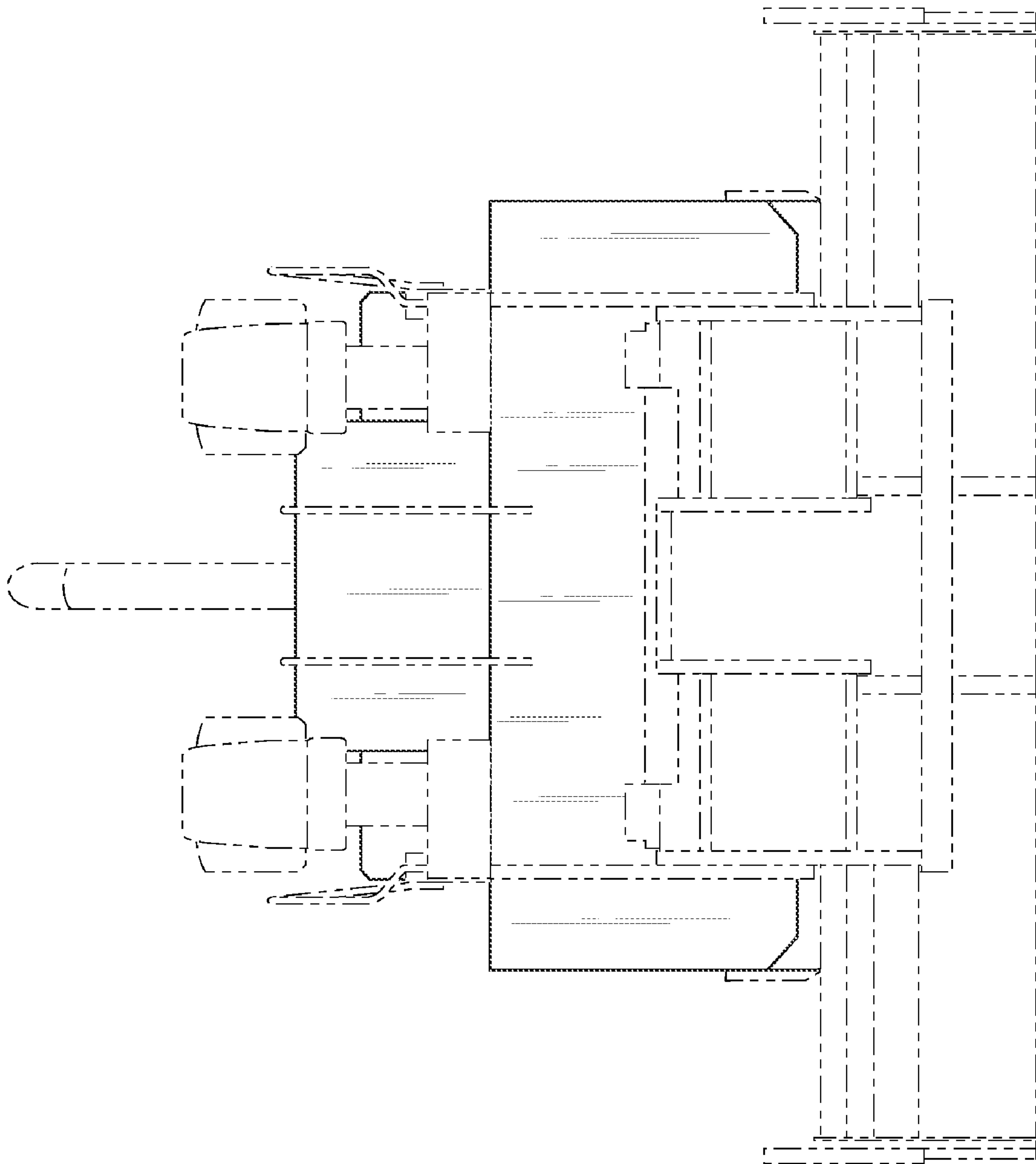

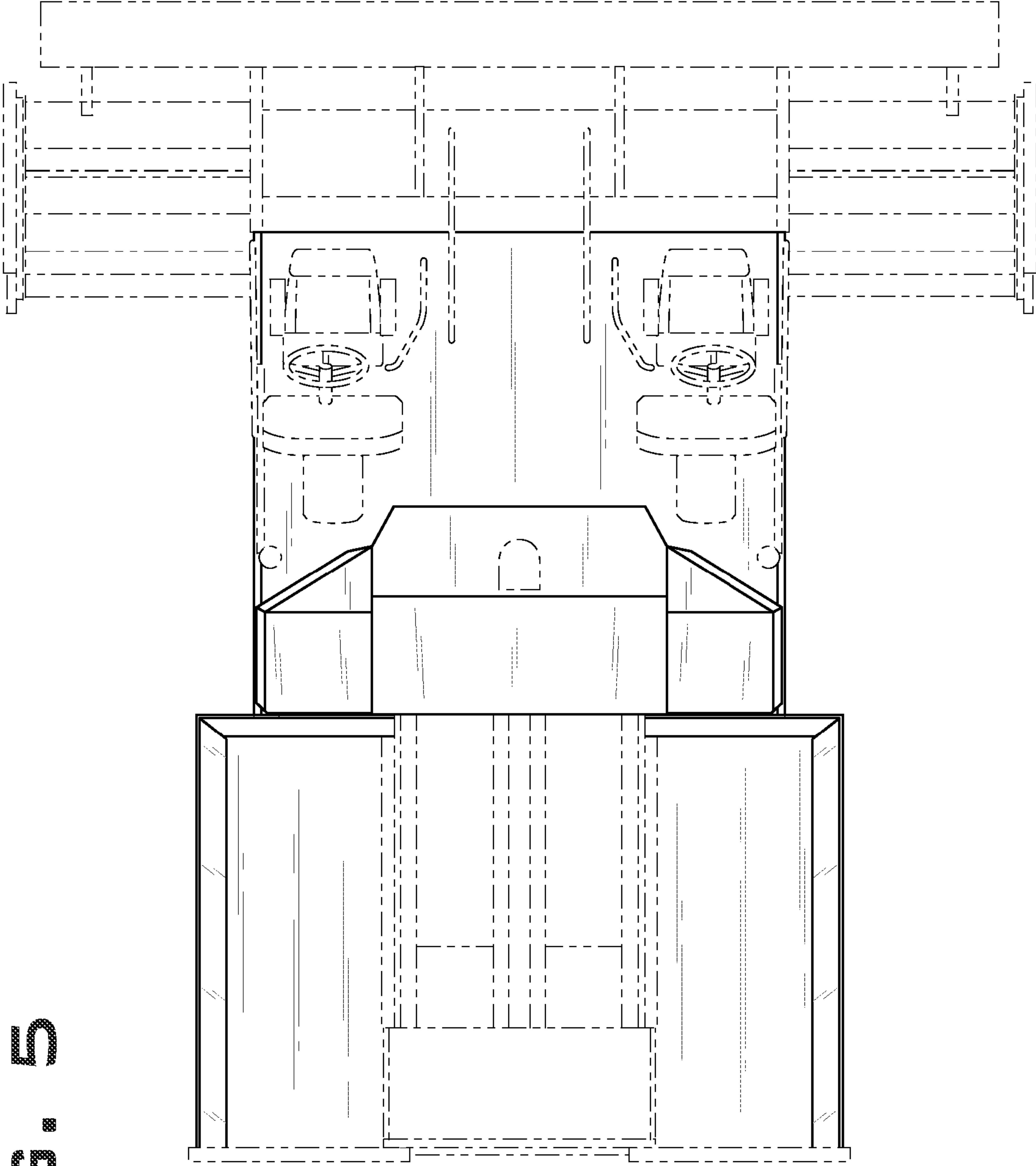
