FIG. 3 is a perspective view of the organizer clip shown in FIG. 1;

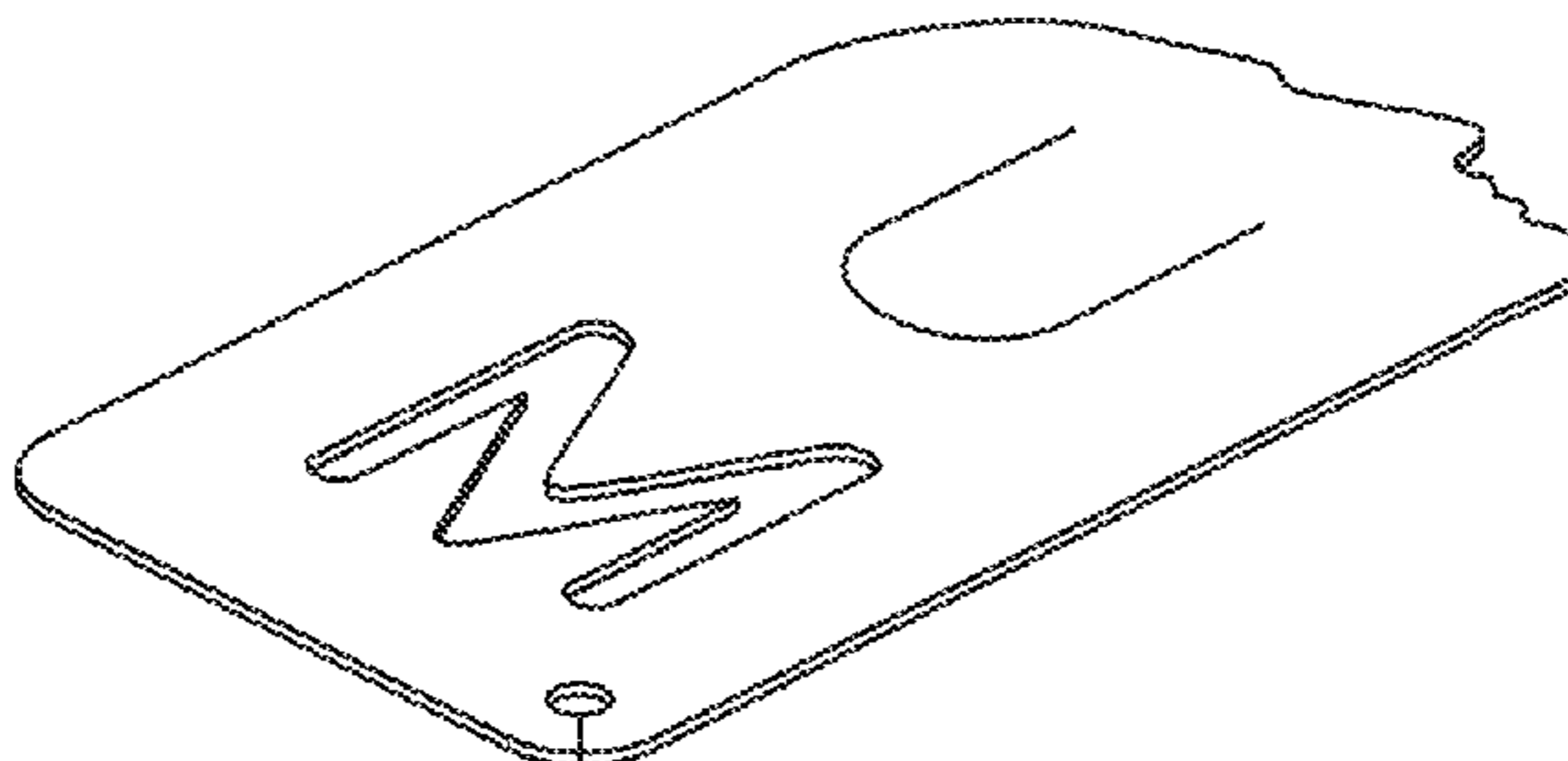
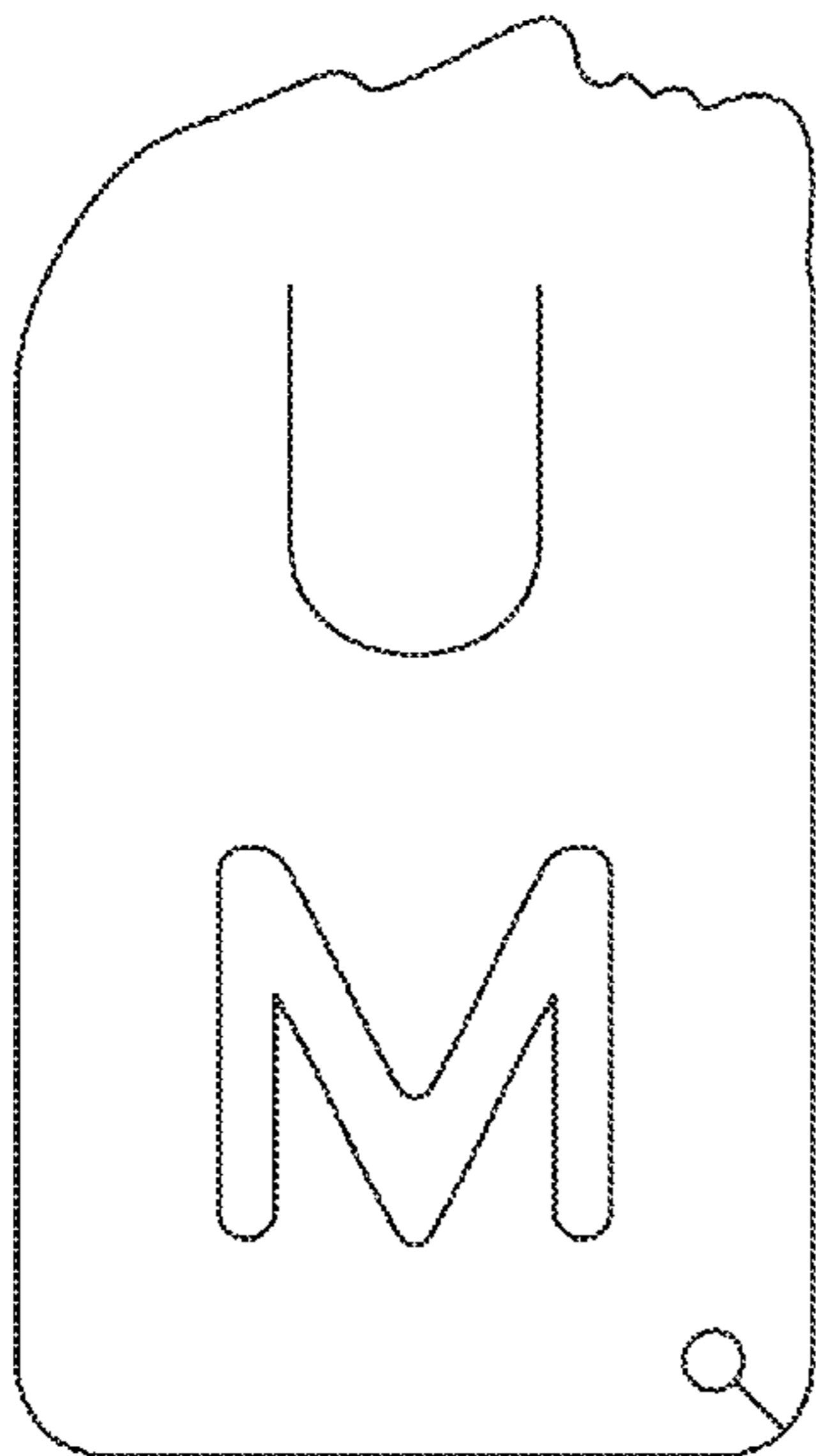
FIG. 4 is a left side view of the organizer clip shown in FIG. 1;

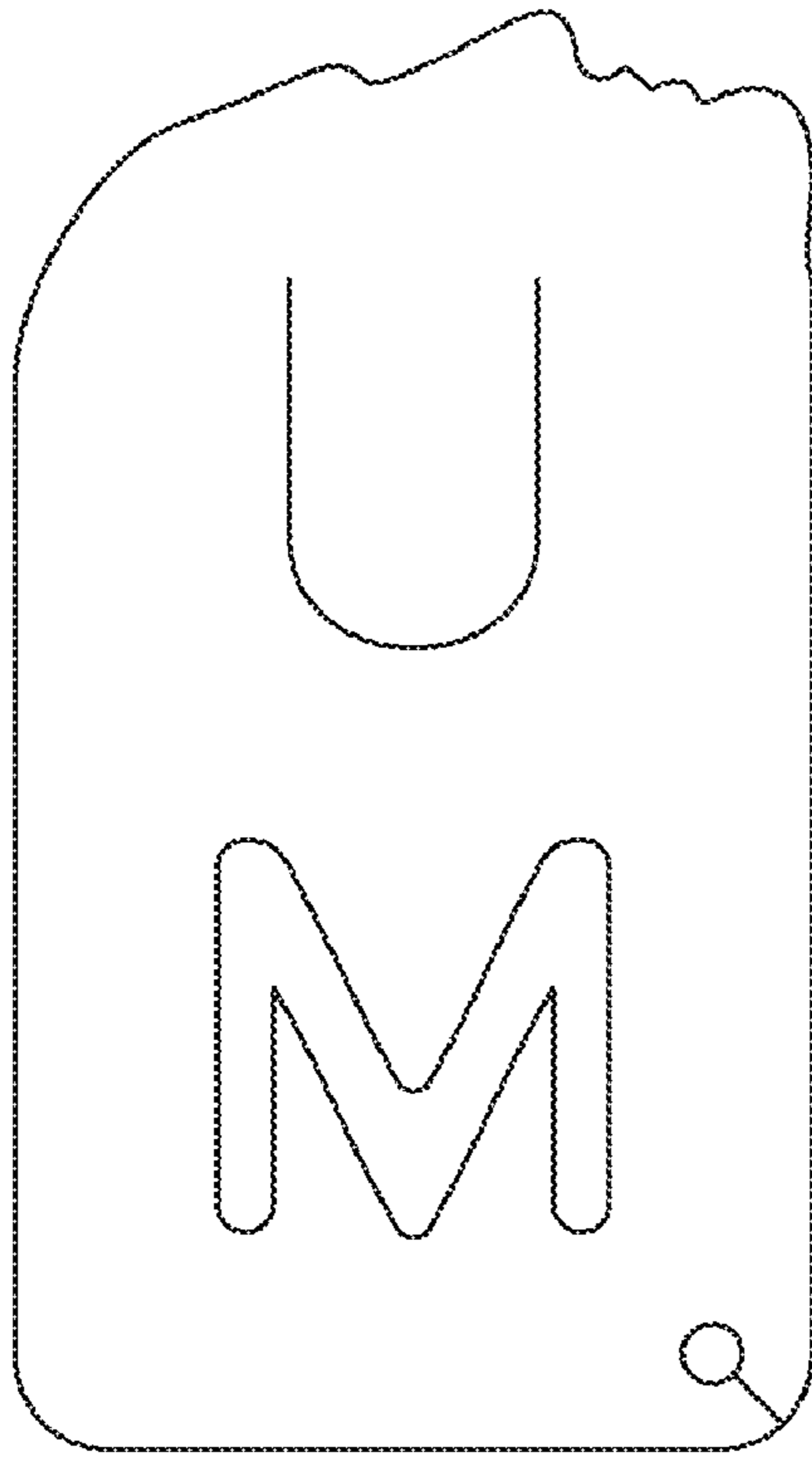

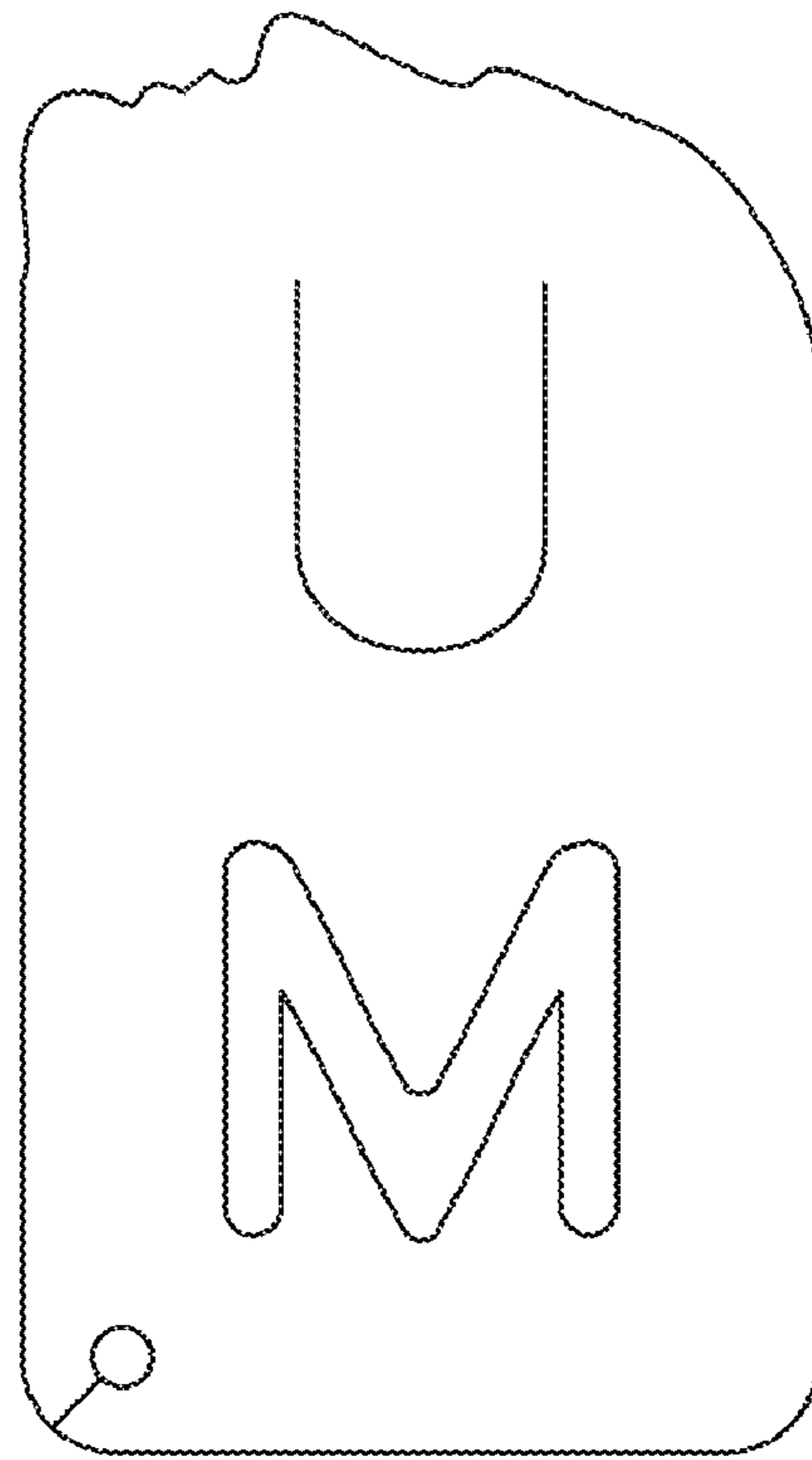

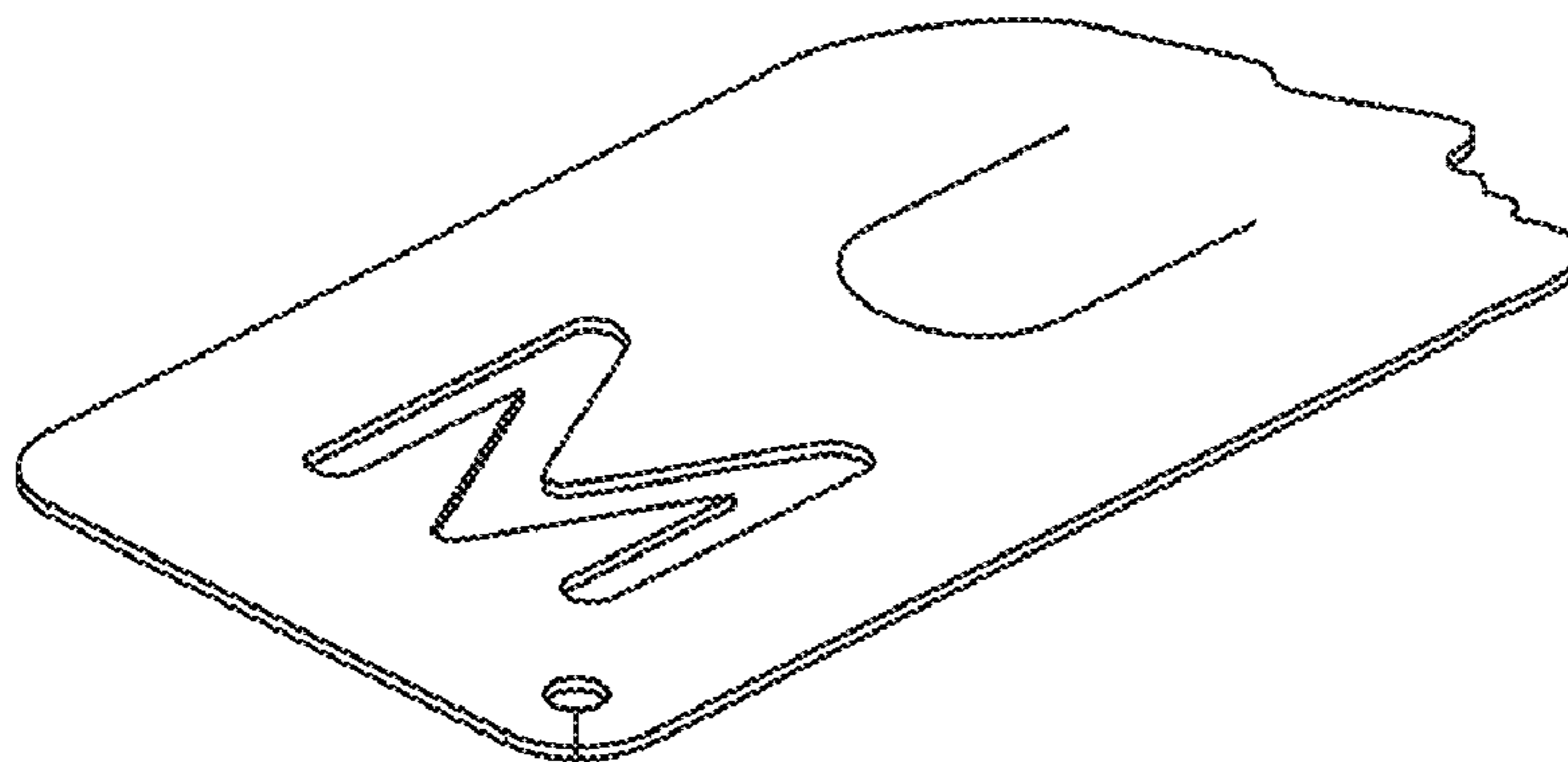

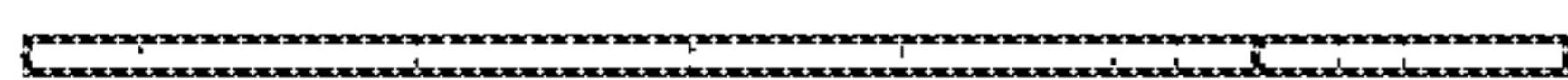
