(57) **CLAIM**

The ornamental design for an organizer clip, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an organizer clip in accordance with a preferred embodiment of my new design;

FIG. 2 is a rear view of the organizer clip shown in FIG. 1;

FIG. 3 is a perspective view of the organizer clip shown in FIG. 1;

FIG. 4 is a left side view of the organizer clip shown in FIG. 1;

FIG. 5 is a right side view of the organizer clip shown in FIG. 1;

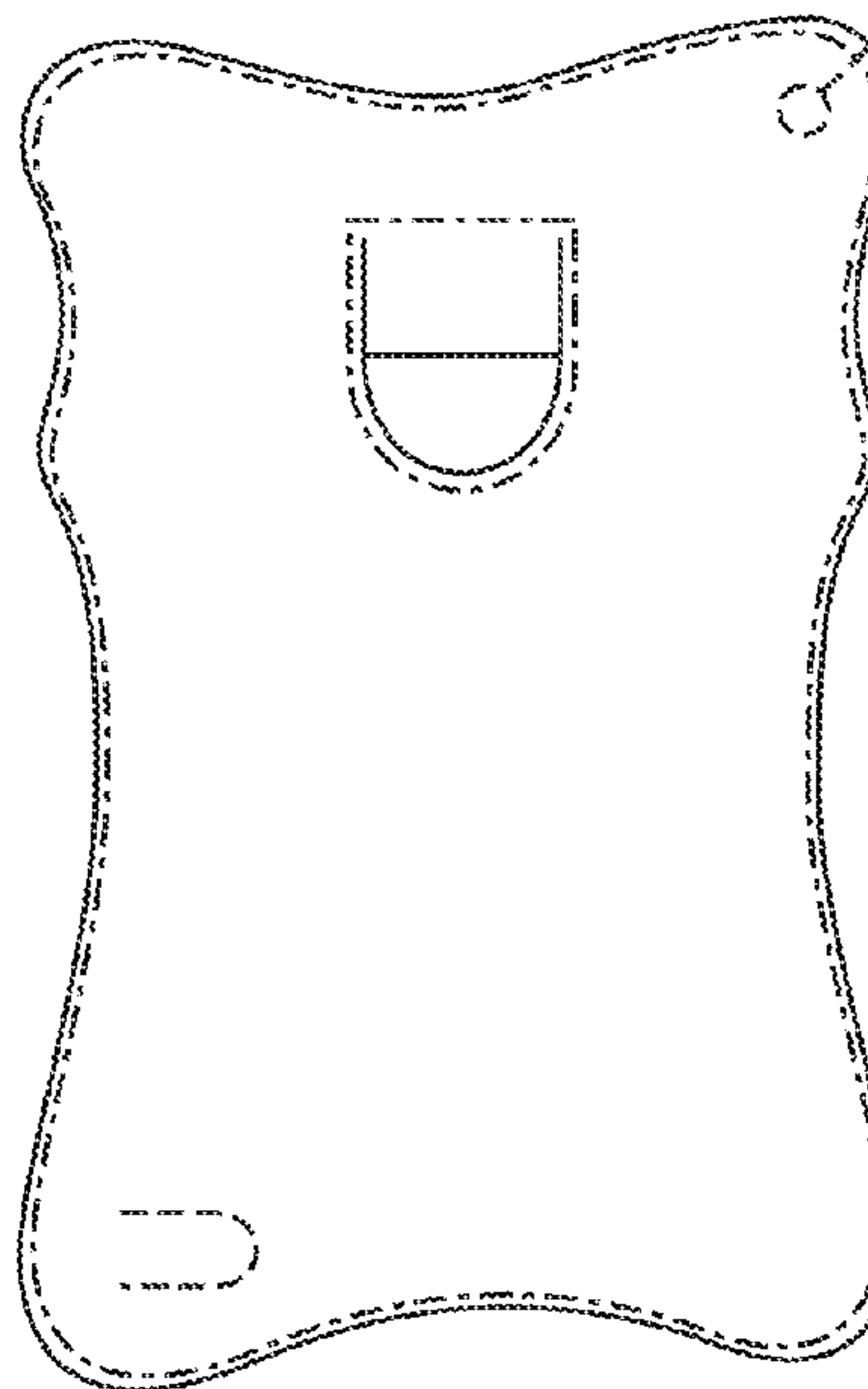
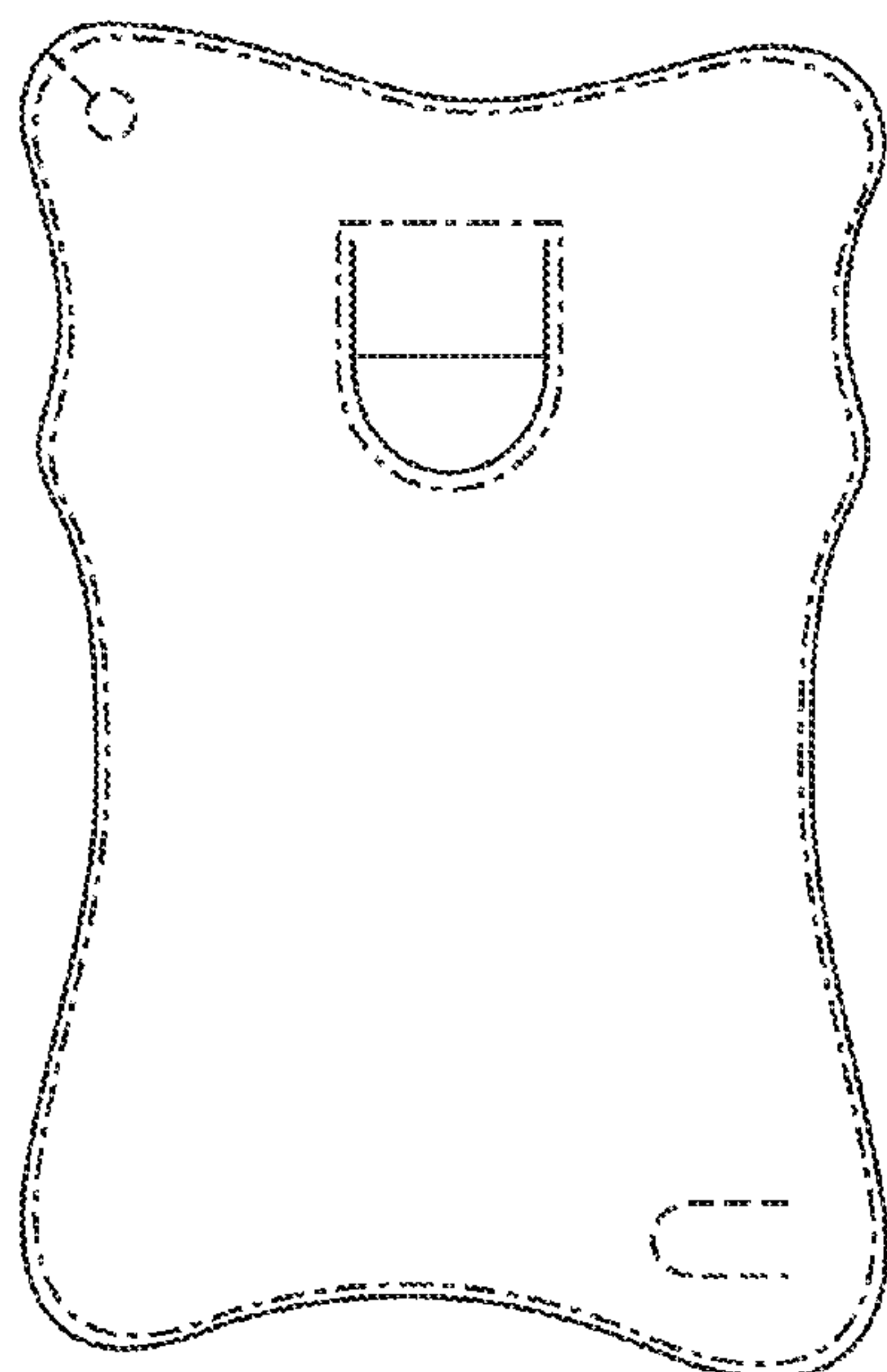
FIG. 6 is a top view of the organizer clip shown in FIG. 1; and,

FIG. 7 is a bottom view of the organizer clip shown in FIG. 1.

The long and short broken lines around the edges and around the aperture in FIGS. 1, 2, and 3 define the bounds of the claimed design and form no part thereof.

The evenly spaced broken lines showing lines and features on the surface in FIGS. 1, 2, and 3 show portions of the organizer clip that form no part of the claimed design.

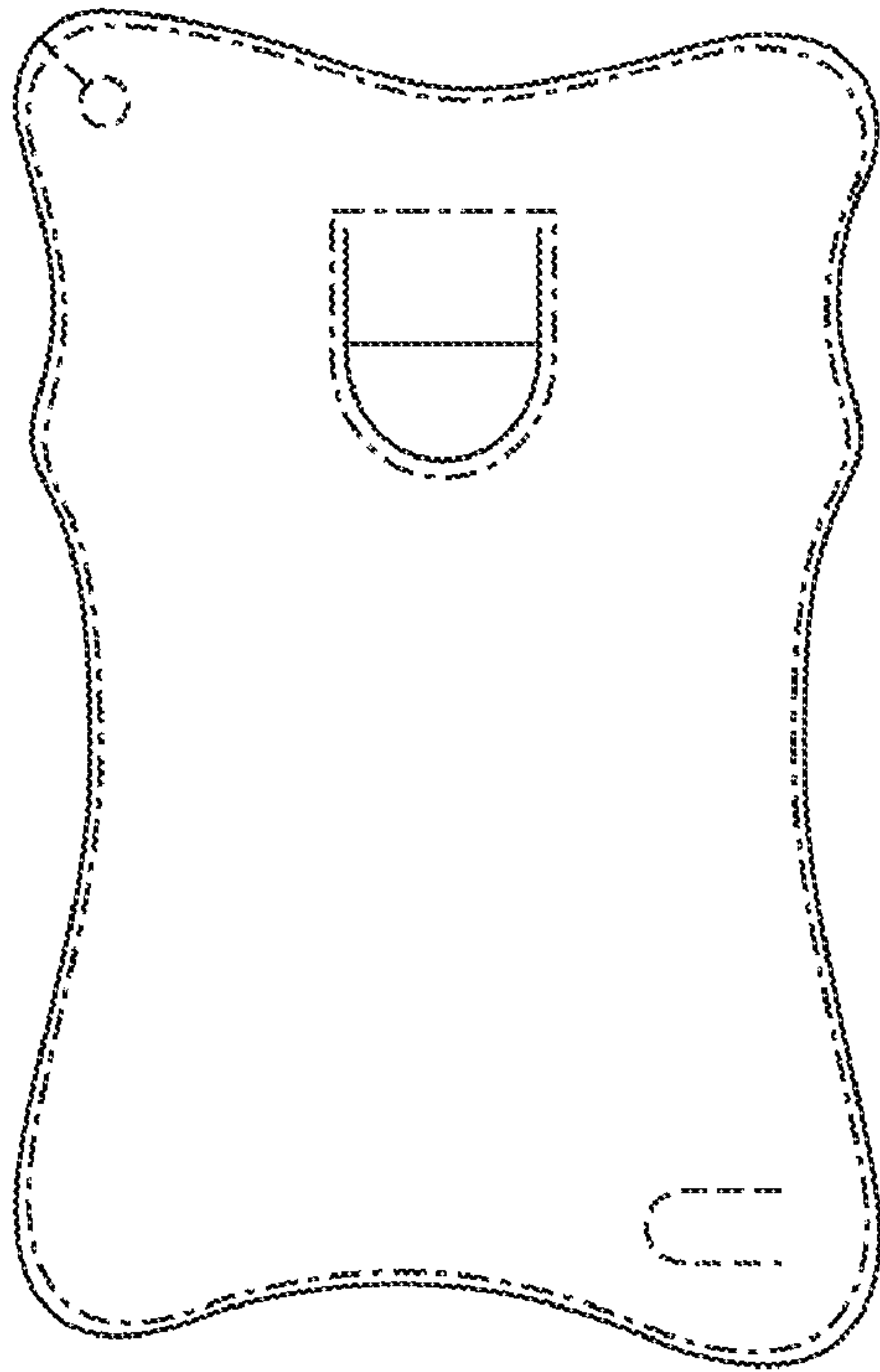

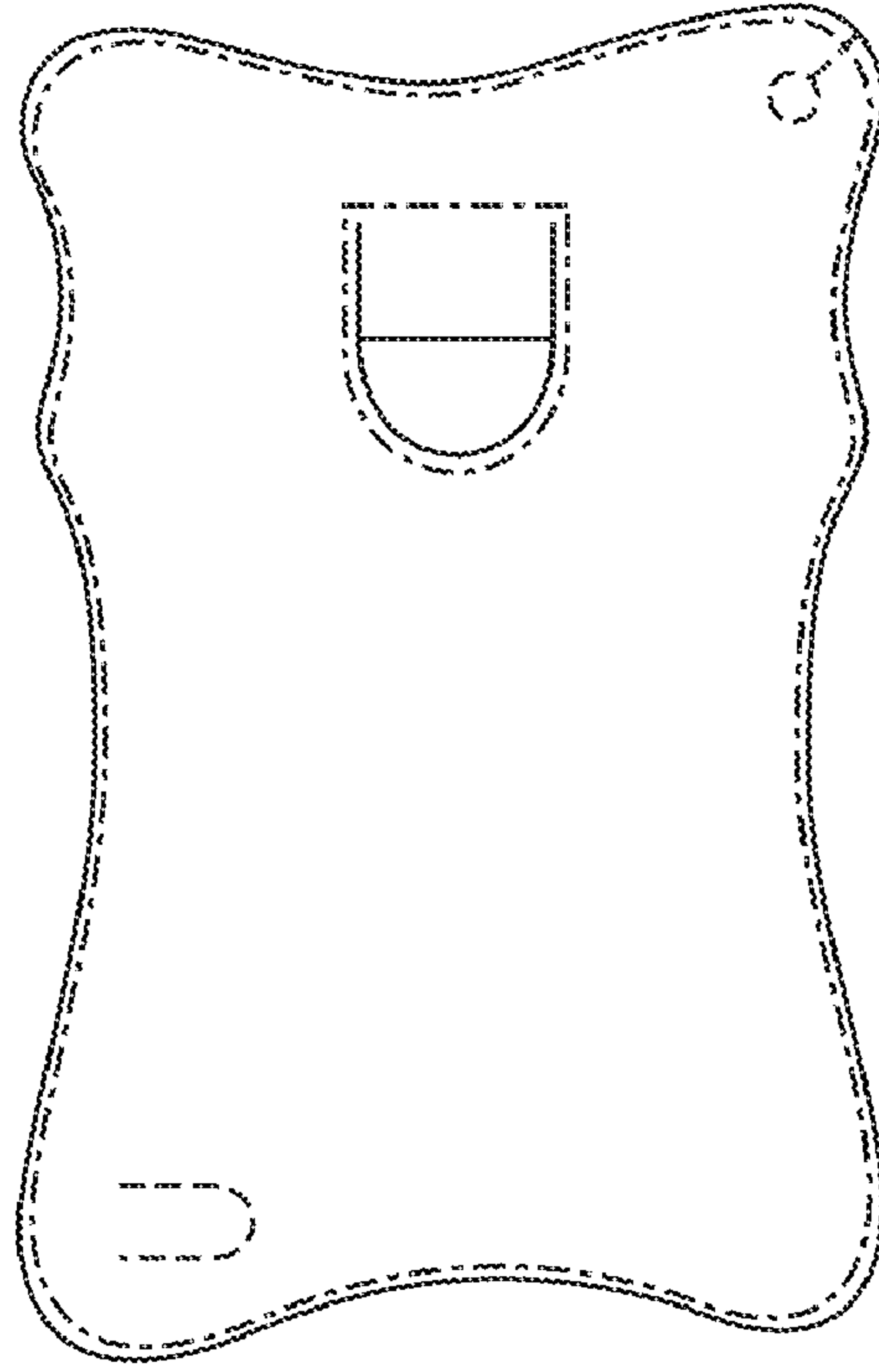

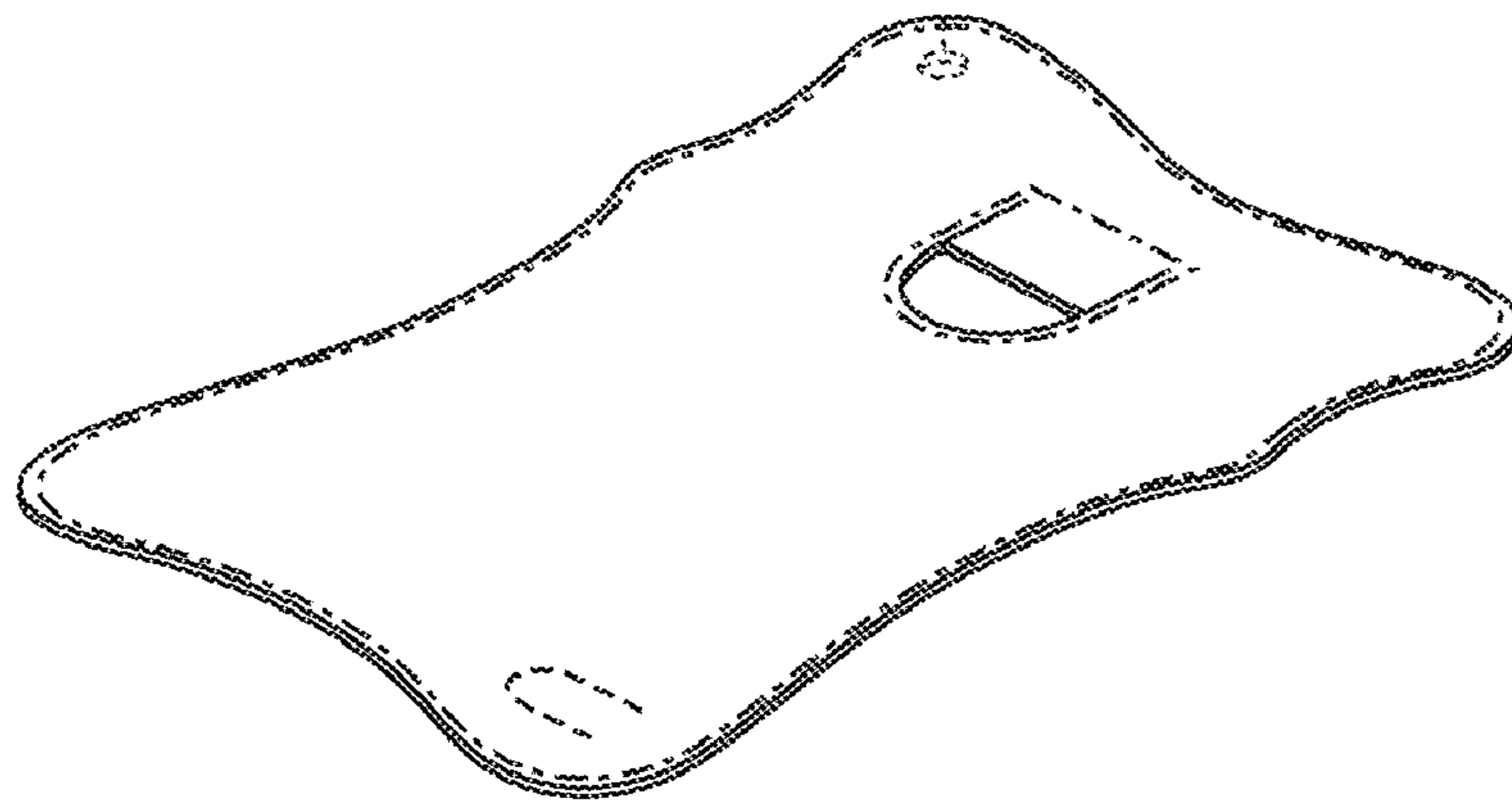

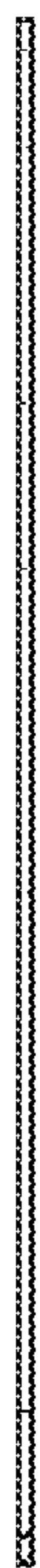
