(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a heel-side rear perspective view of a golf club head embodying the inventive design.

FIG. 2 is a toe-side rear perspective view thereof.

FIG. 3 is a rear elevational view thereof.

FIG. 4 is a top plan view thereof.

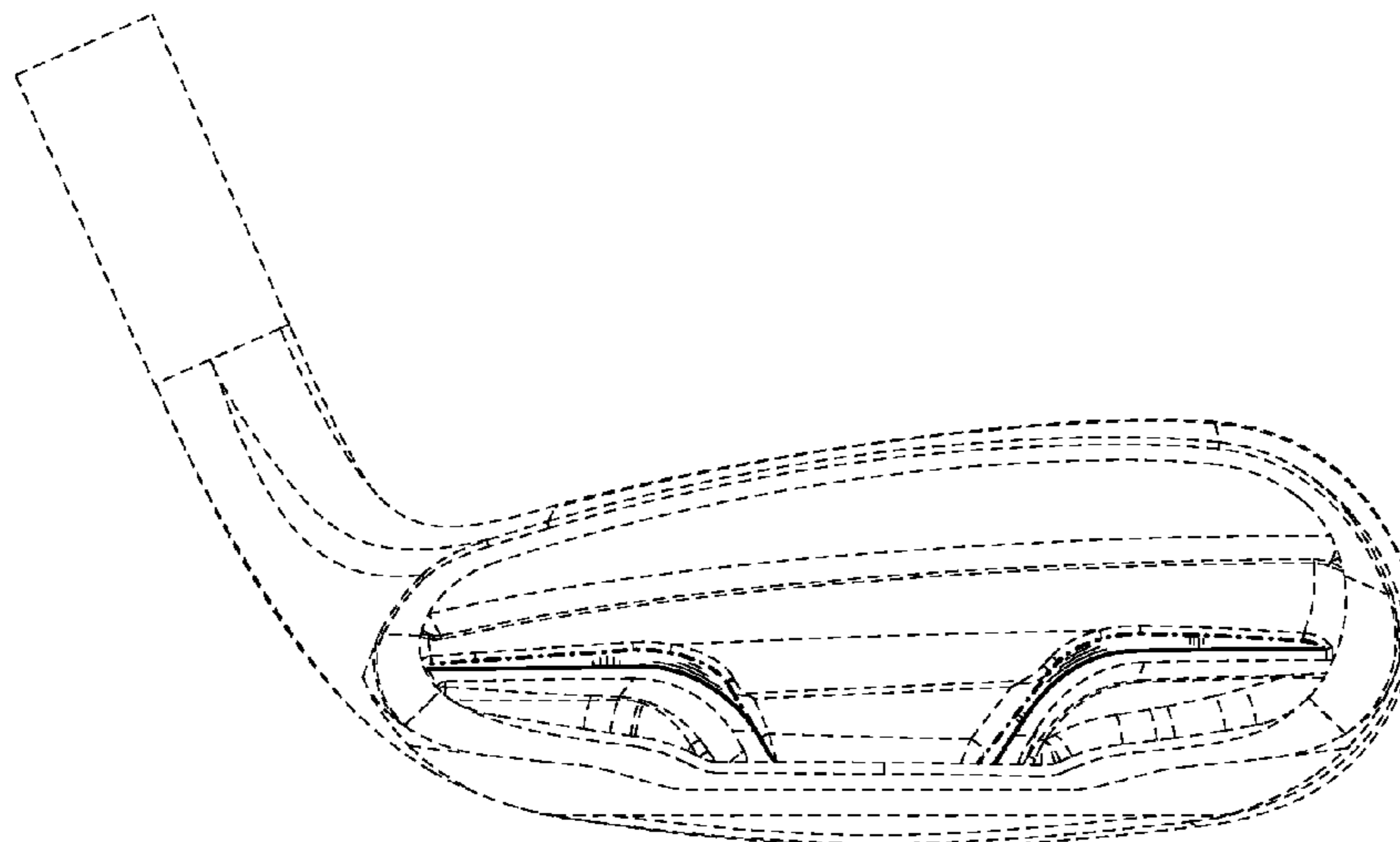
FIG. 5 is a toe-side elevational view thereof.

FIG. 6 is a heel-side elevational view thereof; and,

FIG. 7 is a front elevational view thereof.

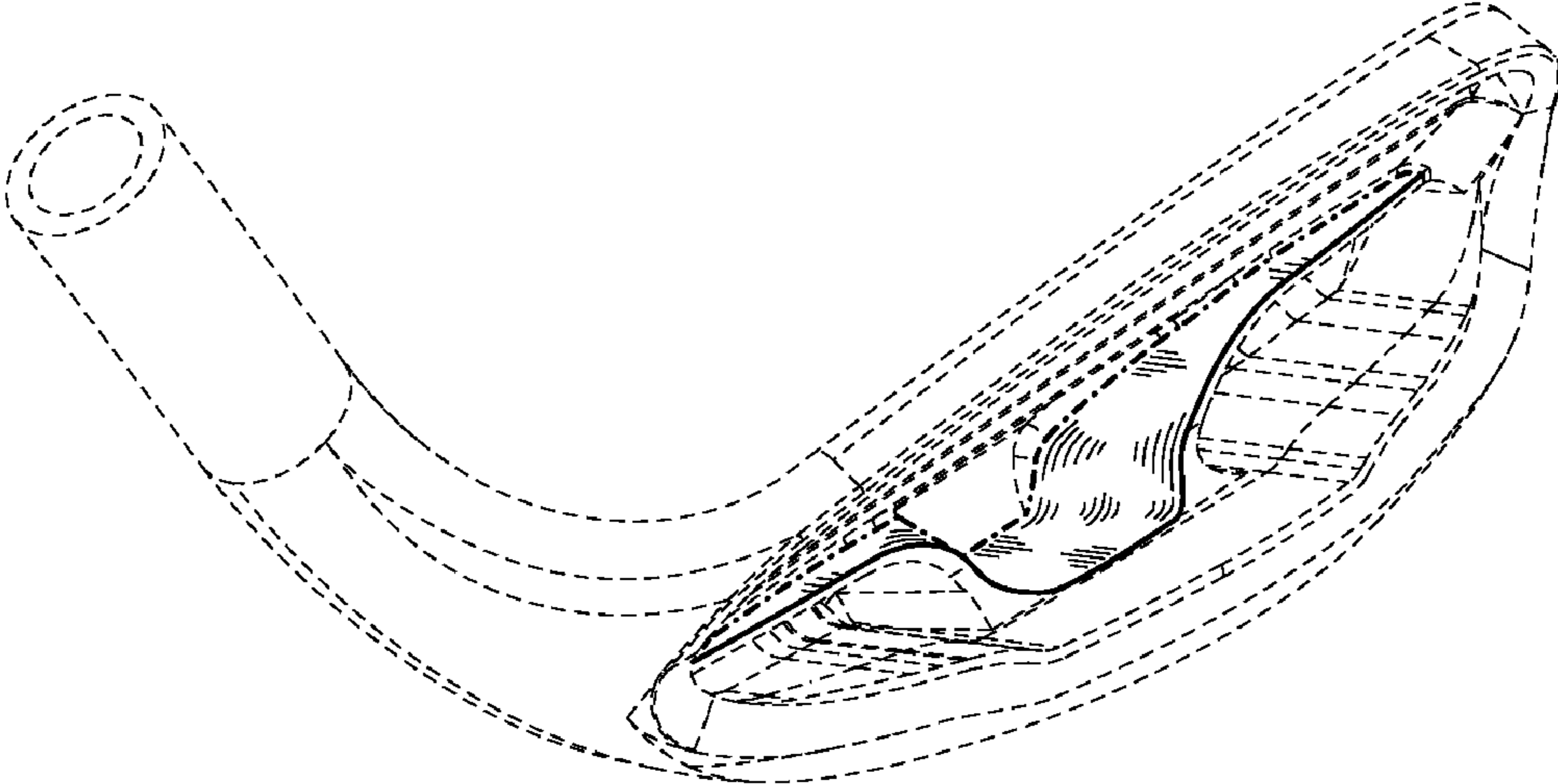

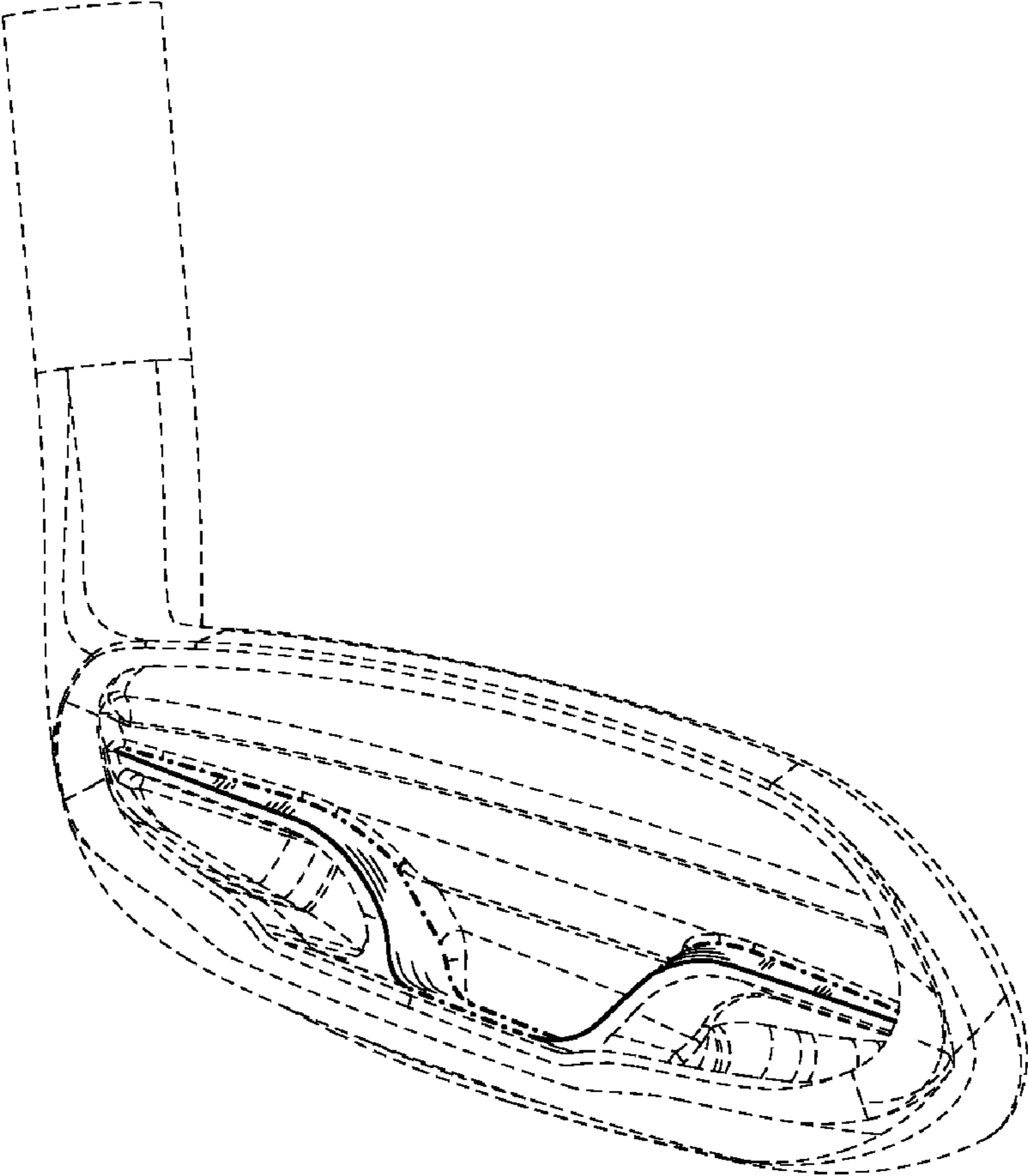

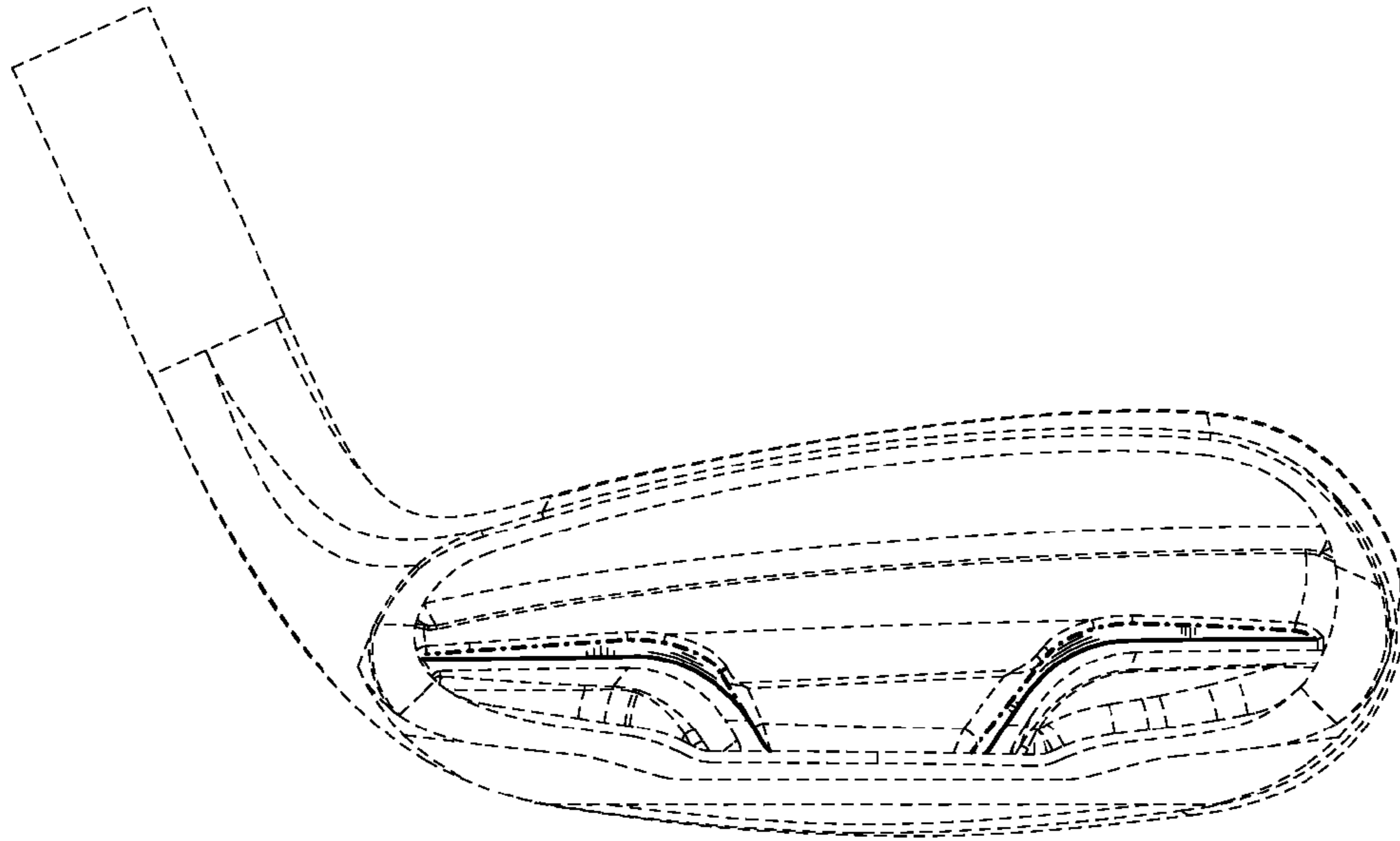

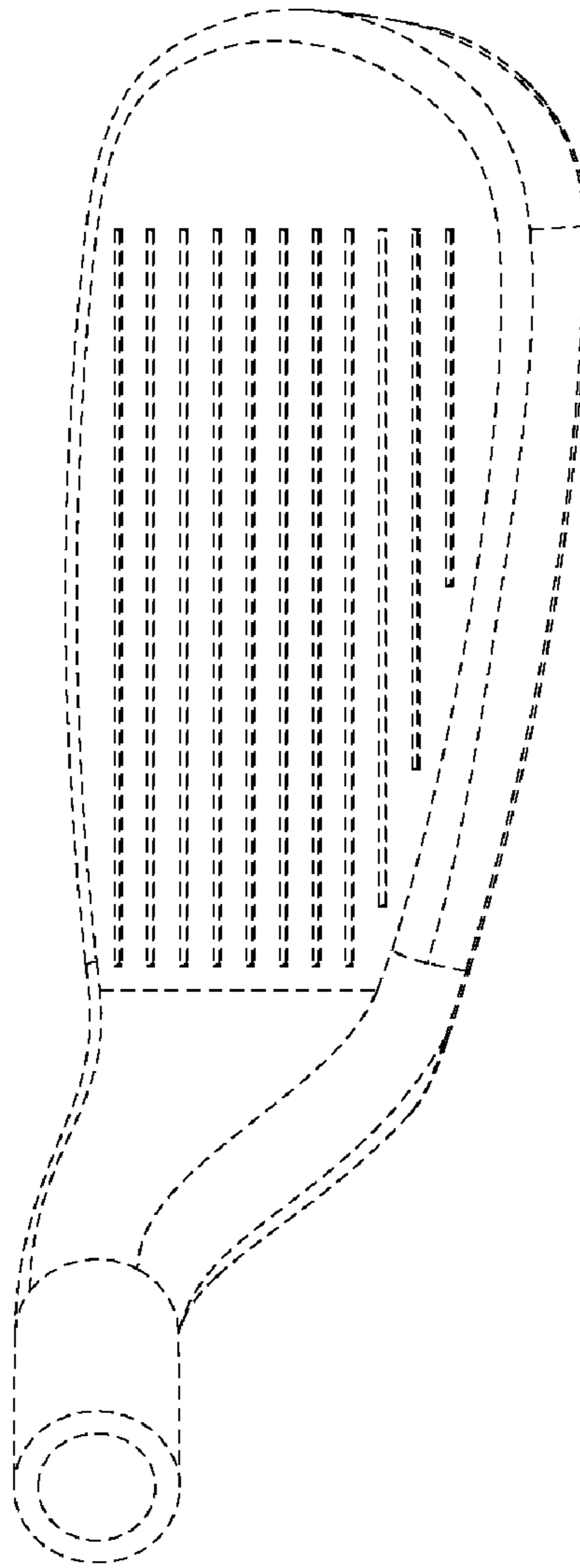

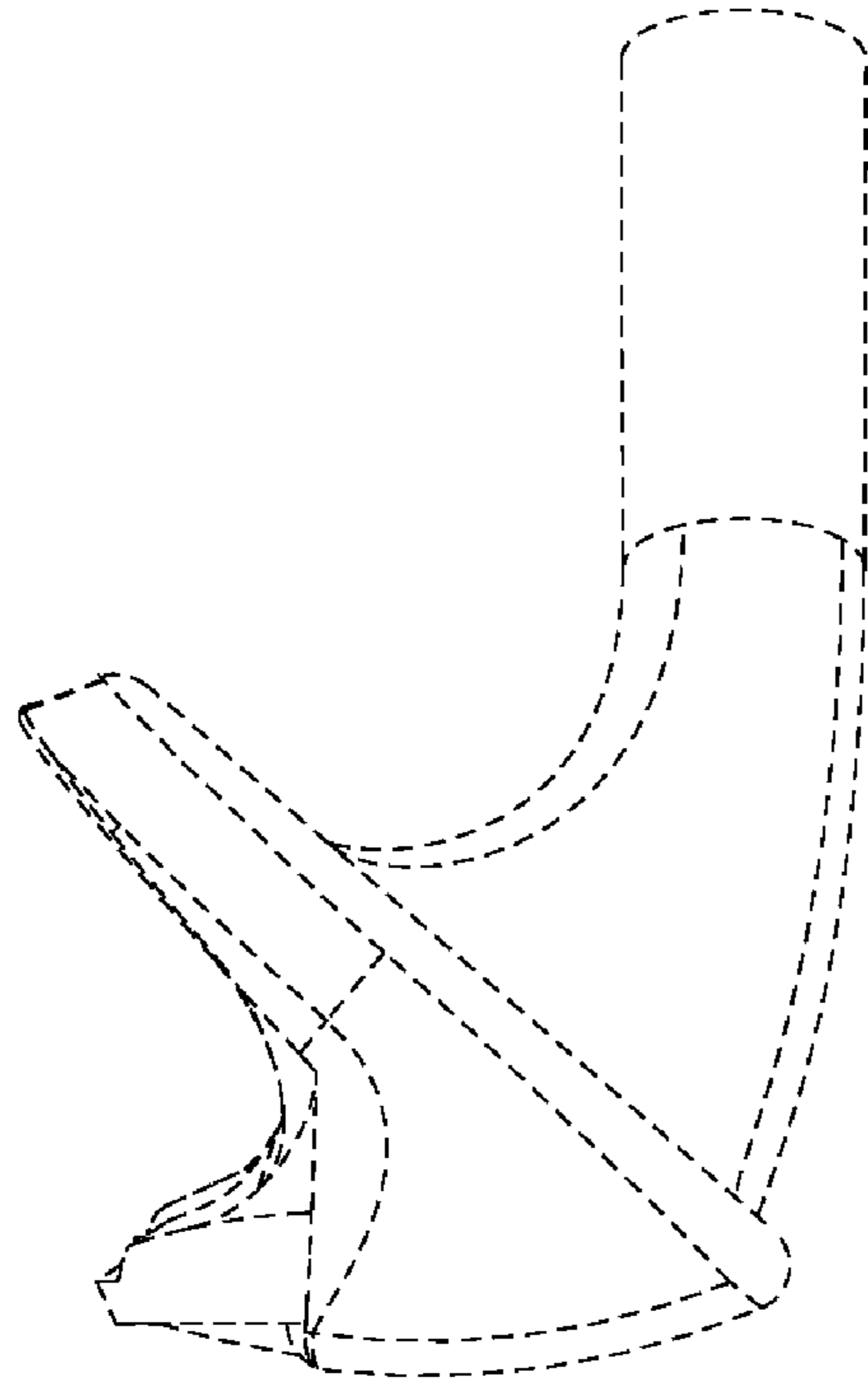

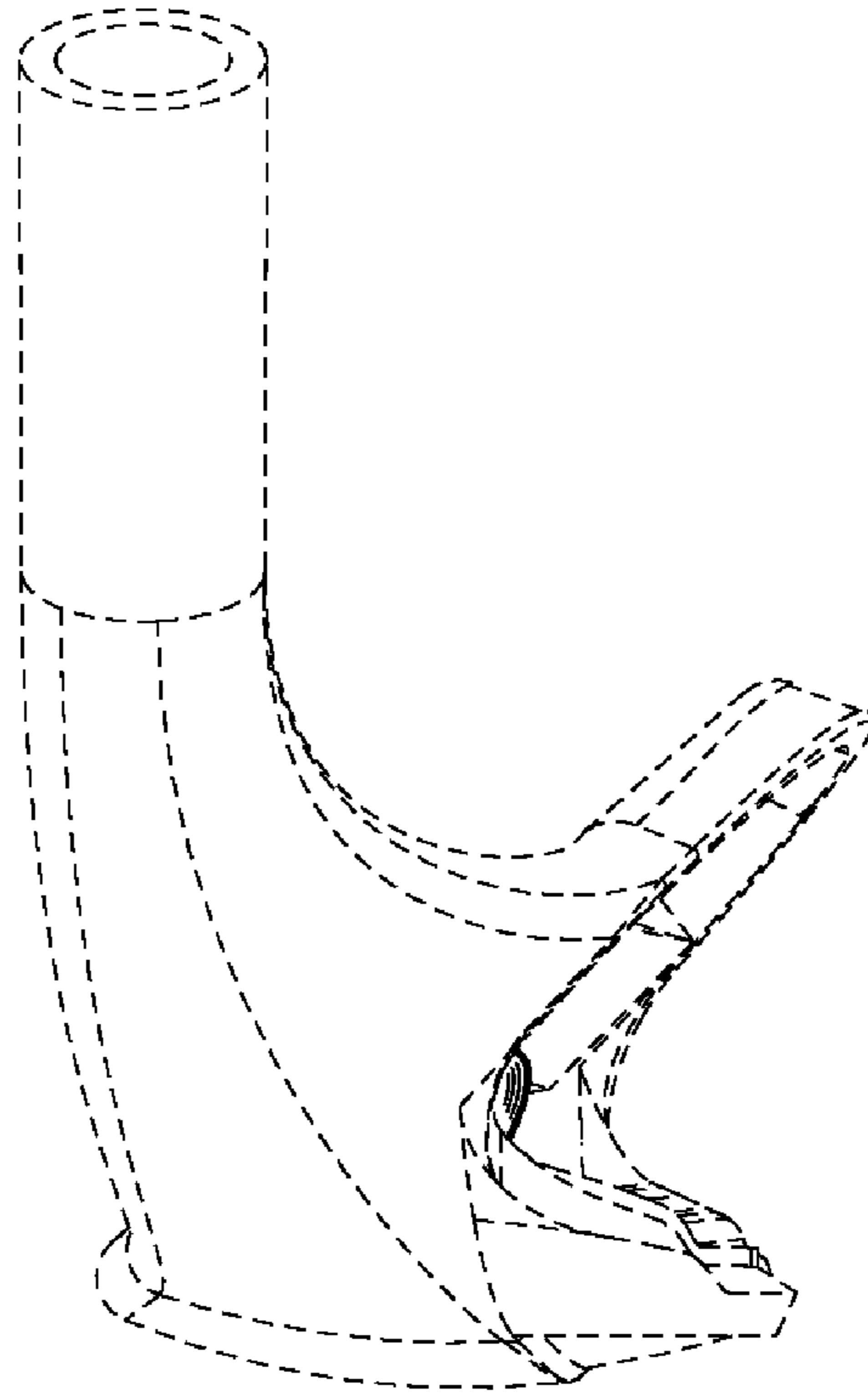

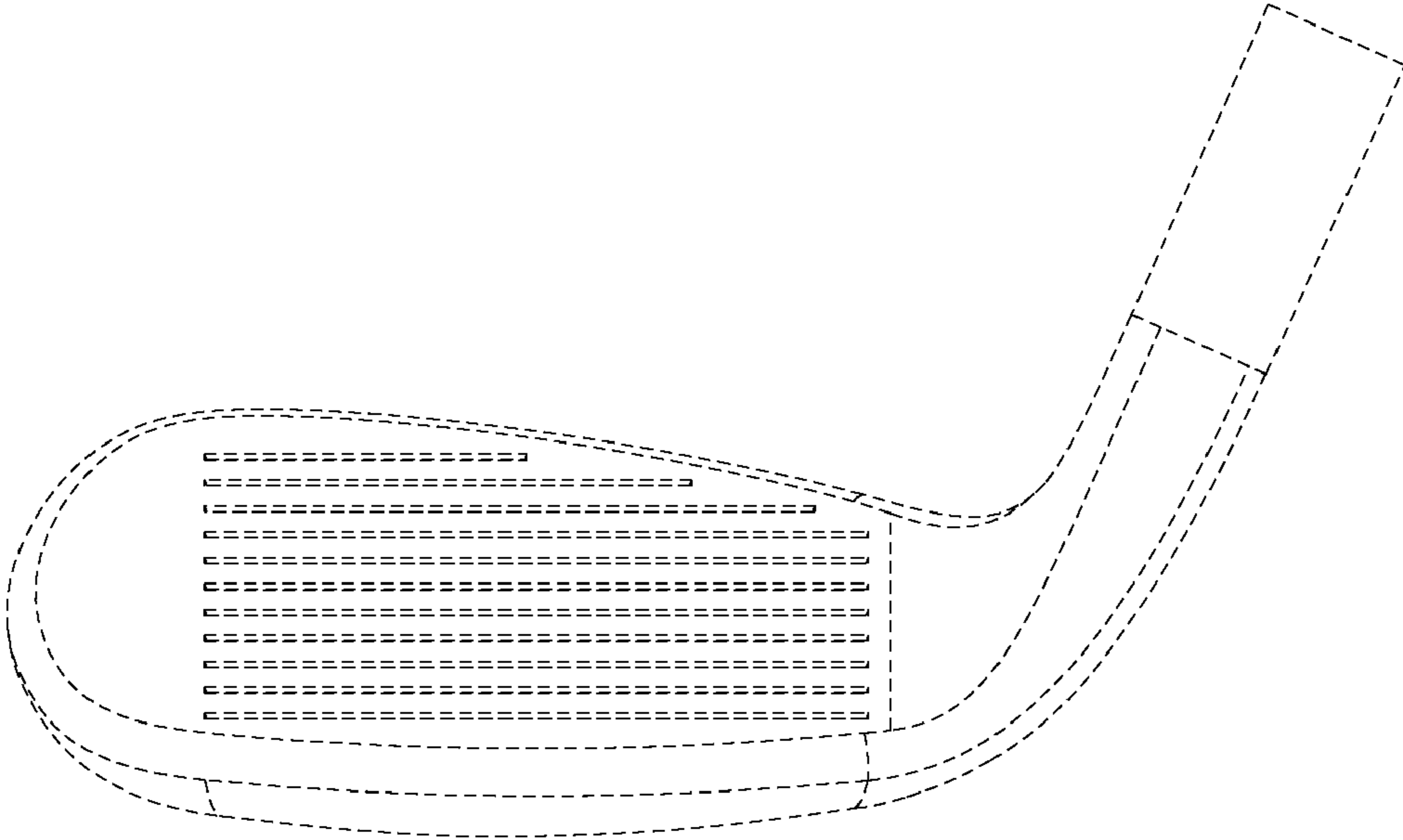
