(57) **CLAIM**

The ornamental design for a fishing pole carrier and stand, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a fishing pole carrier and stand showing our new design;

FIG. 2 is a front elevation thereof;

FIG. 3 is a side elevation thereof, the opposite side being a mirror image;

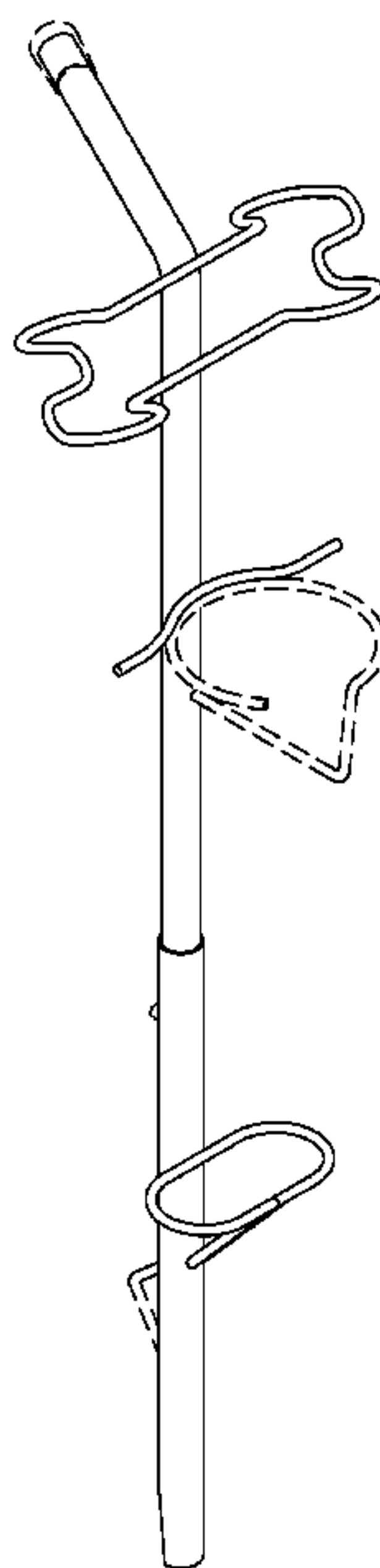
FIG. 4 is a rear elevation thereof;

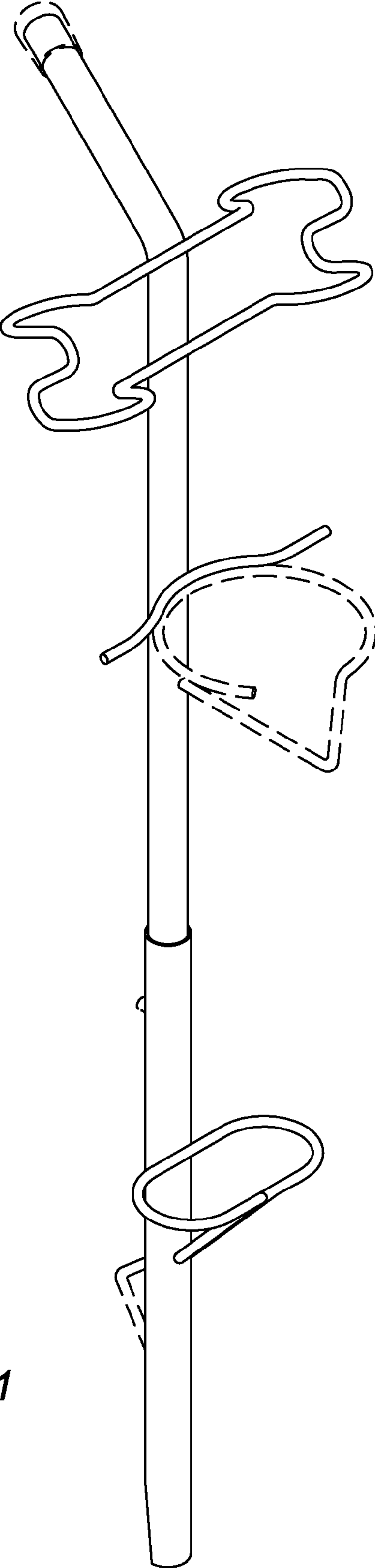

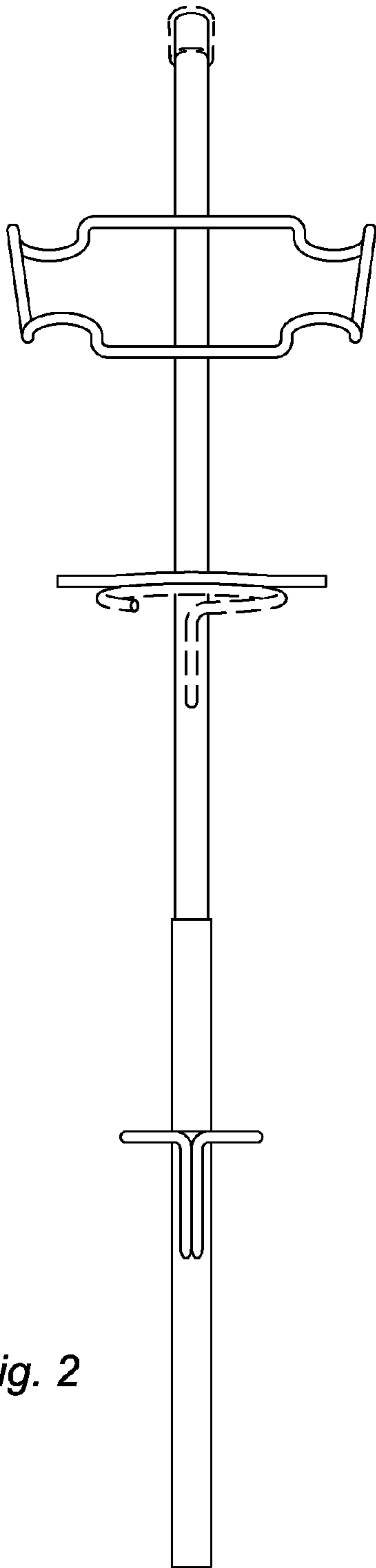

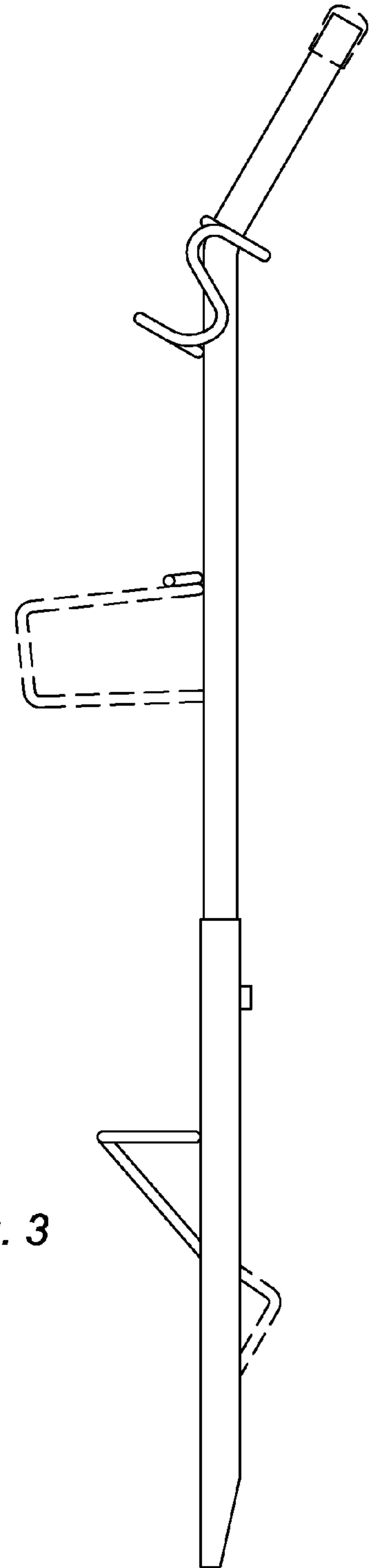
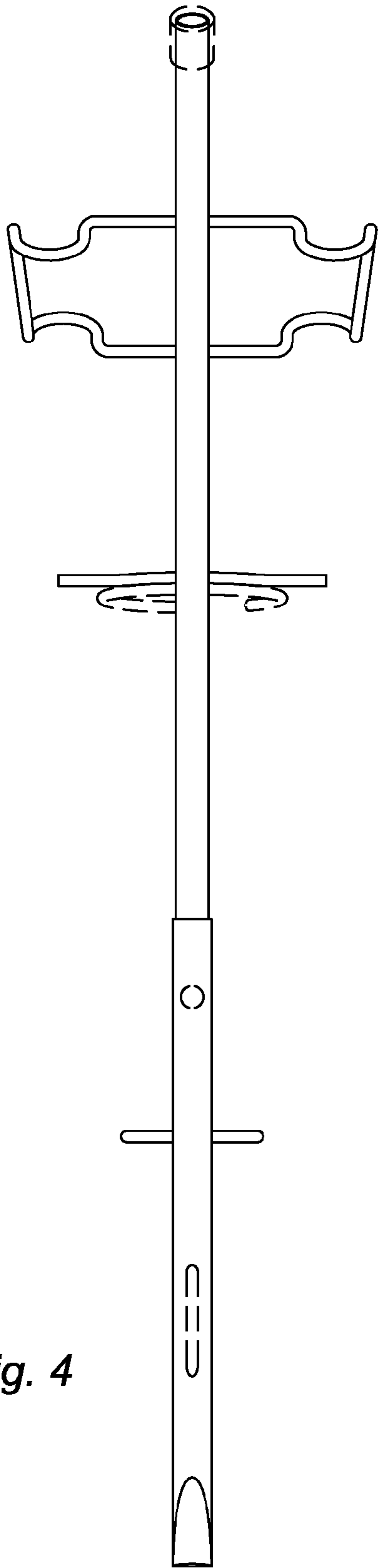
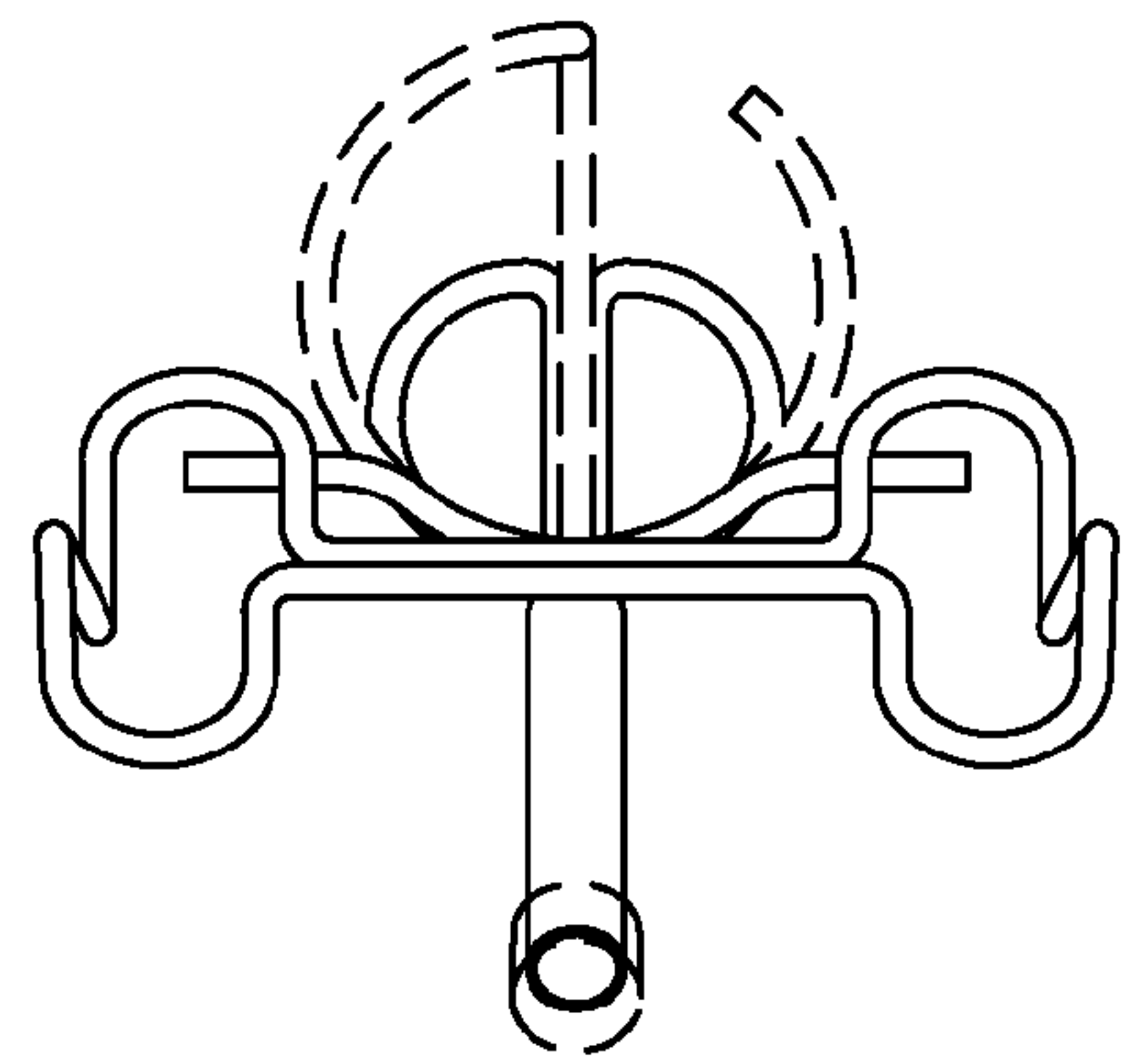


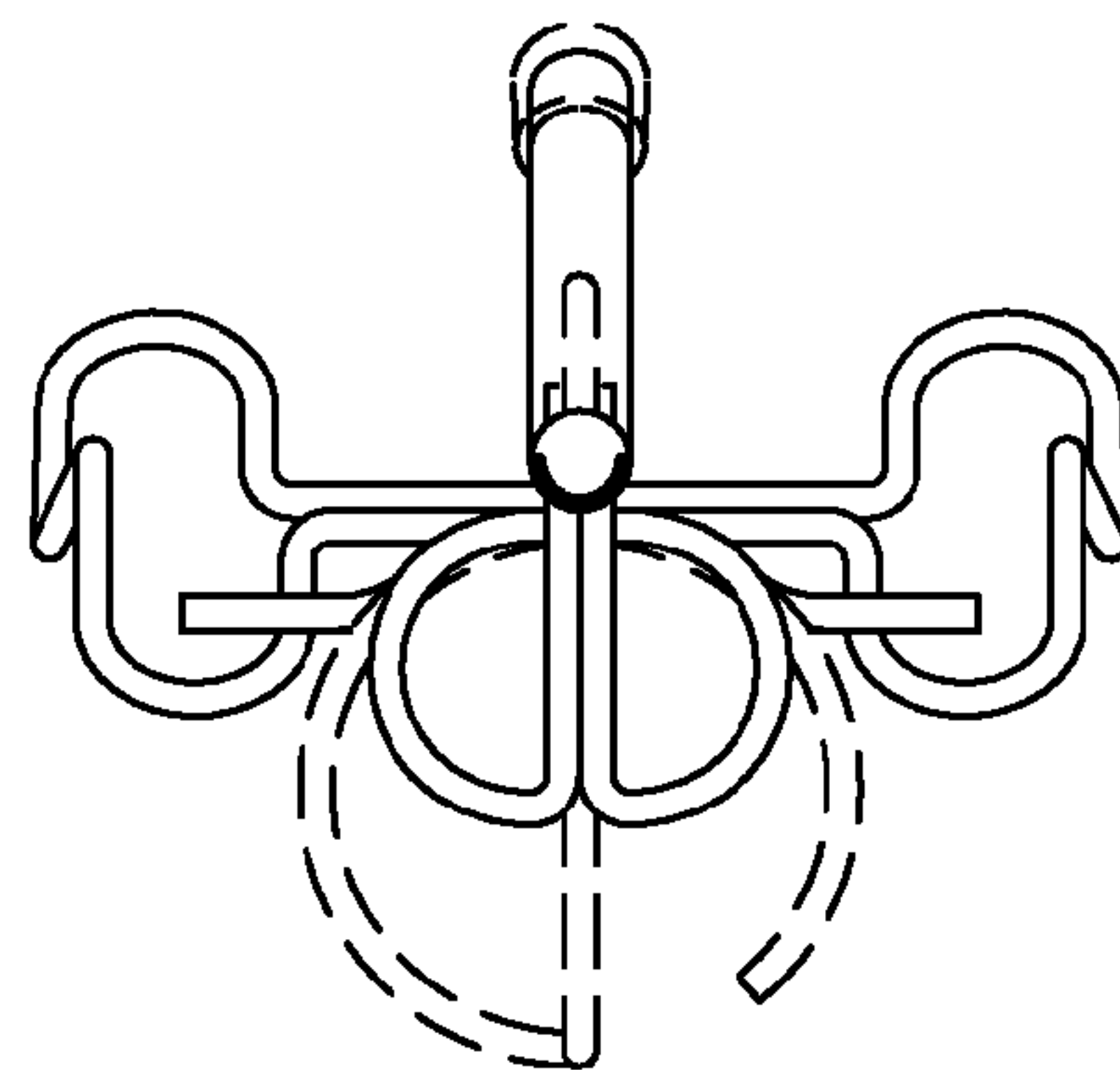
