FIG. 4 is a right side view of the fragrance dispenser shown in FIG. 1 showing our new design.

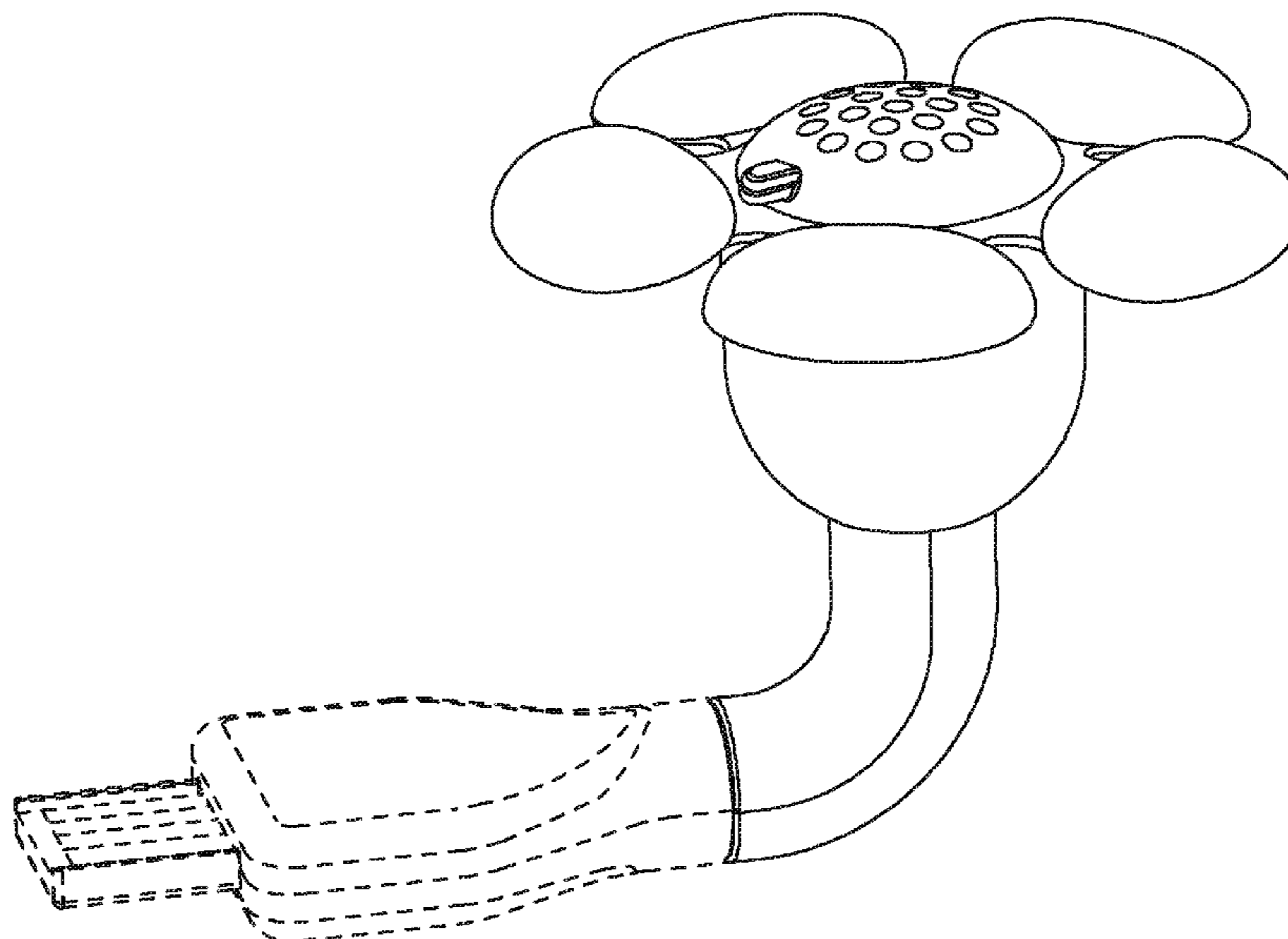
FIG. 5 is a back view of a fragrance dispenser shown in FIG. 1 showing our new design.

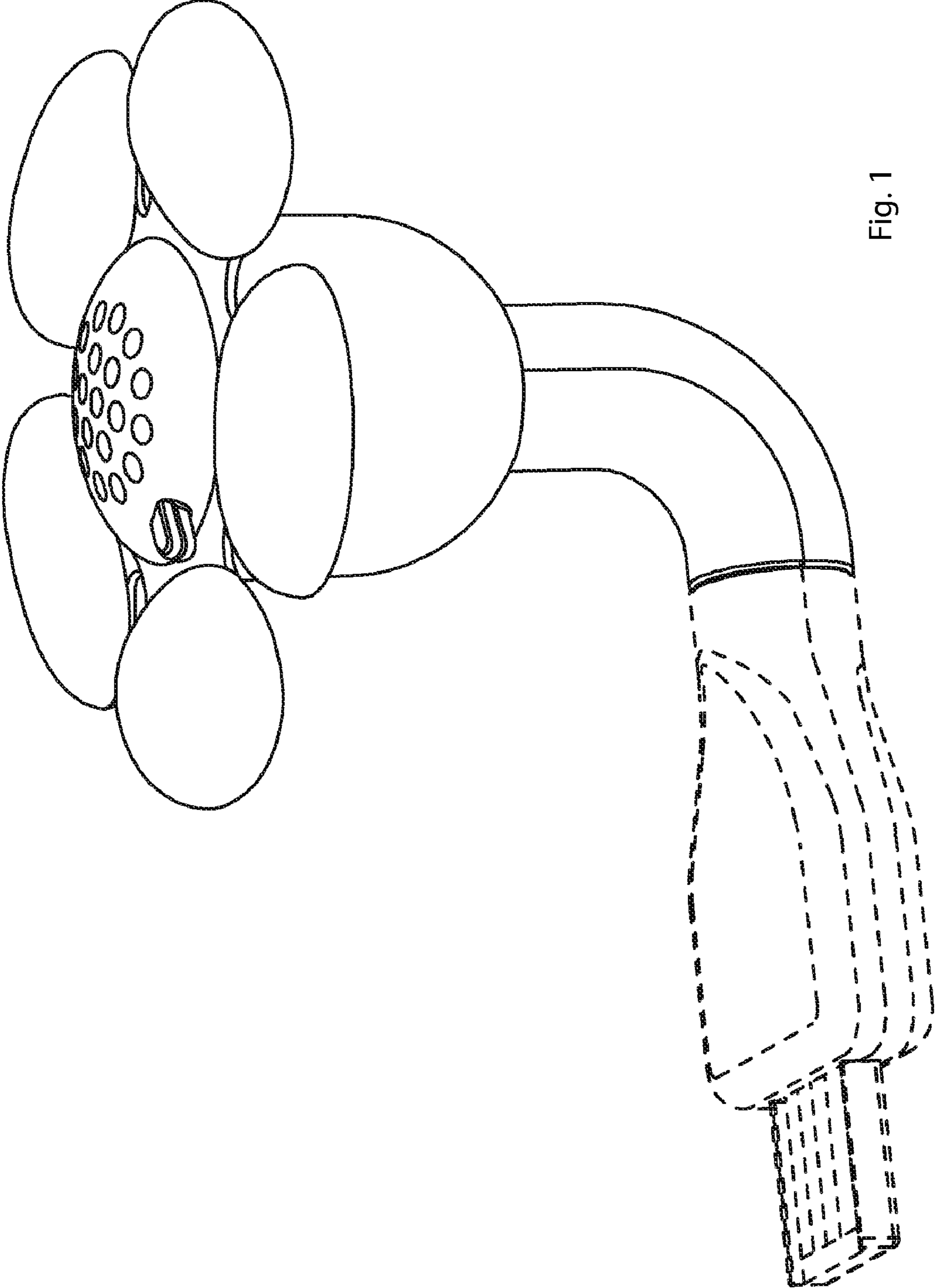

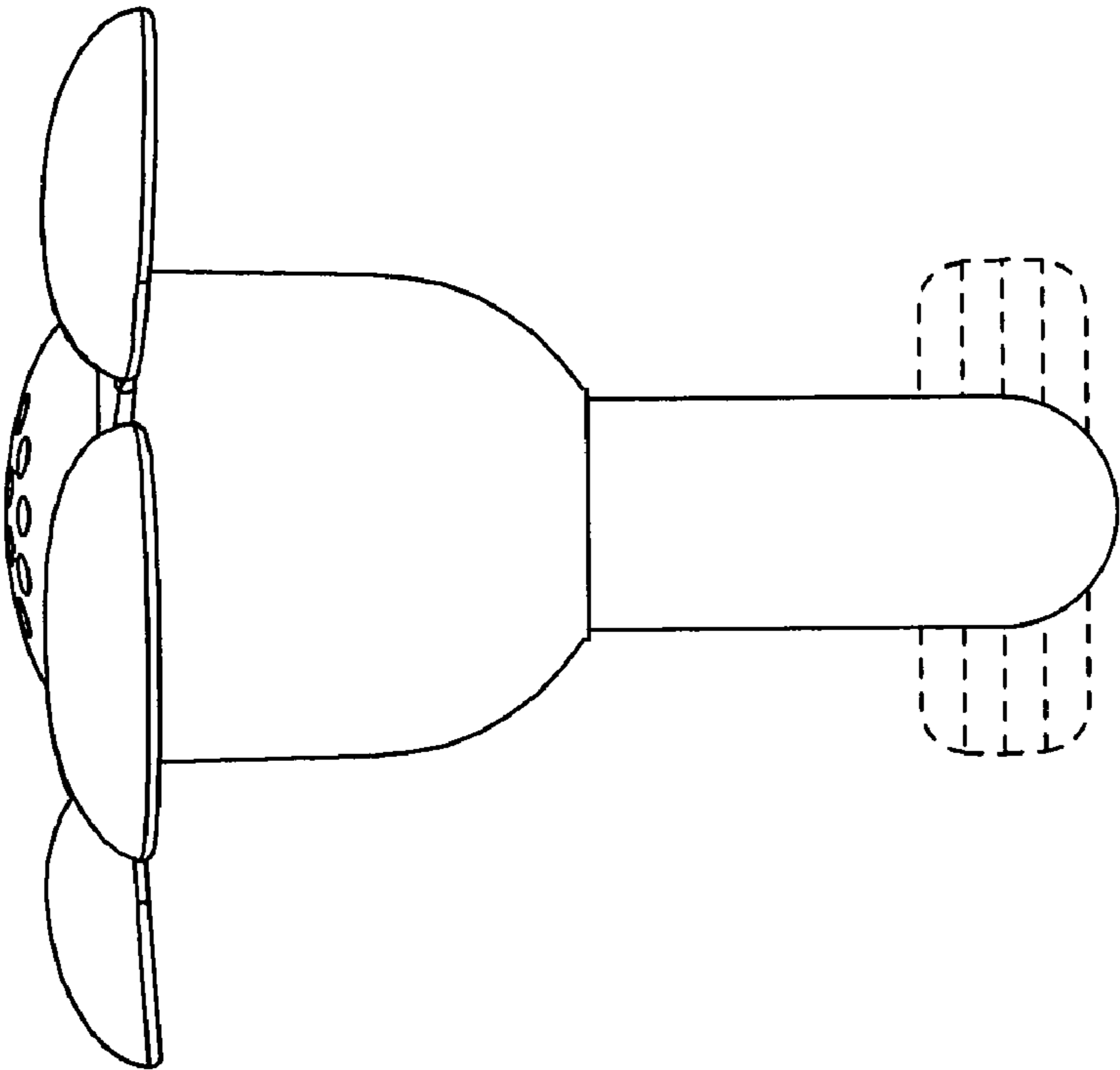

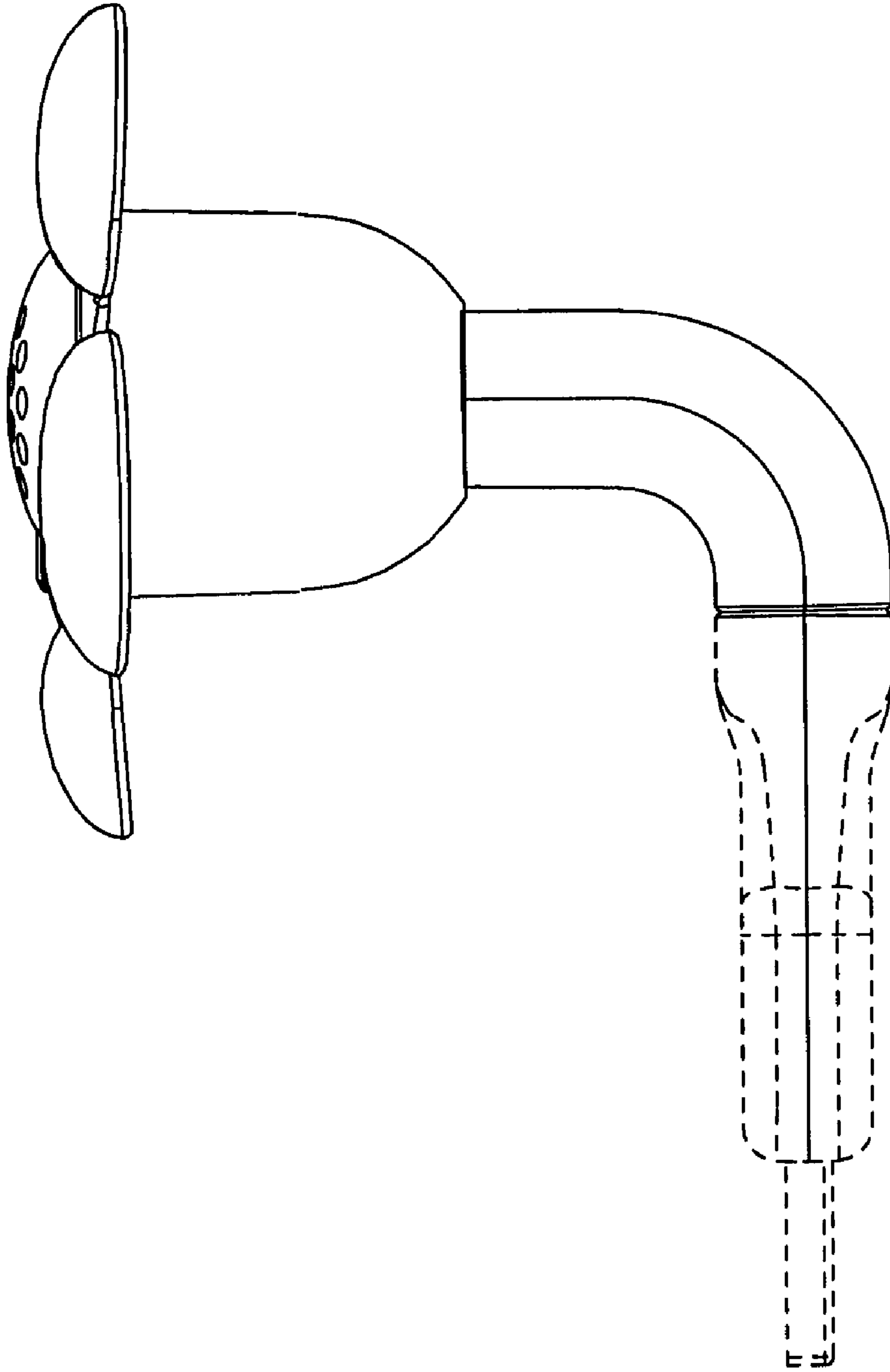

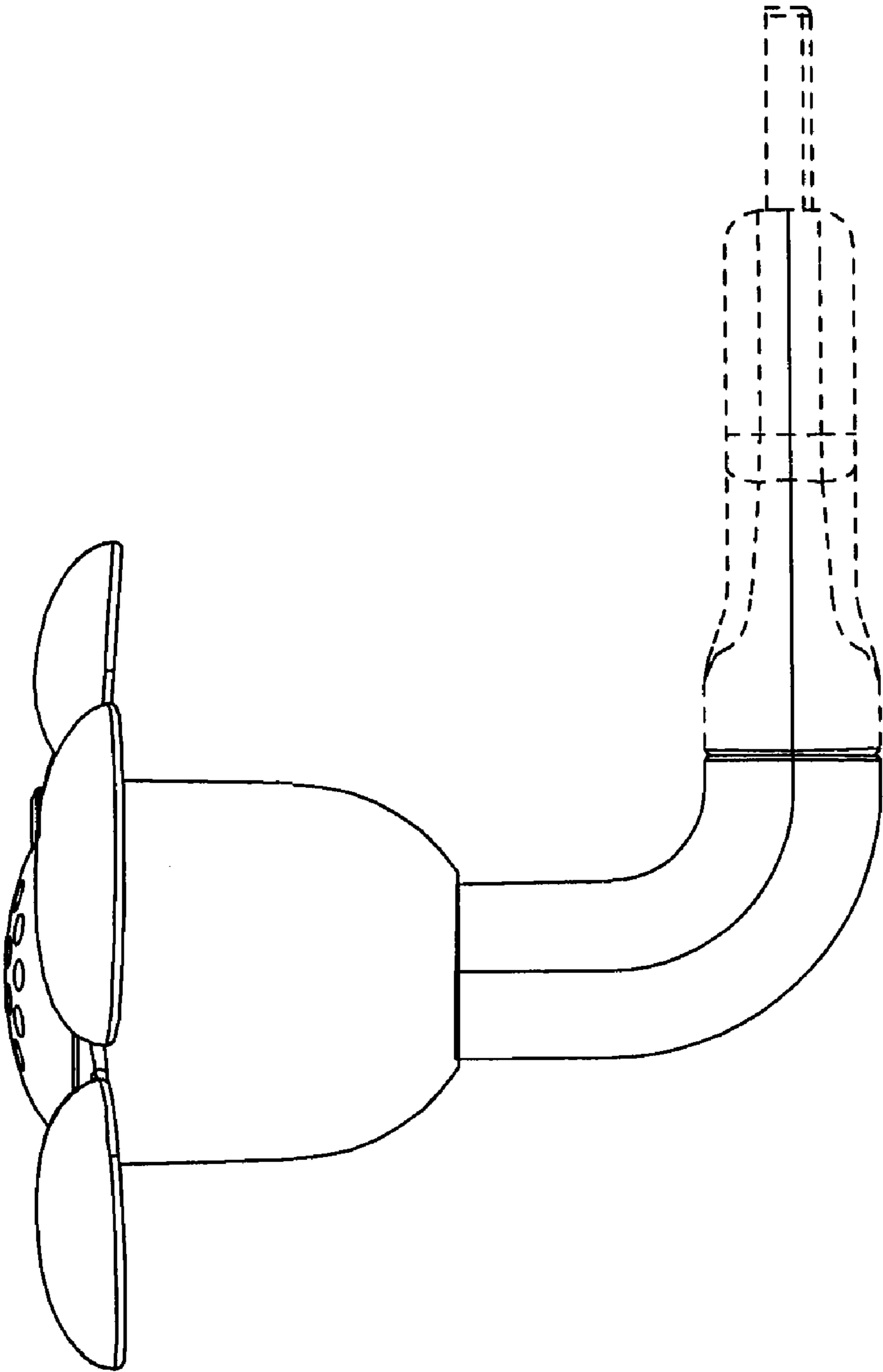

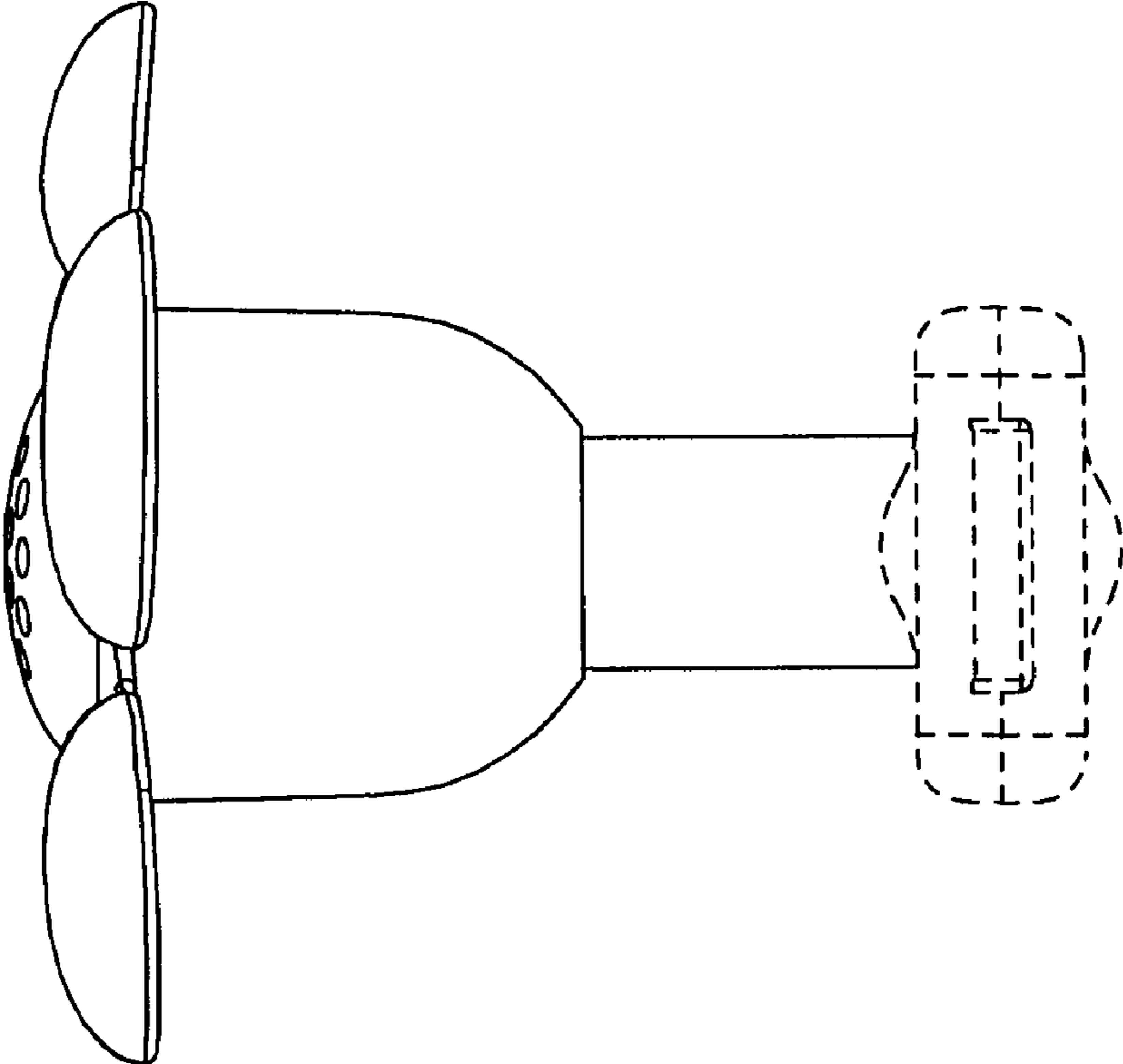

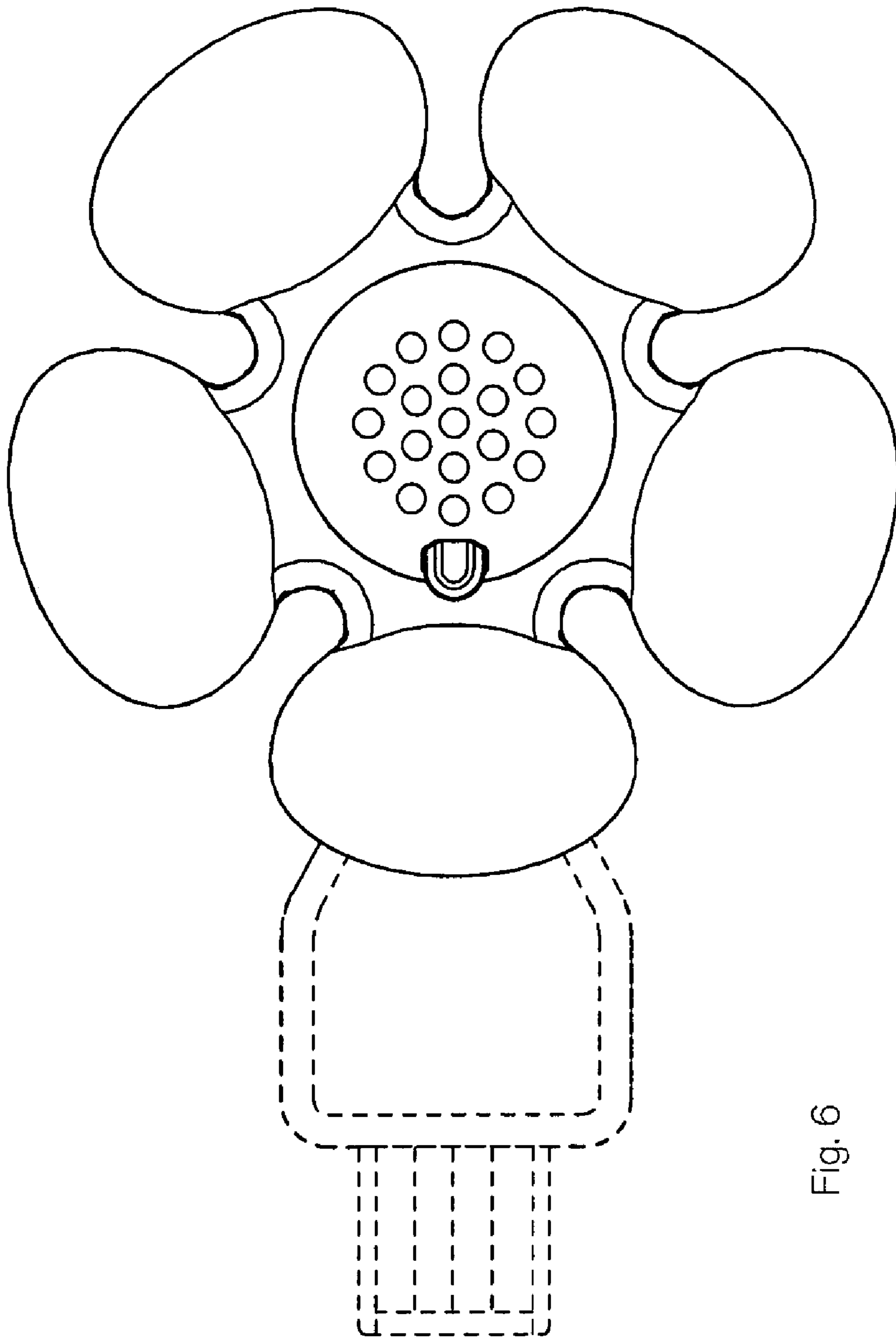

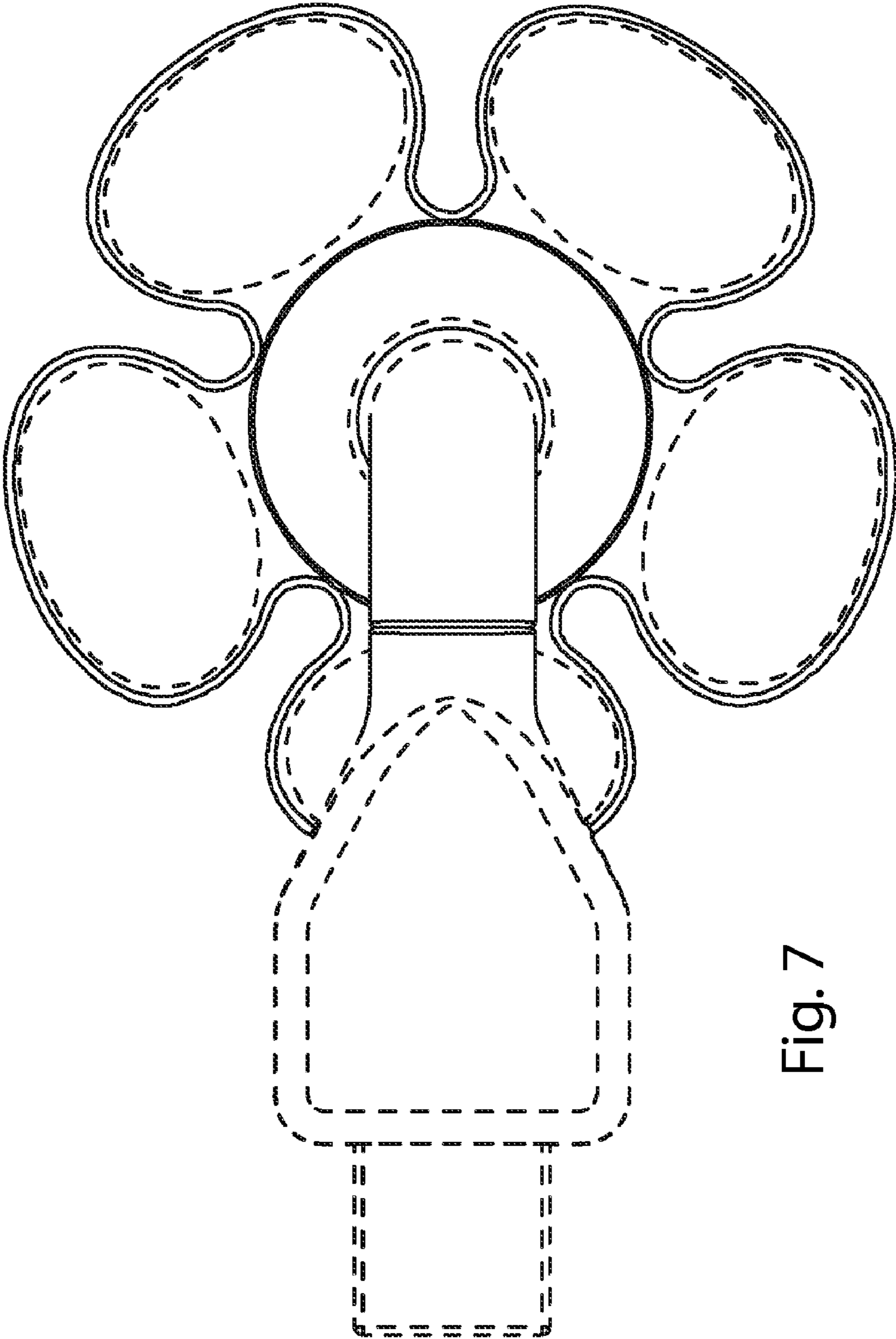
