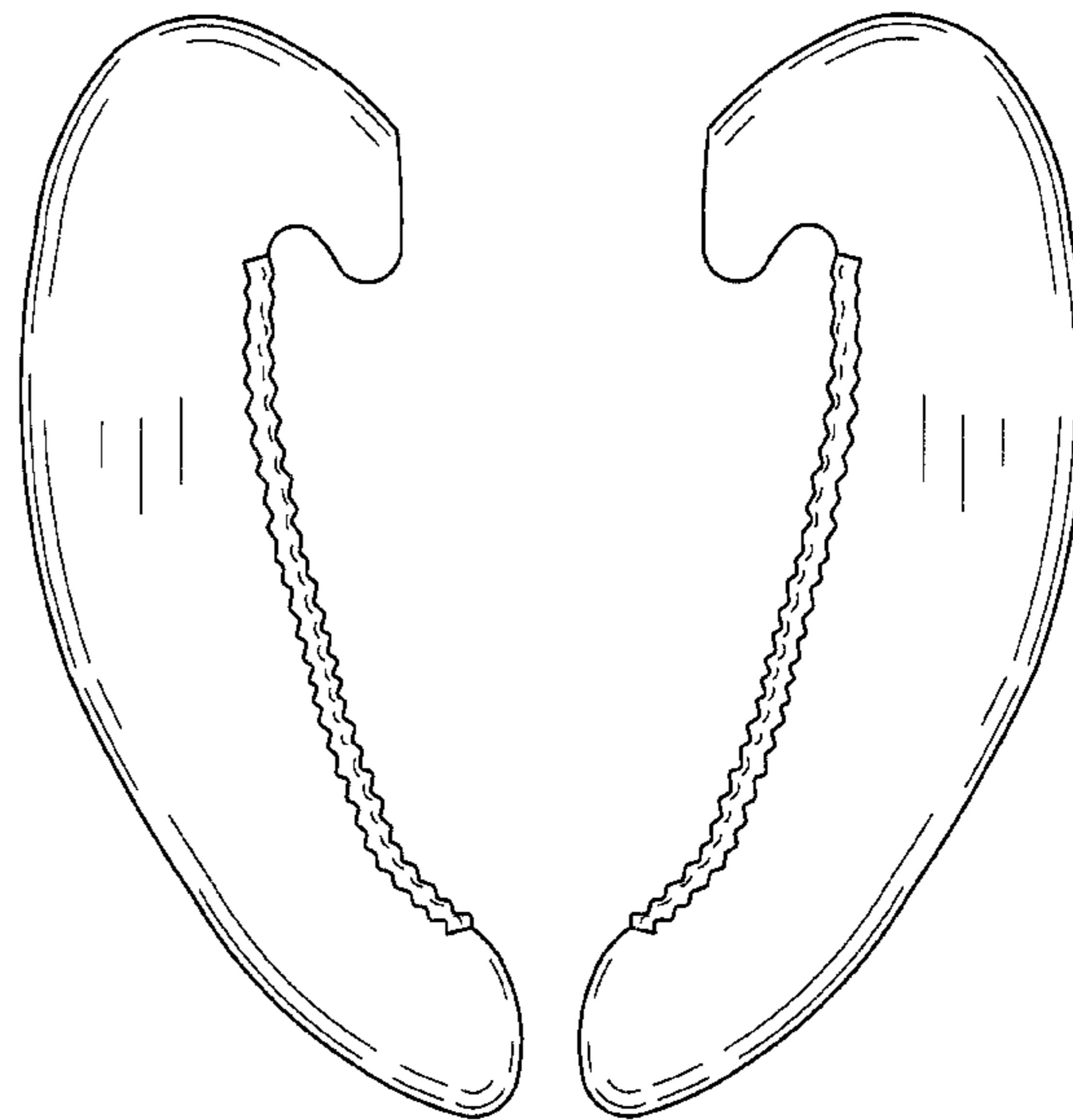
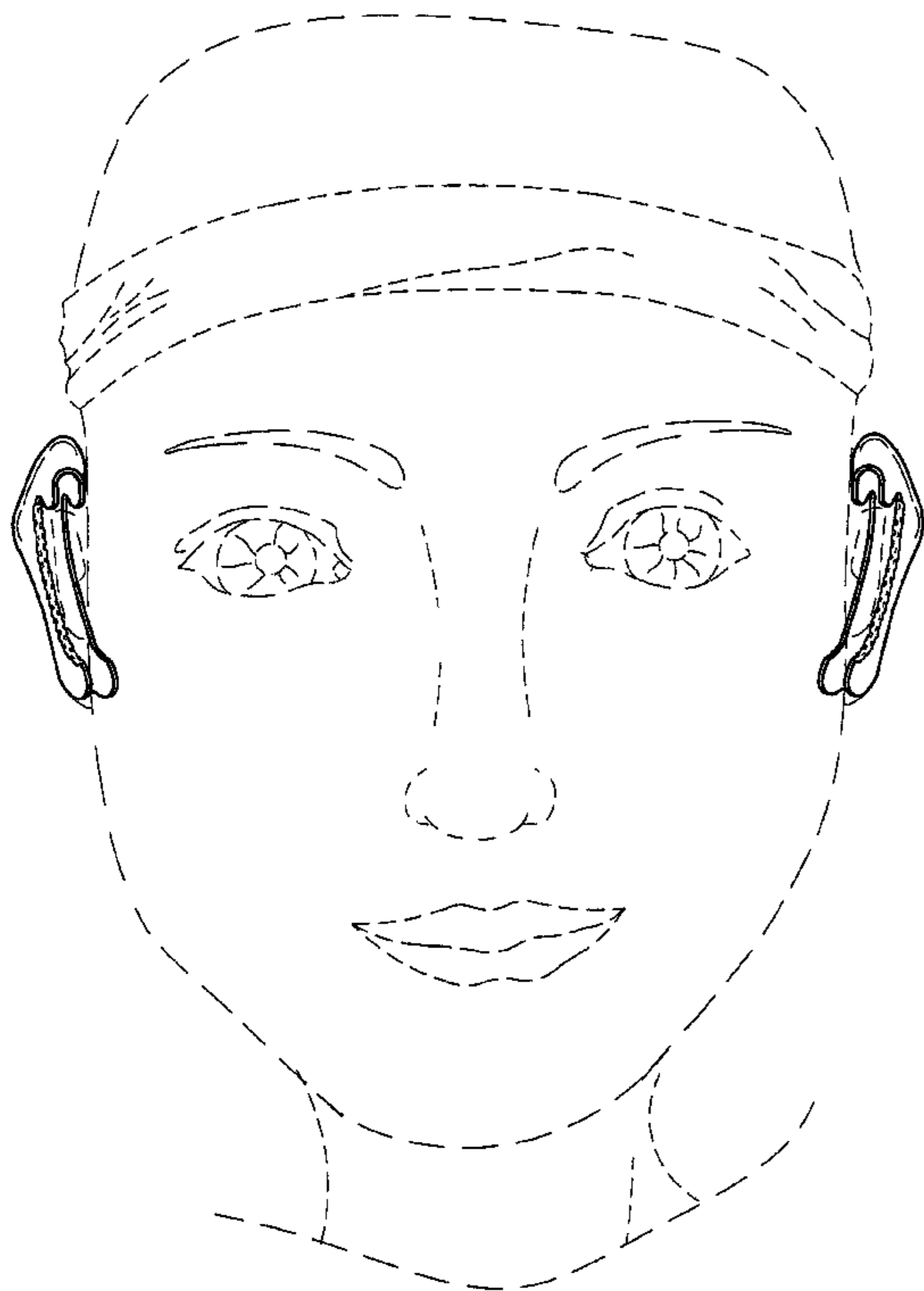
The broken line showing of a person's head is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

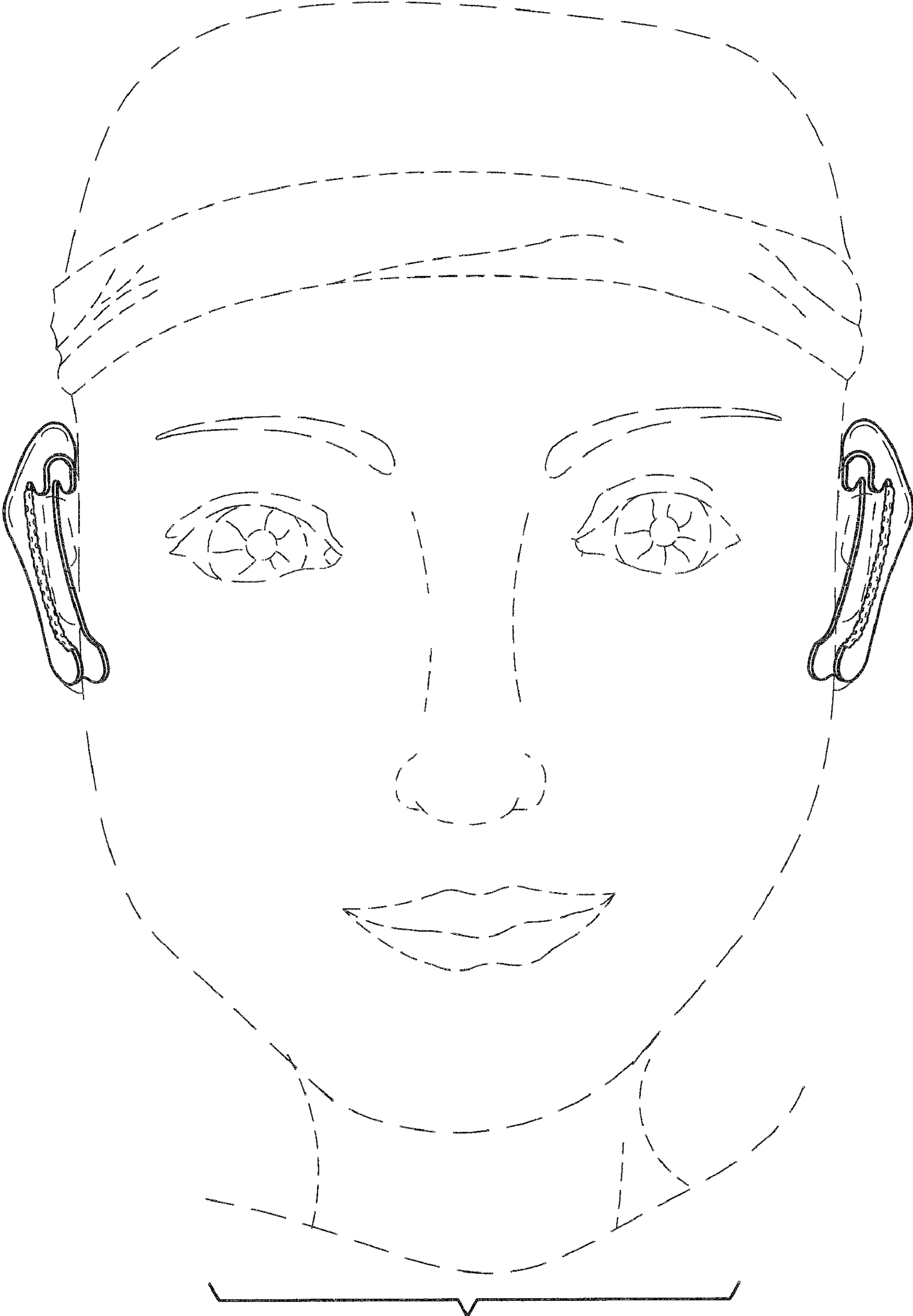

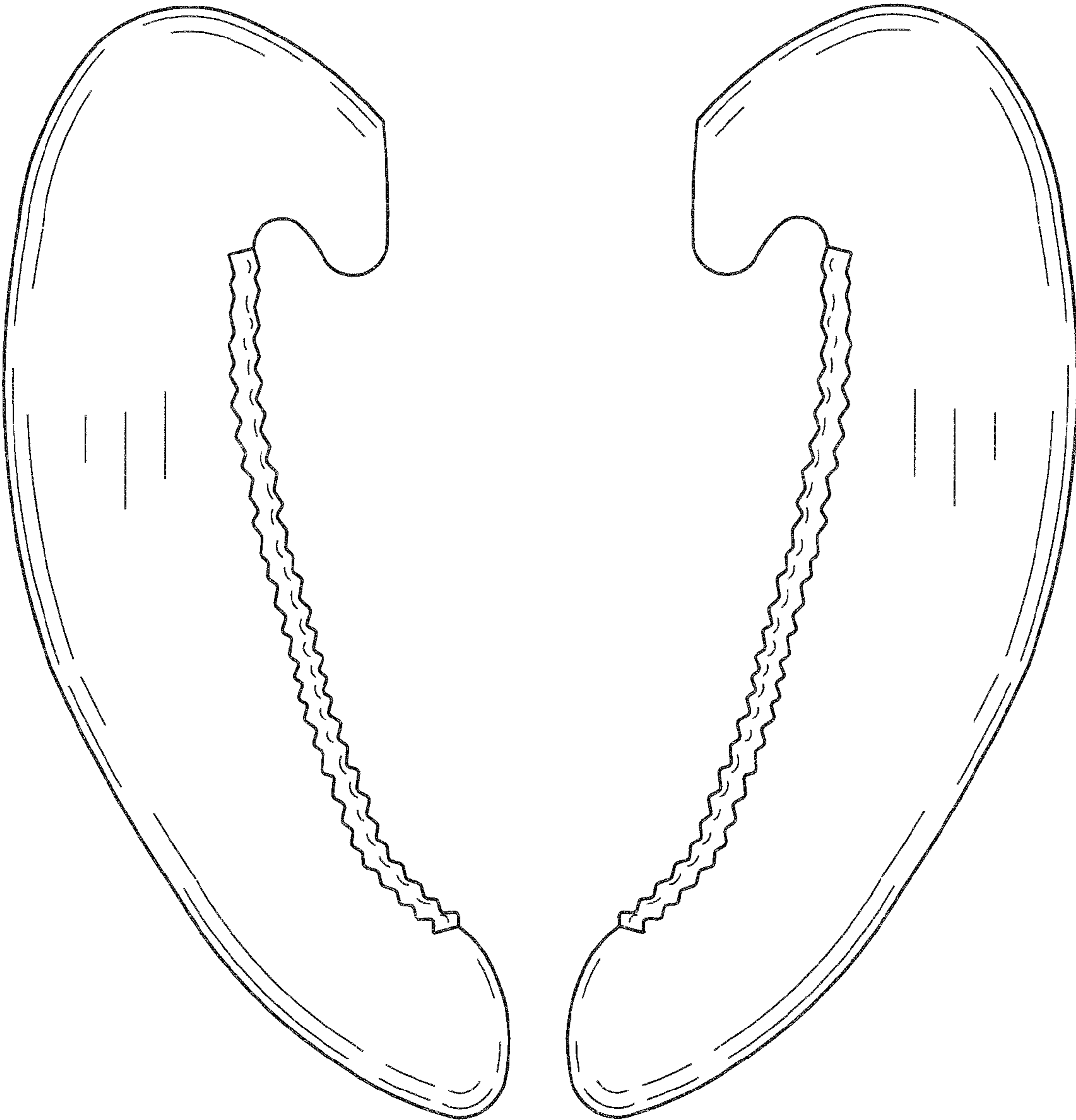

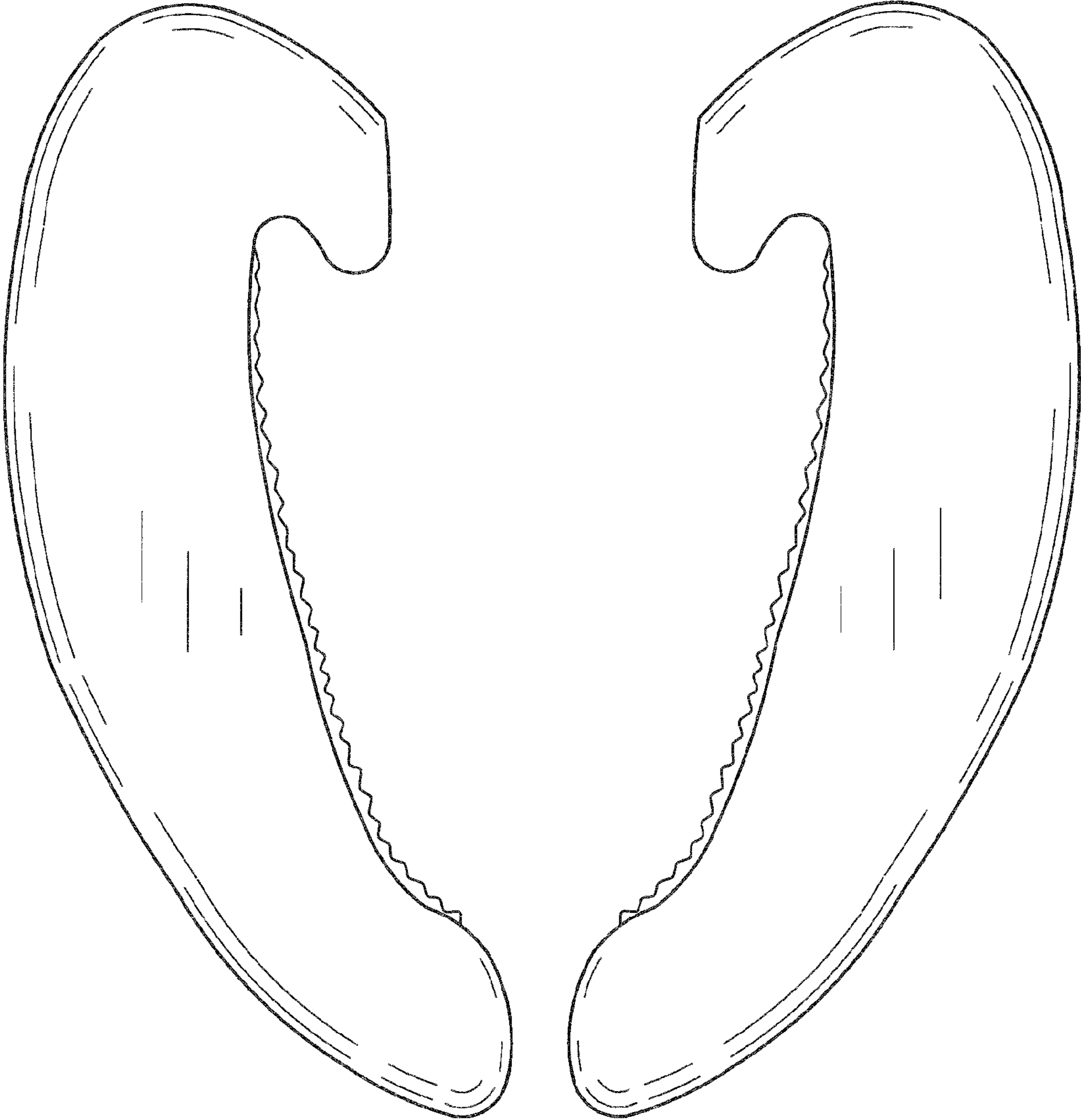

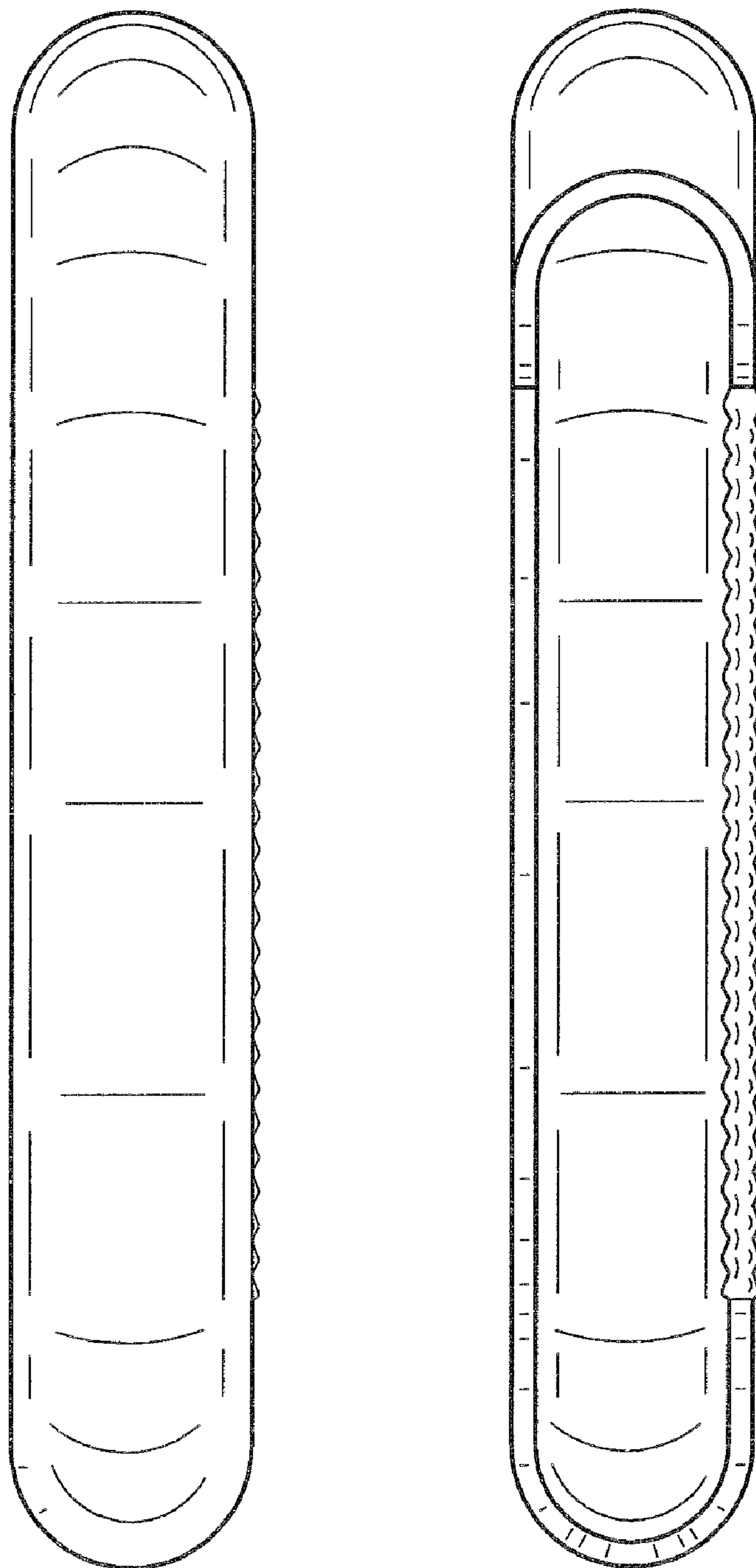

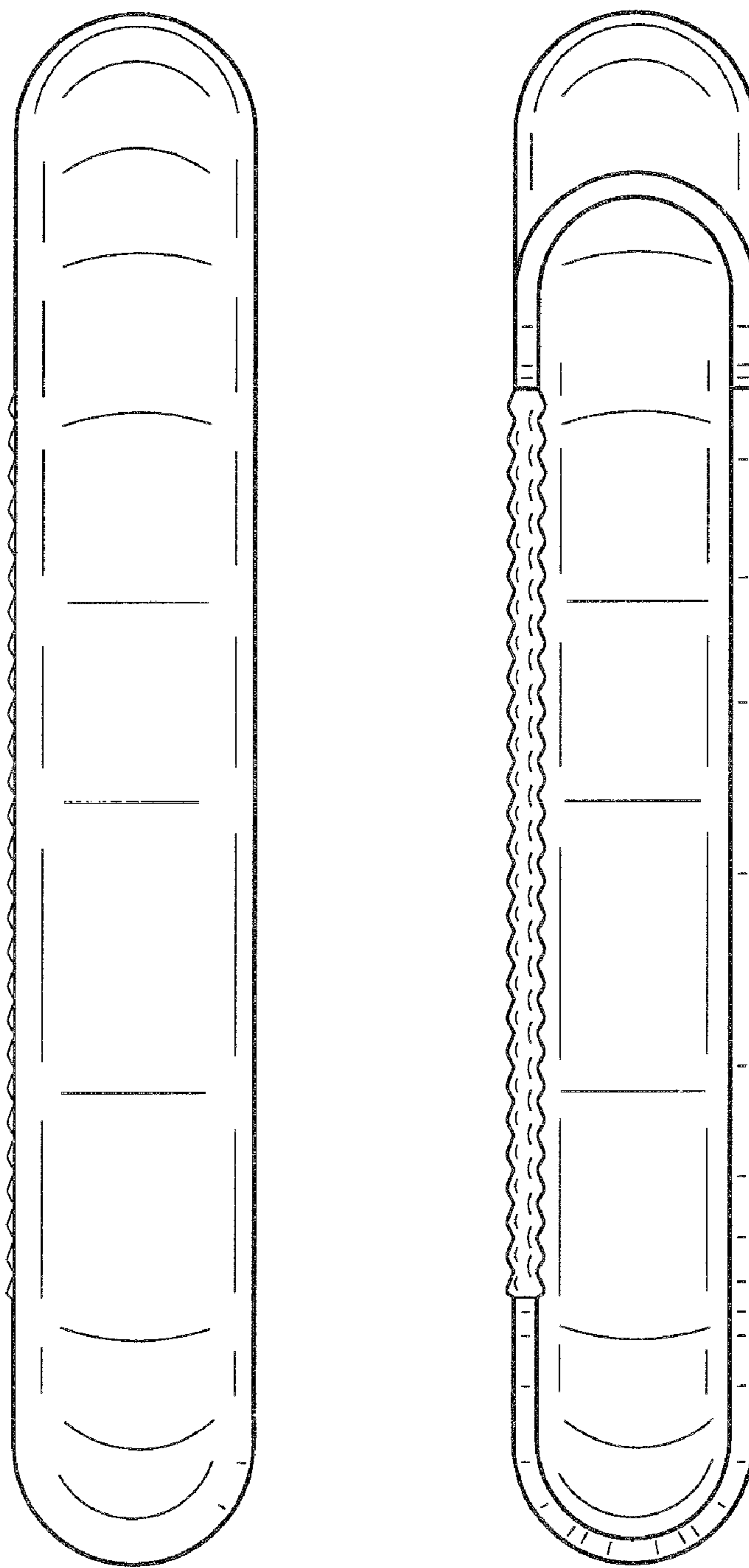

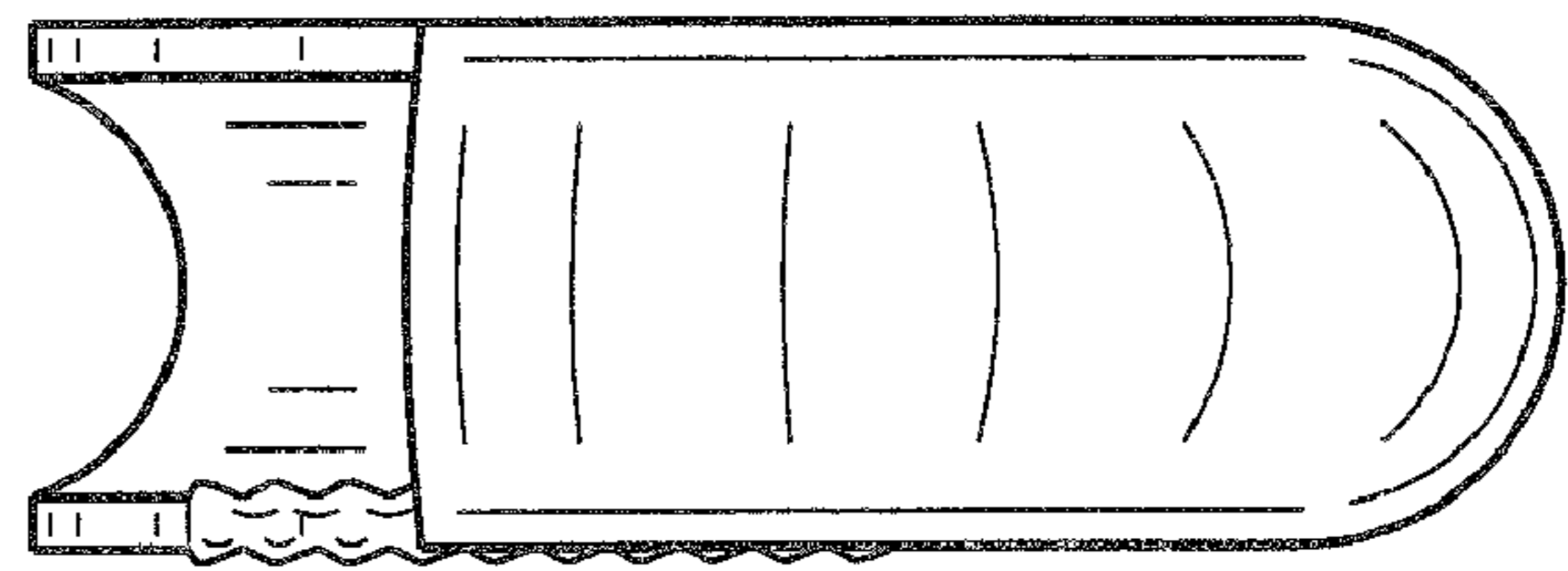
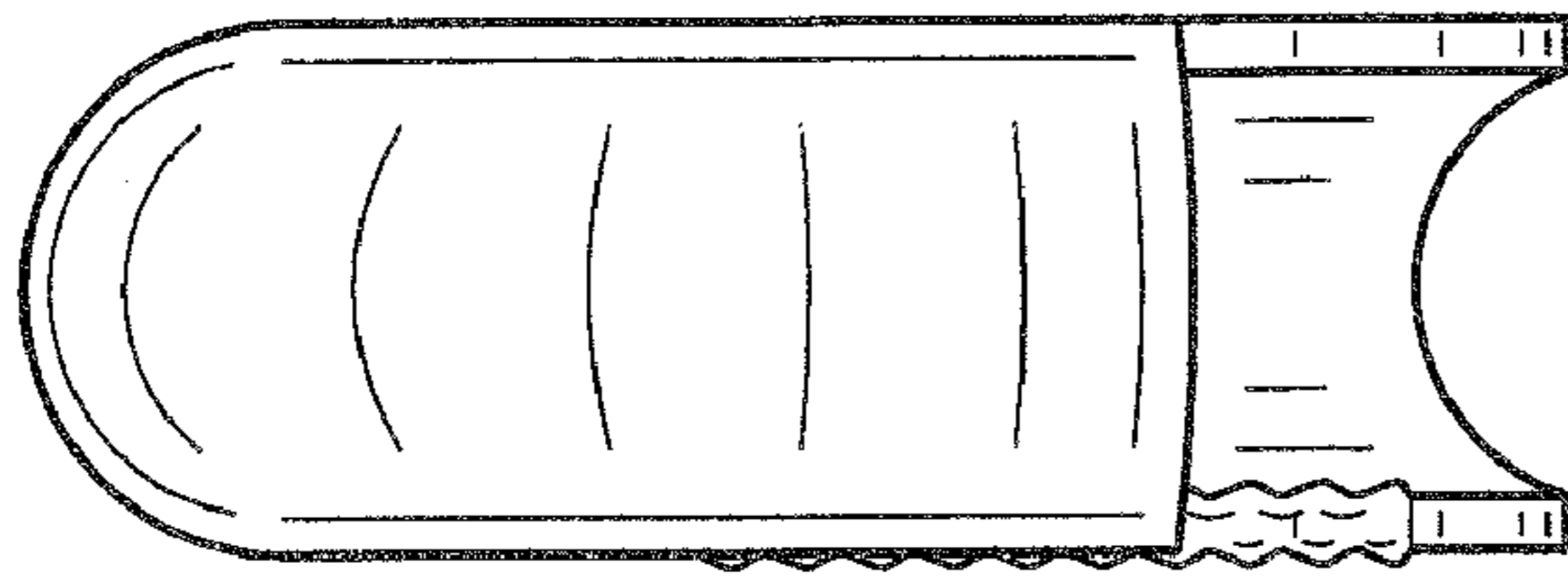
