The ornamental design for sport pants, as shown and
described.

DESCRIPTION

FIG. 1 is a front right top perspective view of a first embodi-
ment of sport pants showing our new design;

FIG. 2 is a rear left top perspective view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a left side elevational view thereof; and

FIG. 7 is a rear elevational view thereof, wherein the pants are
laid flat.

embodiment of sport pants showing our new design;

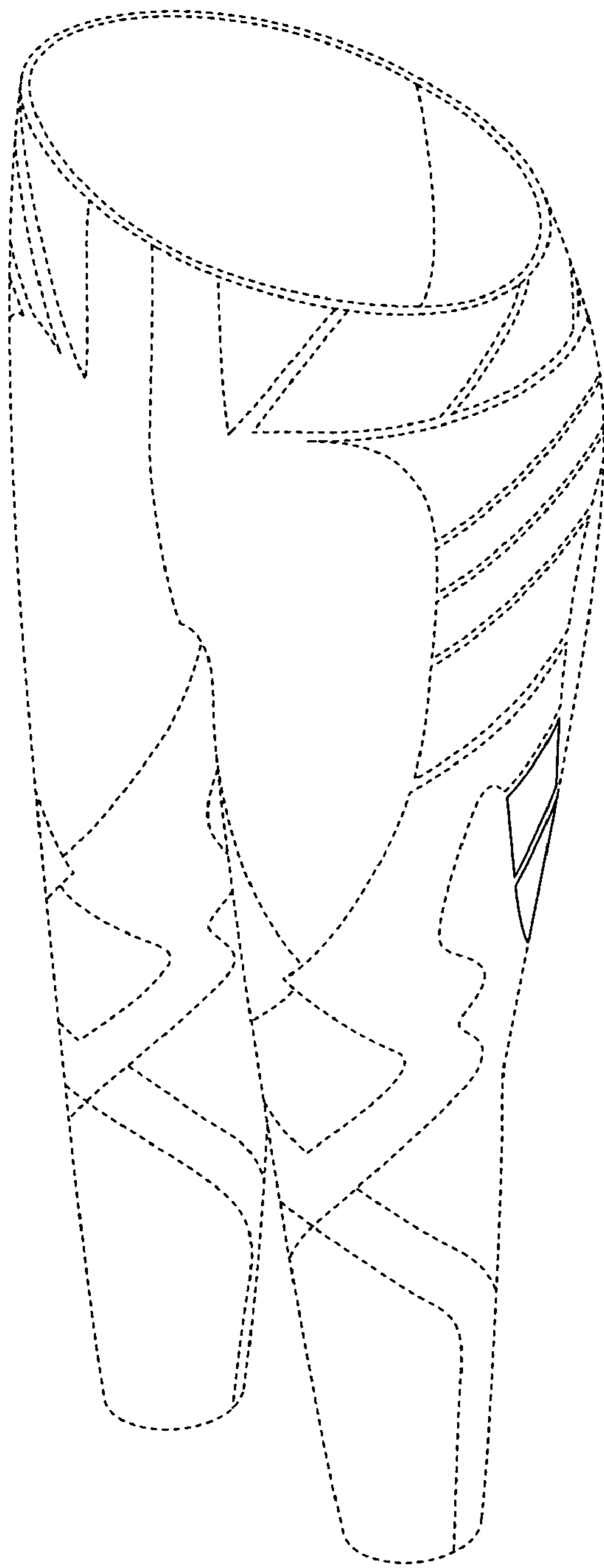

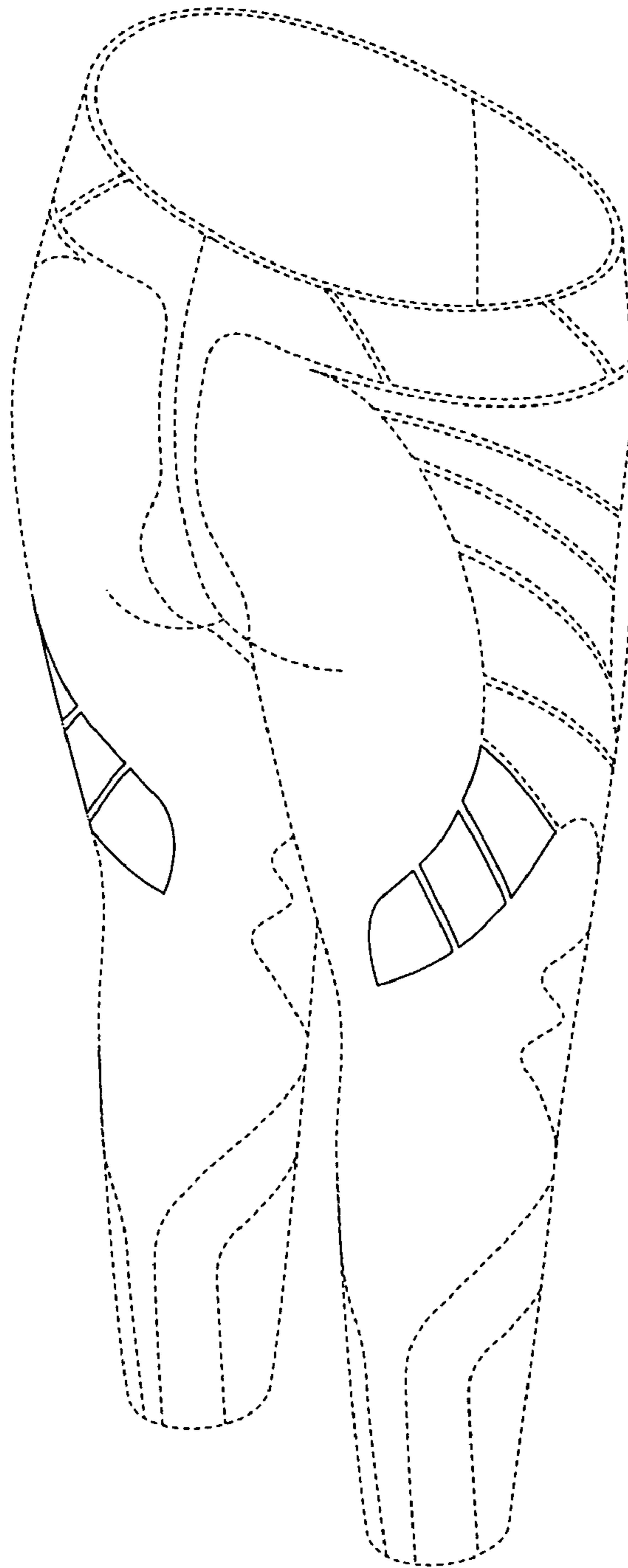

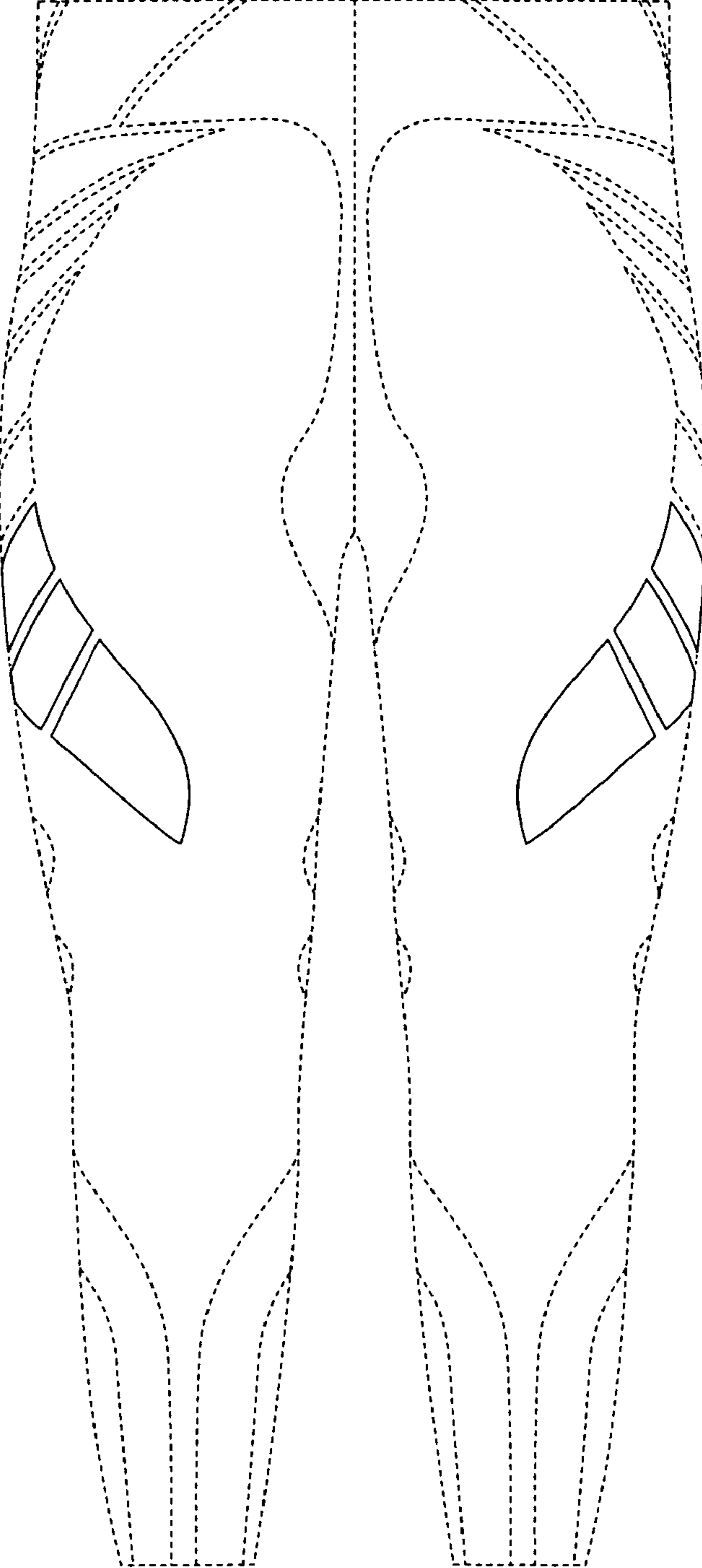

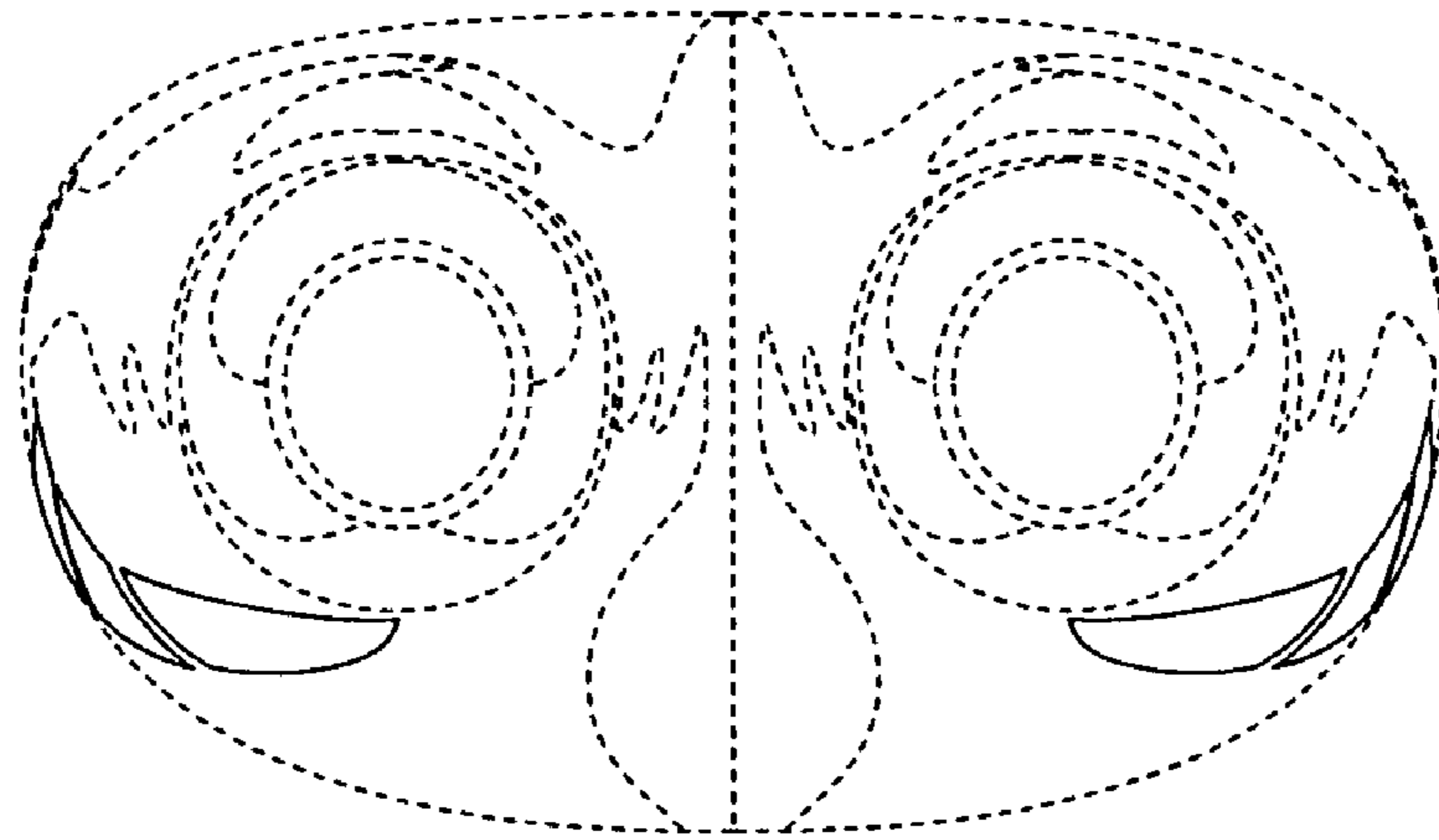

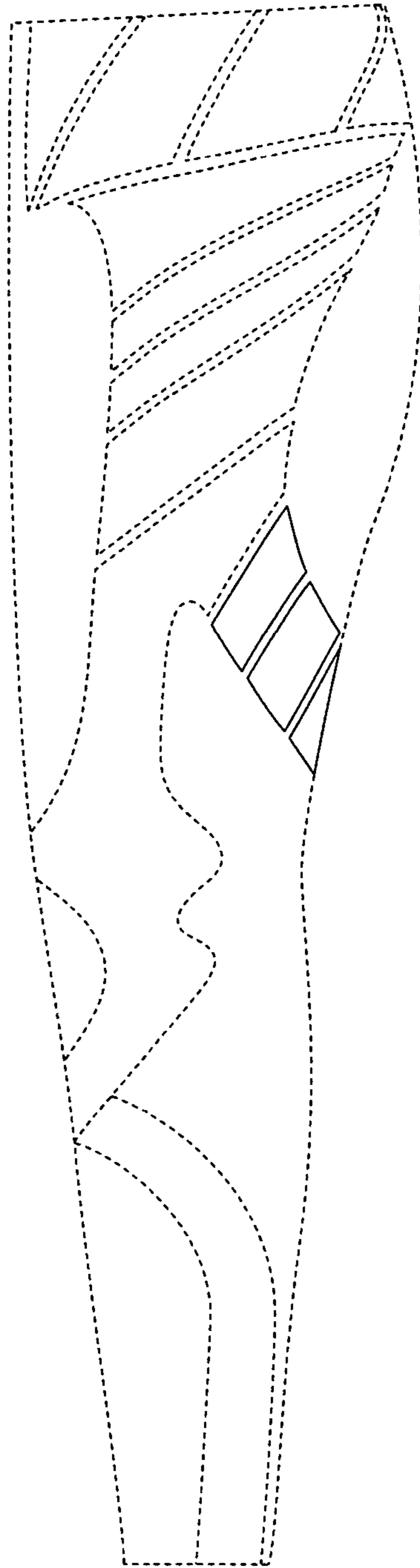

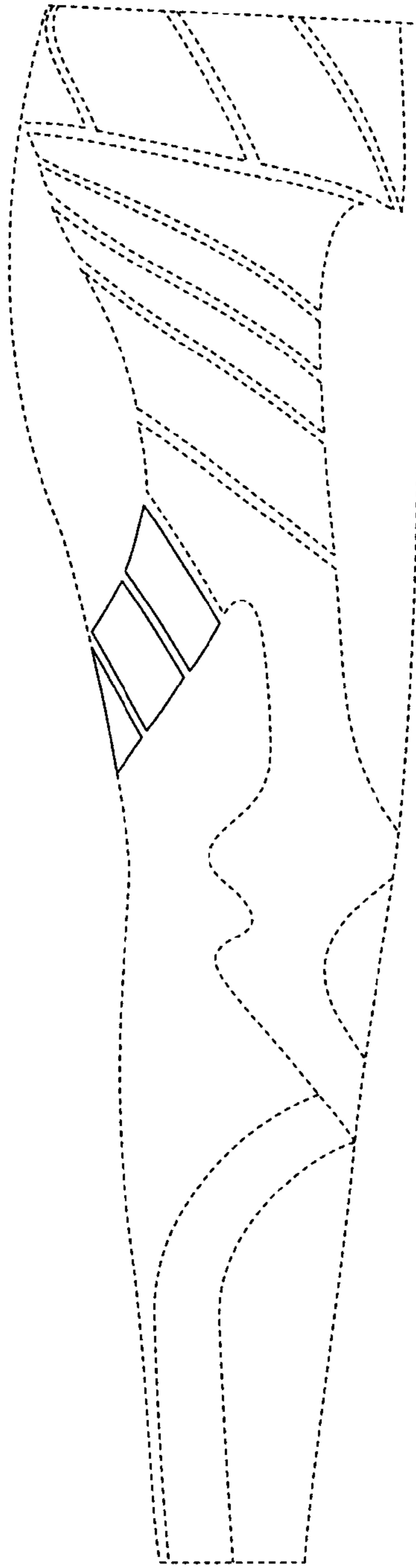

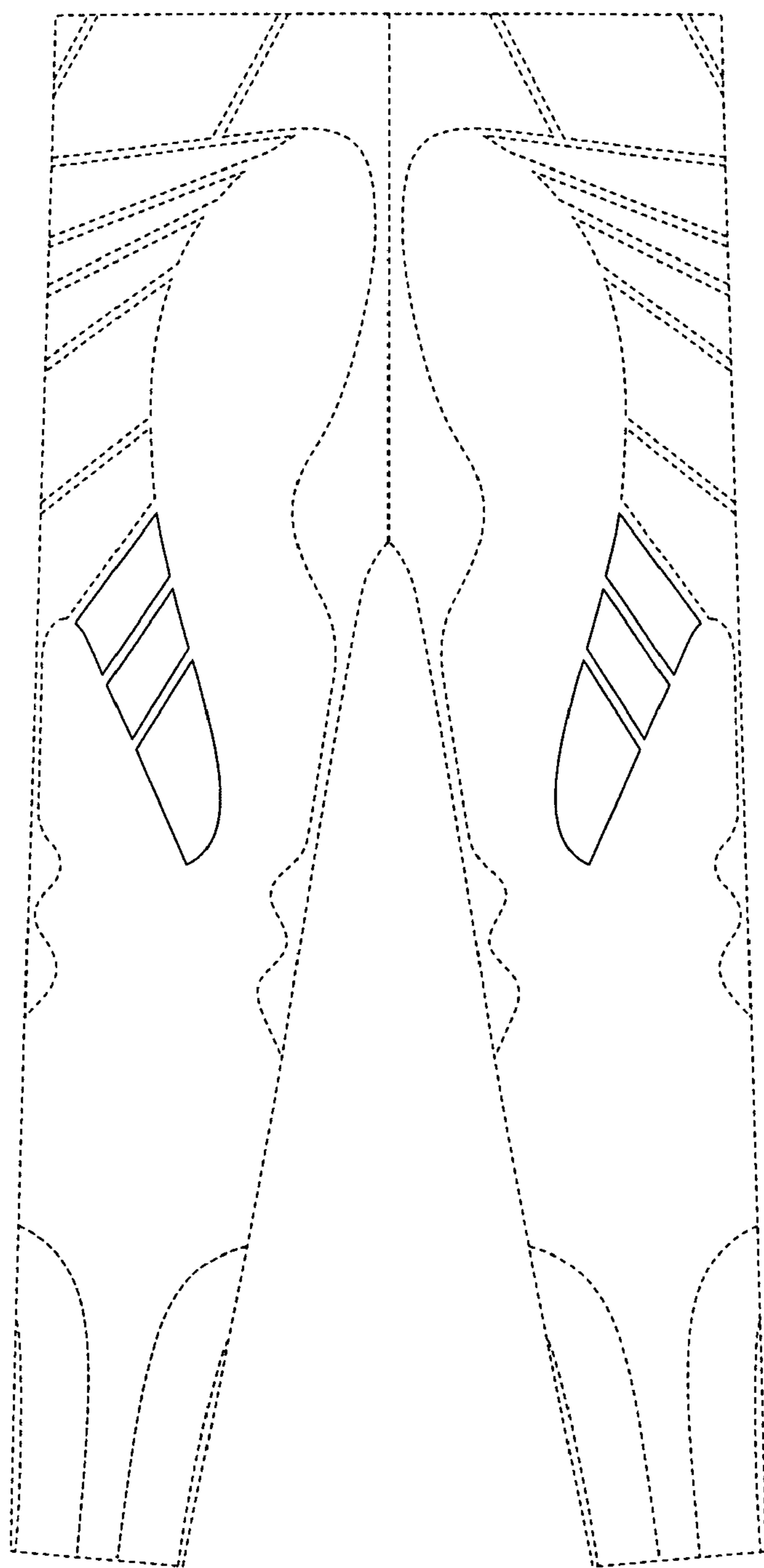

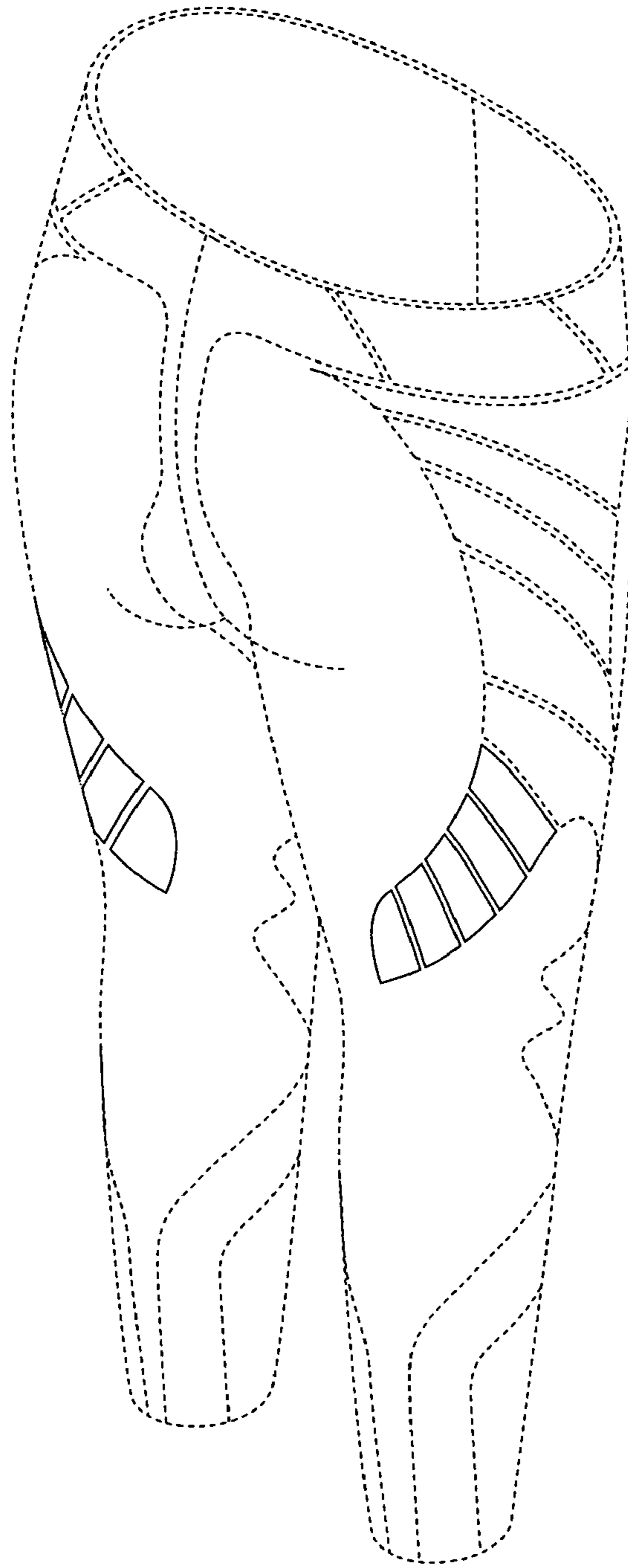

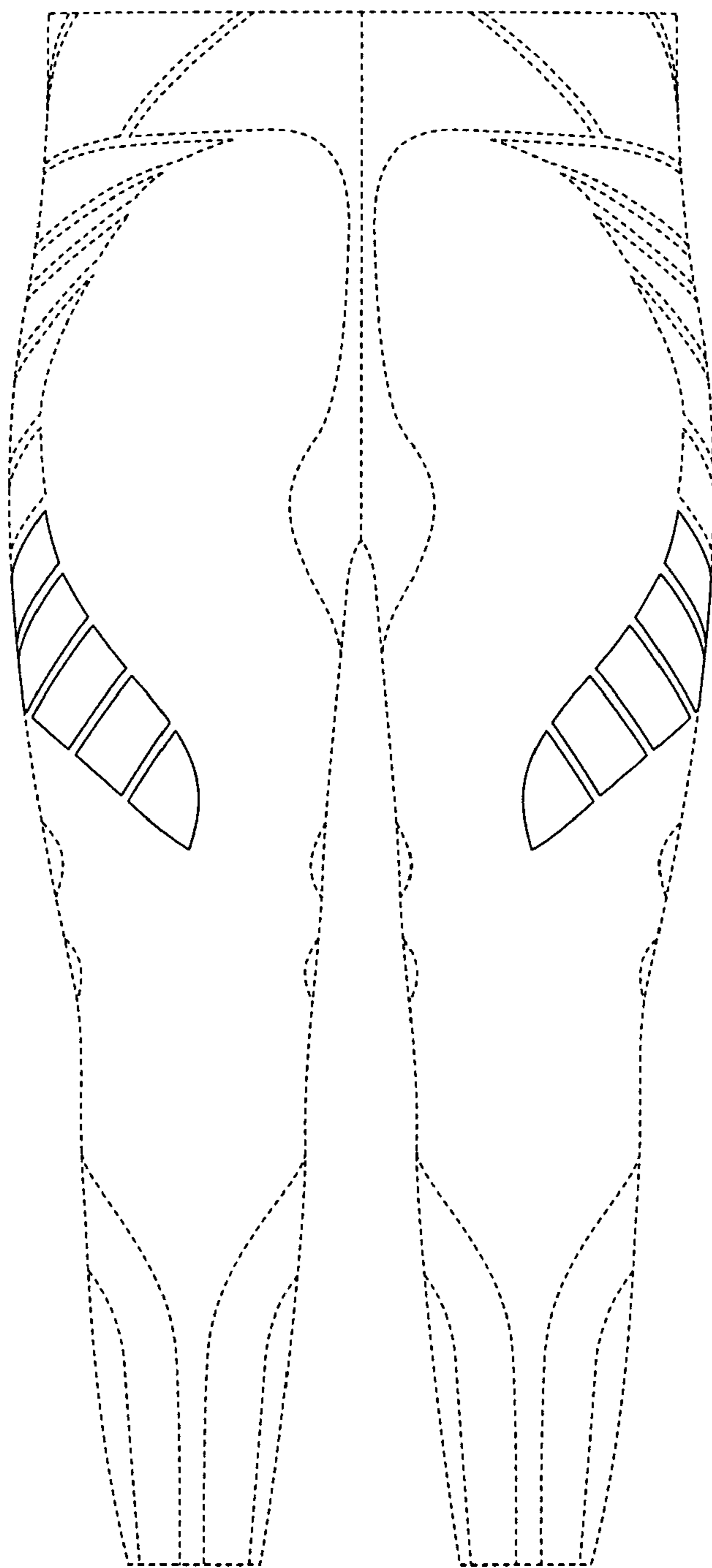

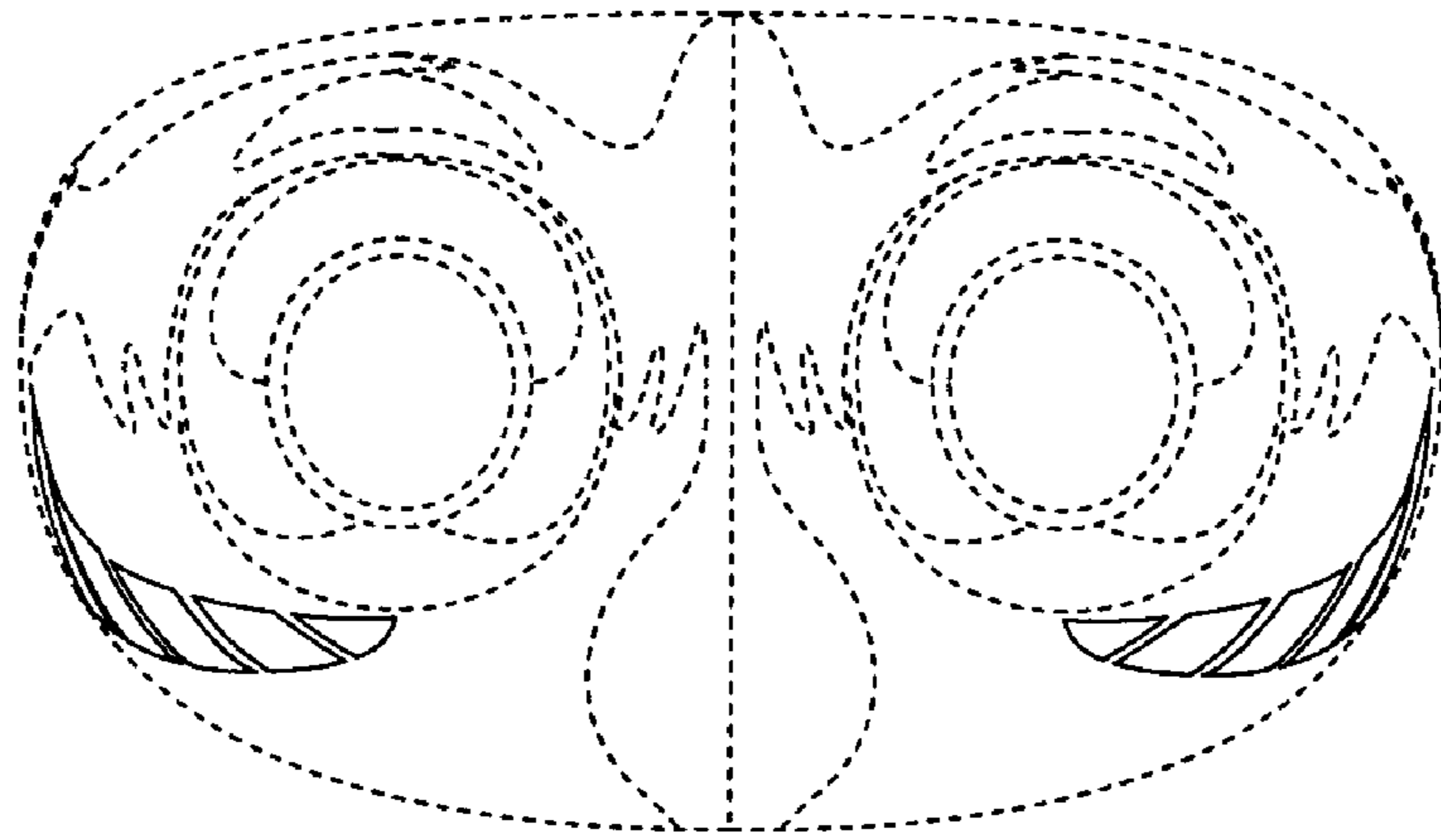

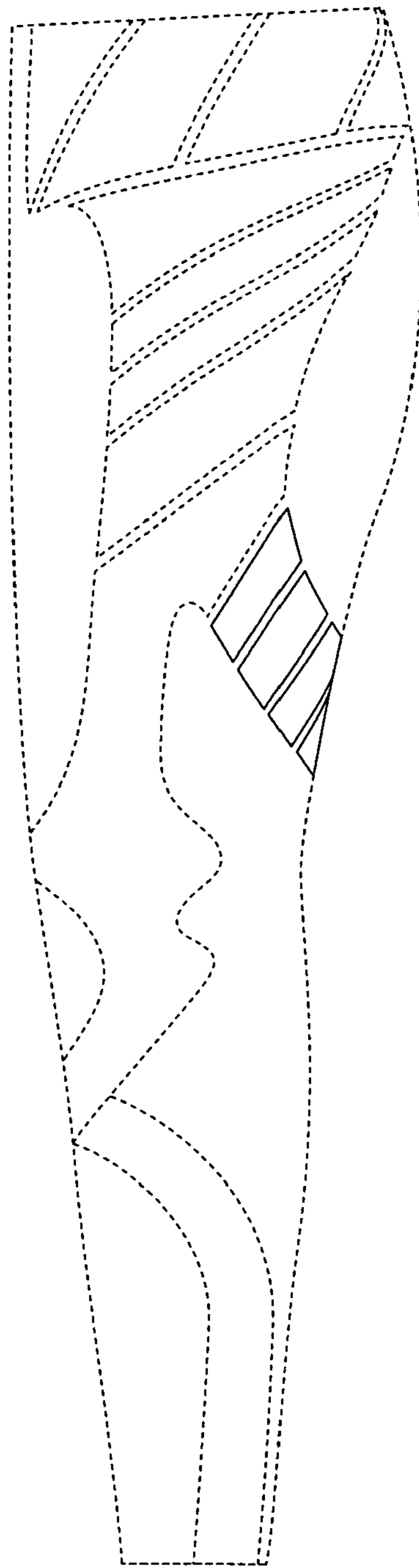

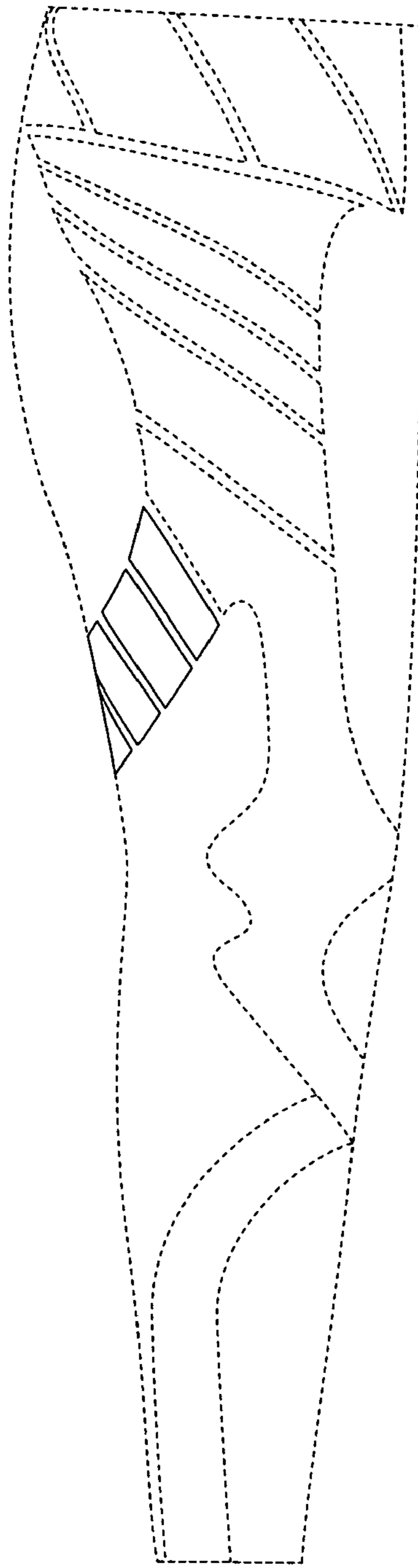

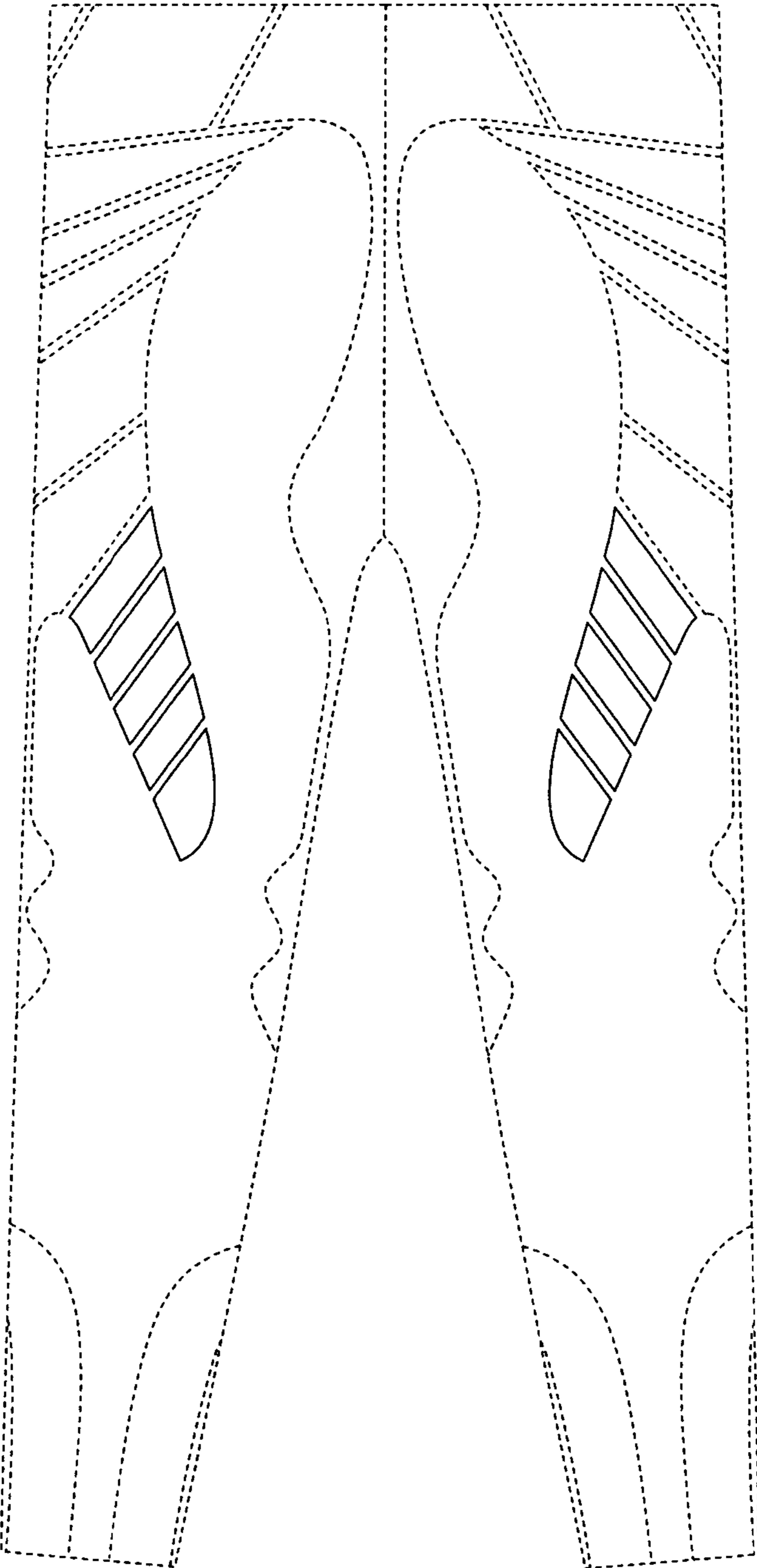
