(57) **CLAIM**

What is claimed is the ornamental design for a shirt with an integral cape, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shirt with an integral cape, showing the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right-side elevational view thereof, the left-side elevational view being a mirror image thereof;

FIG. 5 is a top plan view thereof; and,

FIG. 6 is a bottom plan view thereof.

The broken lines showing a person in FIG. 1 are included for the purpose of illustrating the invention in use, and form no part of the claimed design.

The even dash line shown in FIGS. 1, 4, 5 and 6 represents the stitch.

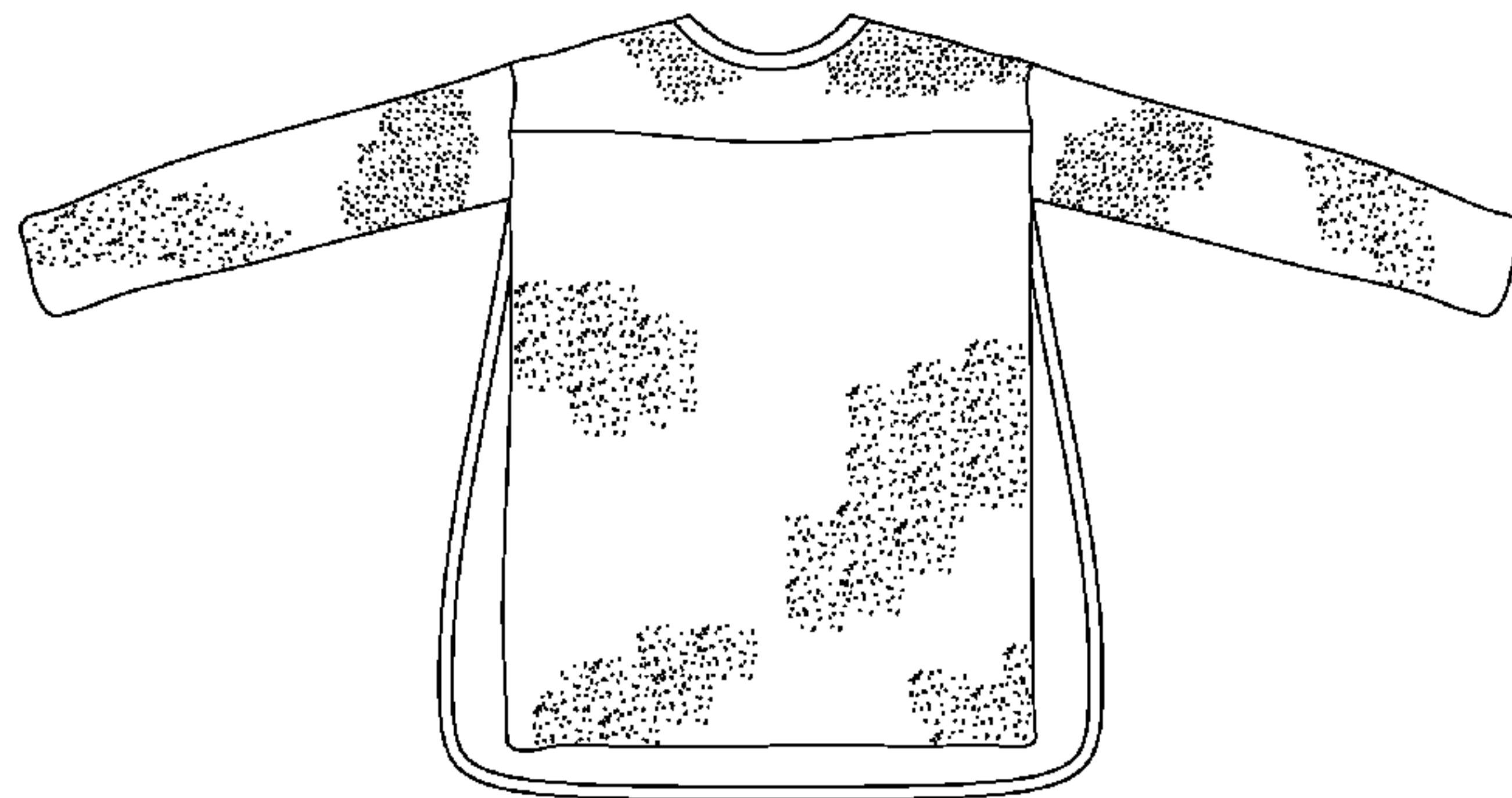
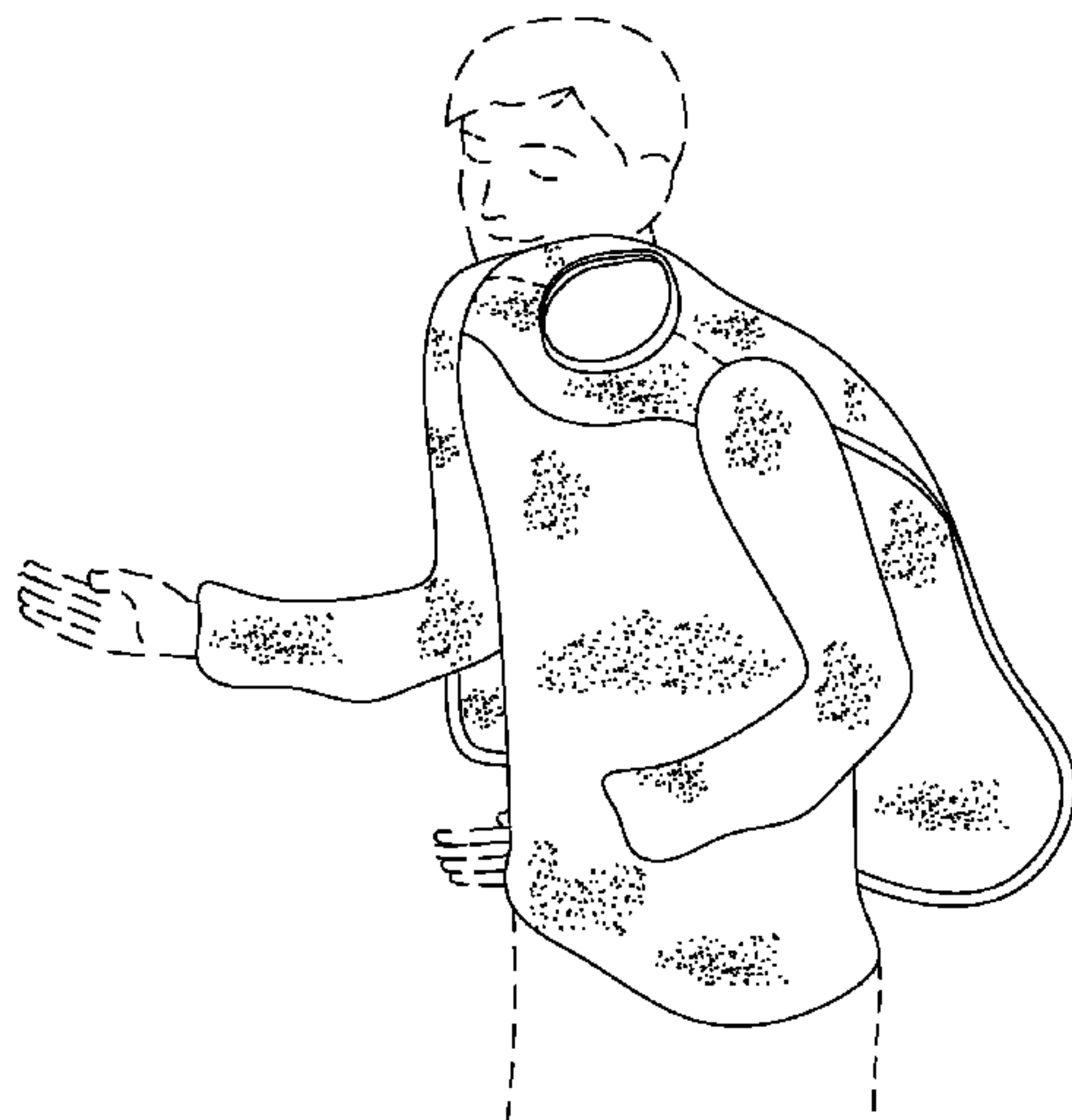

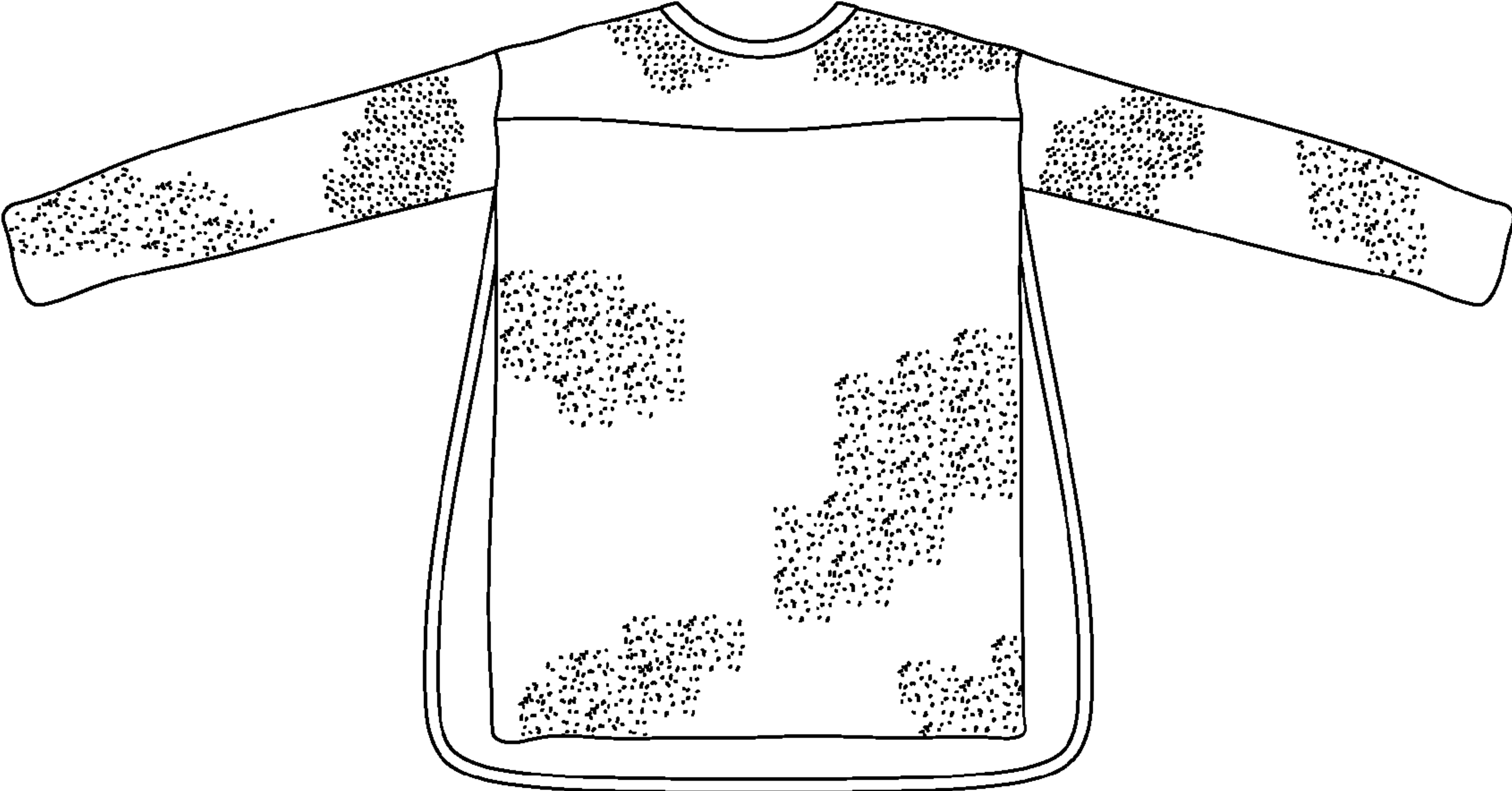

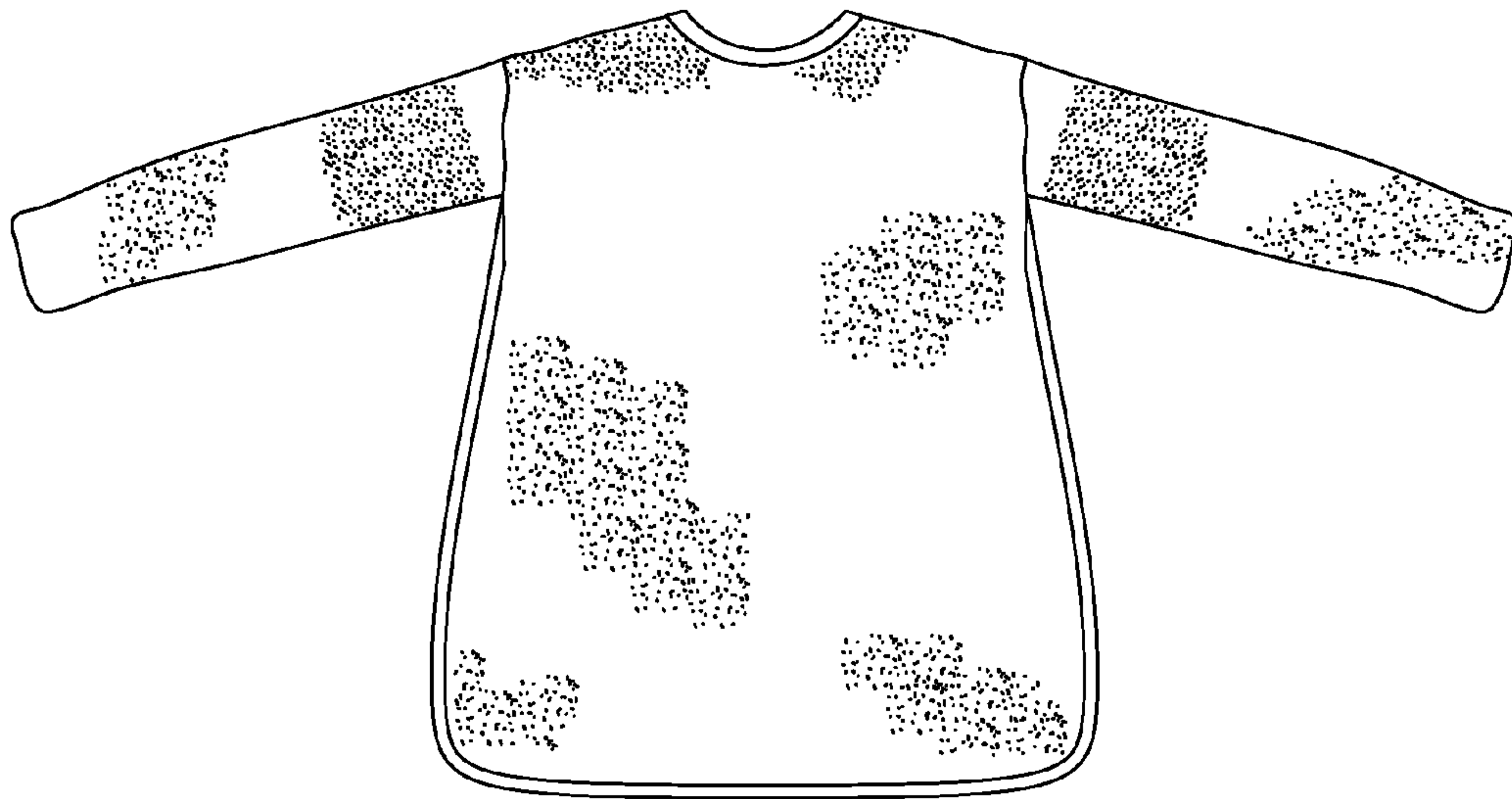

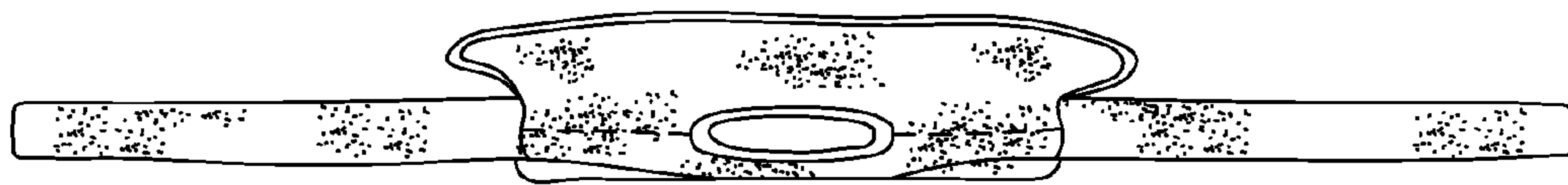

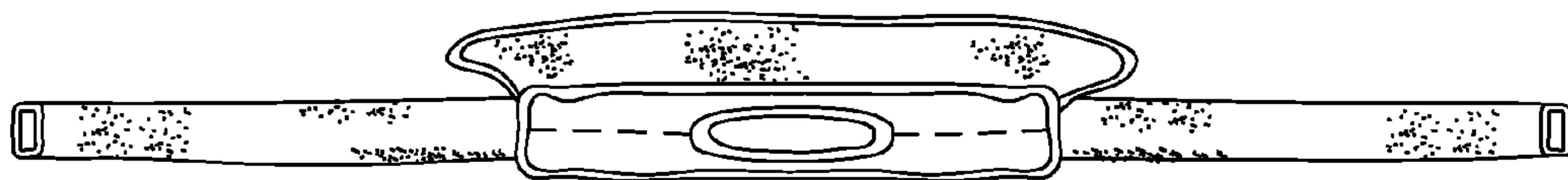
