FIG. 1 illustrates a front plan view of an emergency kit showing the design in a closed position;

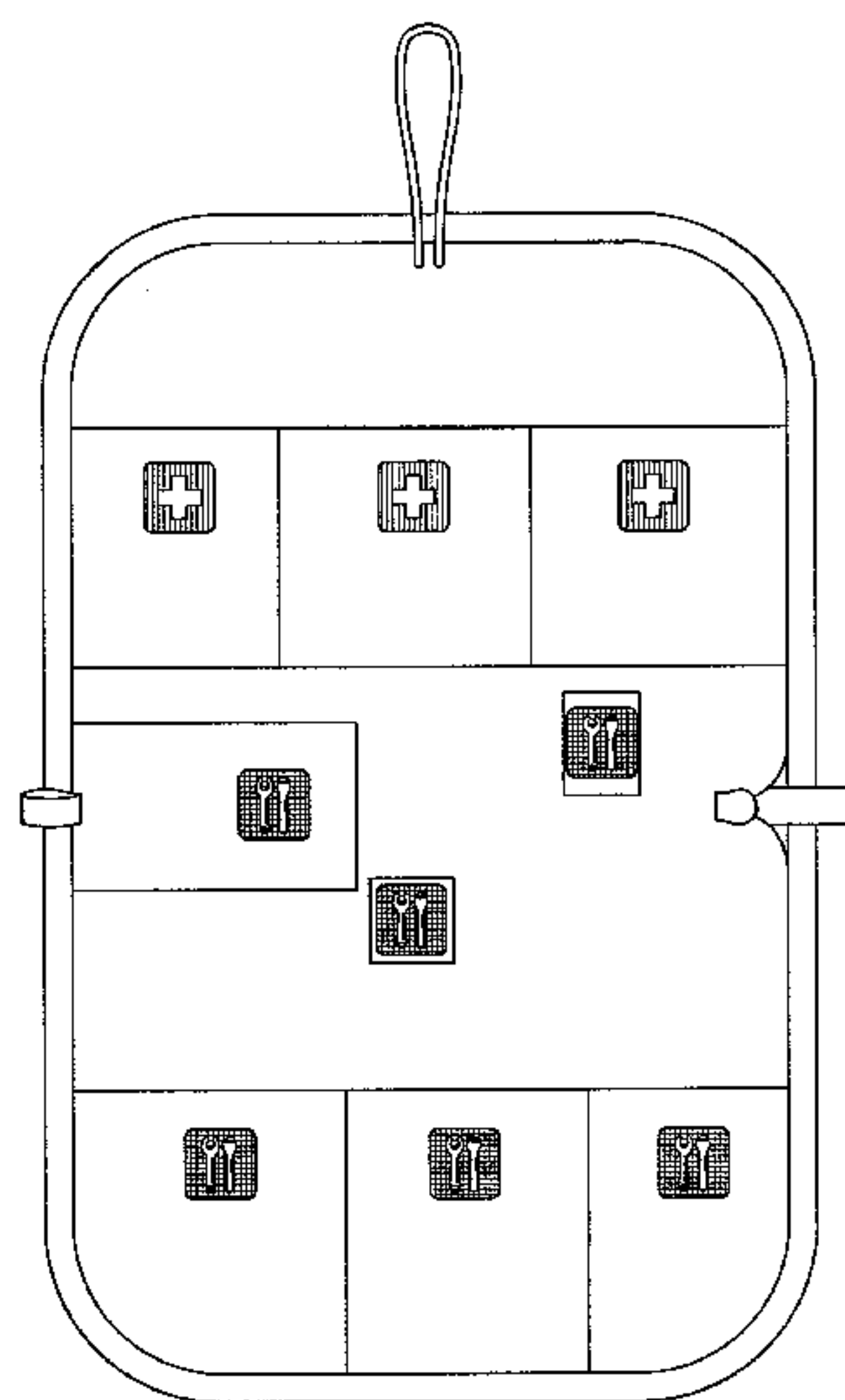
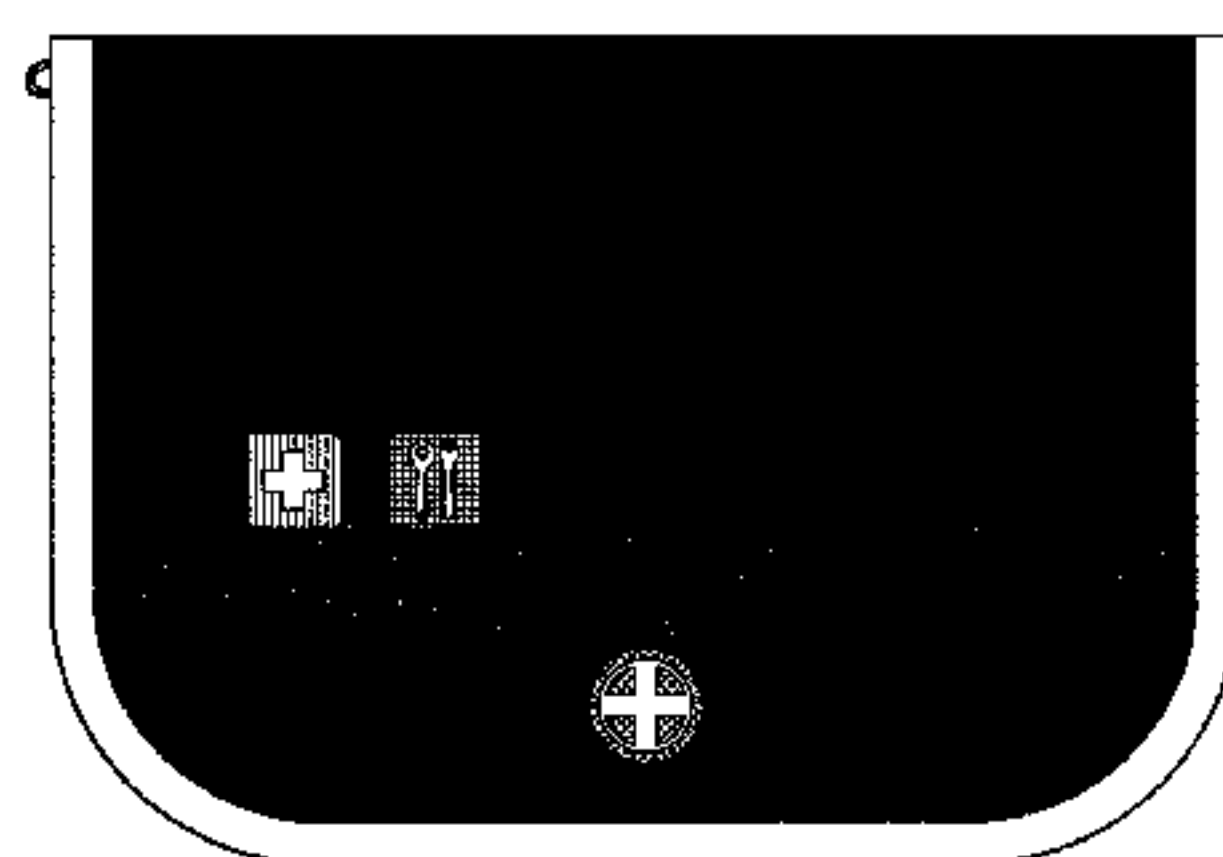
FIG. 2 illustrates a rear plan view thereof;

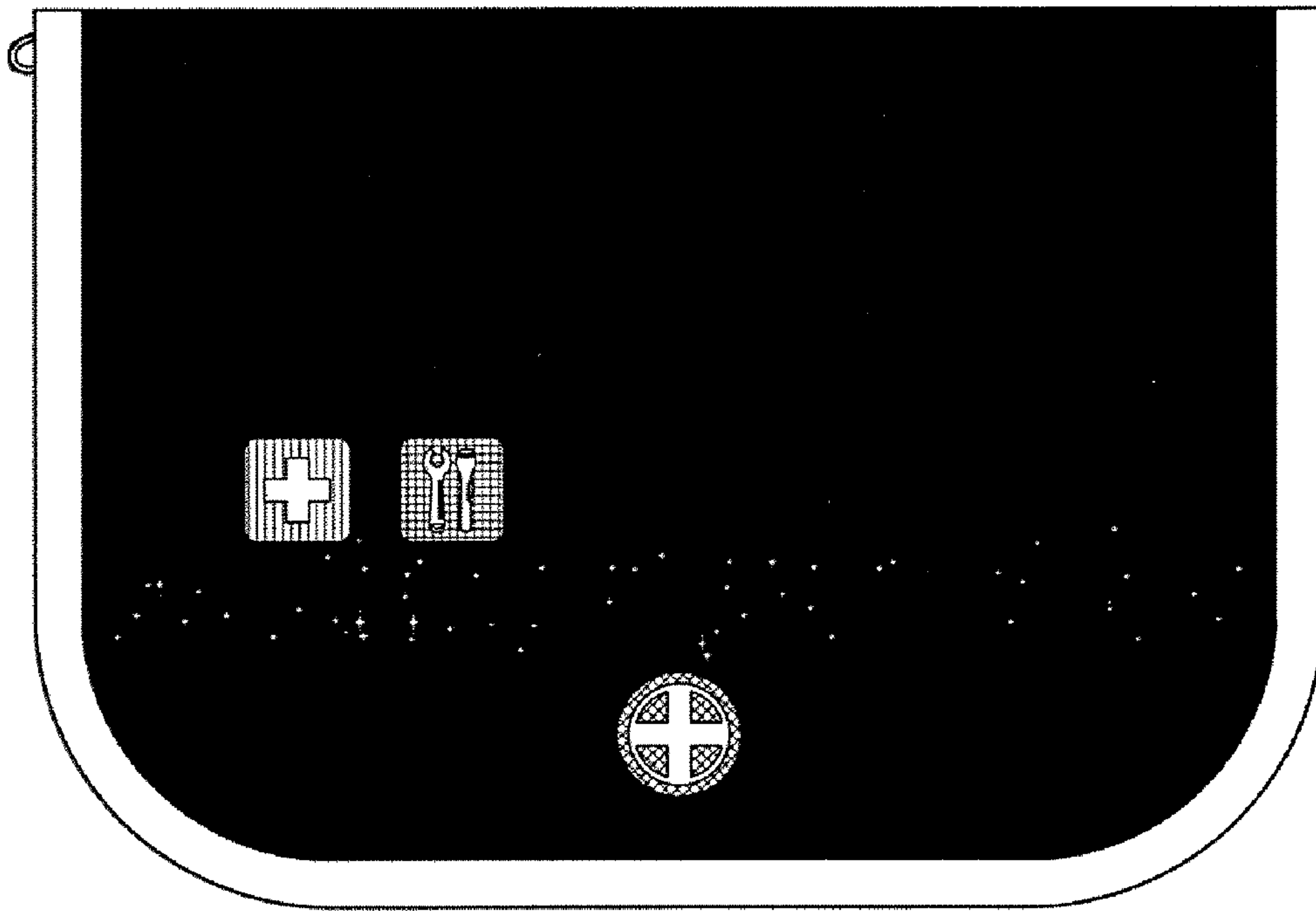

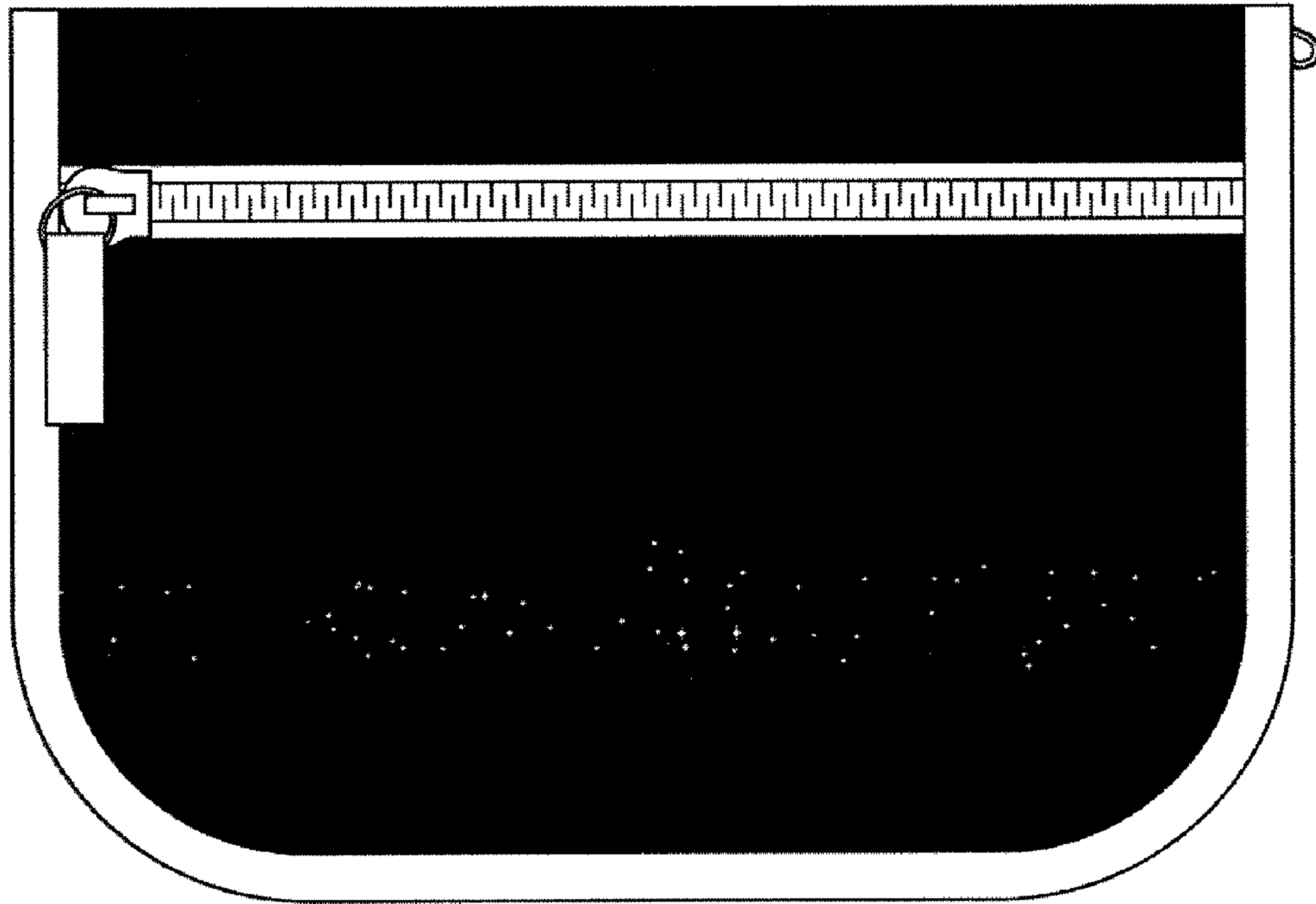

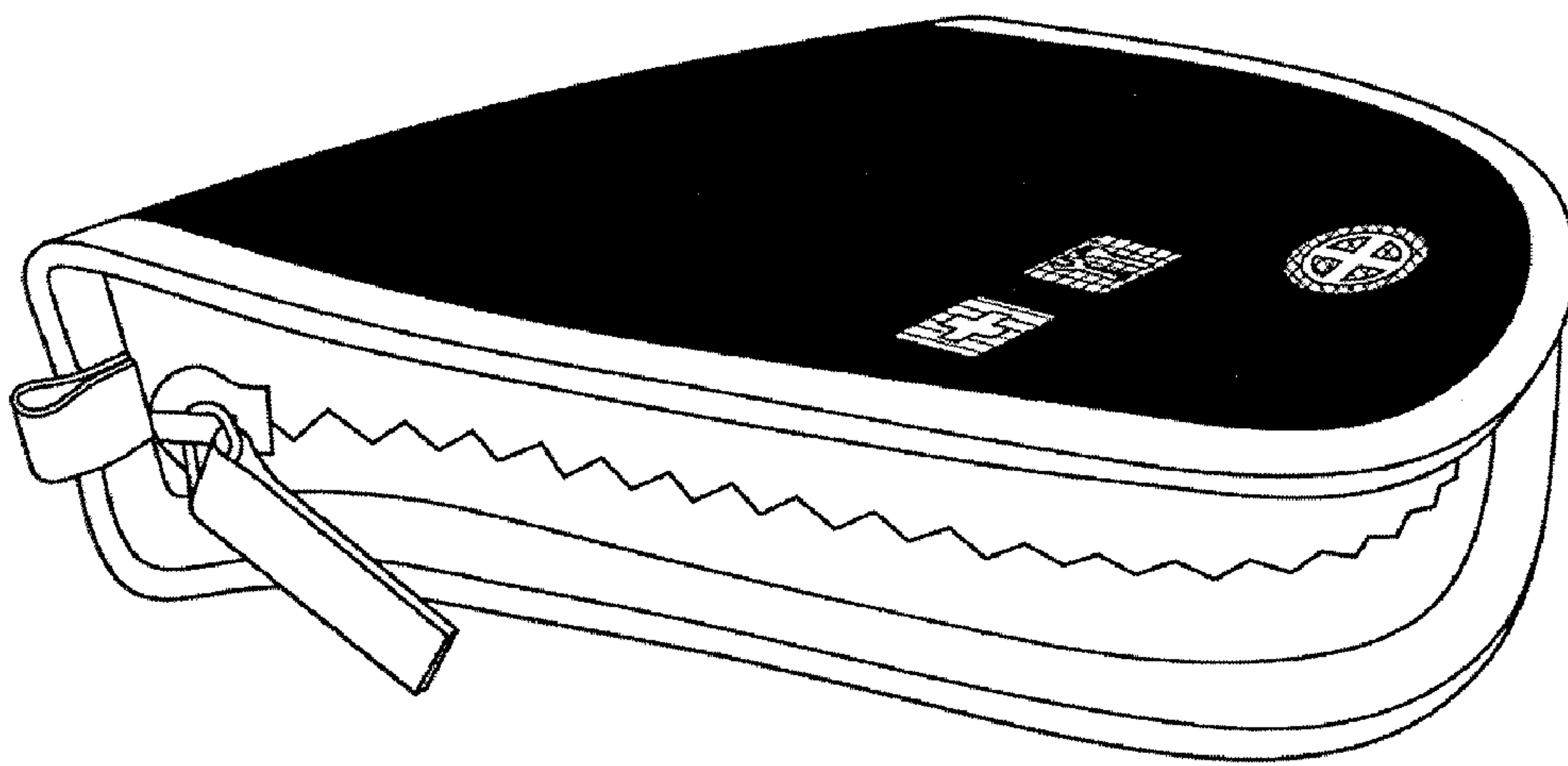

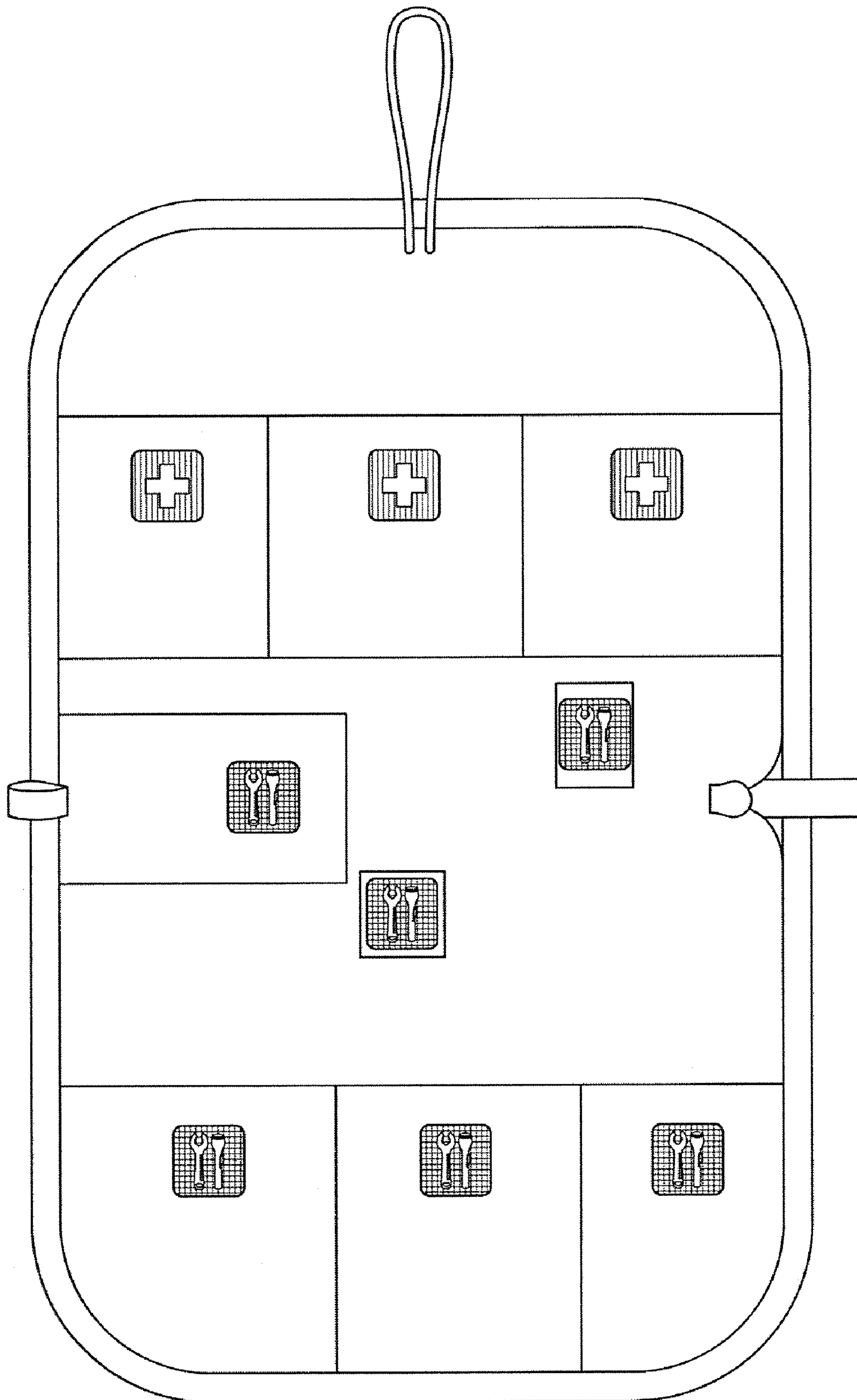
