(57) **CLAIM**

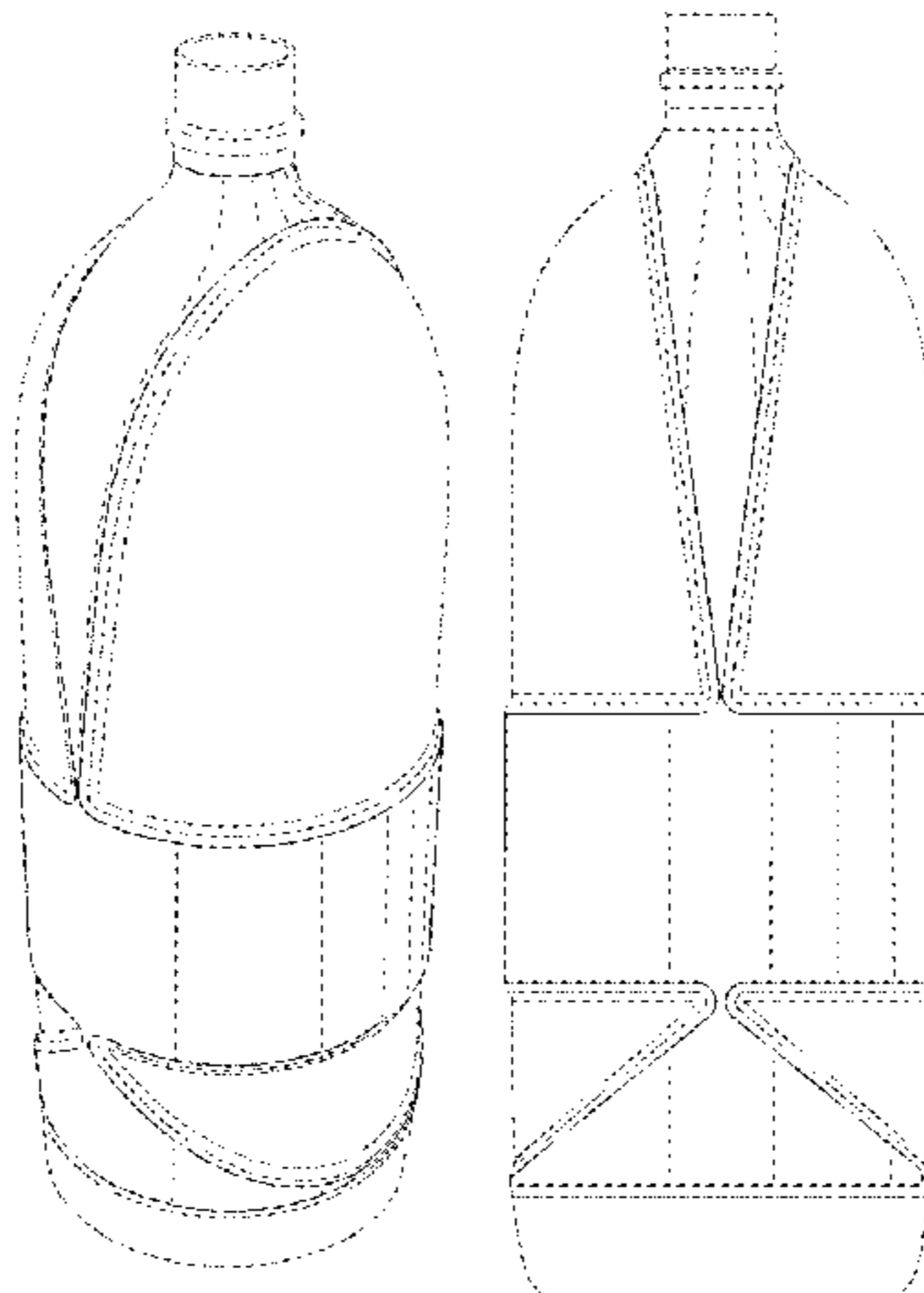
The ornamental design for a collapsible container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a collapsible container showing my design;
FIG. 2 is a left side view thereof;
FIG. 3 is a front view thereof;

FIG. 5 is a back view thereof;
FIG. 6 is a bottom view thereof; and,
FIG. 7 is a top view thereof.

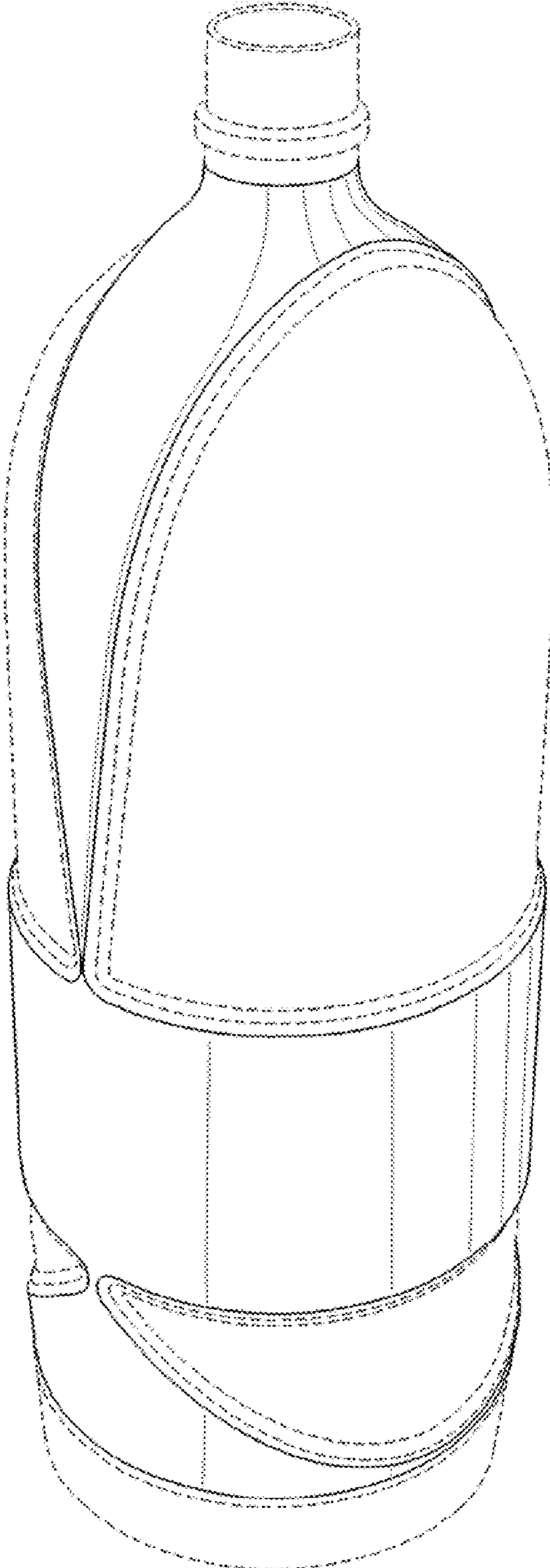

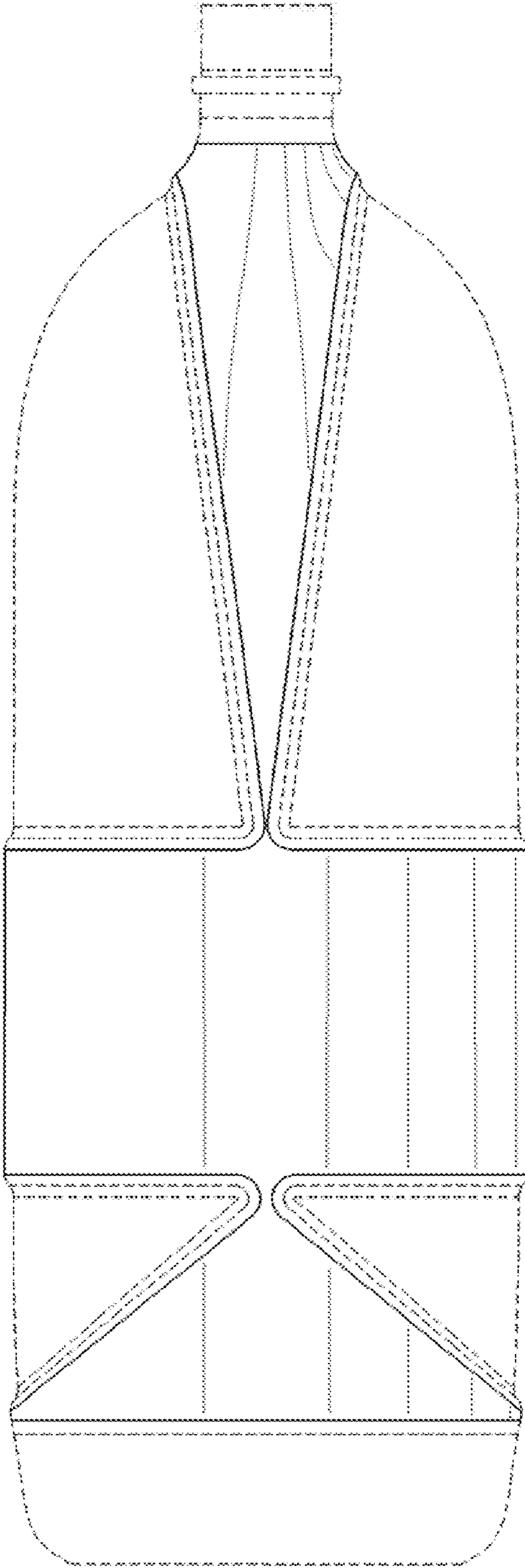

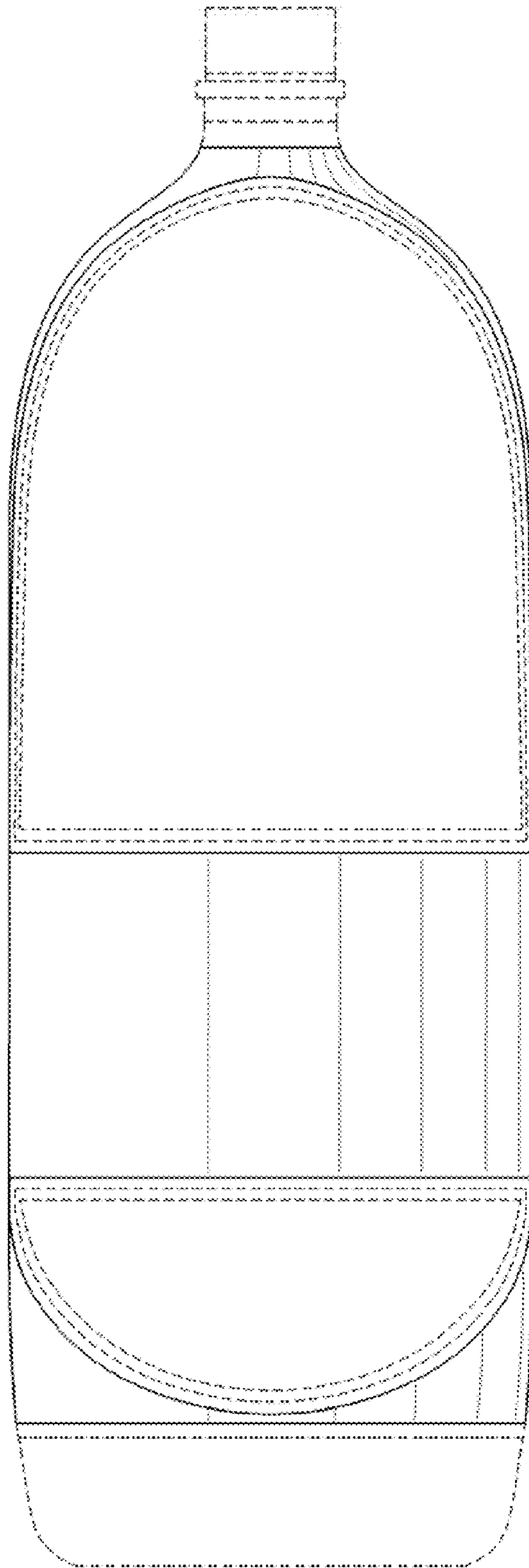

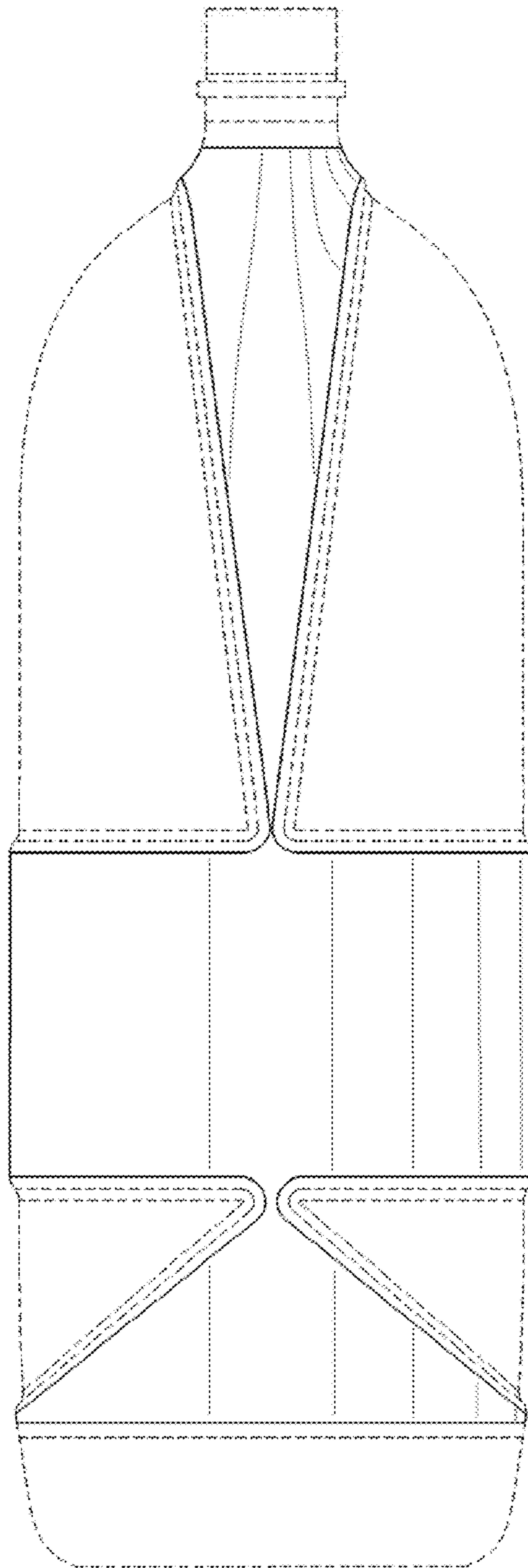

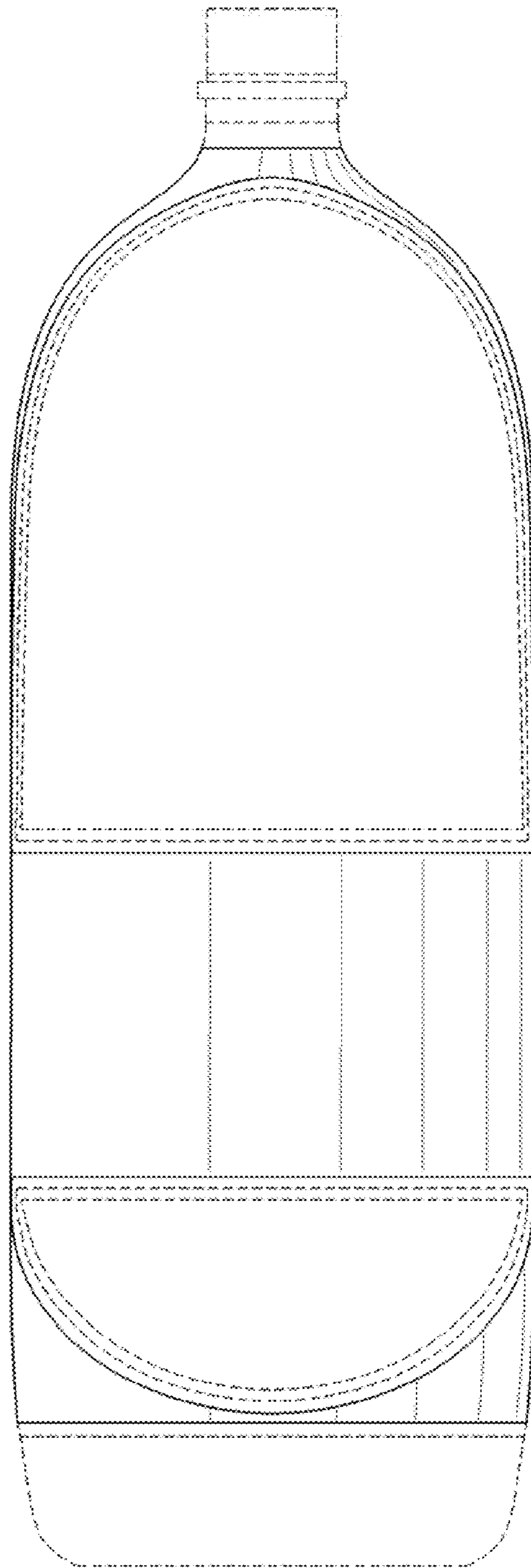

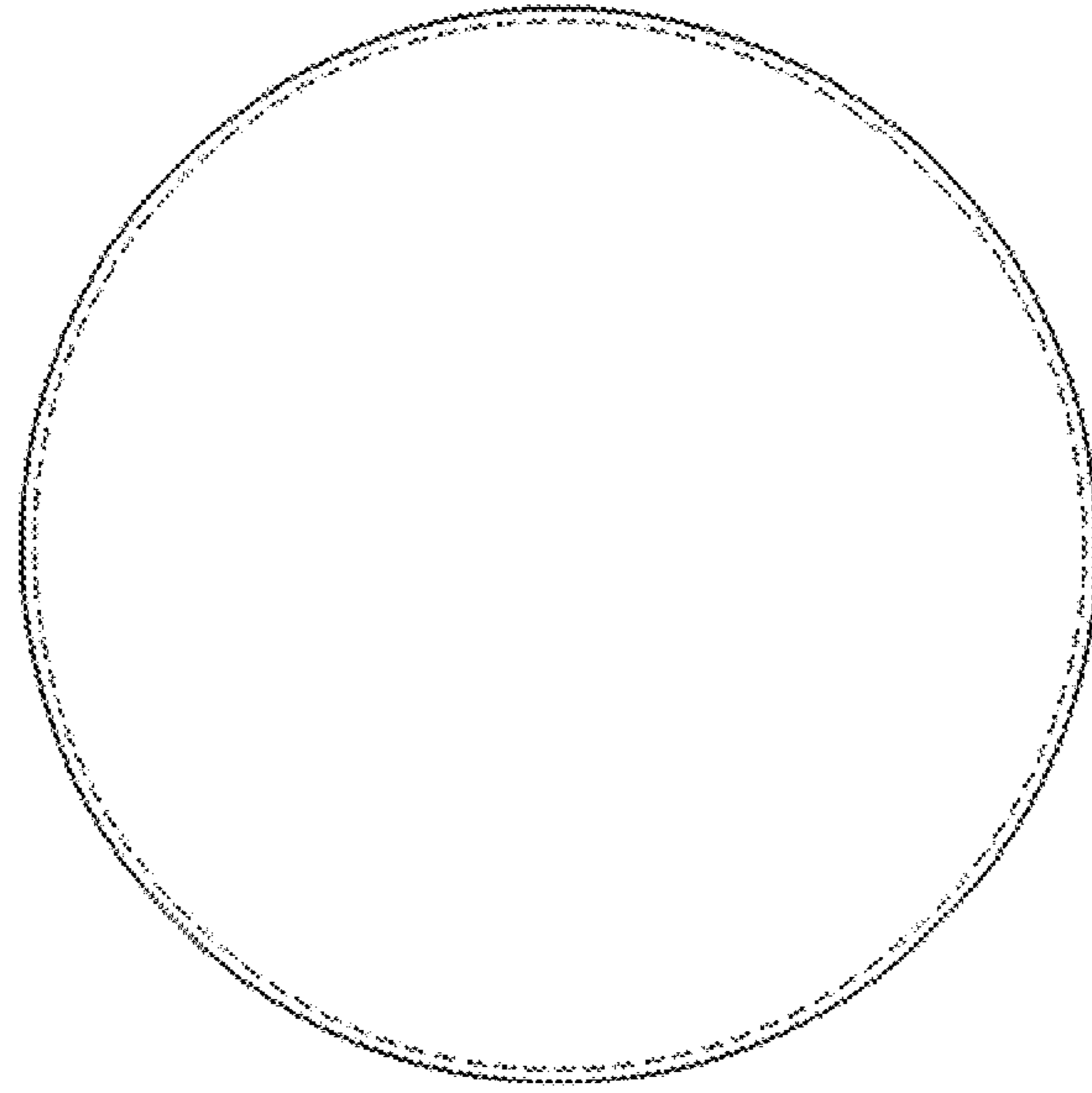

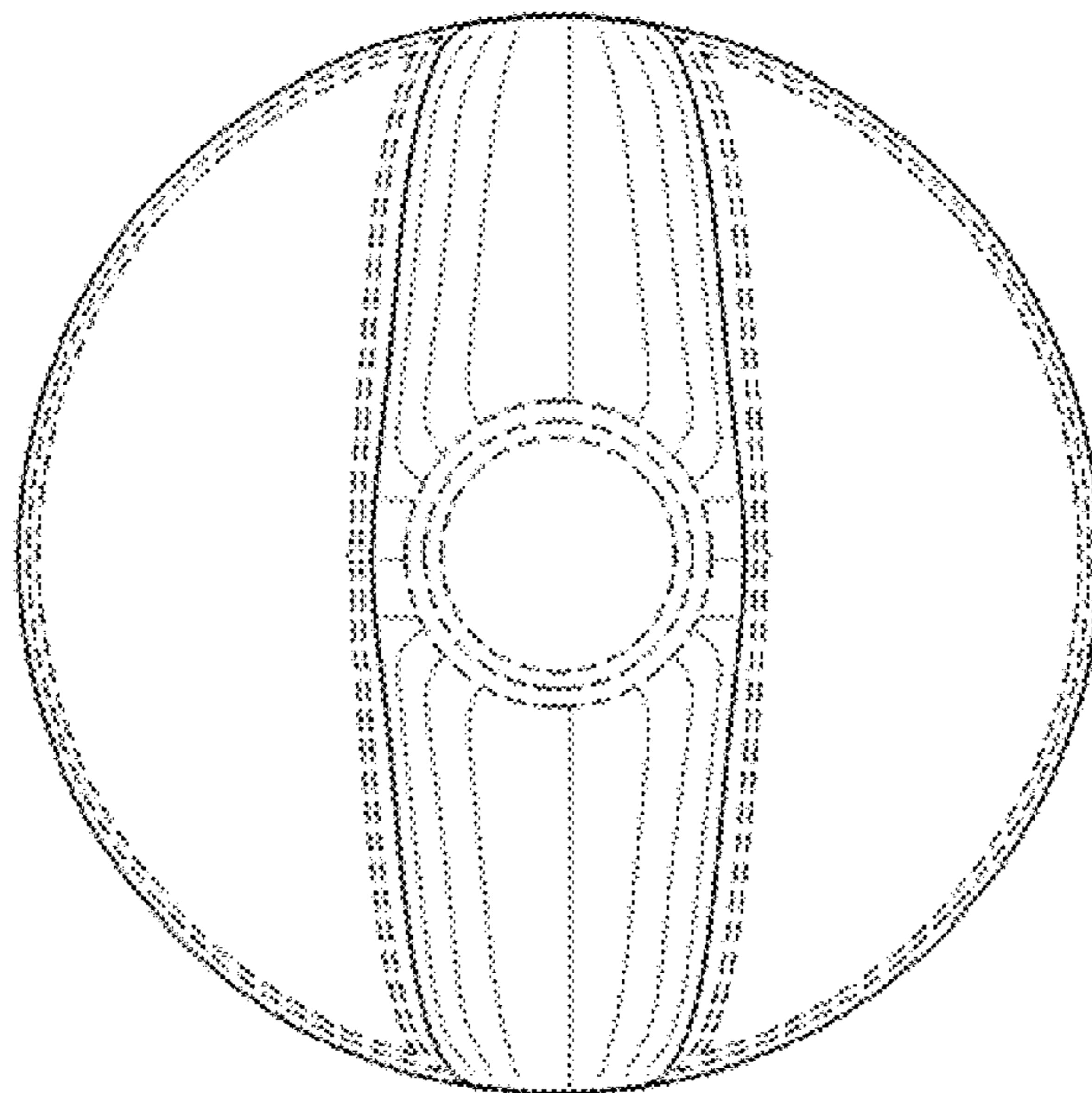
