FIG. 3 is a right side elevation view thereof;

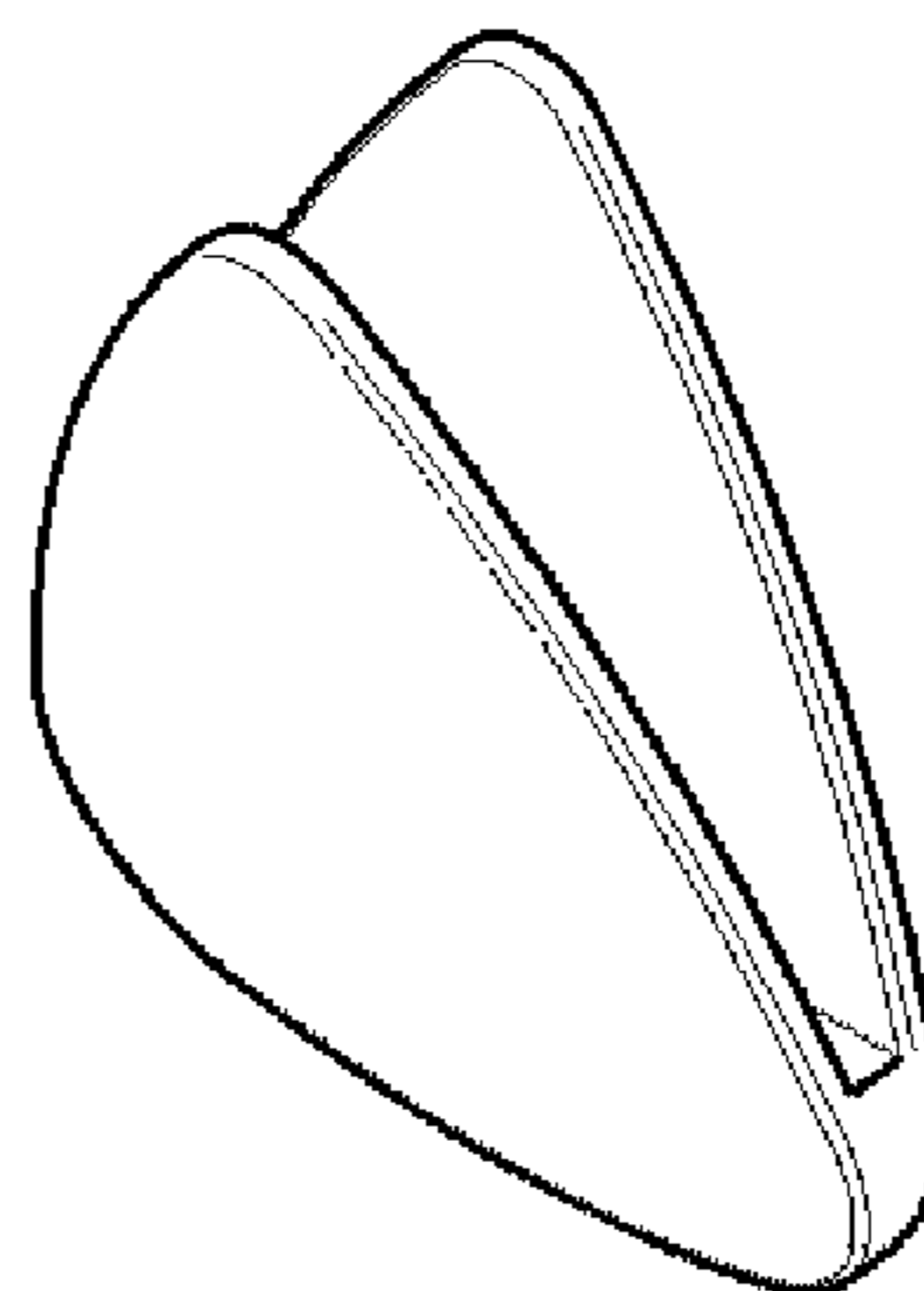
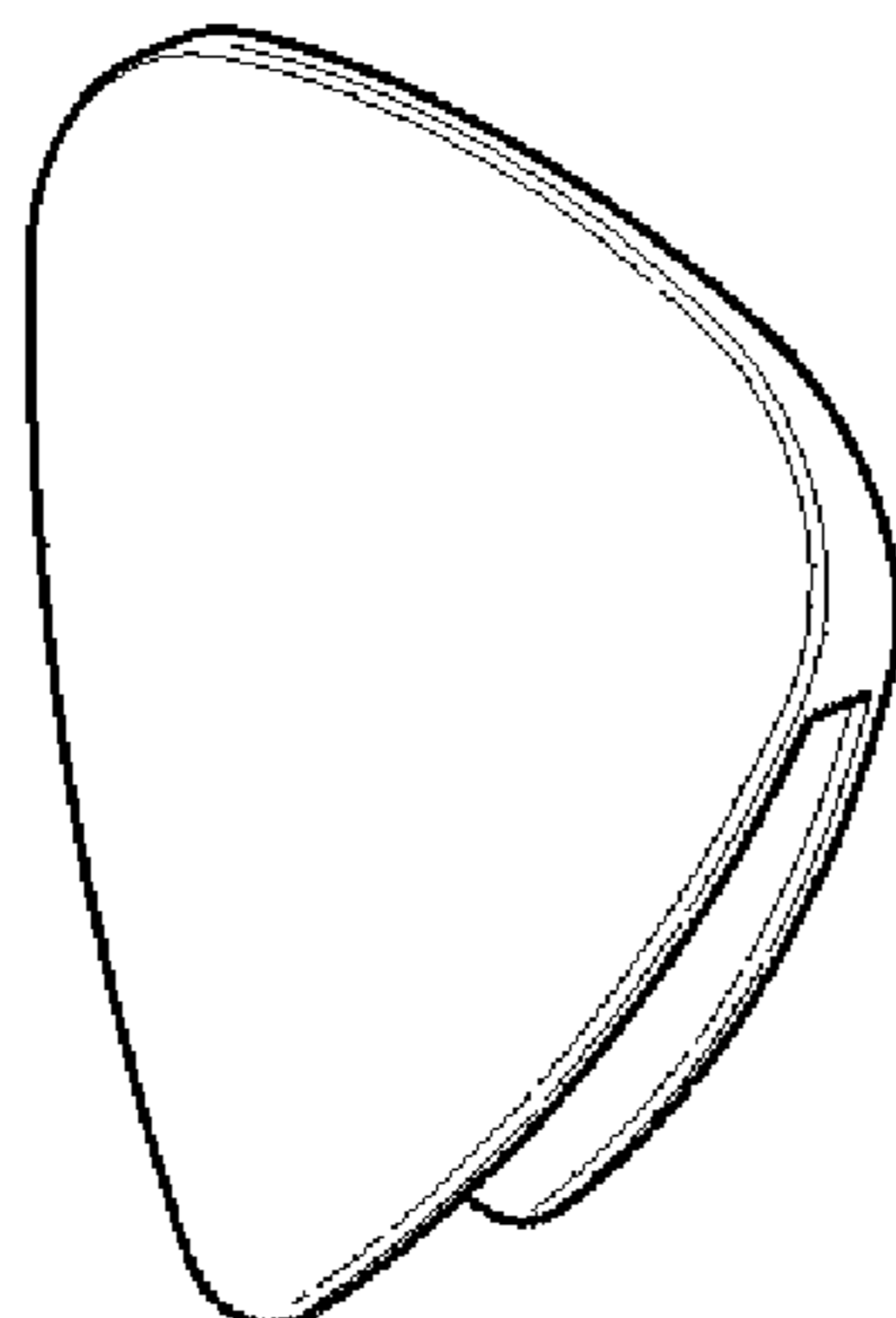
FIG. 4 is a top plan view thereof;

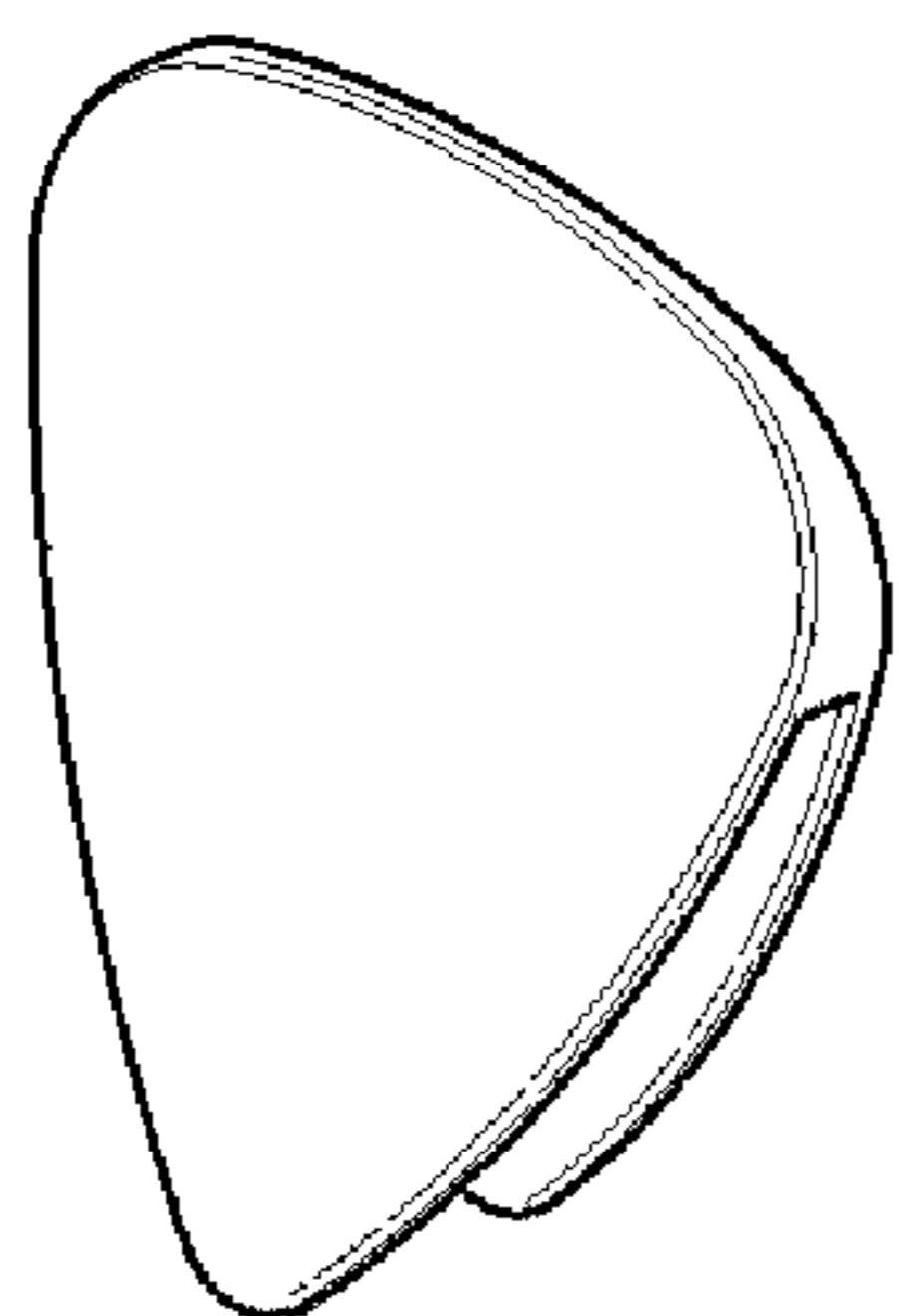

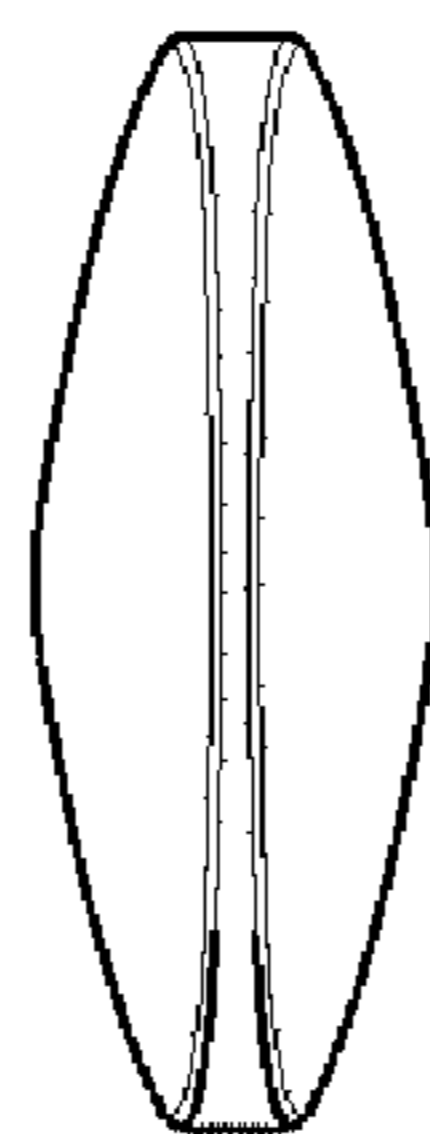

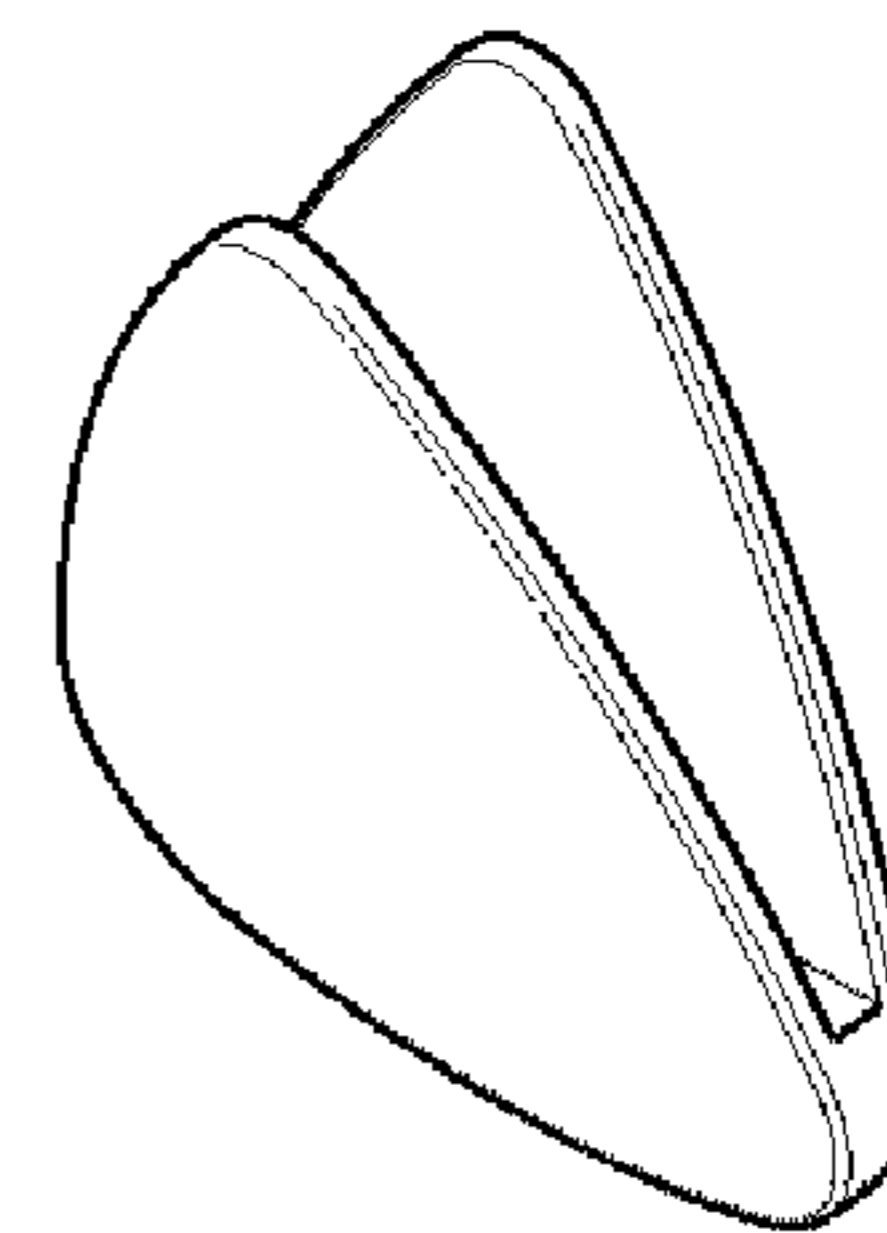

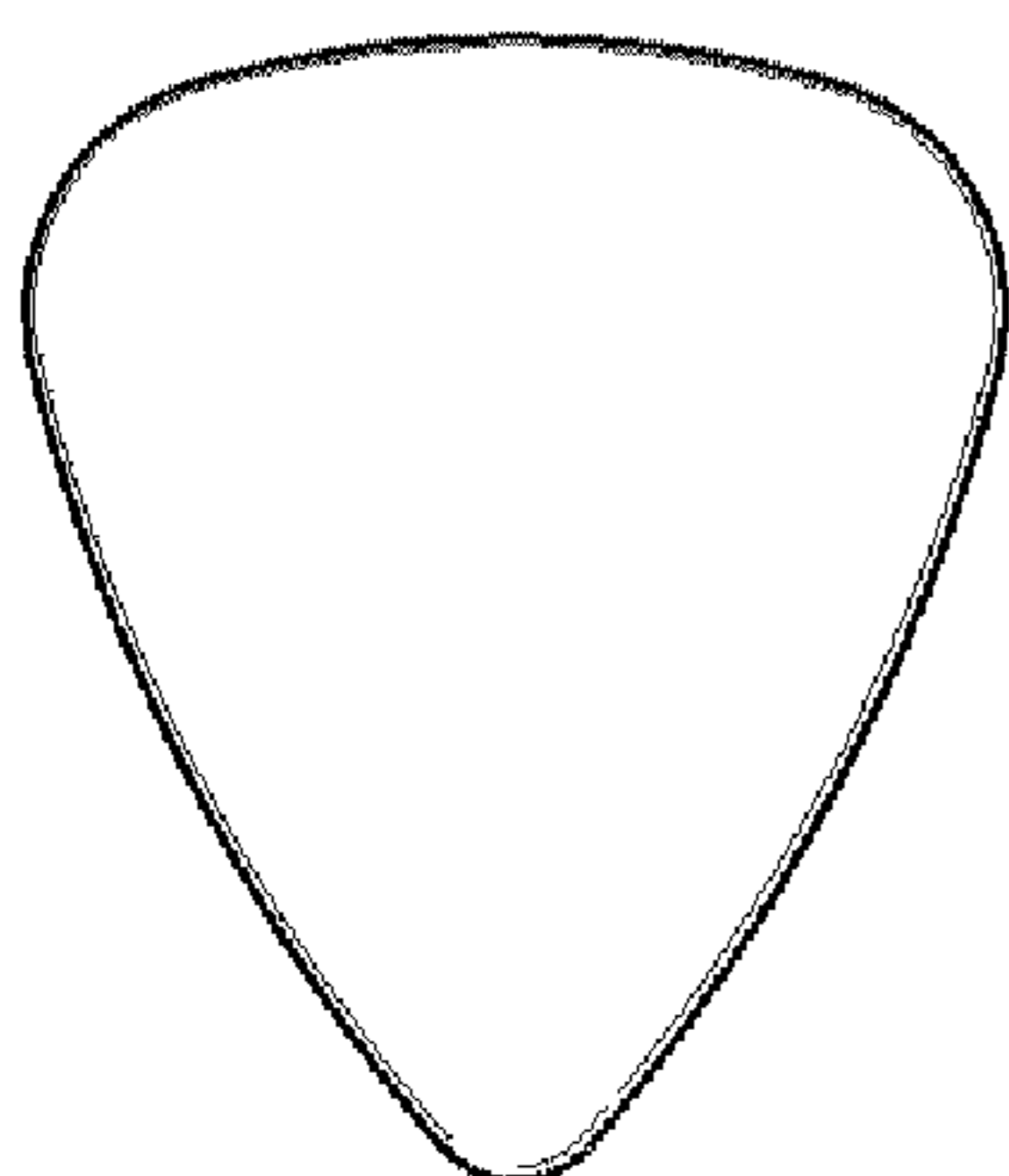

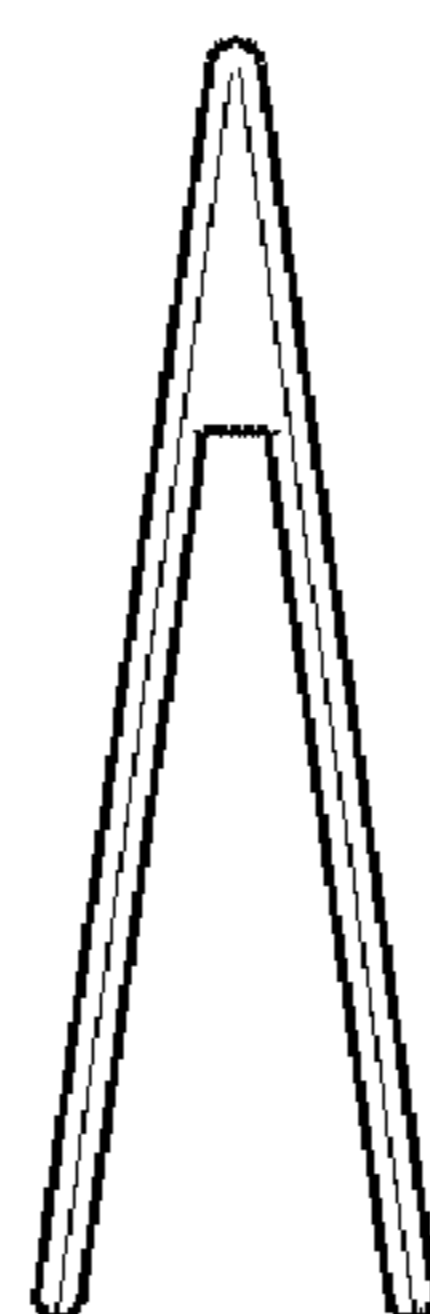

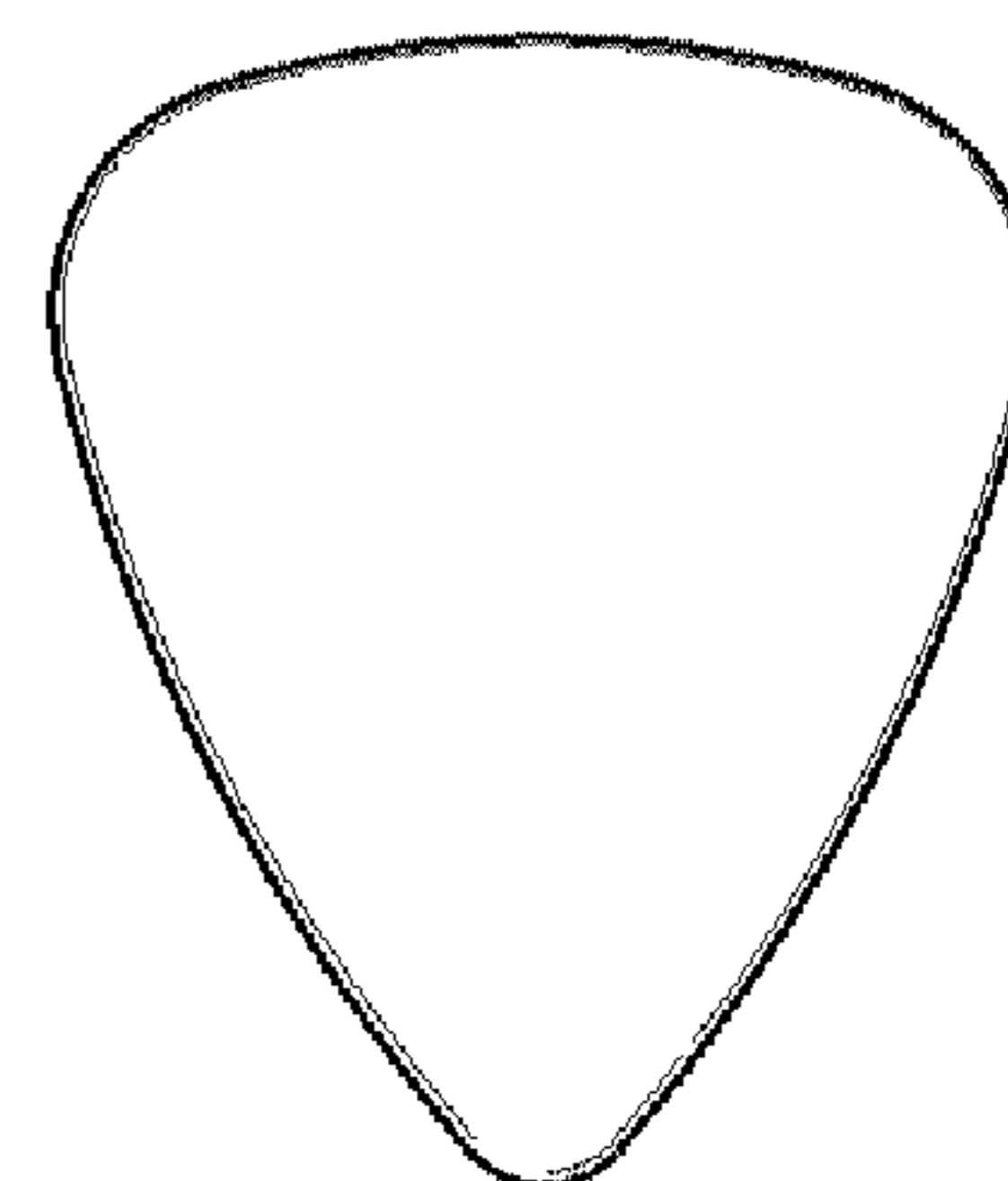

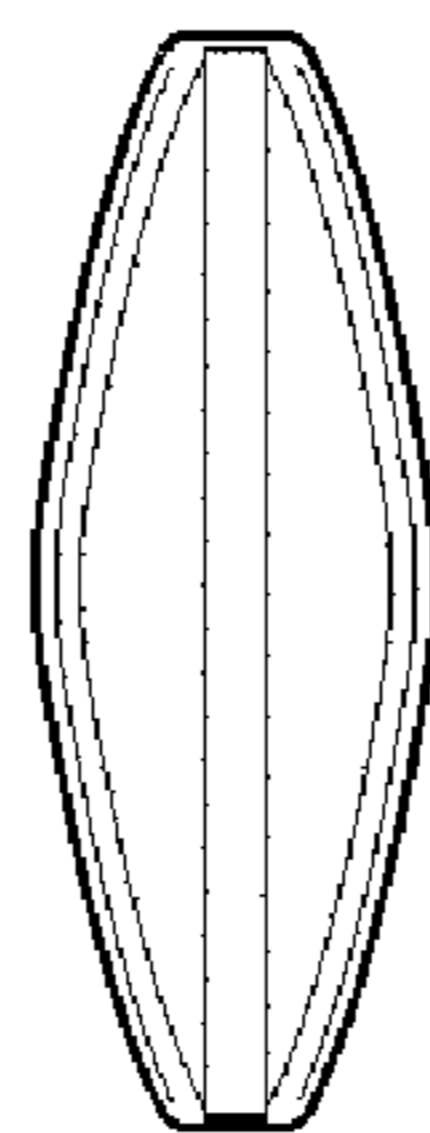
