FIG. 1 is a perspective view of a water heater showing our new design.

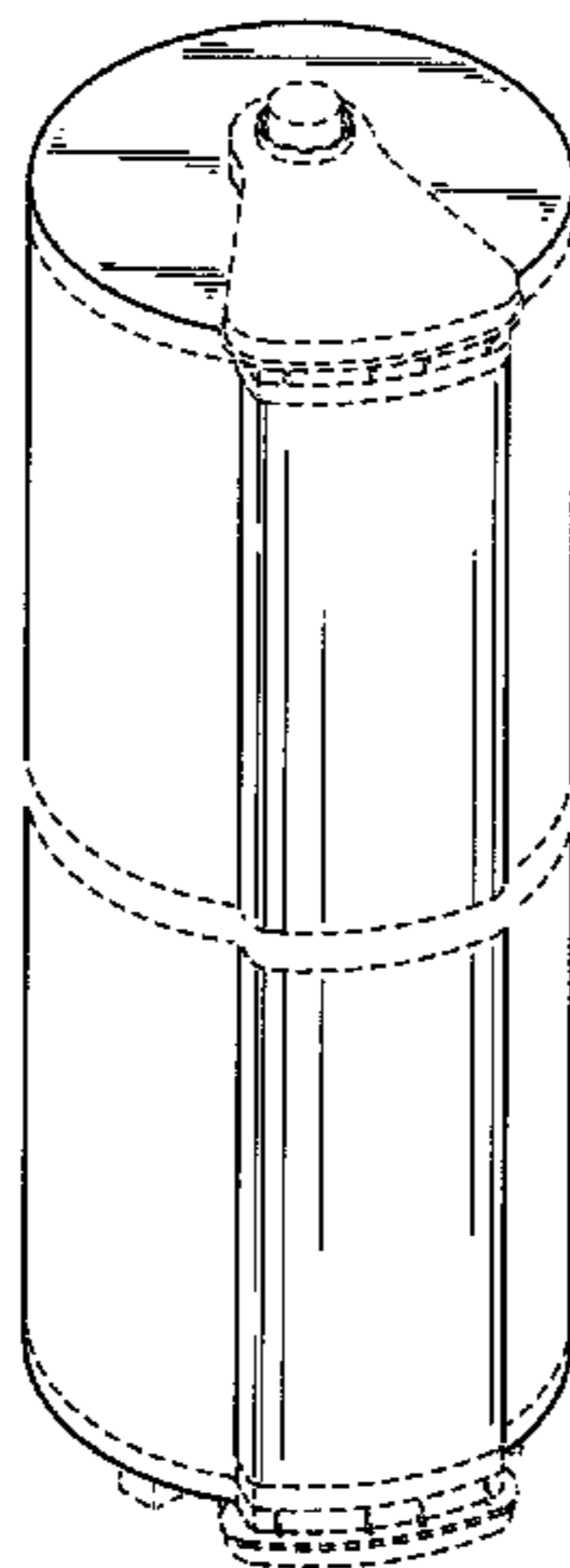
FIG. 2 is a top plan view of the water heater shown in FIG. 1, with the top element shown broken away to disclose the top of the claimed portion thereof.

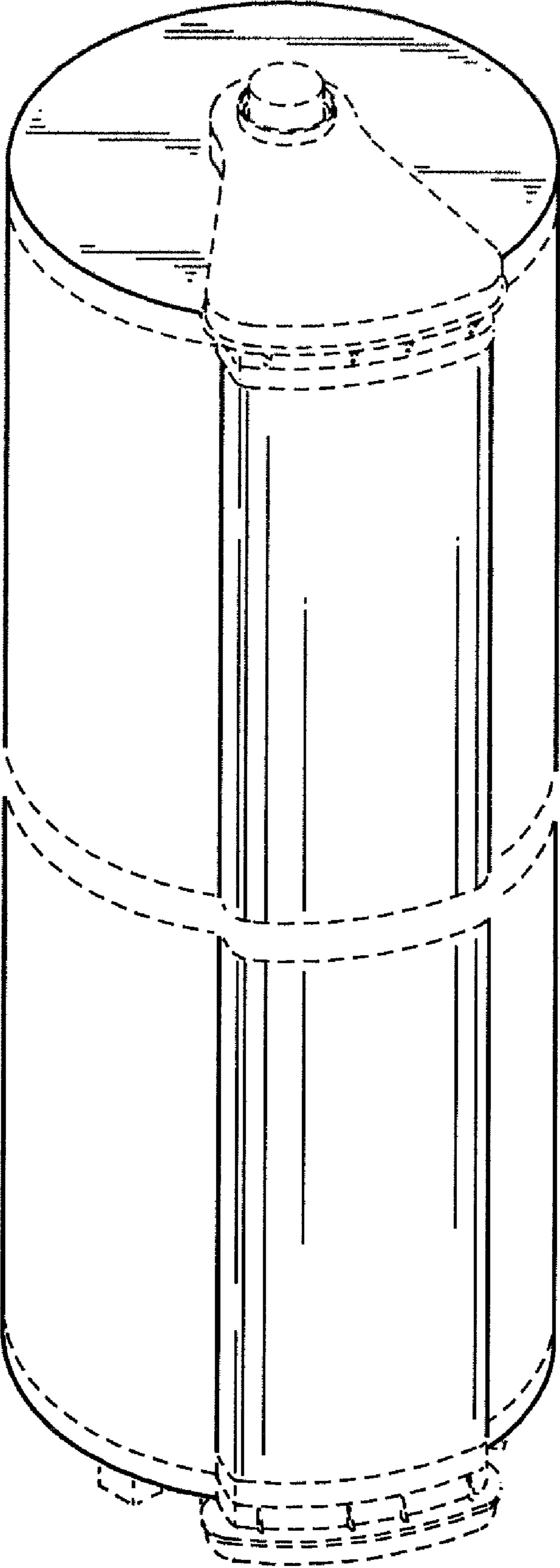

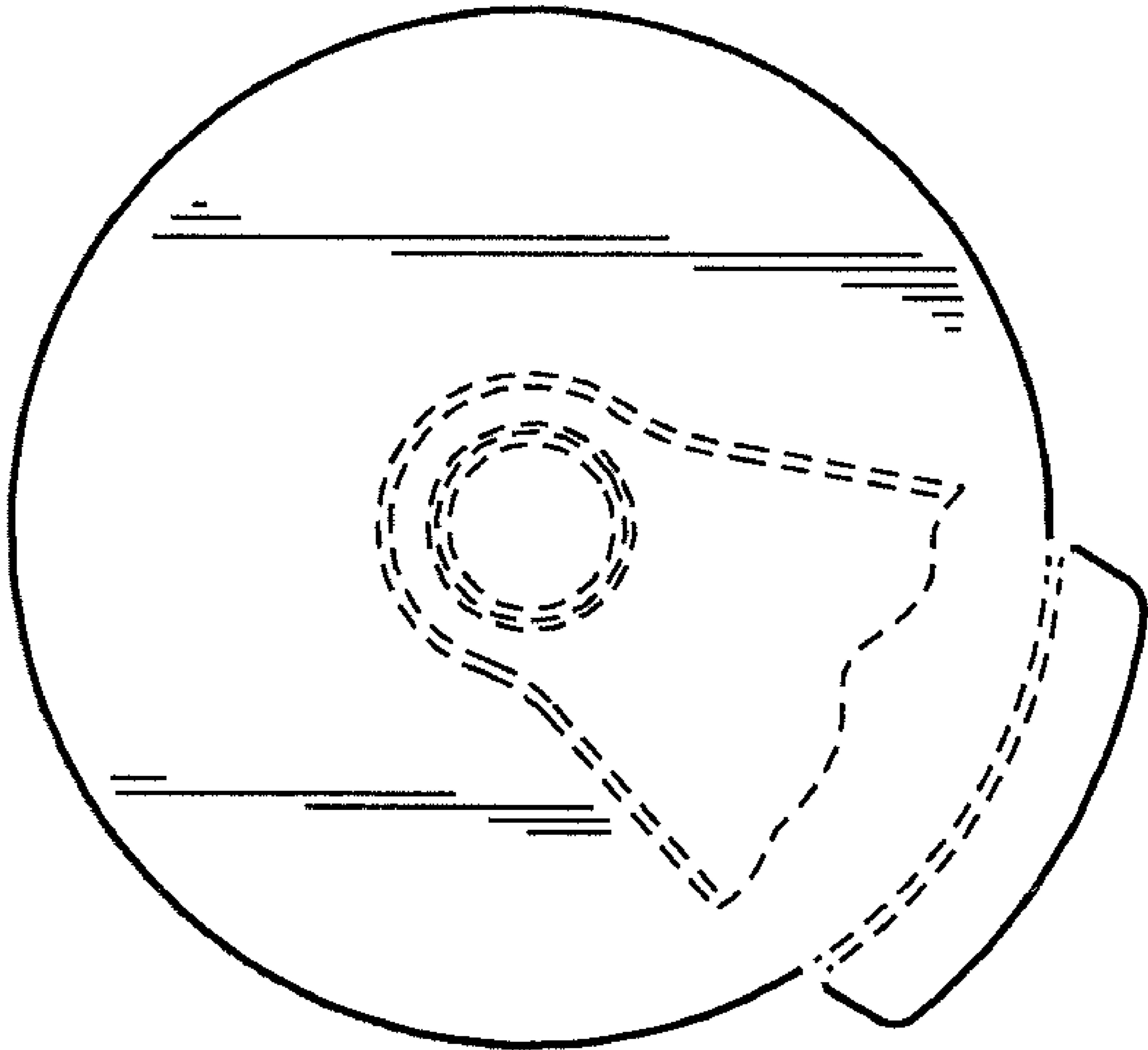

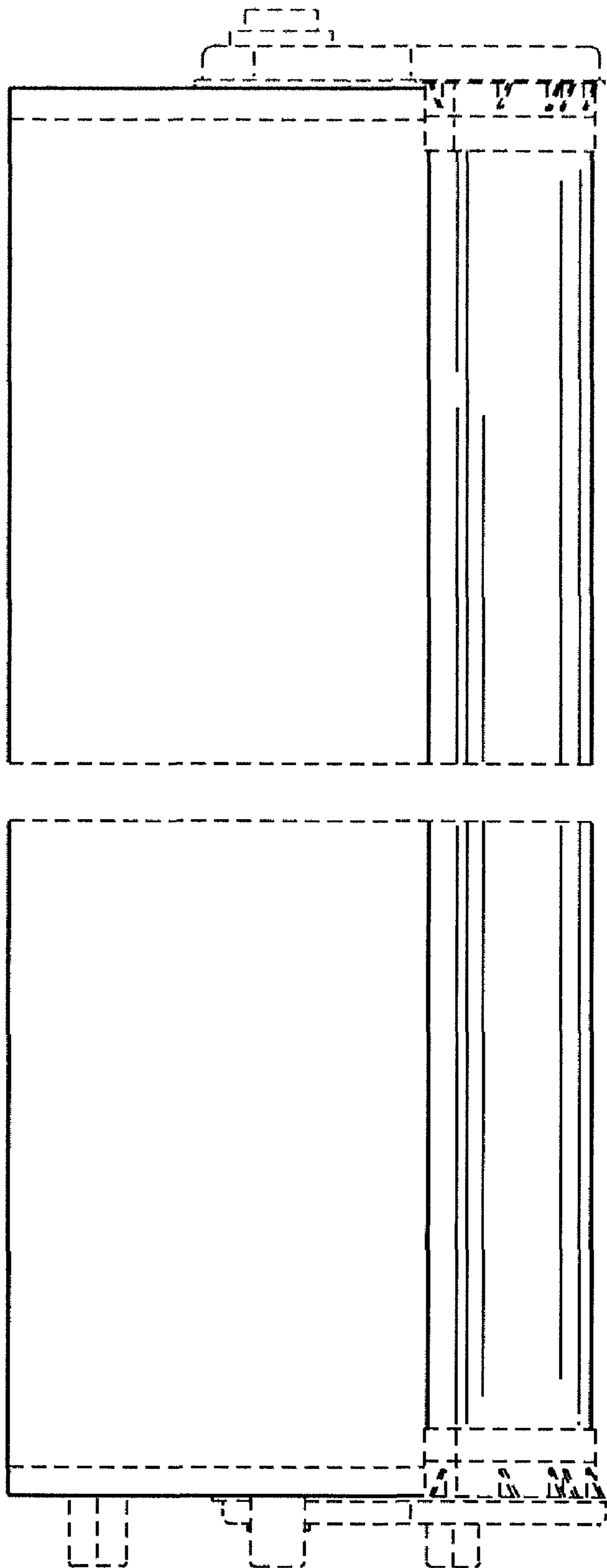
