The ornamental design for a connector for medical device, as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view of a connector for medical device according to an embodiment of the present invention.

FIG. 2 is a right side perspective view of the connector for medical device of FIG. 1.

FIG. 3 is a top perspective view of the connector for medical device of FIG. 1.

FIG. 4 is a bottom perspective view of the connector for medical device of FIG. 1.

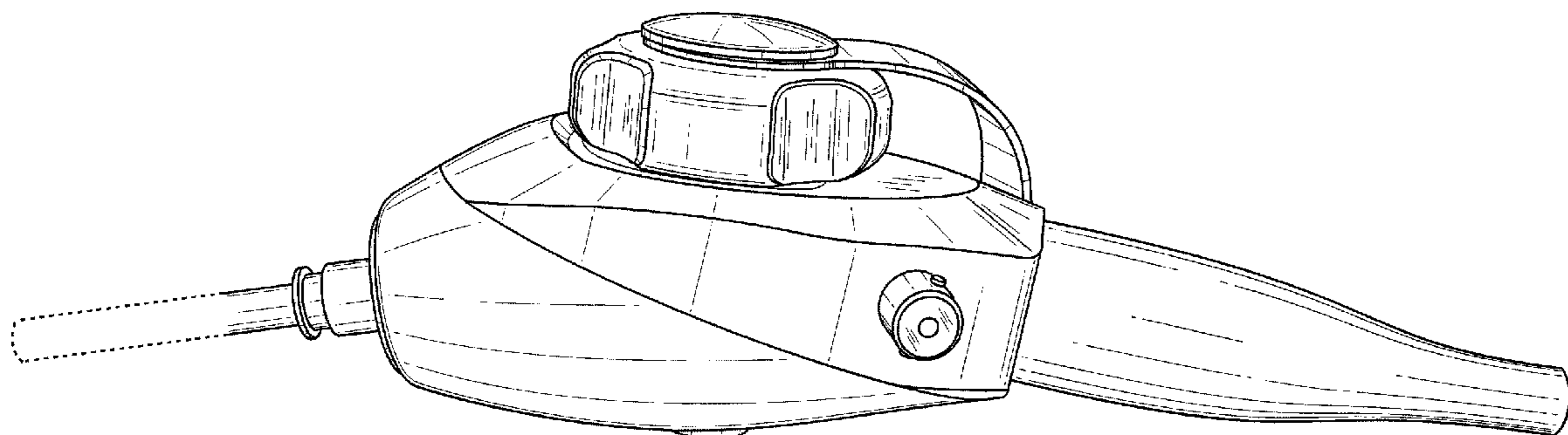
FIG. 5 is a rear perspective view of the connector for medical device of FIG. 1.

FIG. 6 is a front perspective view of the connector for medical device of FIG. 1; and,

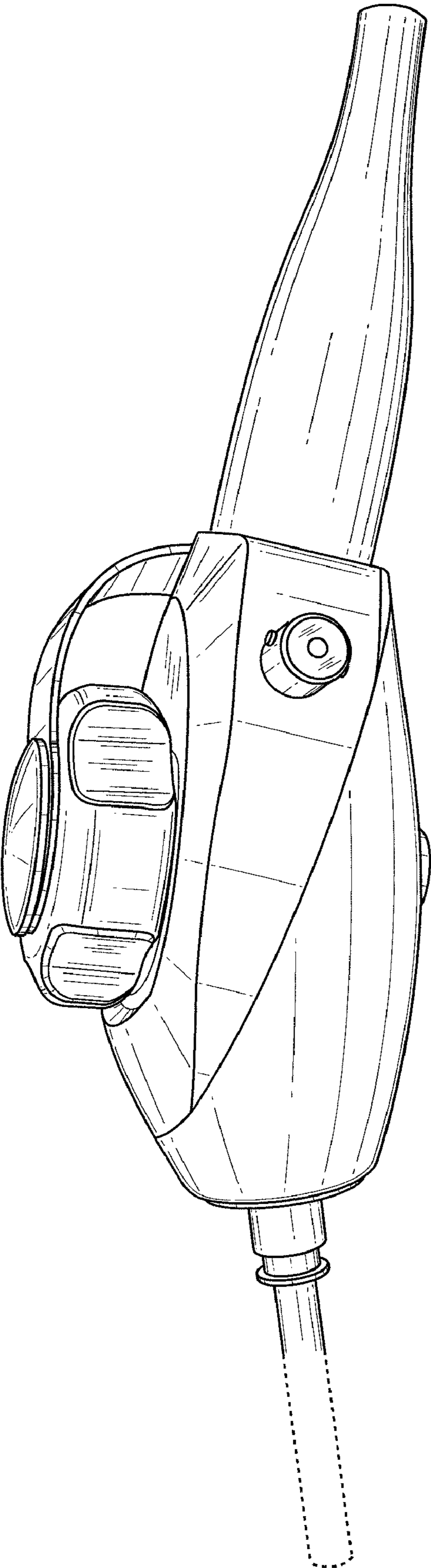

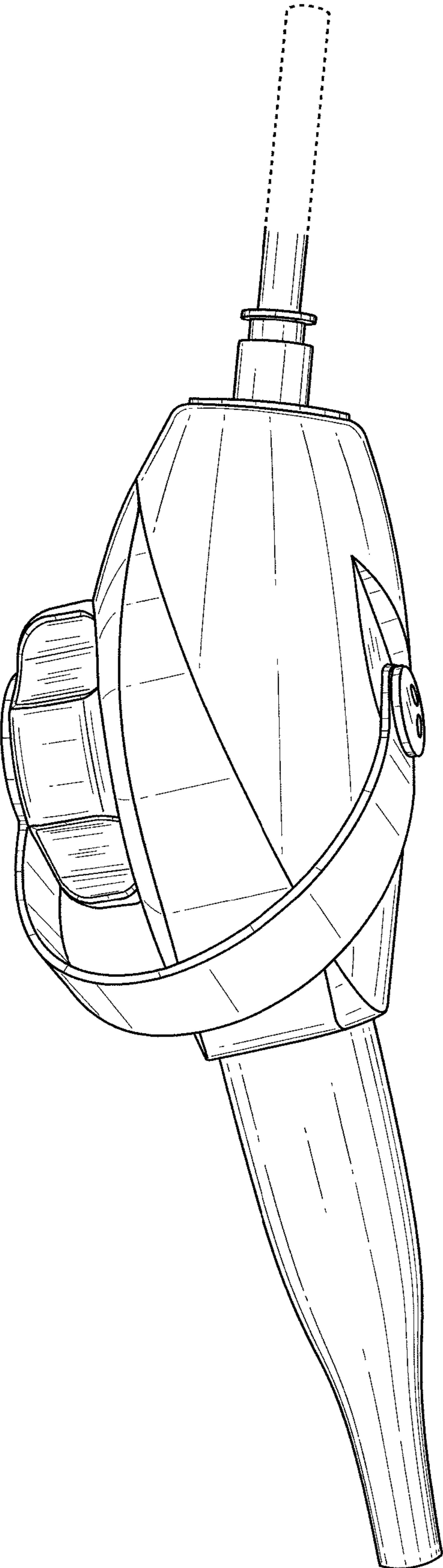

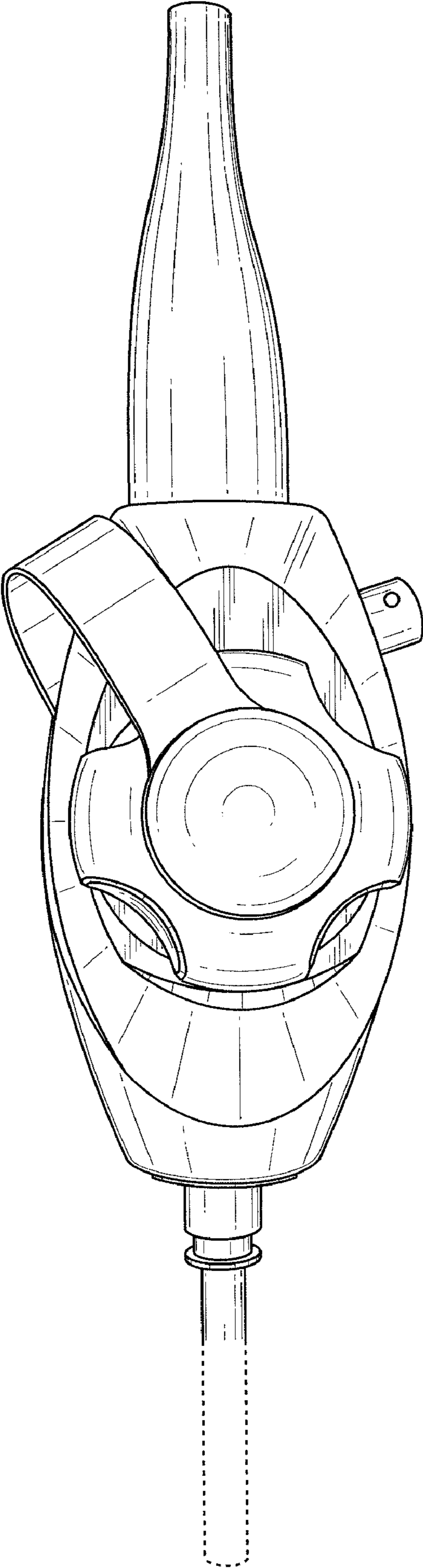

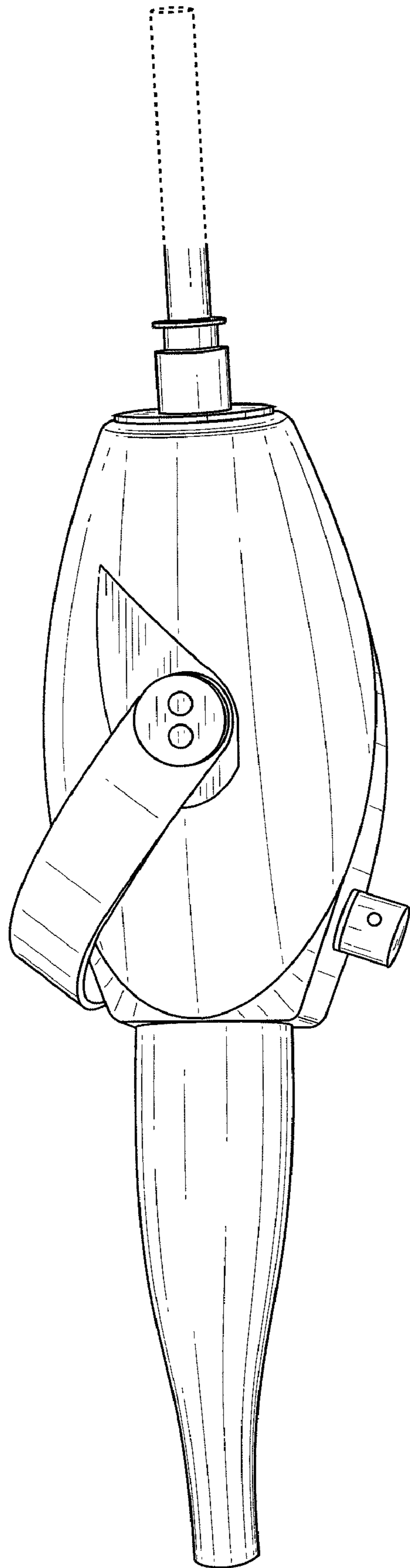

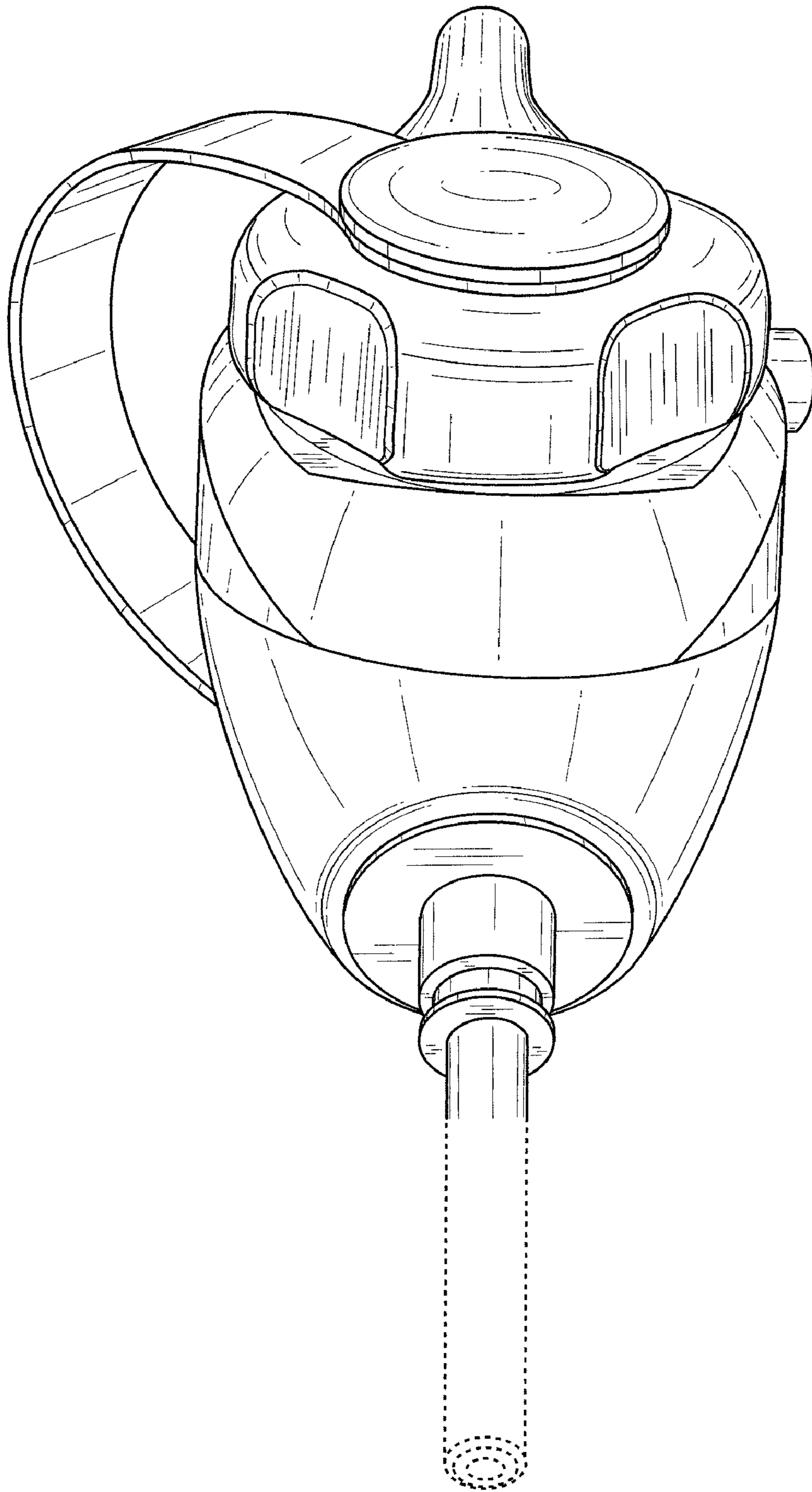

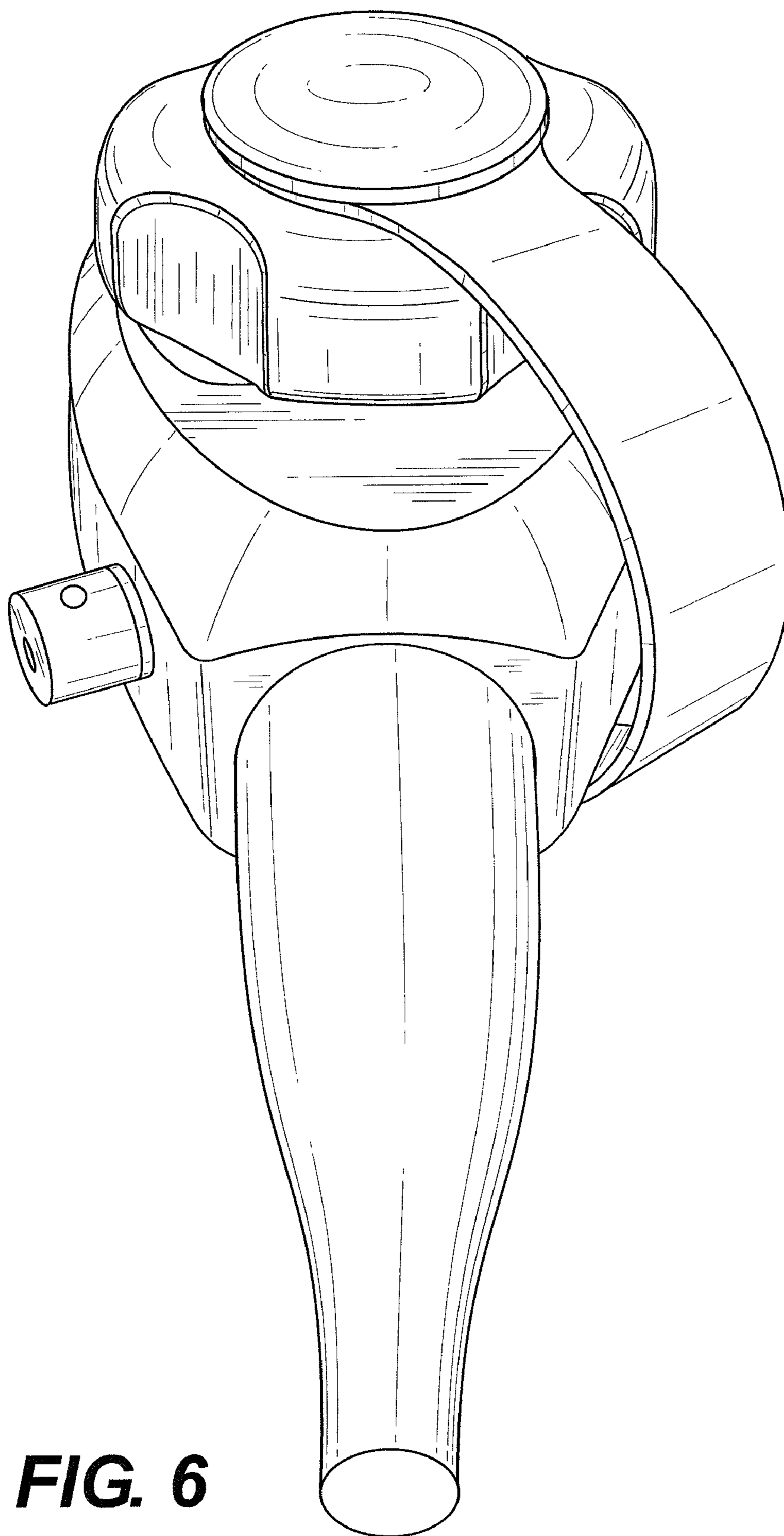

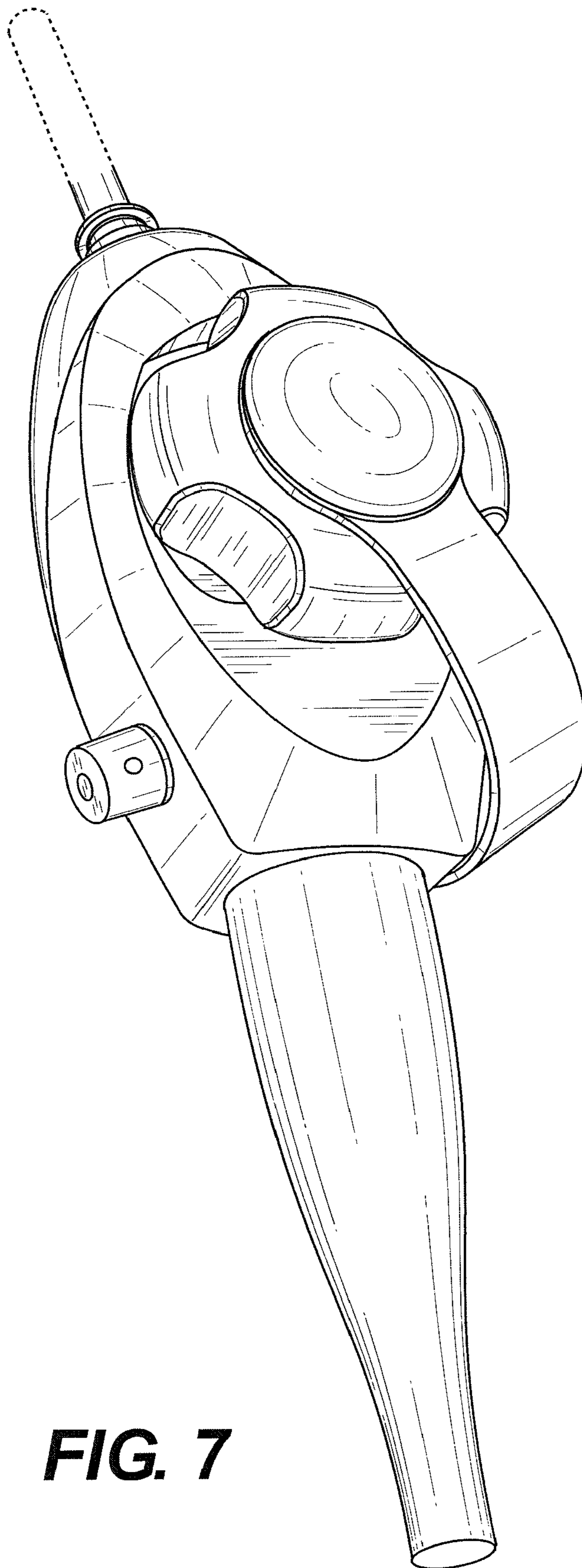
