(57) **CLAIM**

The ornamental design for a lavender spa bowl, as shown and described.

**DESCRIPTION**

FIG. 1 is a prospective front-top view of the lavender spa bowl.

FIG. 2 is a prospective rear-top view of the lavender spa bowl.

FIG. 3 is a prospective top view of the lavender spa bowl.

FIG. 4 is a prospective bottom view of the lavender spa bowl.

FIG. 5 is a prospective right -side view of the lavender spa bowl.

FIG. 6 is a prospective left-side view of the lavender spa bowl.

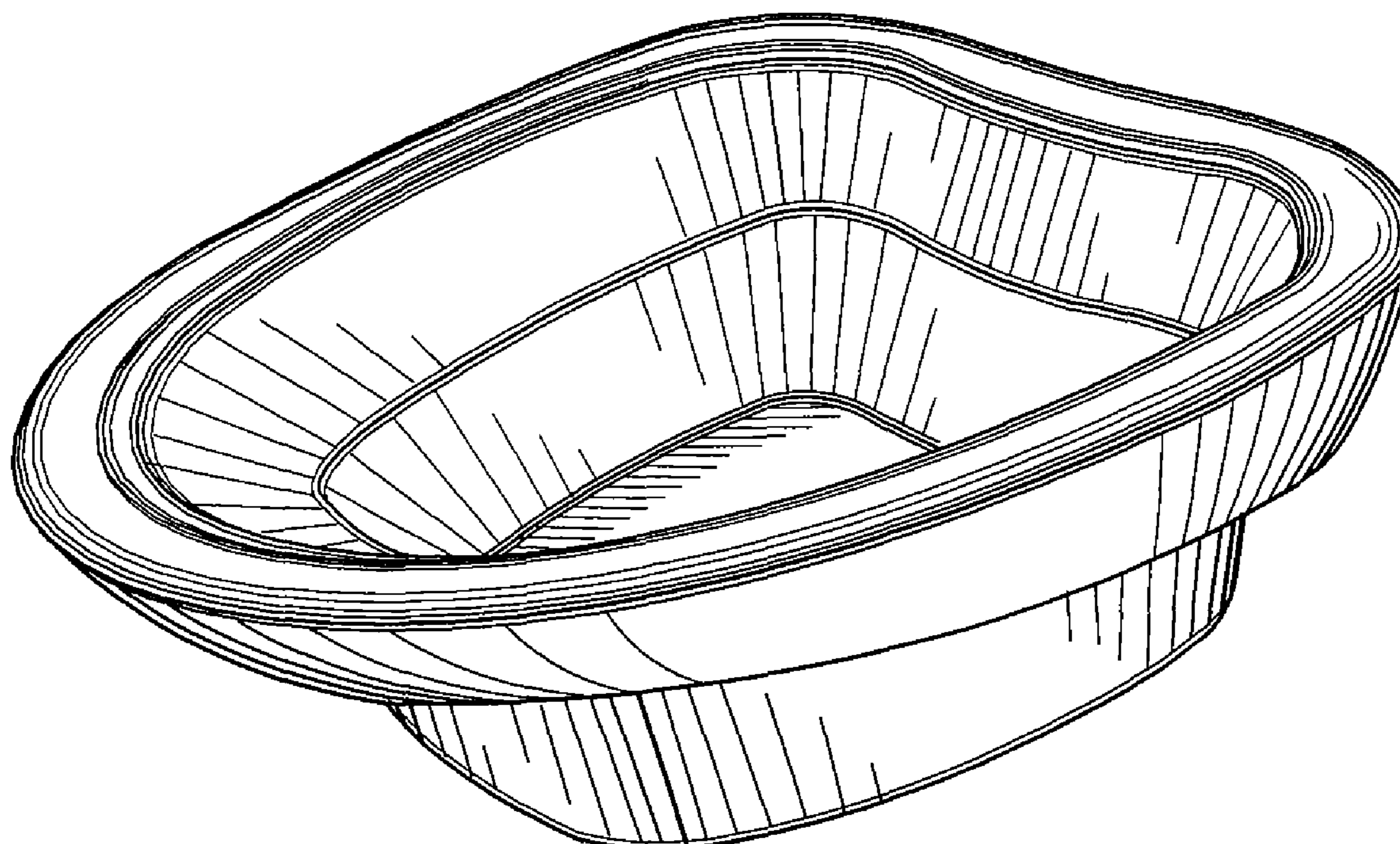
FIG. 7 is a prospective front view of the lavender spa bowl.

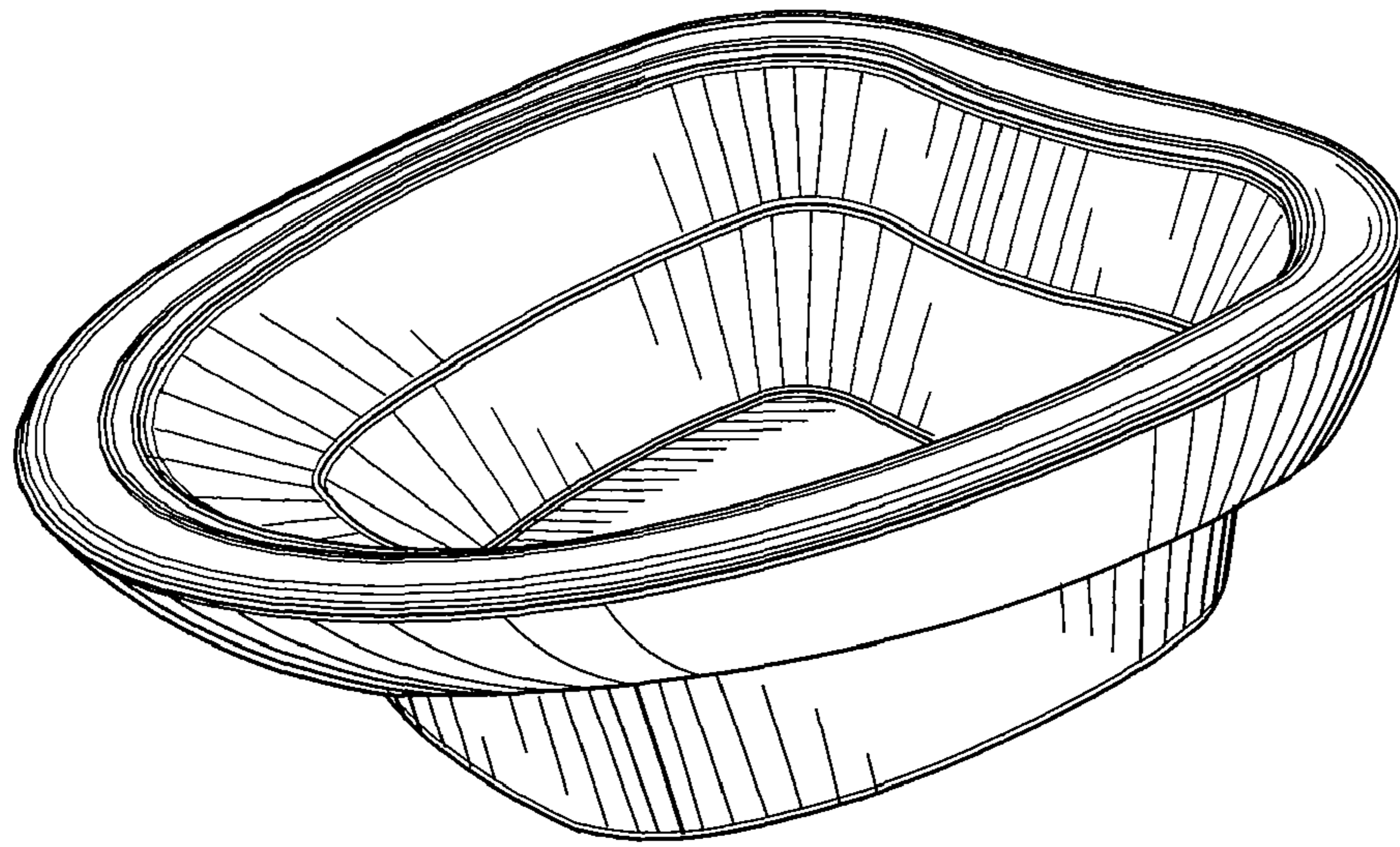

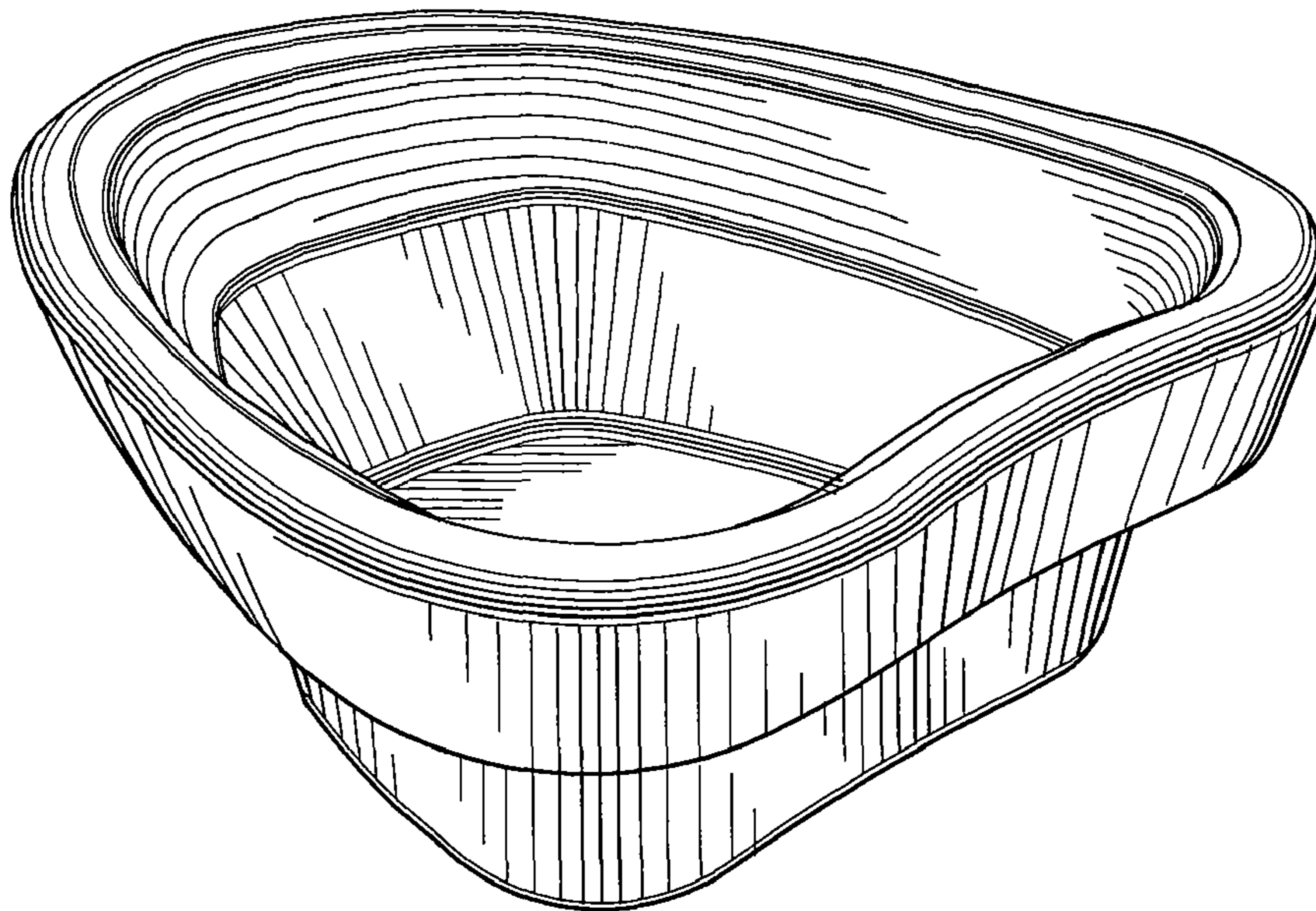

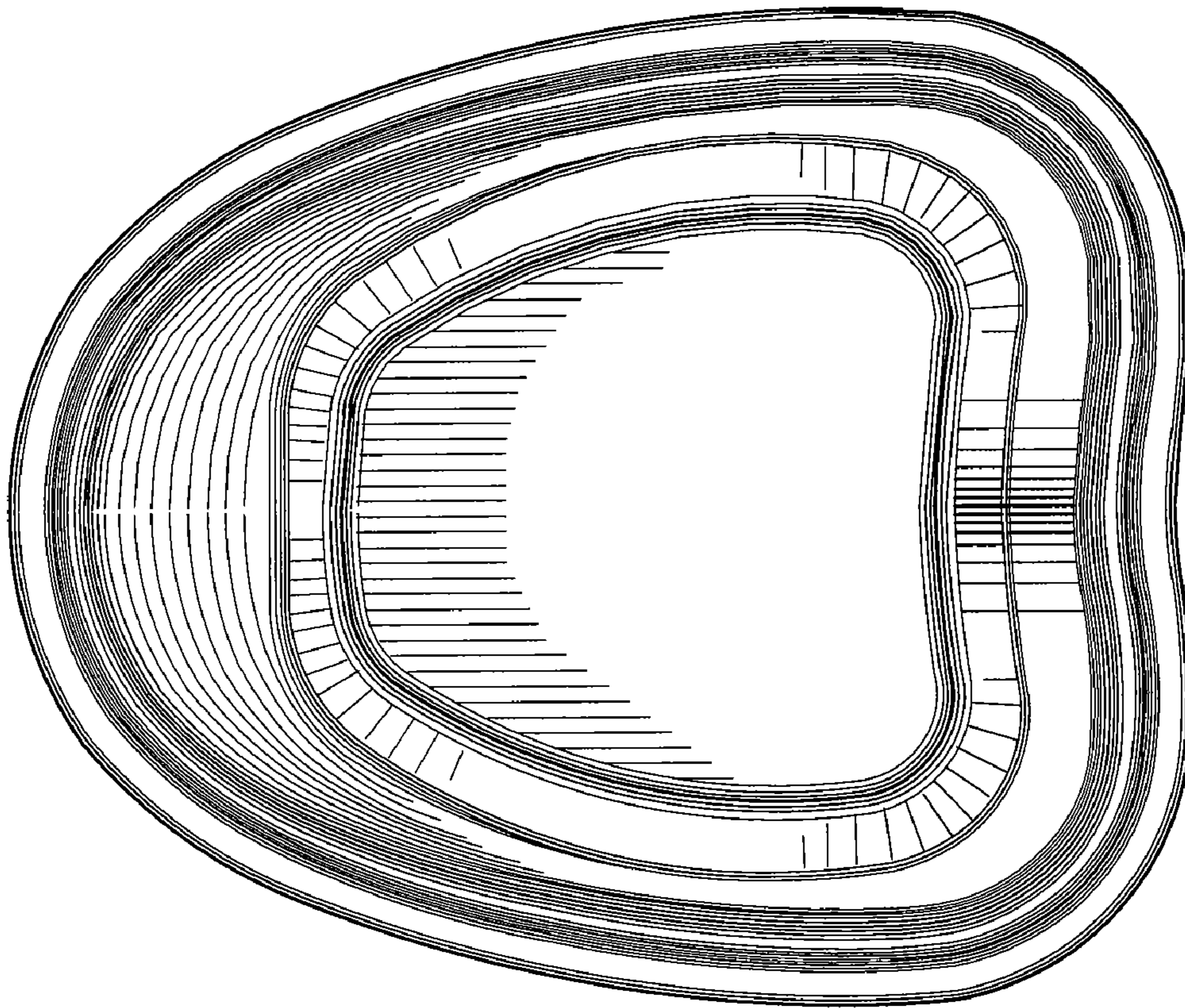

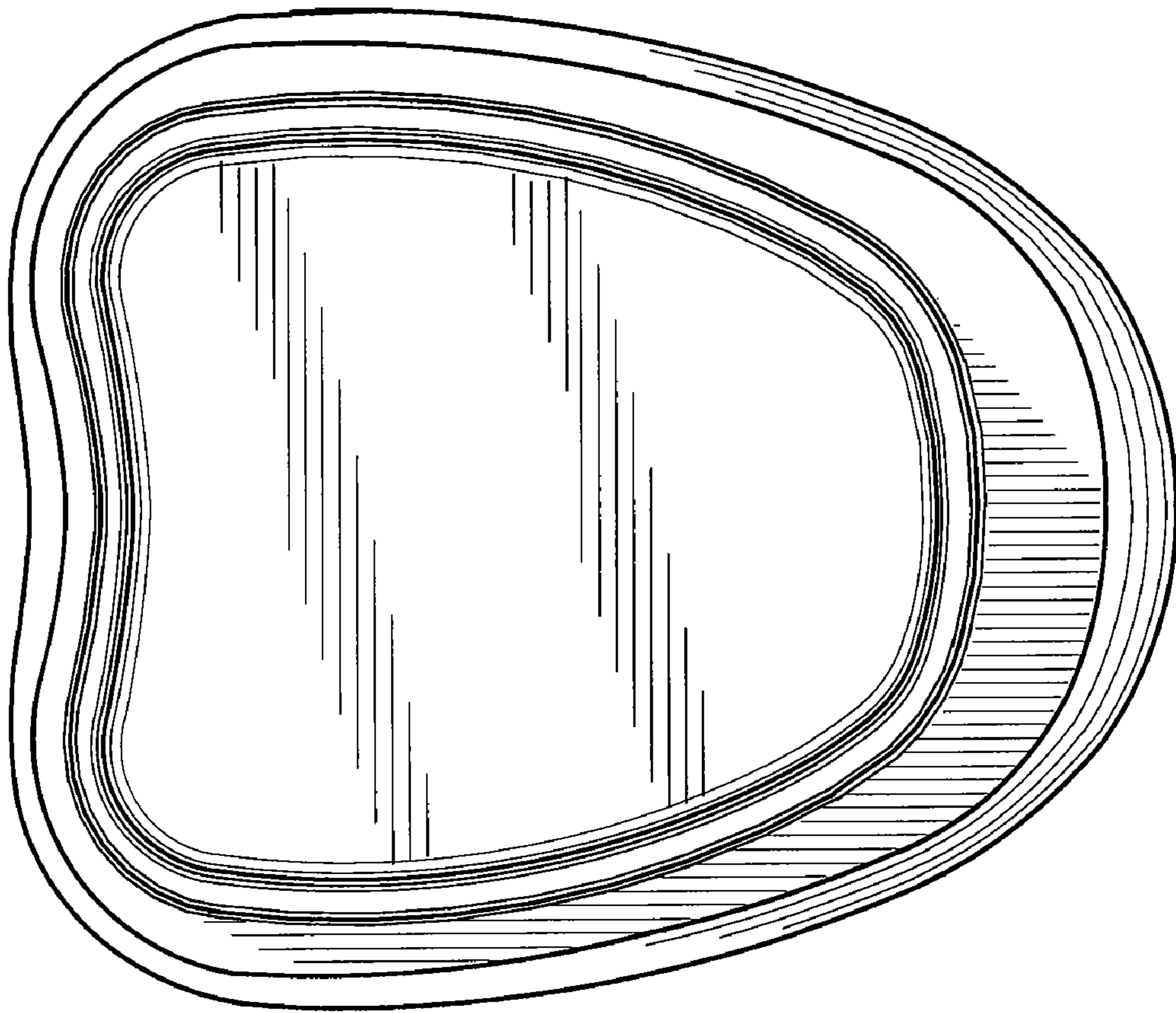

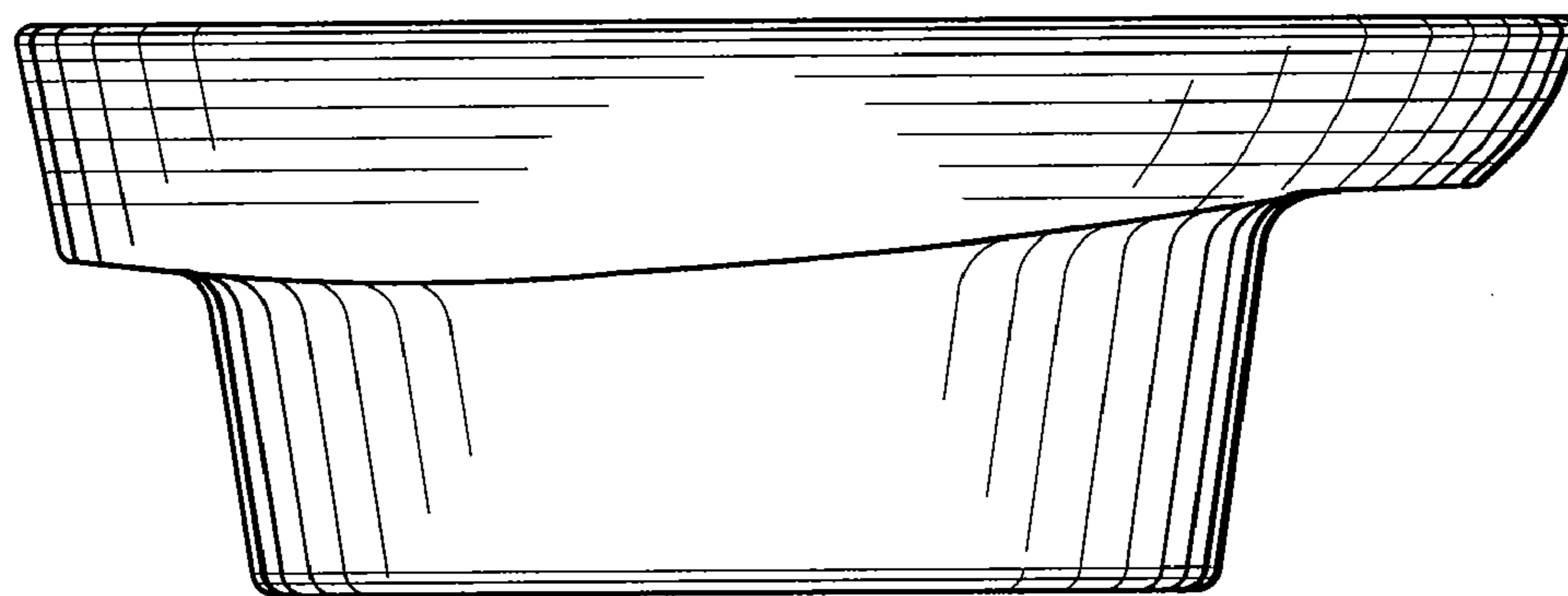

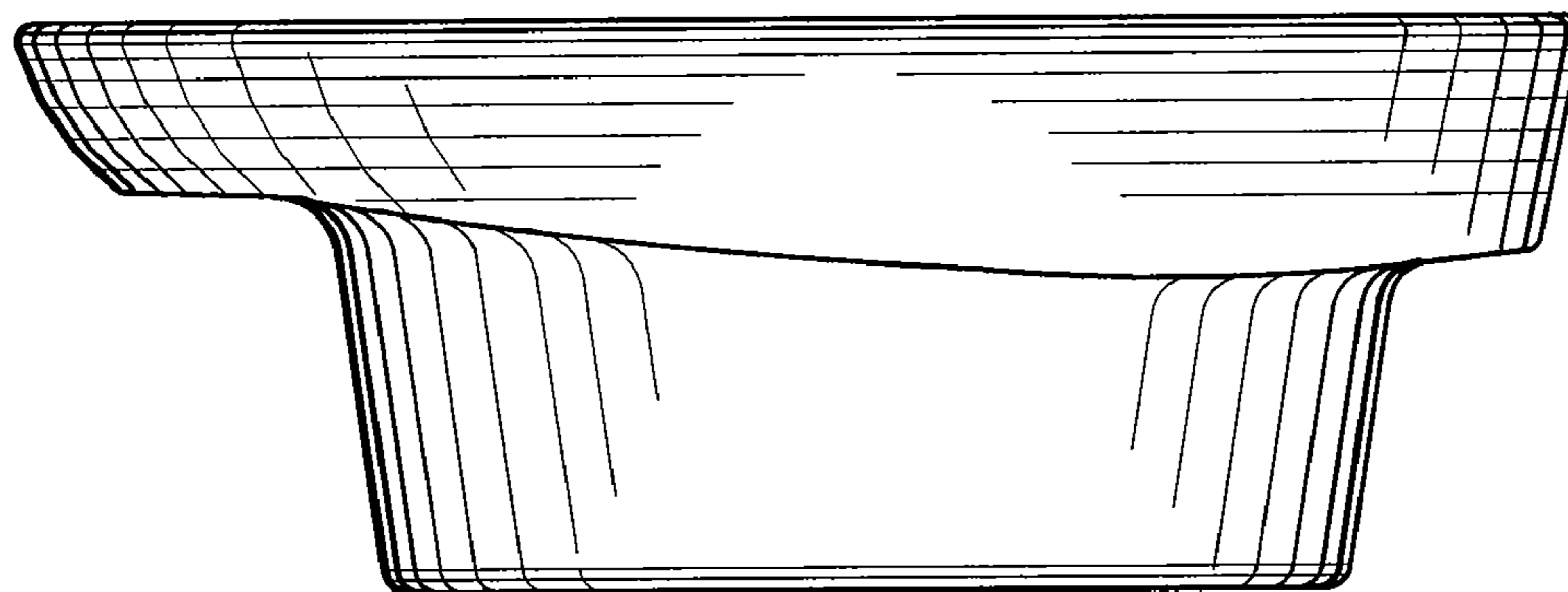

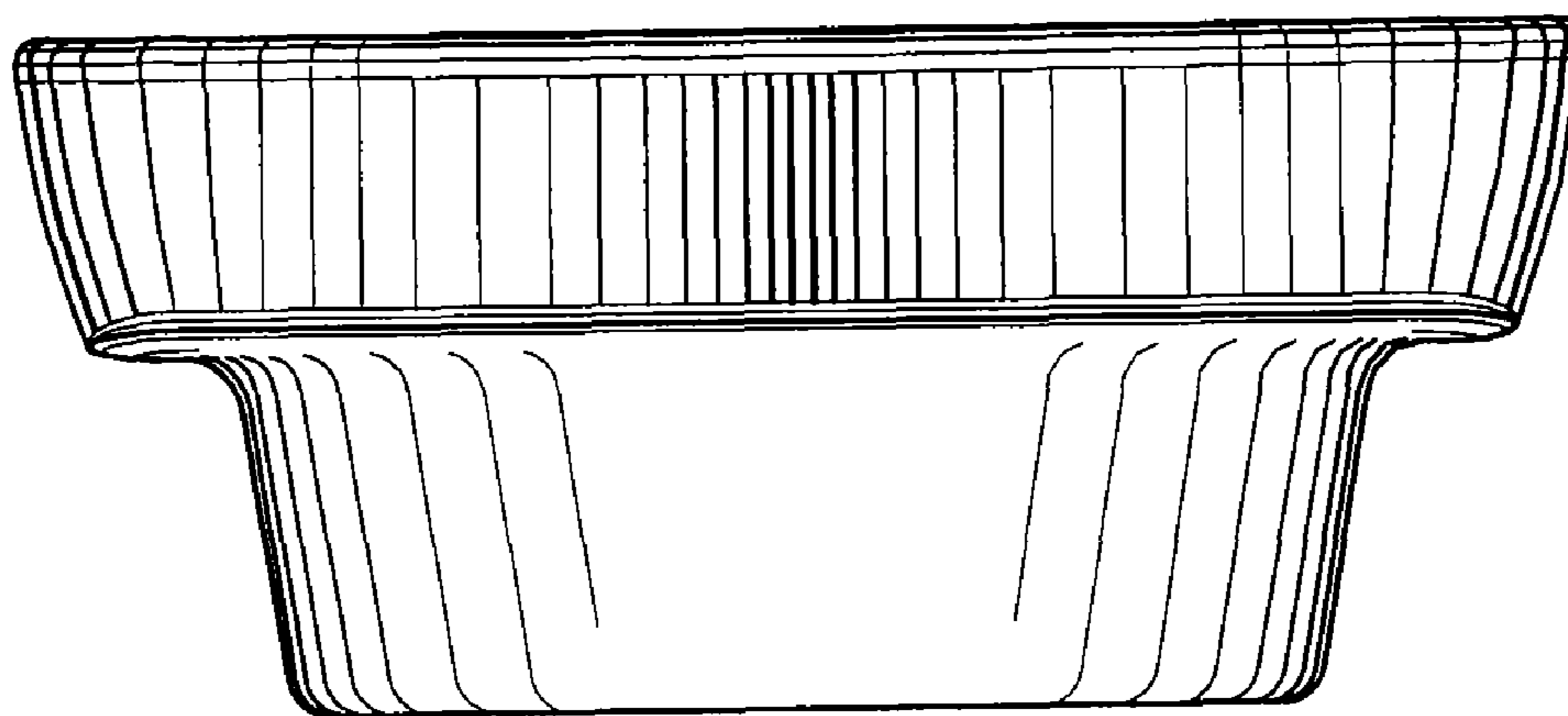

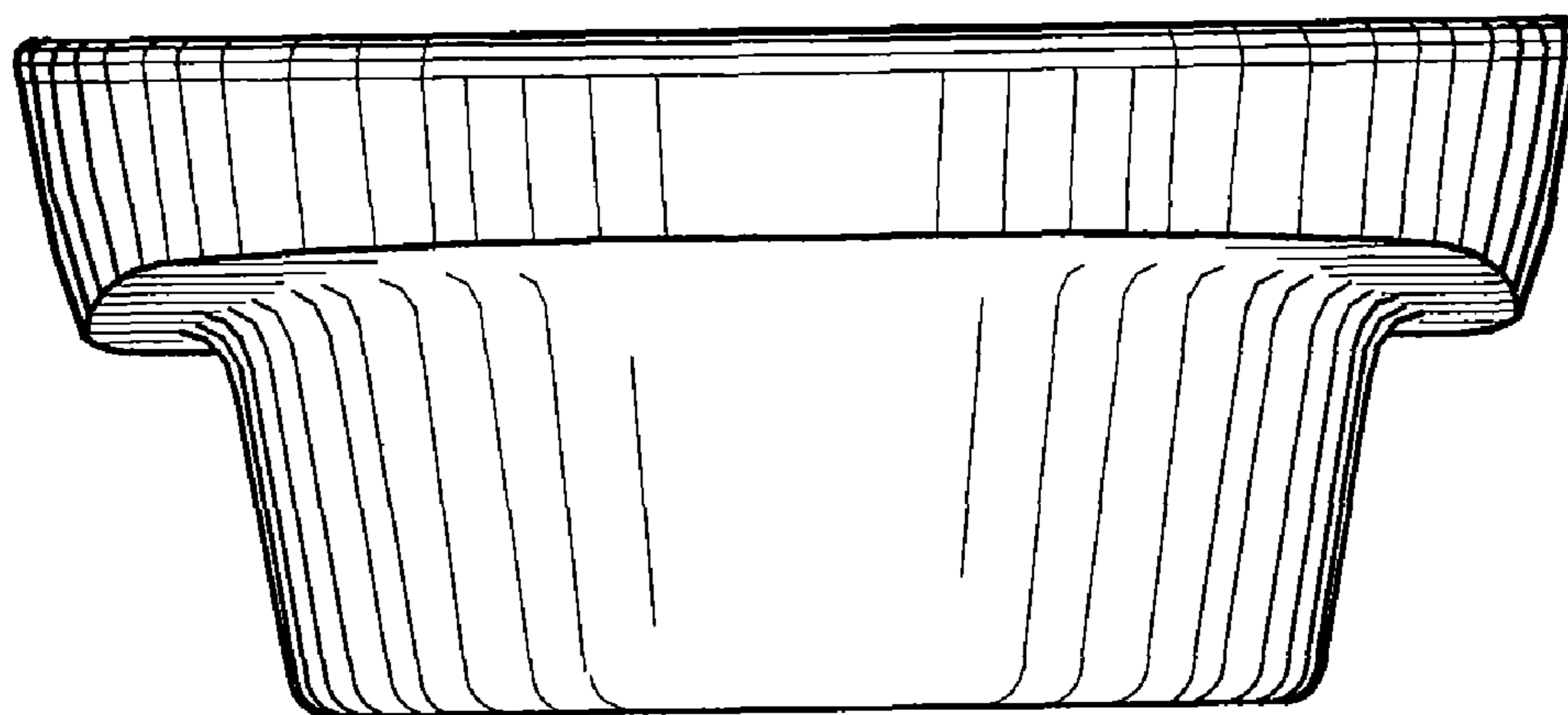

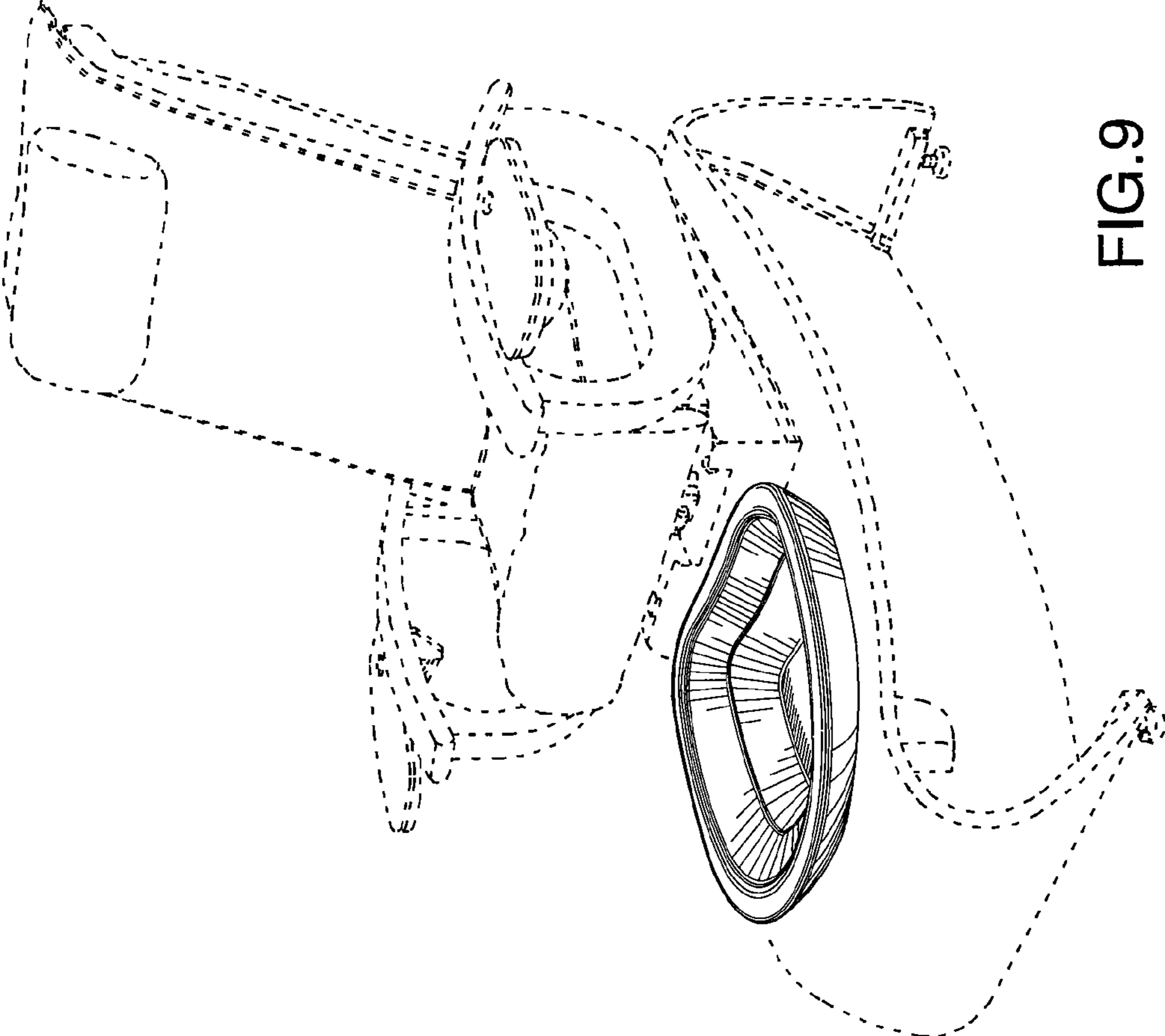
