The ornamental design for a sterilizer door panel, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a sterilizer door panel showing our new design.

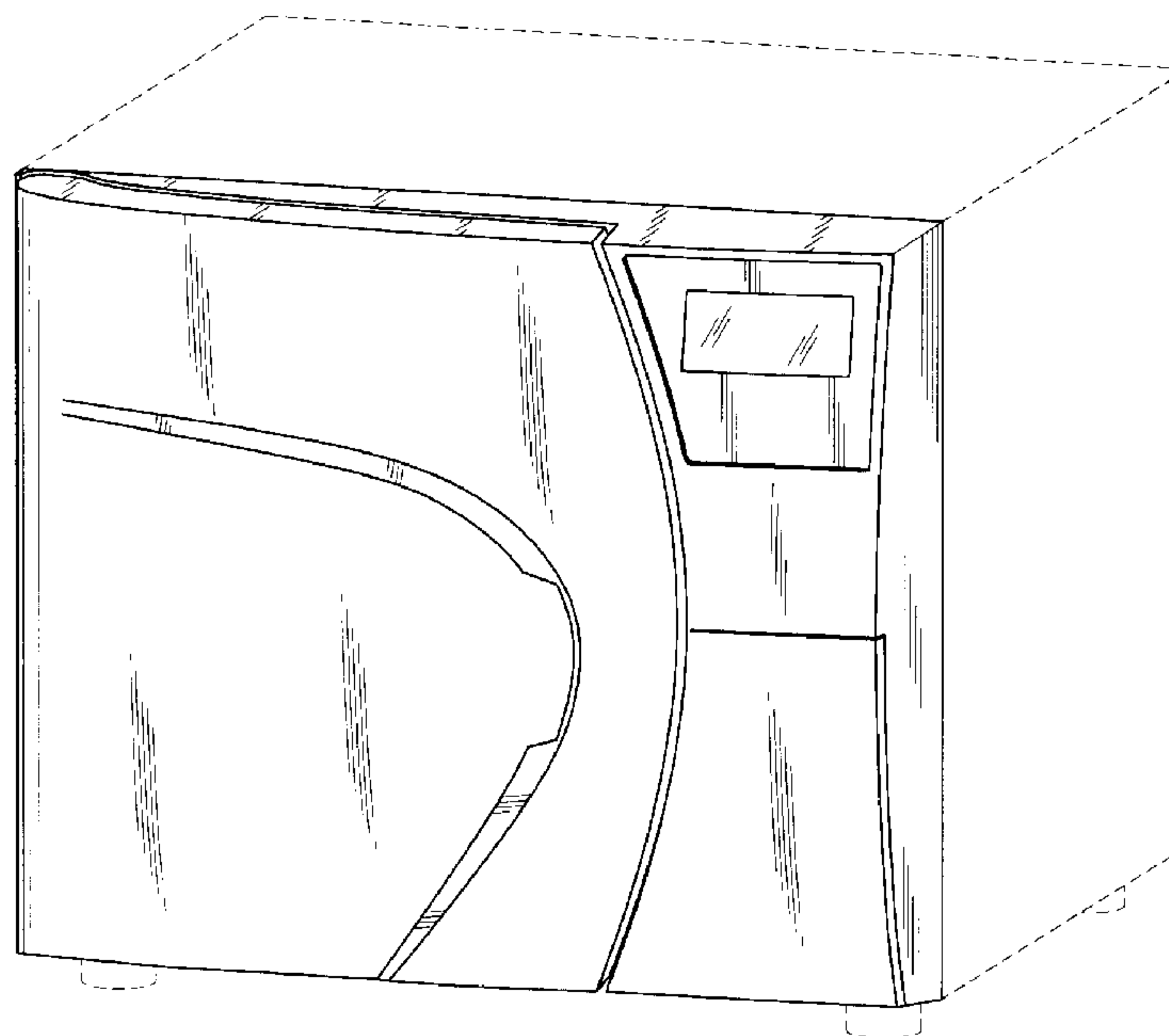

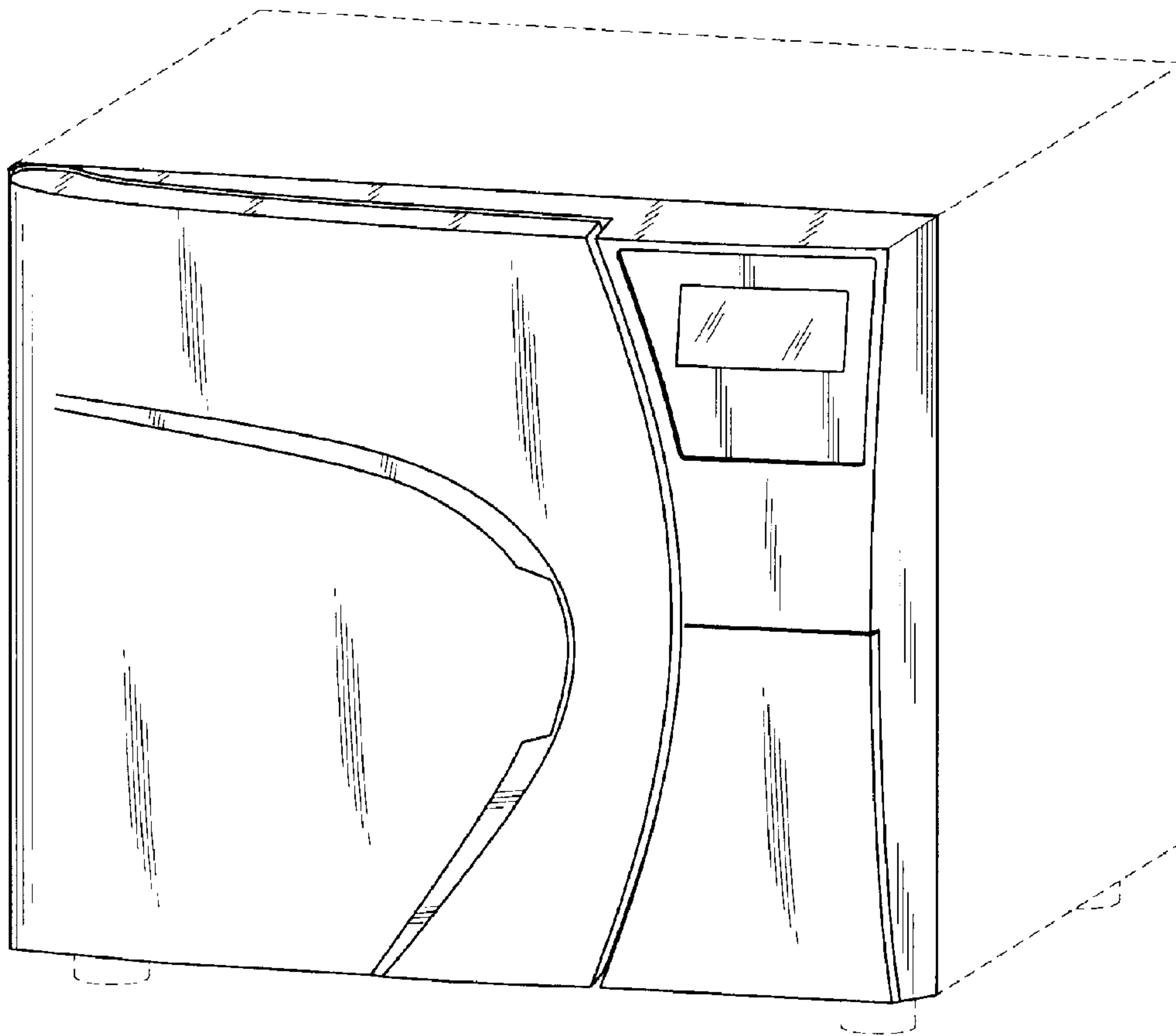

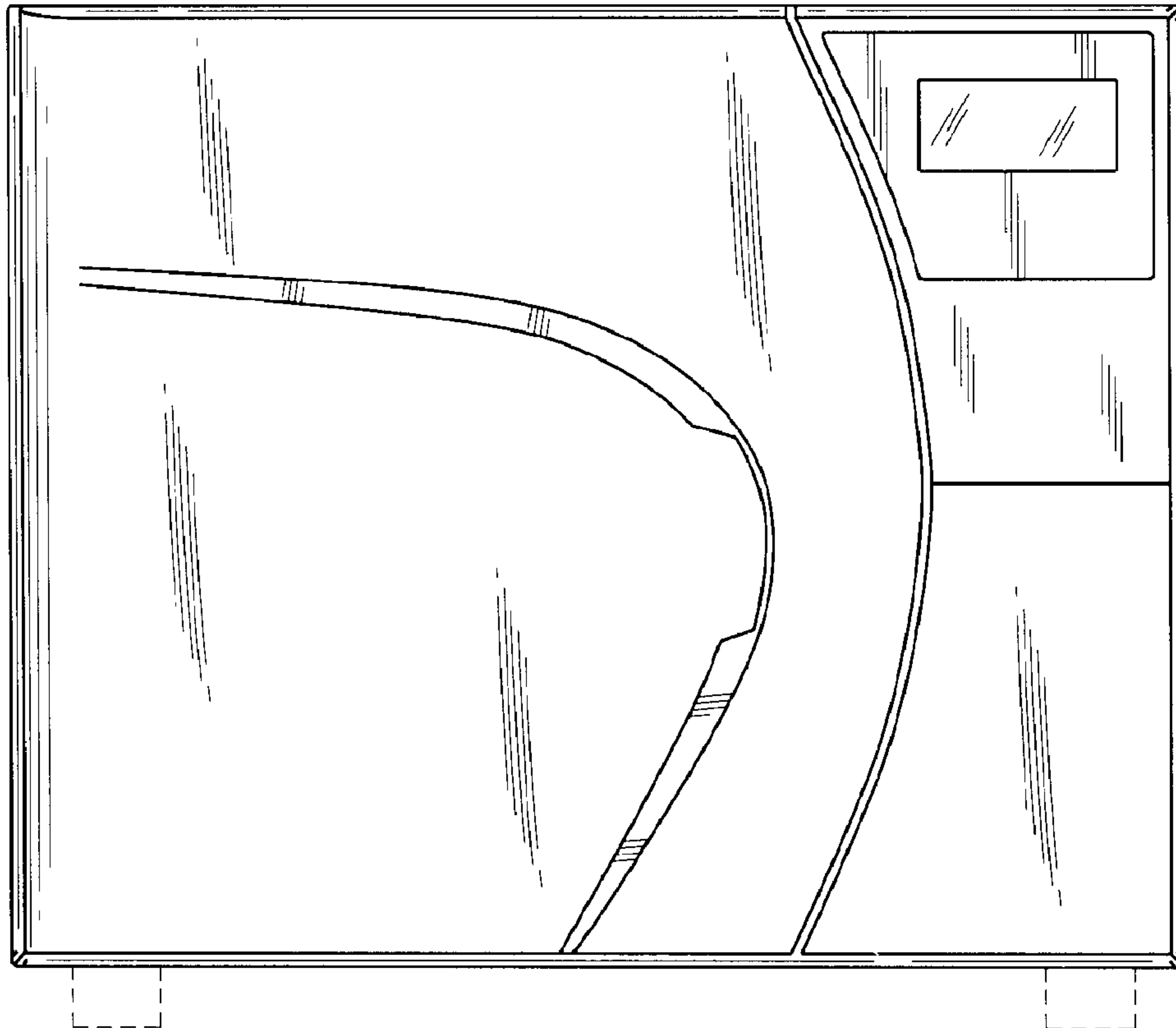

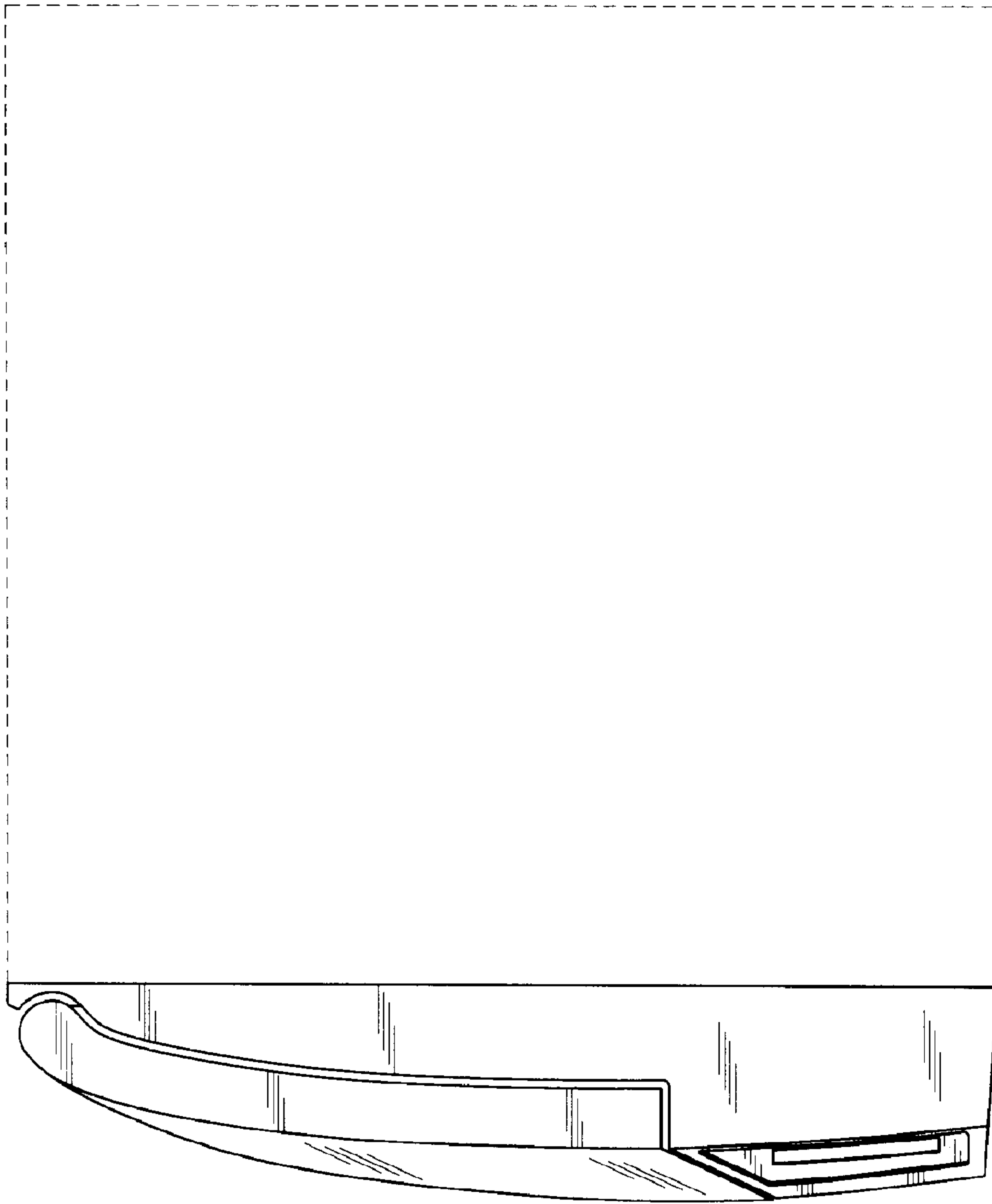

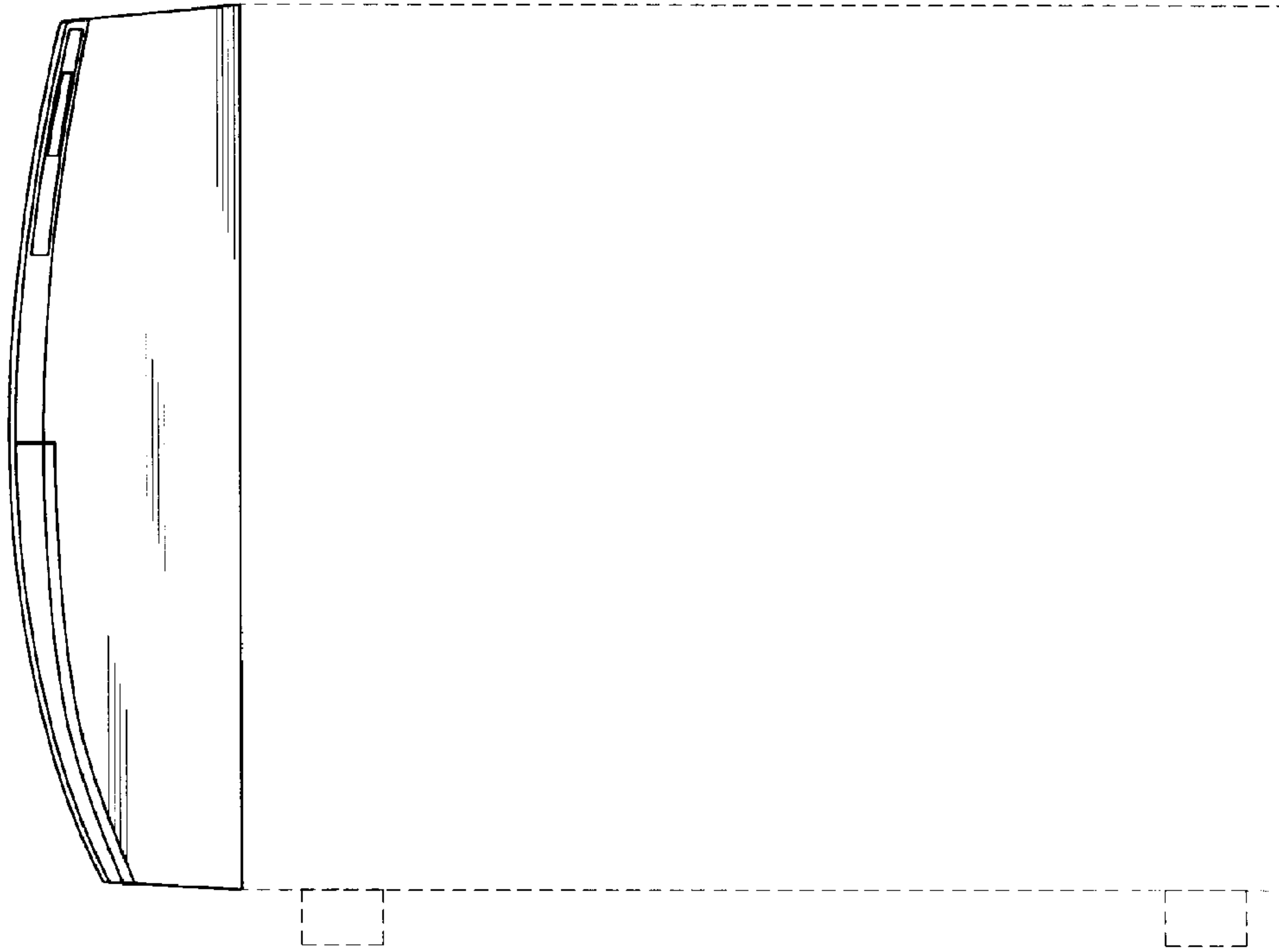

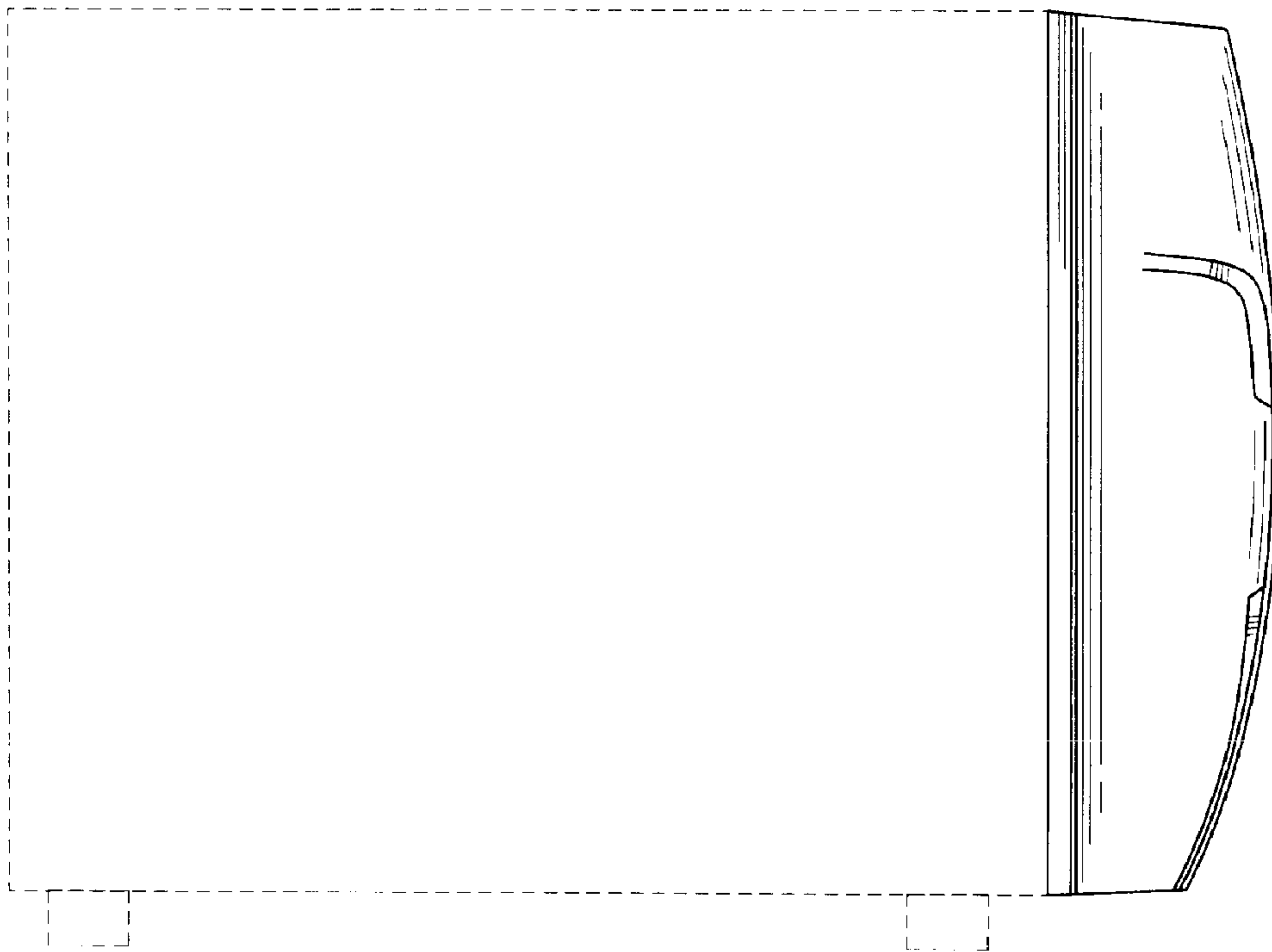
