FIG. 17 is a top plan view thereof;

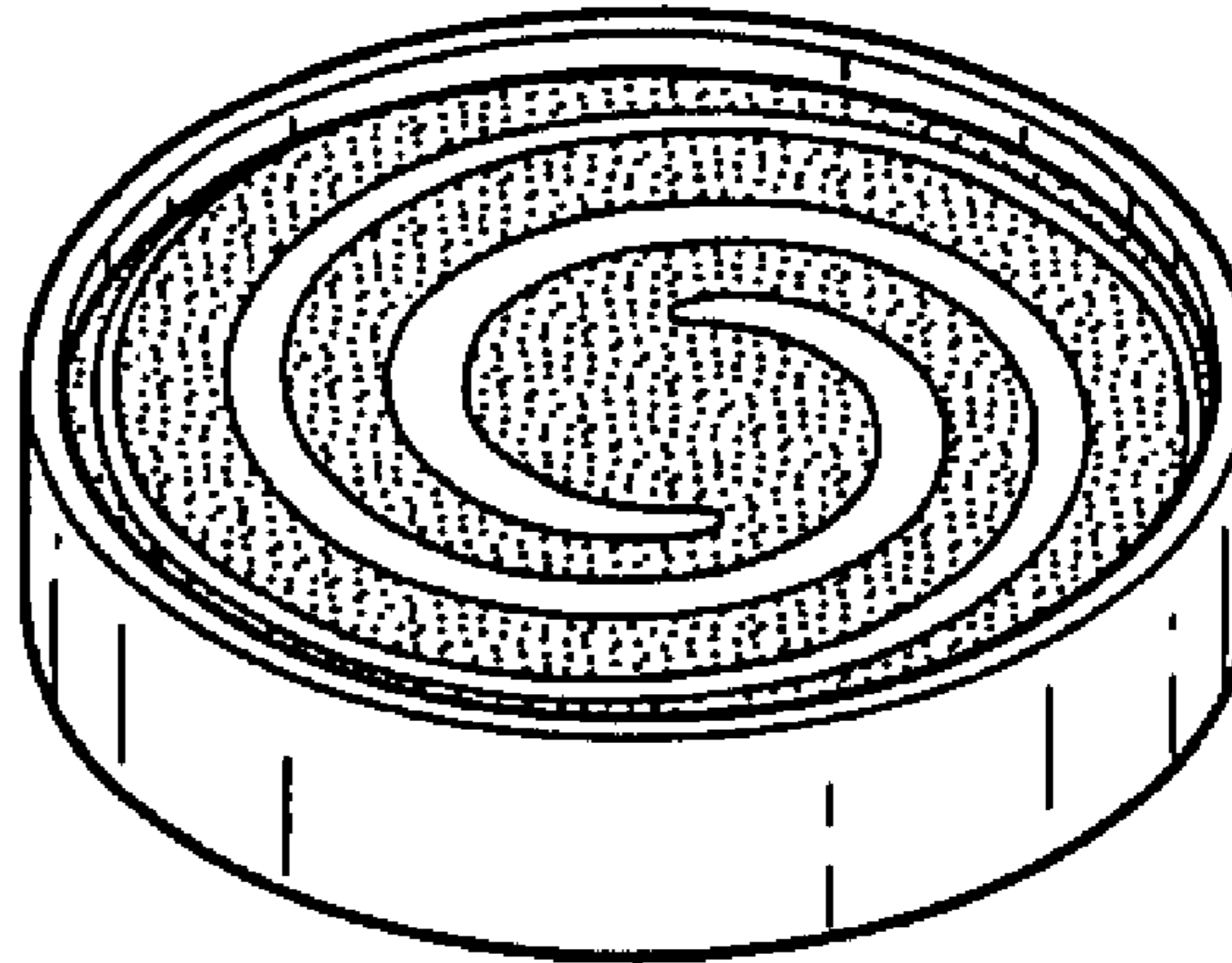
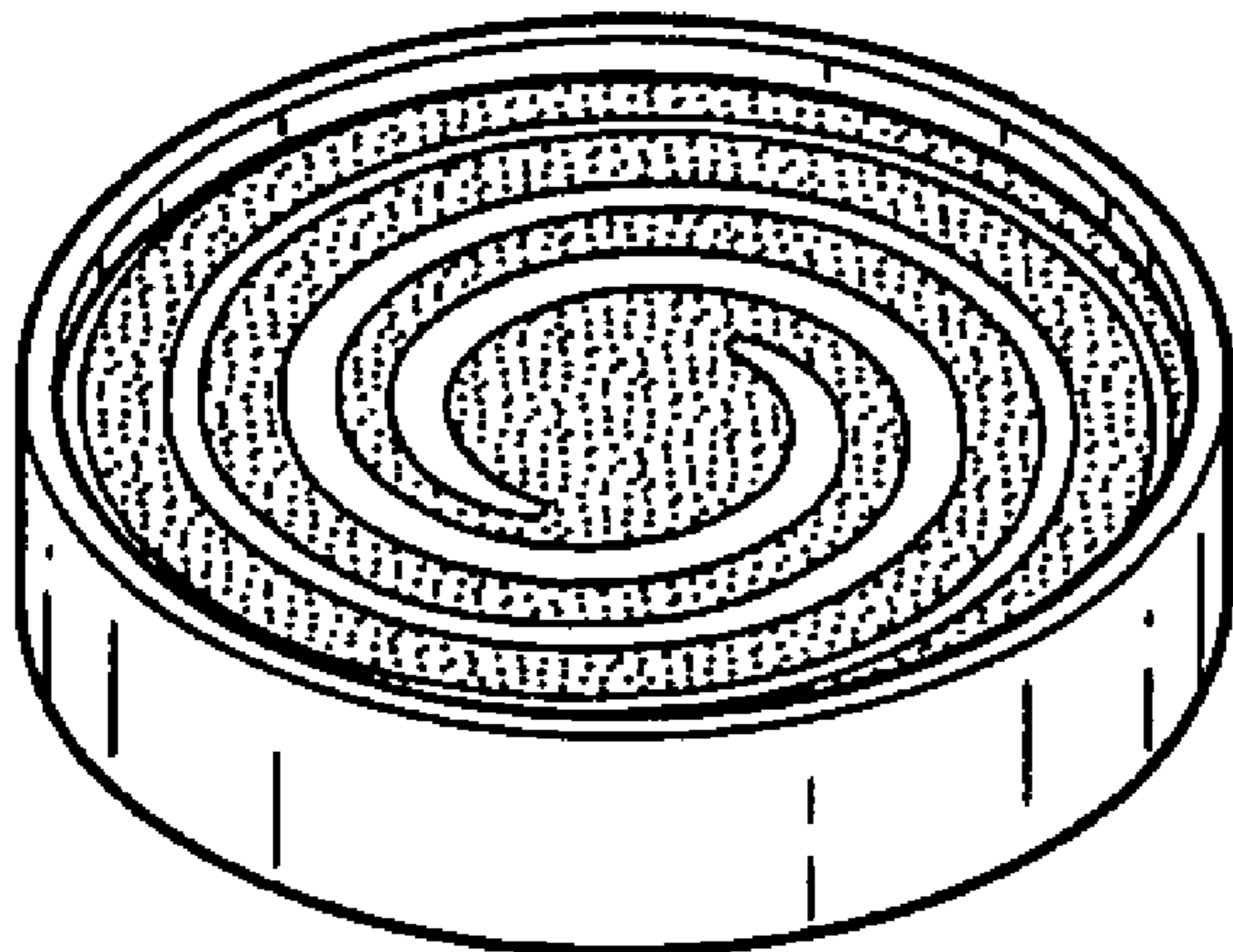
FIG. 18 is a front view thereof;

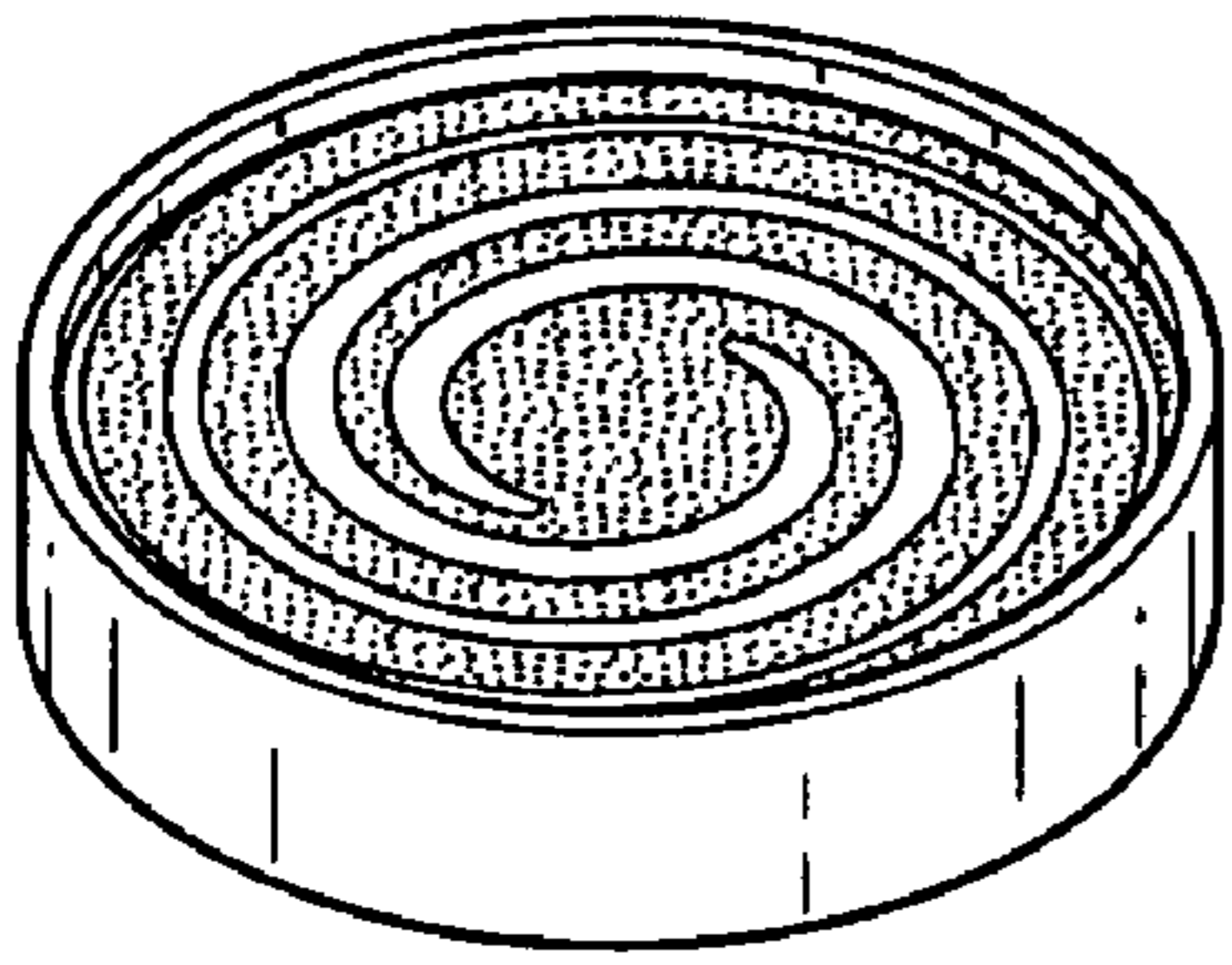

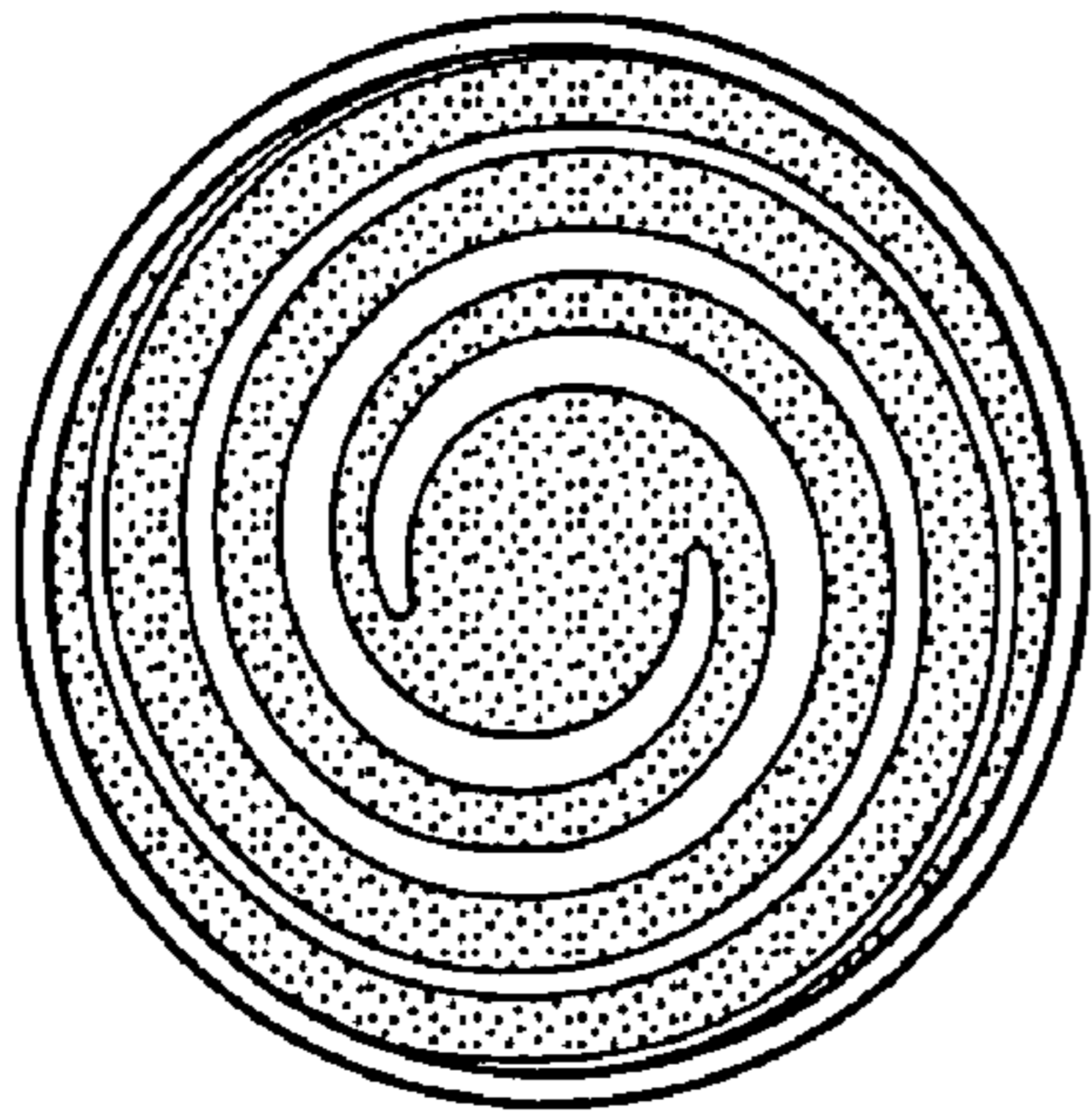

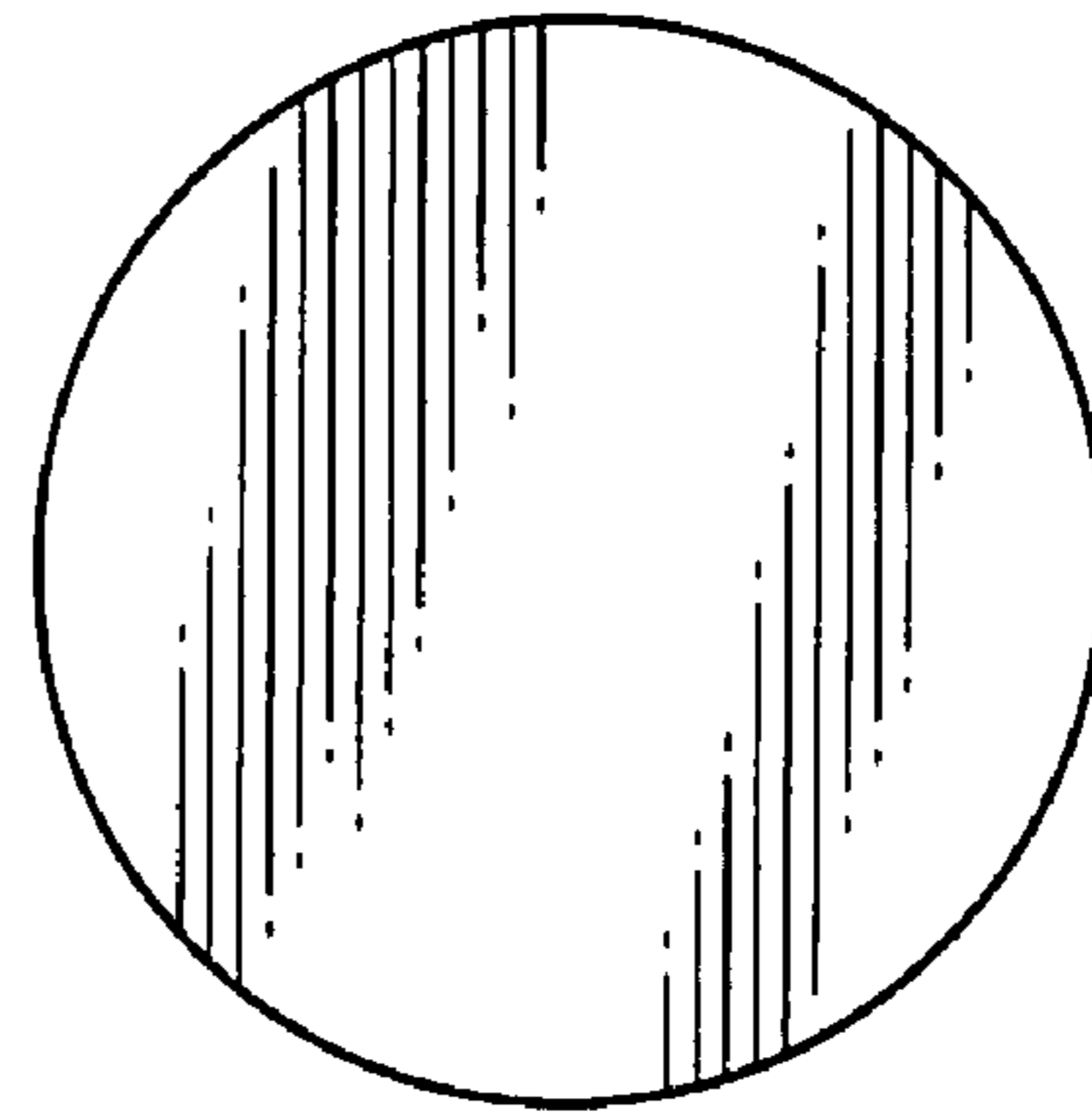

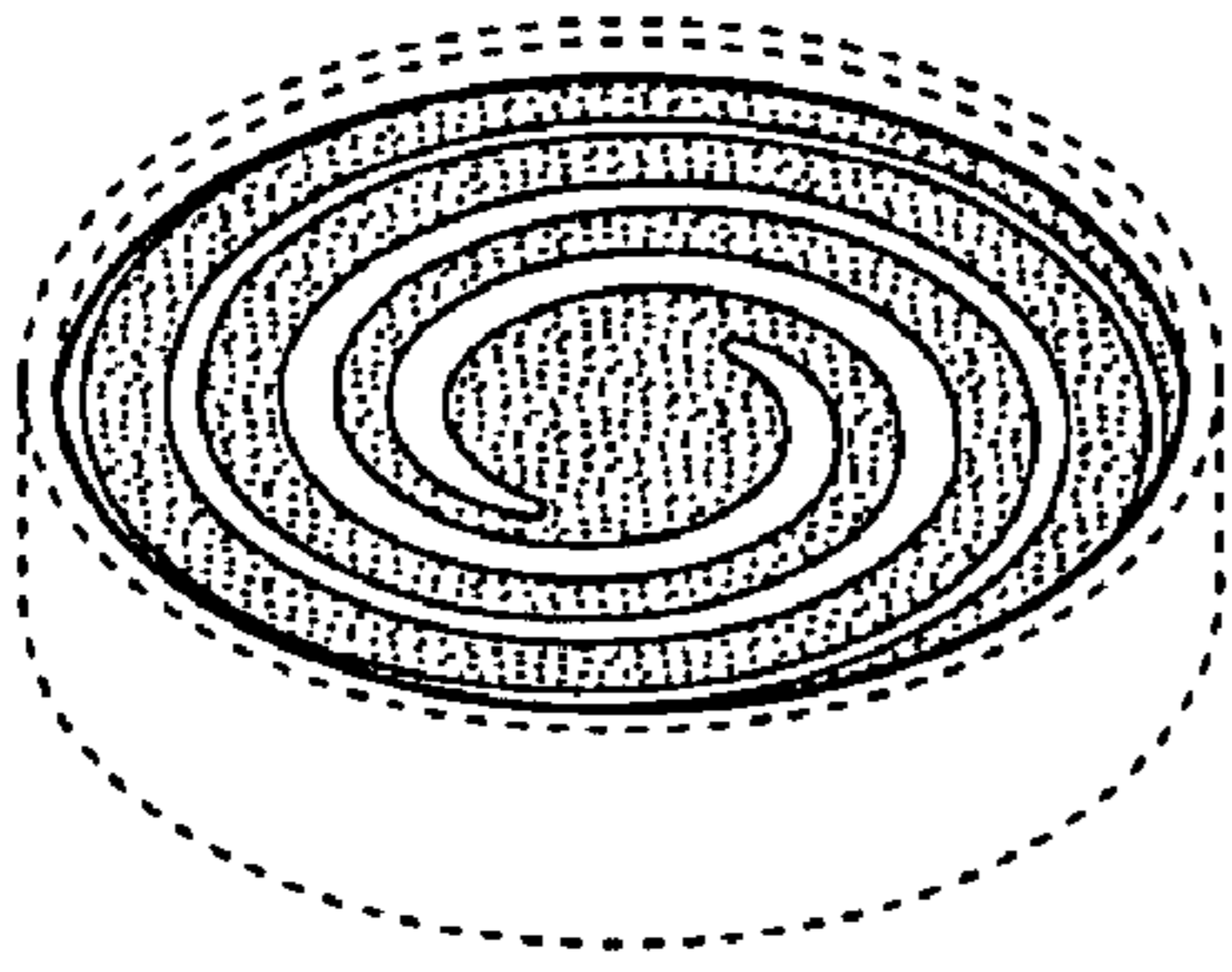

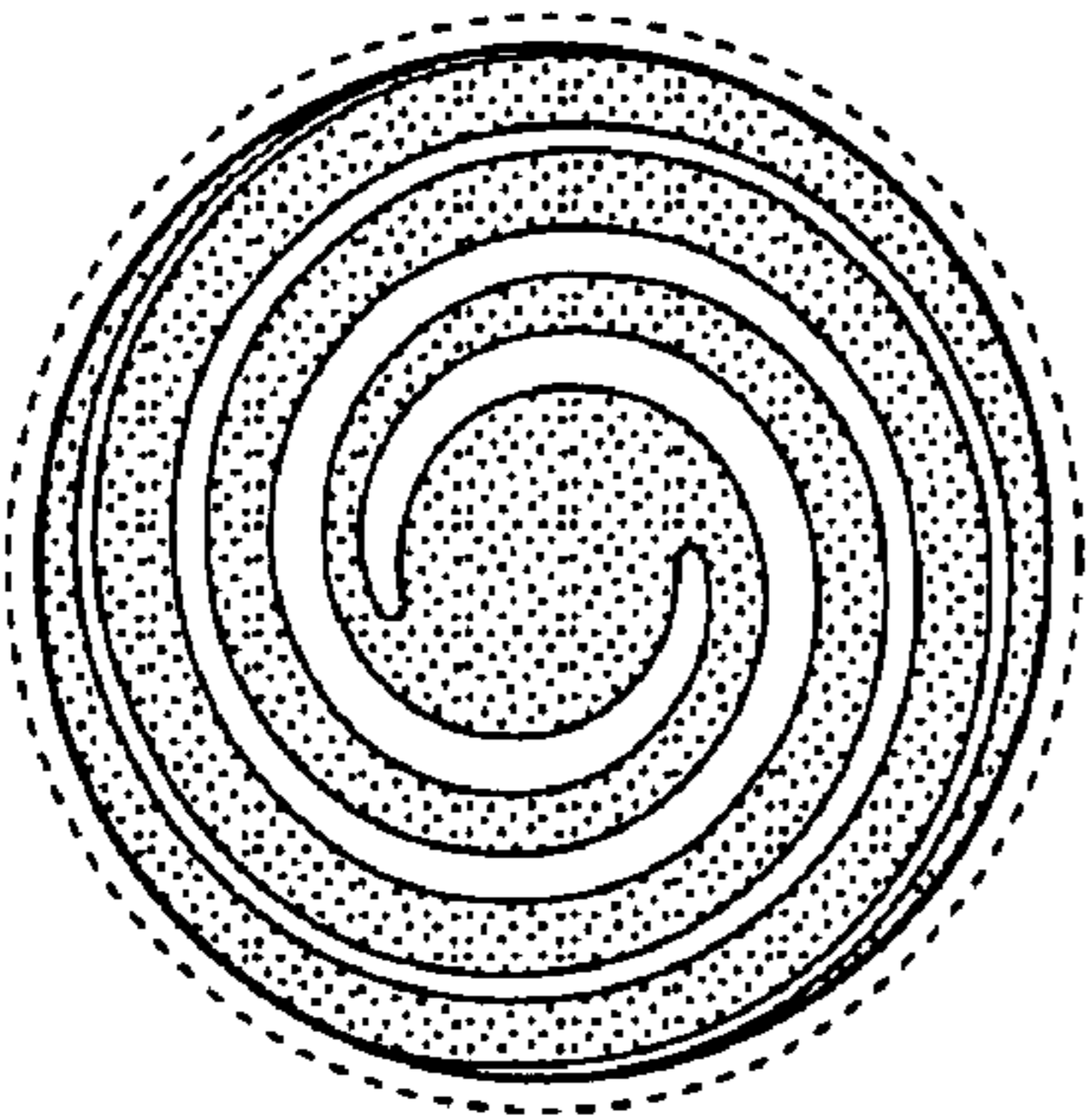

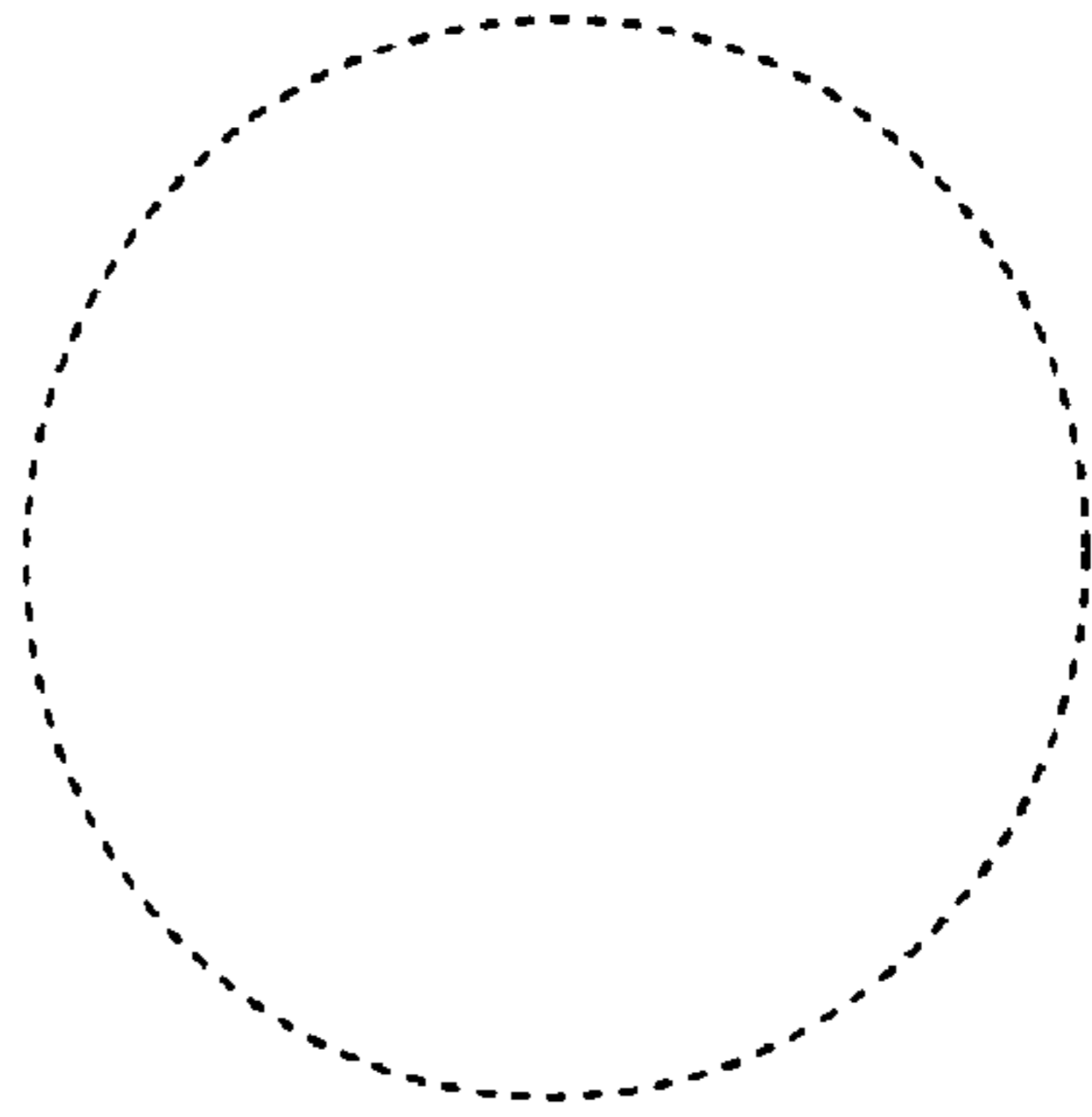

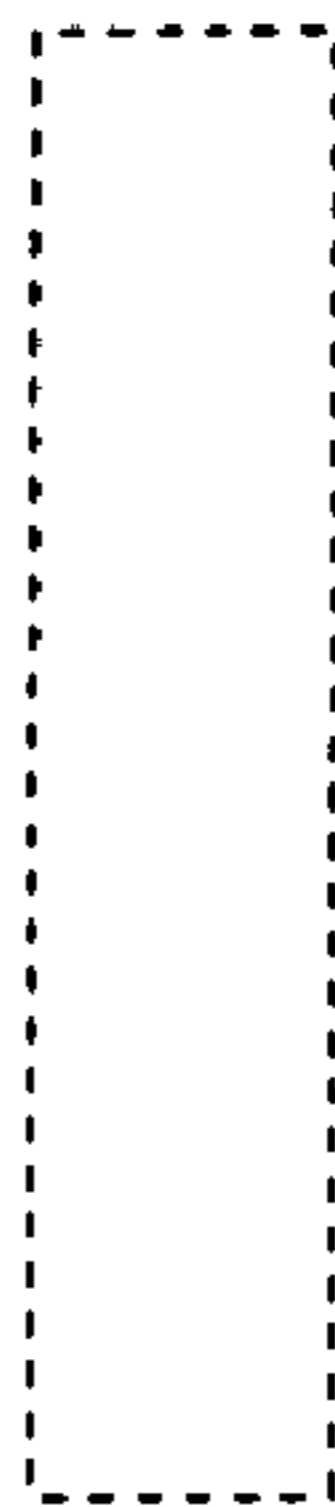

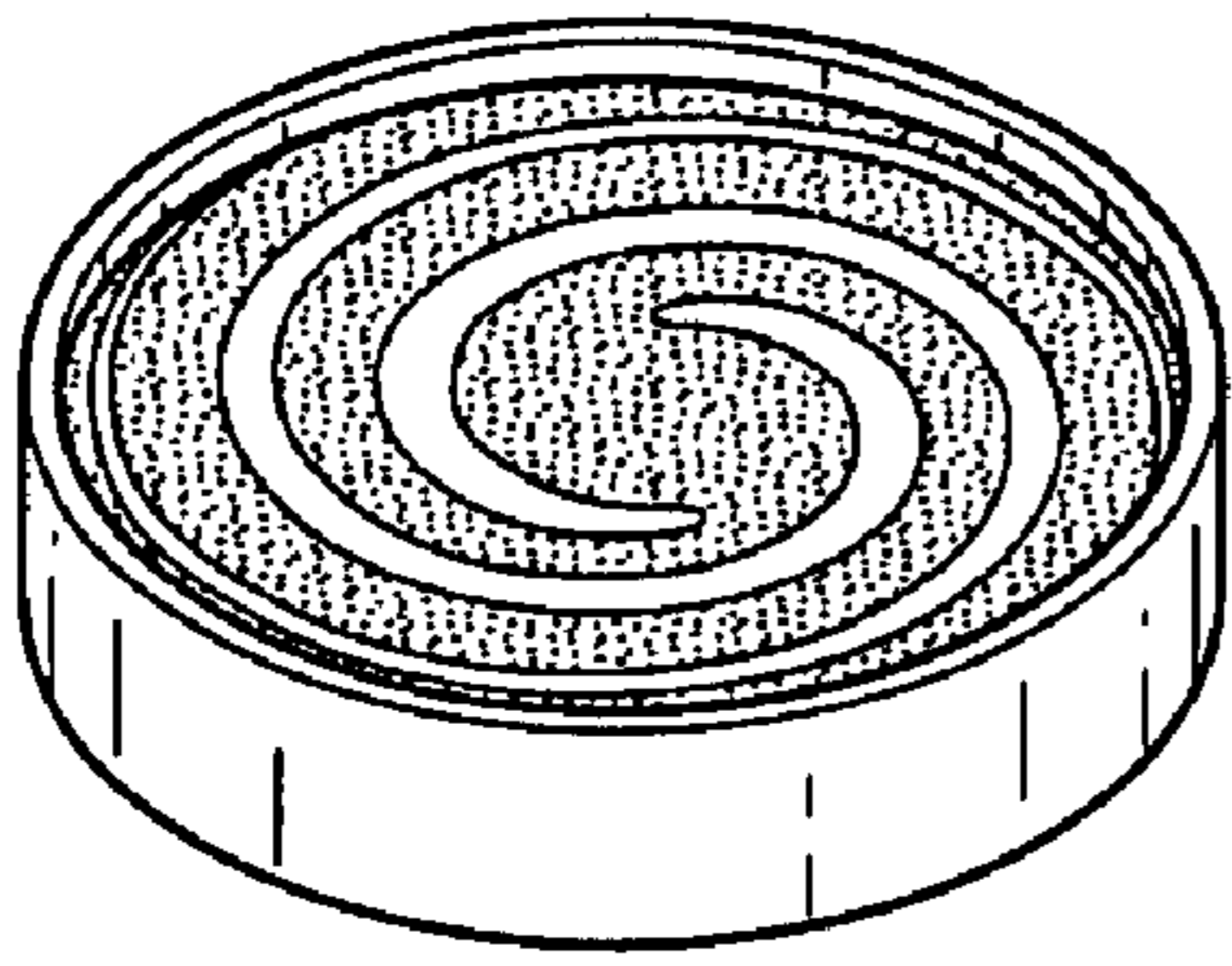

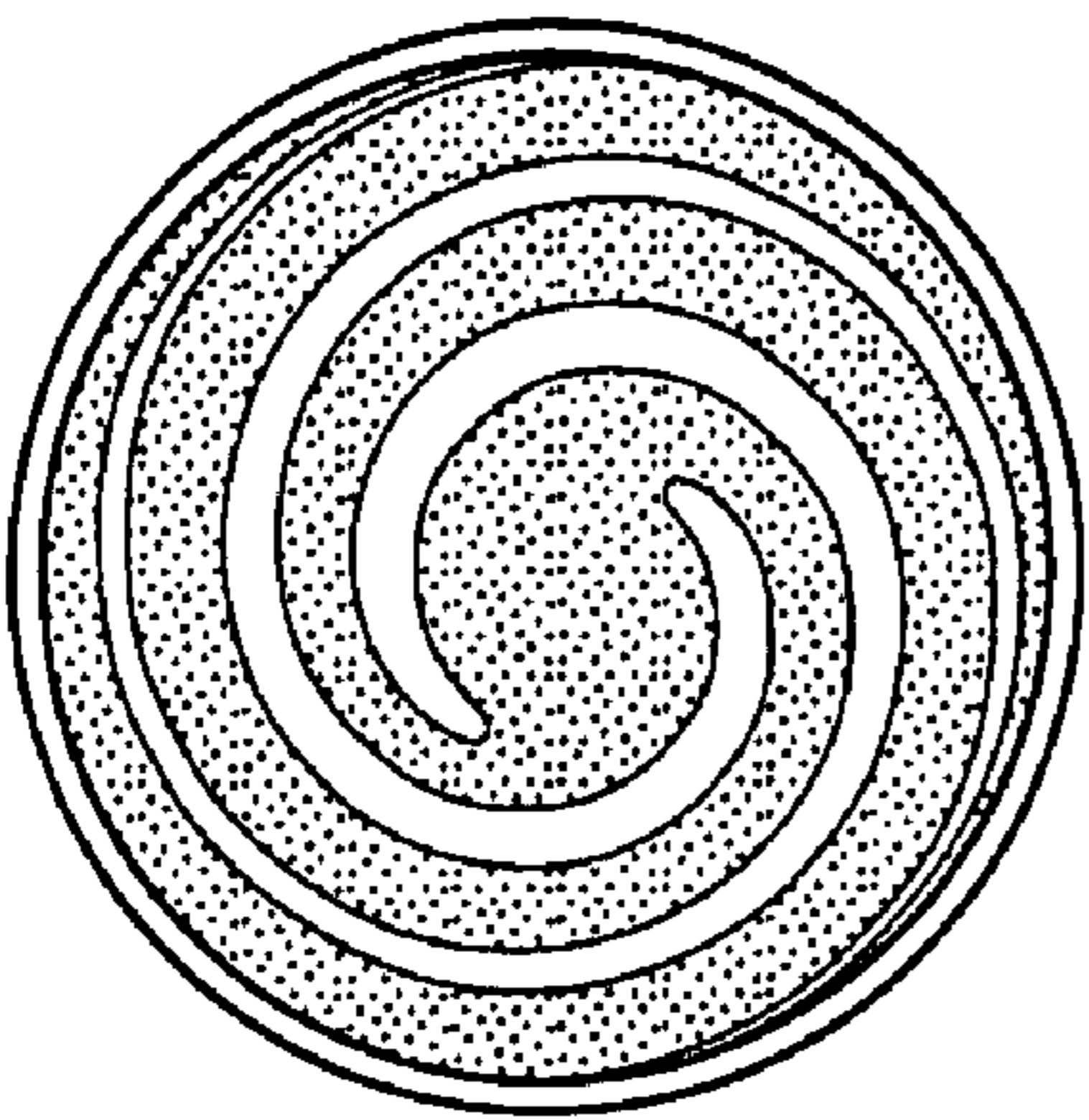

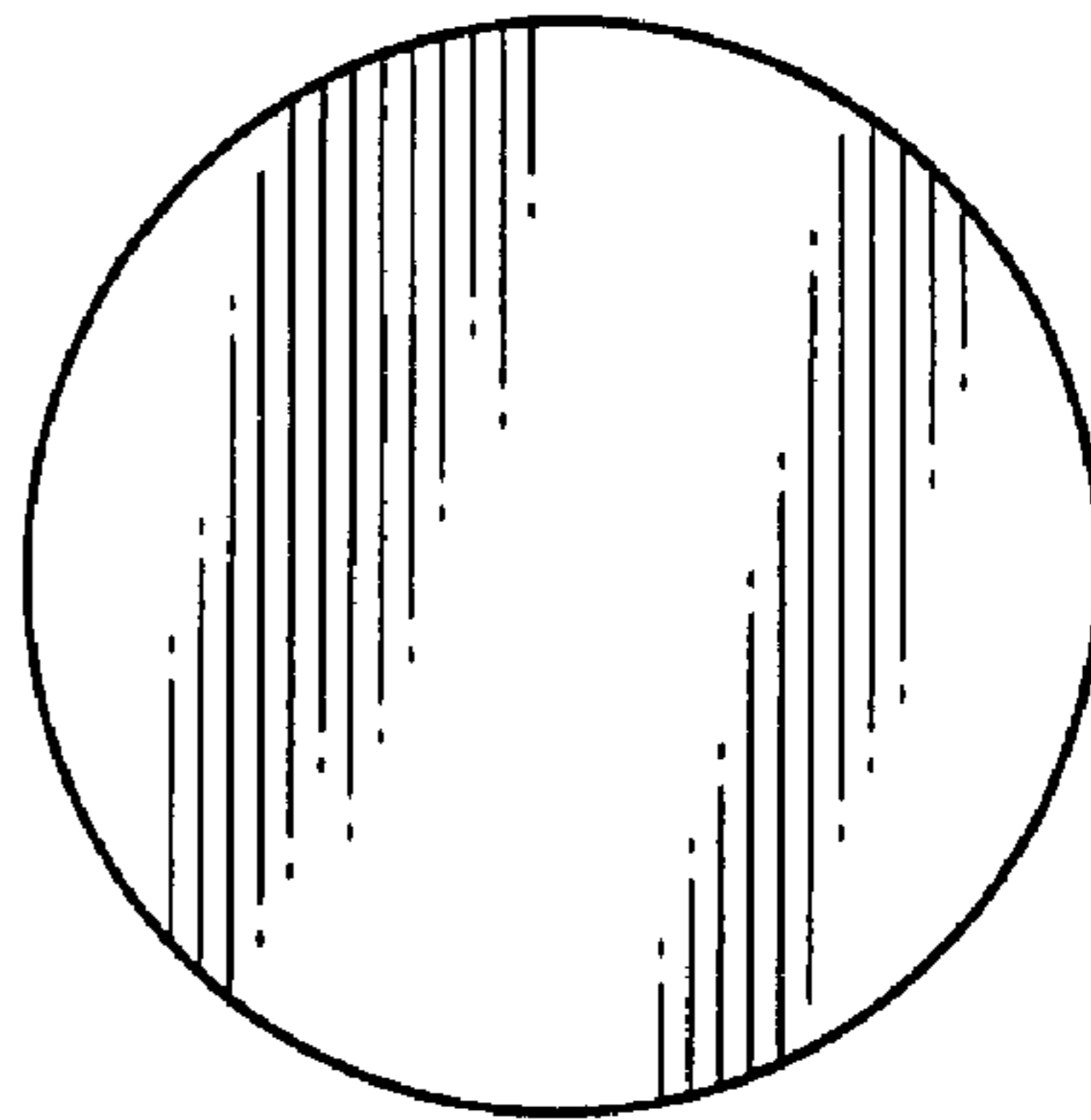

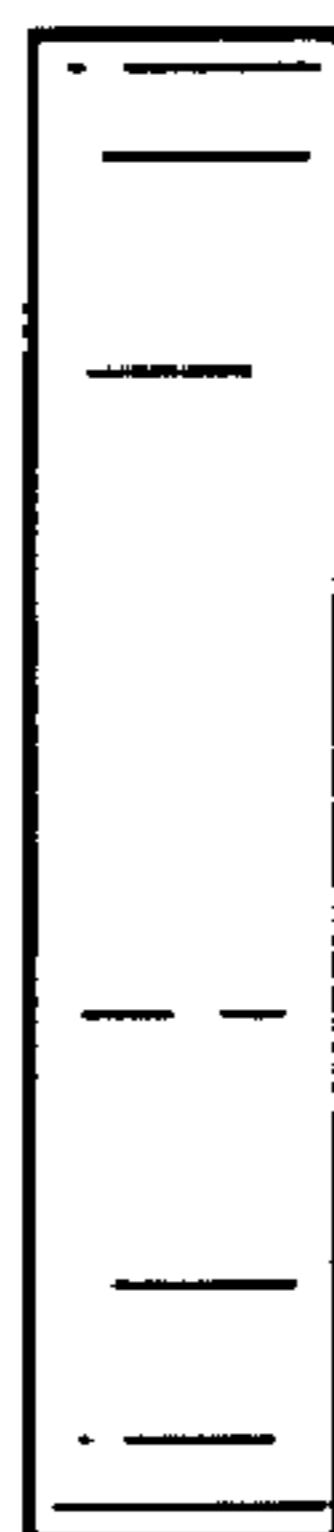

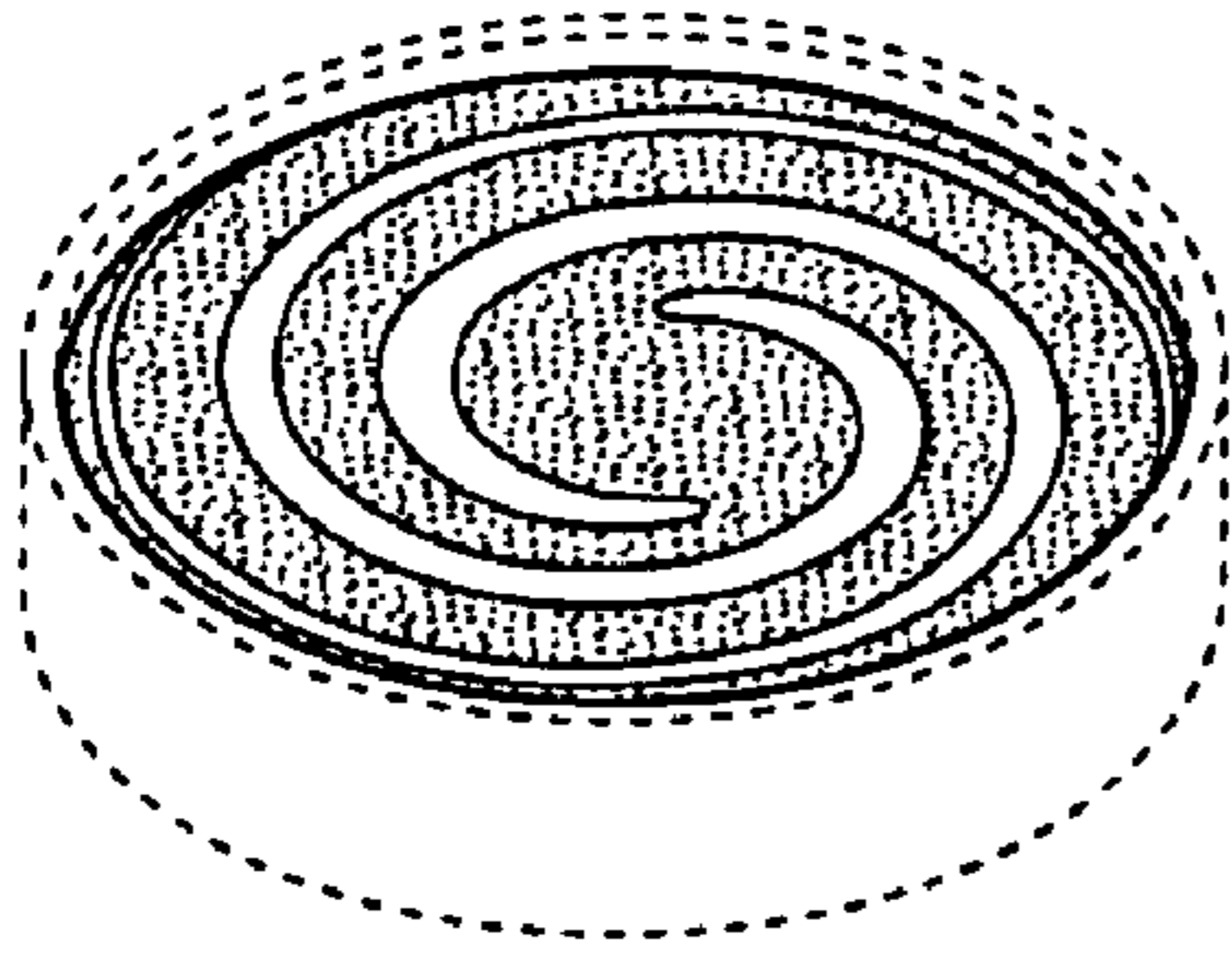

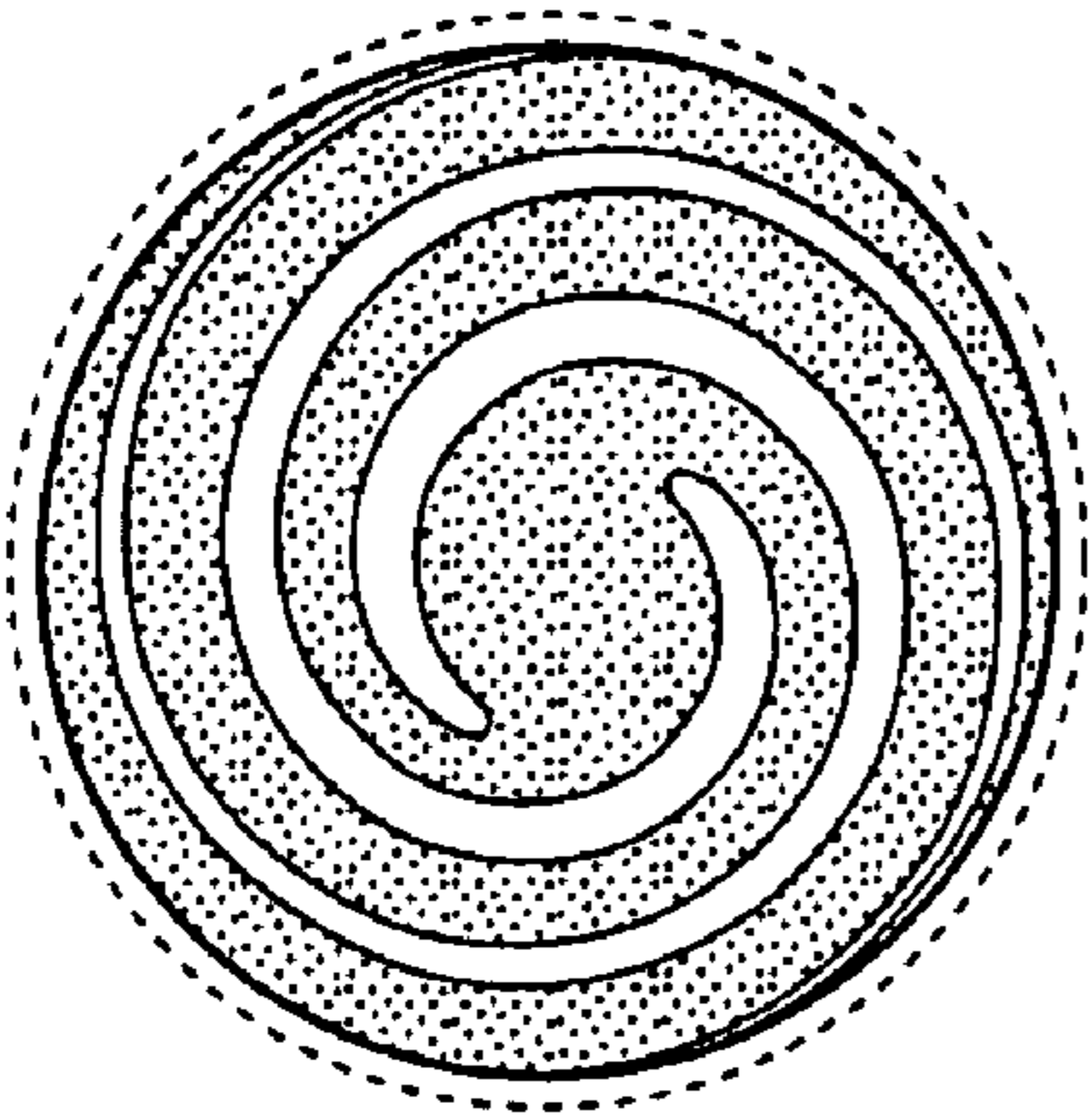

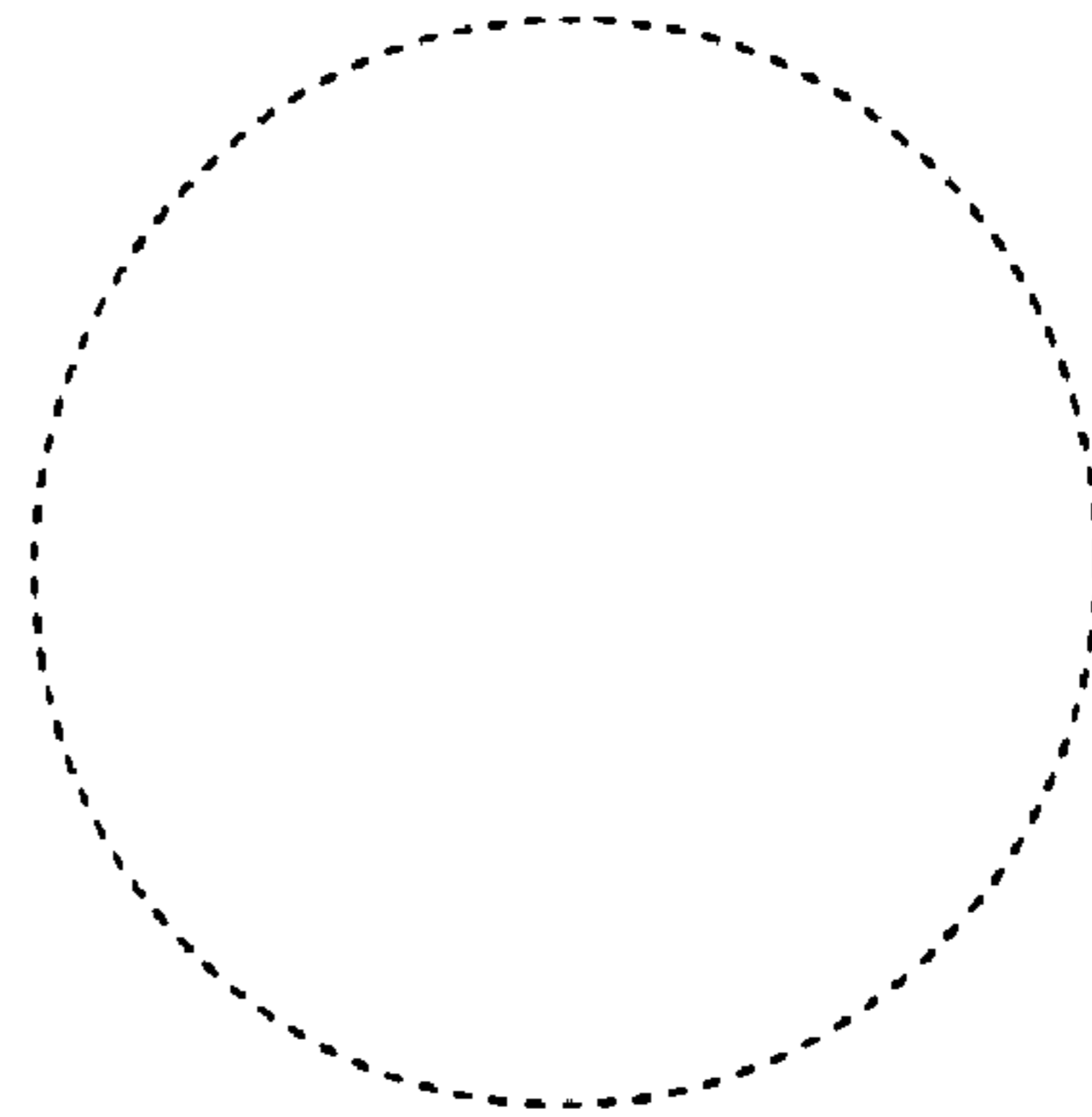
