FIG. 5 is a left side view of the chocolate rabbit with bow, bell and patch design; and,

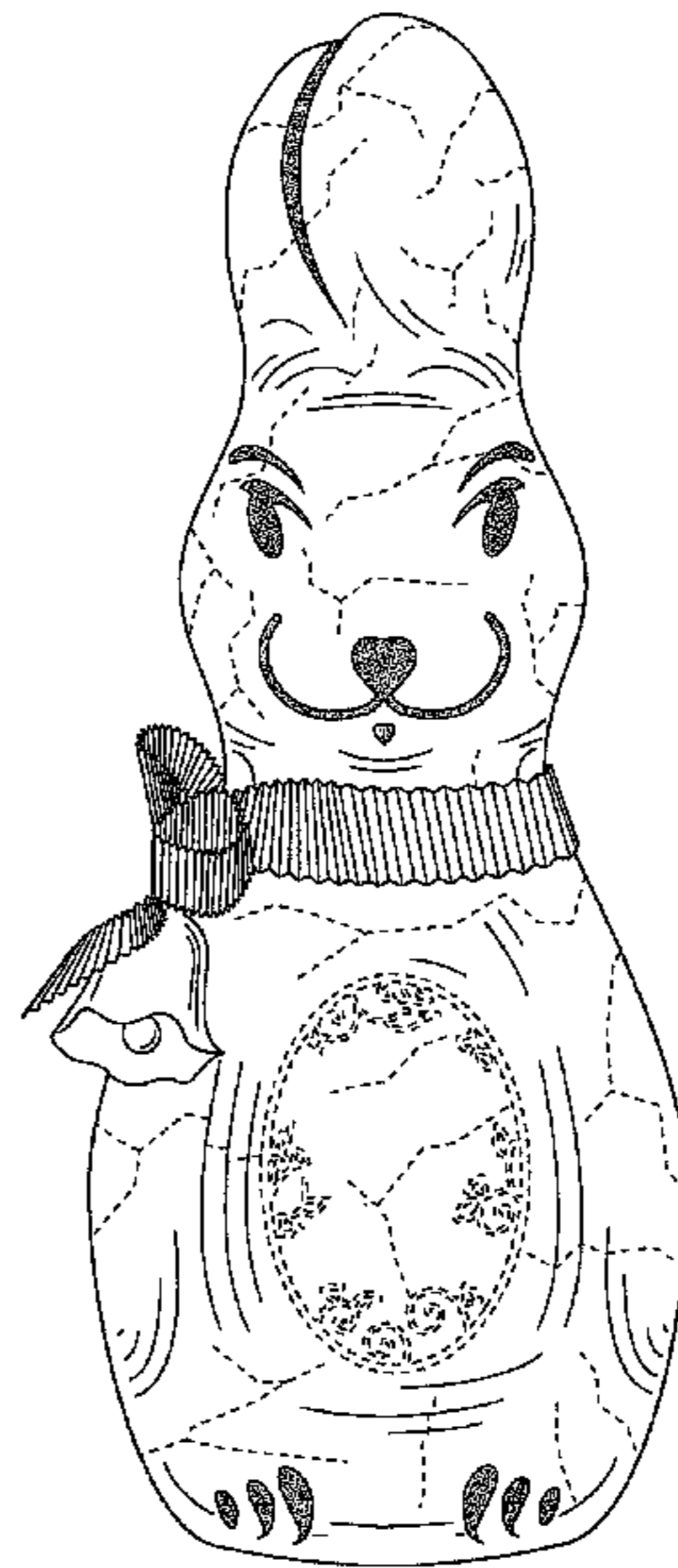
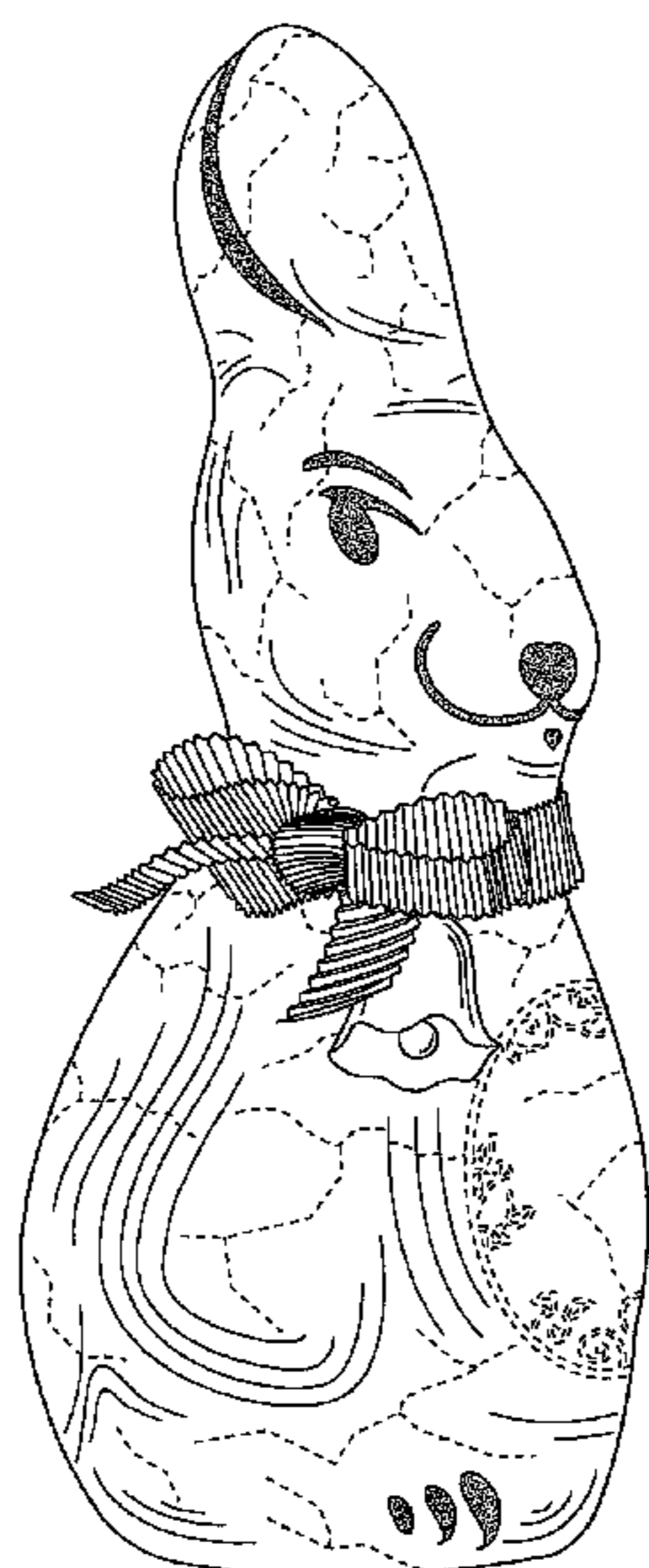
FIG. 6 is a top view of the chocolate rabbit with bow, bell and patch design, the bottom not being a part of the claimed design.

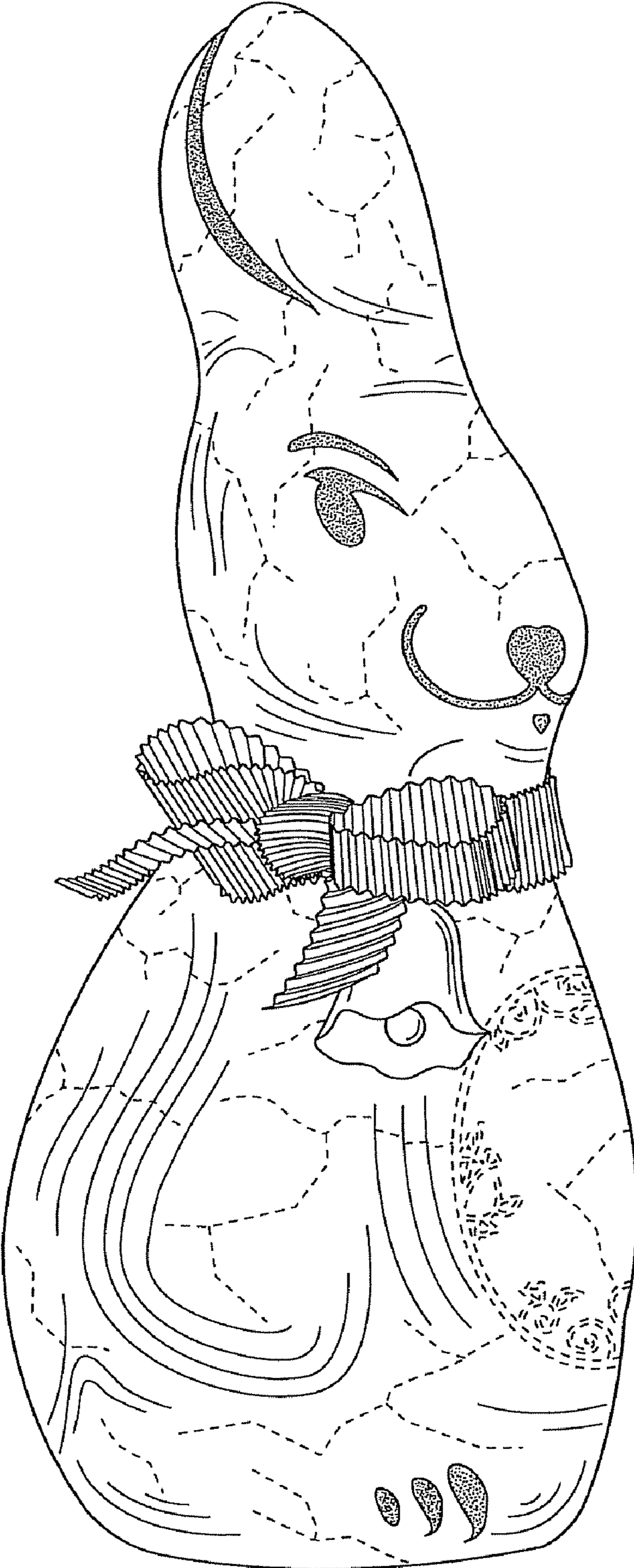

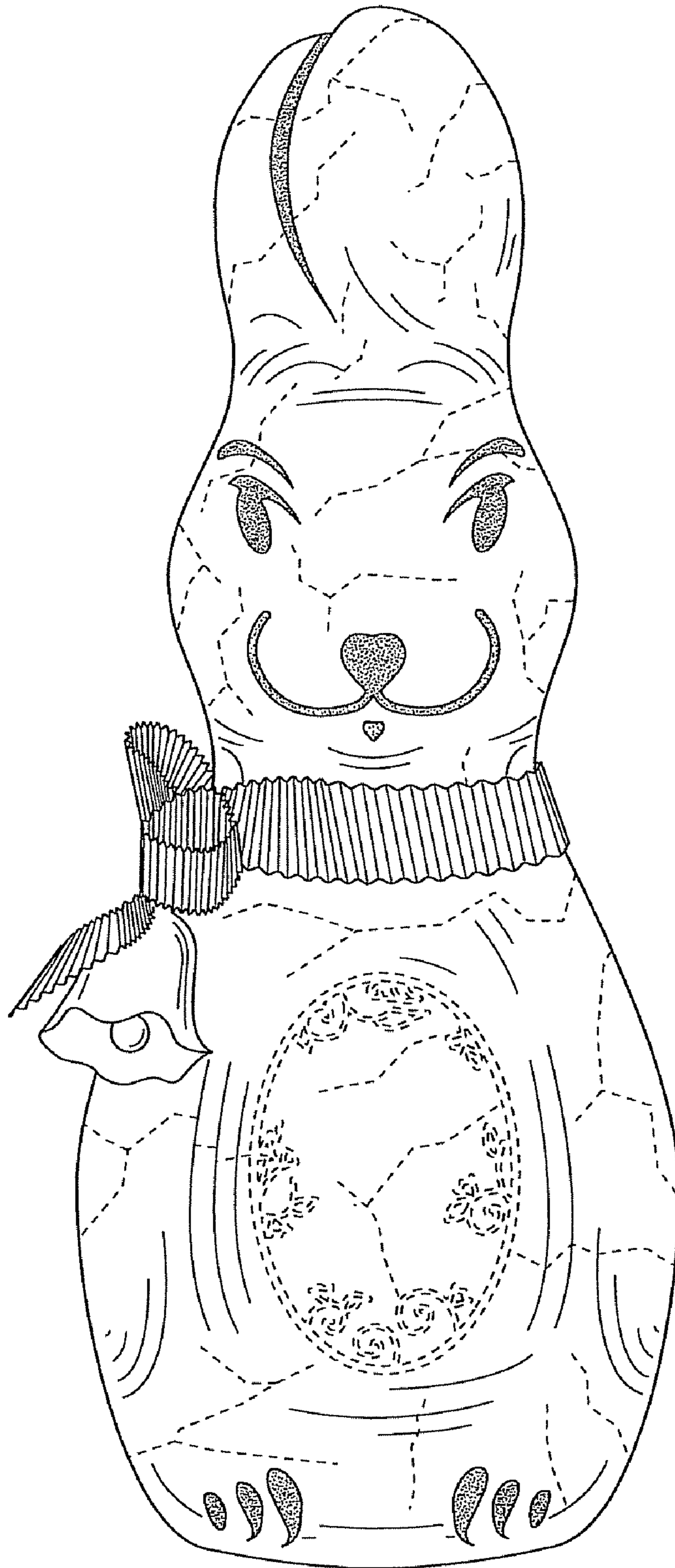

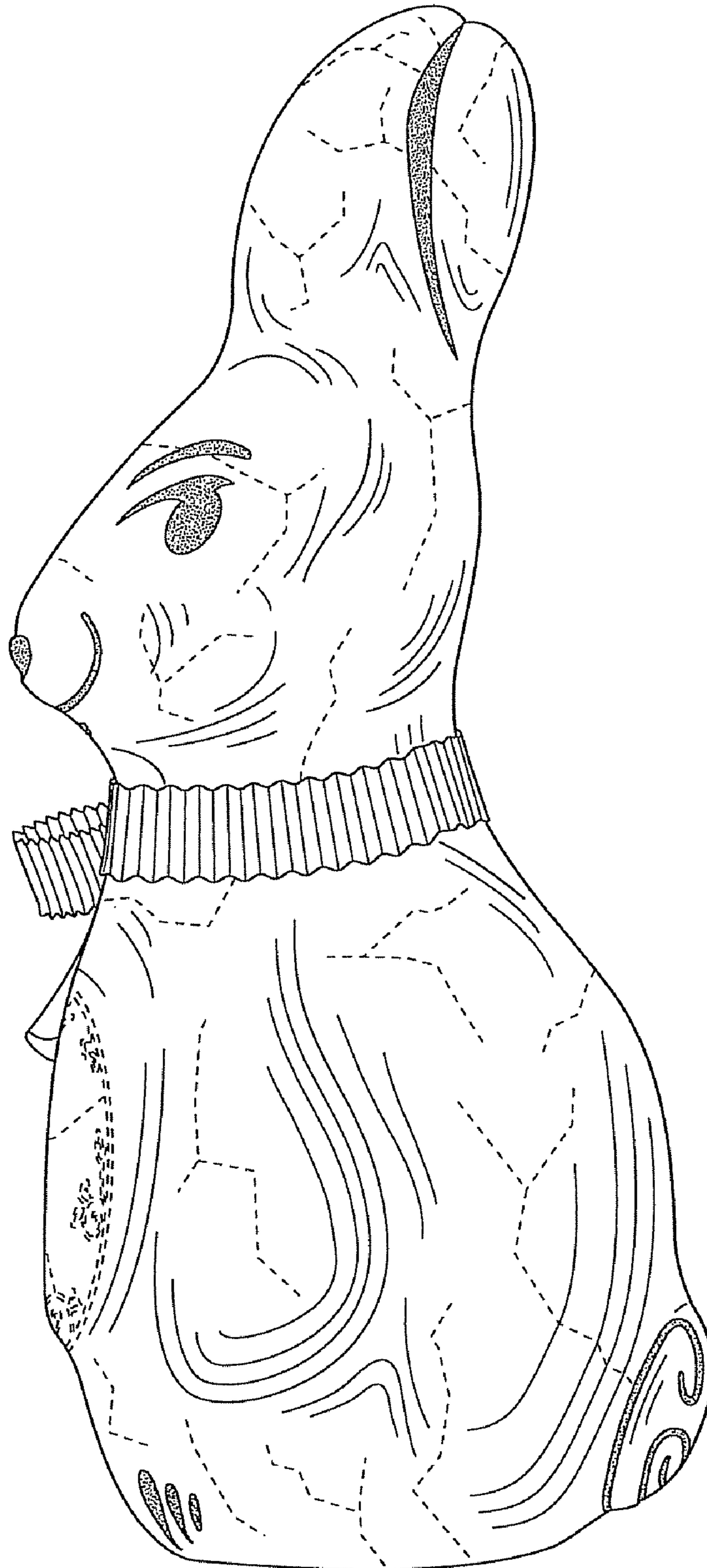

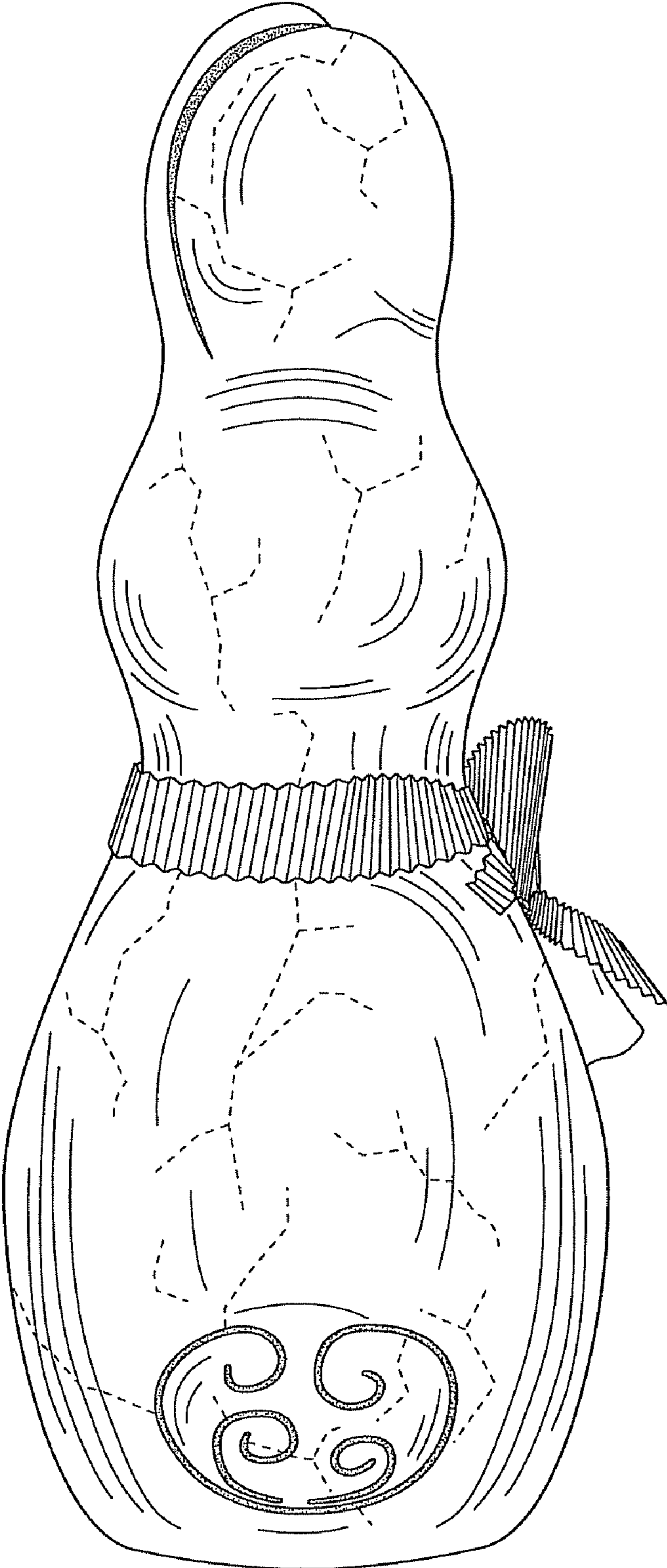

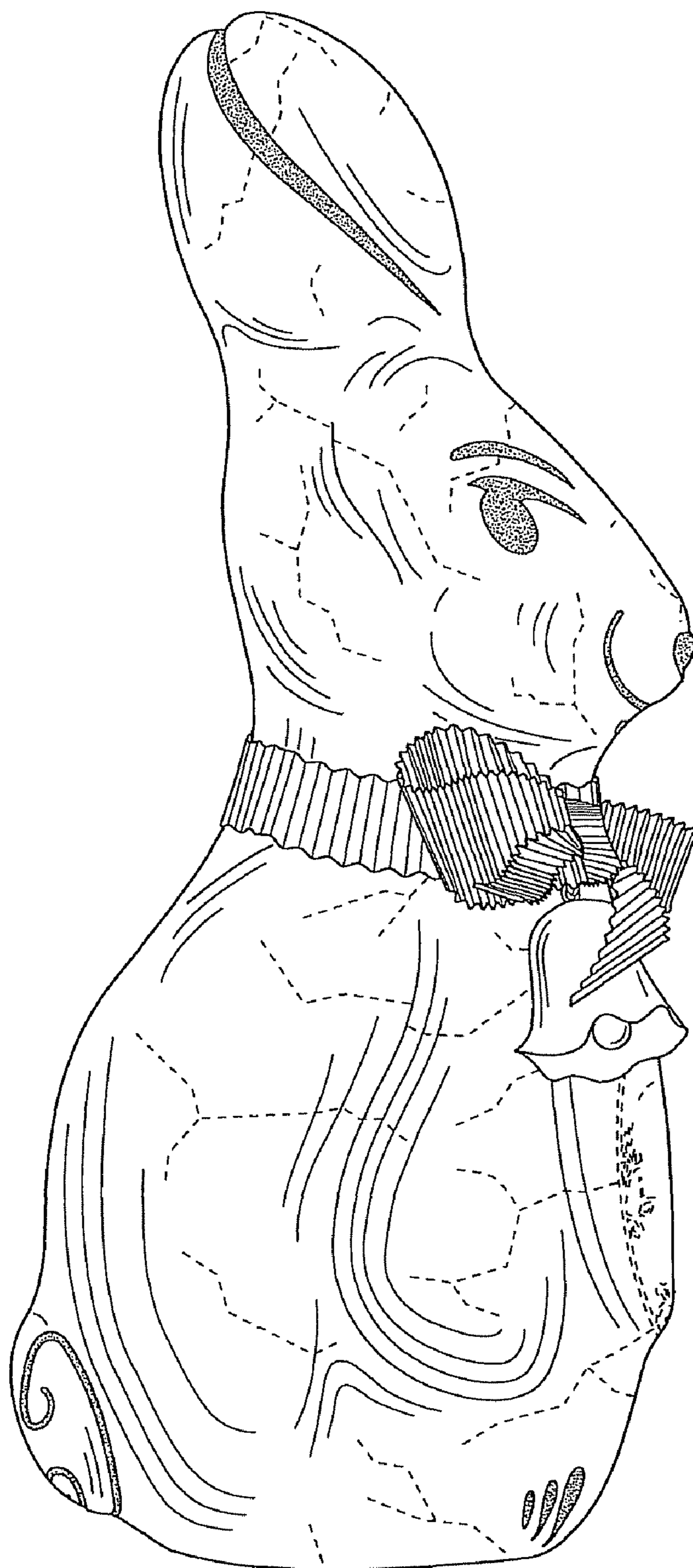

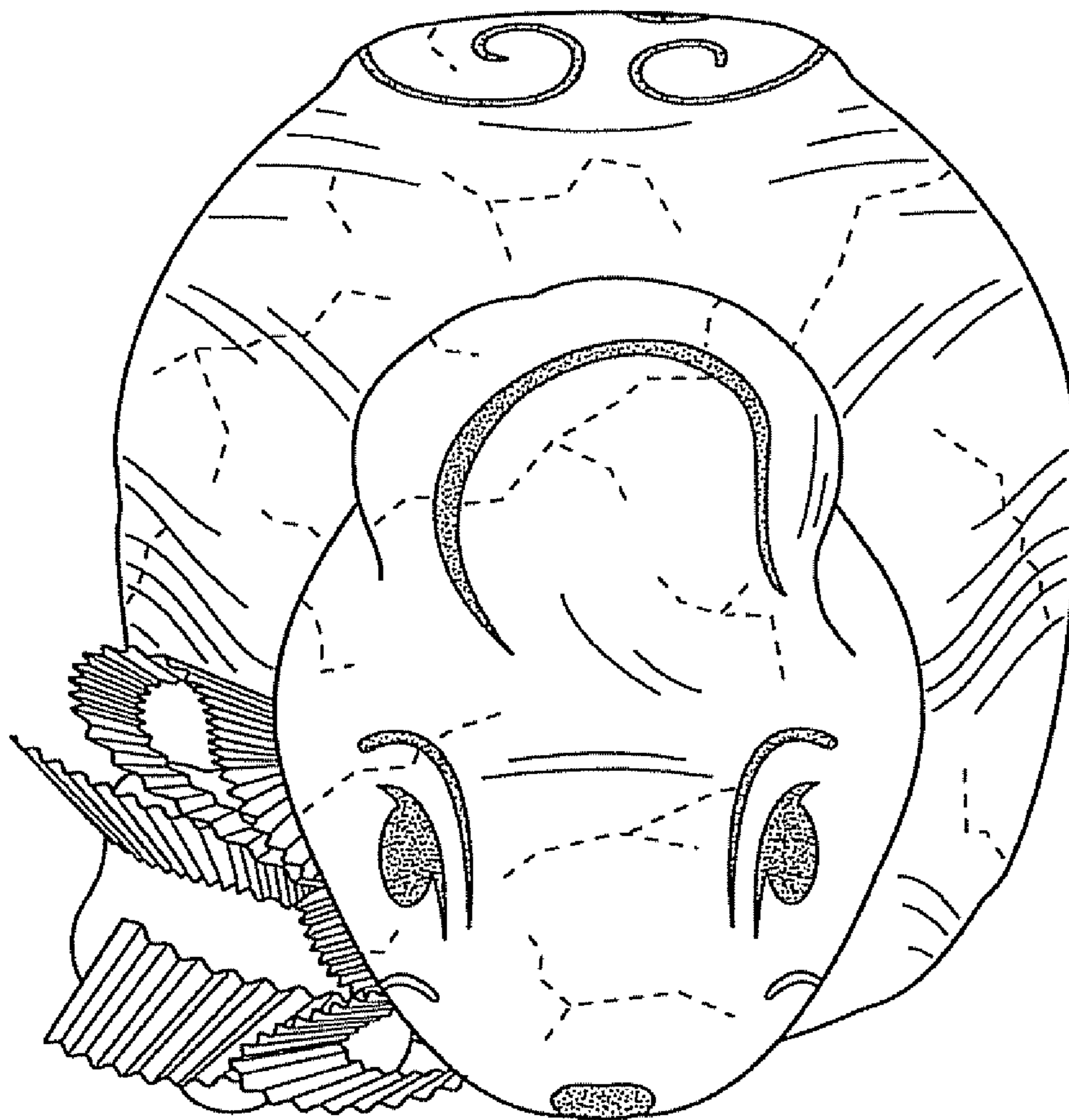
