FIG. 7 is a bottom plan view thereof.

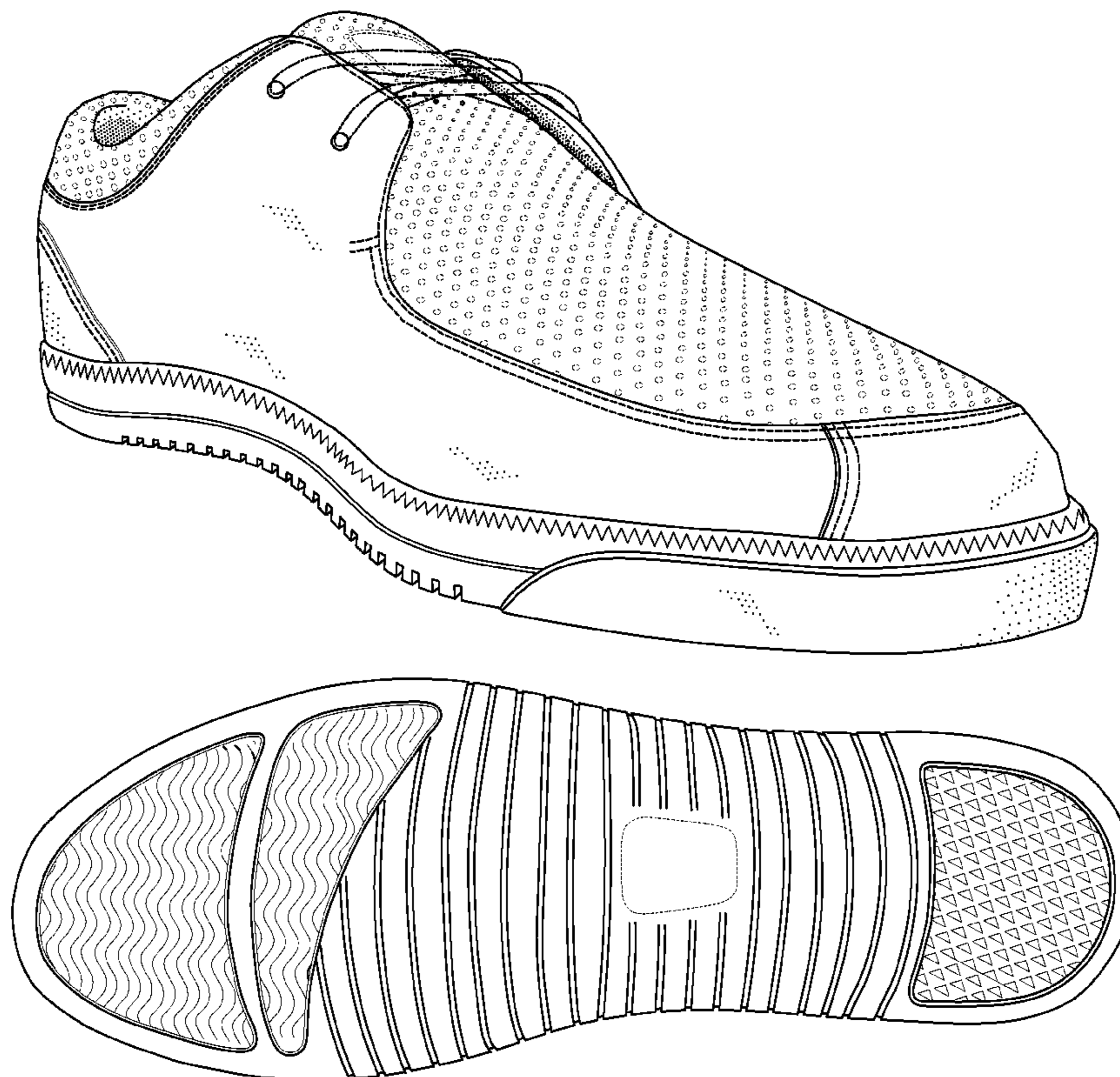
The evenly spaced broken lines represent claimed stitching.

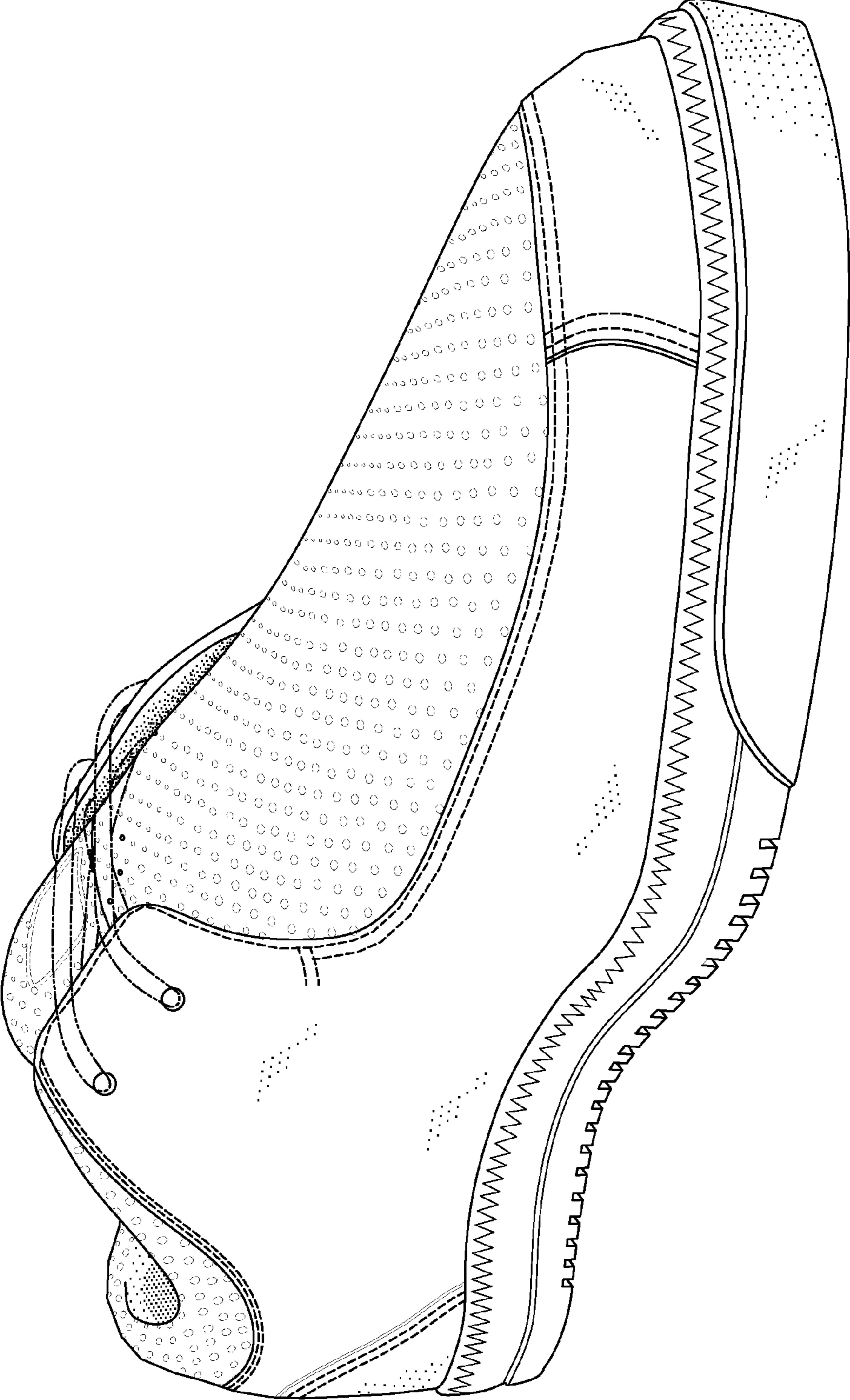

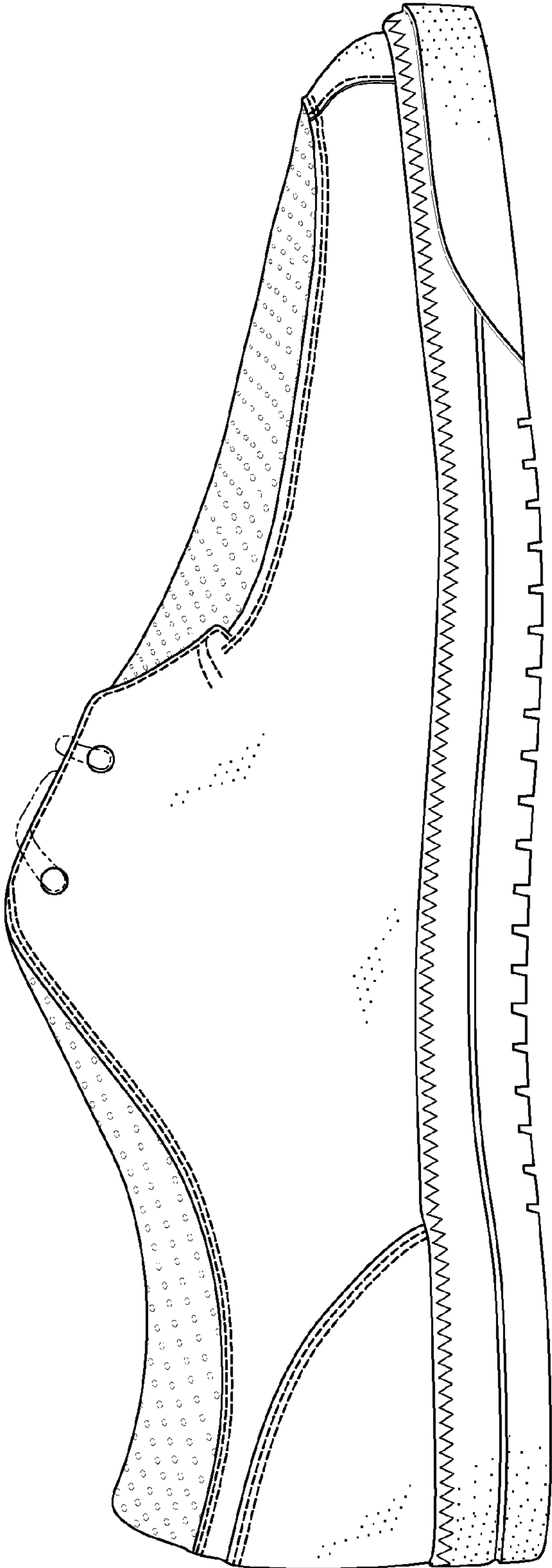

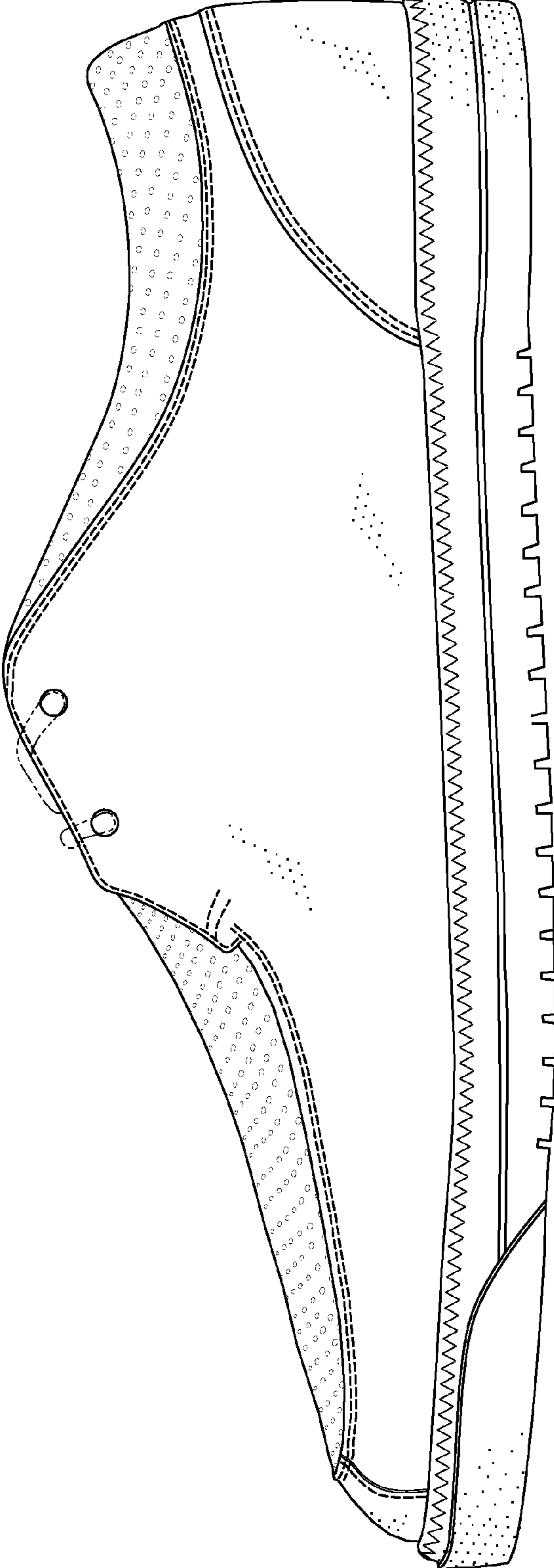

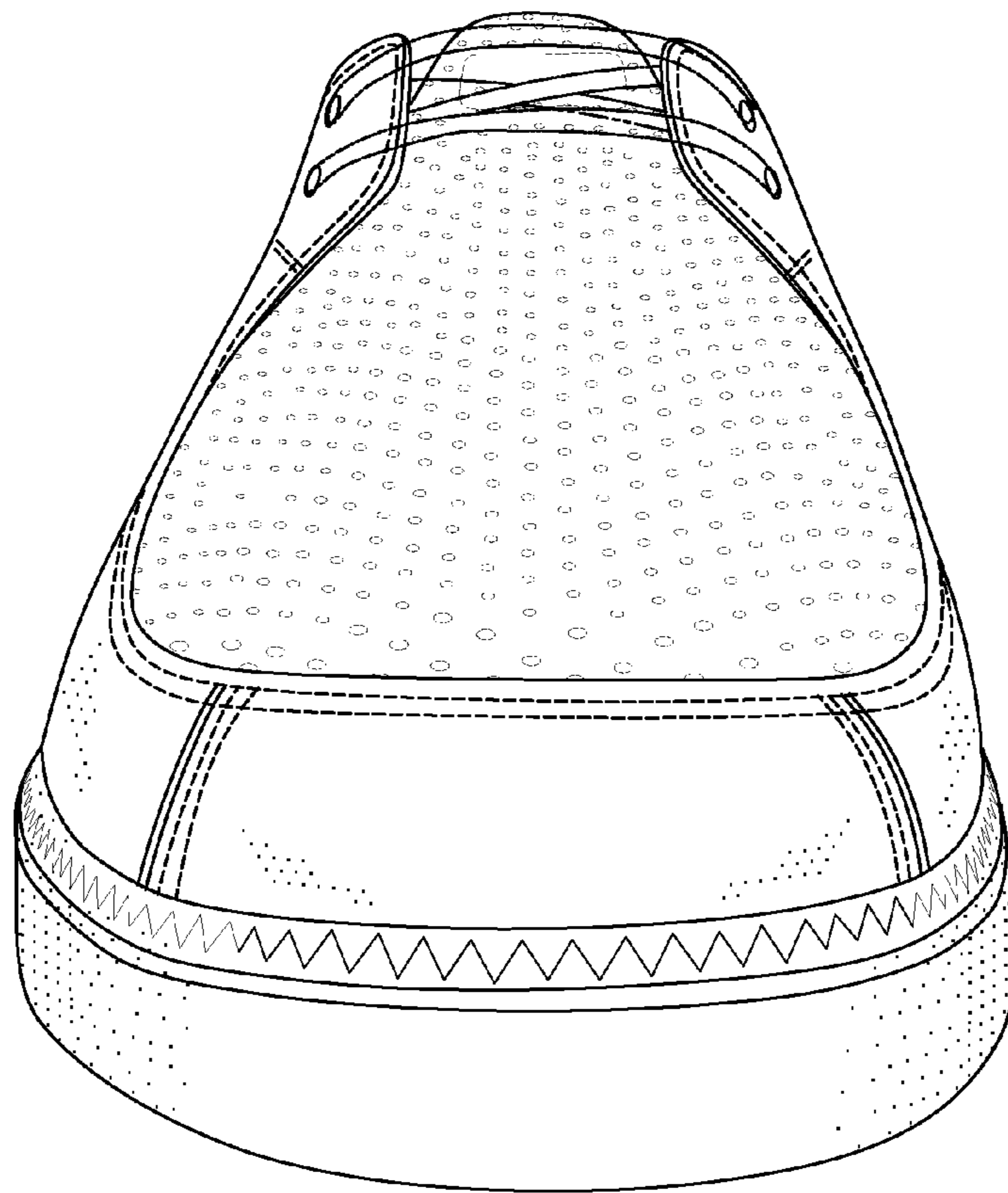

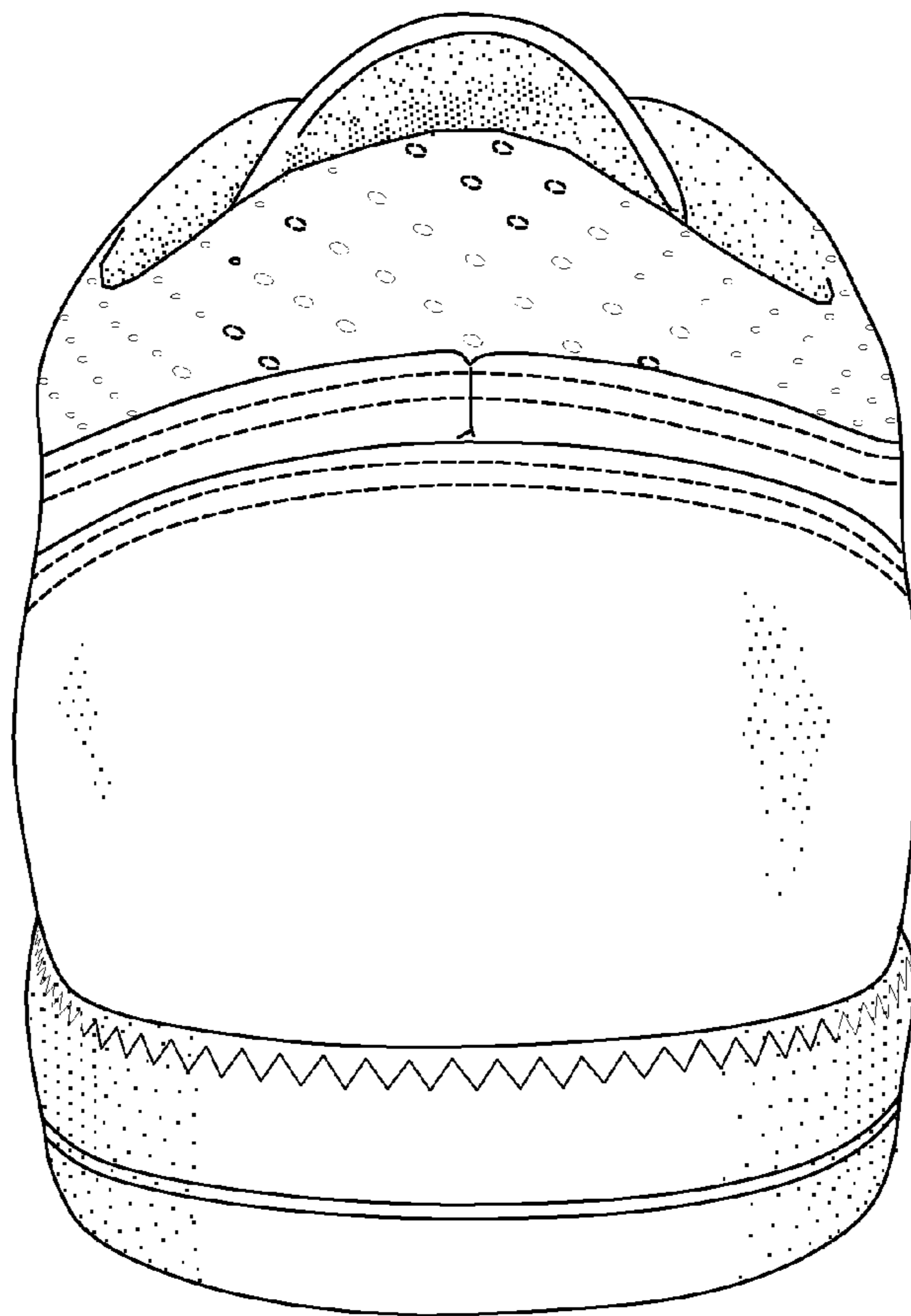

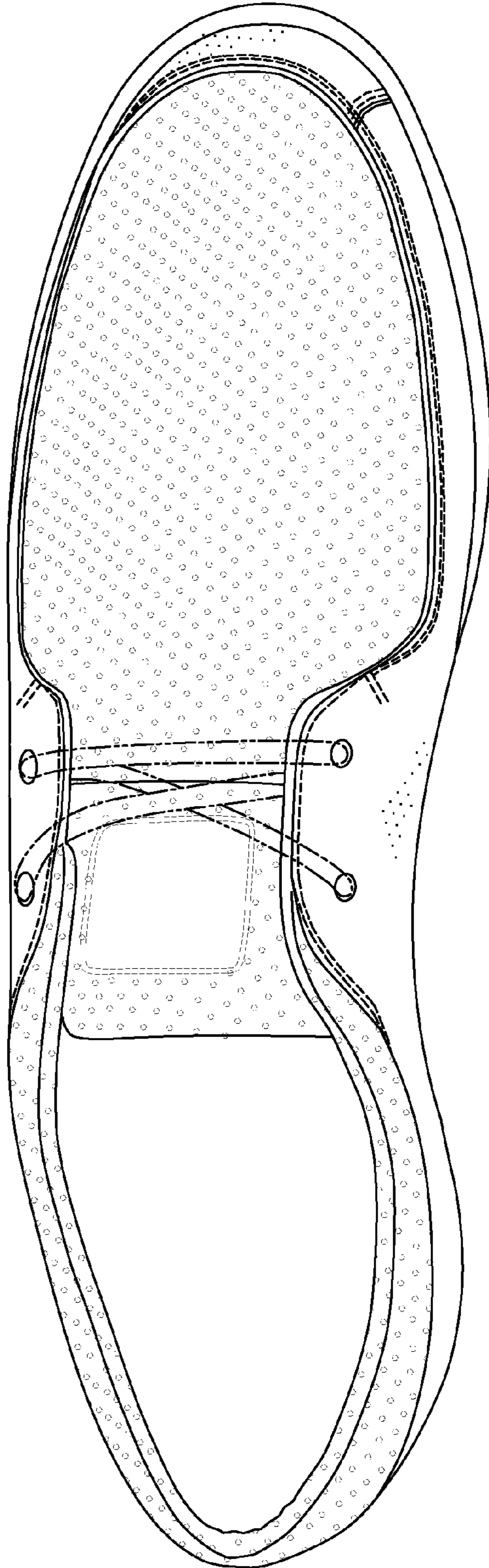
