(57) **CLAIM**

I claim the ornamental design for a shopping bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a shopping bag showing my new design; the handle is shown in an extended position;

FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a perspective view thereof;

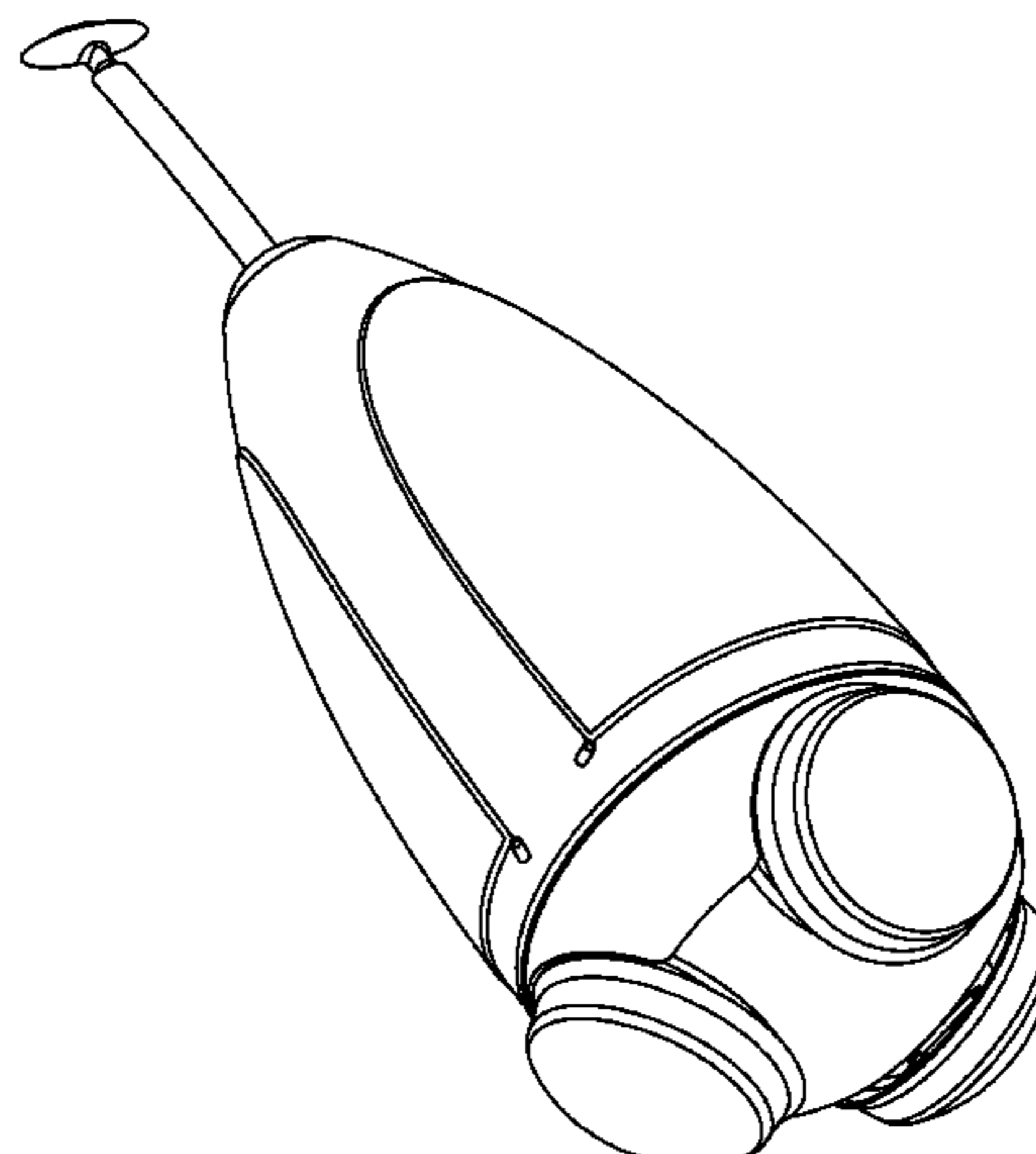
FIG. 5 is a rear elevational view thereof;

FIG. 6 is a perspective view thereof, shown in an alternate position in which the handle is not extended;

FIG. 7 is a perspective view thereof, the handle shown in an extended position, and one of the flaps shown in an open position; and,

FIG. 8 is another perspective view looking from the bottom.

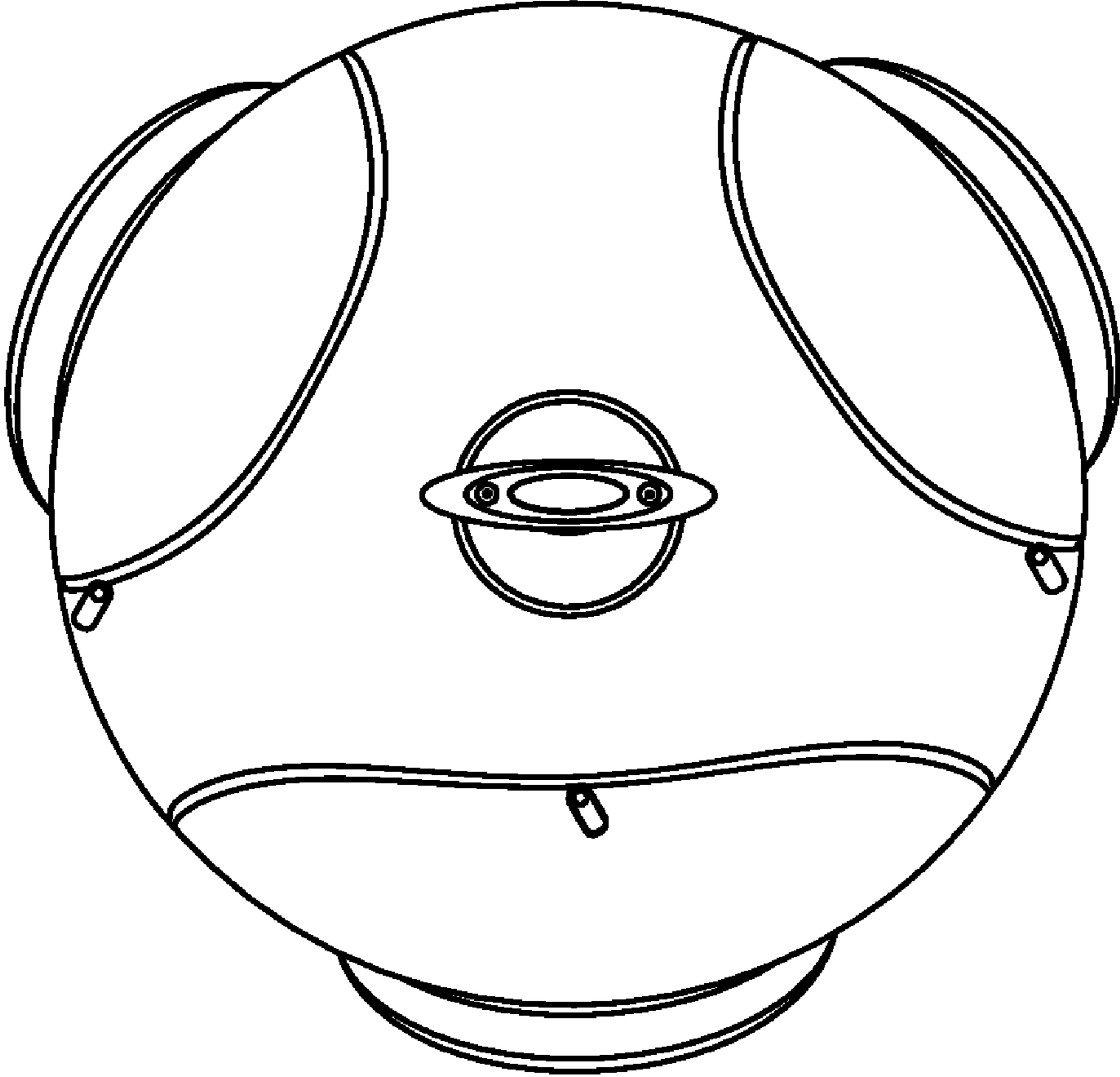

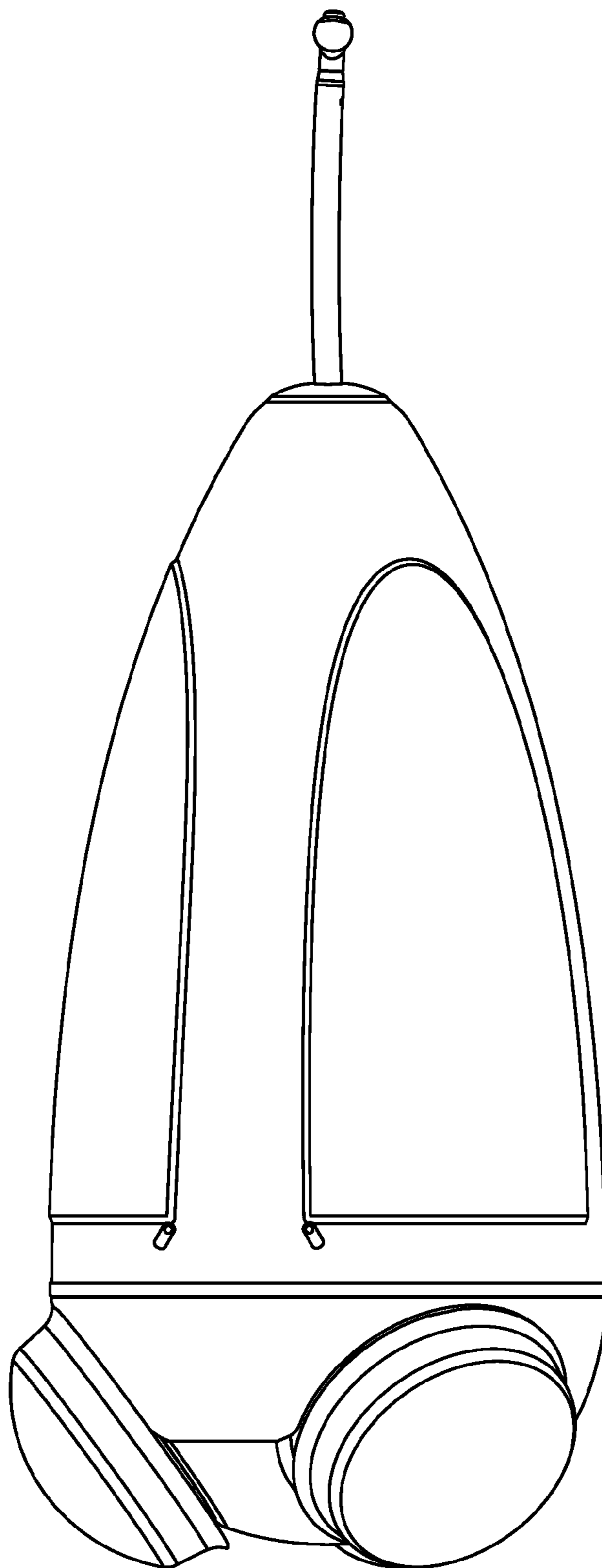

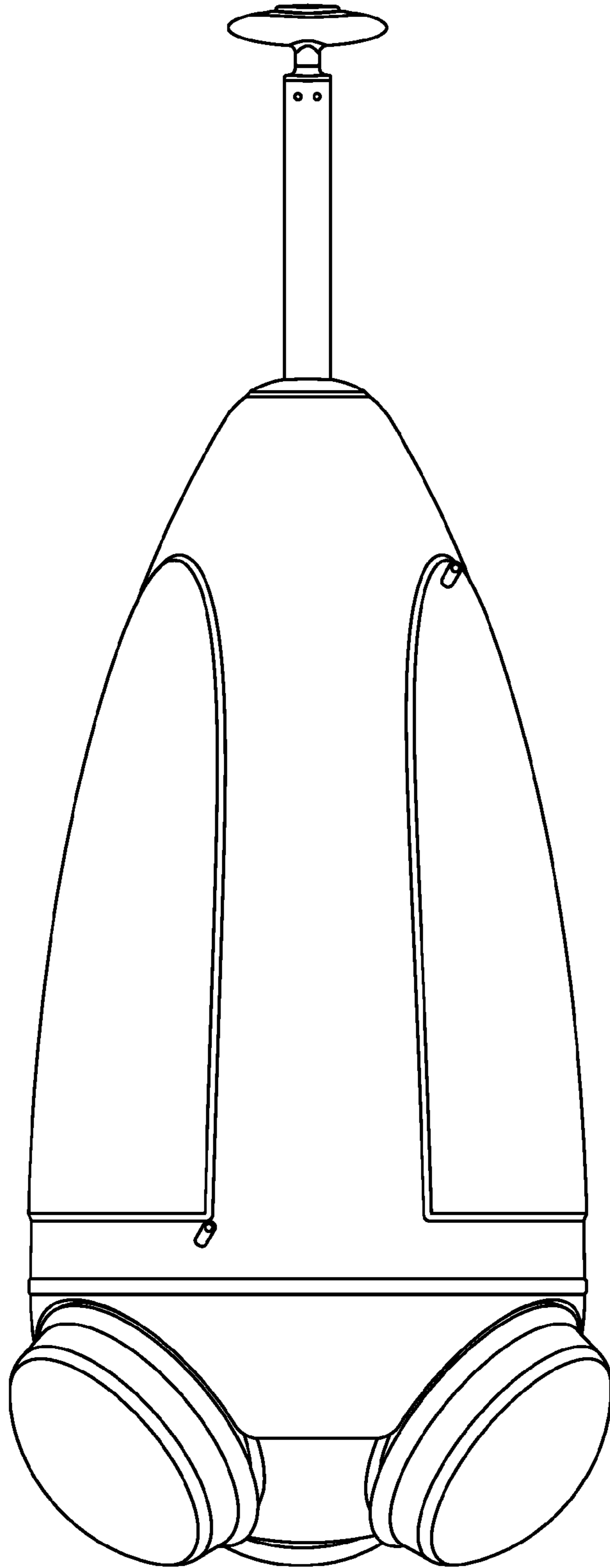

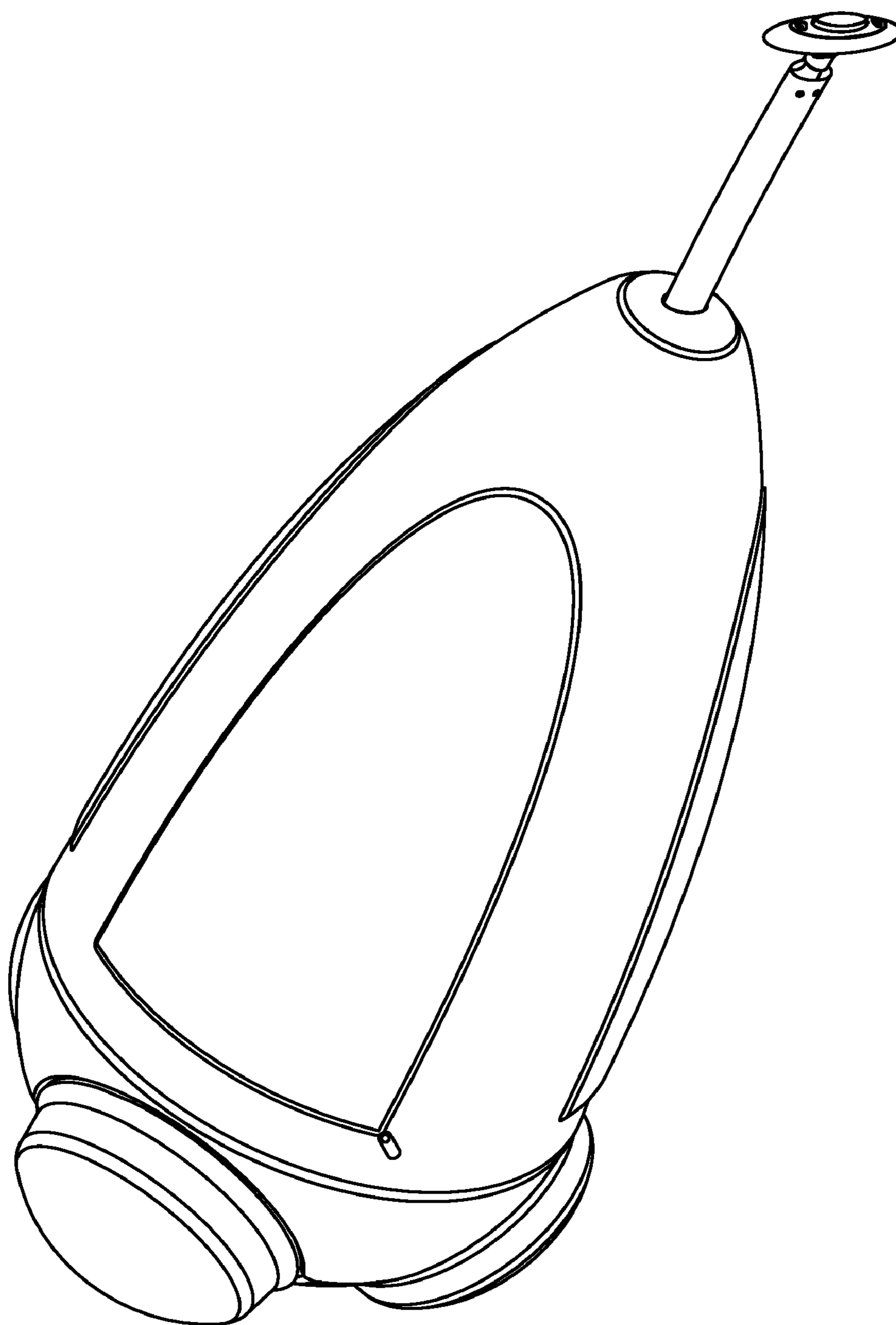

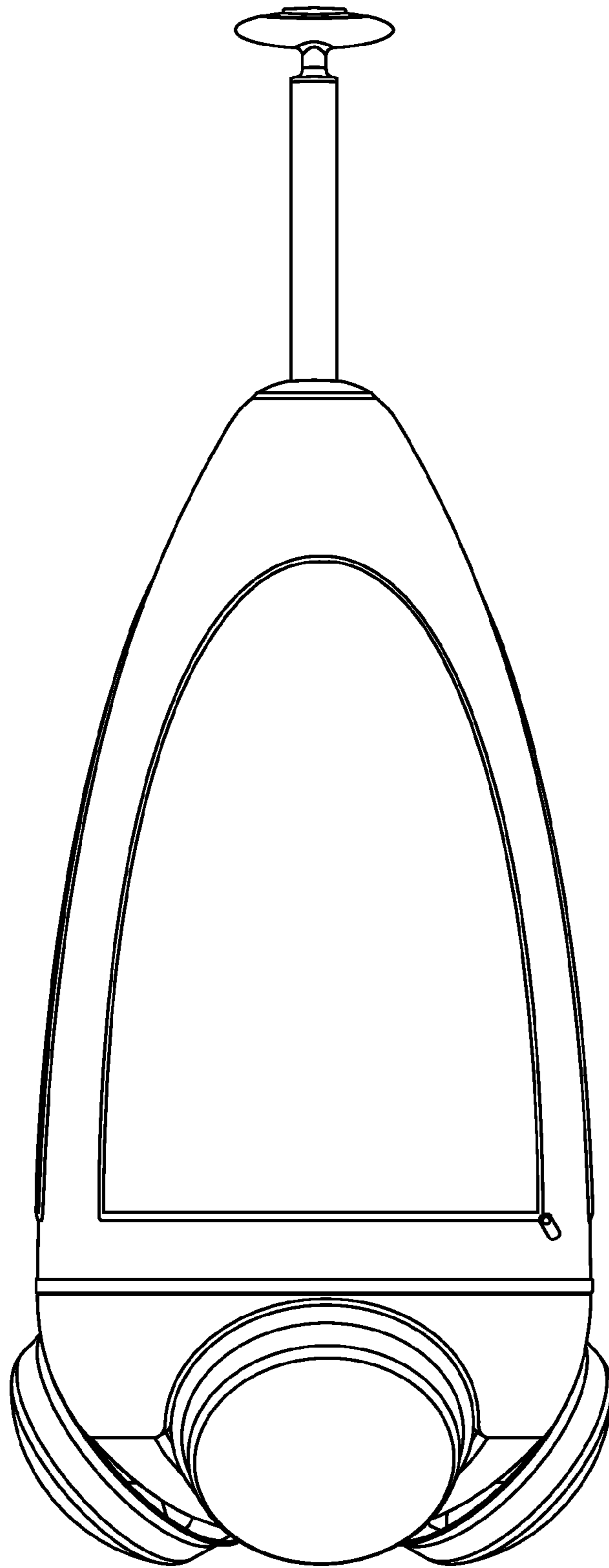

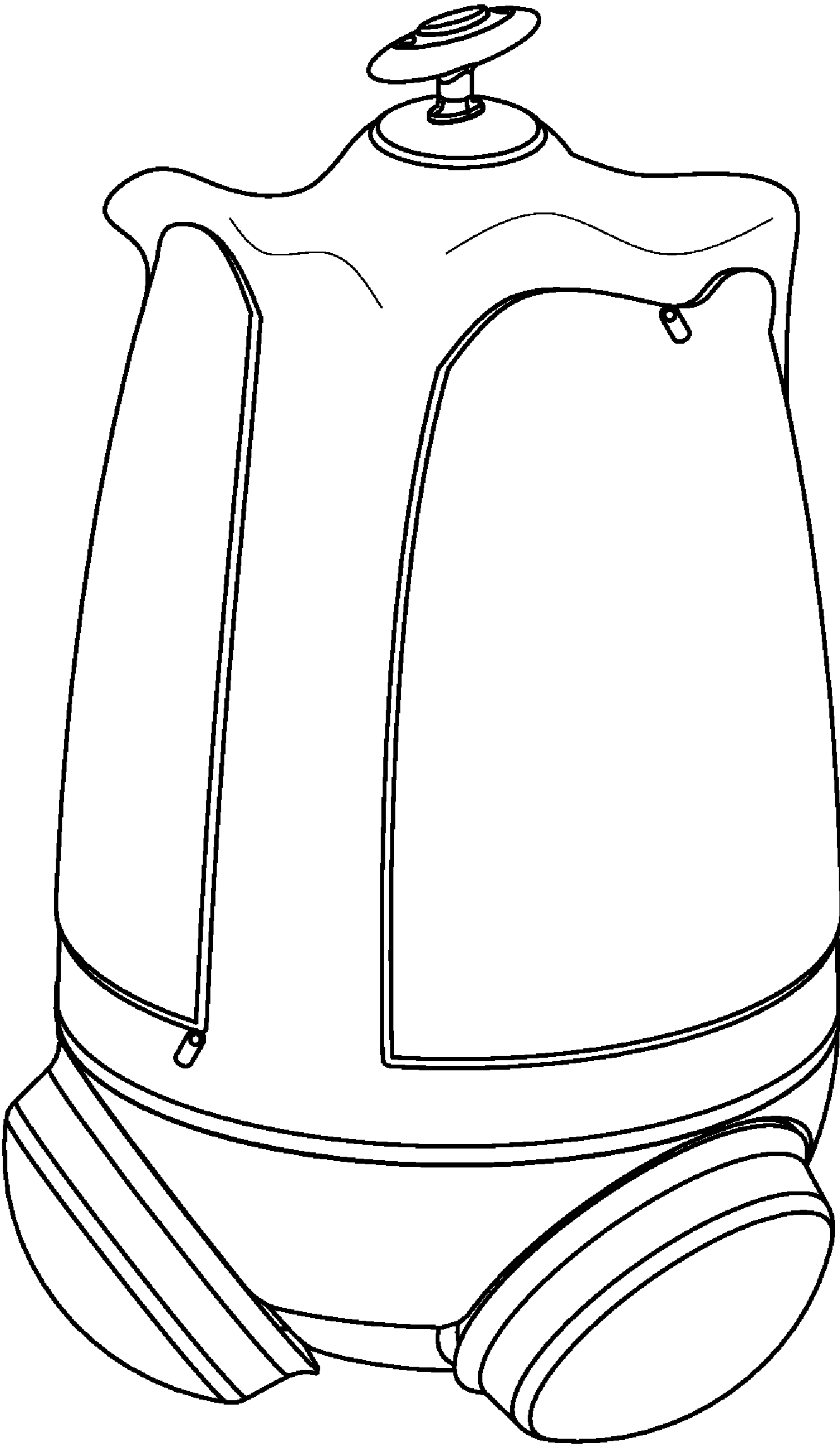

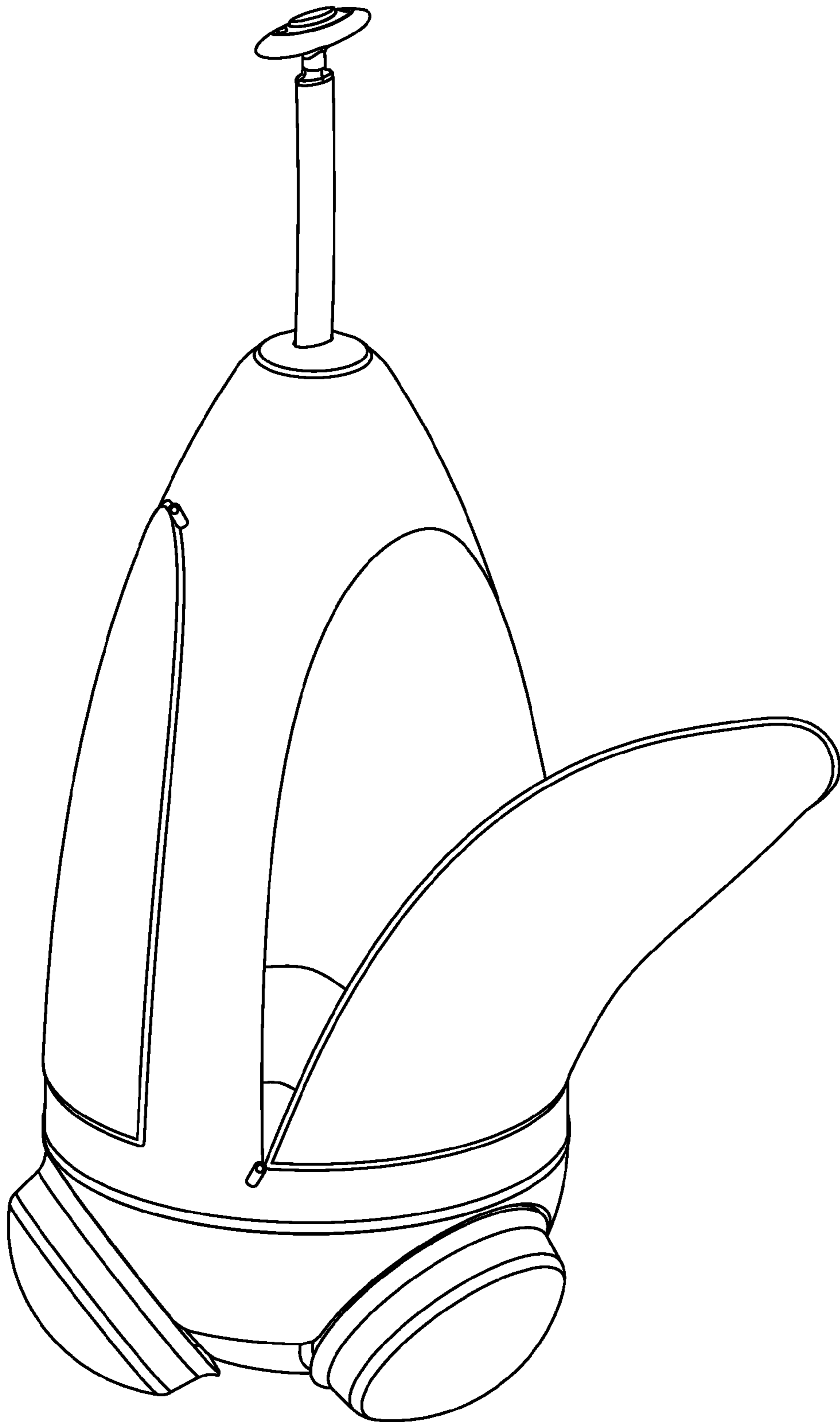

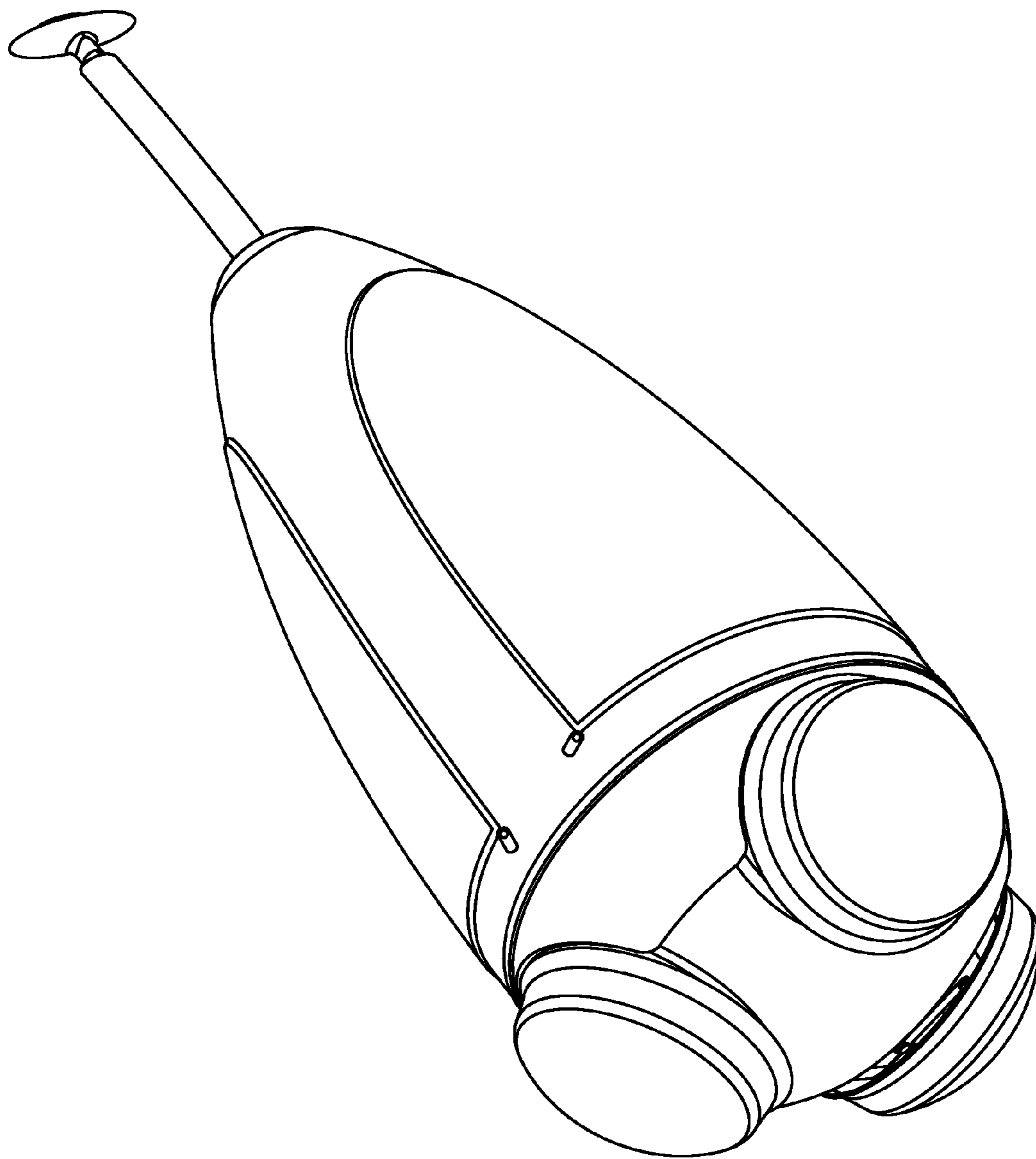
