(57) **CLAIM**

I claim the ornamental design for a mobile stool, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a mobile stool of the present invention (the broken lines in FIGS. 1-7 are for illustrative purposes only and do not form part of the invention shown in FIGS. 1-7);

FIG. 2 is a side perspective view of the mobile stool shown in FIG. 1;

FIG. 3 is a front elevational view of the mobile stool shown in FIG. 1;

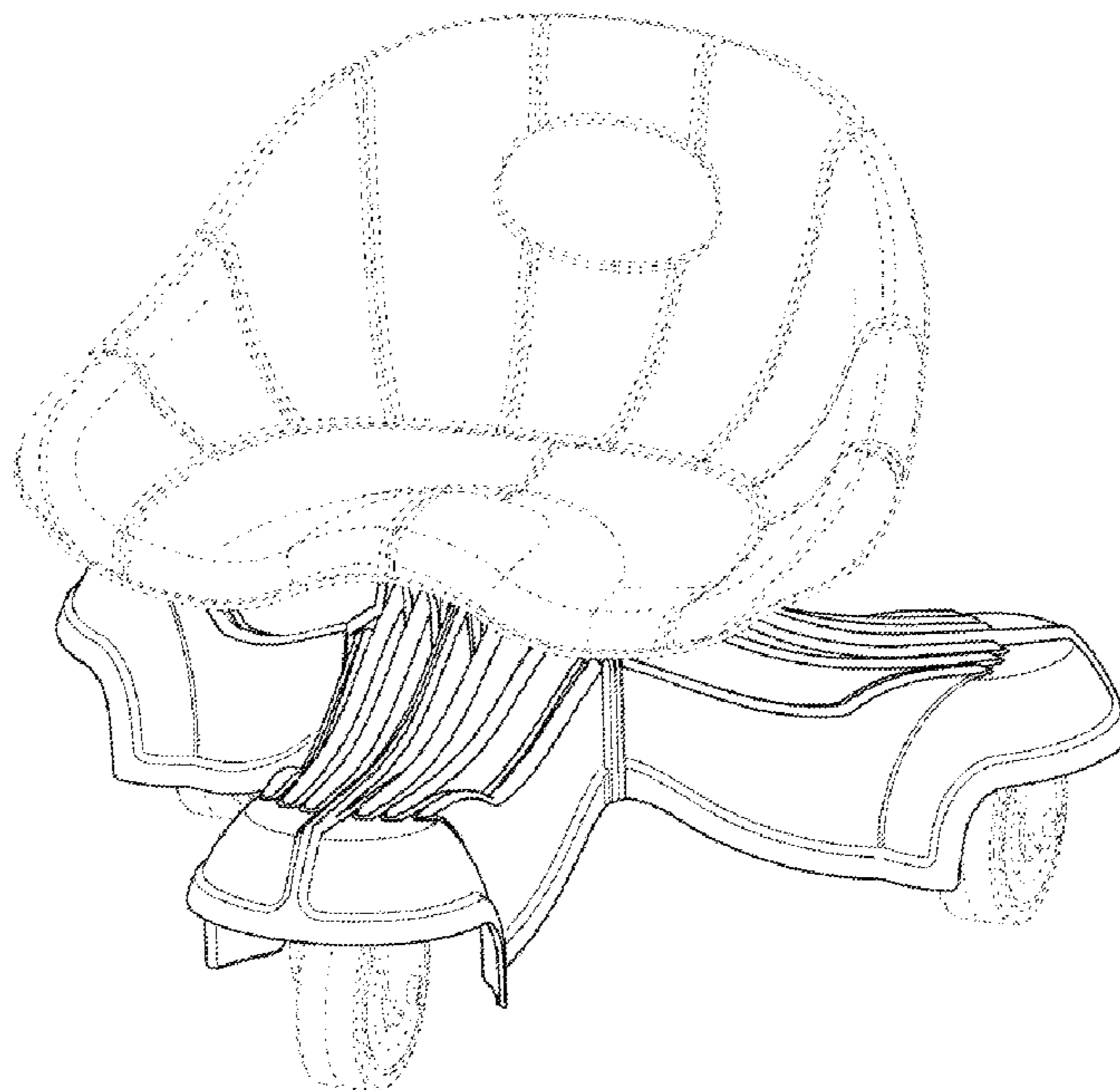
FIG. 4 is a rear elevational view of the mobile stool shown in FIG. 1;

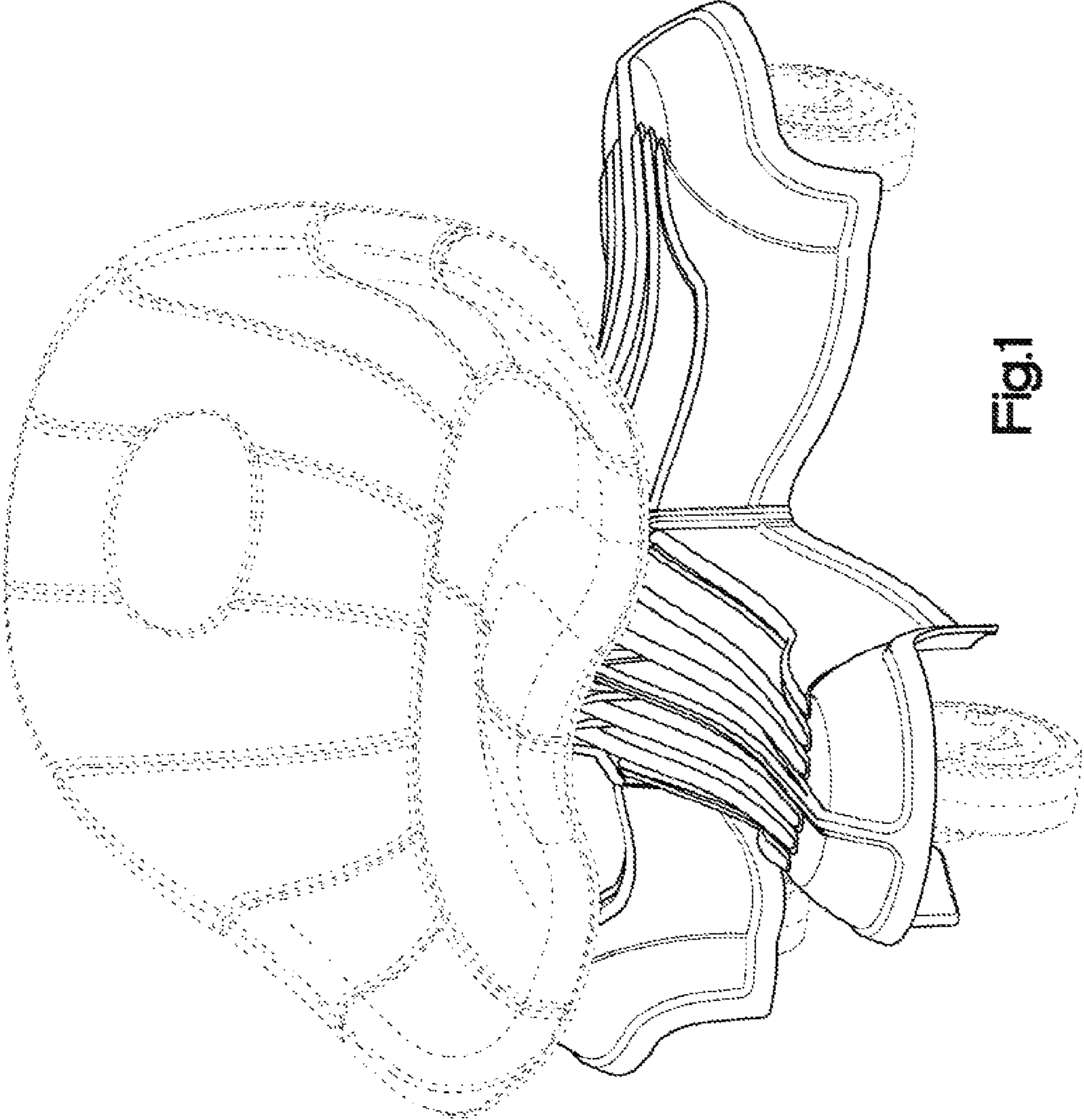

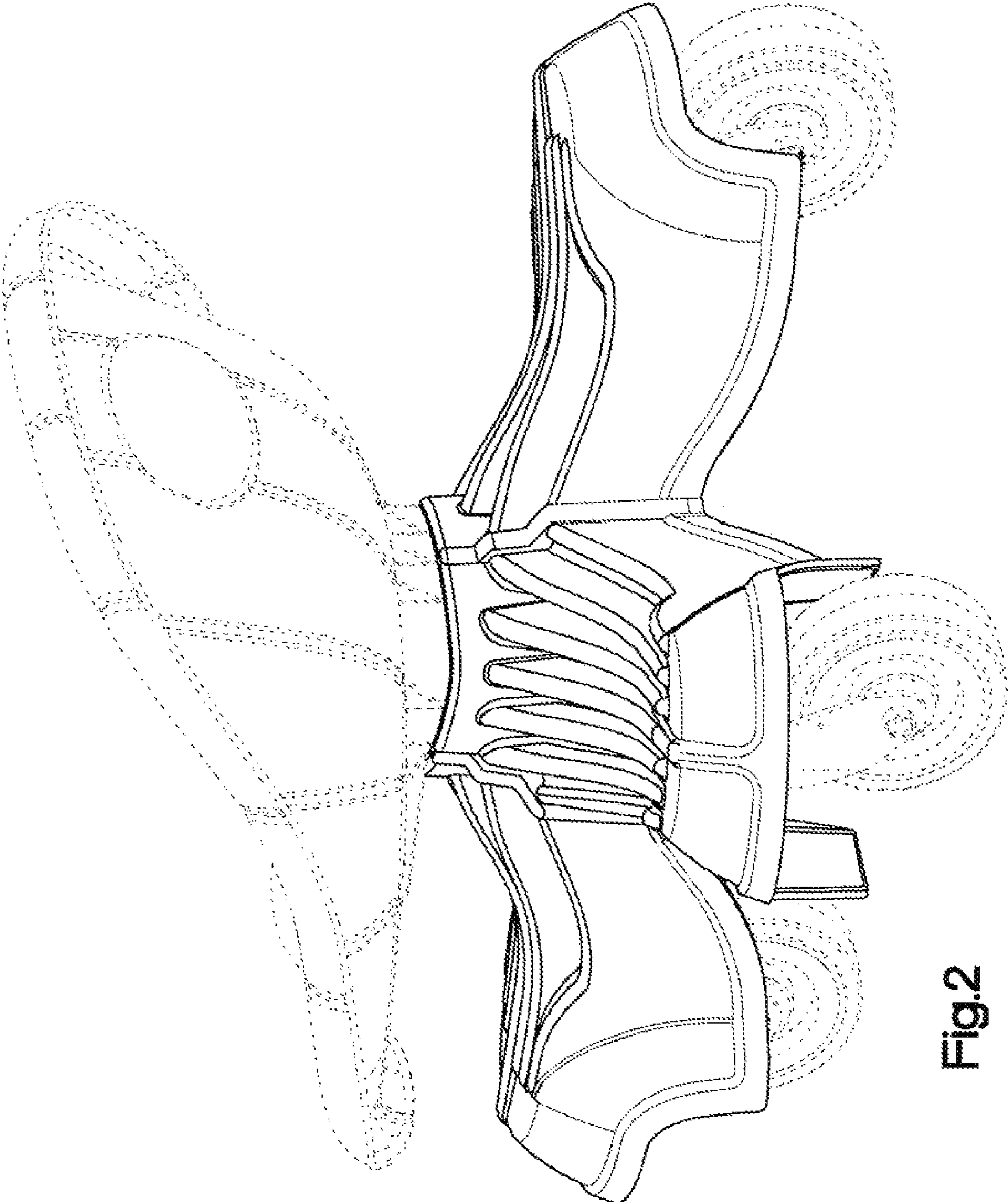

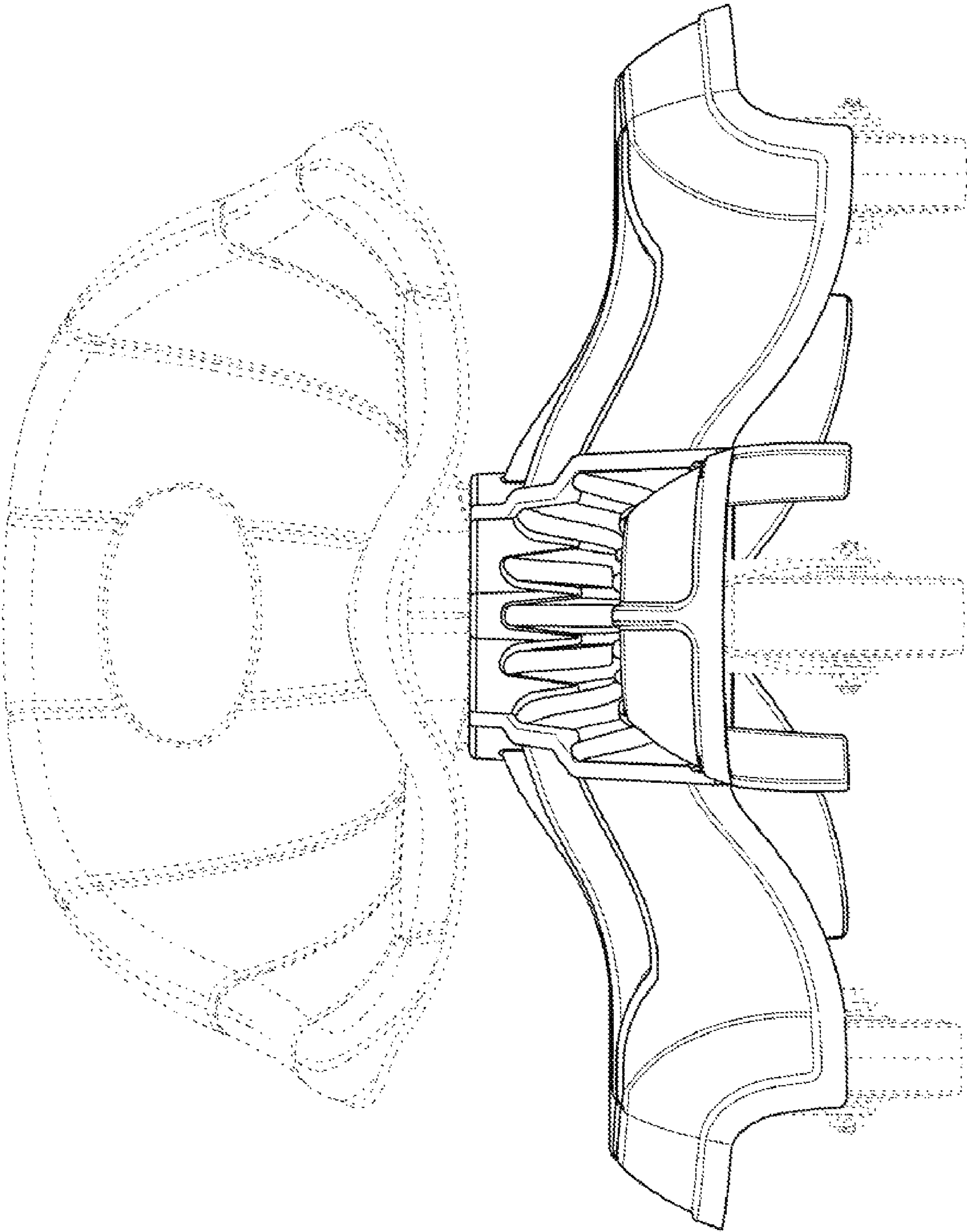

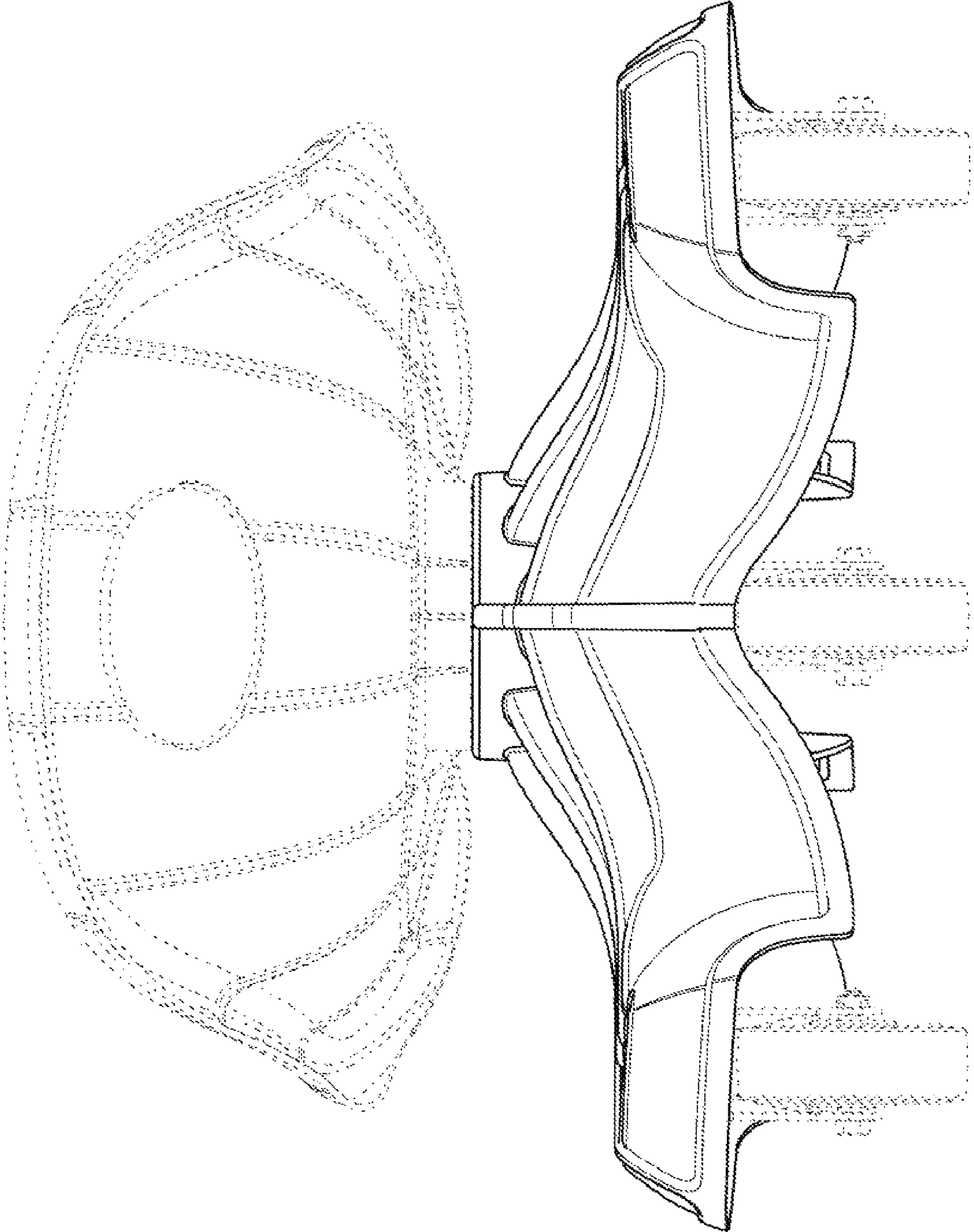

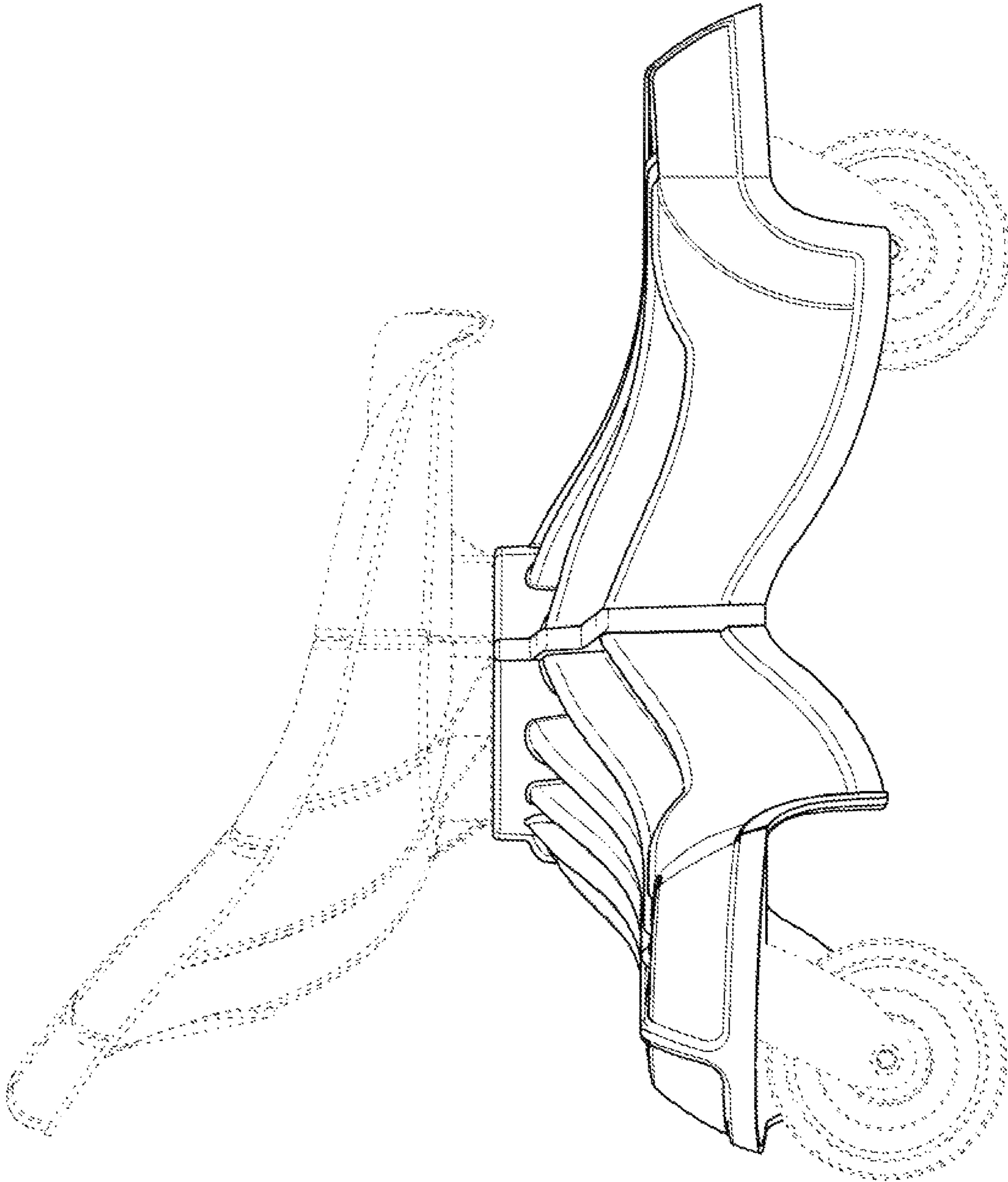

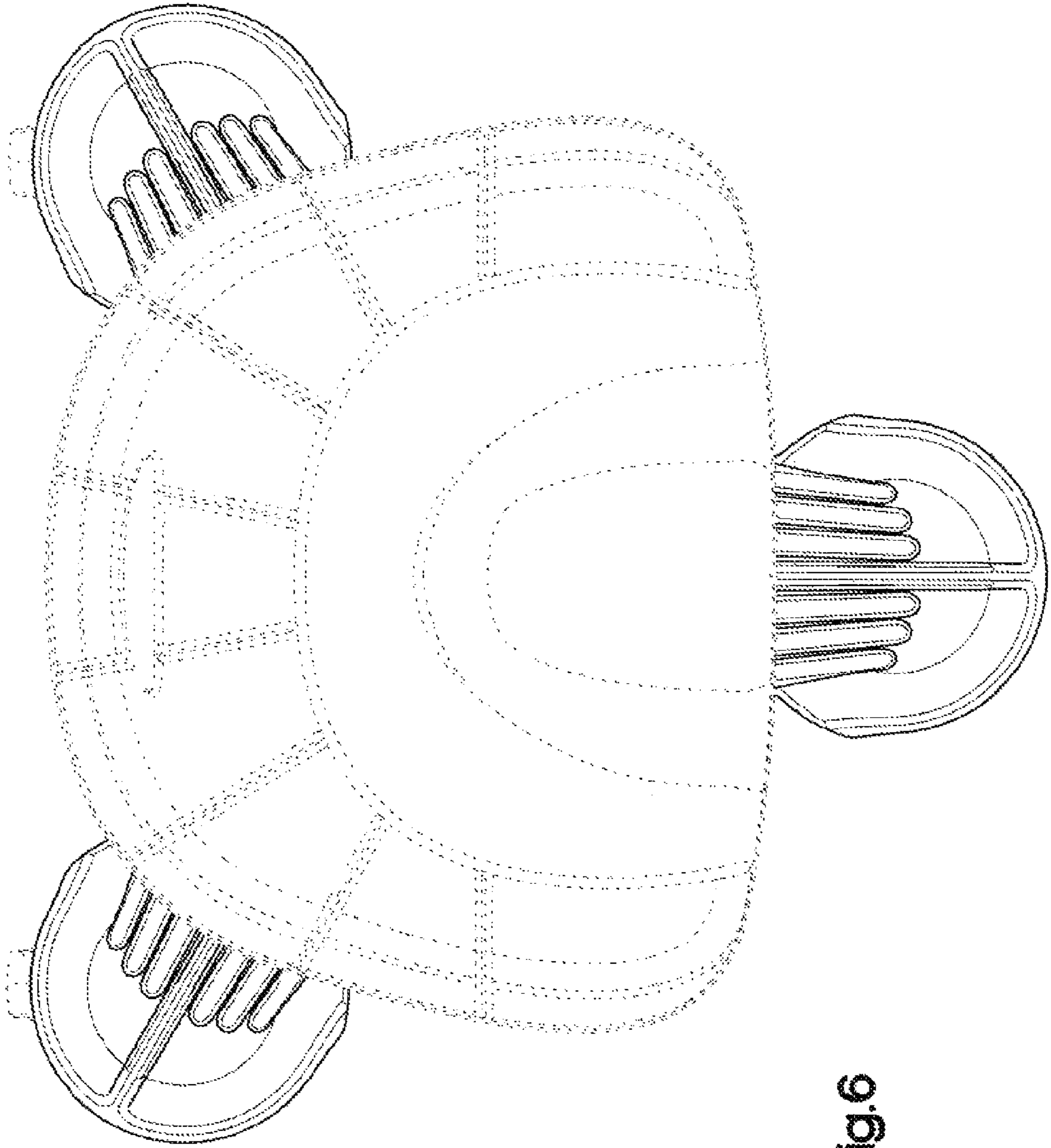

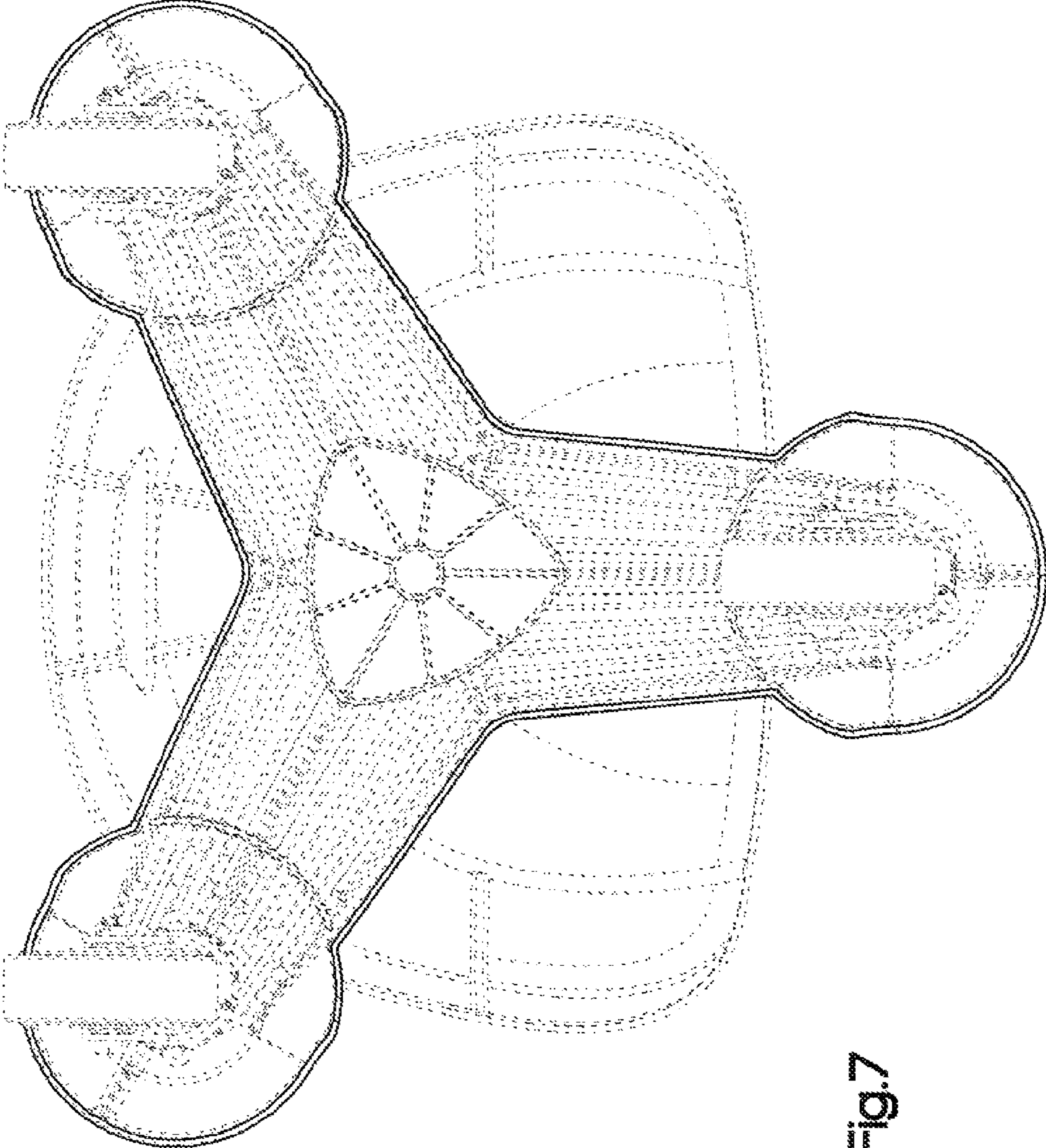
