FIG. 2 shows a front view of a cup holder showing my new design,

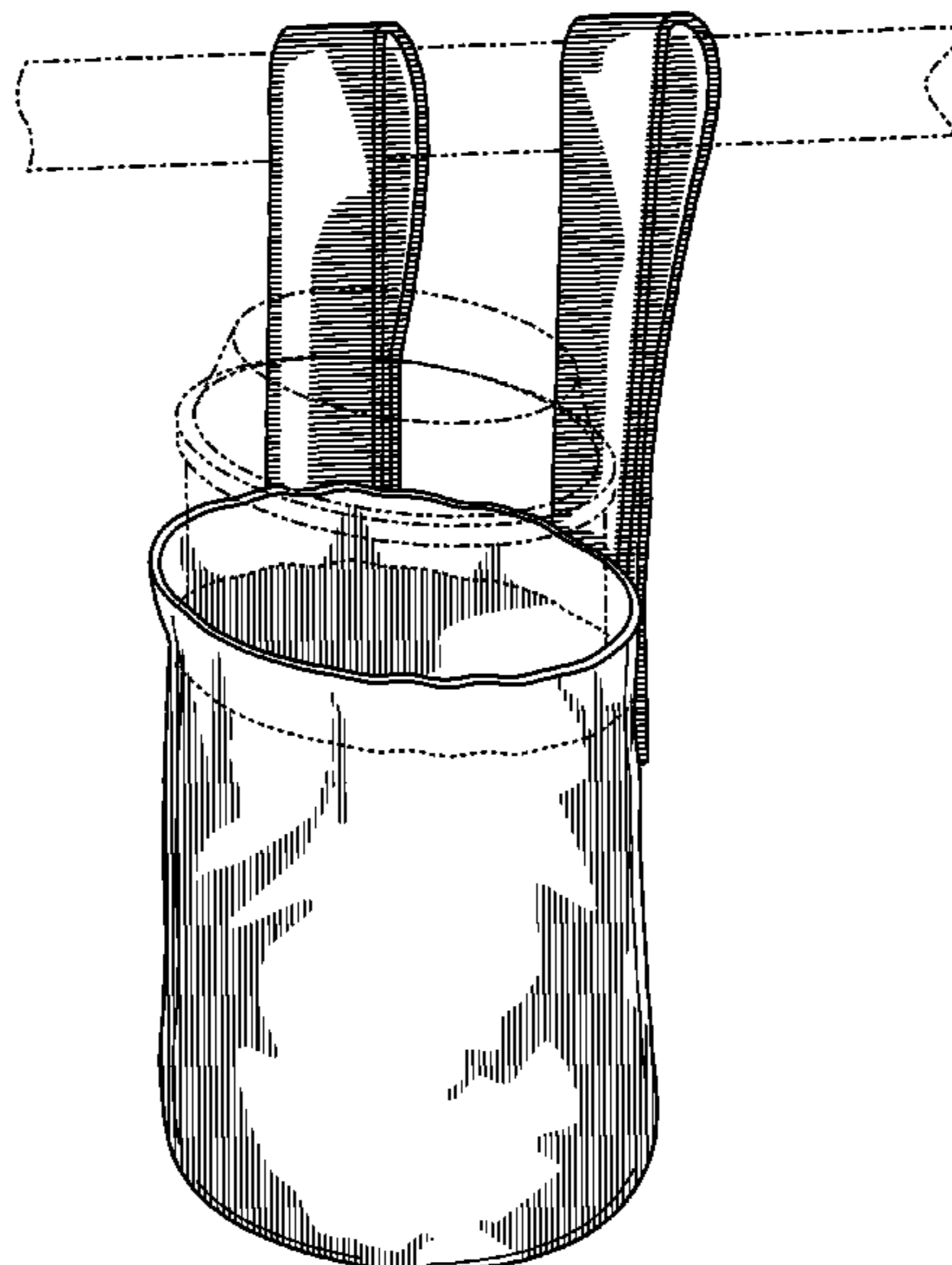
FIG. 3 shows a rear view of a cup holder showing my new design,

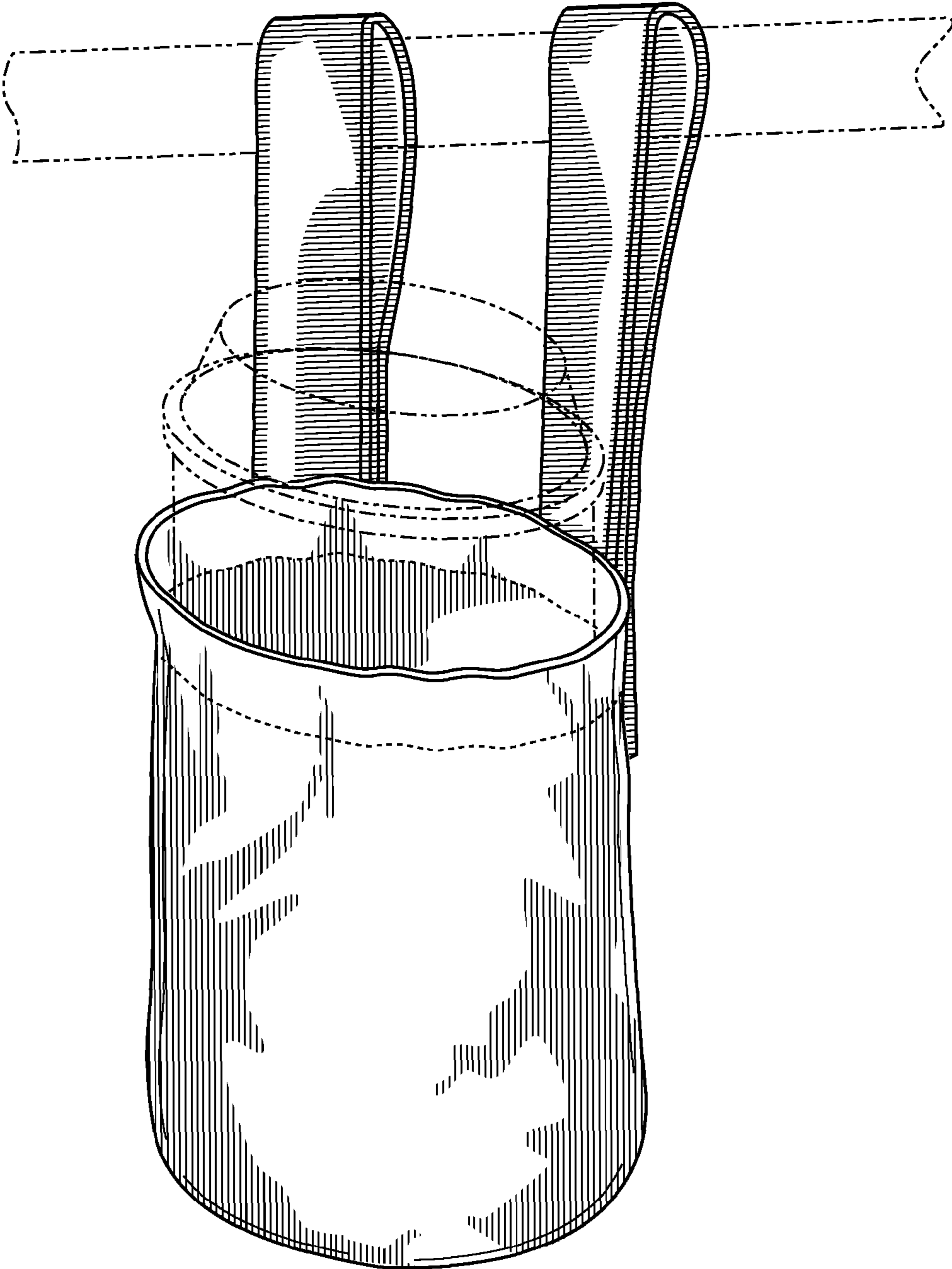

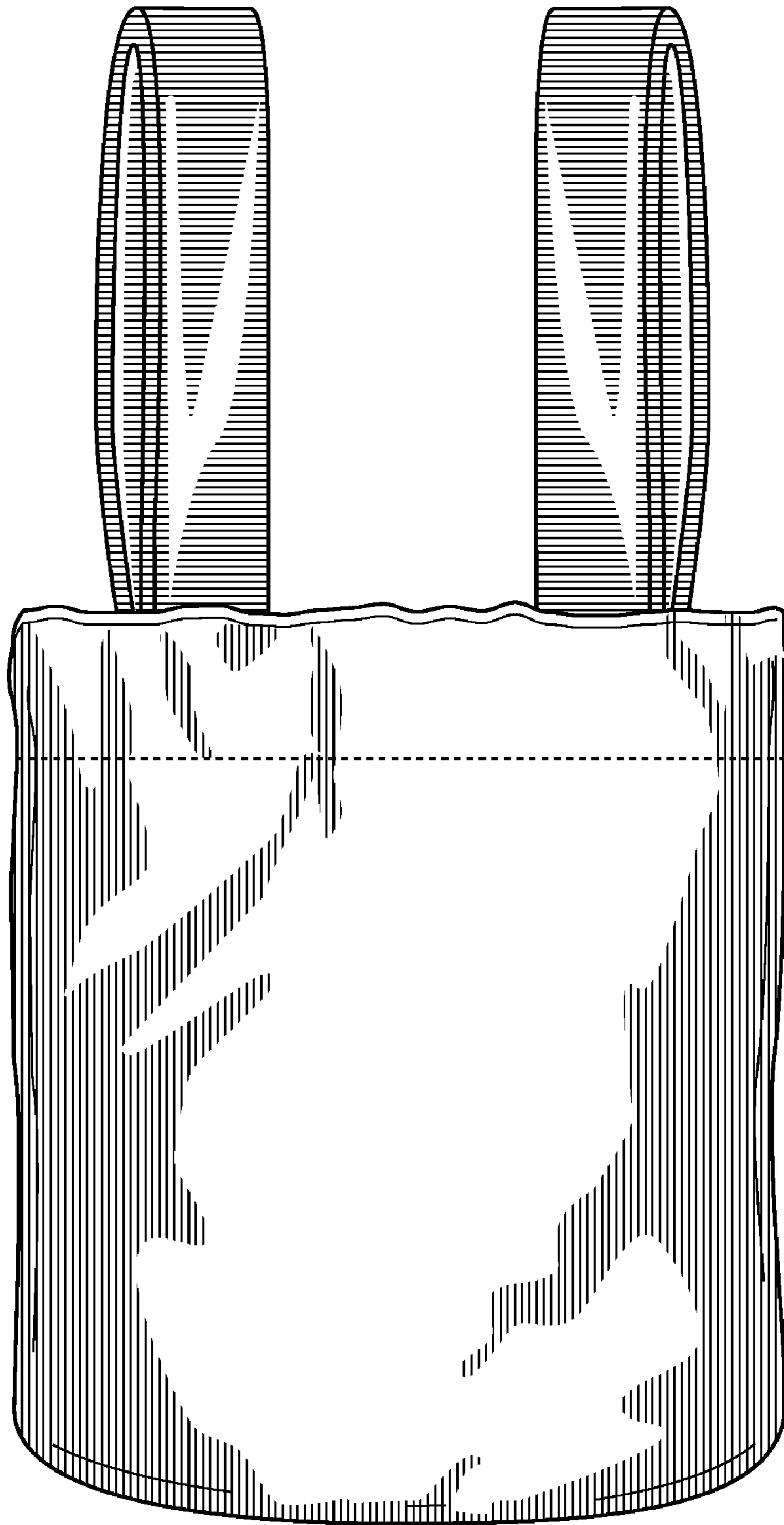

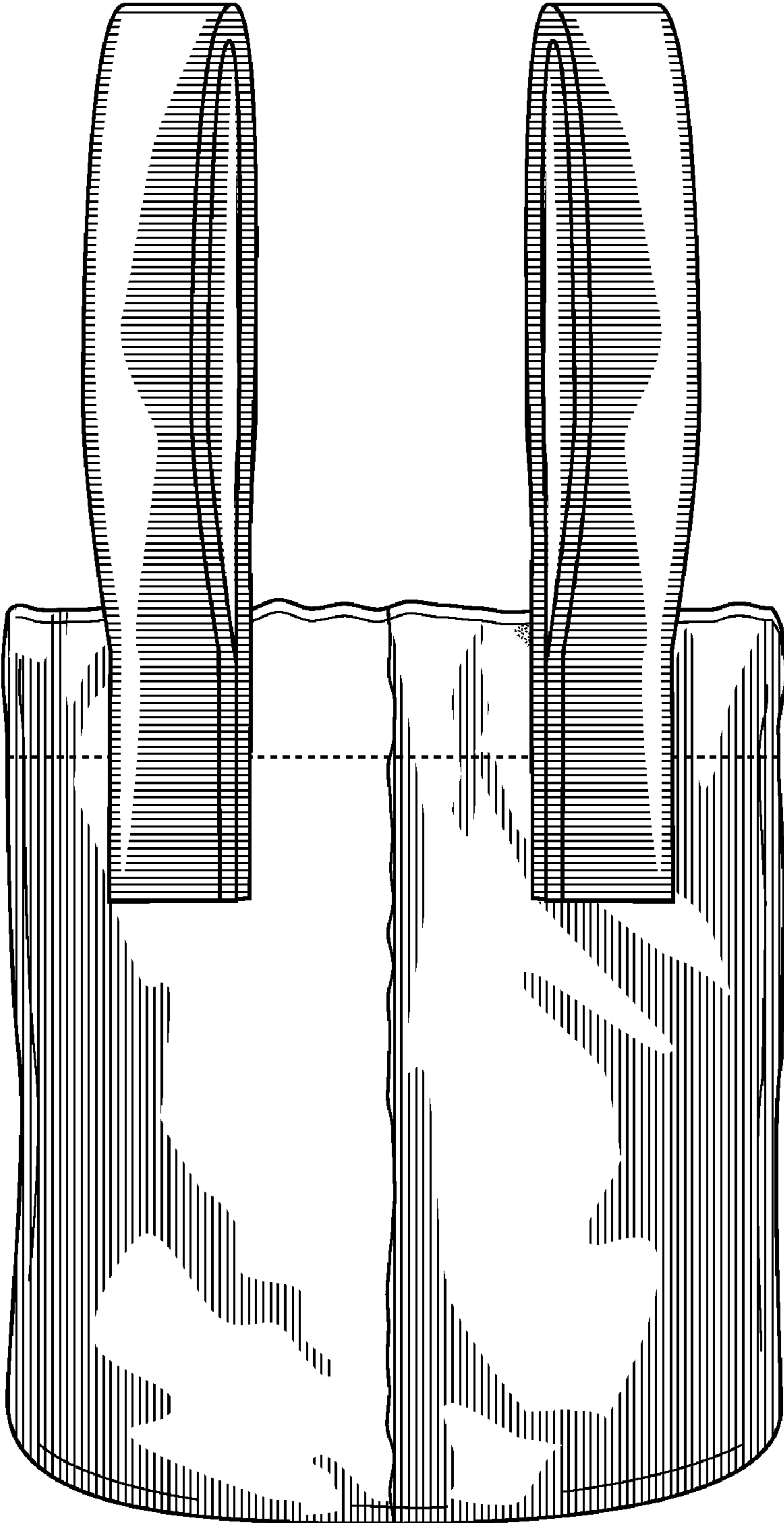

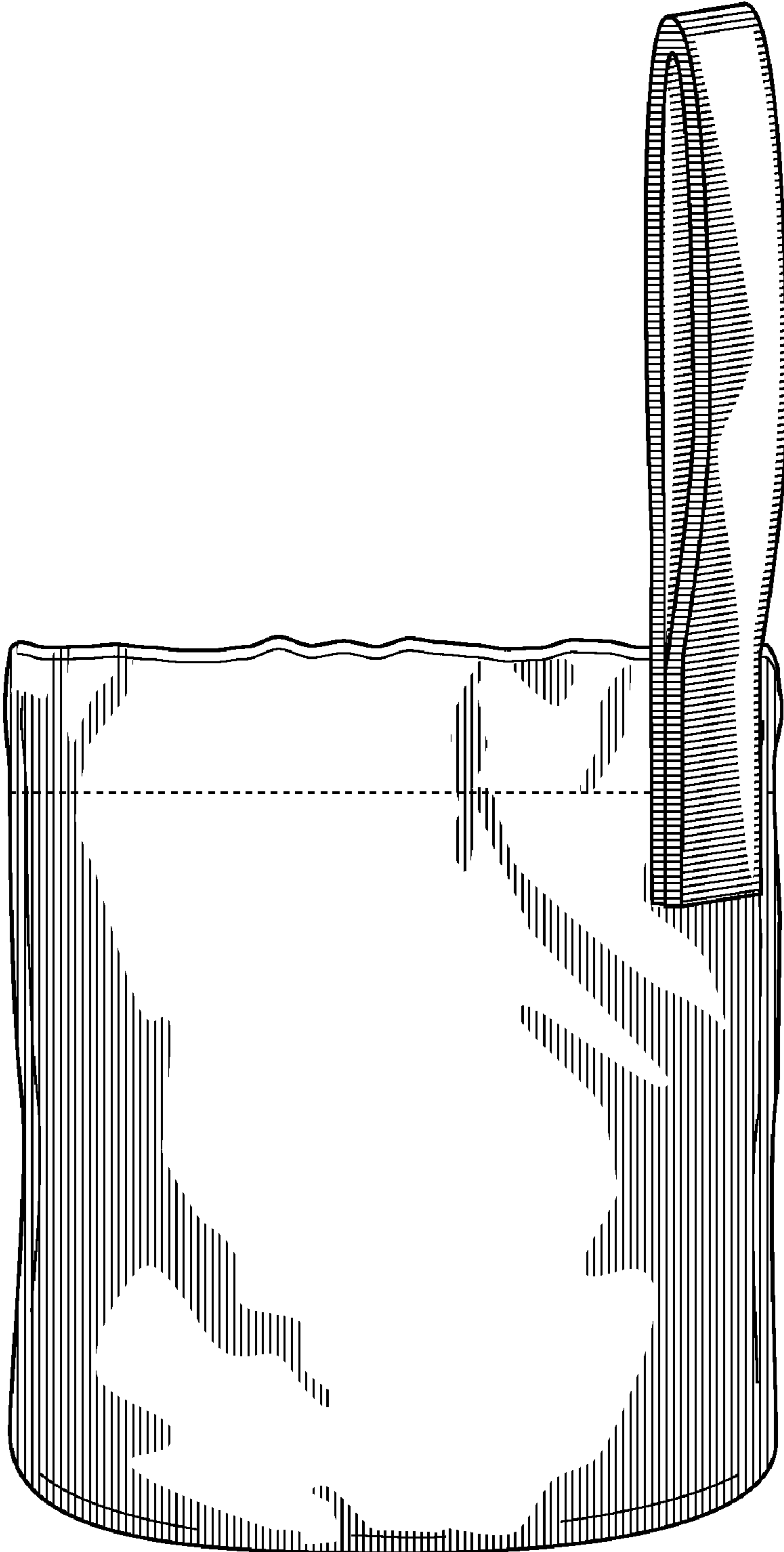

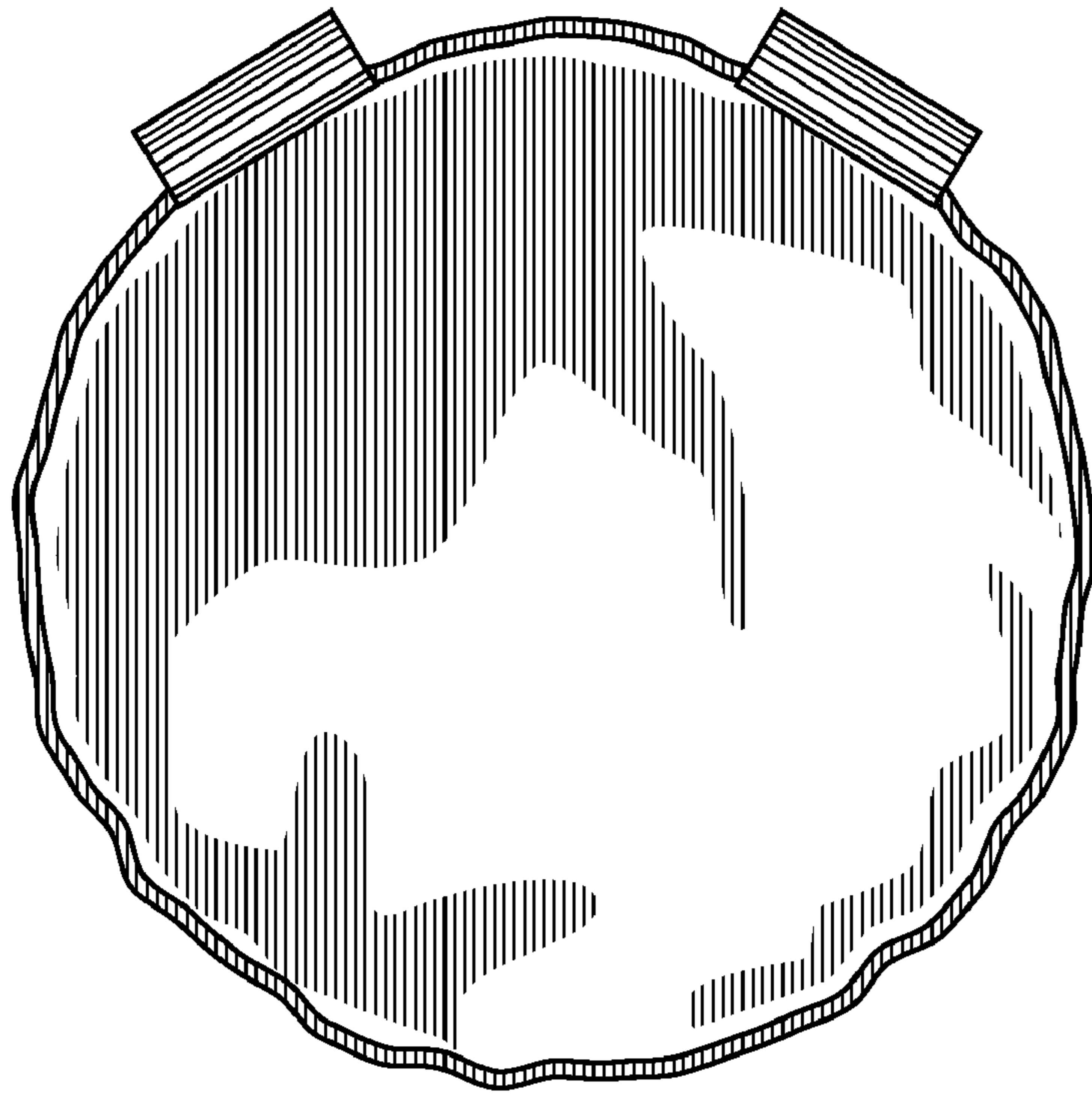

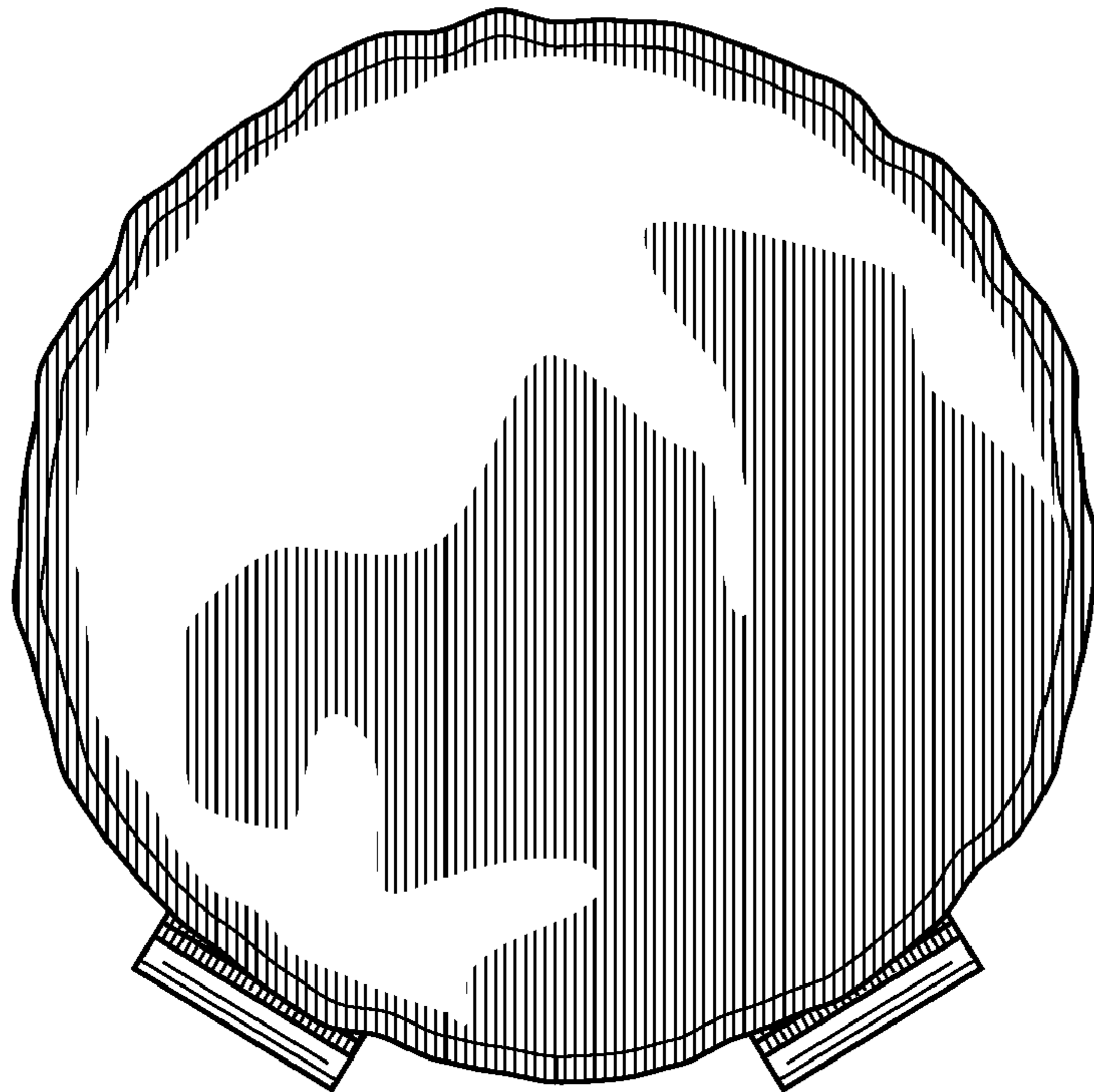
