DESCRIPTION

FIG. 15 is a top plan view of FIG. 13;

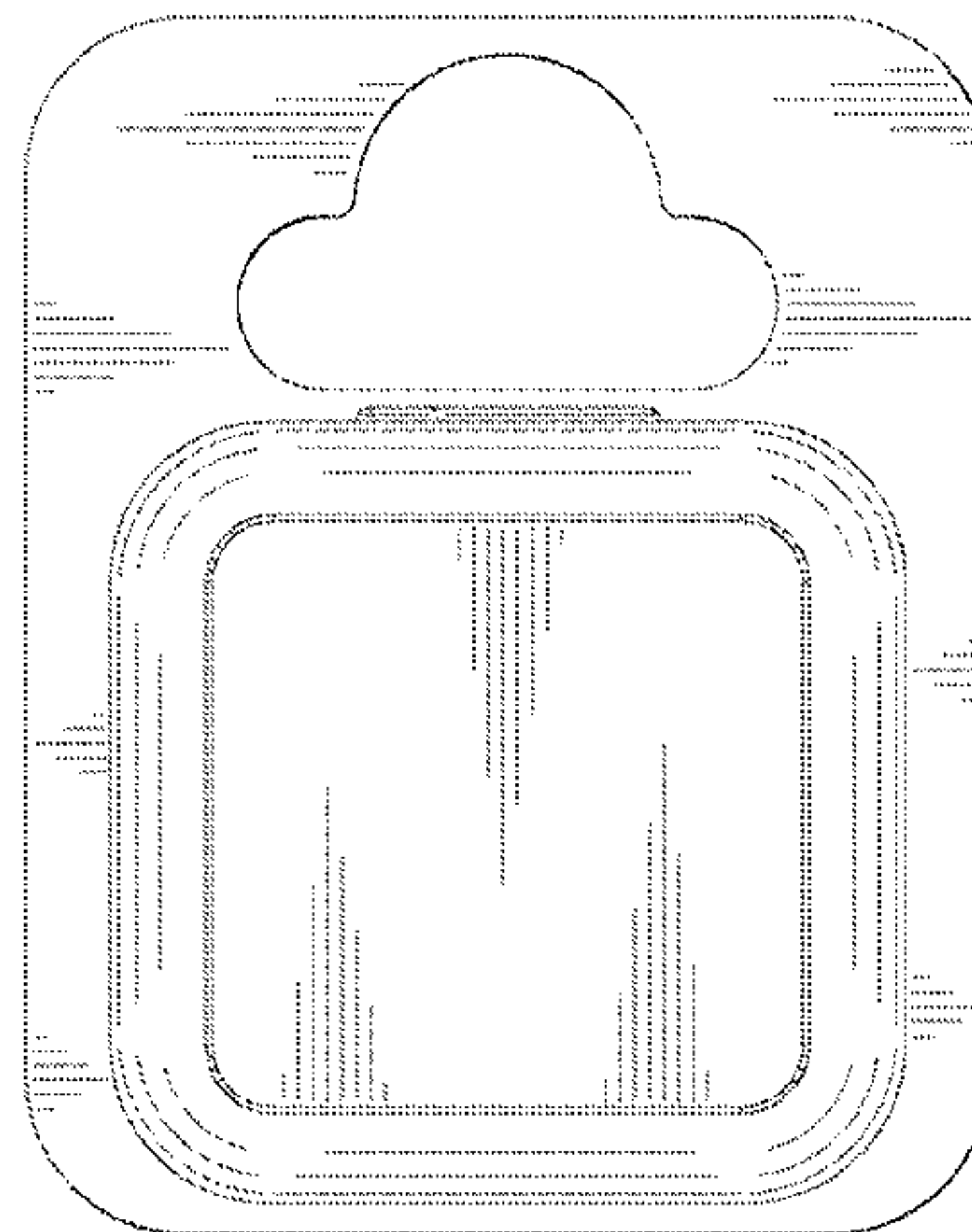
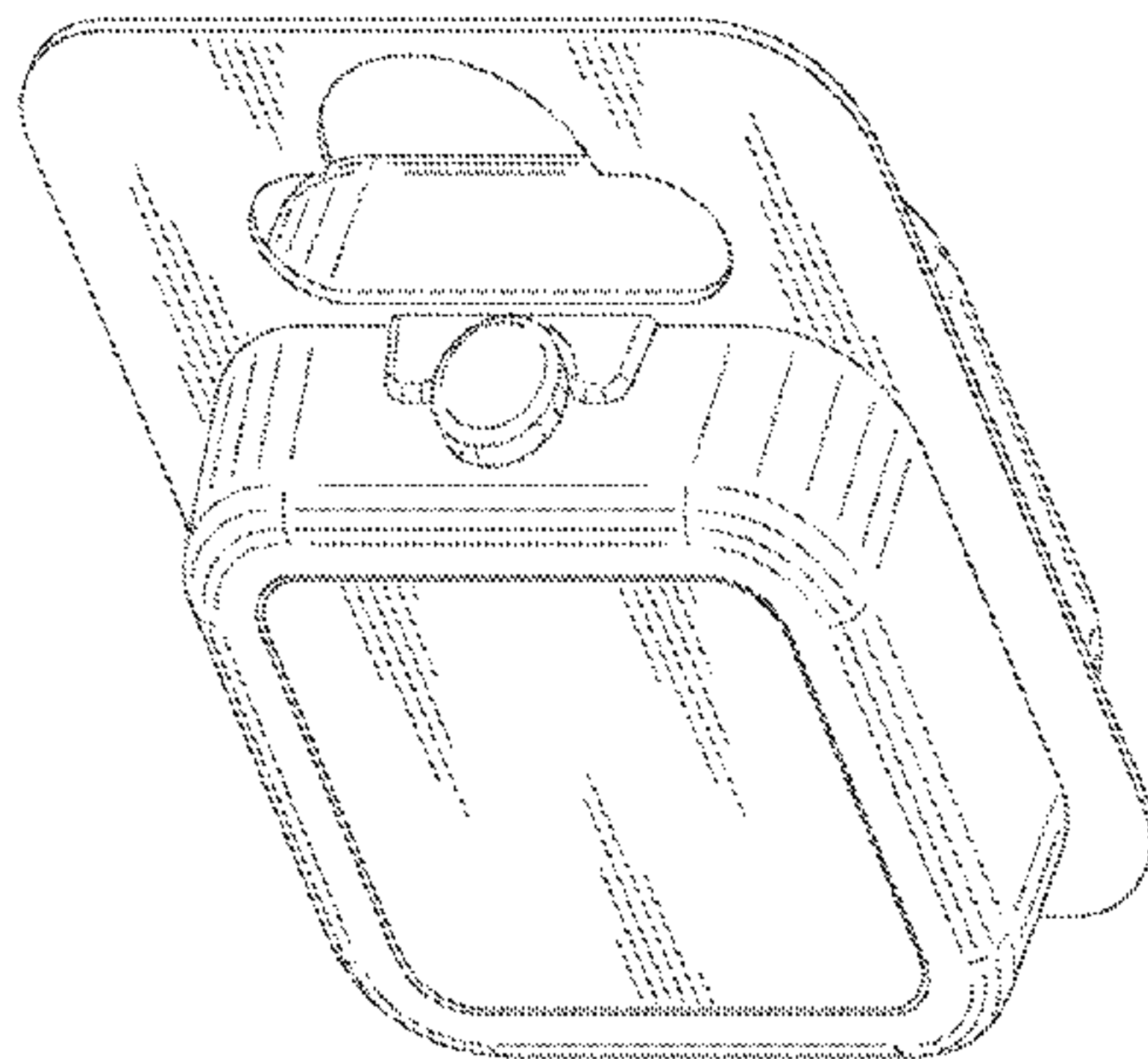
FIG. 16 is a right side elevational view of FIG. 13, the left side elevational view being a mirror image thereof;

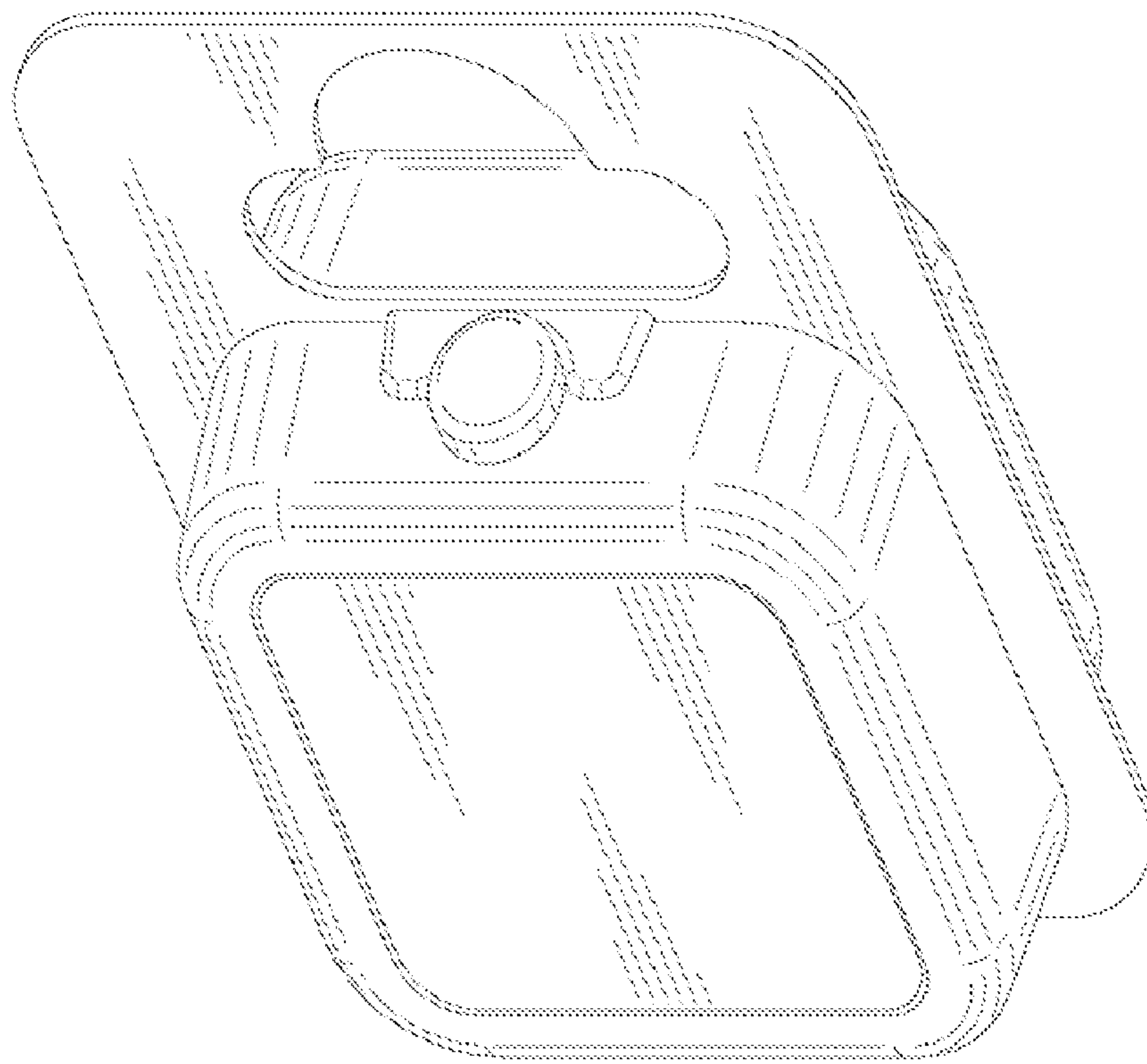

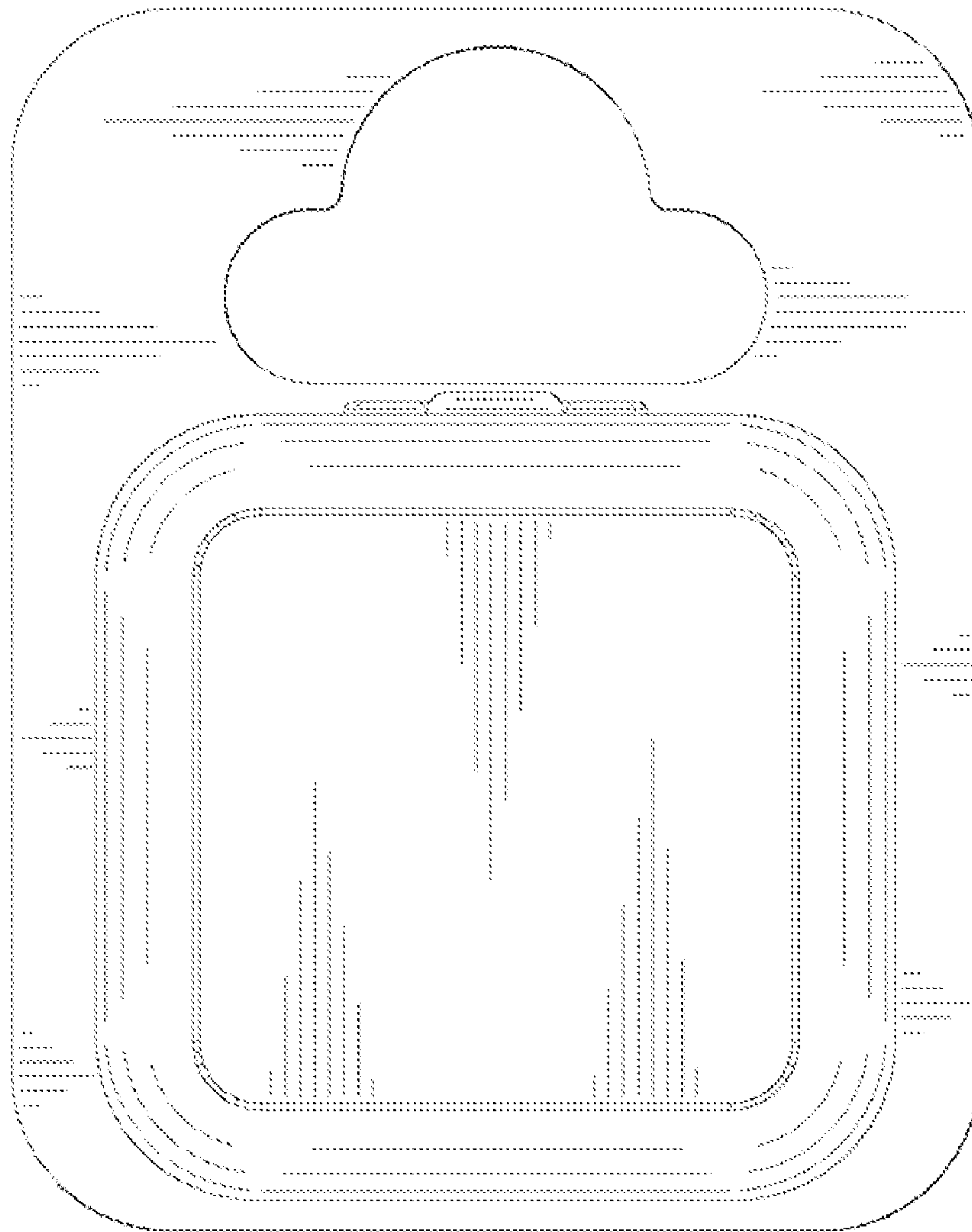

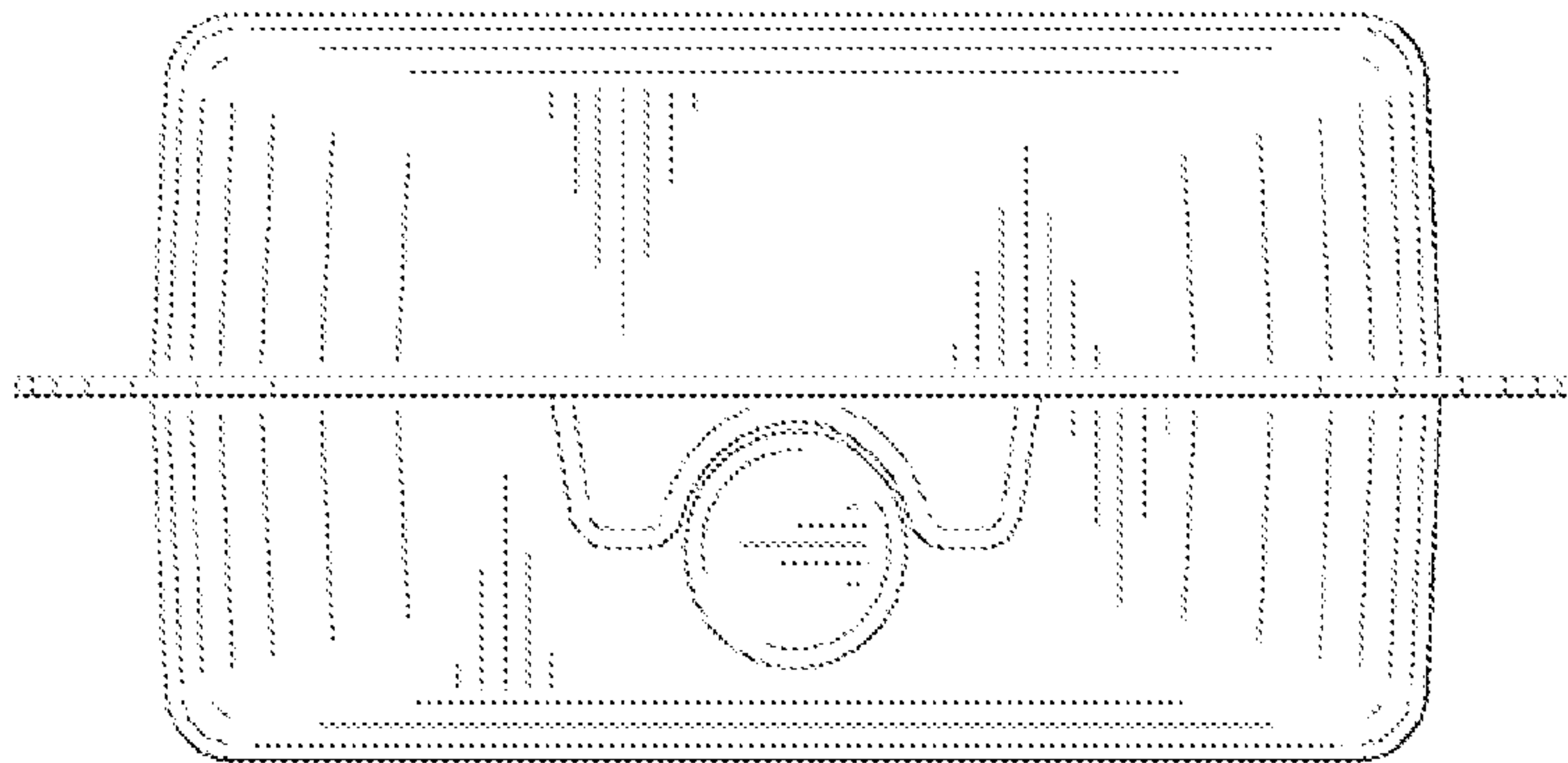

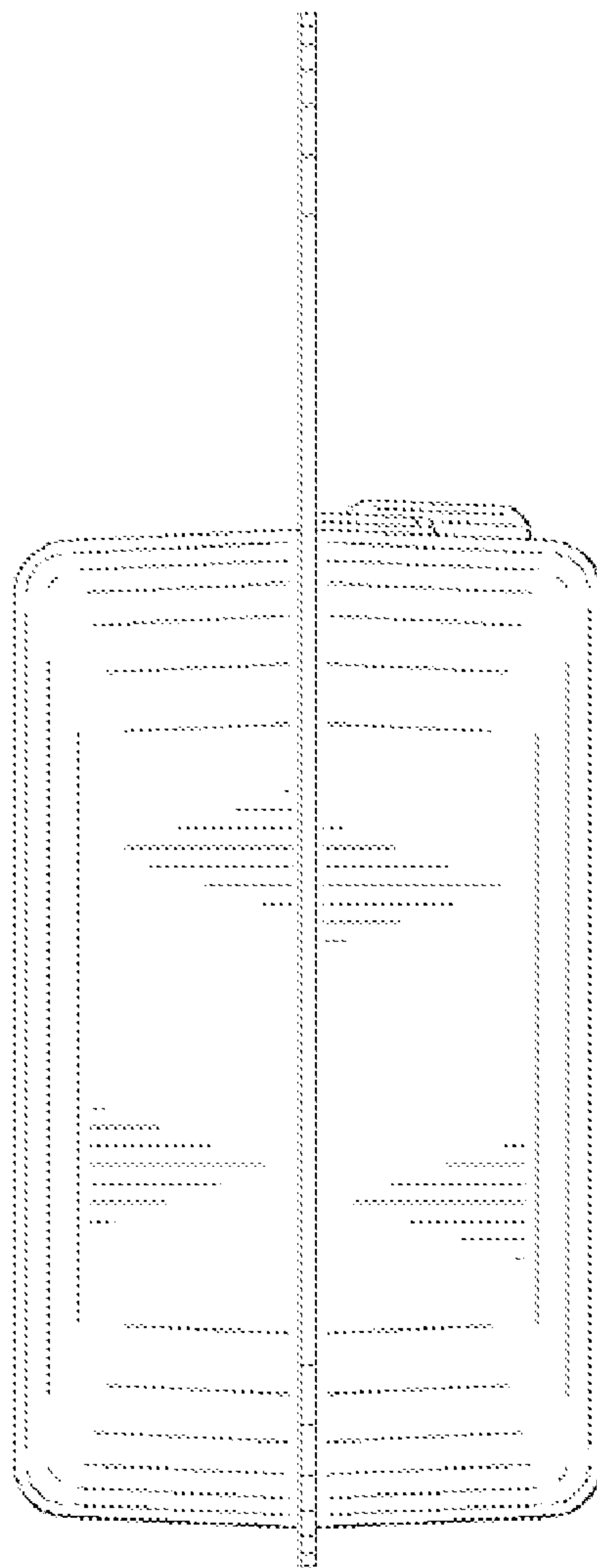

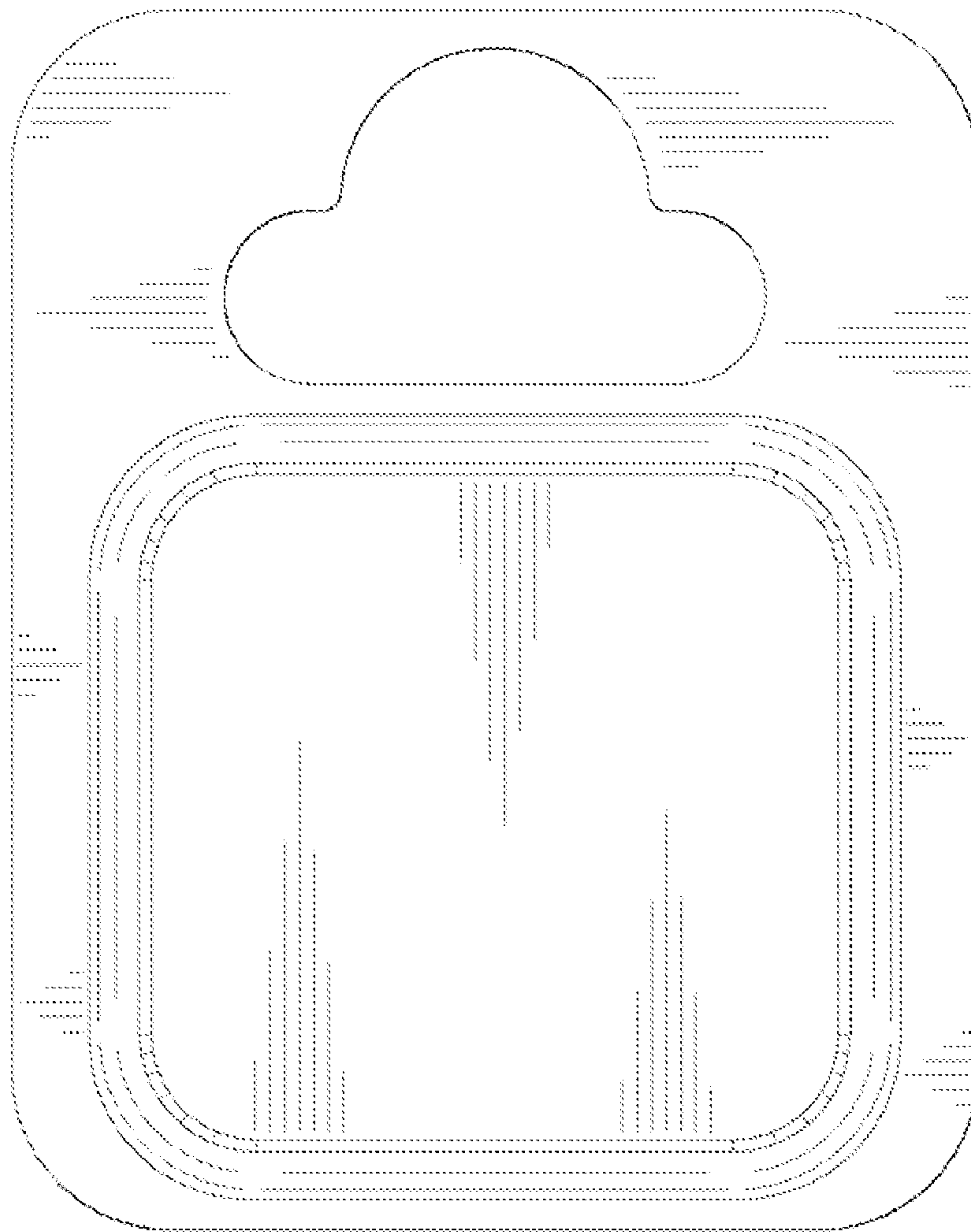

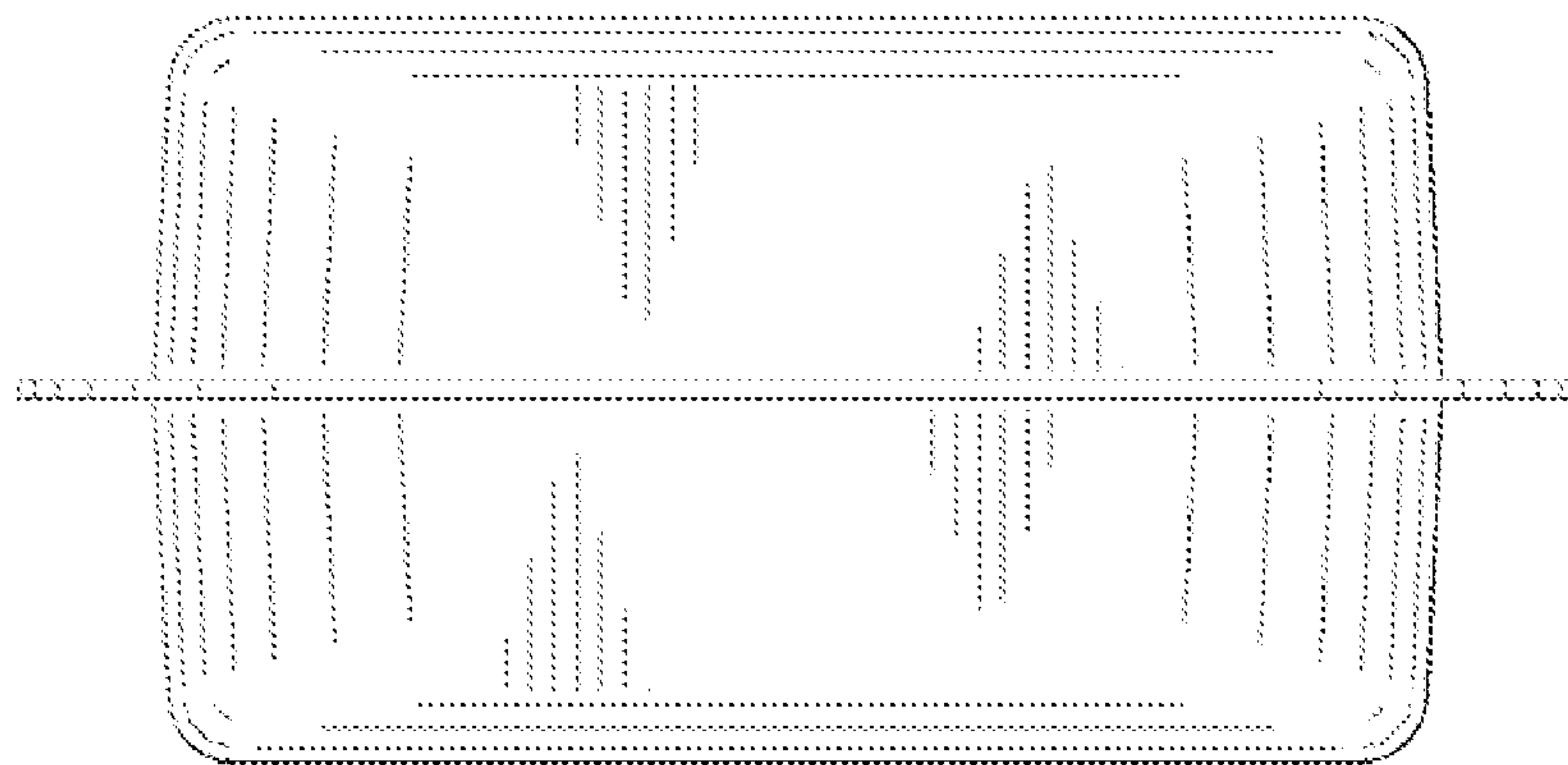

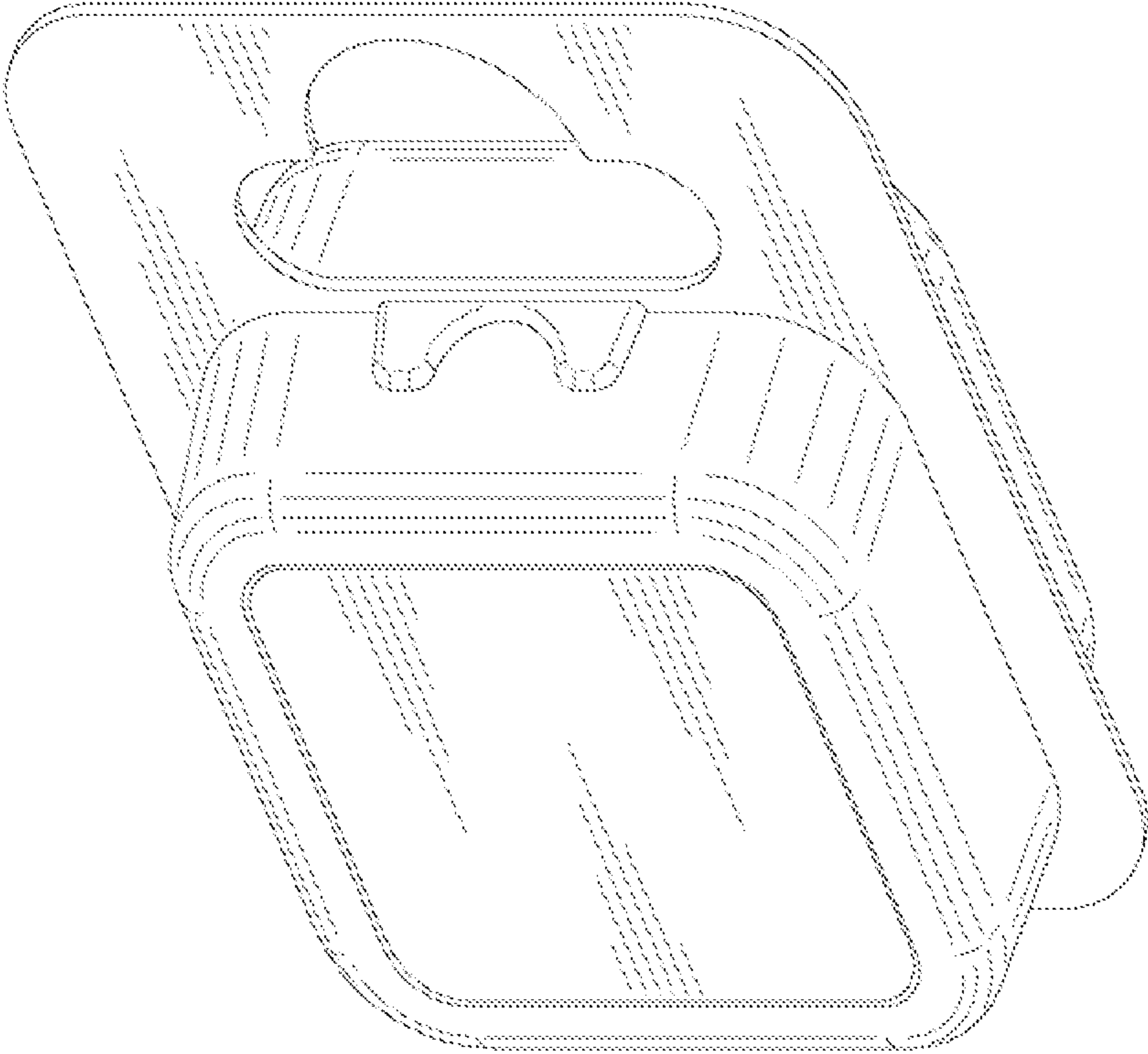

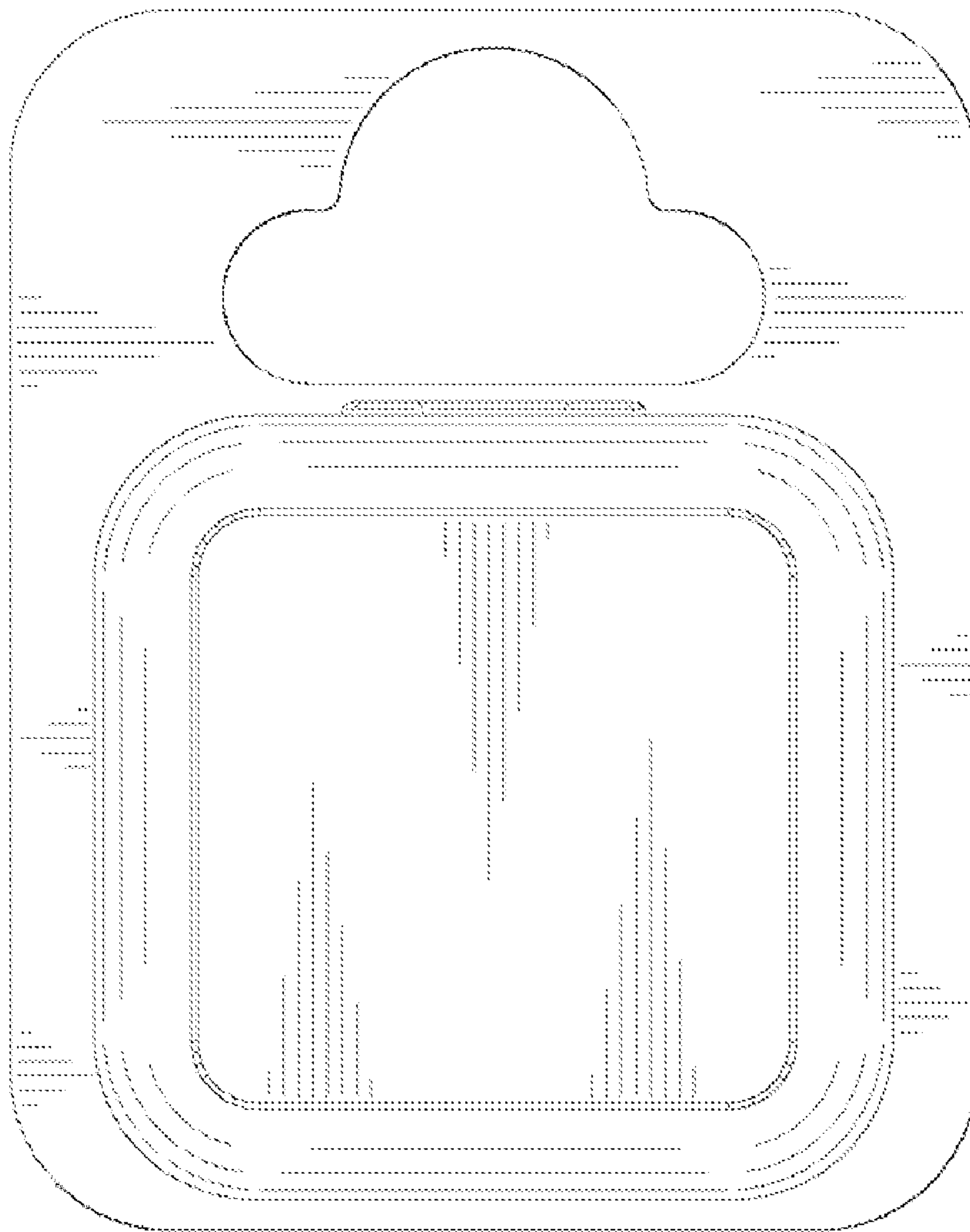

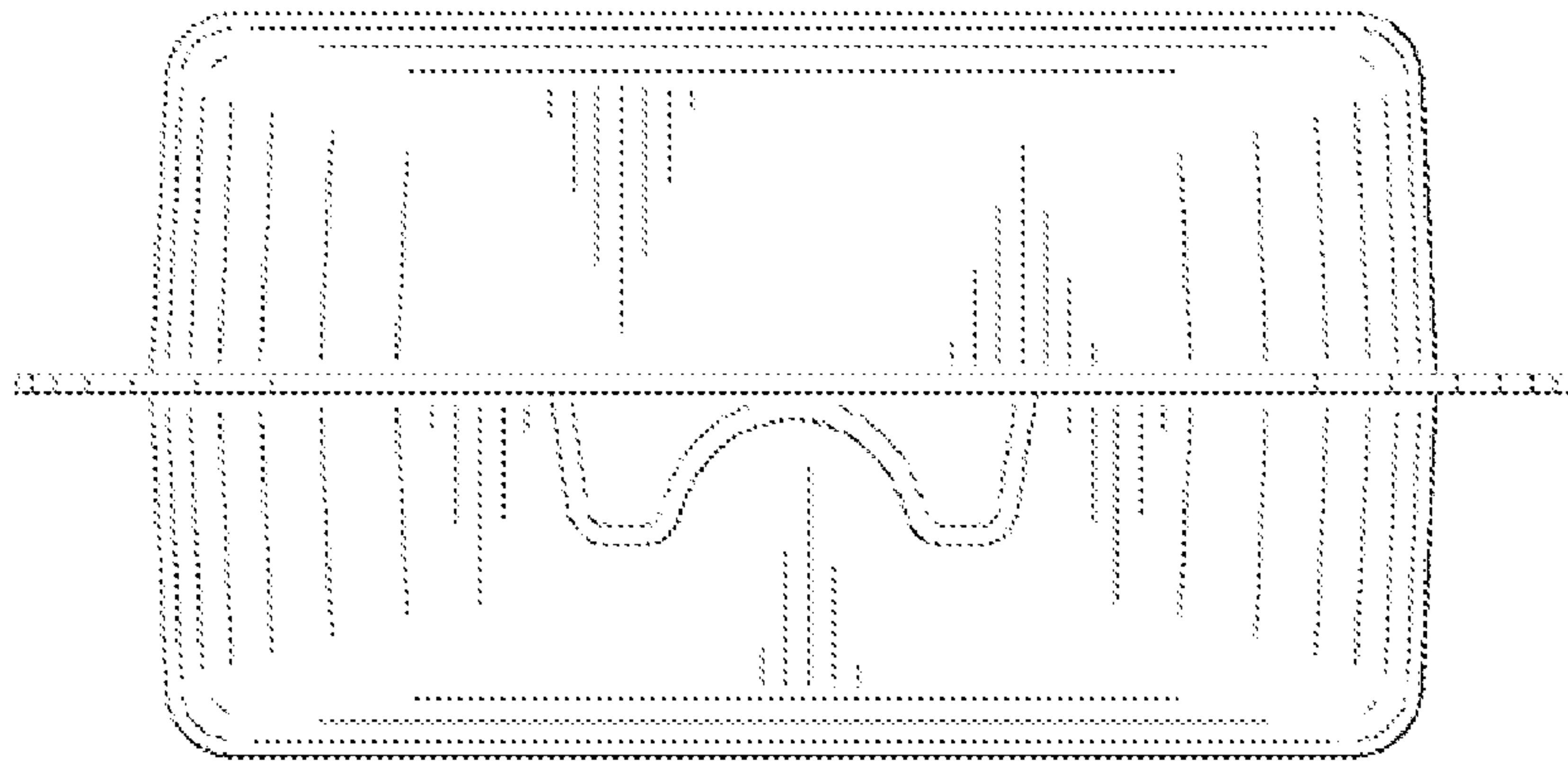

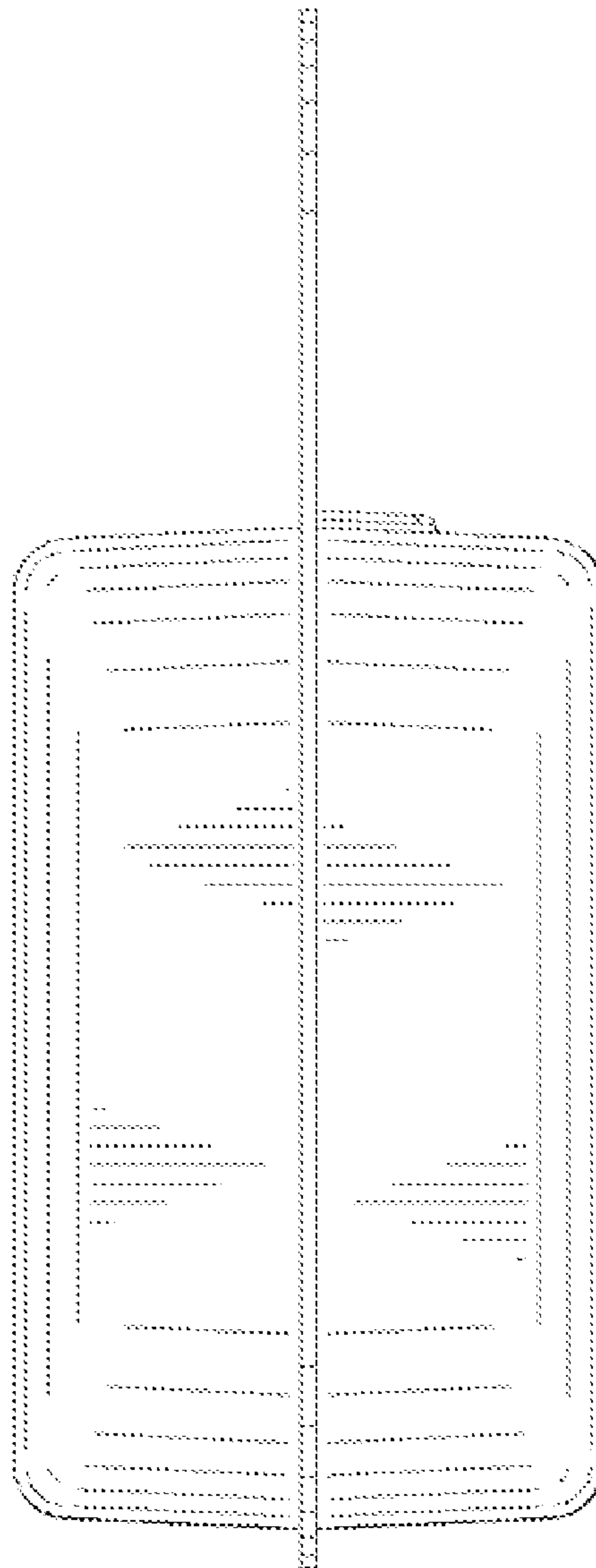

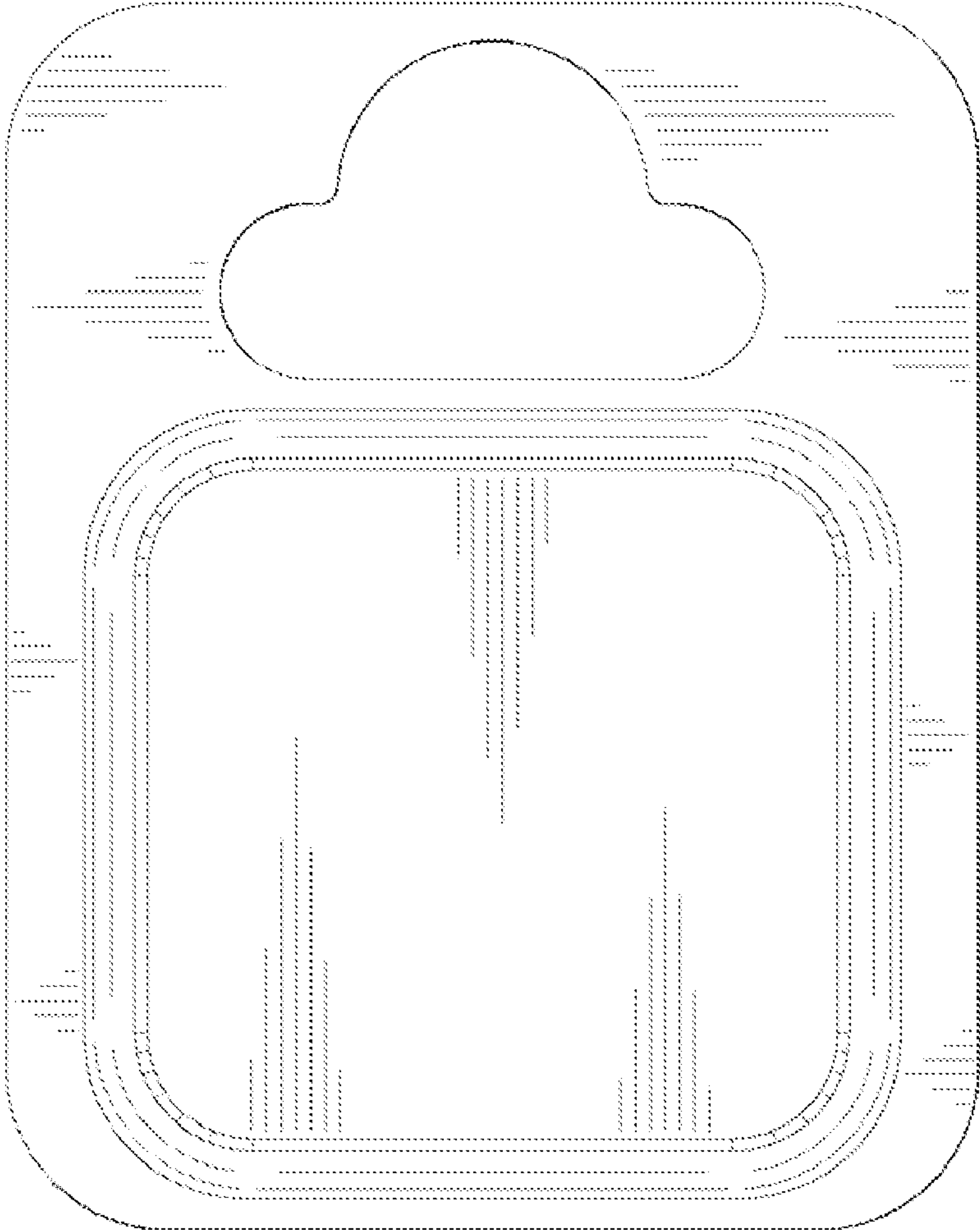

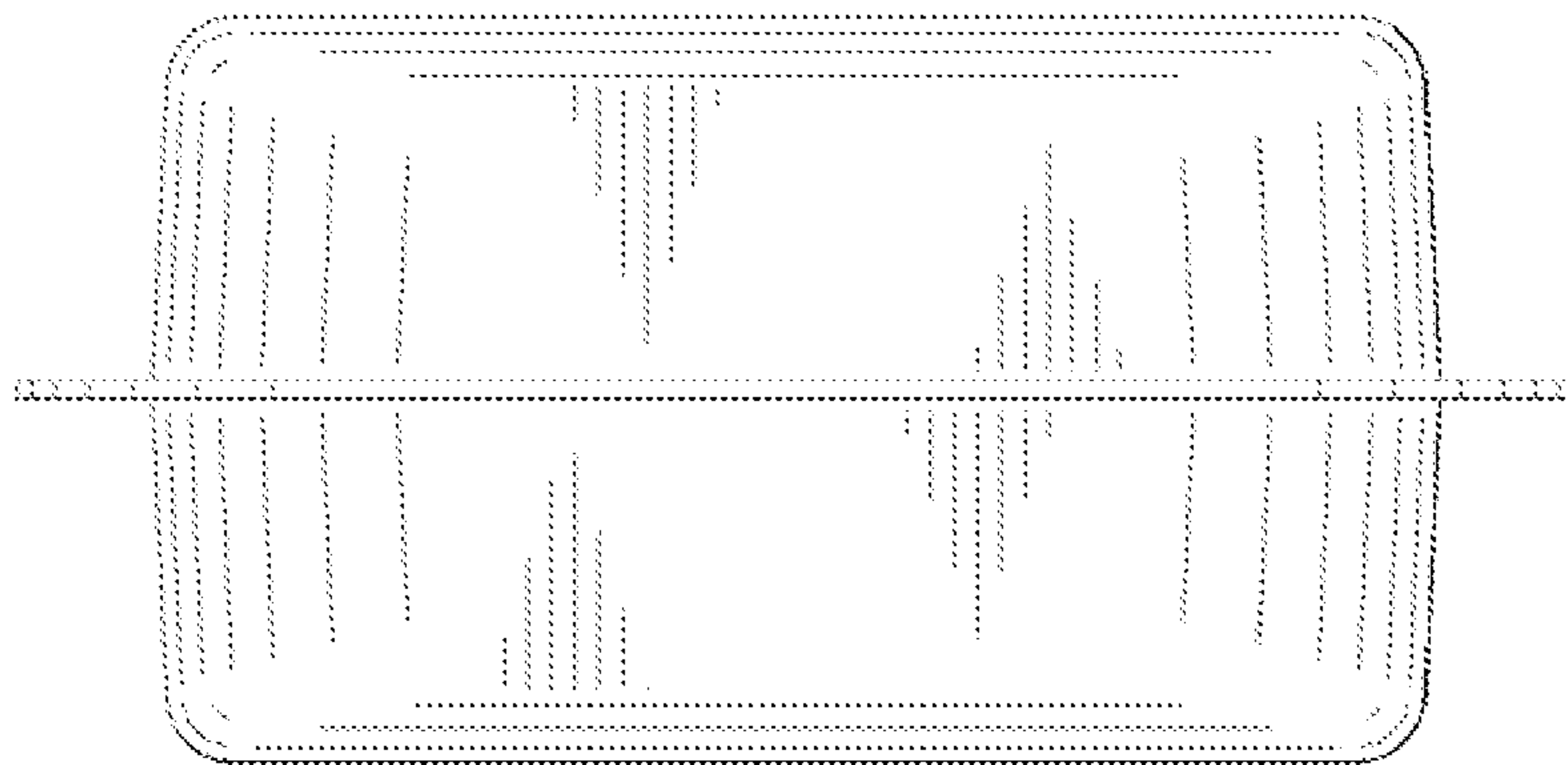

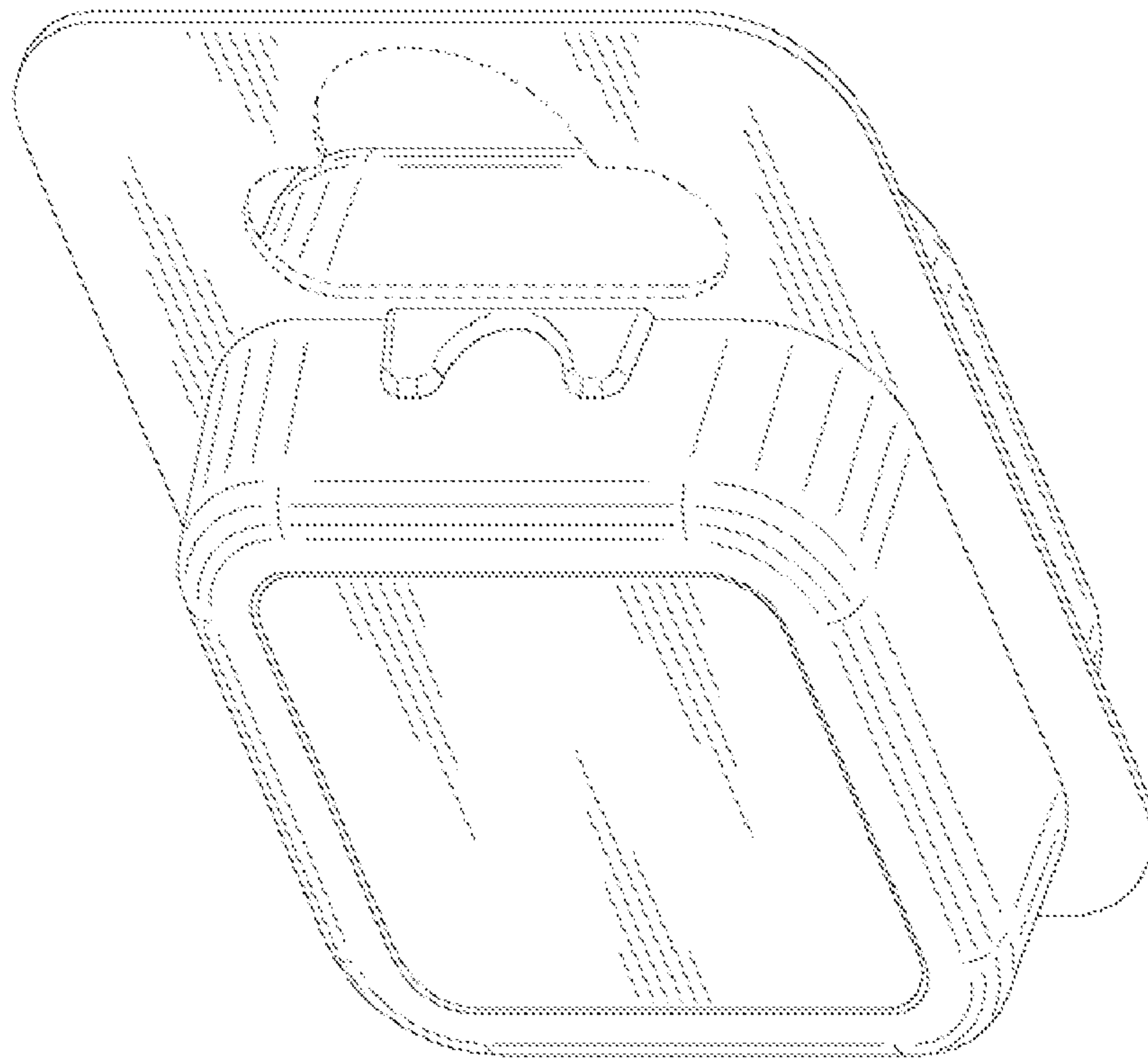

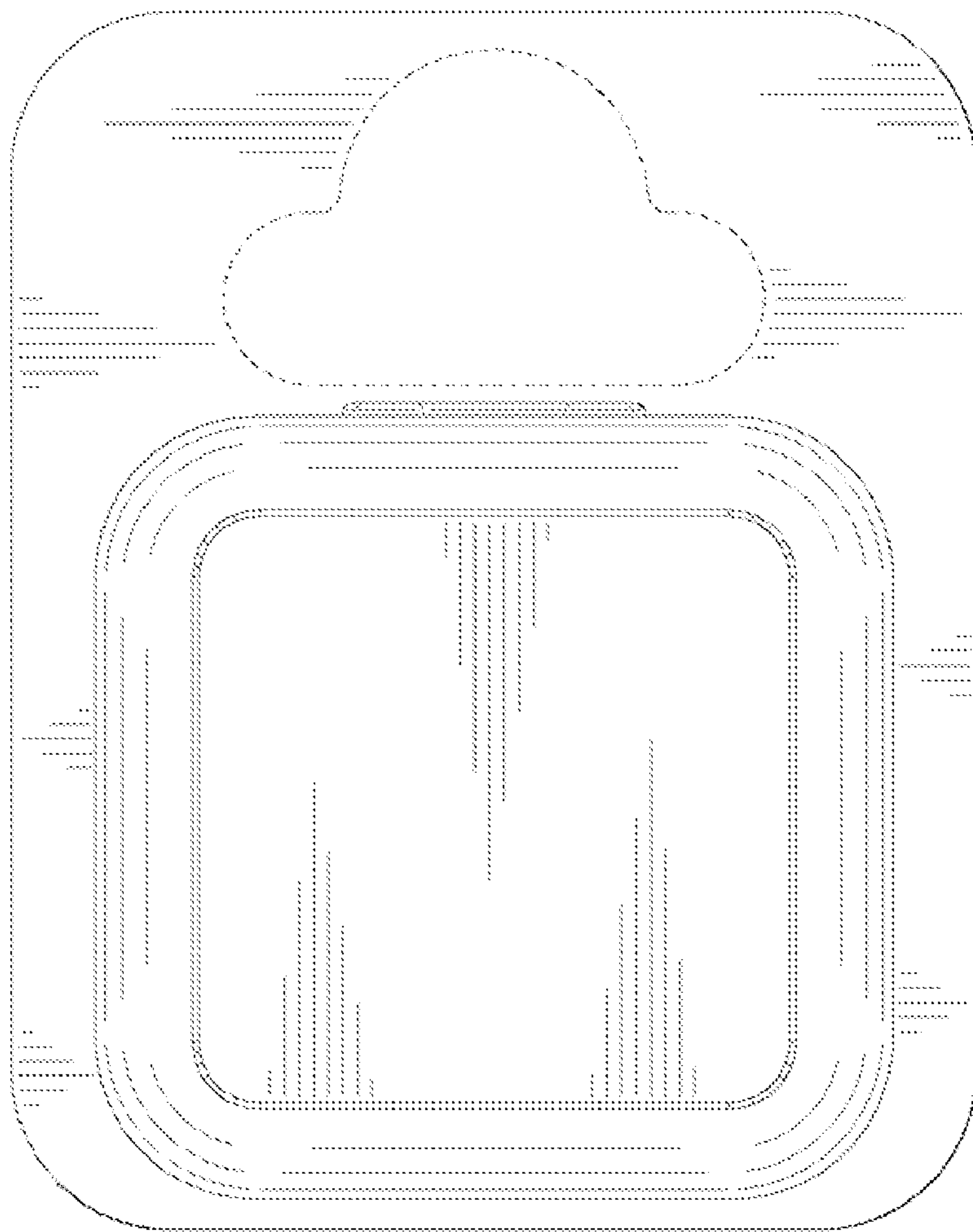

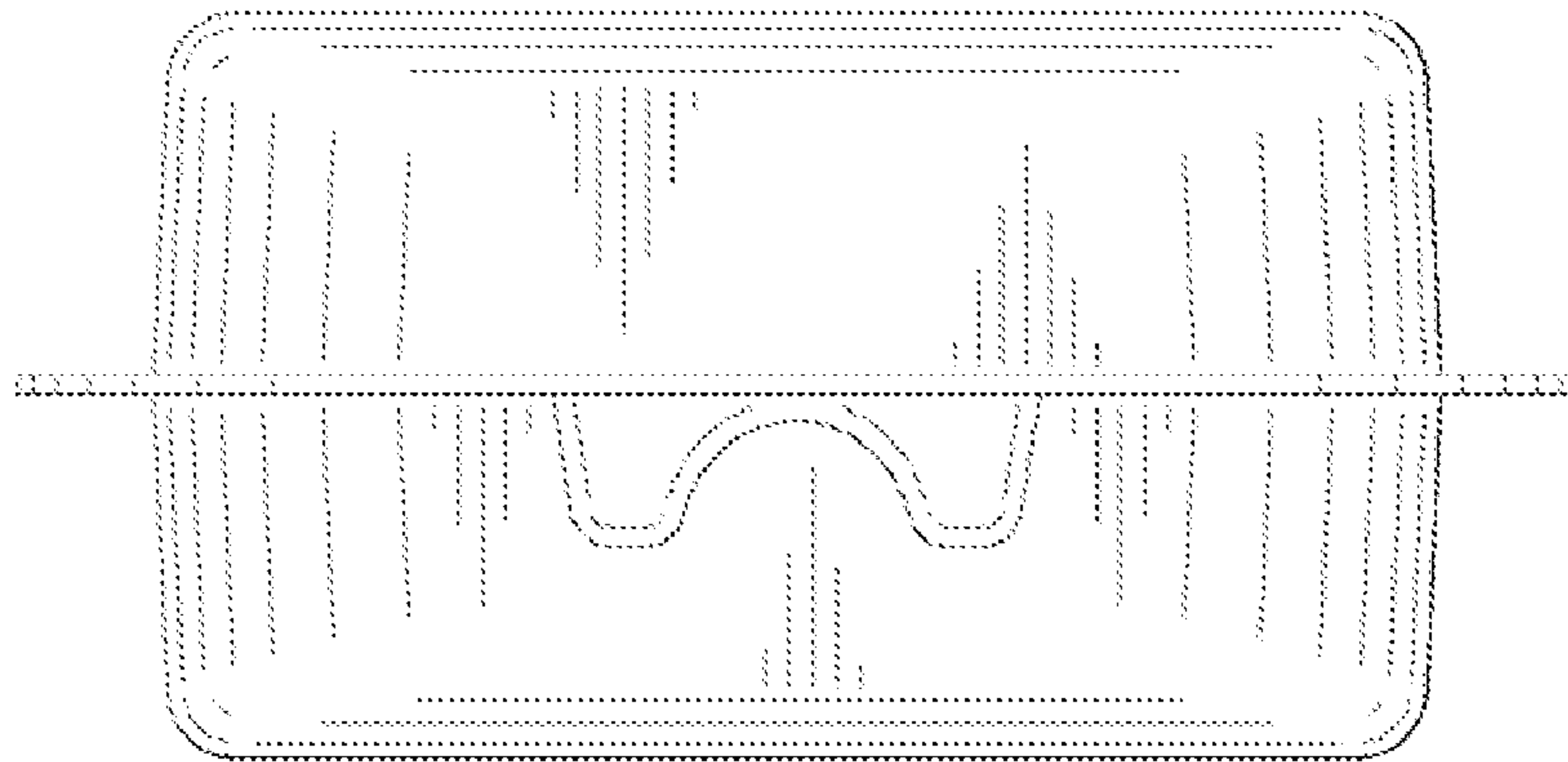

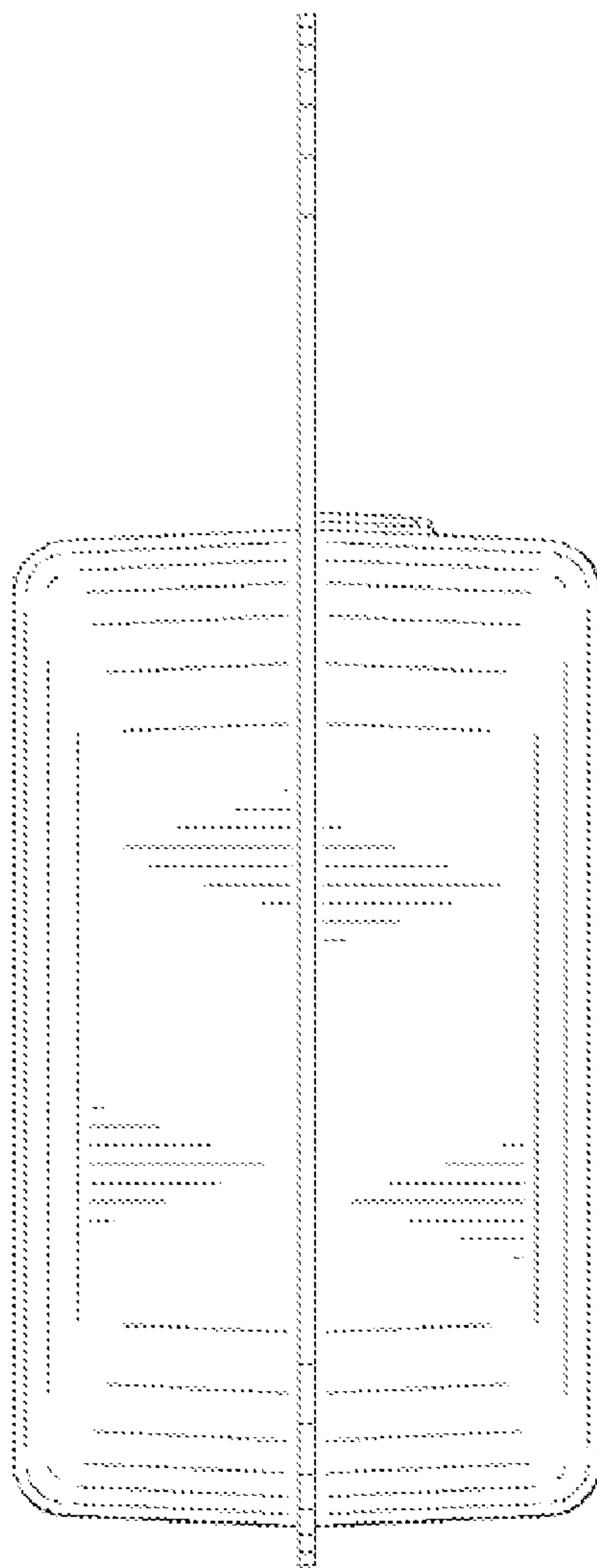

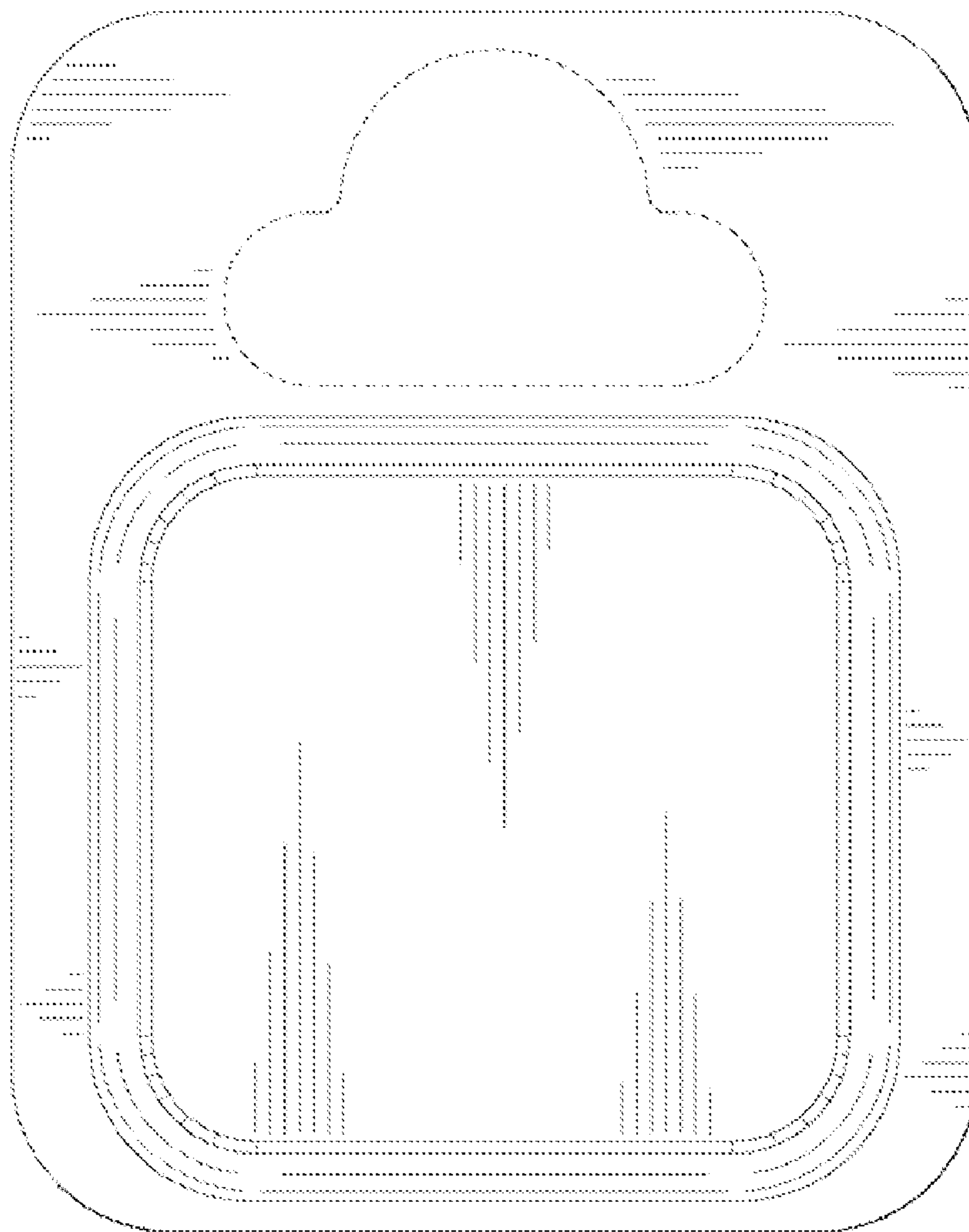
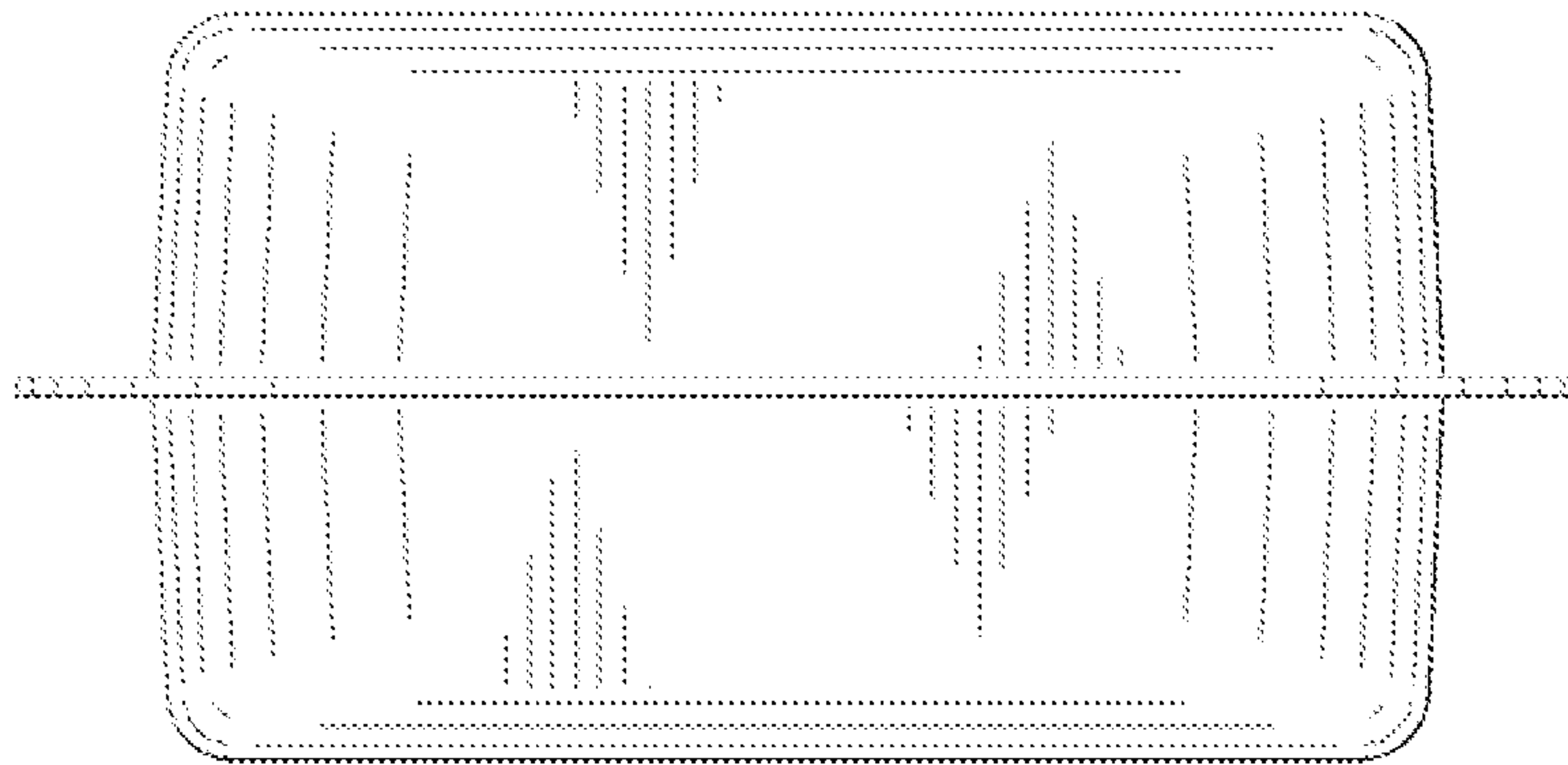

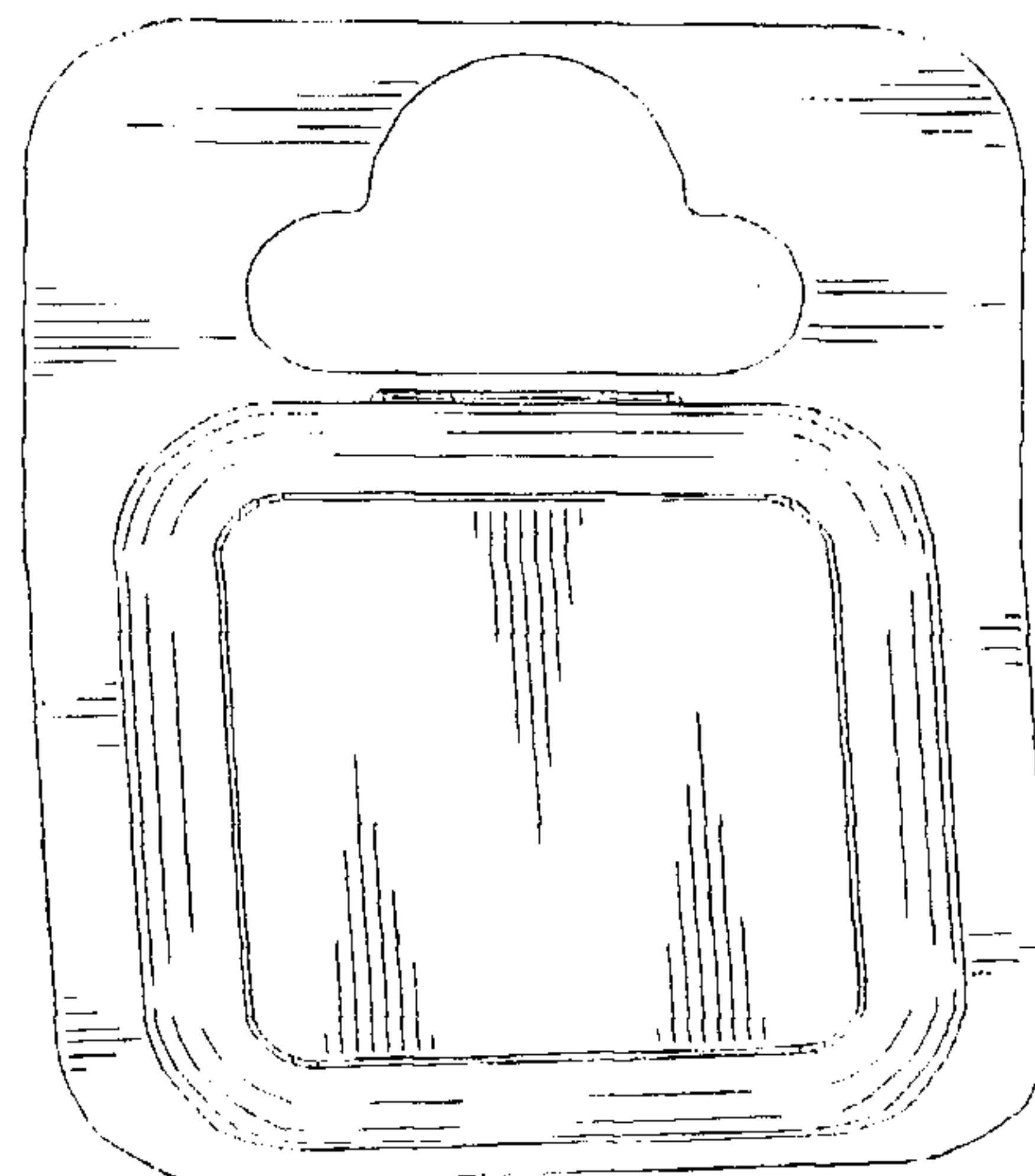
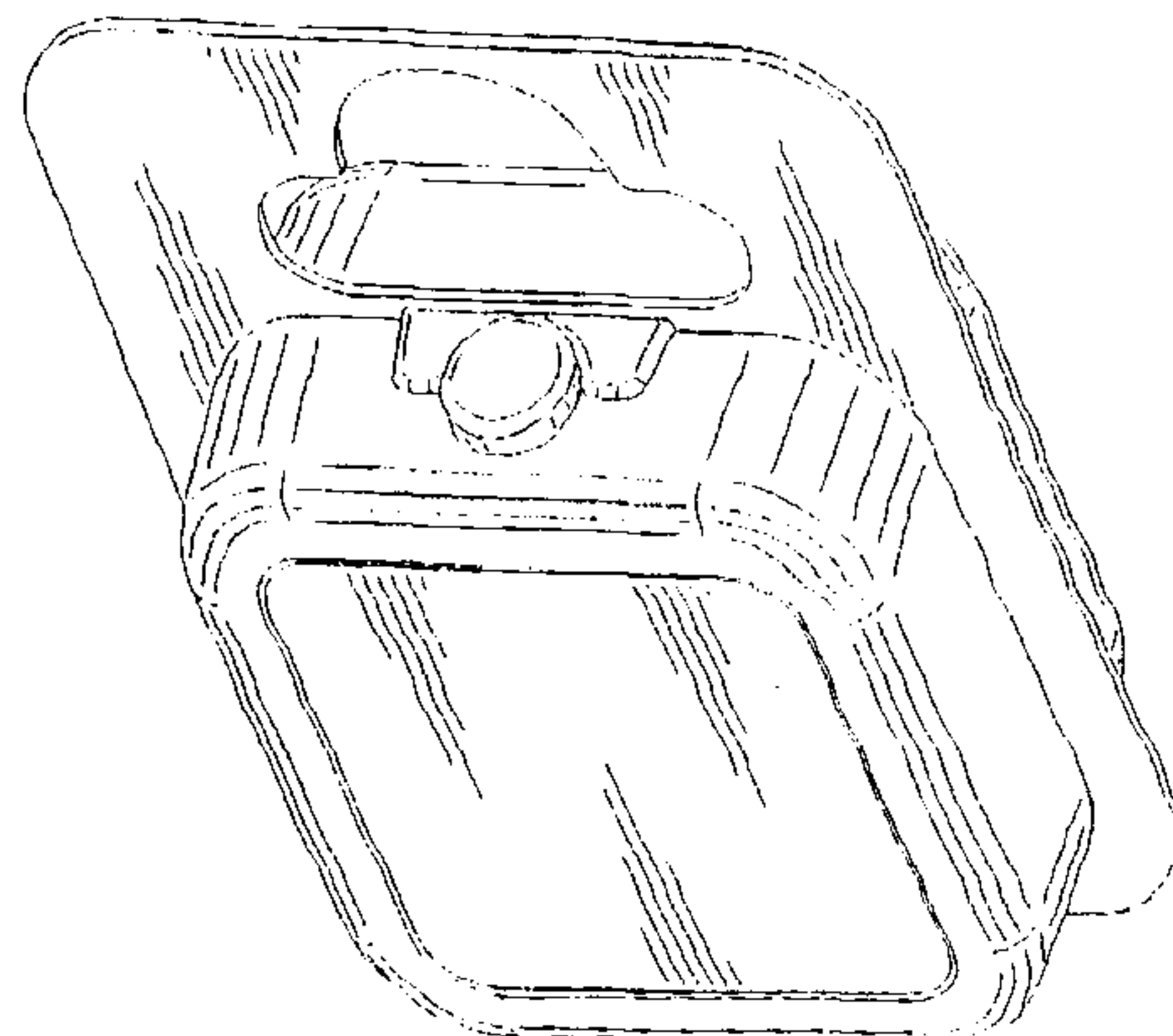

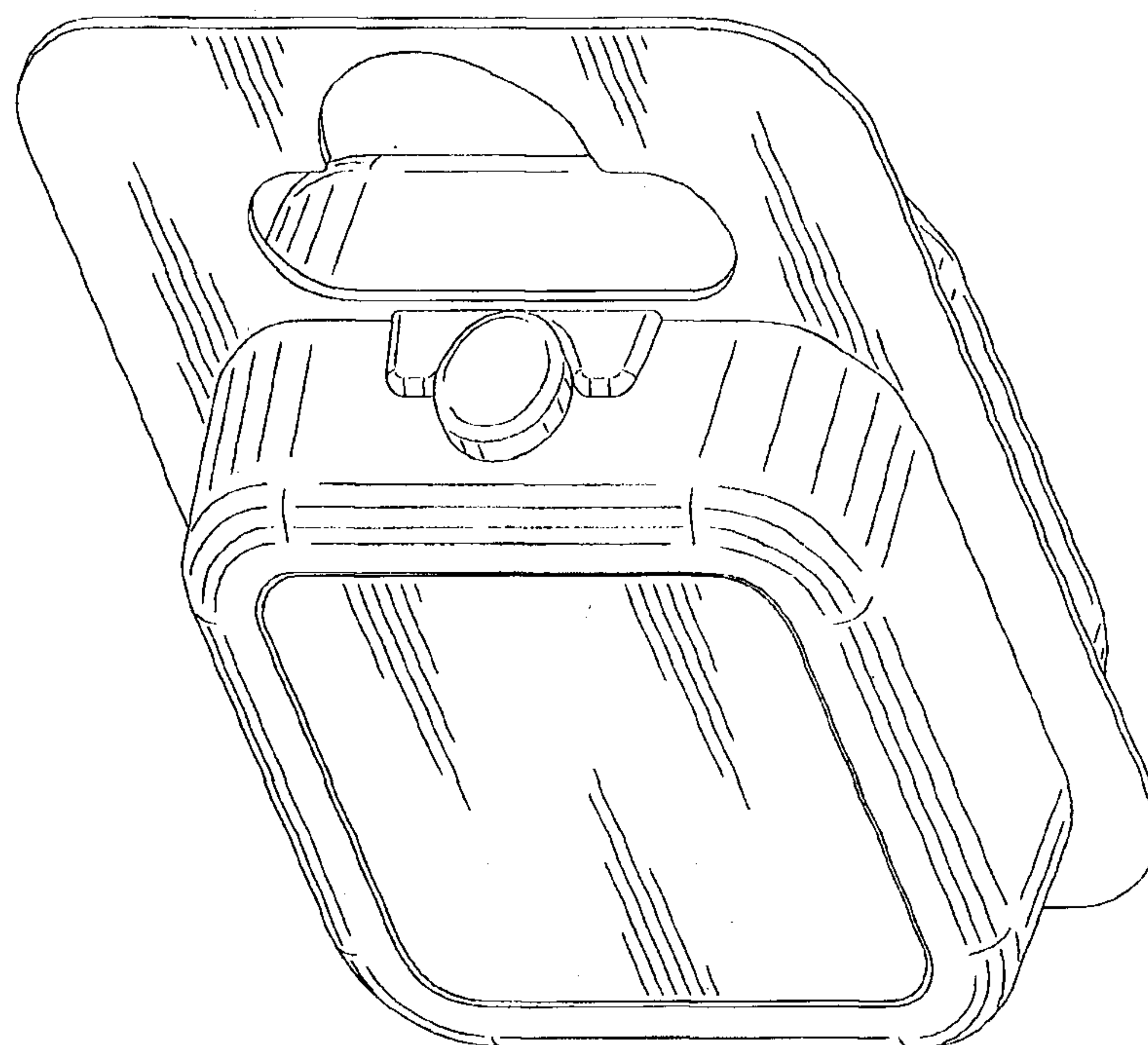

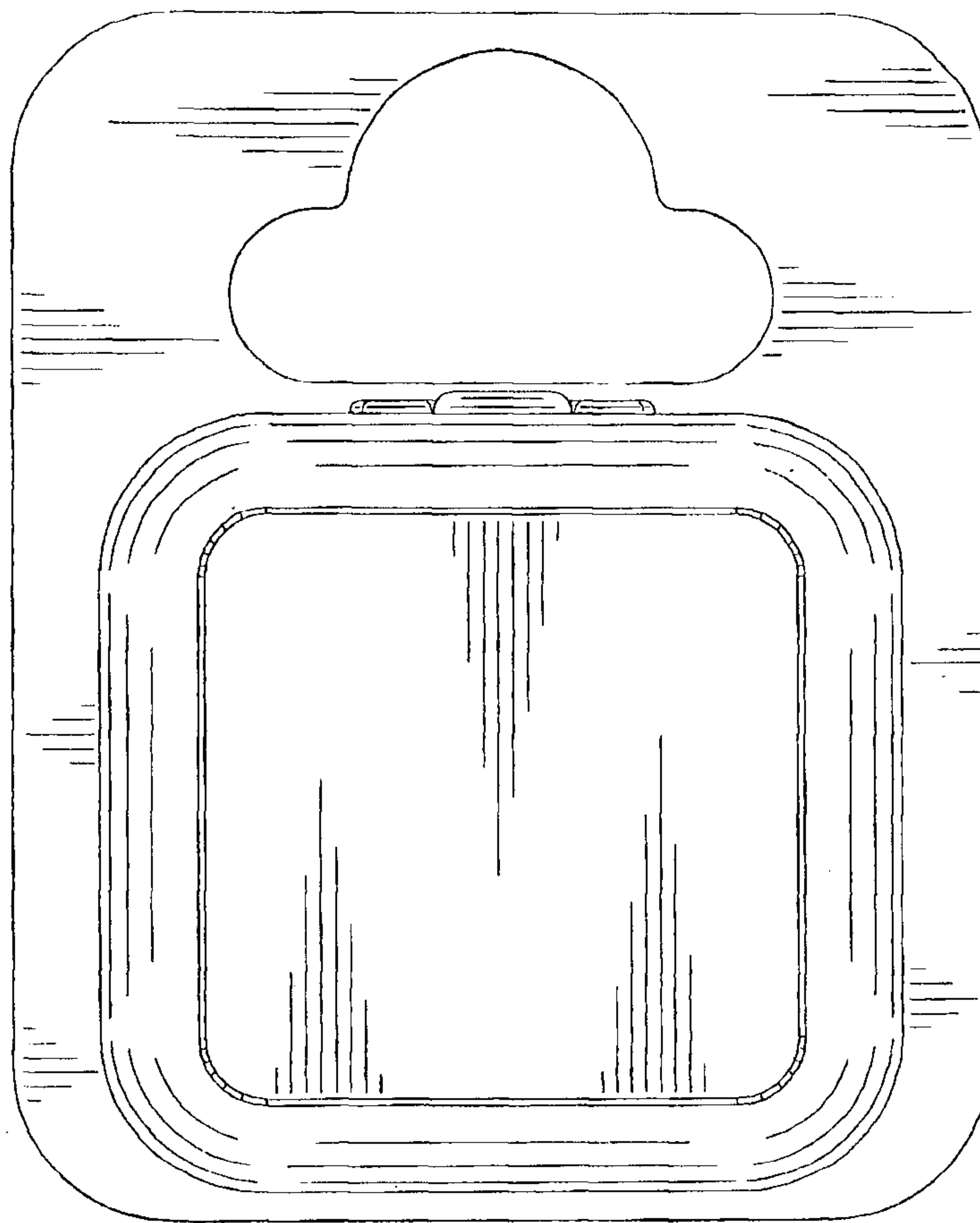

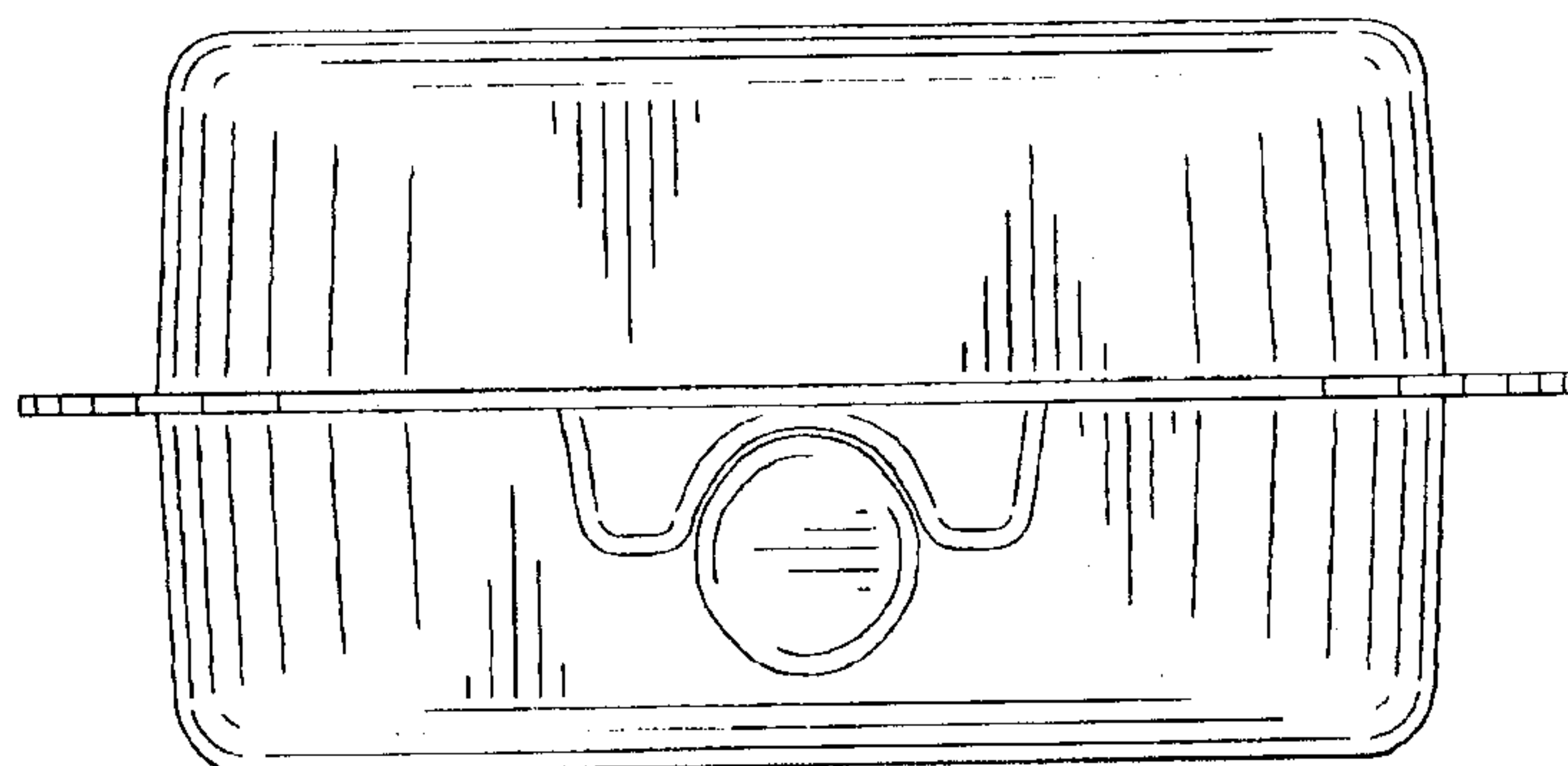

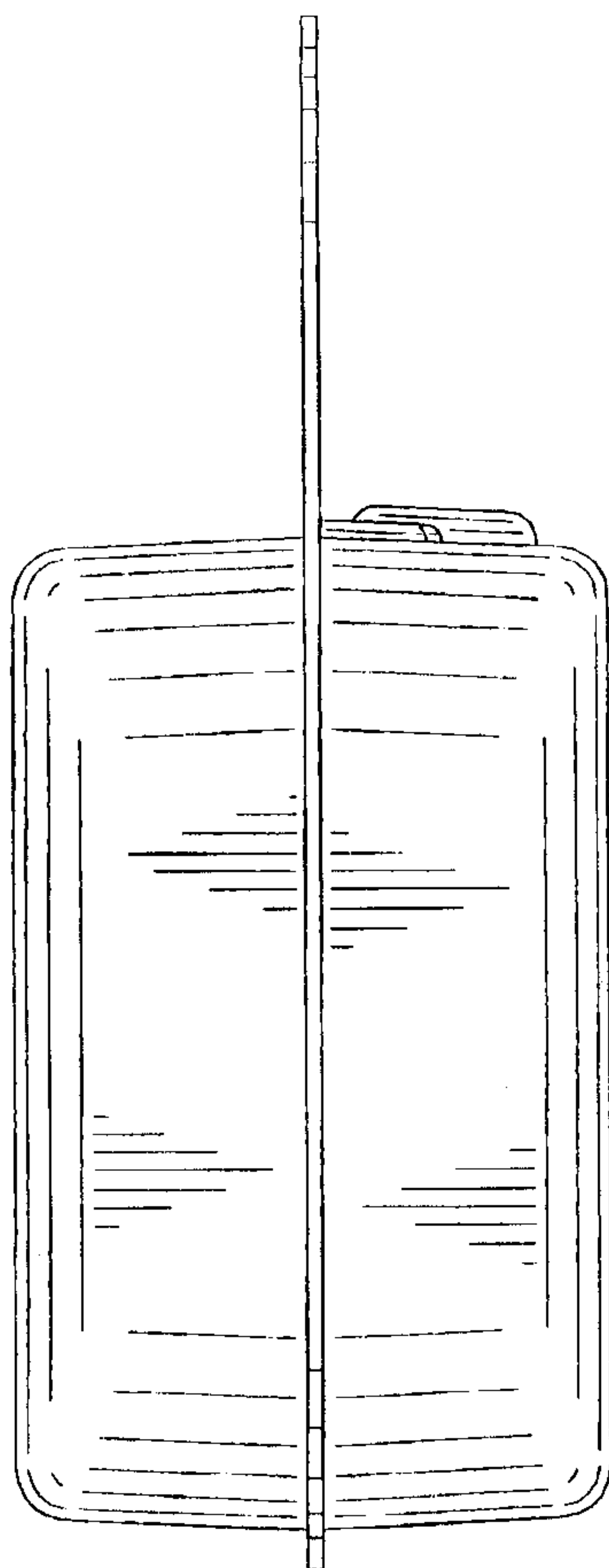

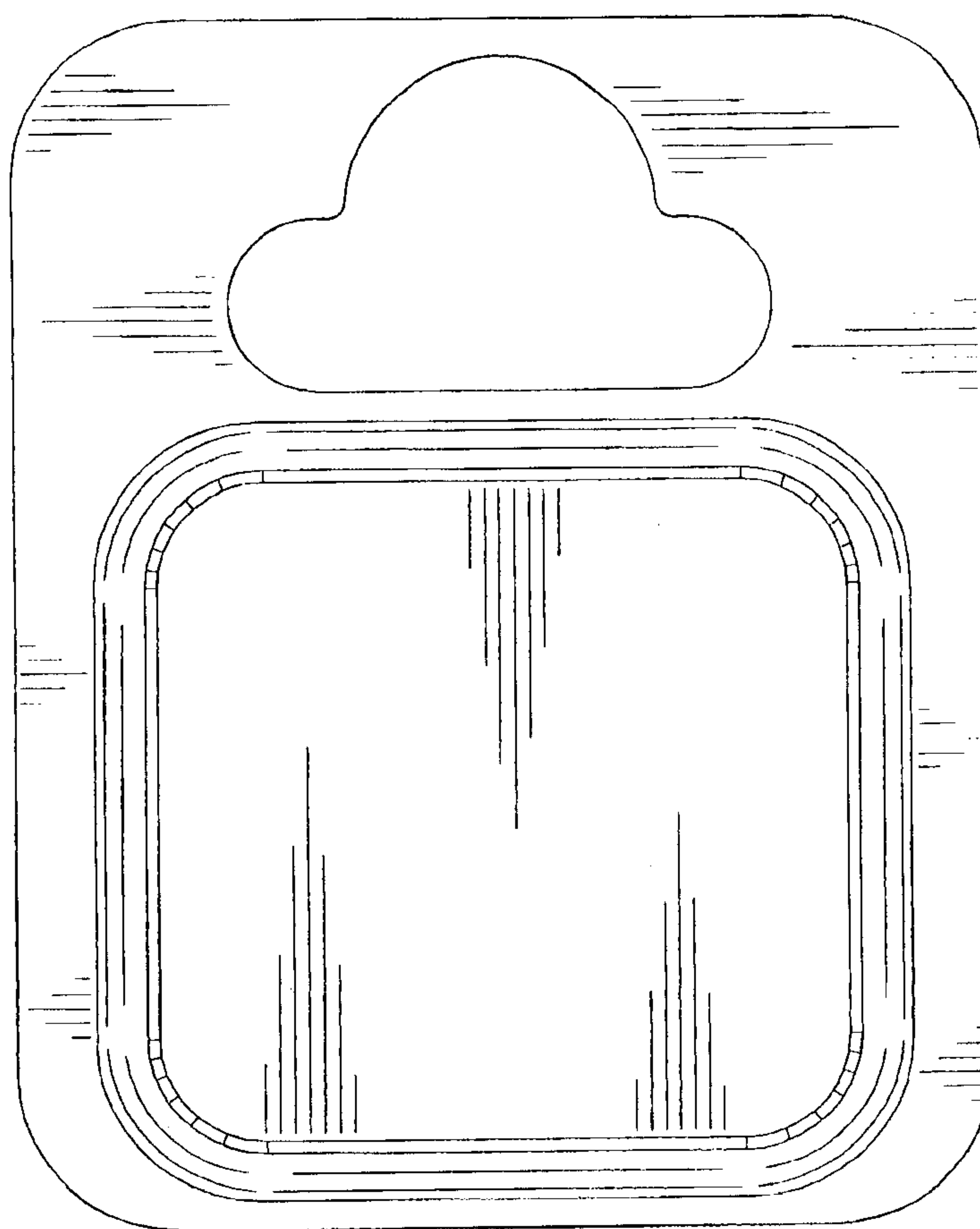

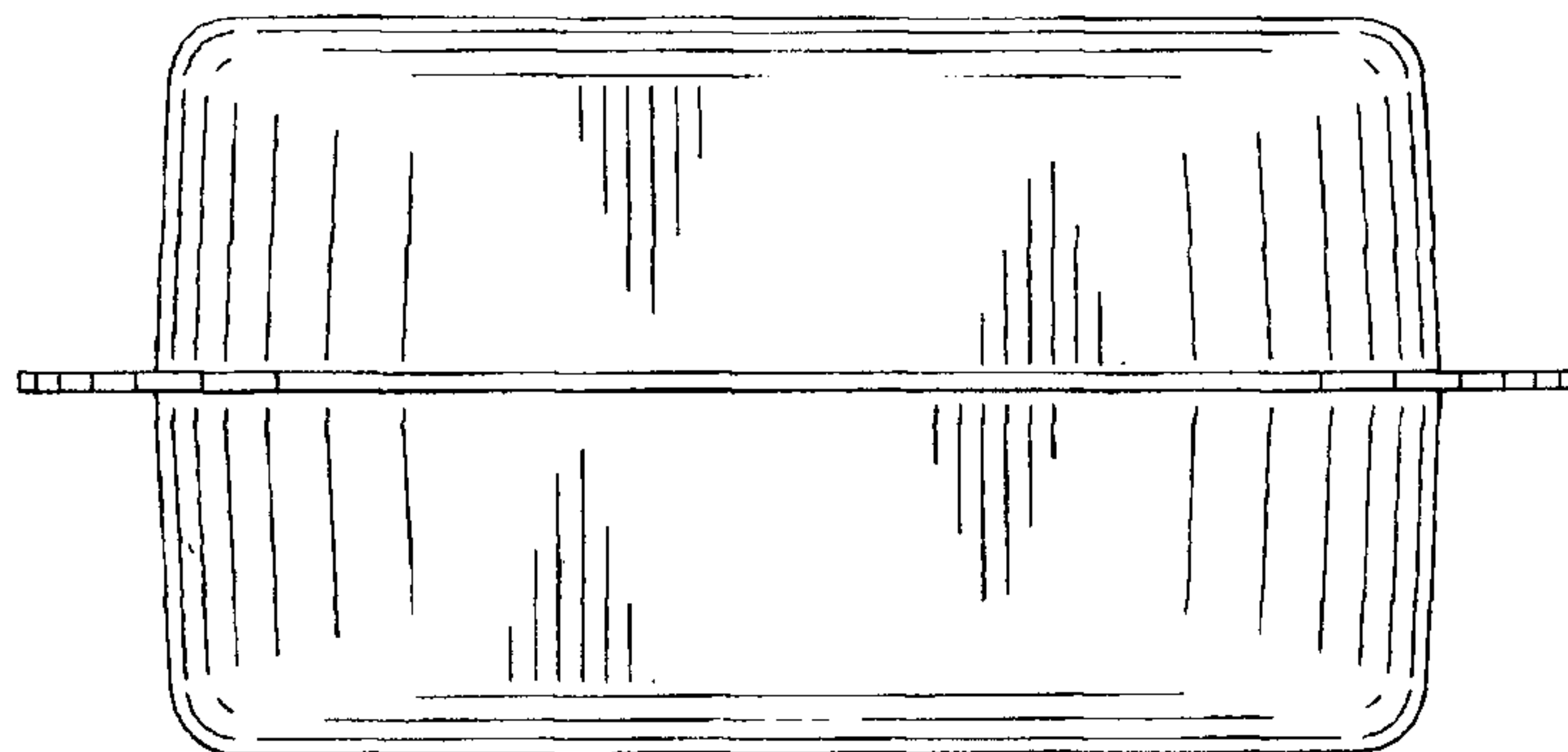

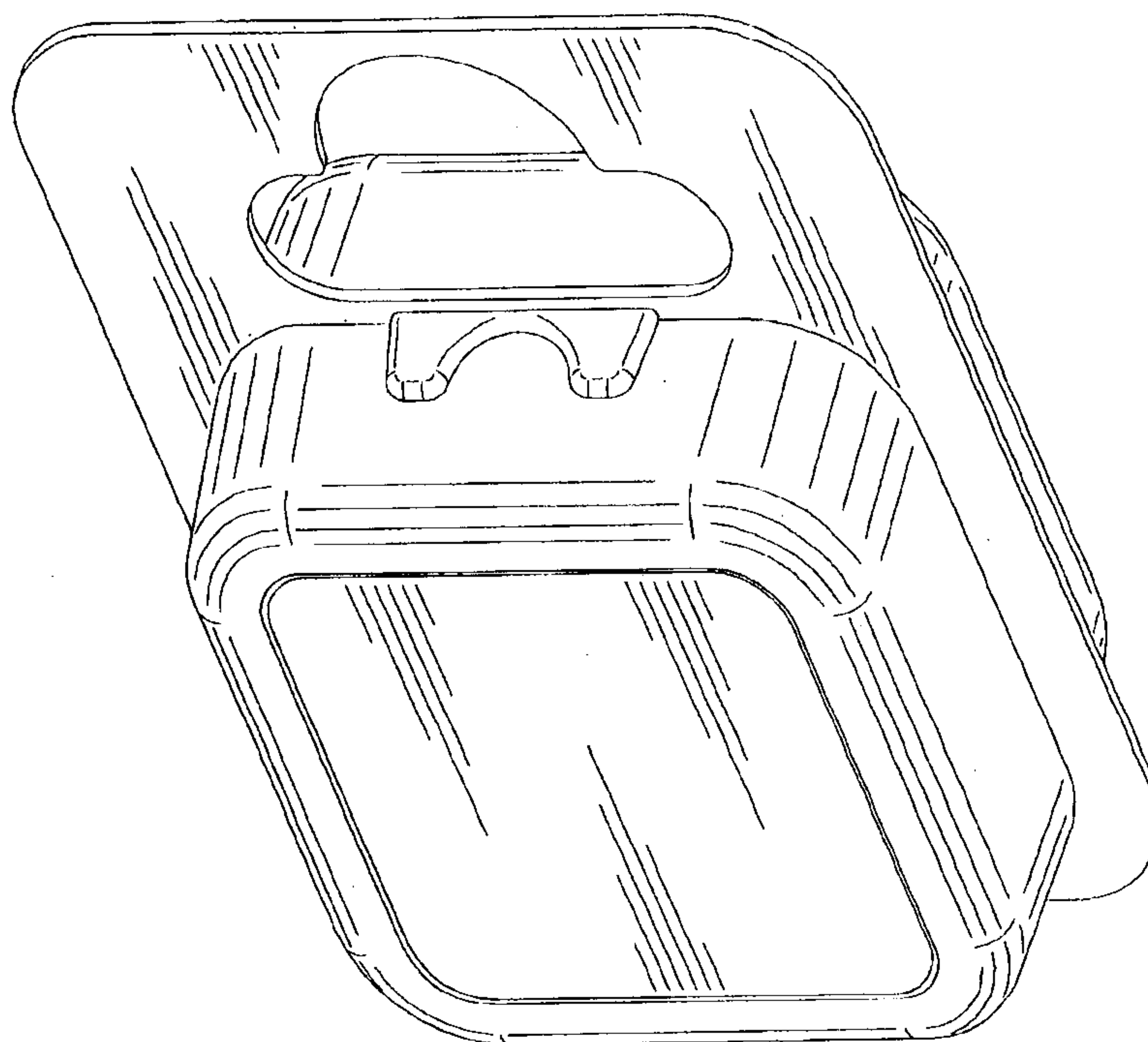

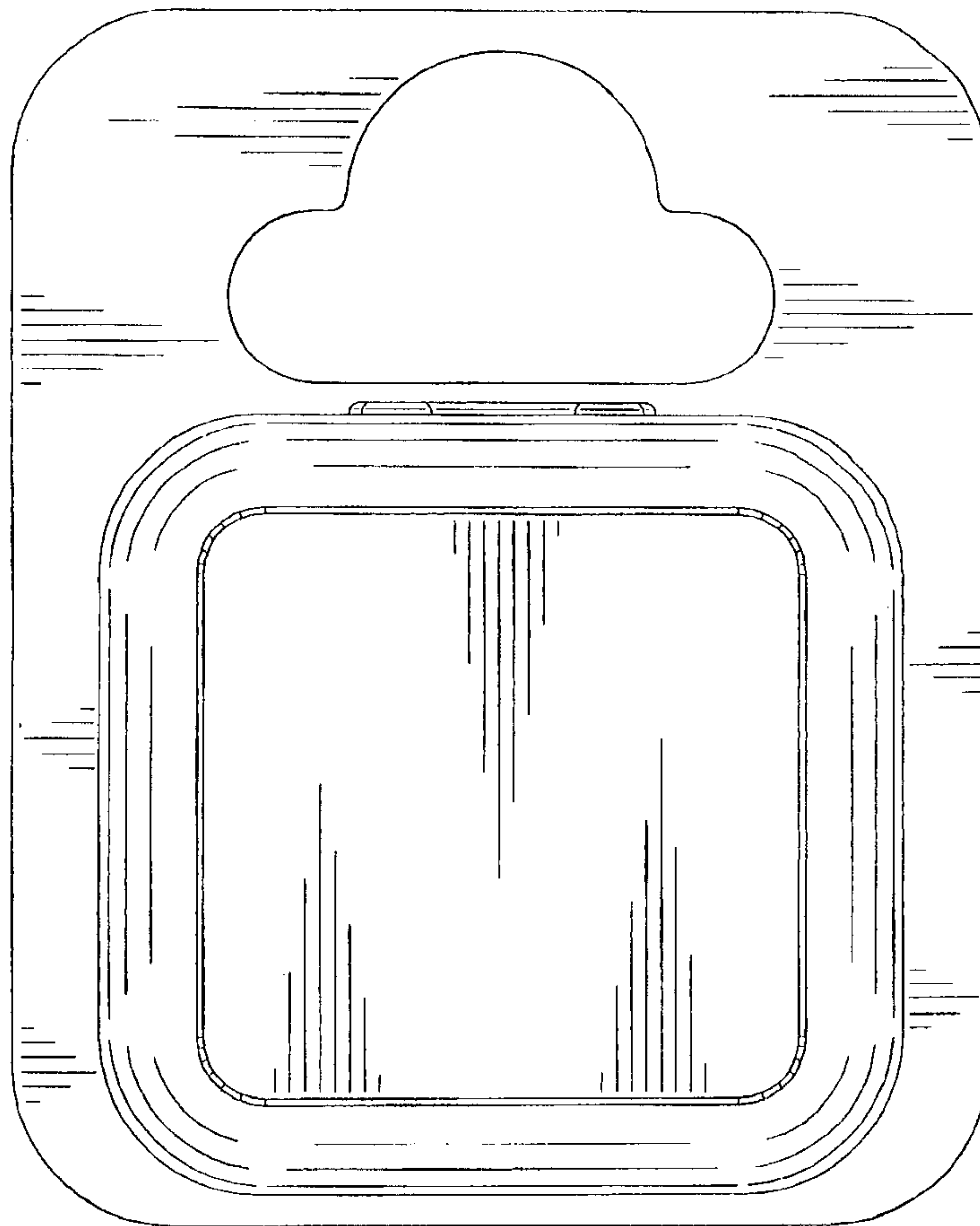

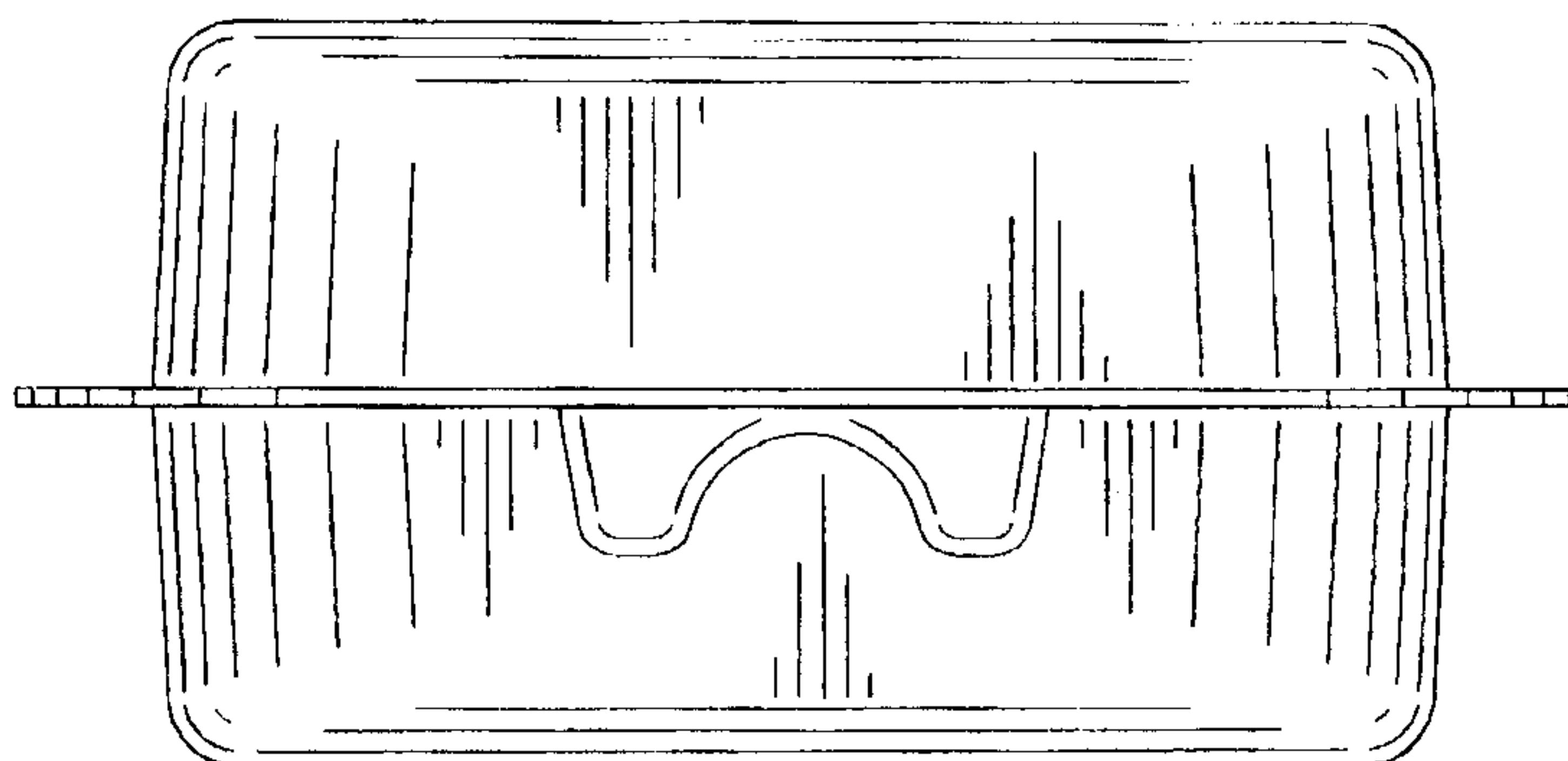

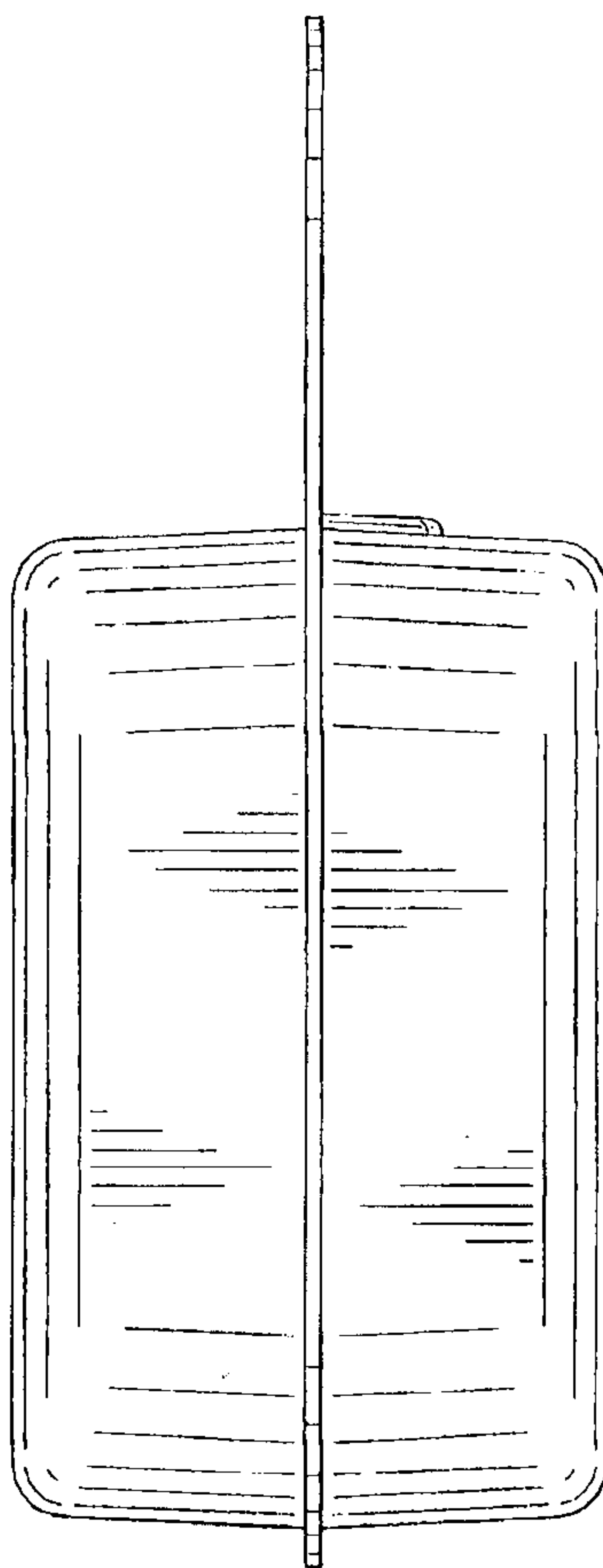

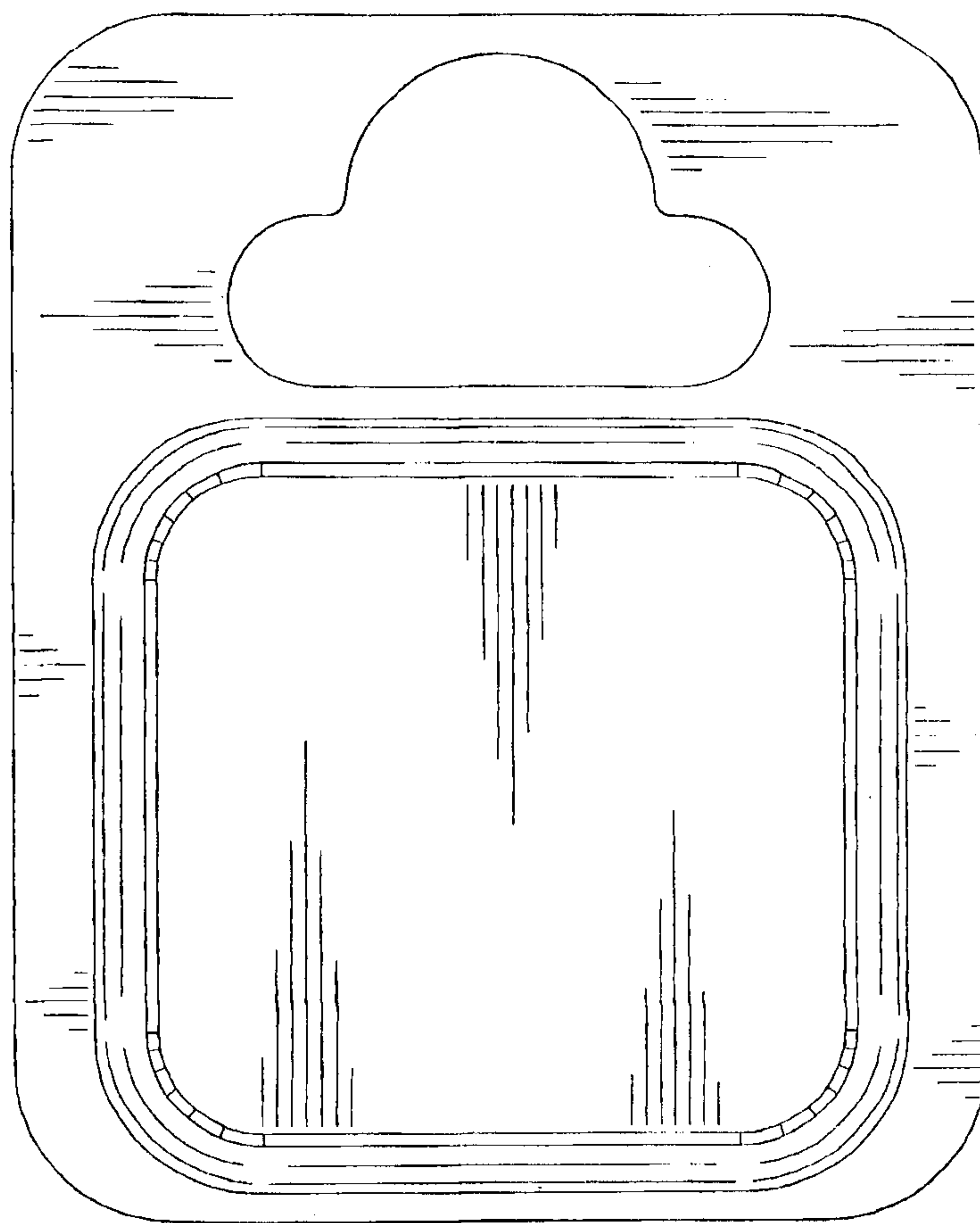

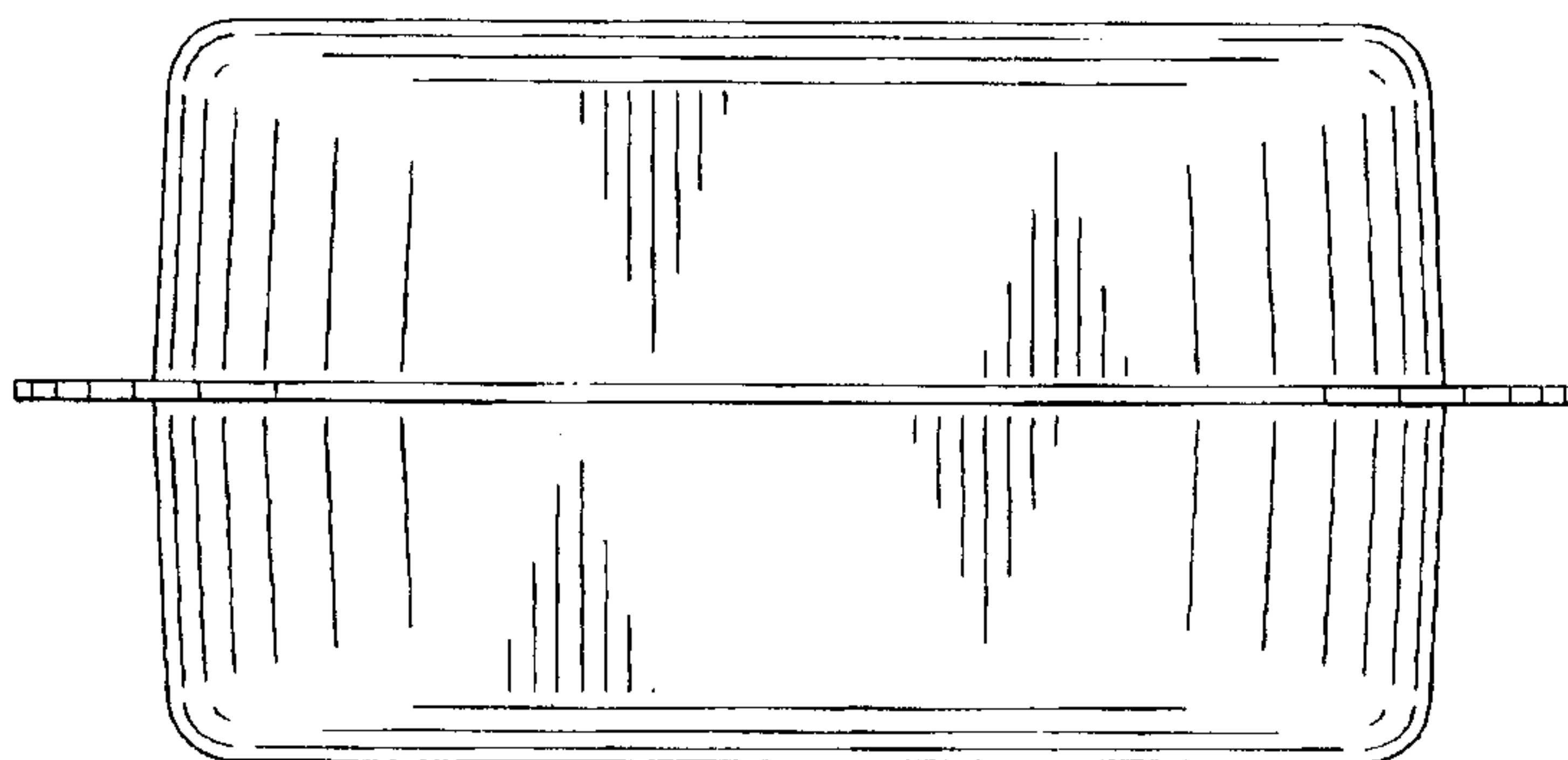

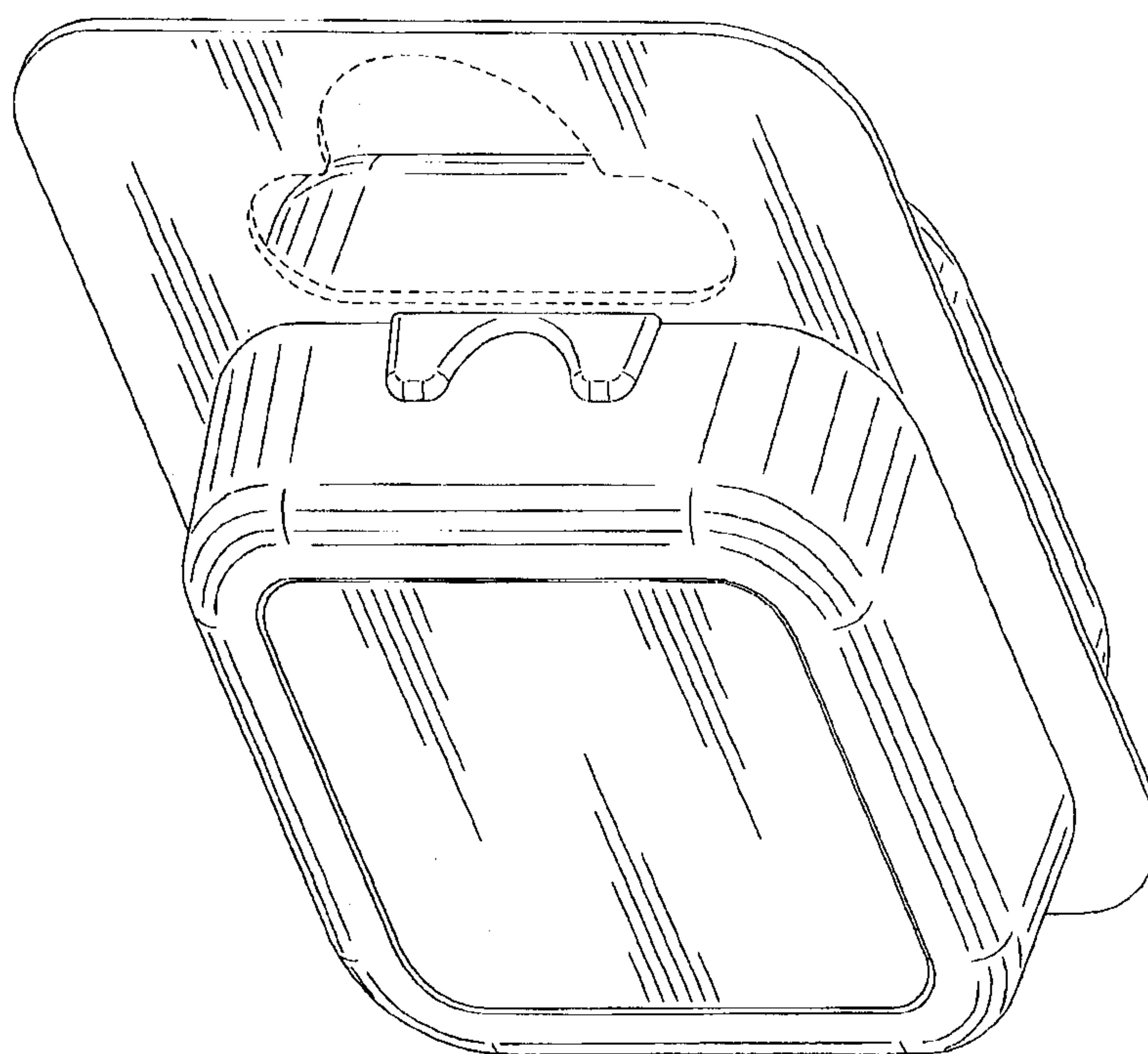

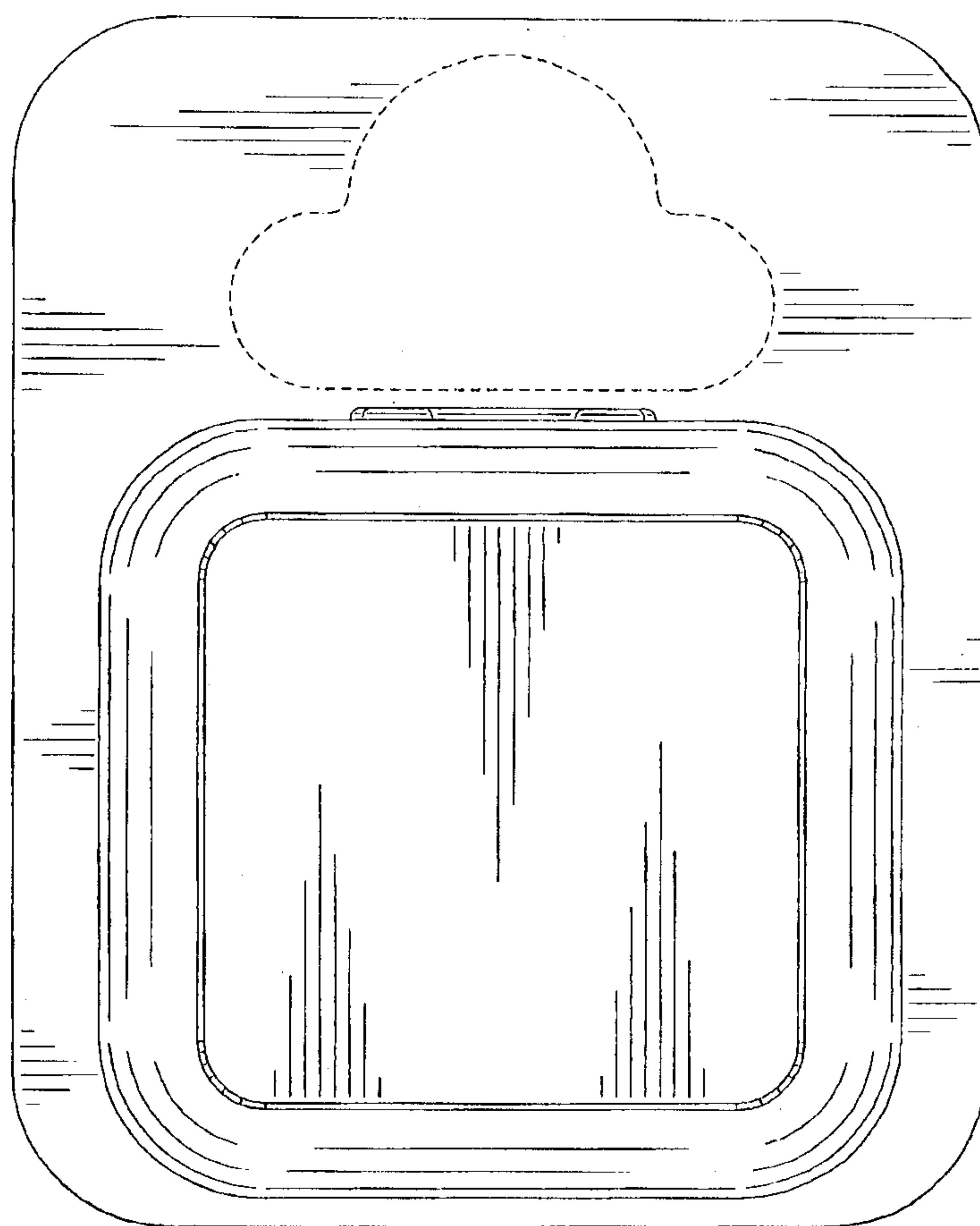

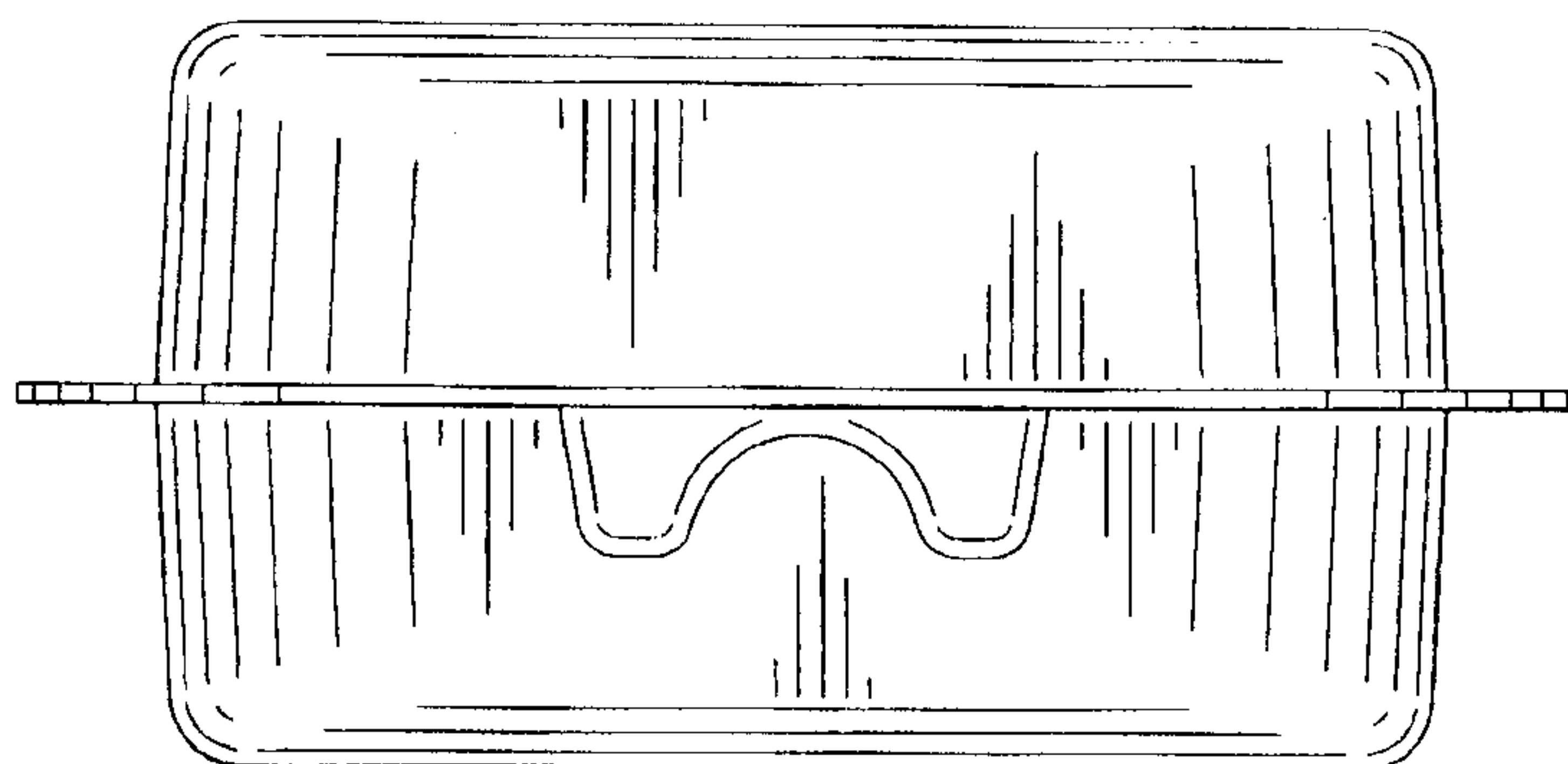

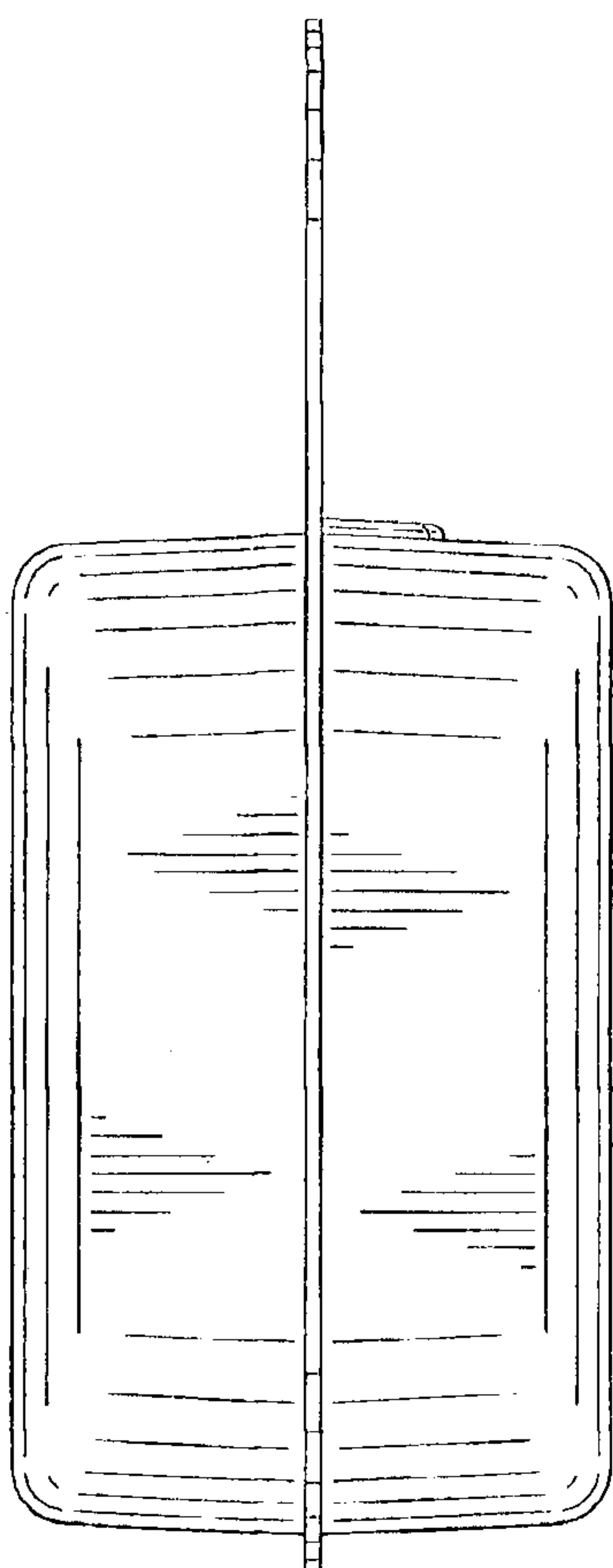

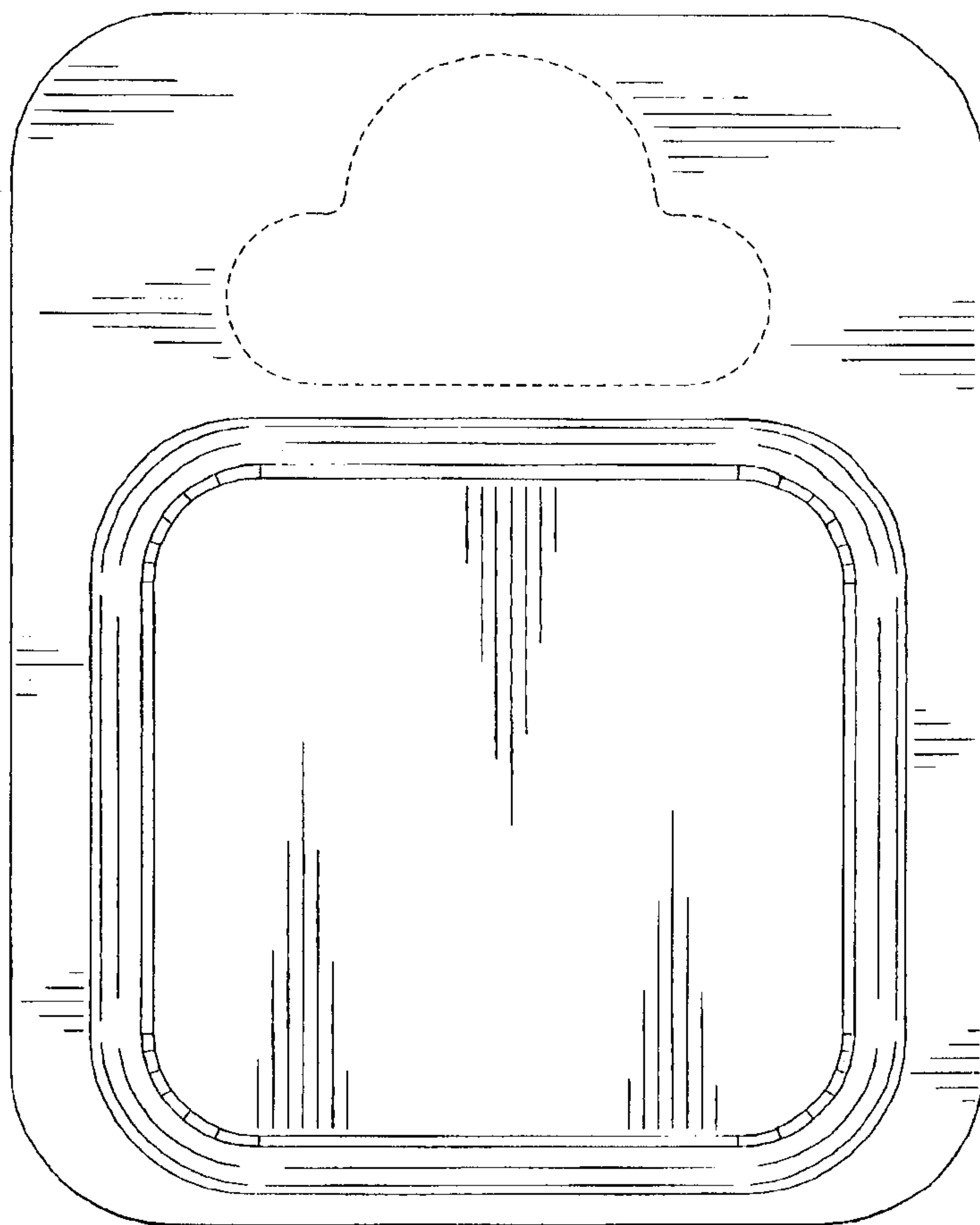
