FIG. 4 is a first side plan view of the container of FIG. 1.

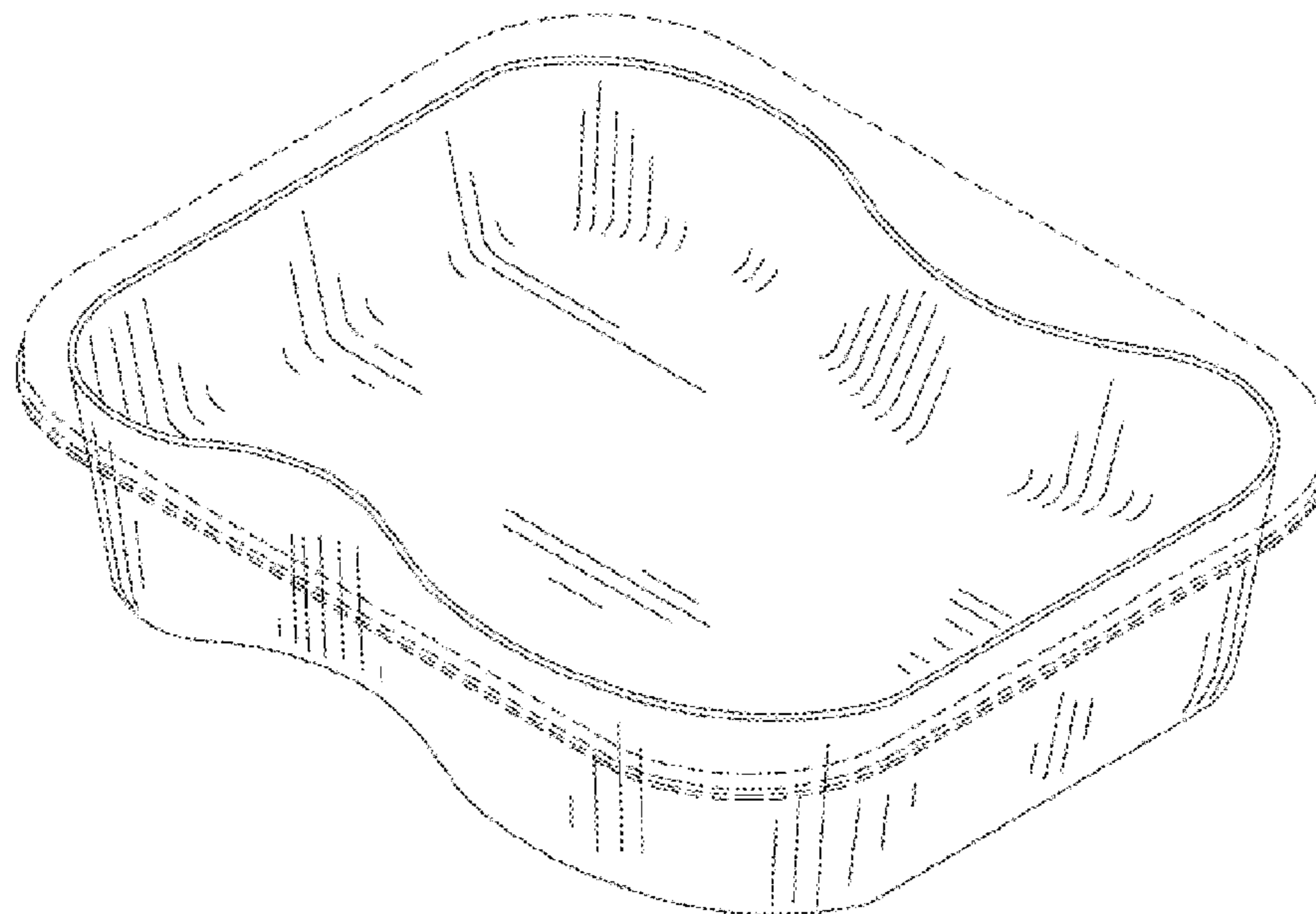
FIG. 5 is a second side plan view of the container of FIG. 1.

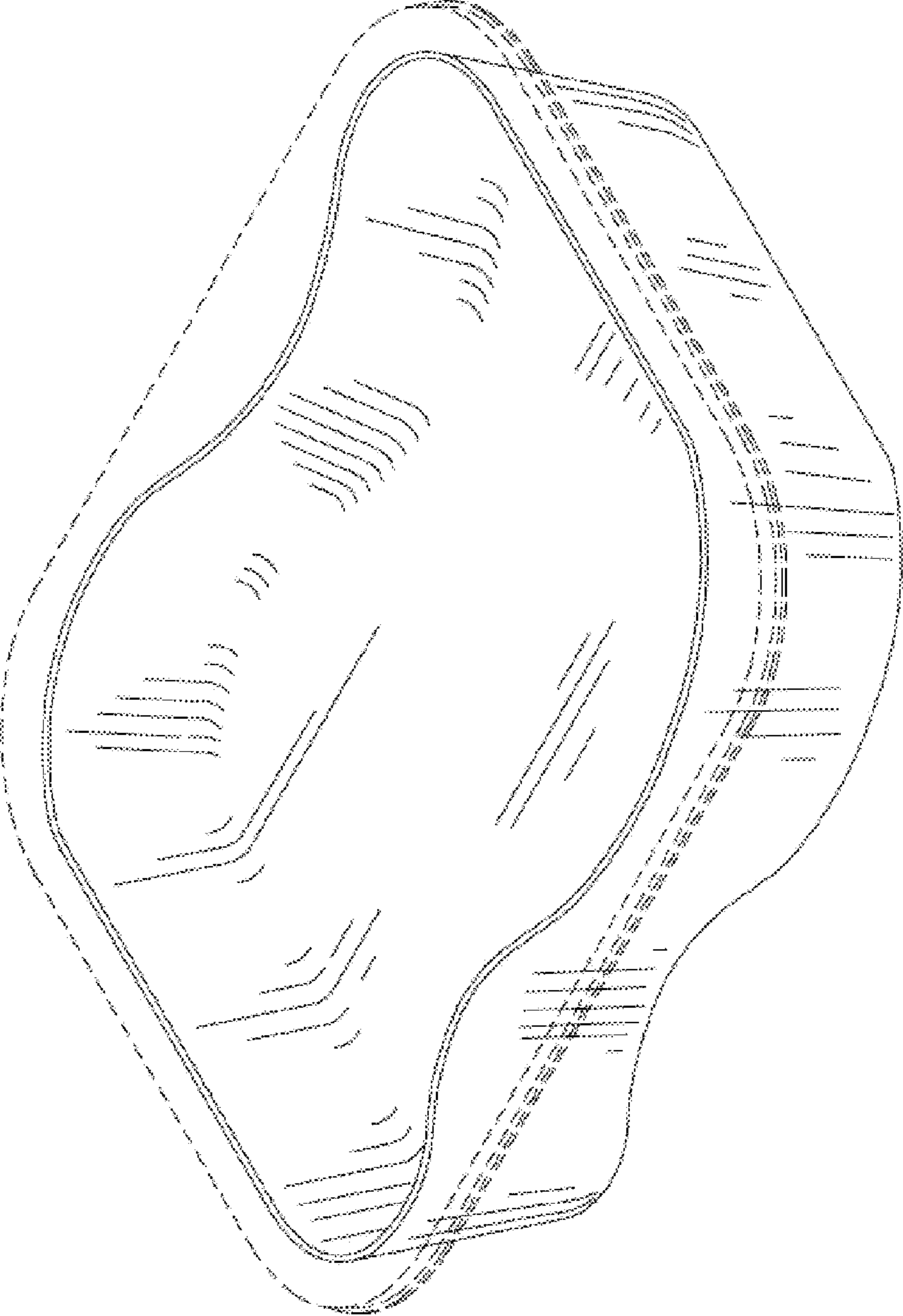

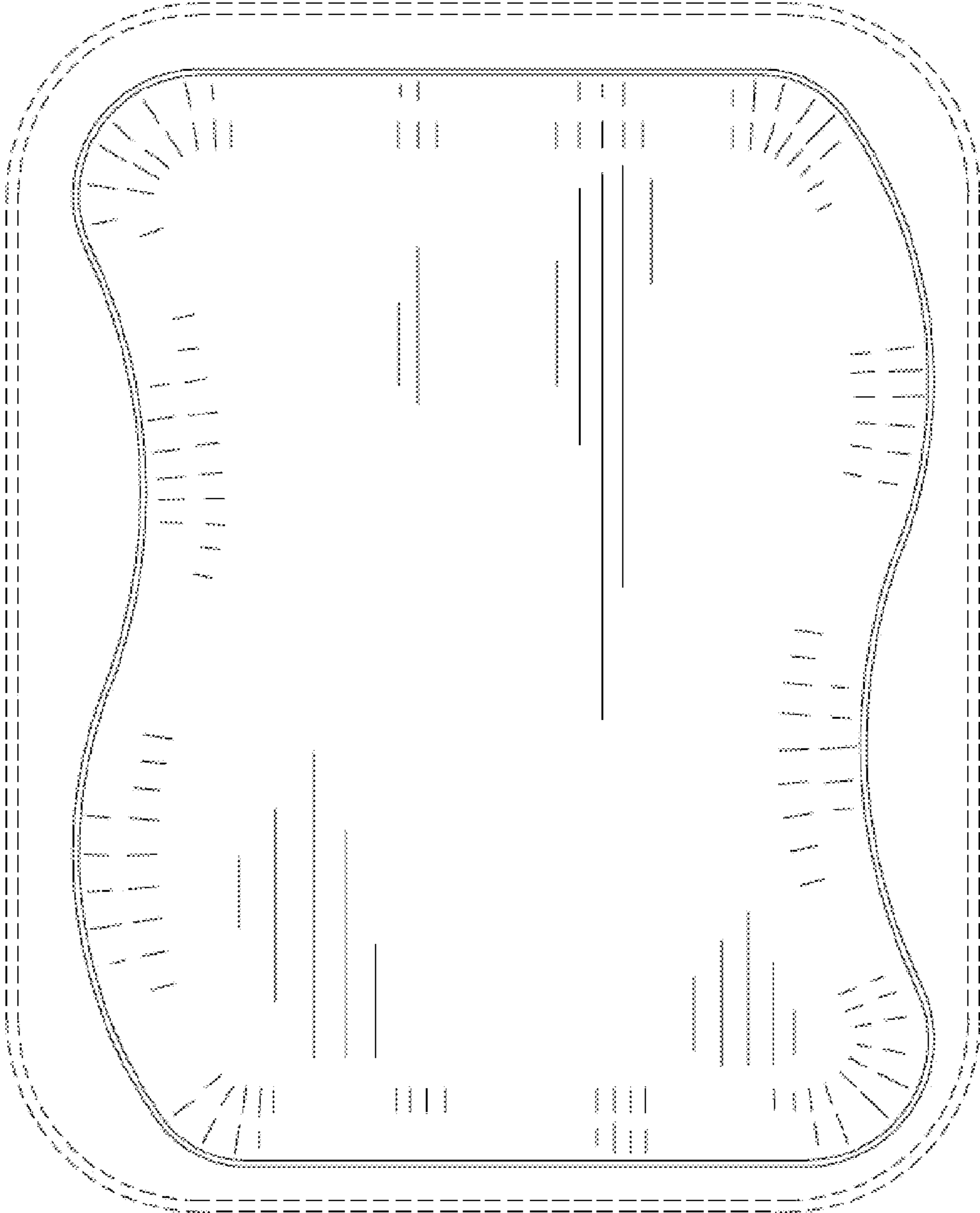

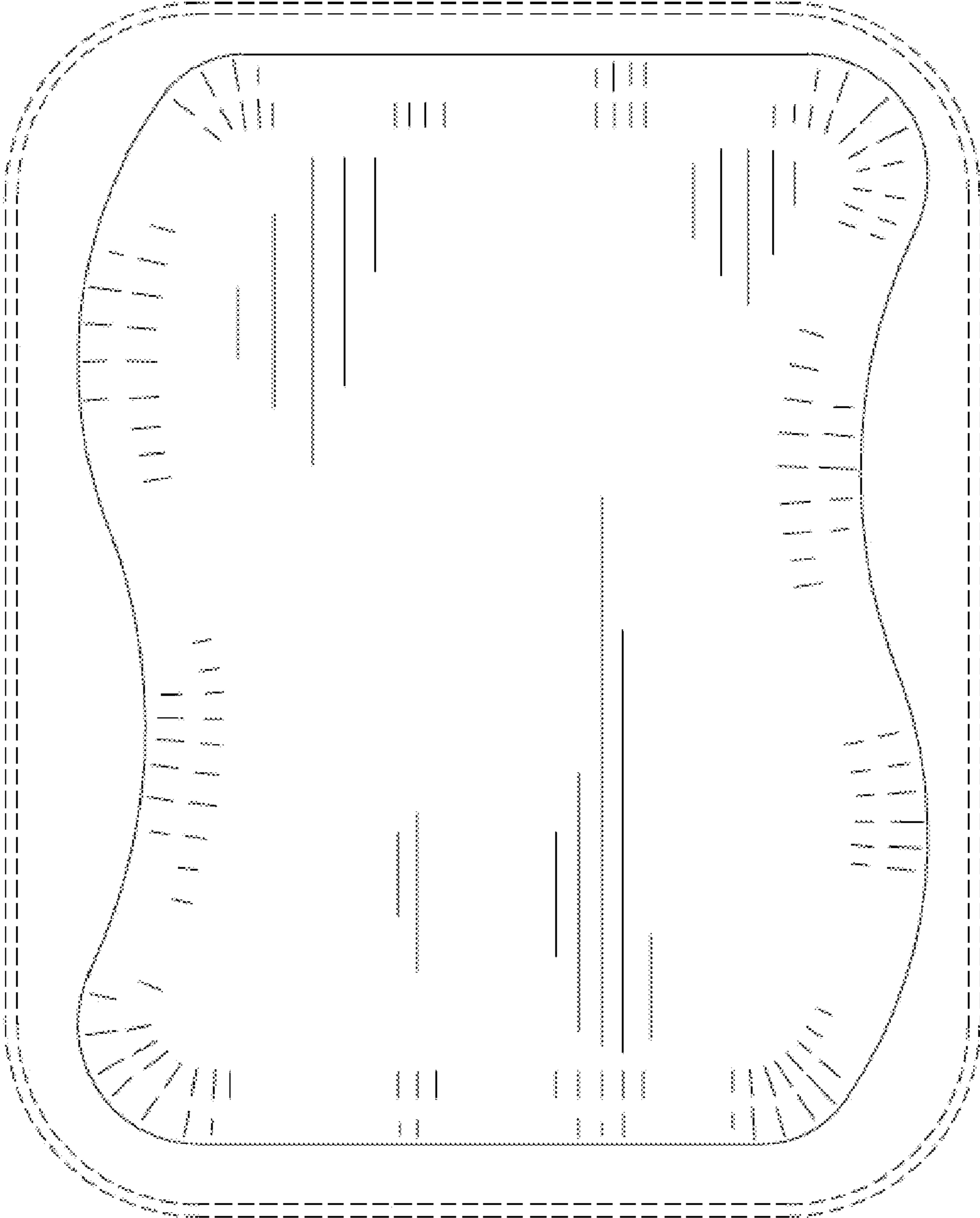

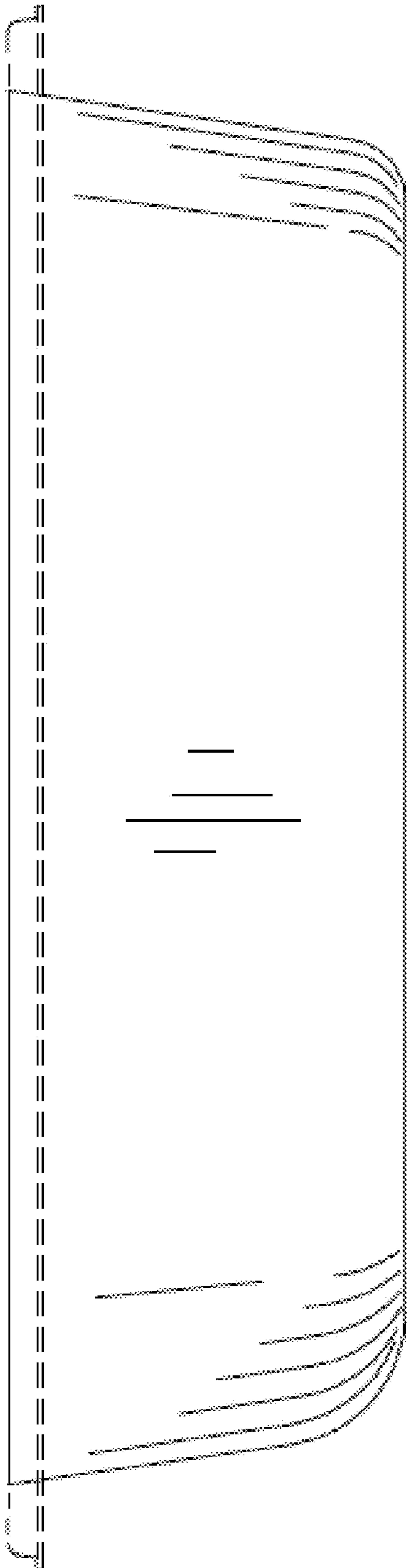

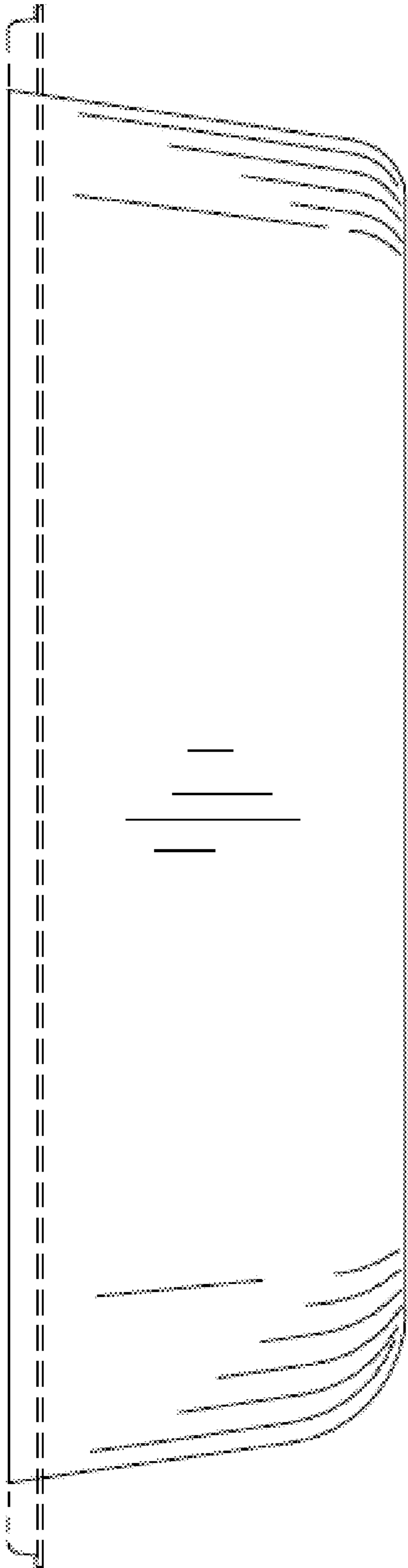

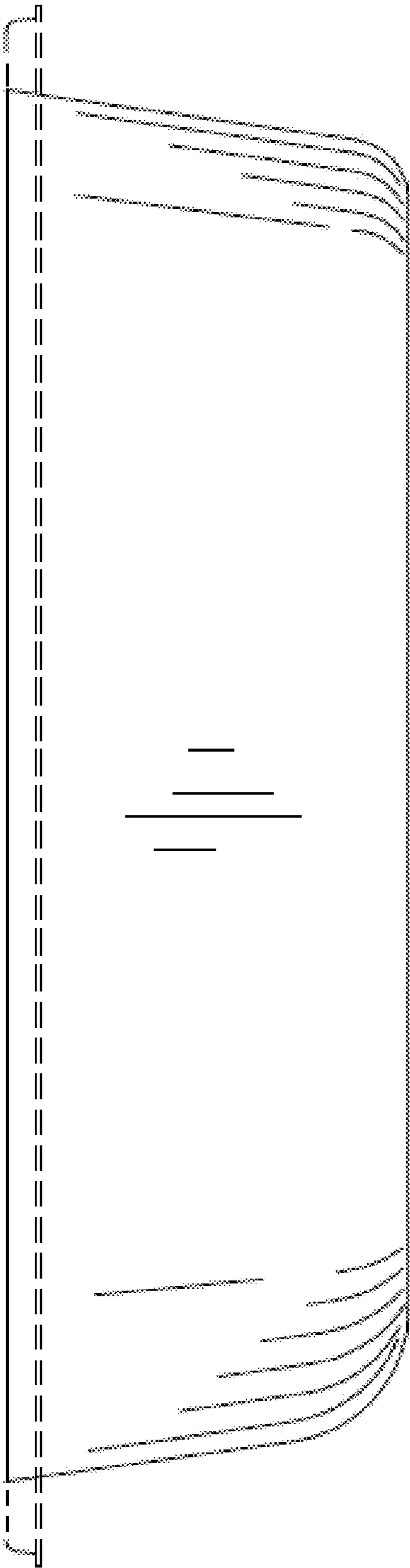

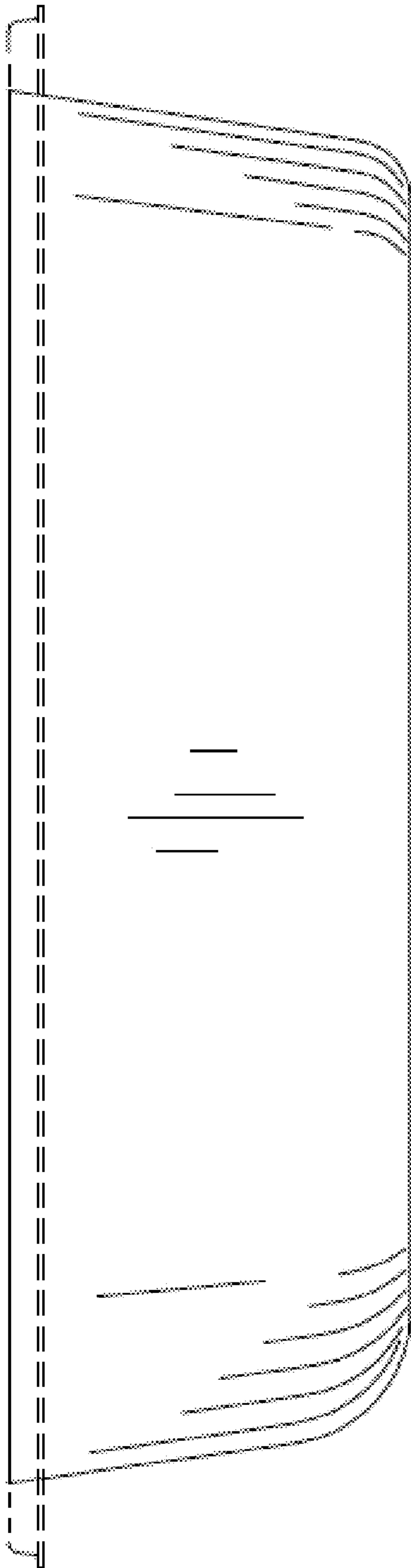
