FIG. 1 is a front view of sample bottle with cord, showing the new design;

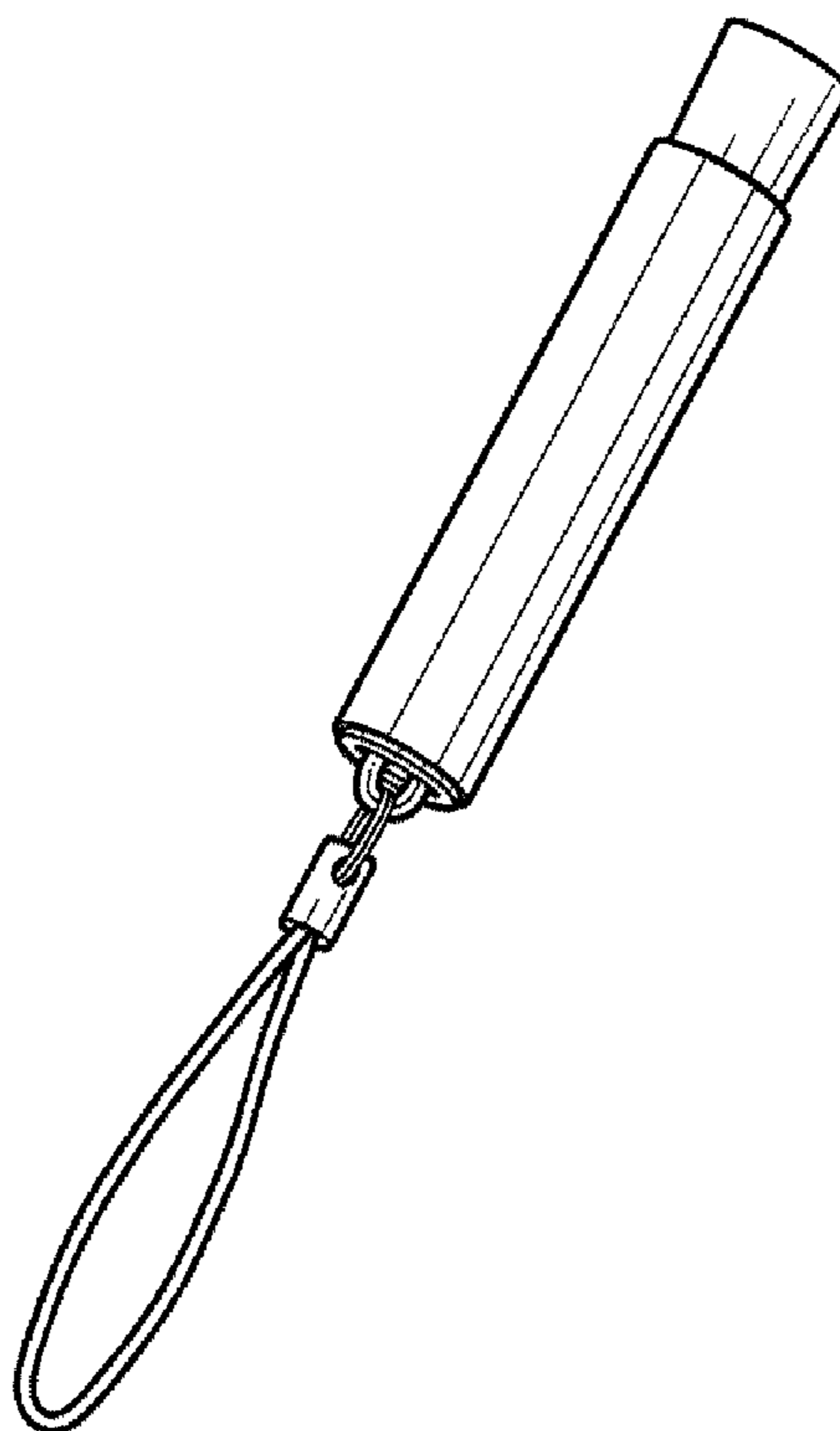
FIG. 2 is a left side view thereof, where the right side view is a mirror image of the left side view;

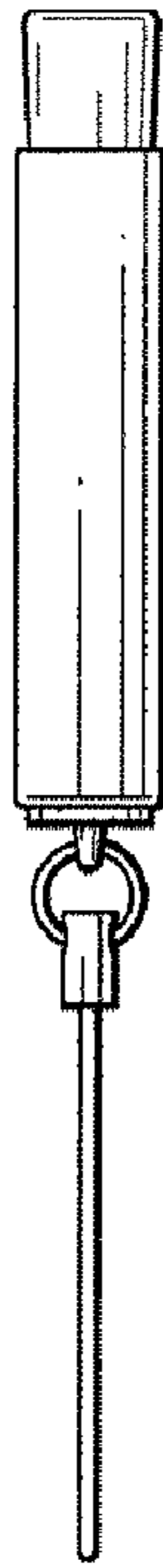

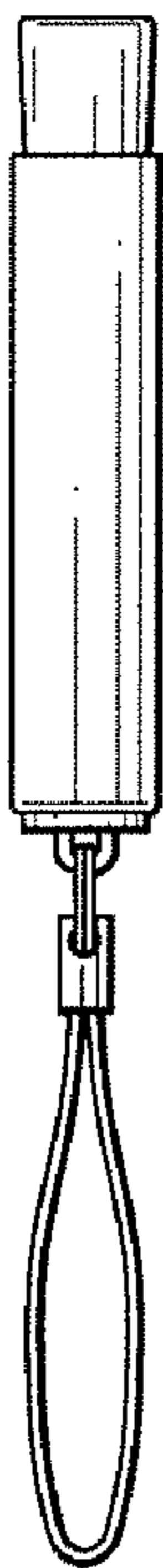

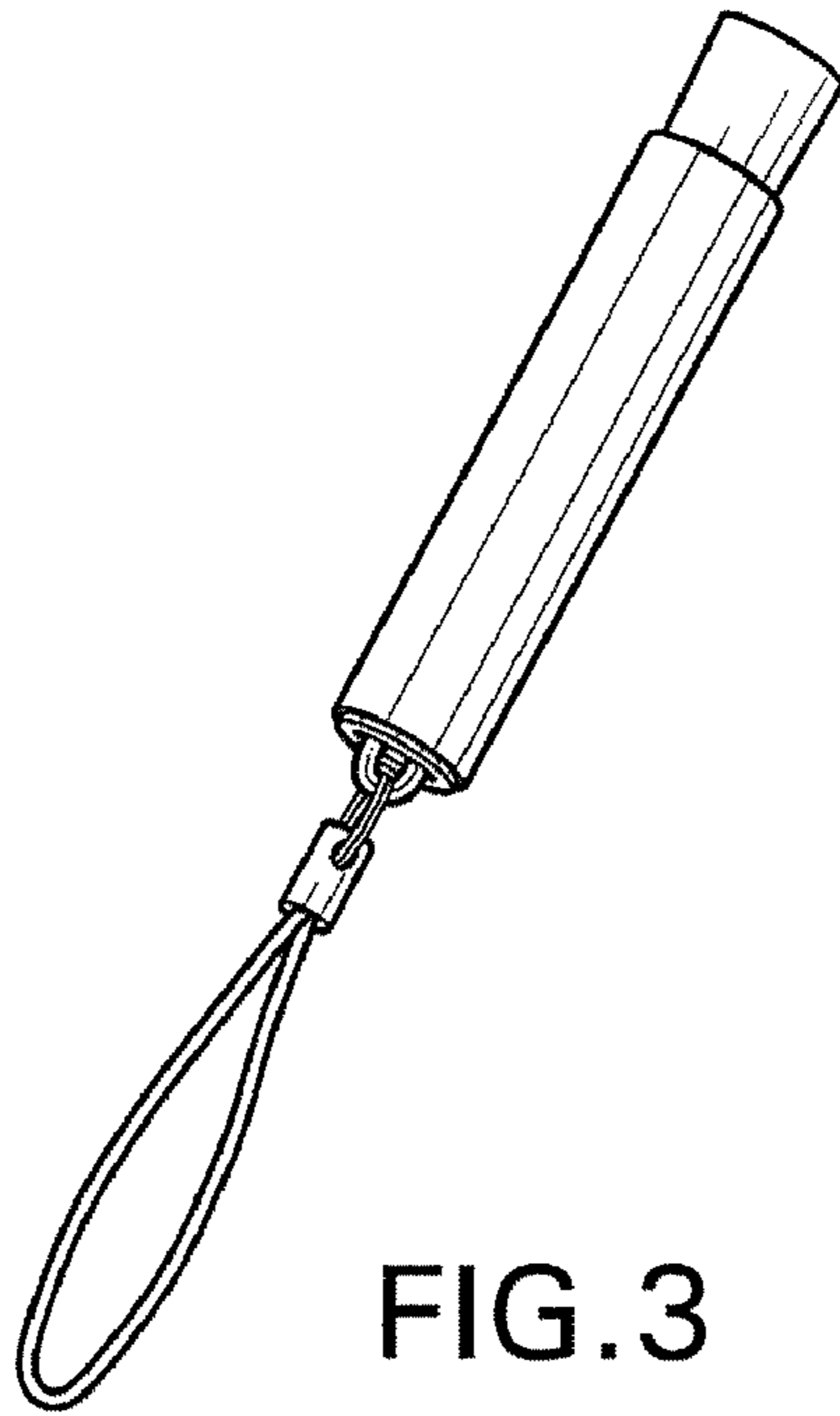

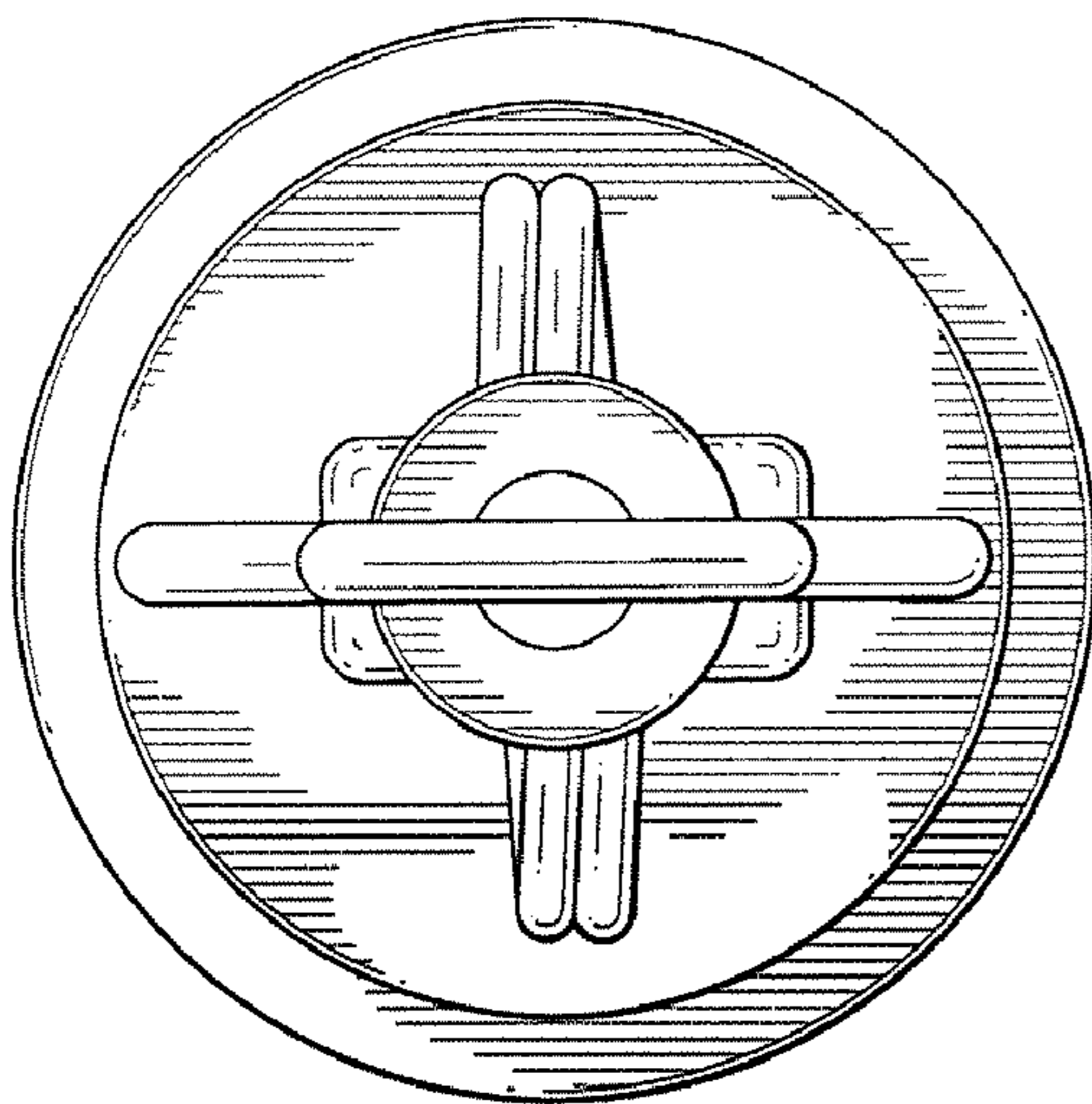

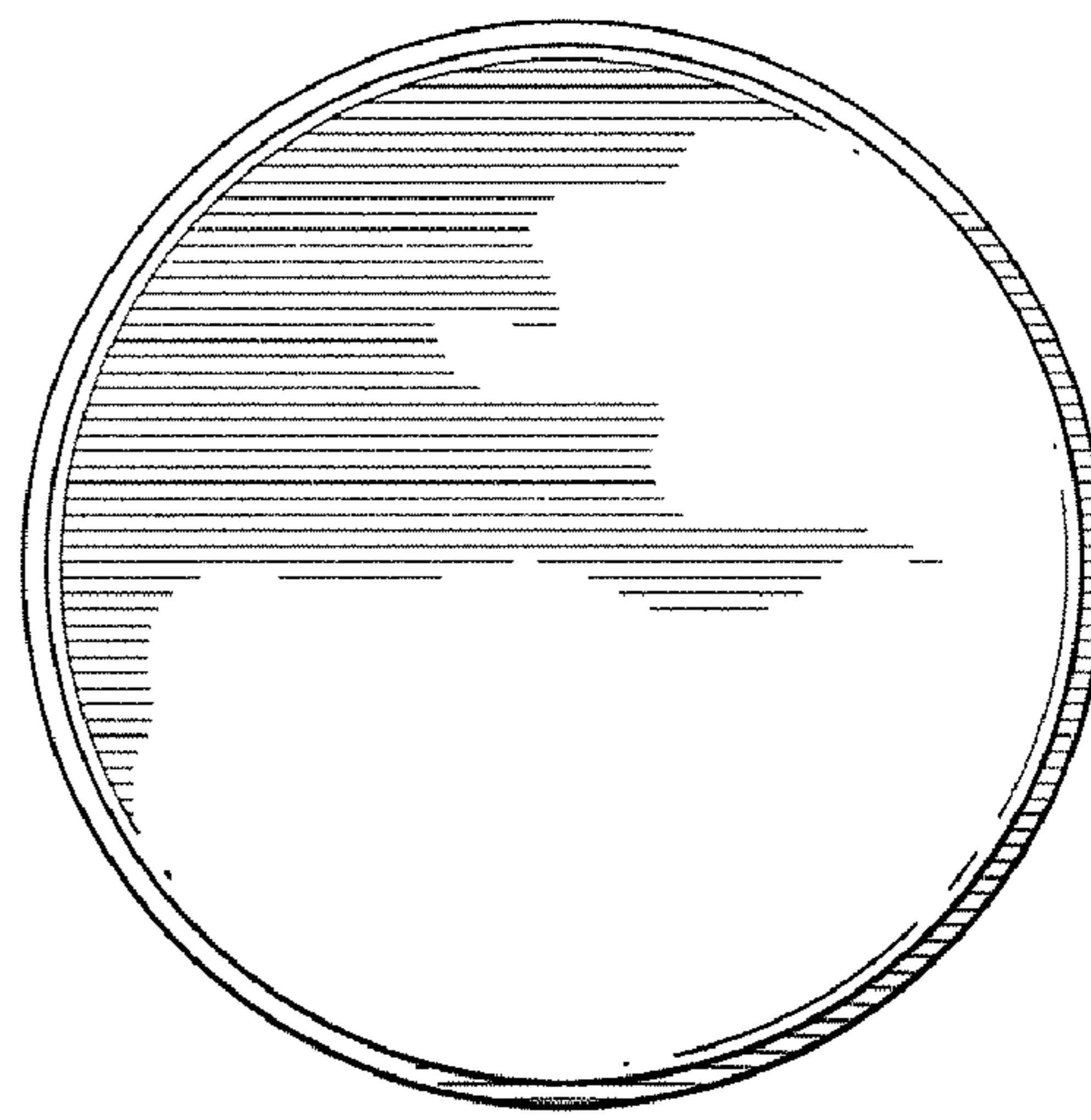
