FIG. 23 is a right side view of the design shown in FIG. 19;

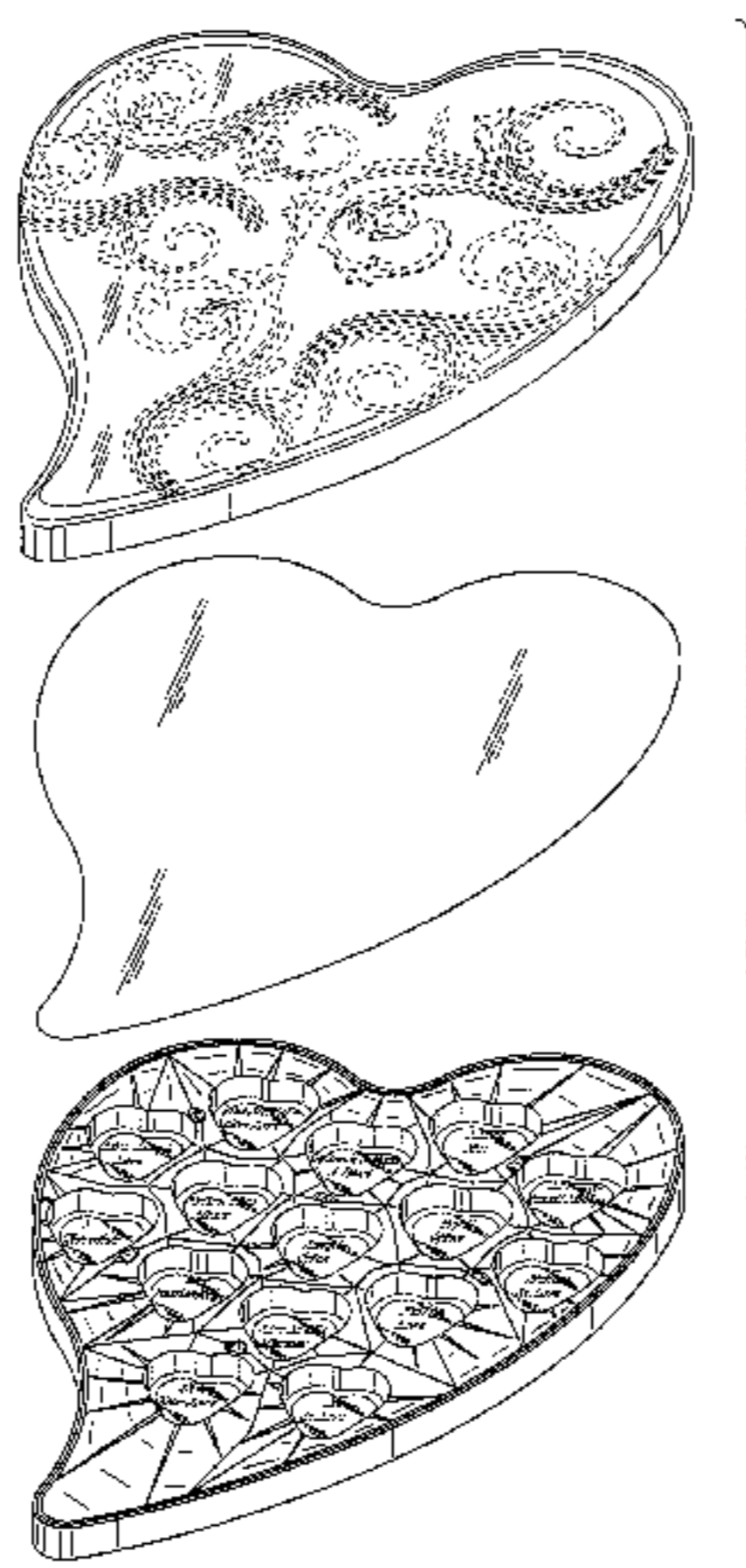


FIG. 24 is a top view of the design shown in FIG. 19;

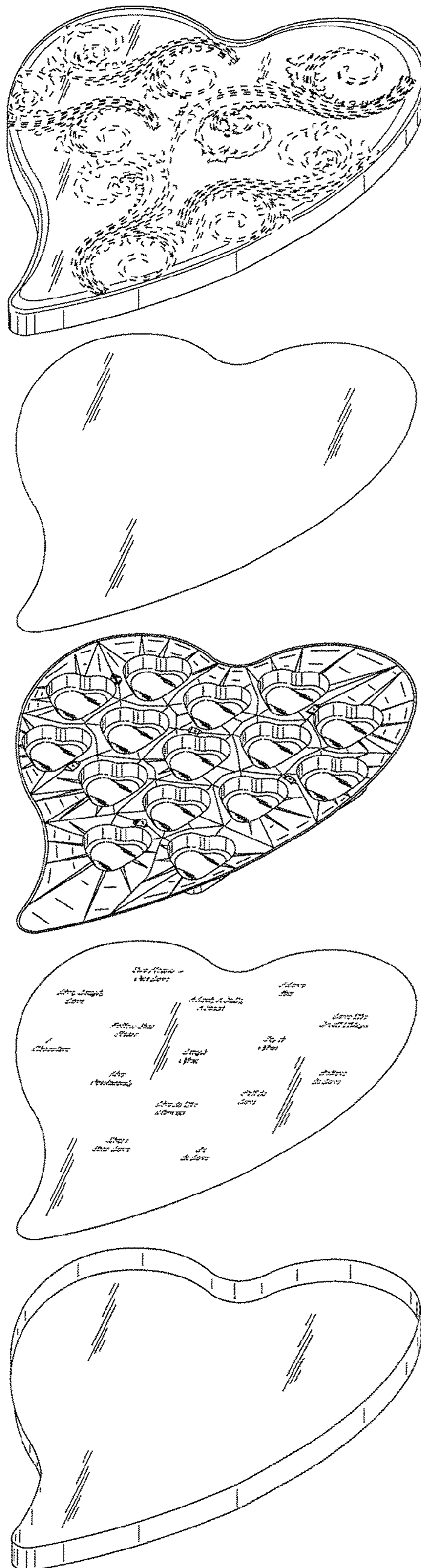

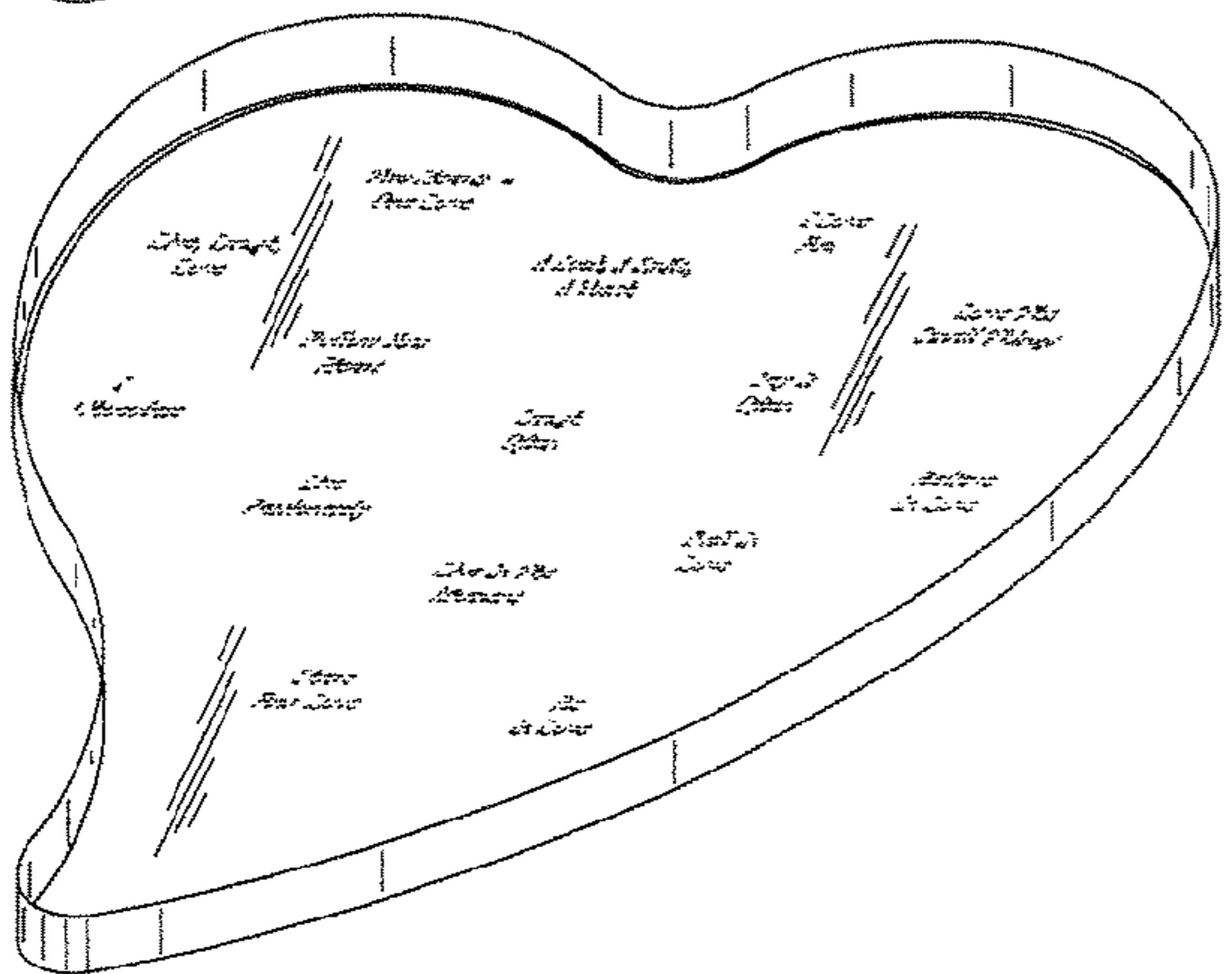
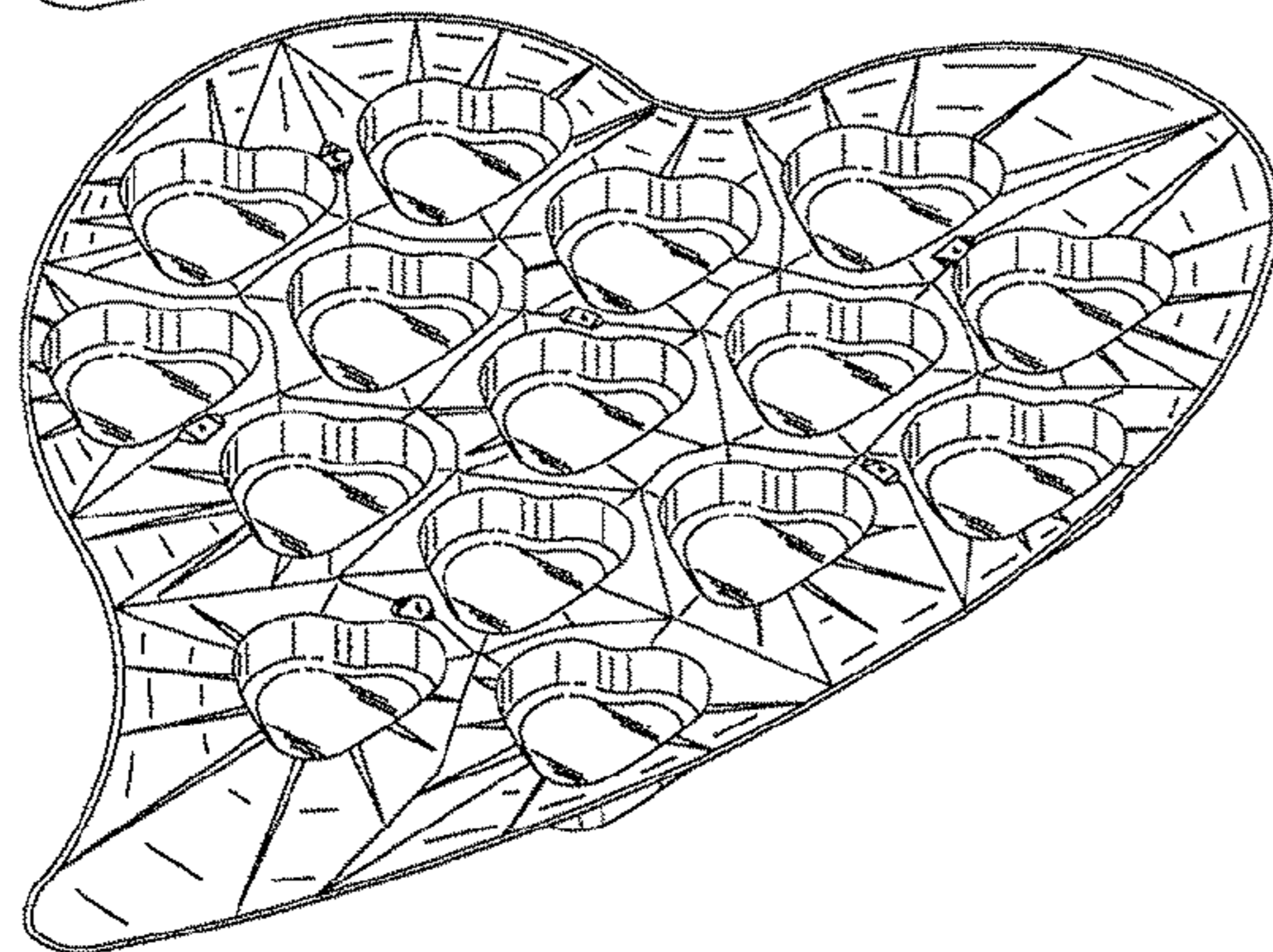
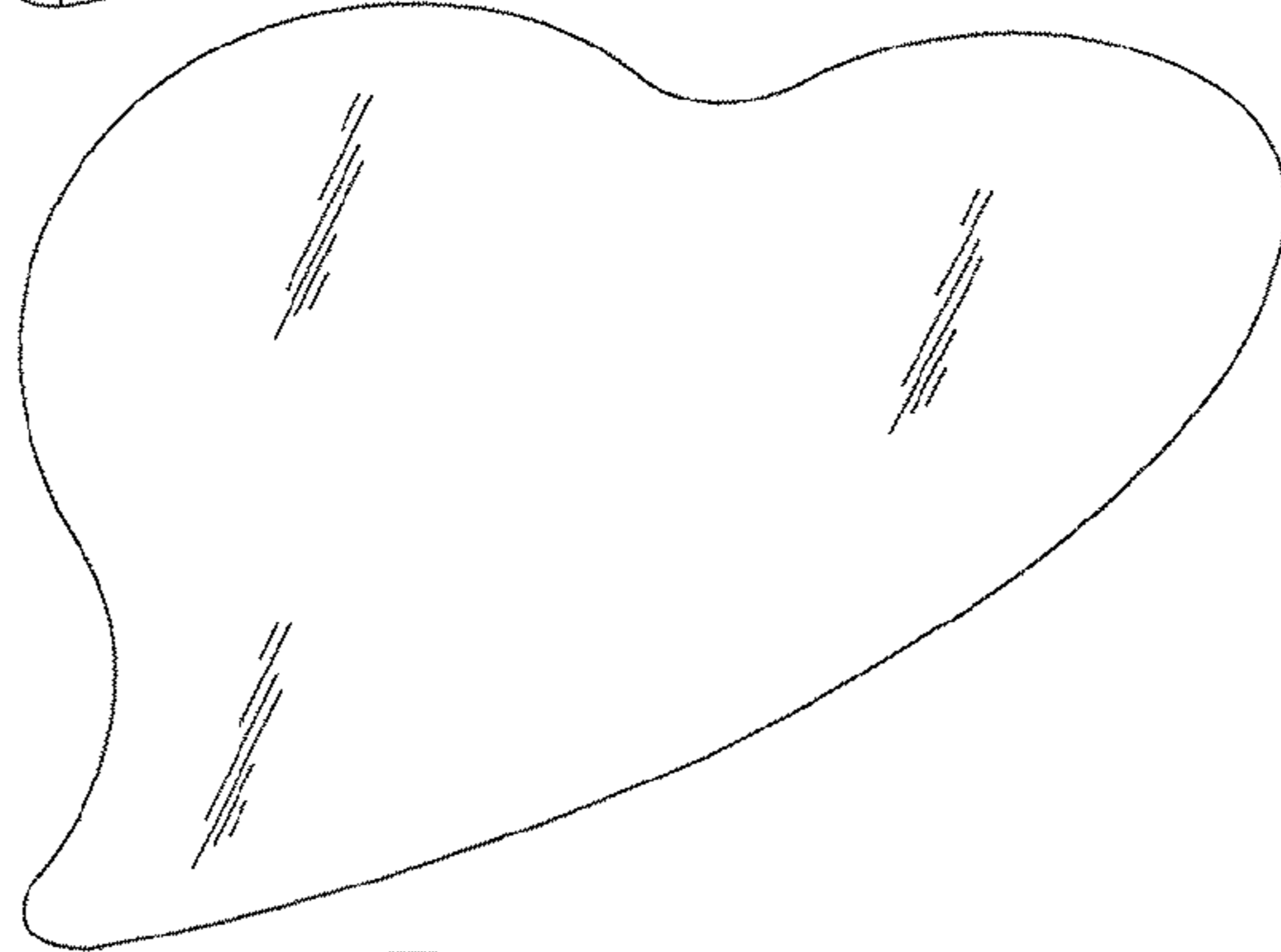
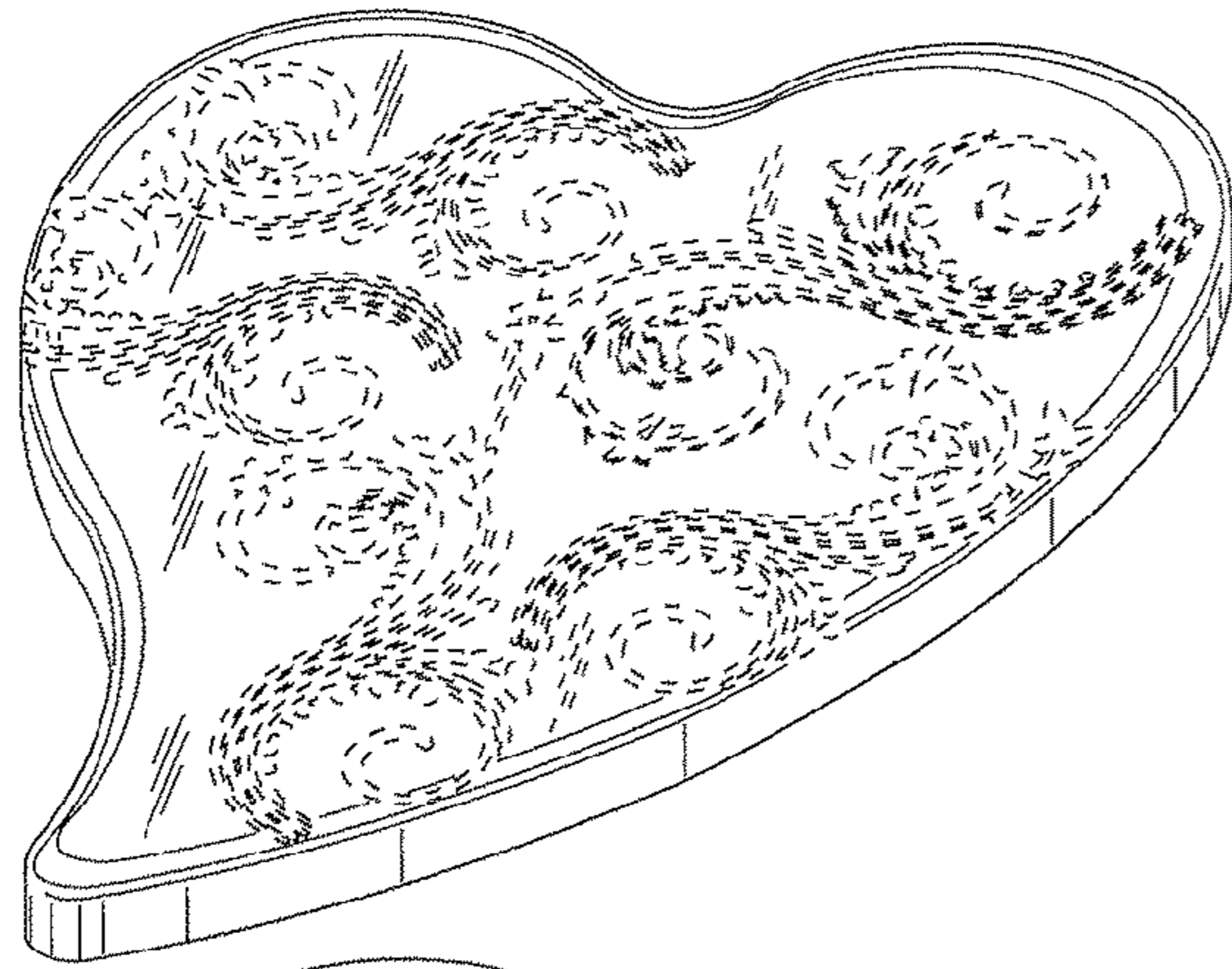

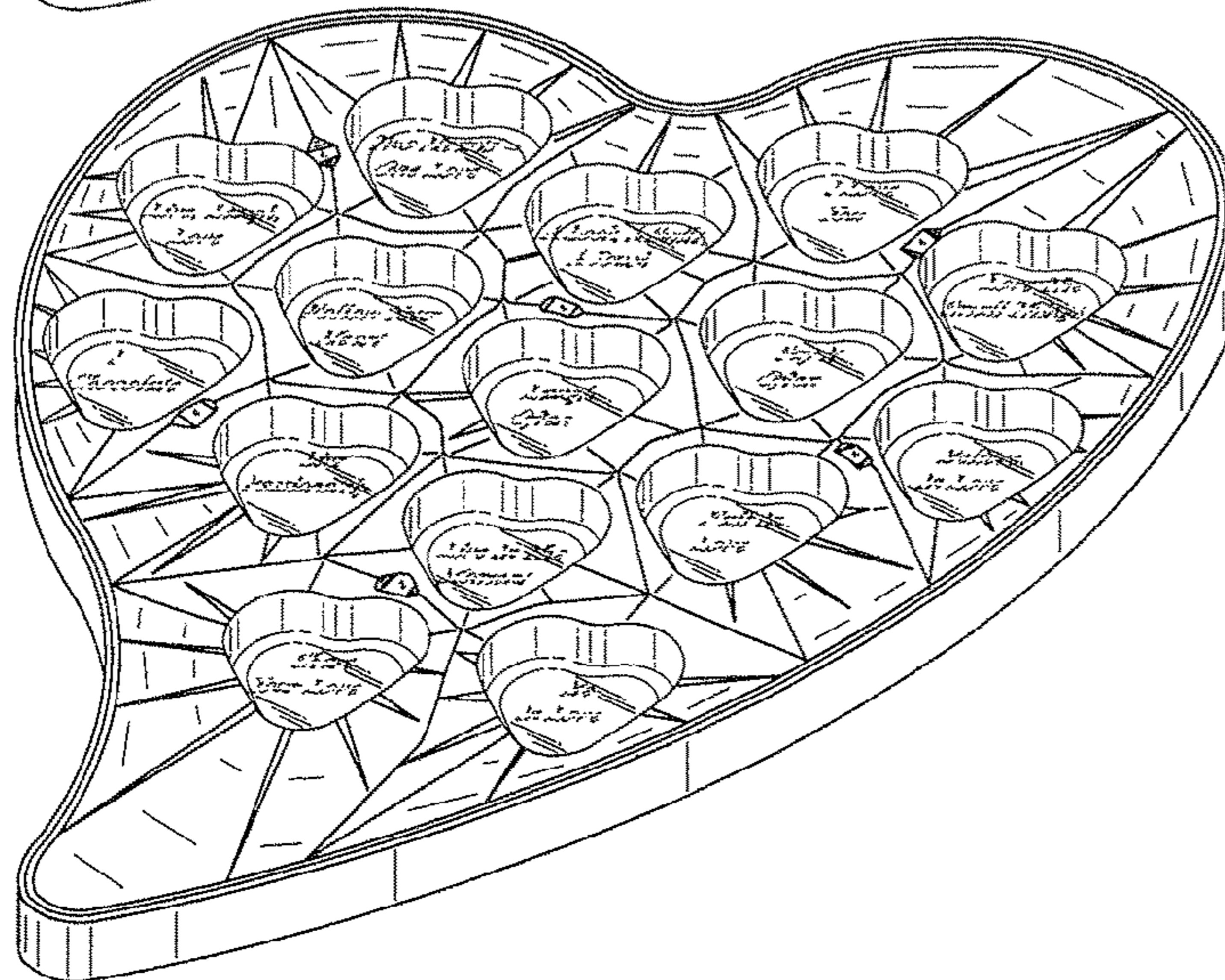
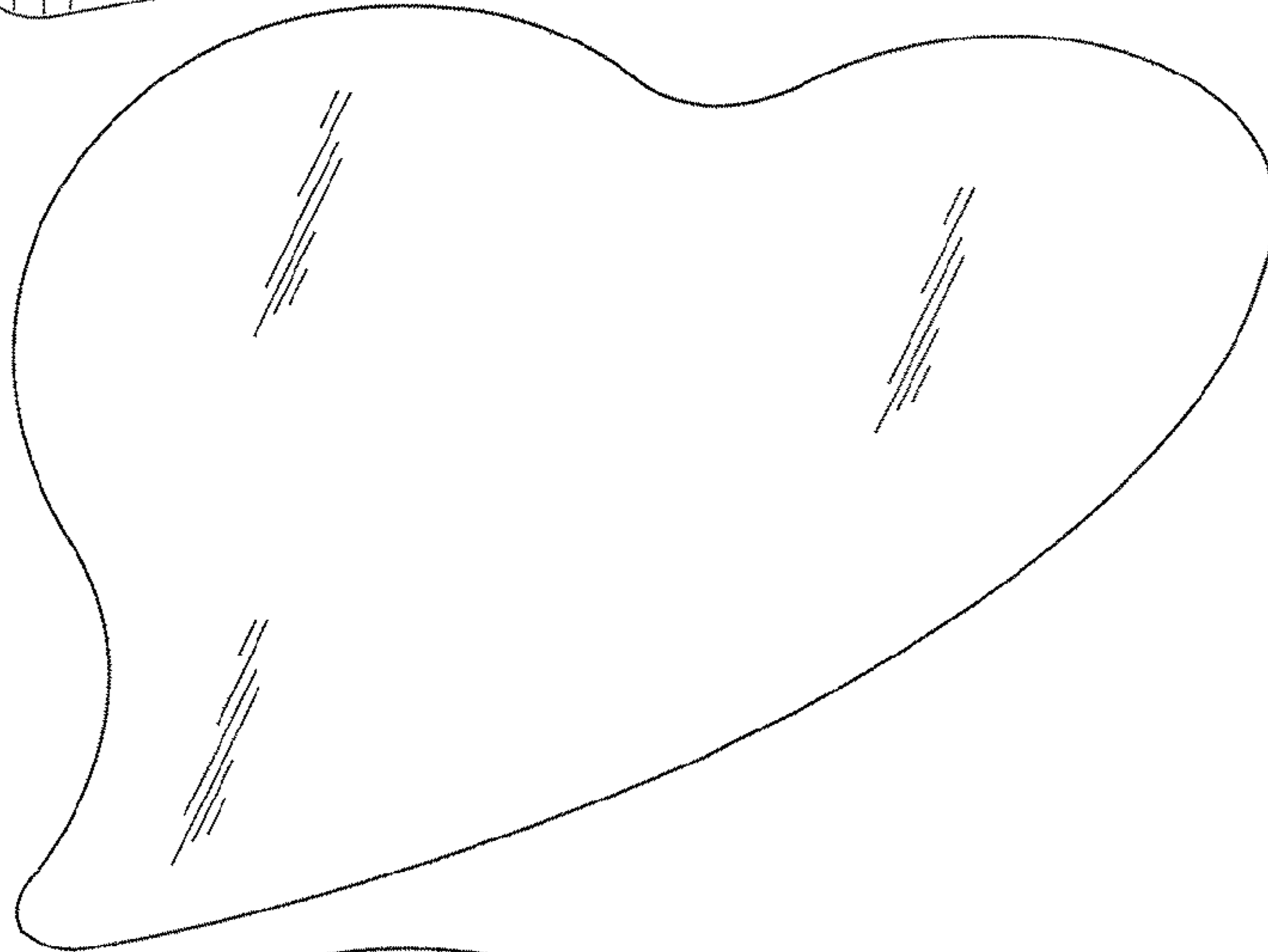
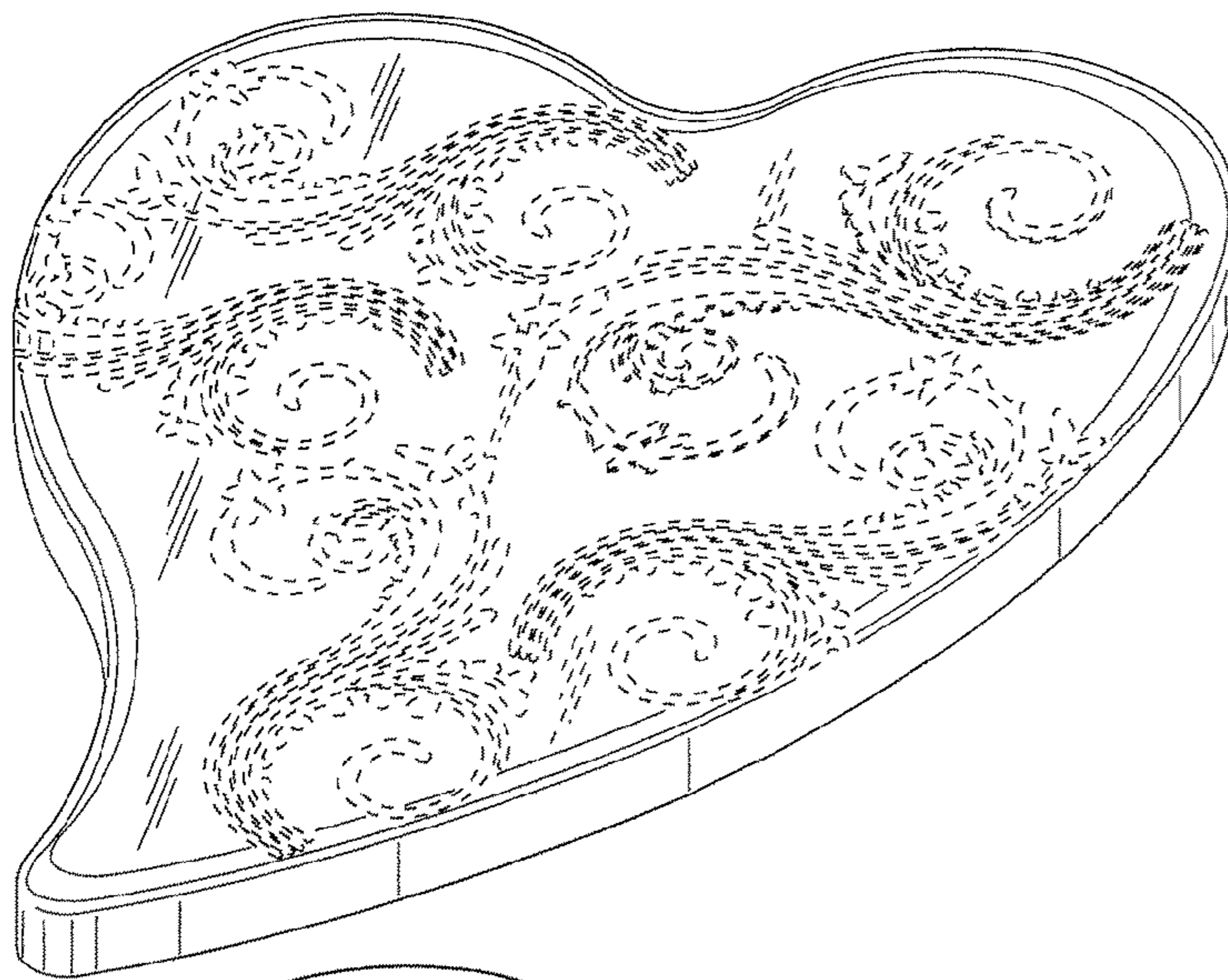

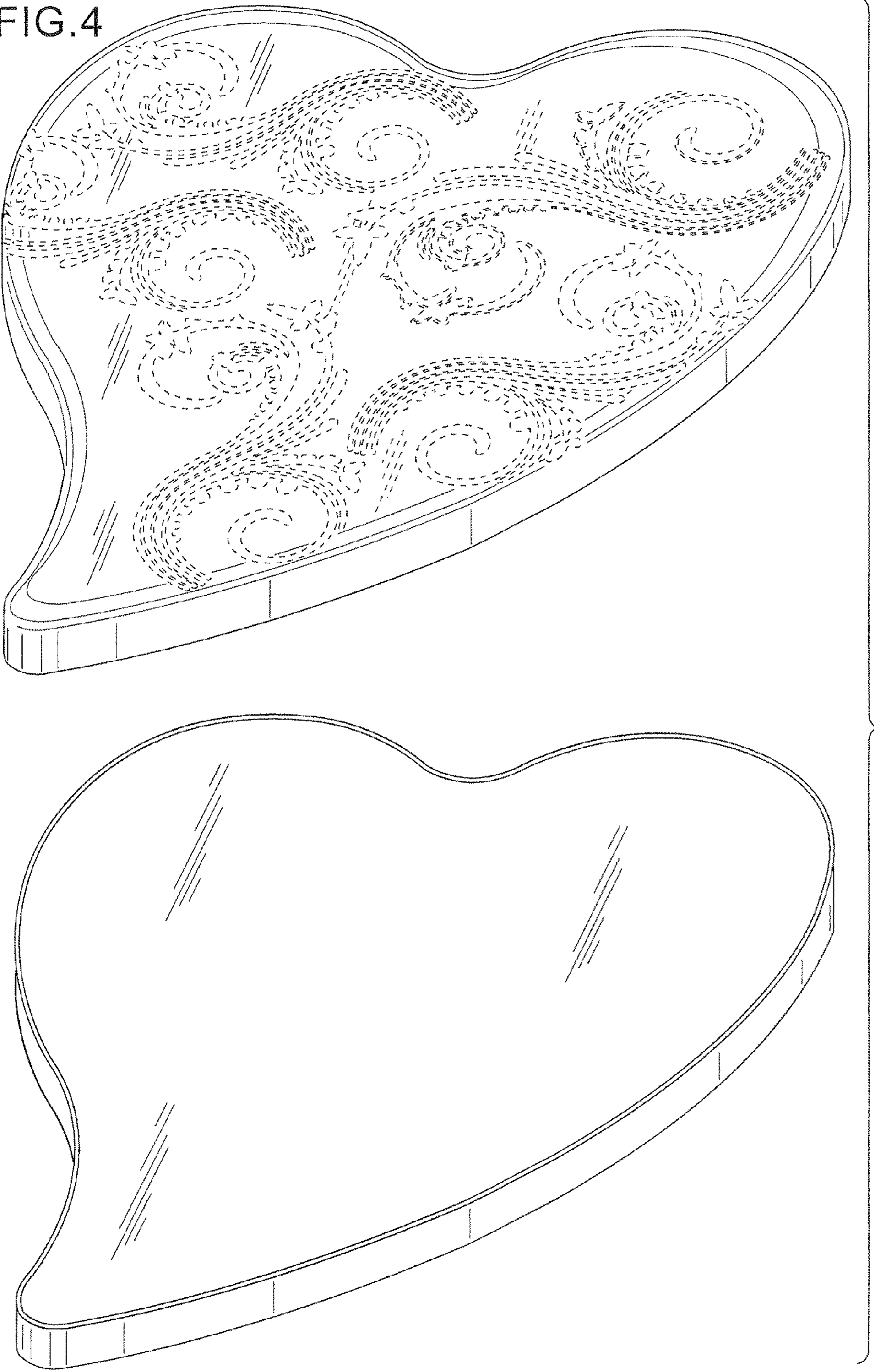

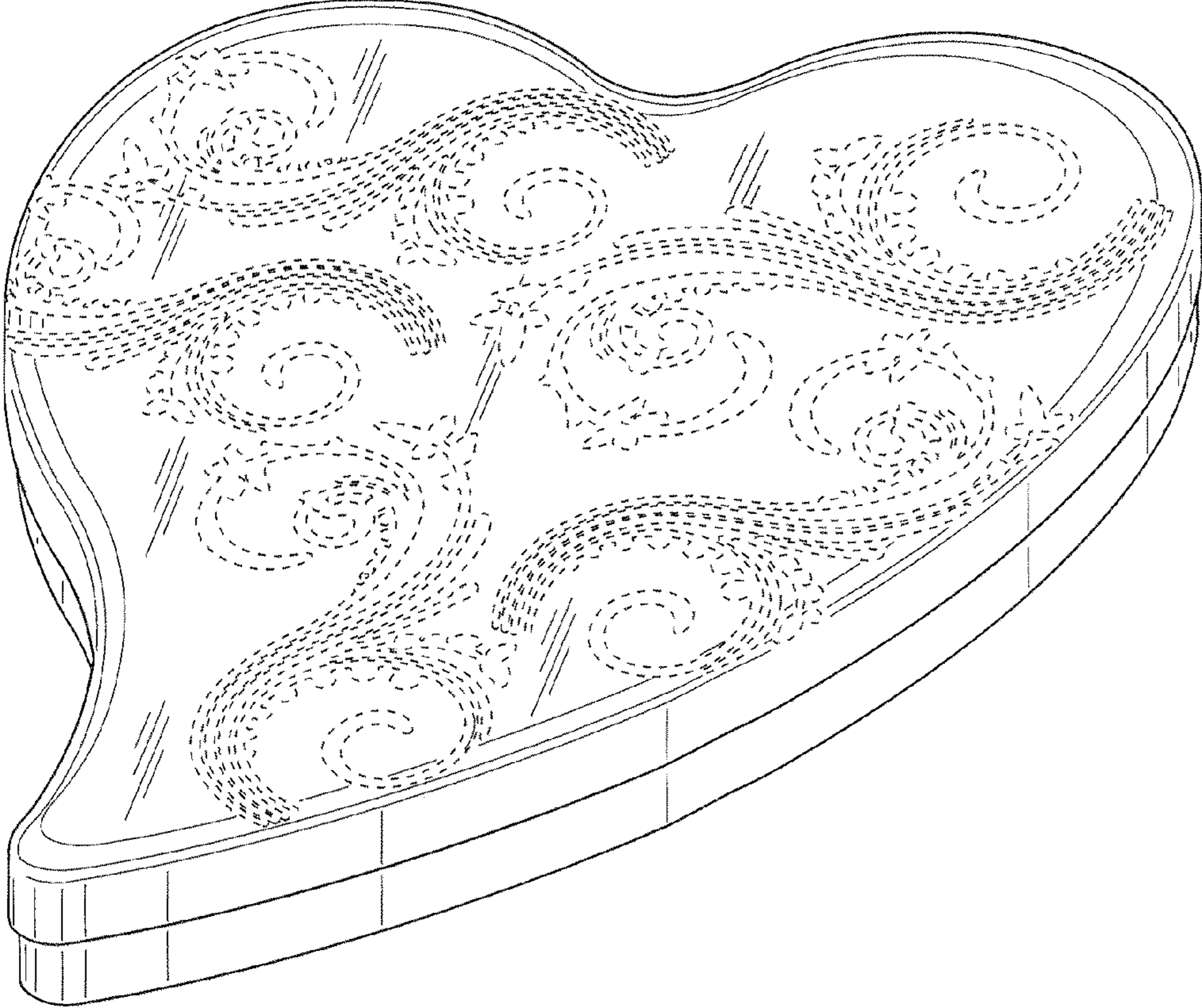

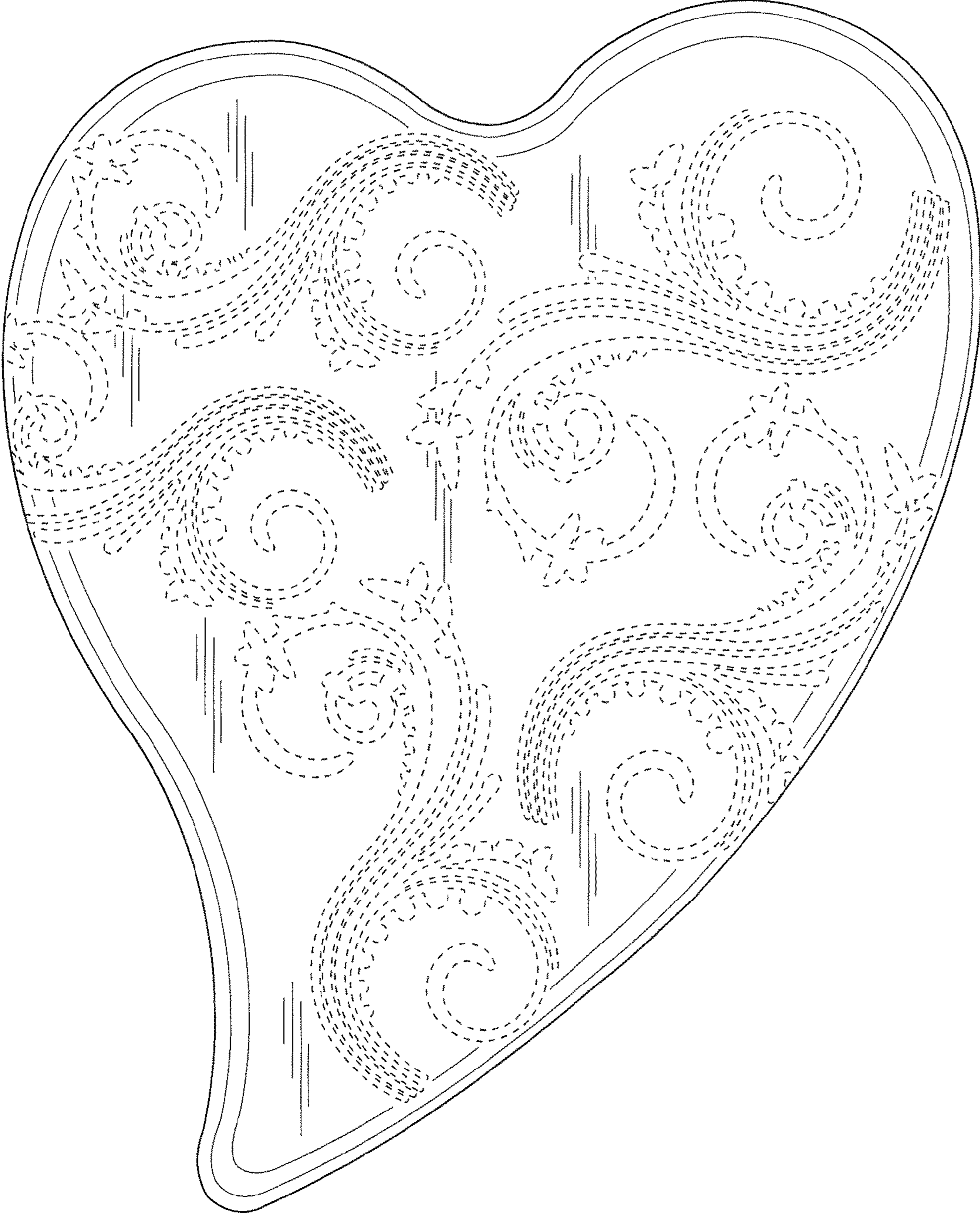

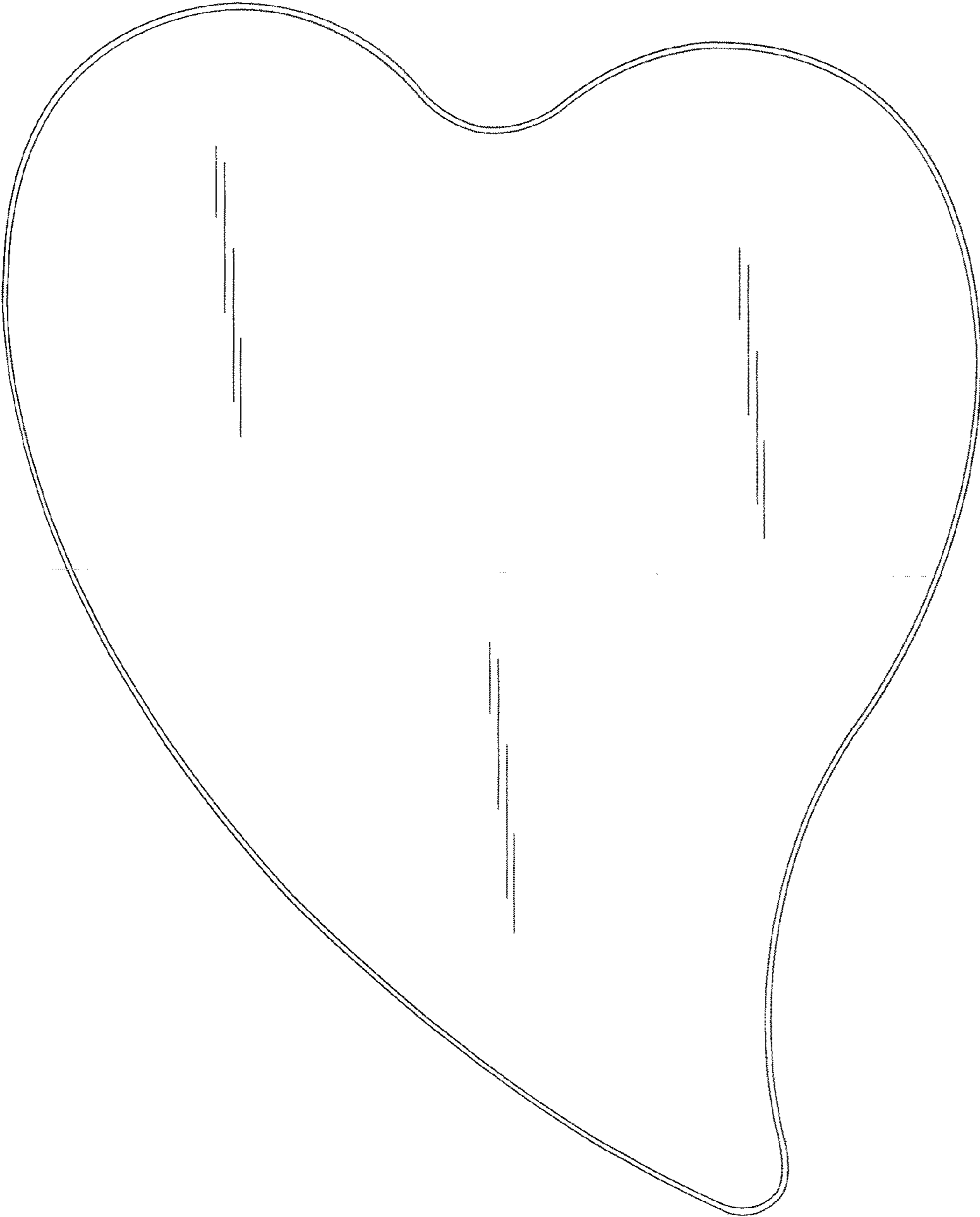

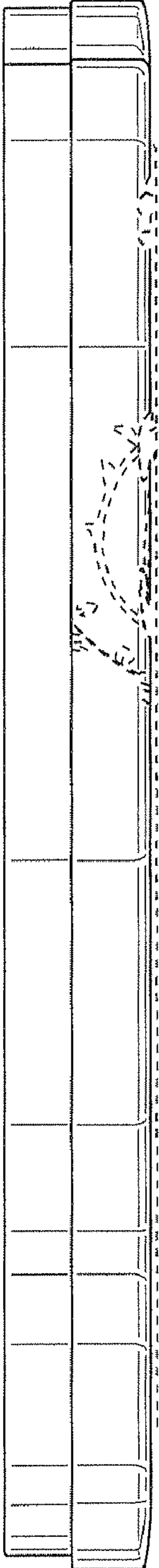

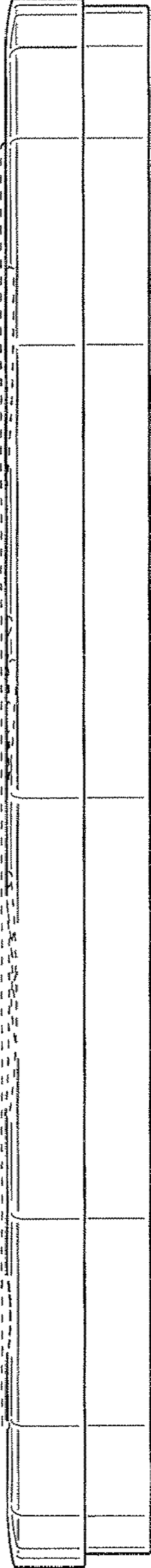

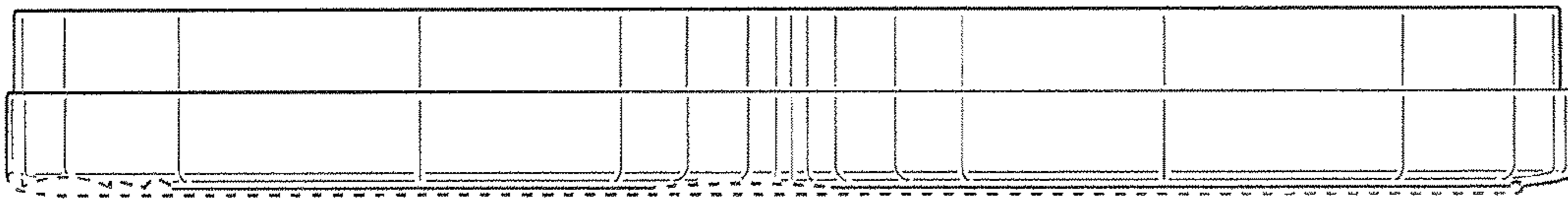

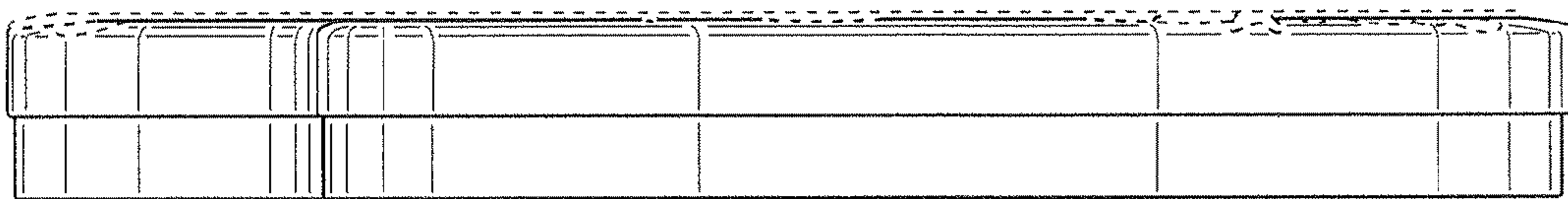

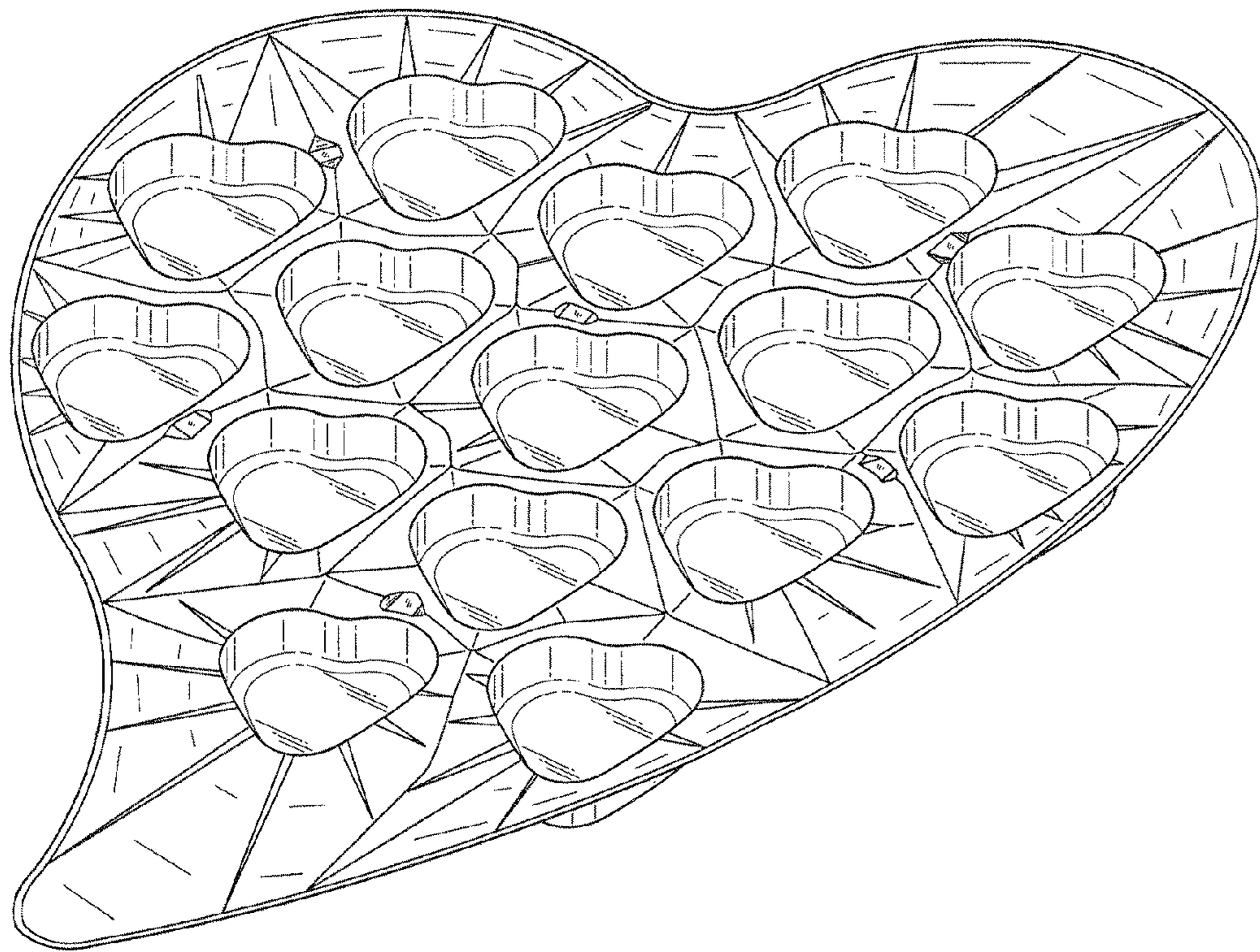

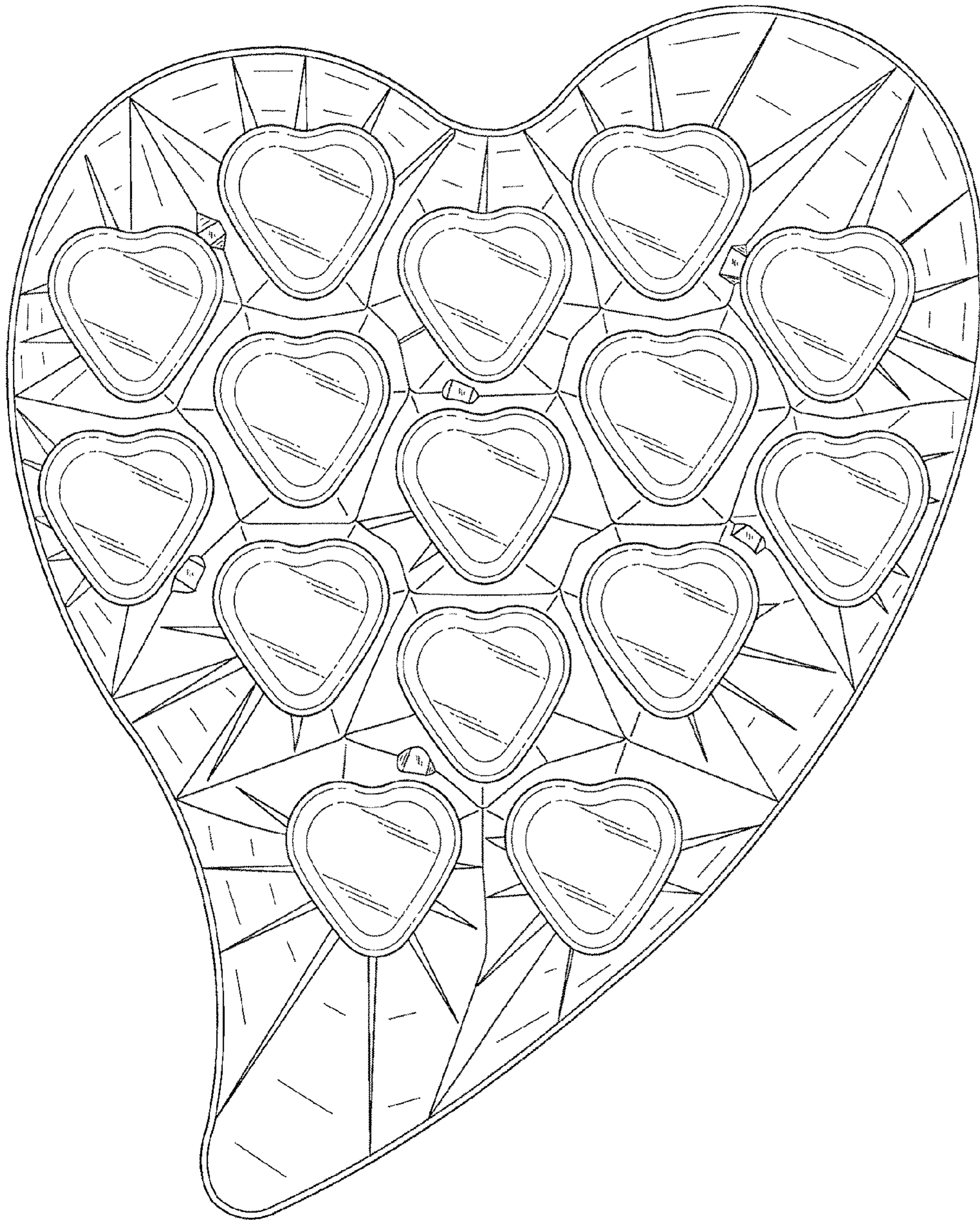

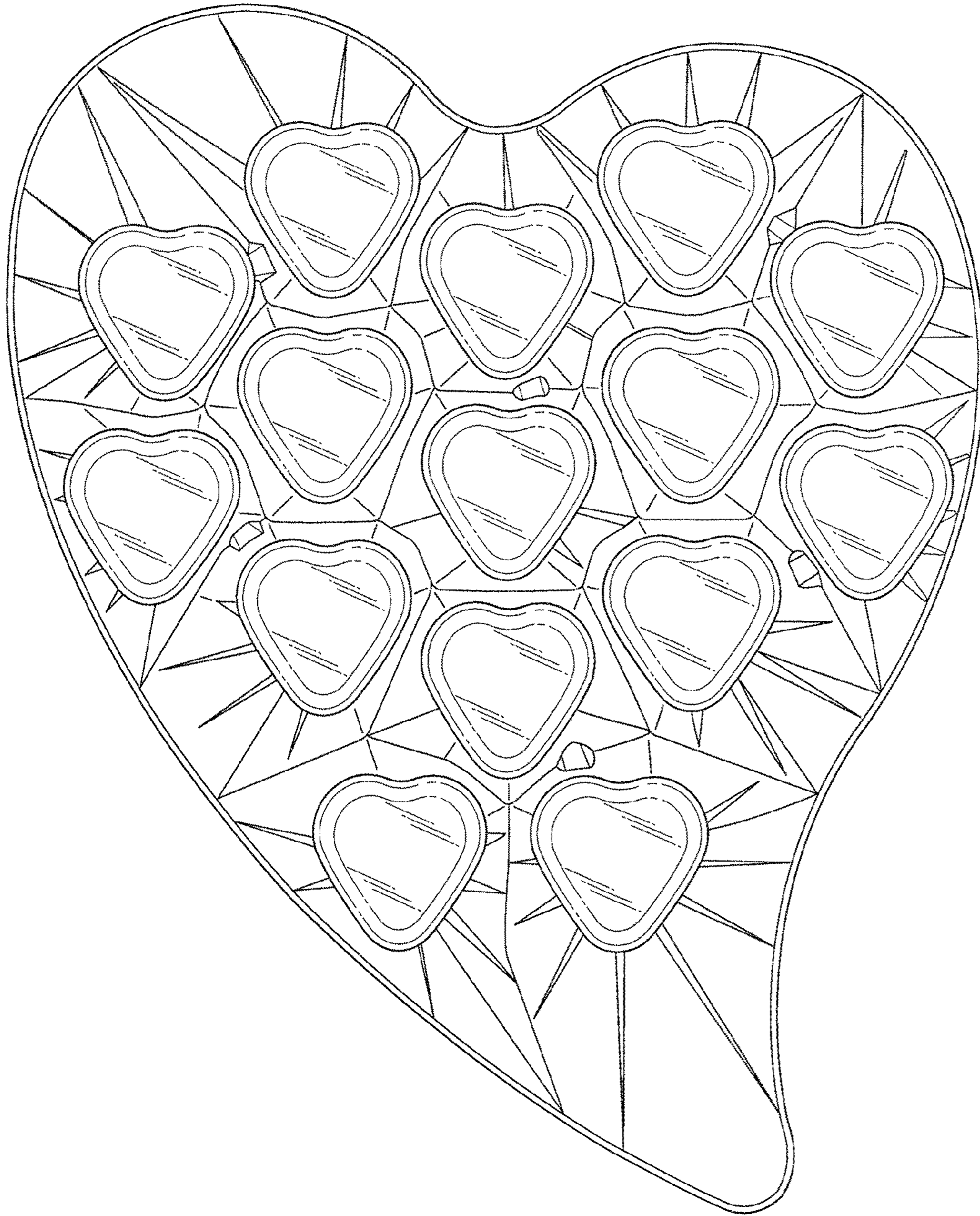

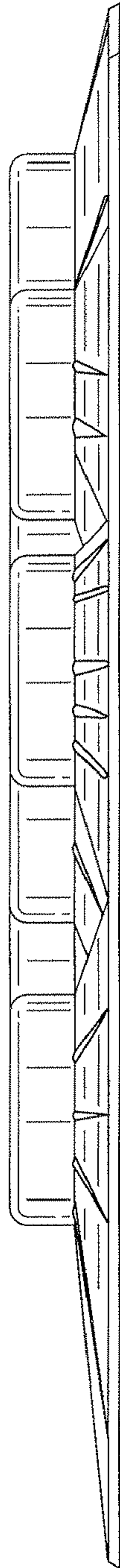

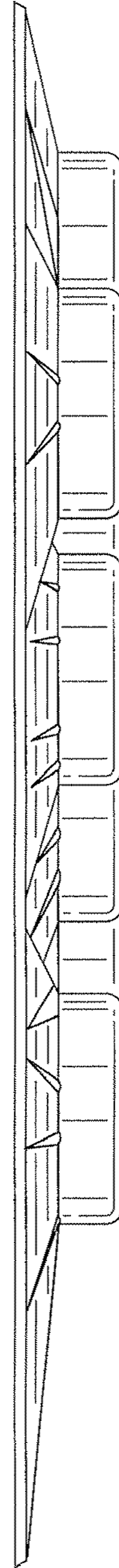

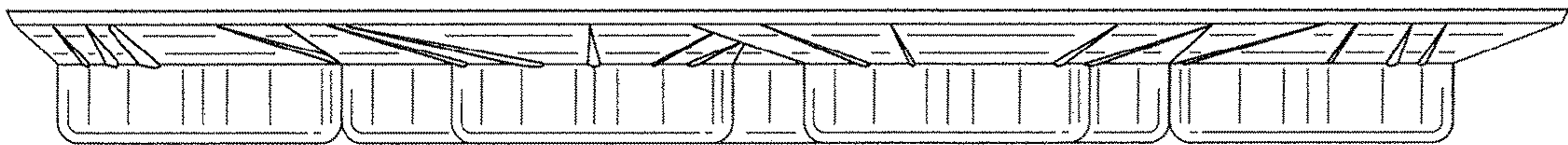

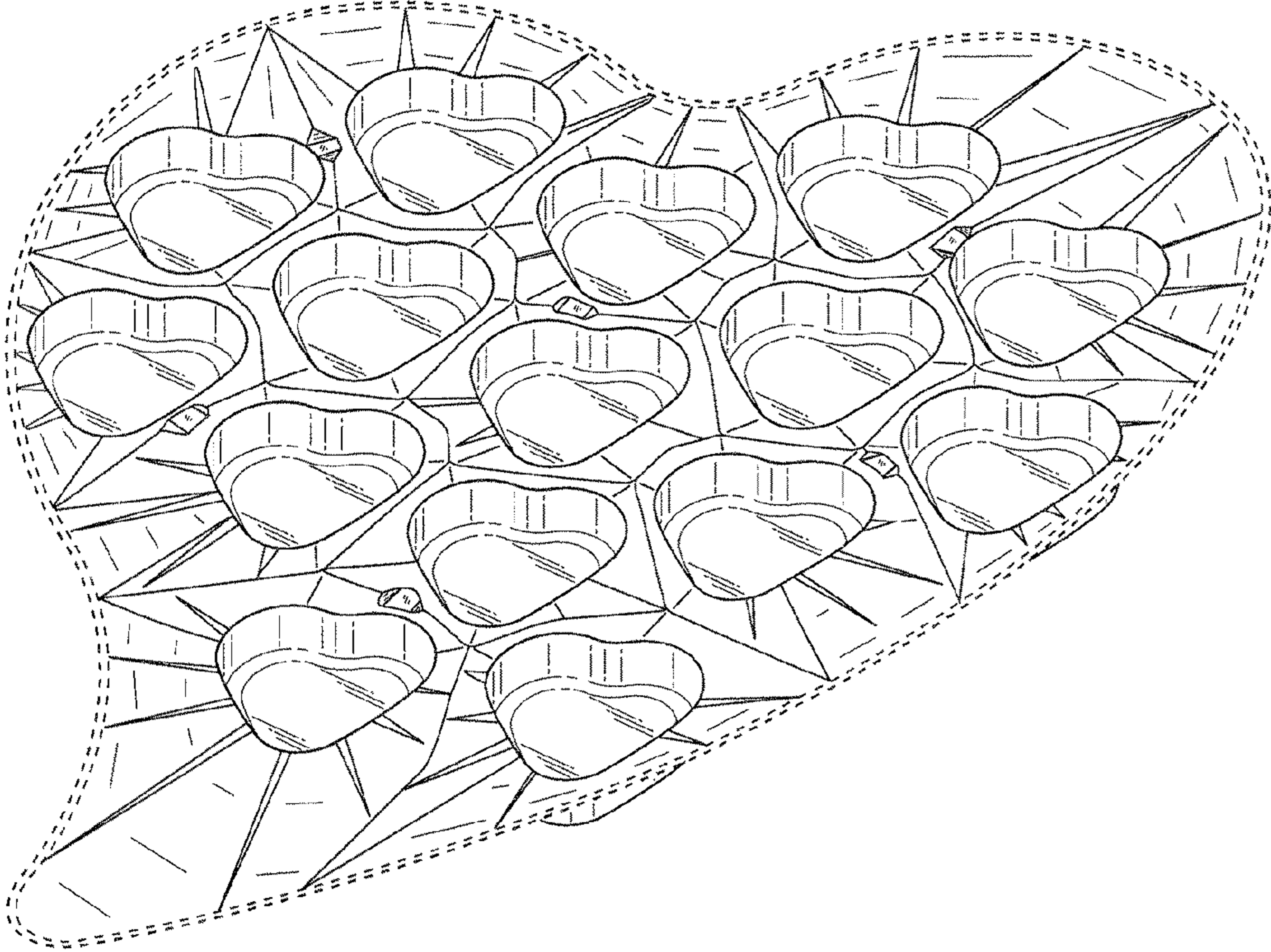

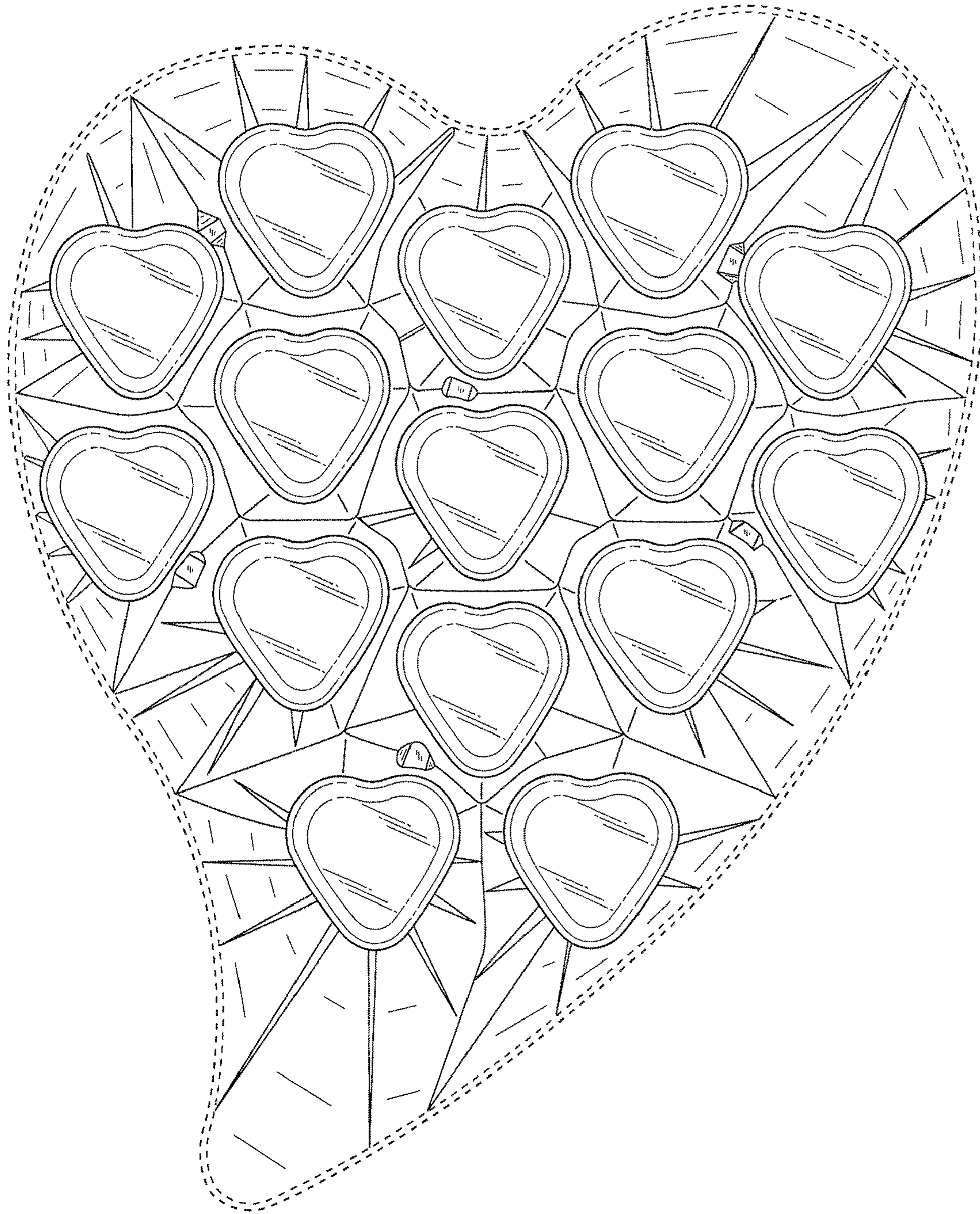

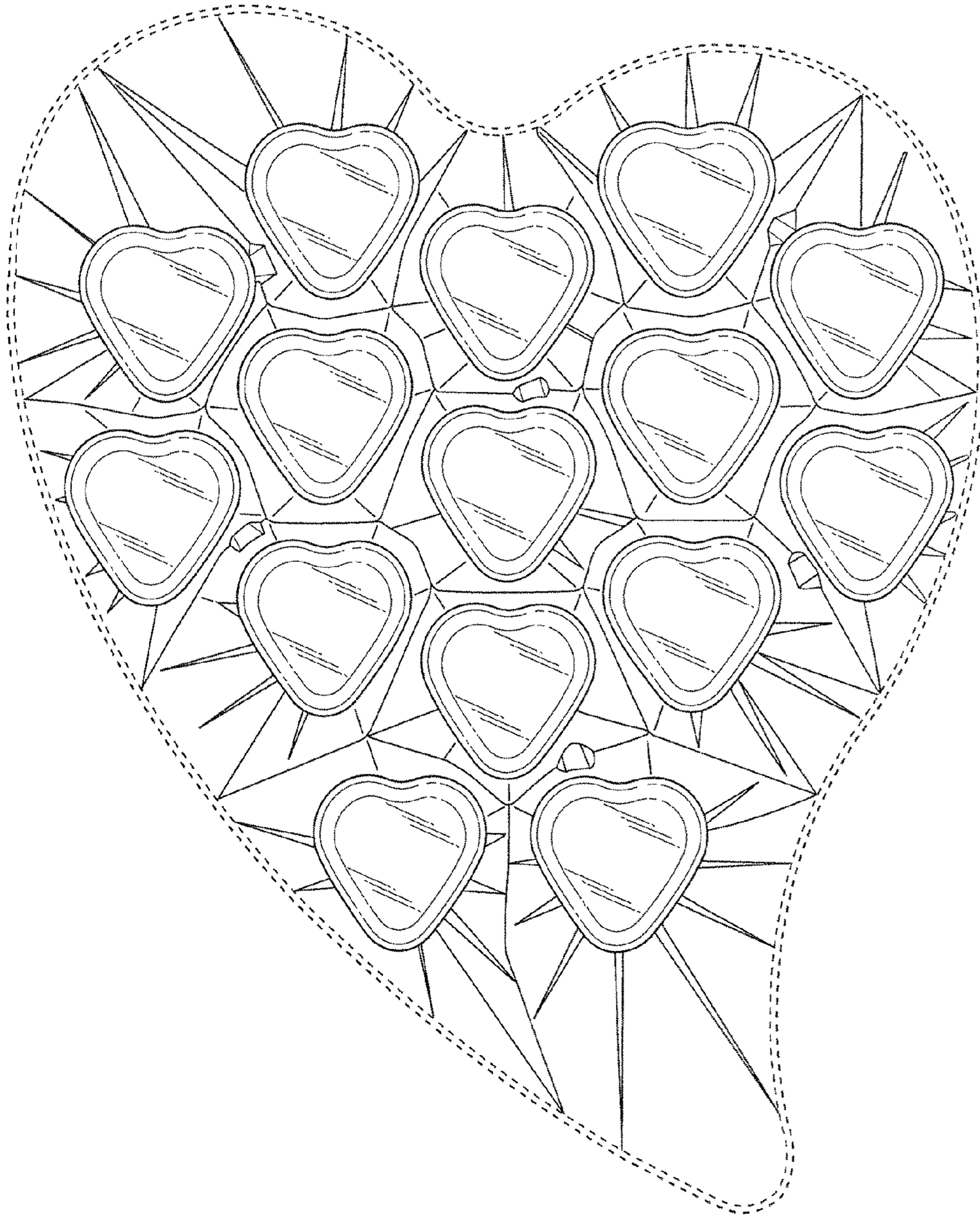

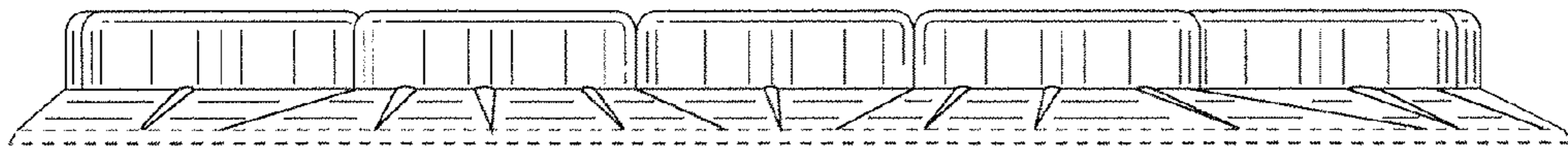

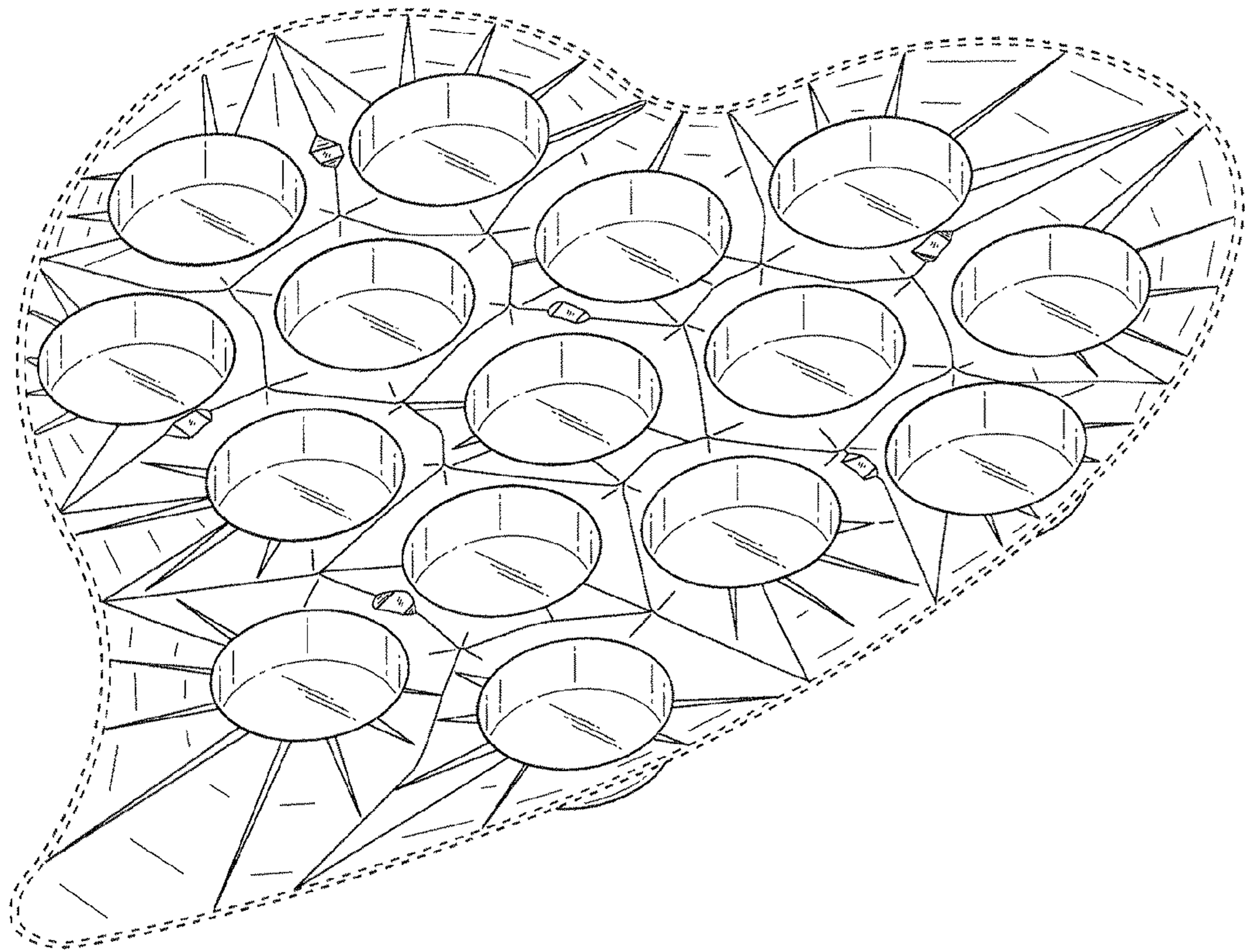

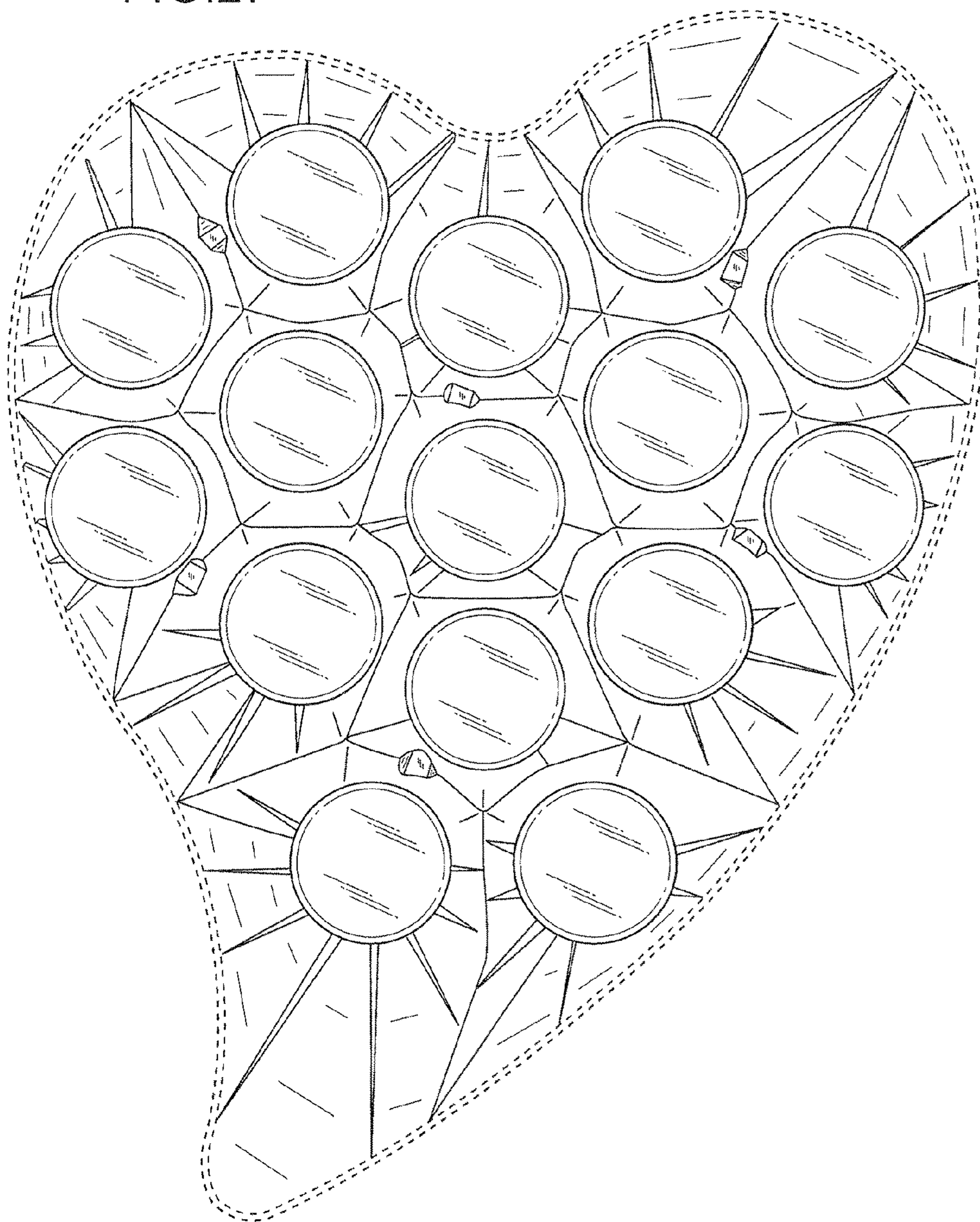

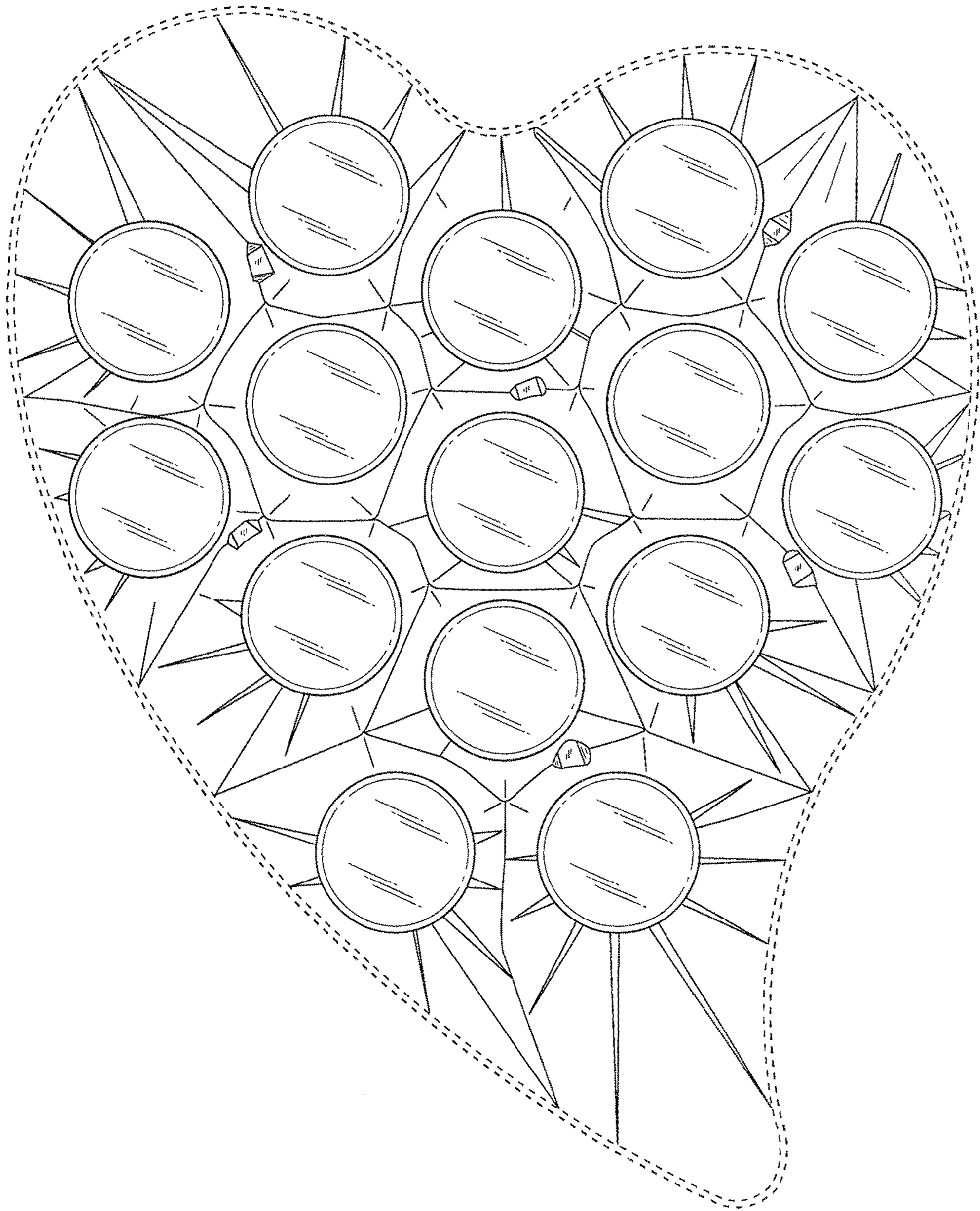

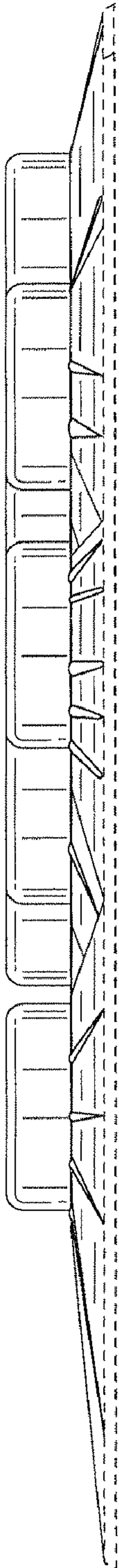

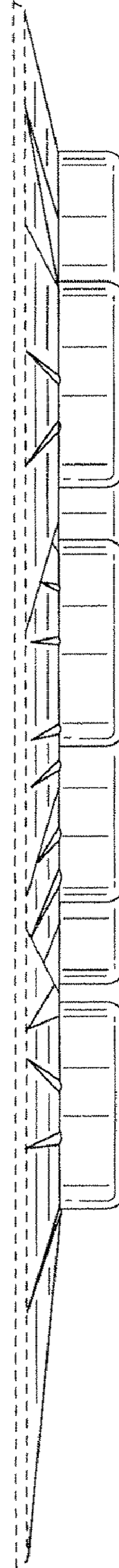

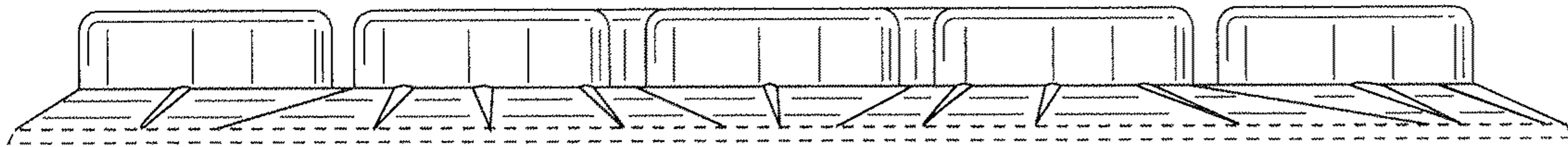

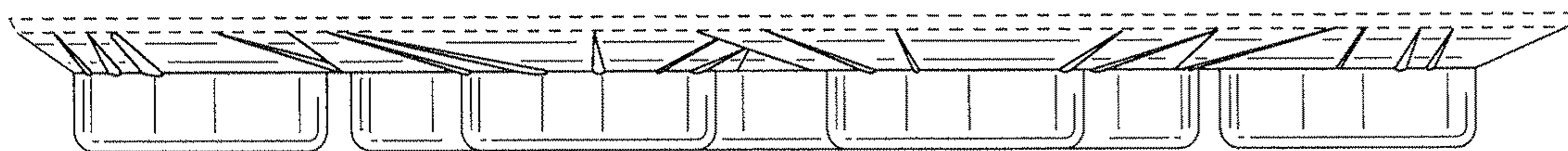

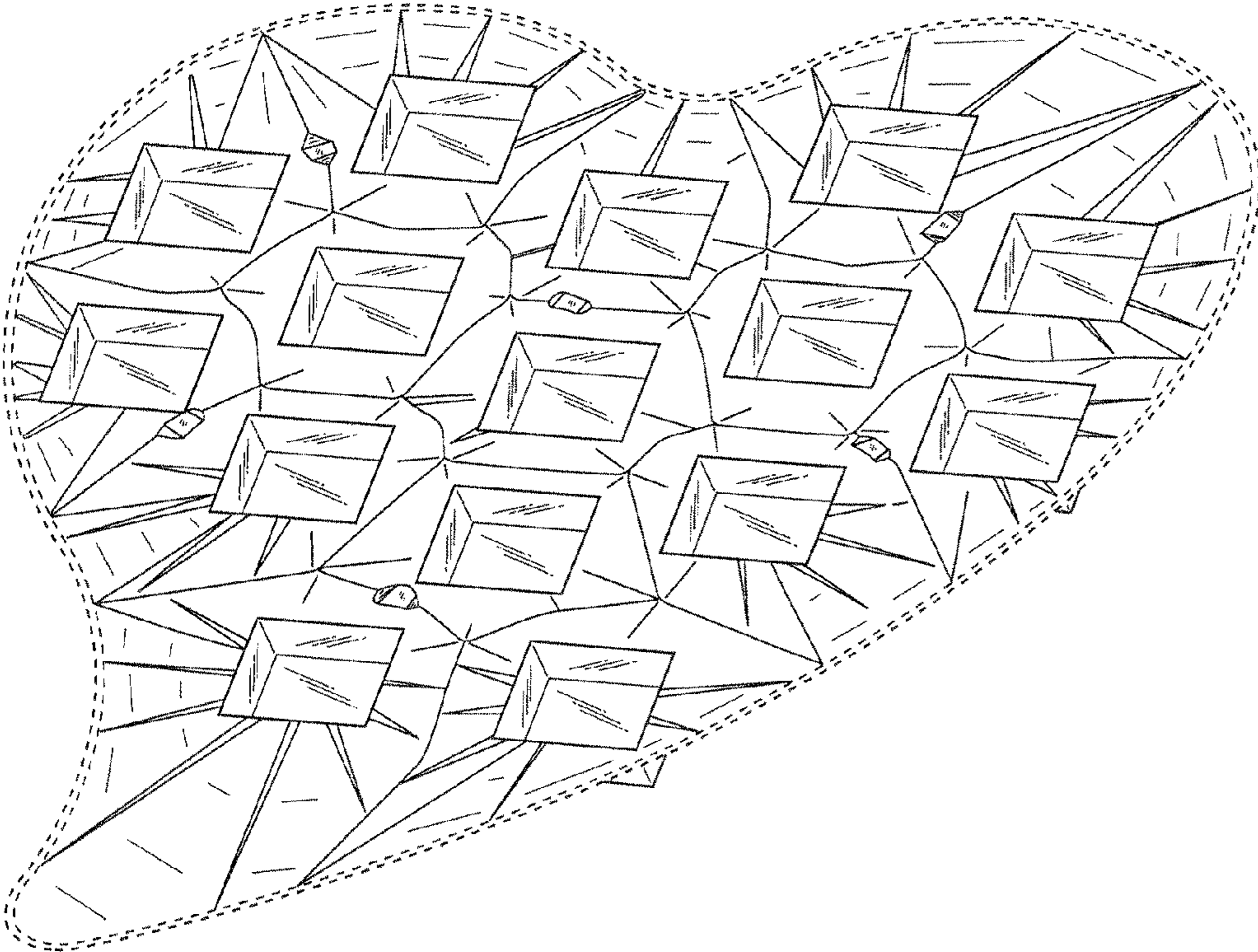

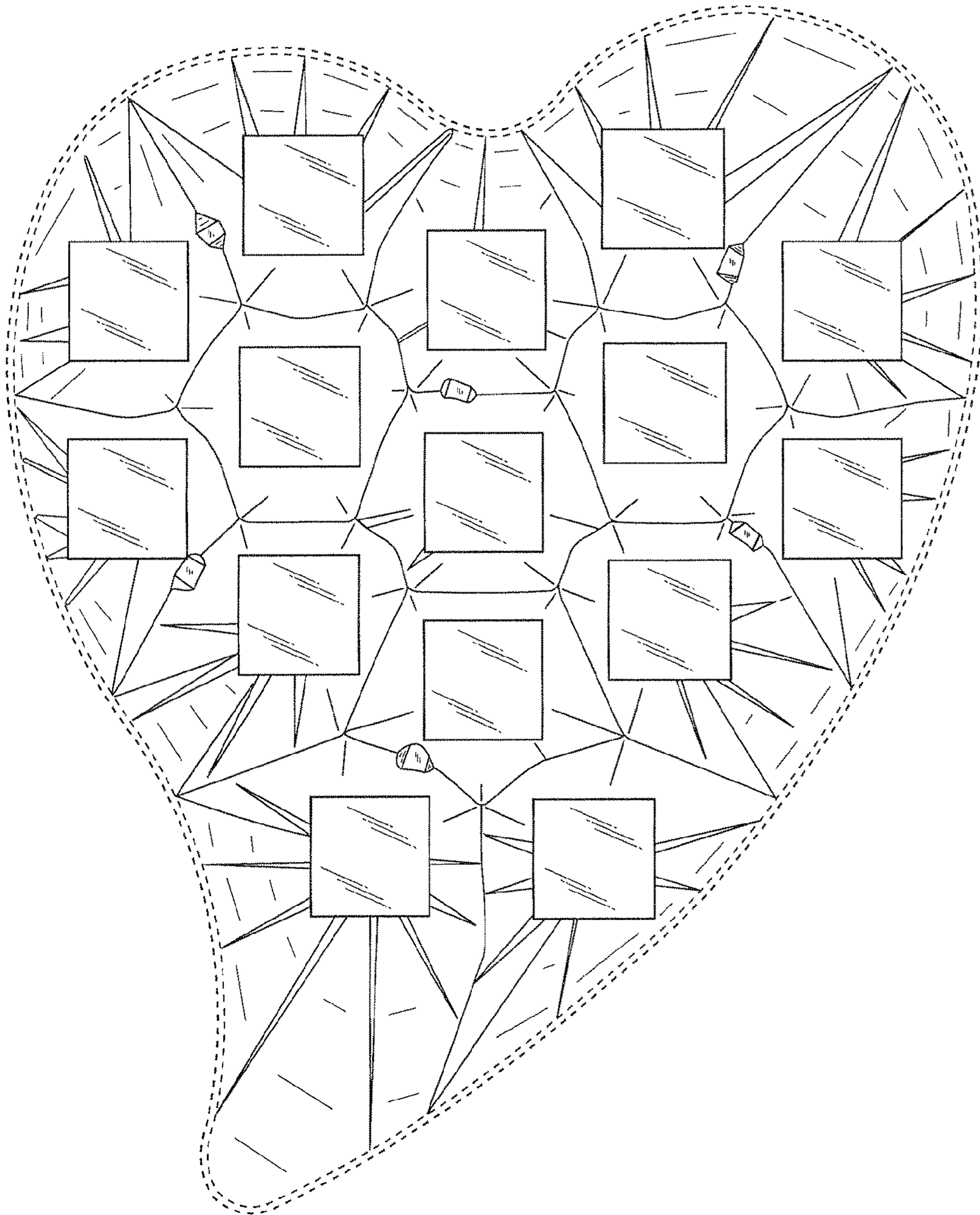

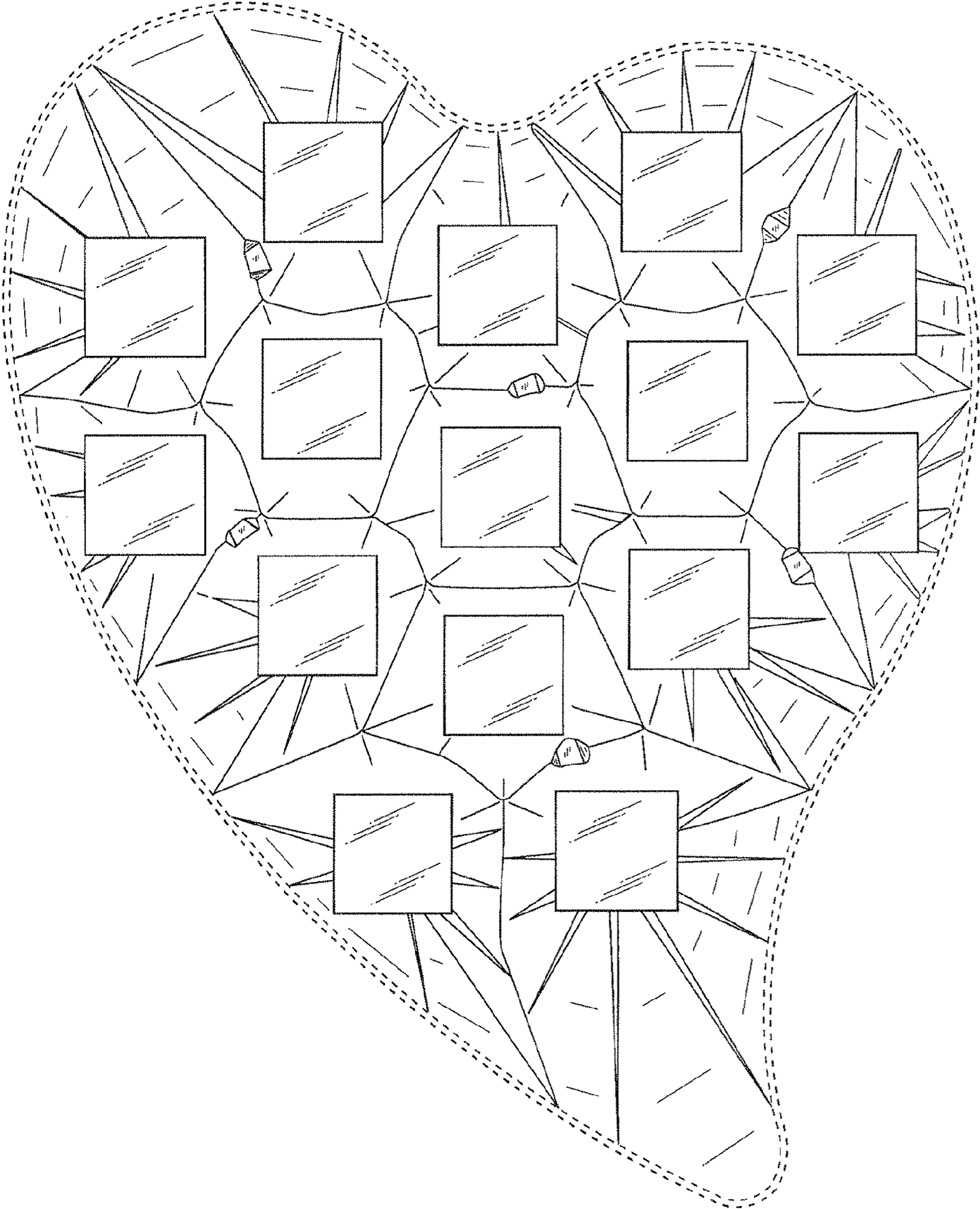

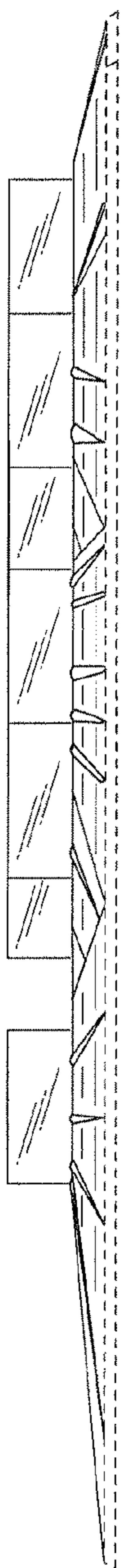

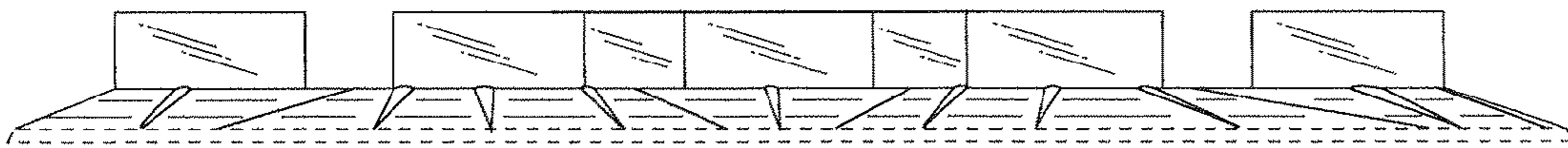
