(57) **CLAIM**

The ornamental design for an egg carton, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of an egg carton showing our new design with its lid in an open position;

FIG. 2 is a top plan view of the egg carton shown in FIG. 1 with its lid in an open position;

FIG. 3 is a rear elevational view of the egg carton shown in FIG. 1 with its lid in an open position;

FIG. 4 is a bottom plan view of the egg carton shown in FIG. 1 with its lid in an open position;

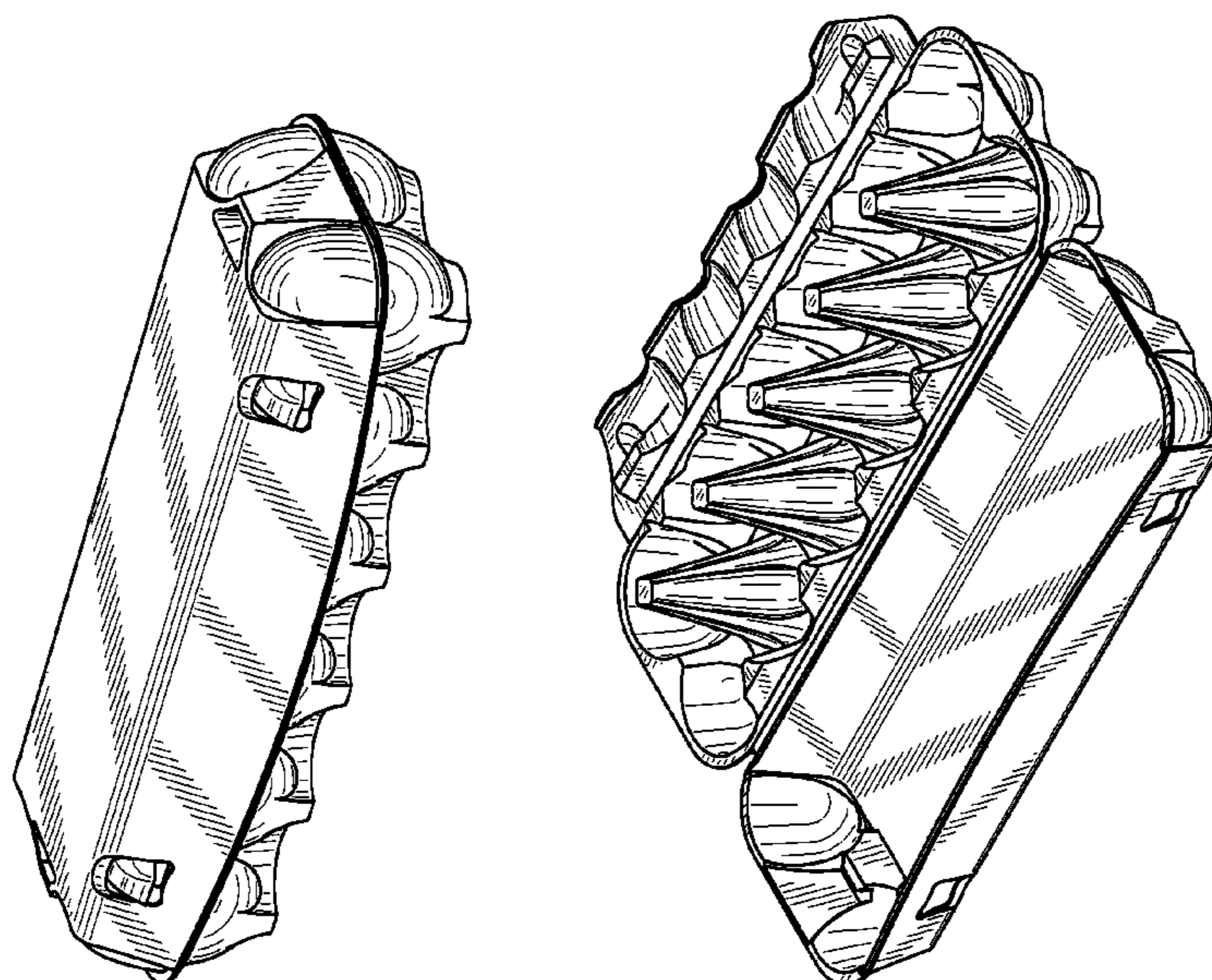
FIG. 5 is a top perspective view of the egg carton shown in FIG. 1 with its lid in a closed position;

FIG. 6 is a front elevational view of the egg carton shown in FIG. 1 with its lid in an open position; and,

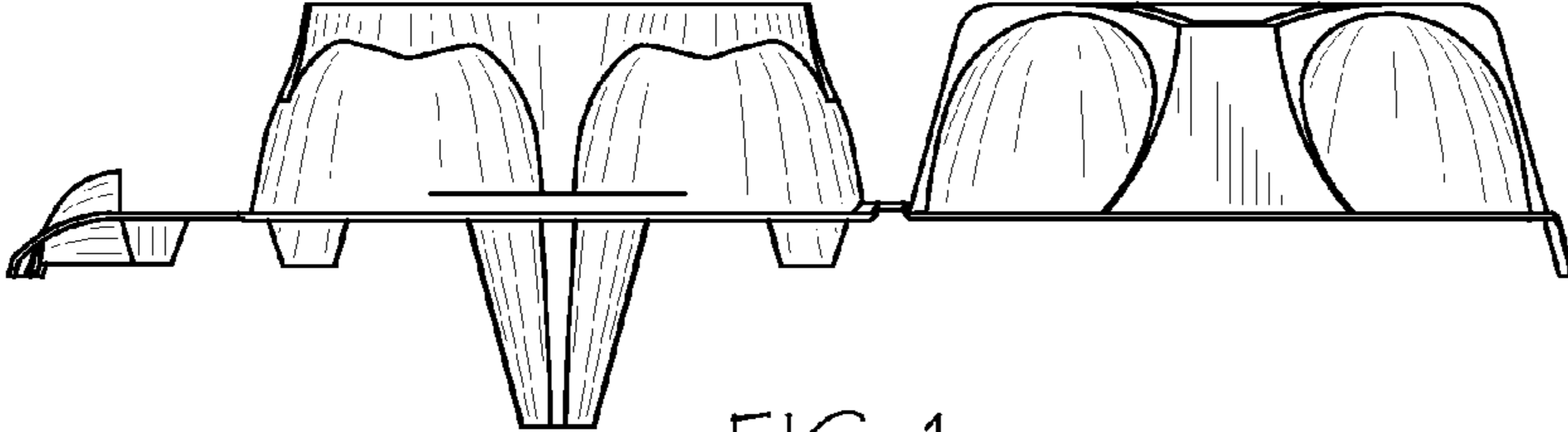

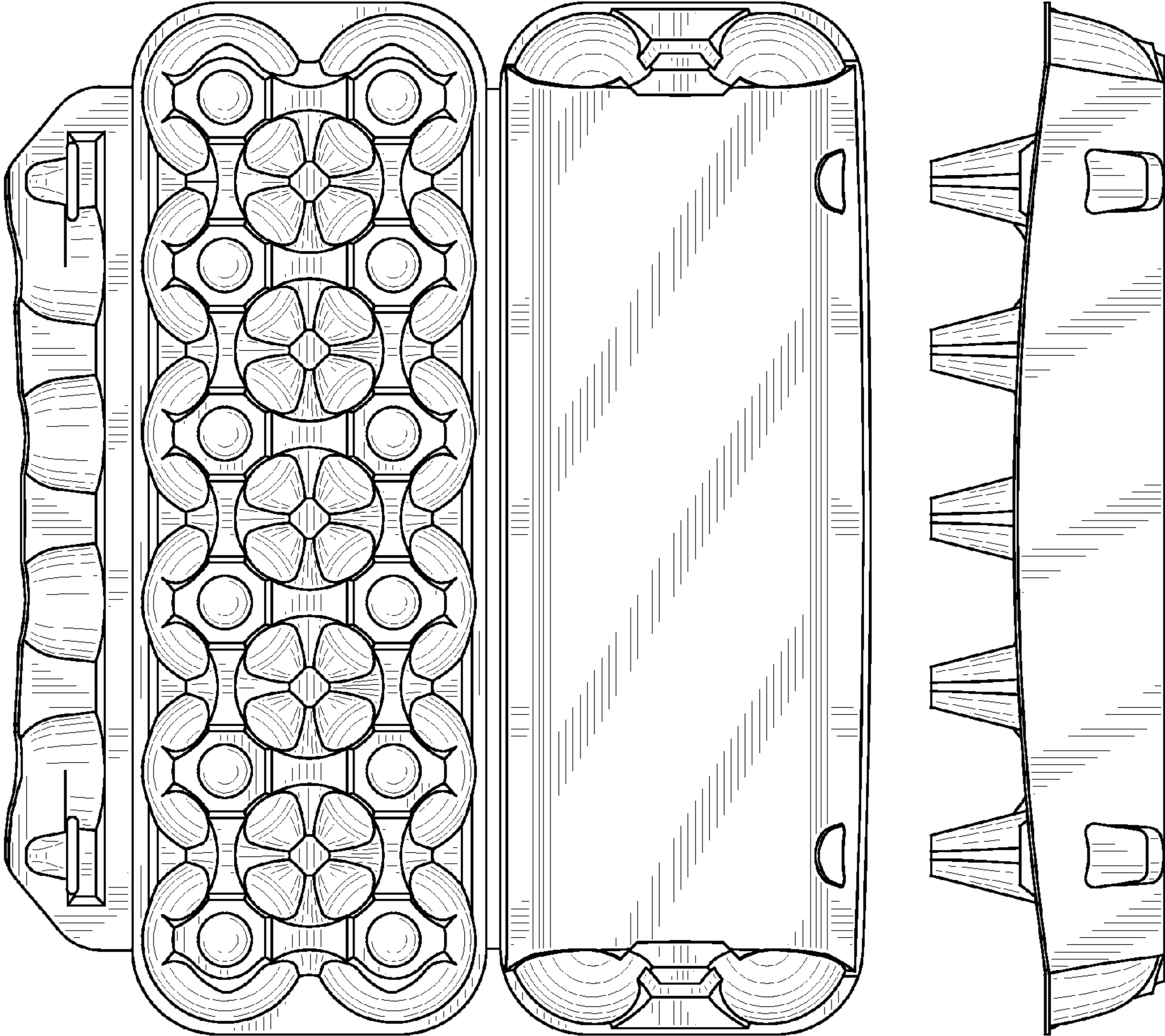

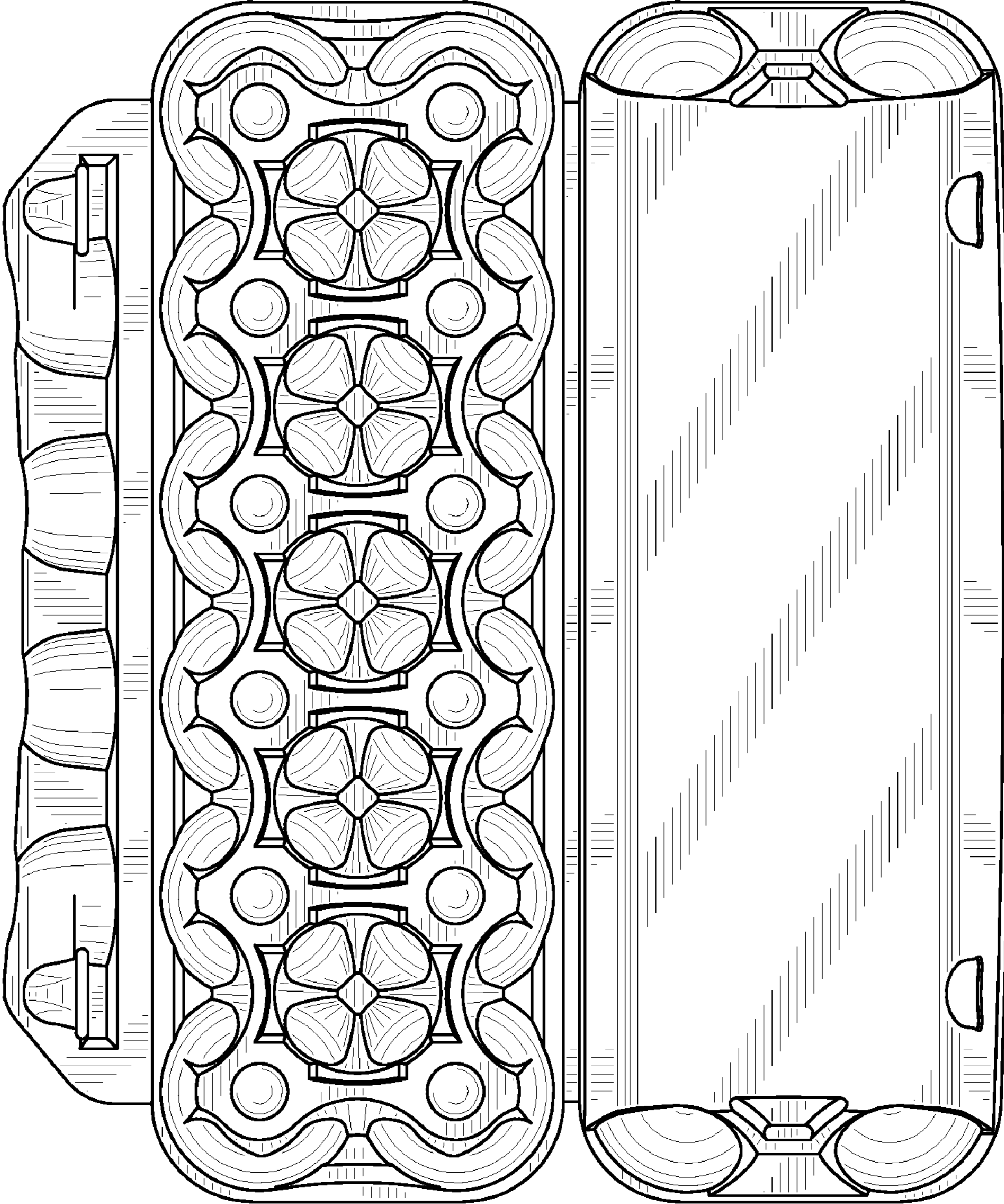

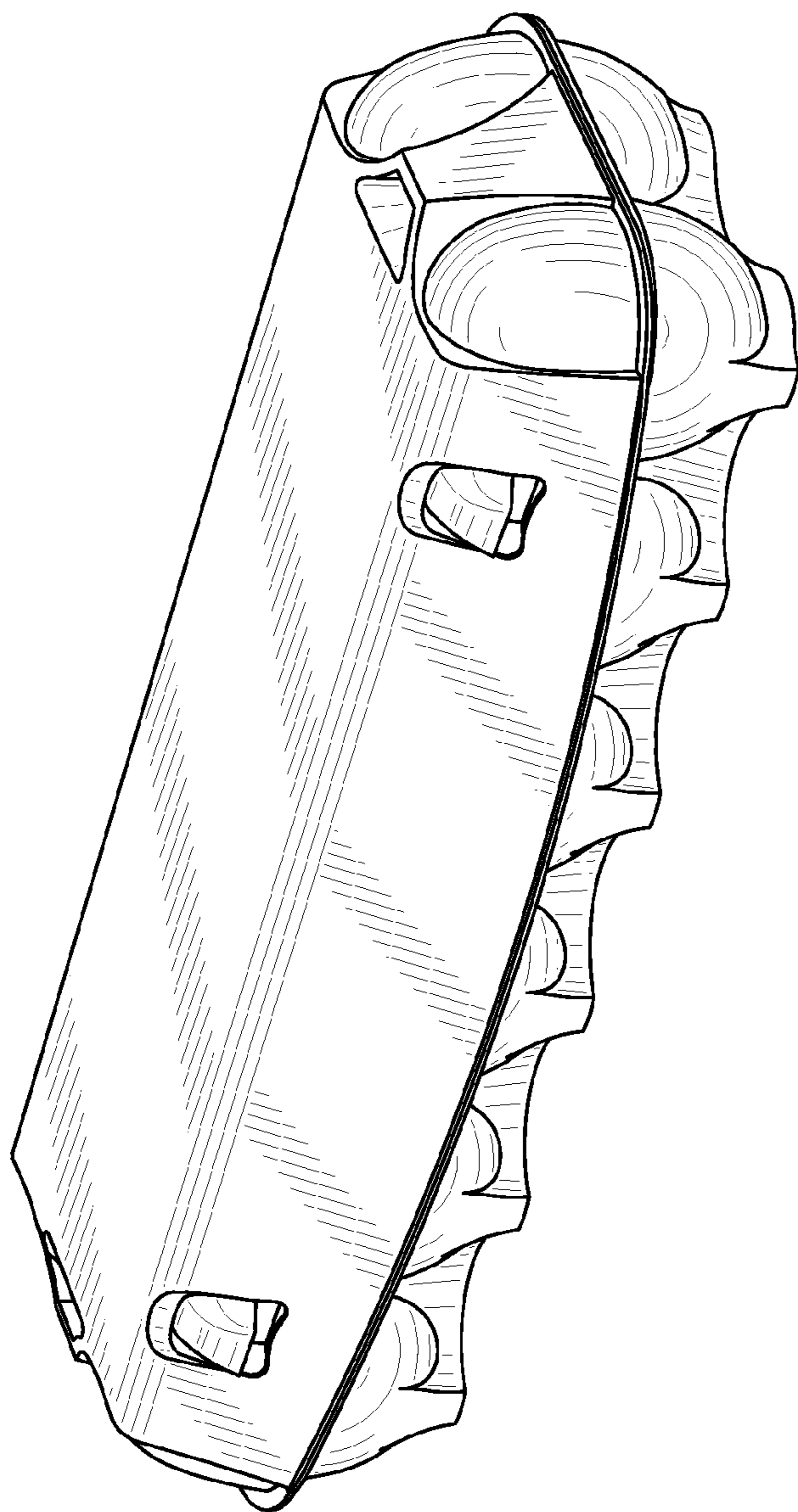

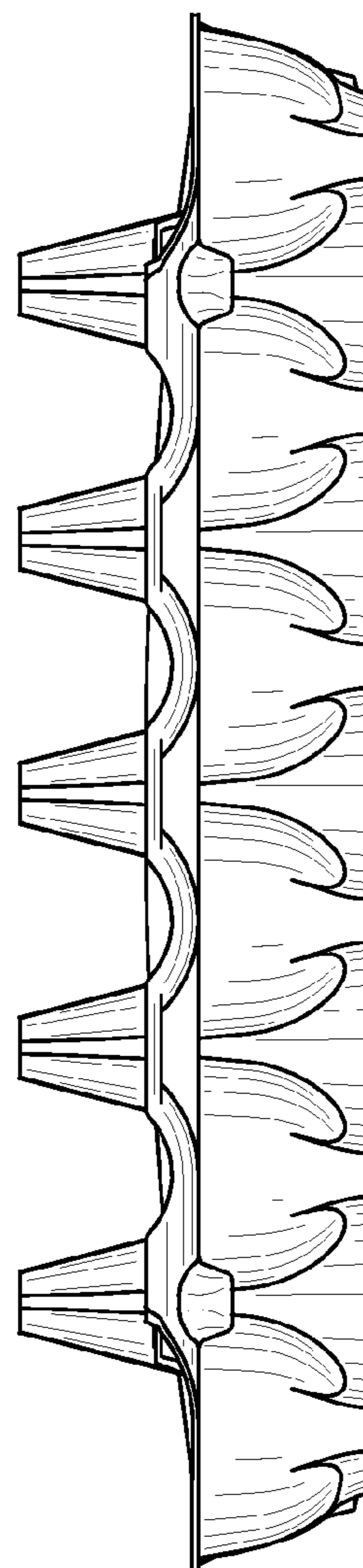

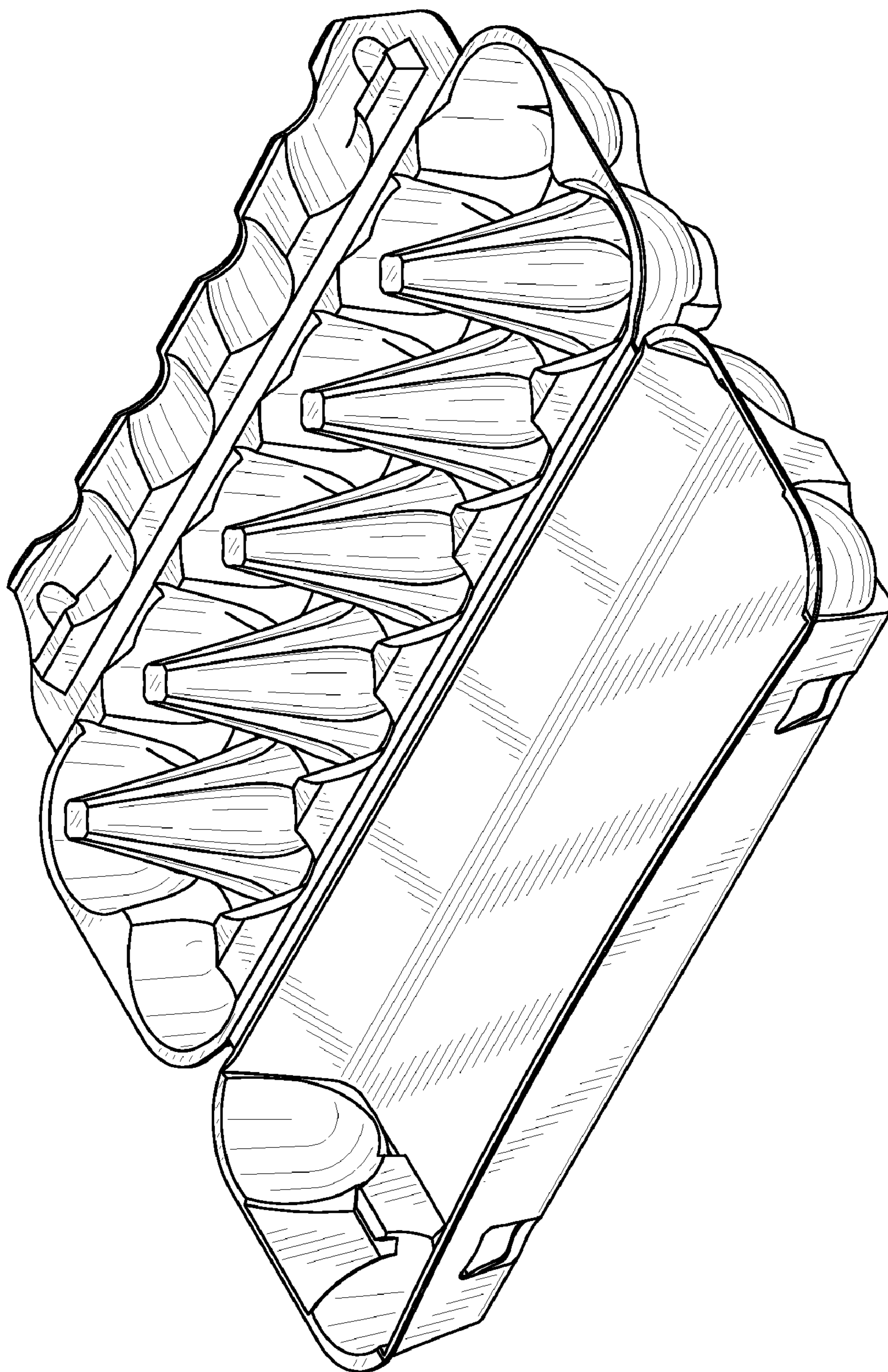
