FIG. 1 is a front view of the golf ball dog statue.

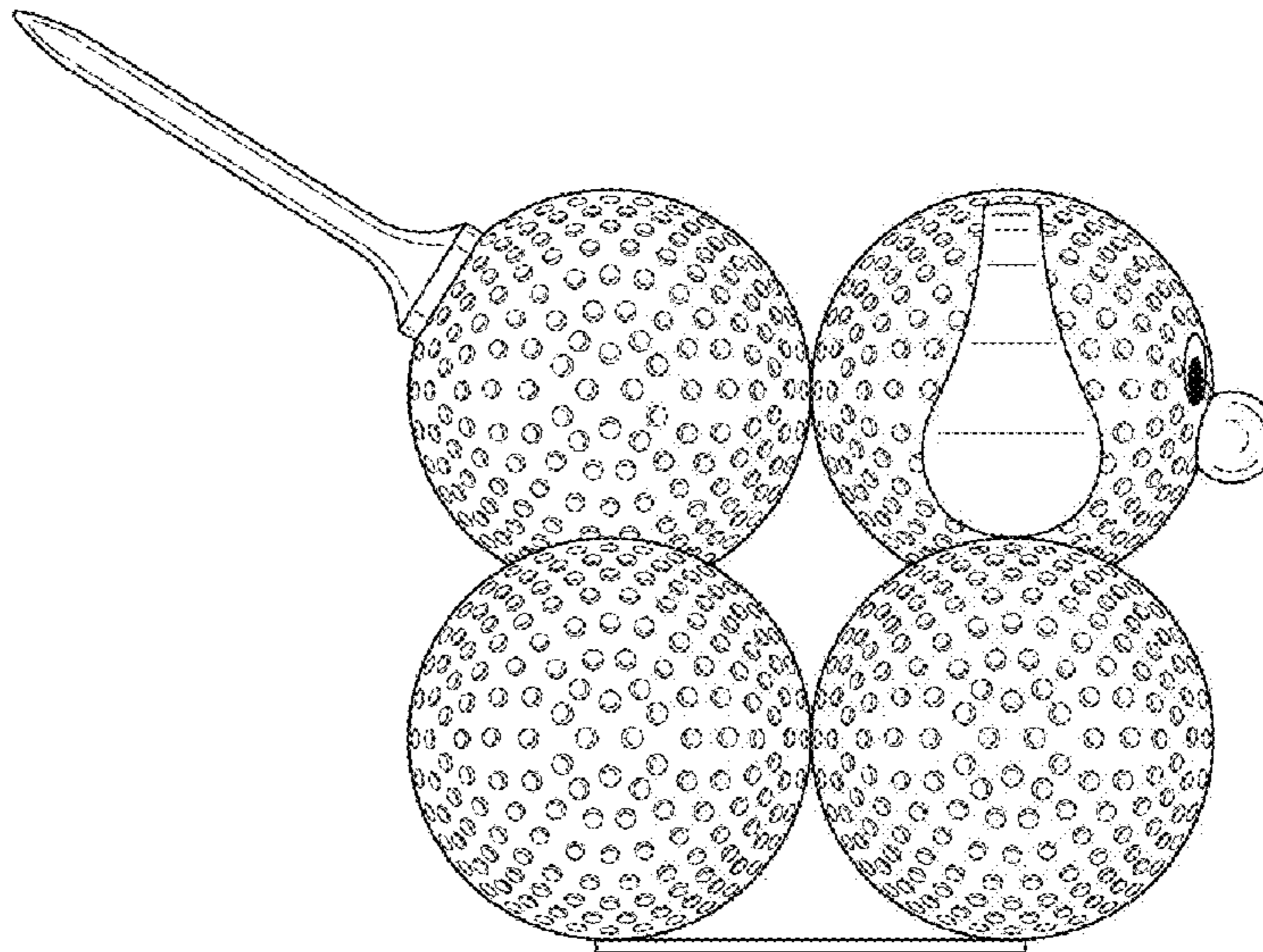
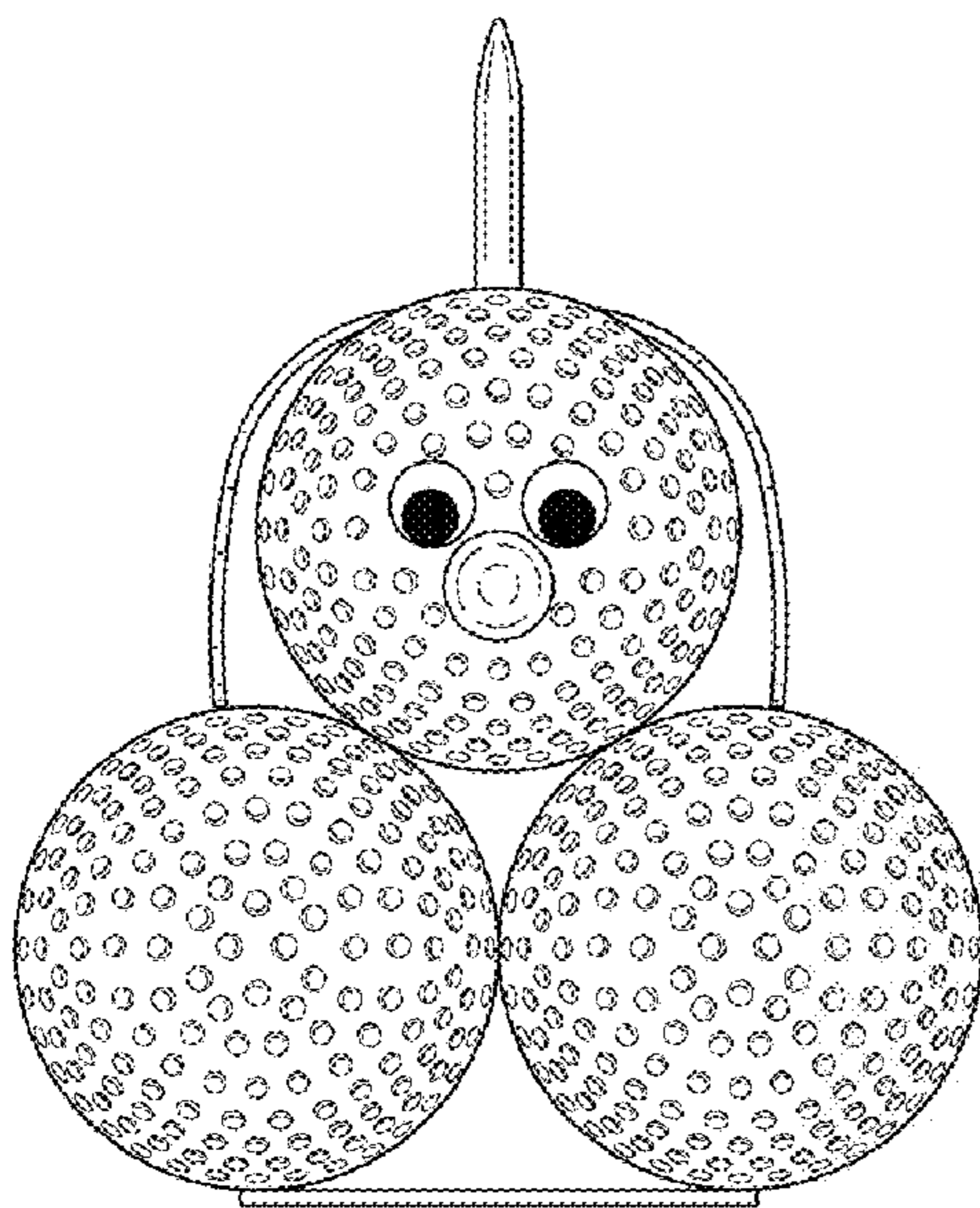
FIG. 2 is a rear view of the claimed design.

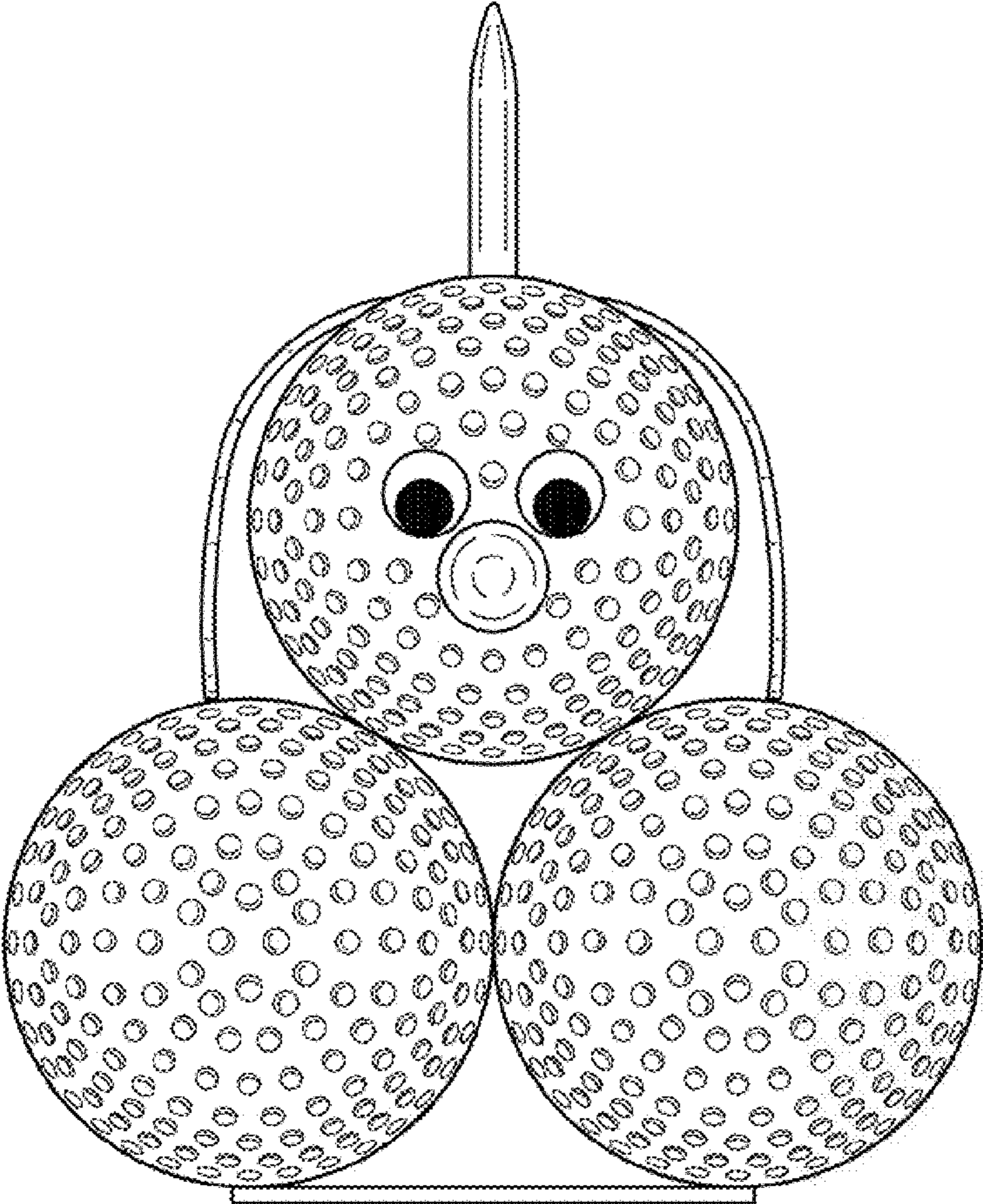

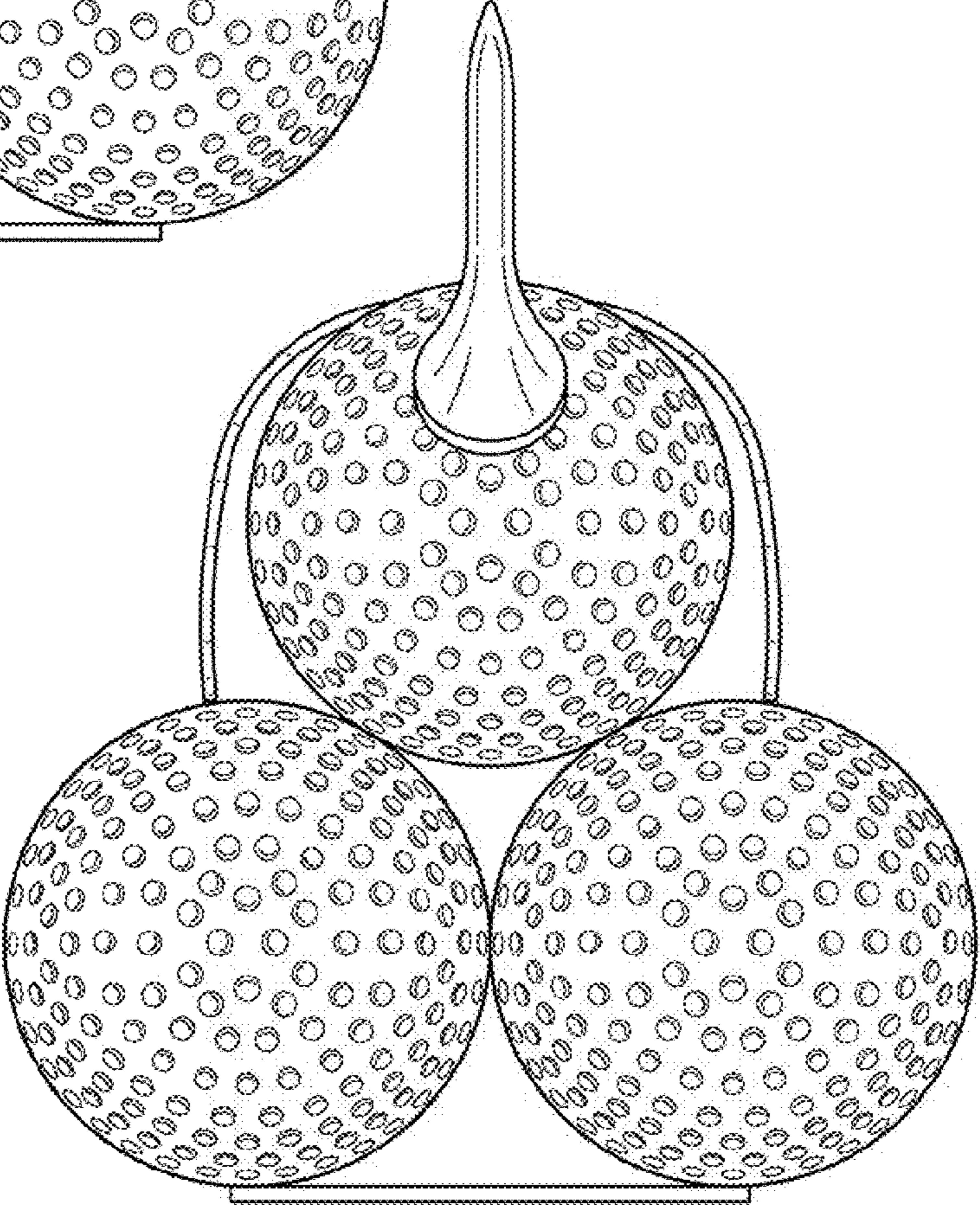

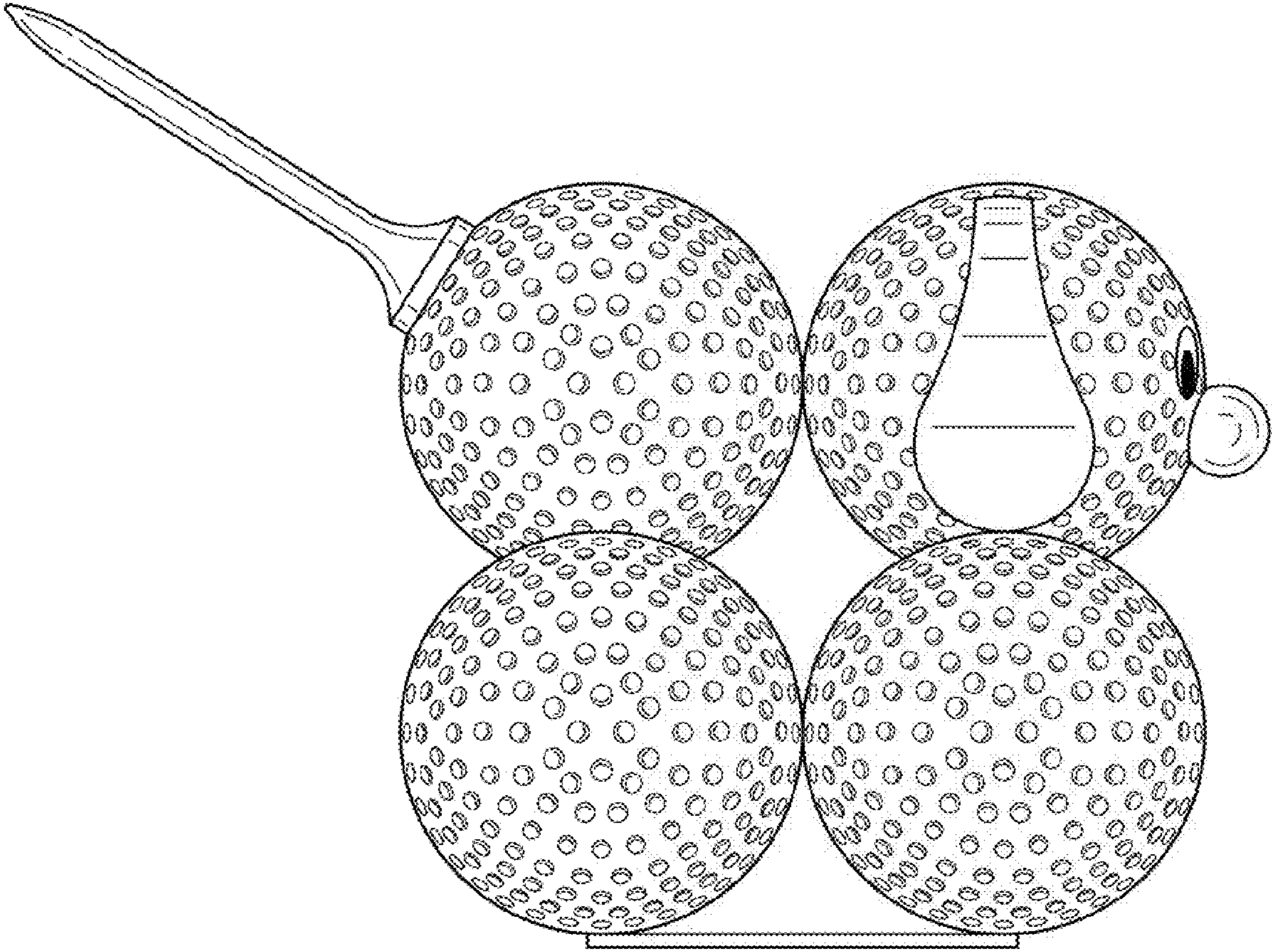

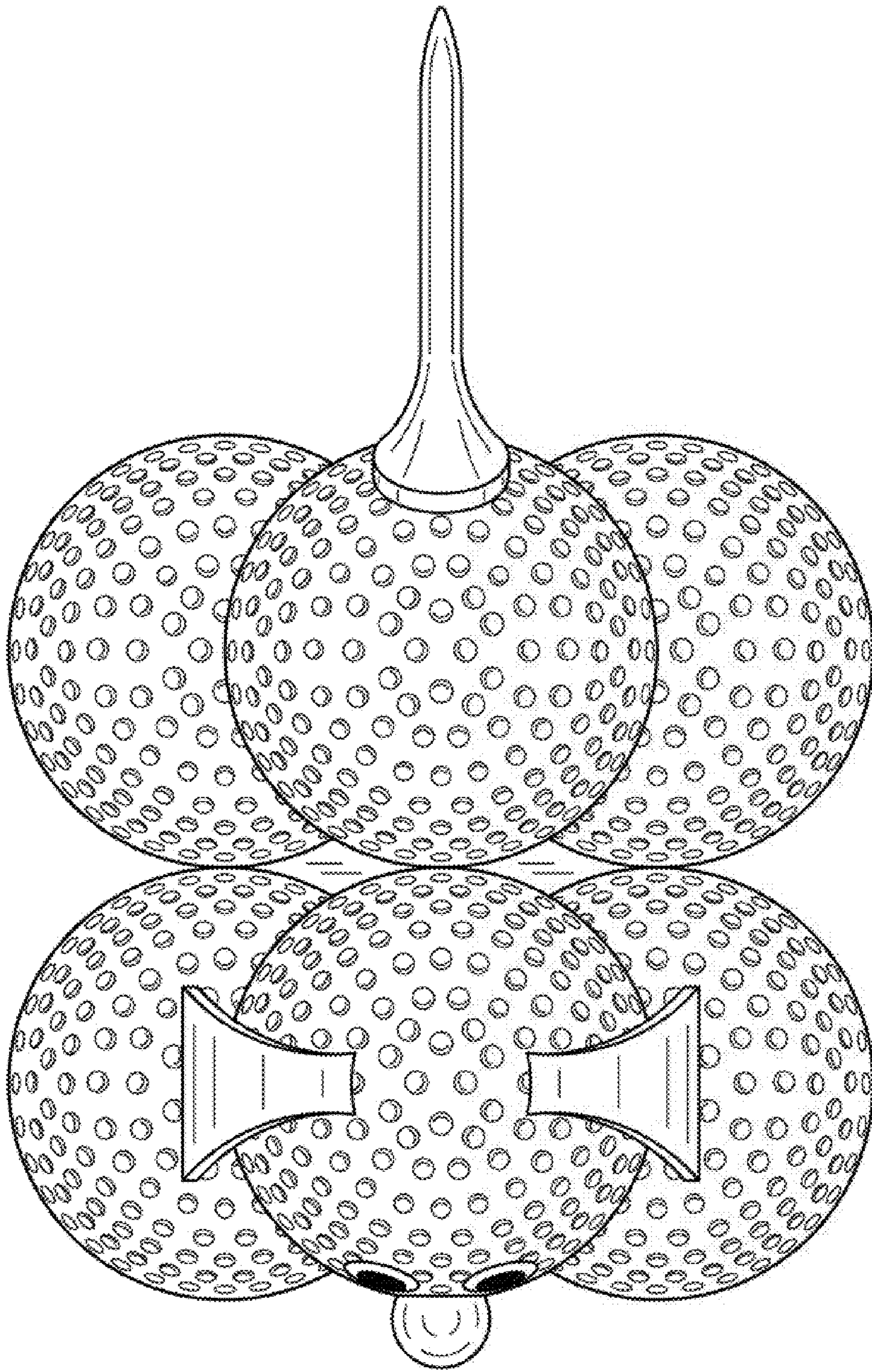

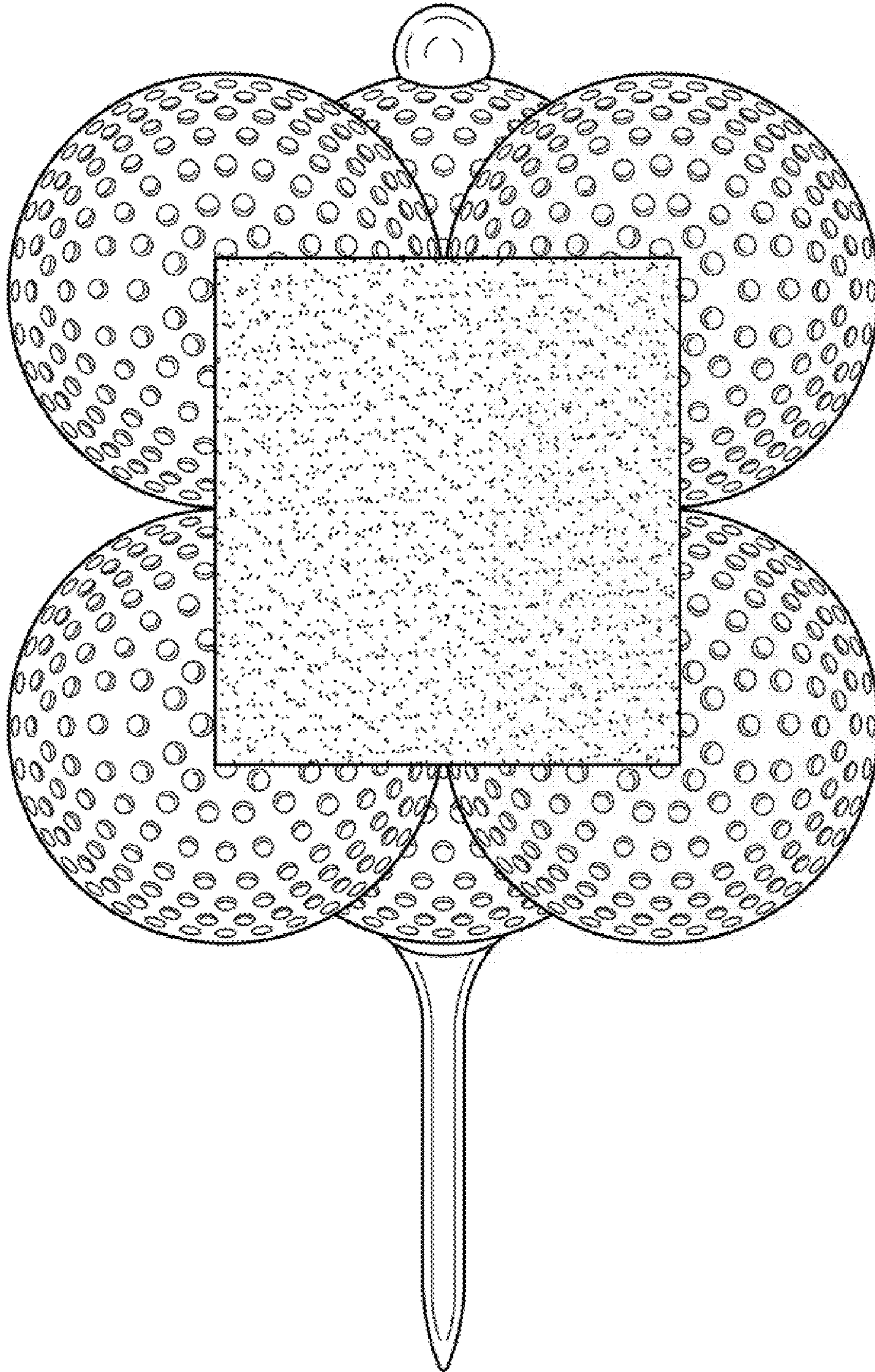
