DESCRIPTION

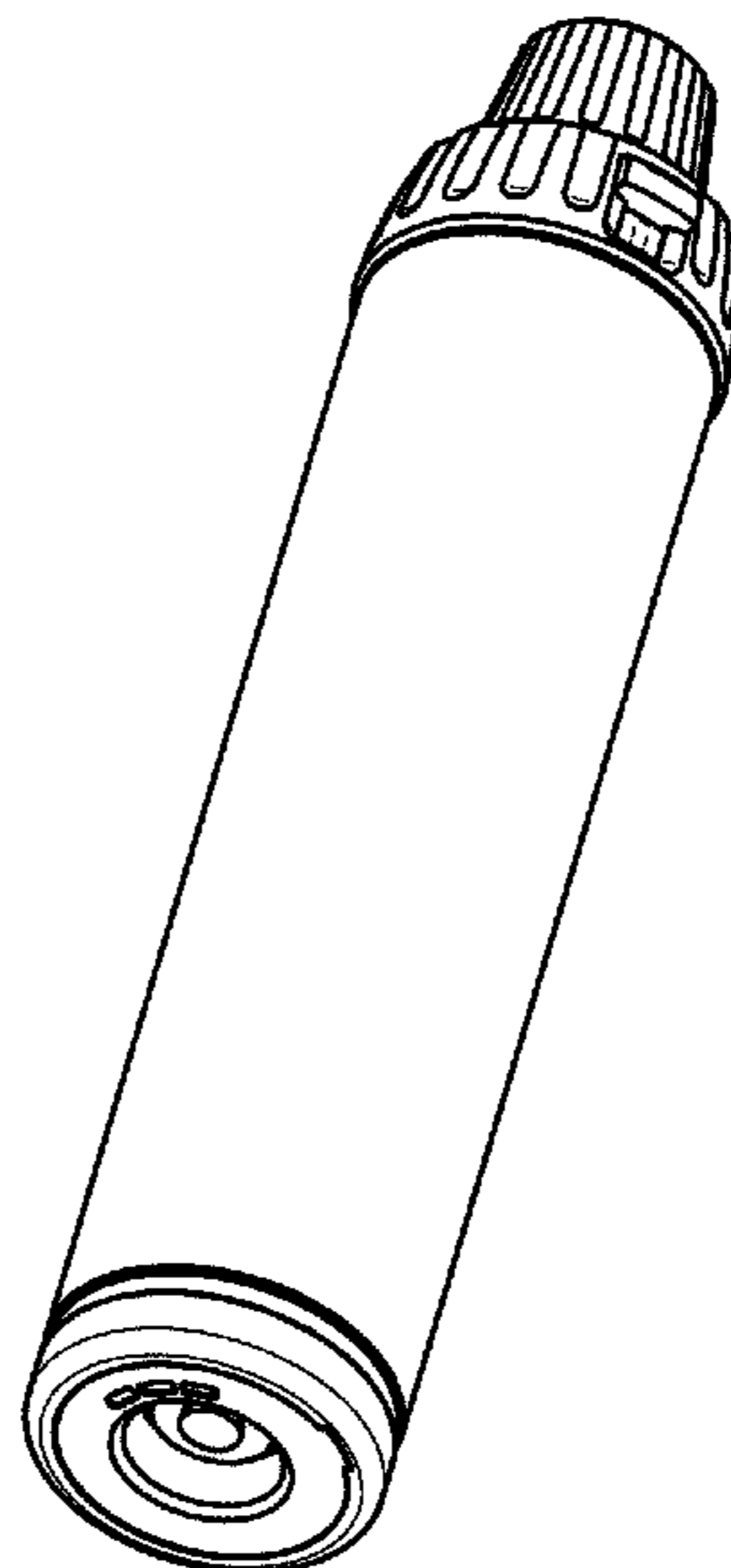
FIG. 1 shows a top plan view of the rechargeable battery handle for diagnostic instruments;

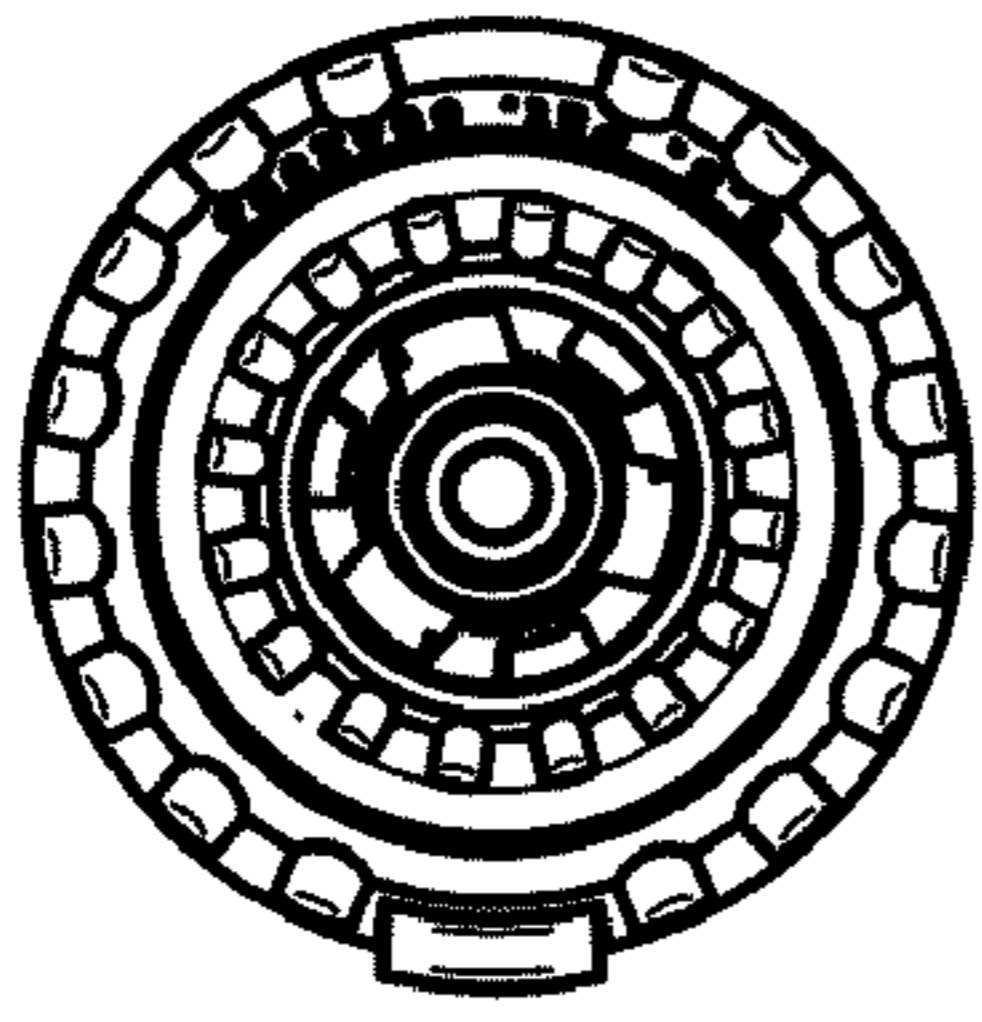

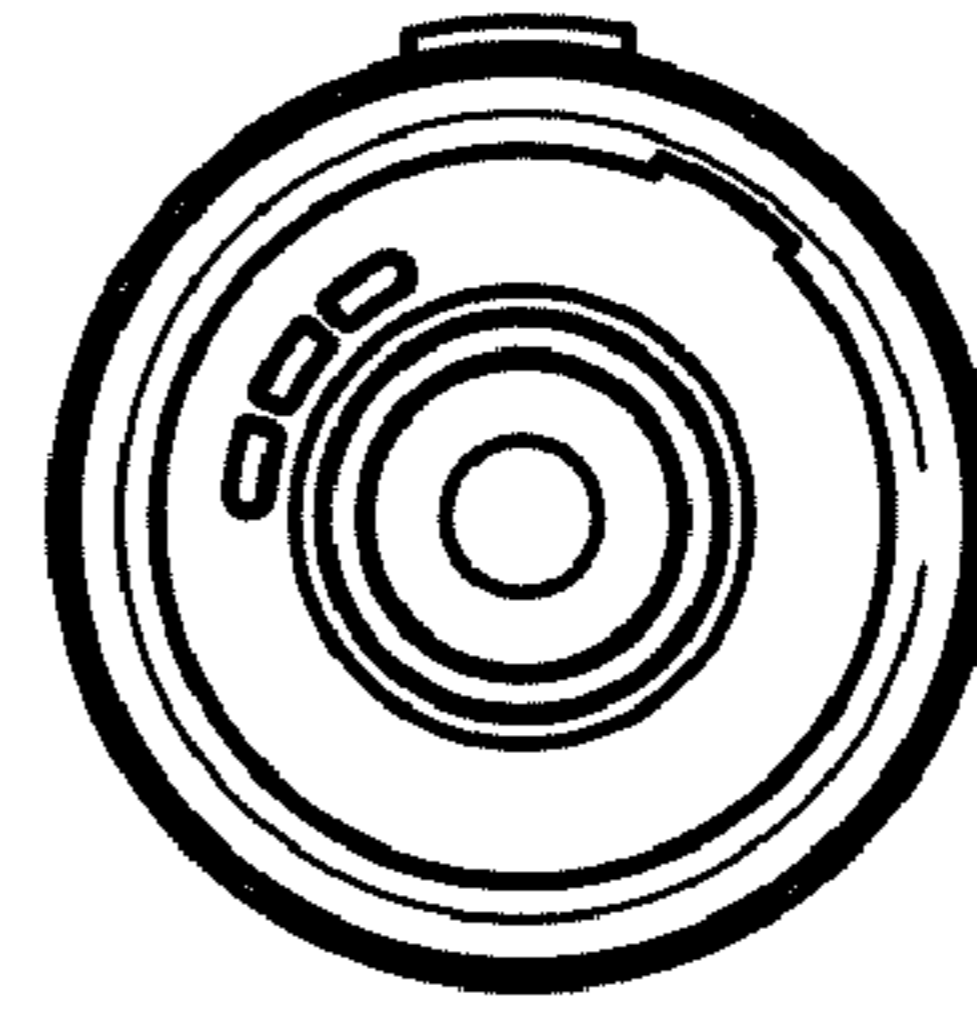

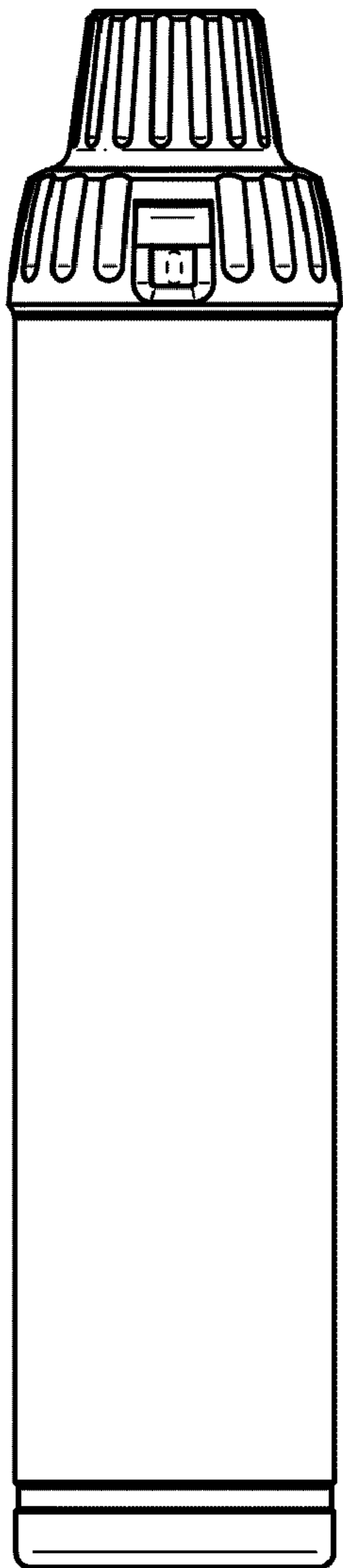

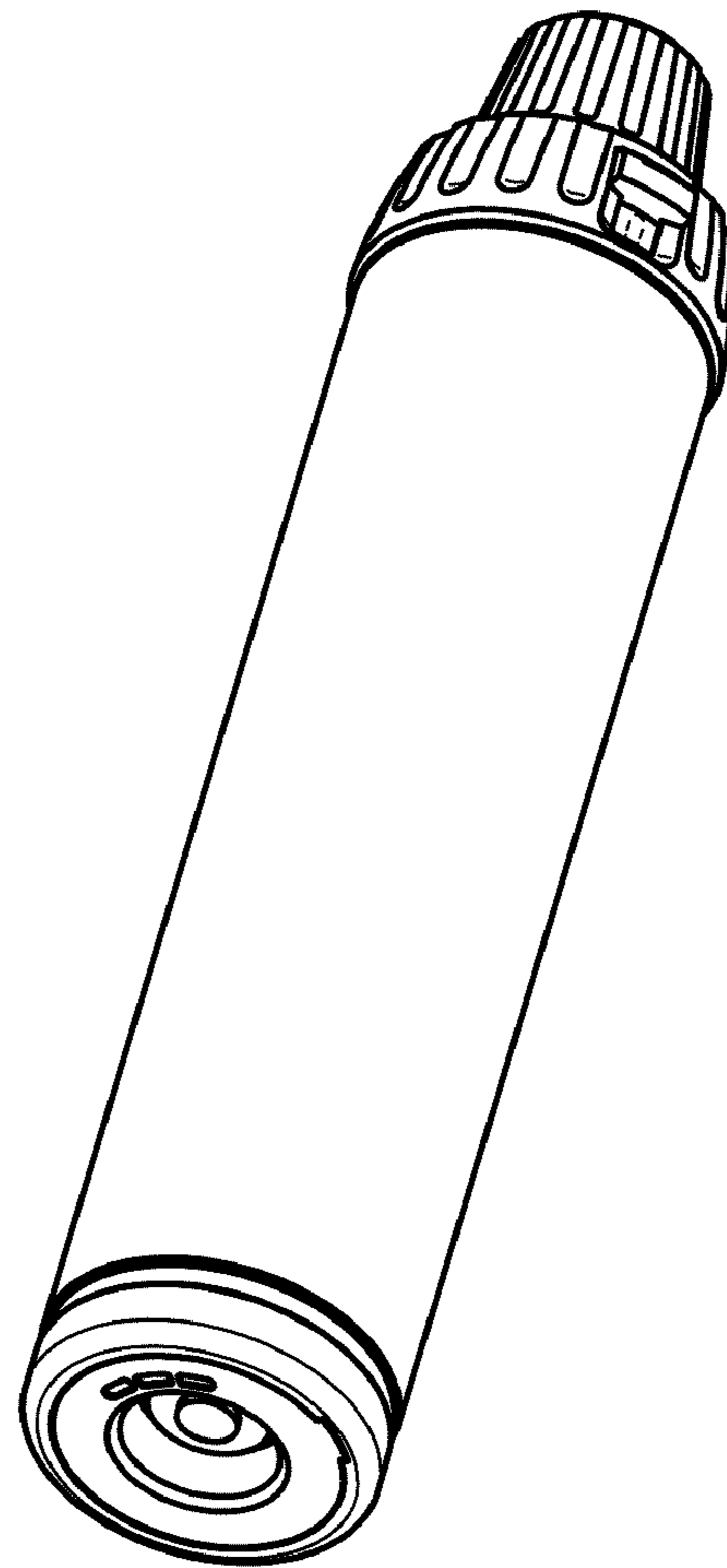
