(57) **CLAIM**

The ornamental design for a digital audio disc player with tuner and amplifier for automobile, as shown and described.

FIG. 5 is a left side view thereof;

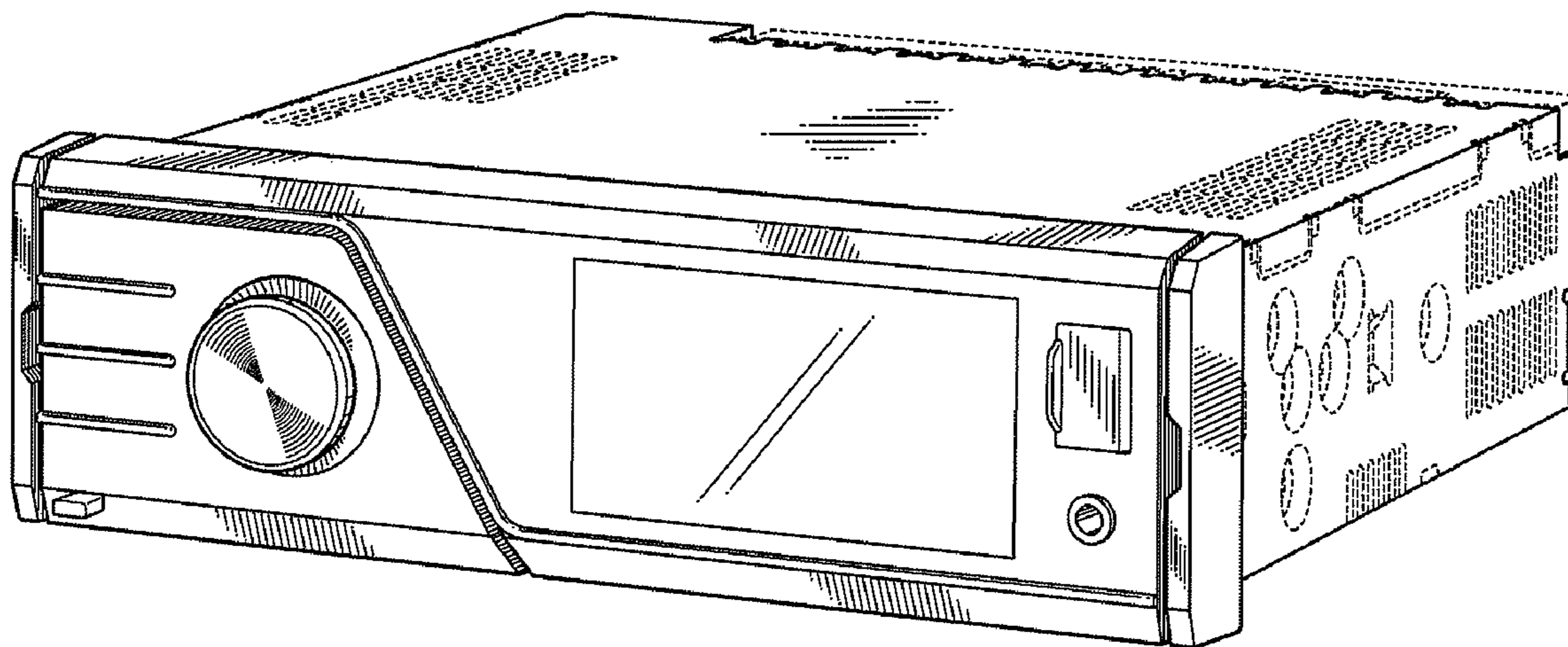
FIG. 6 is a right side view thereof;

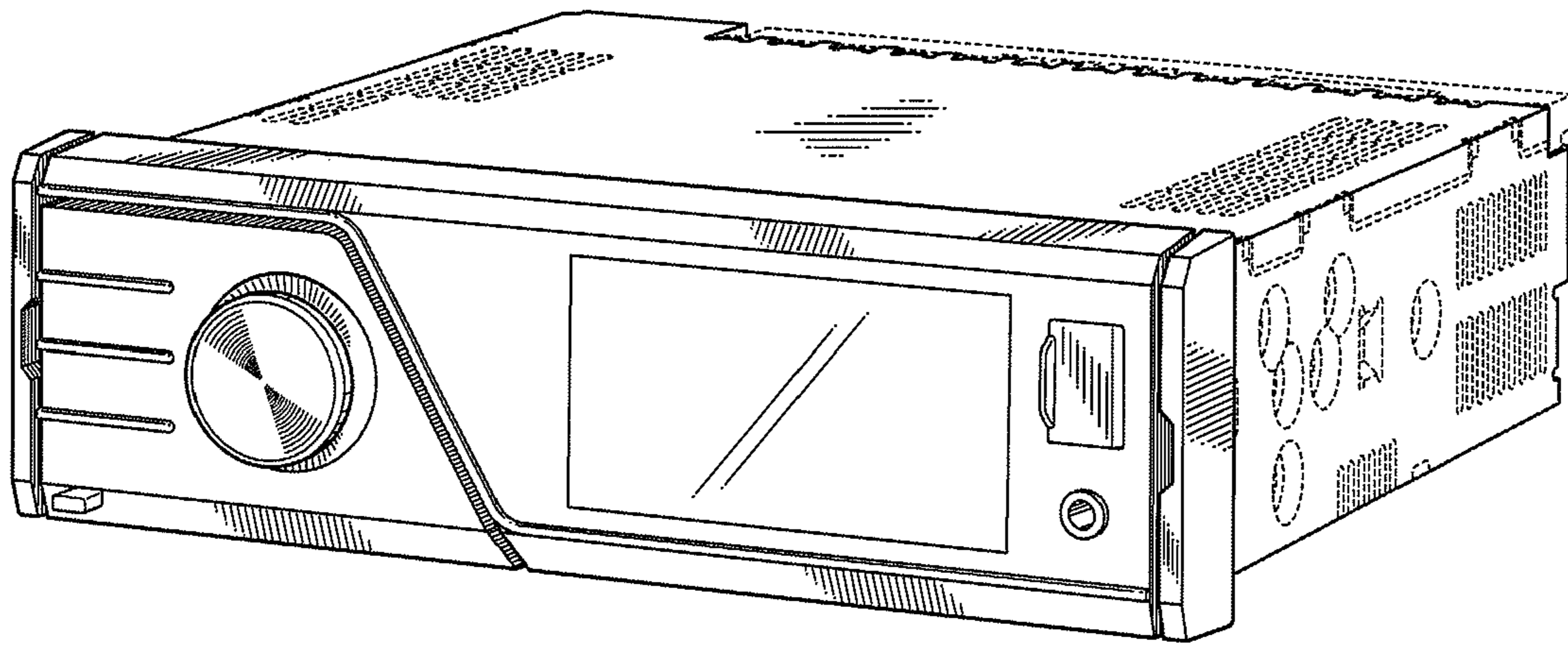

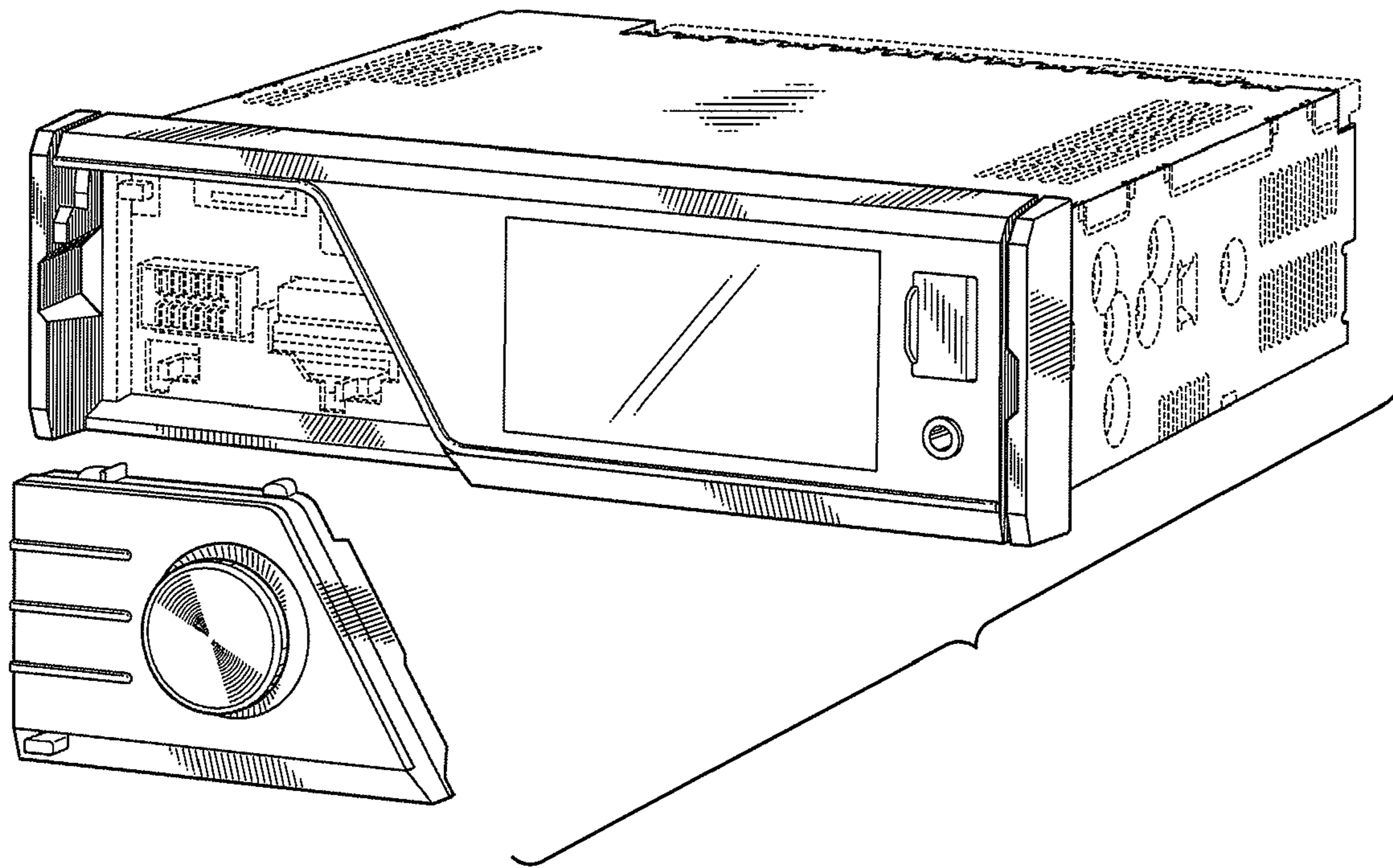

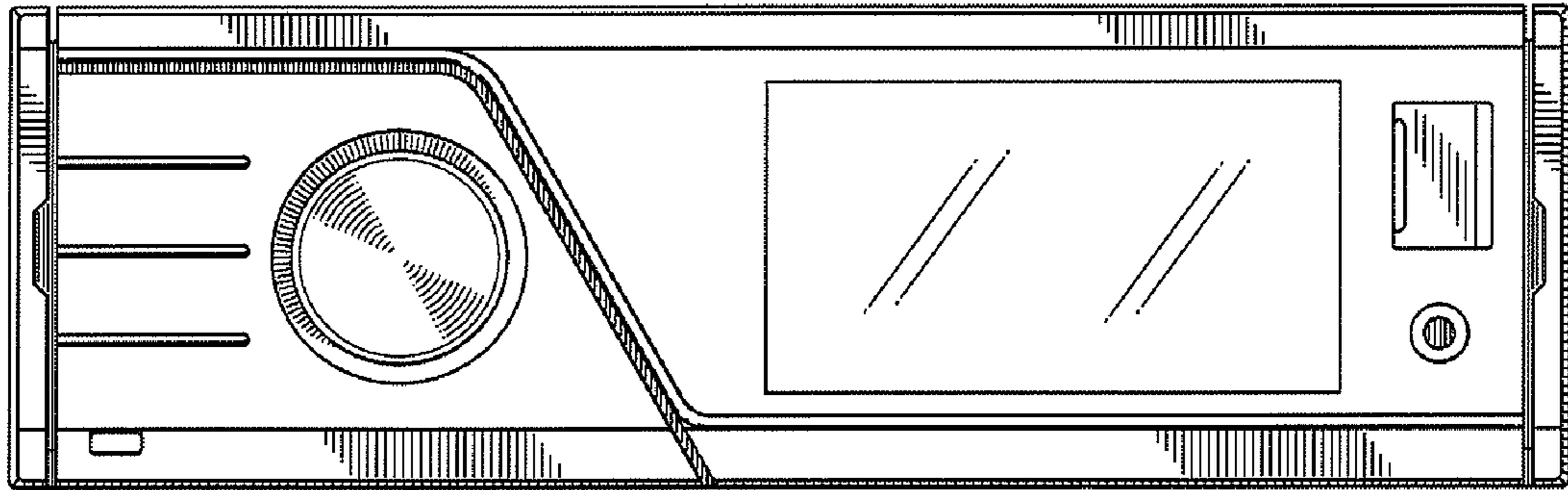

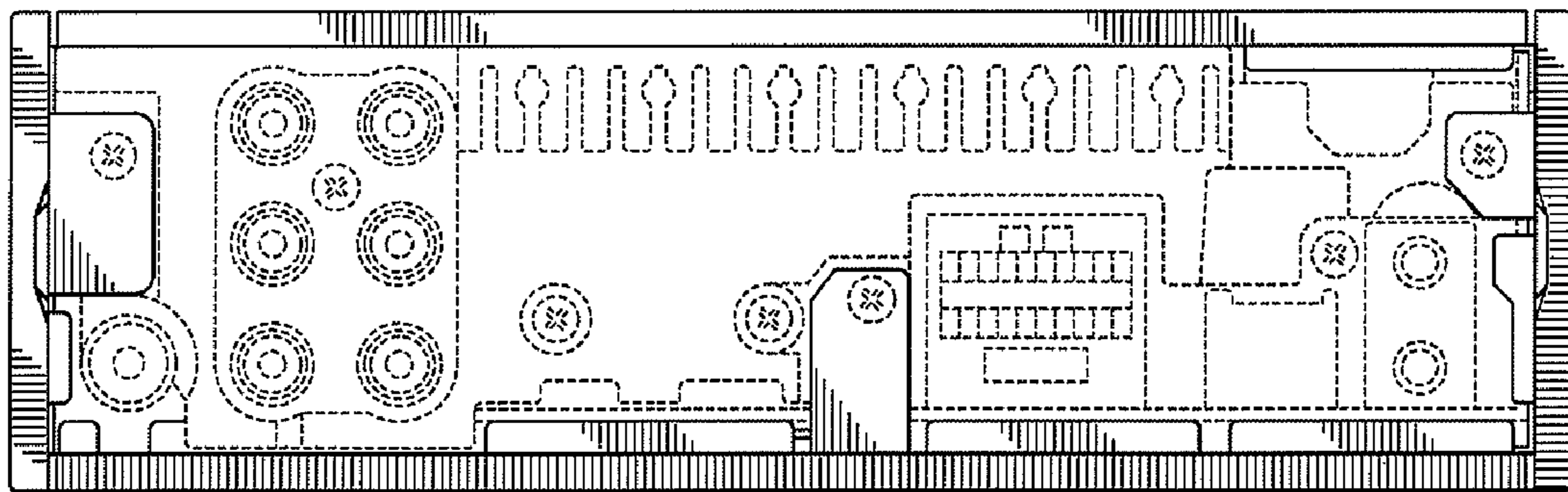

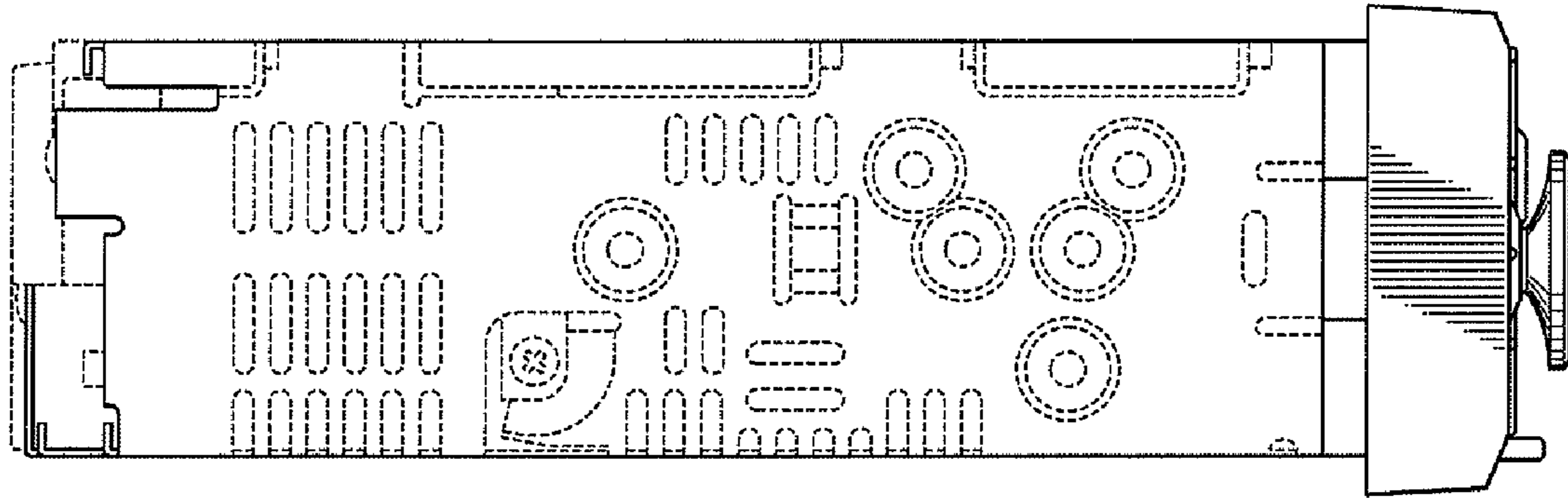

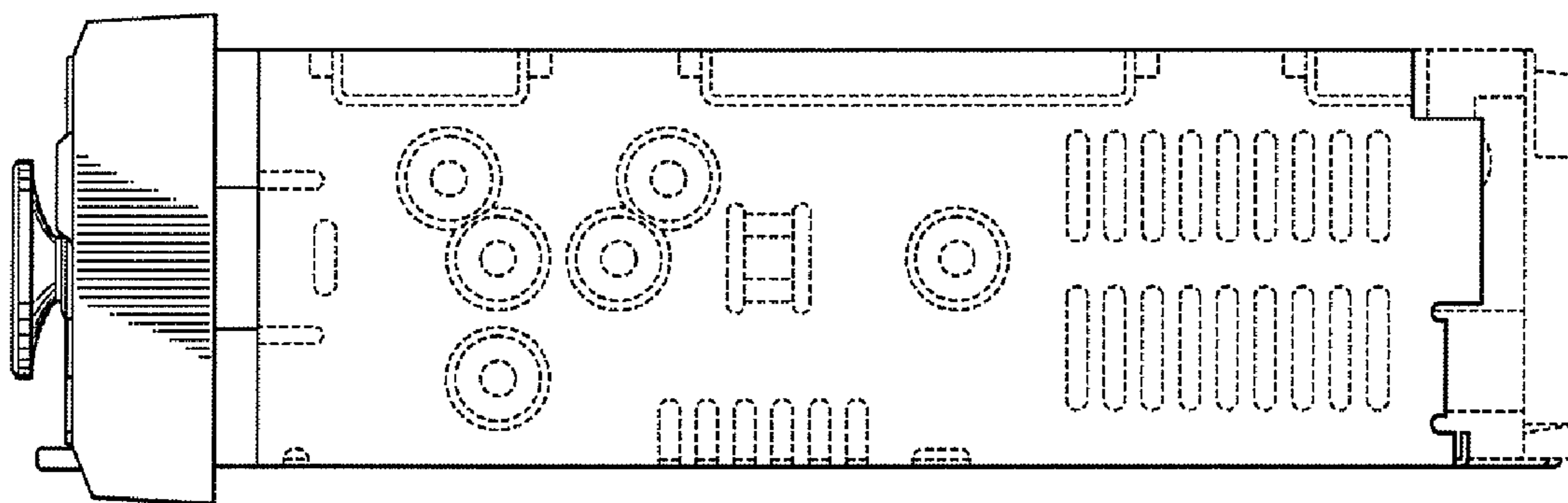

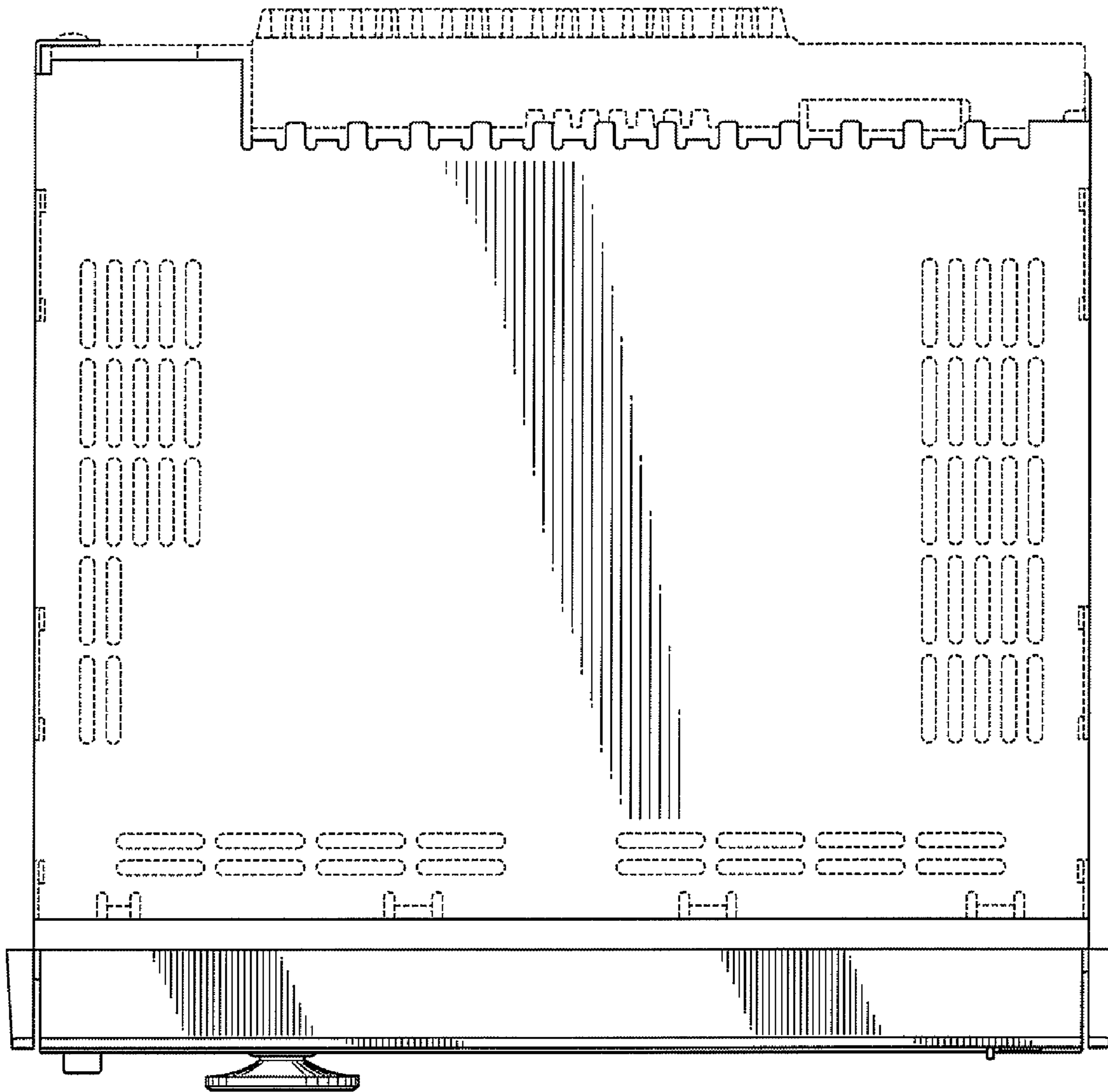

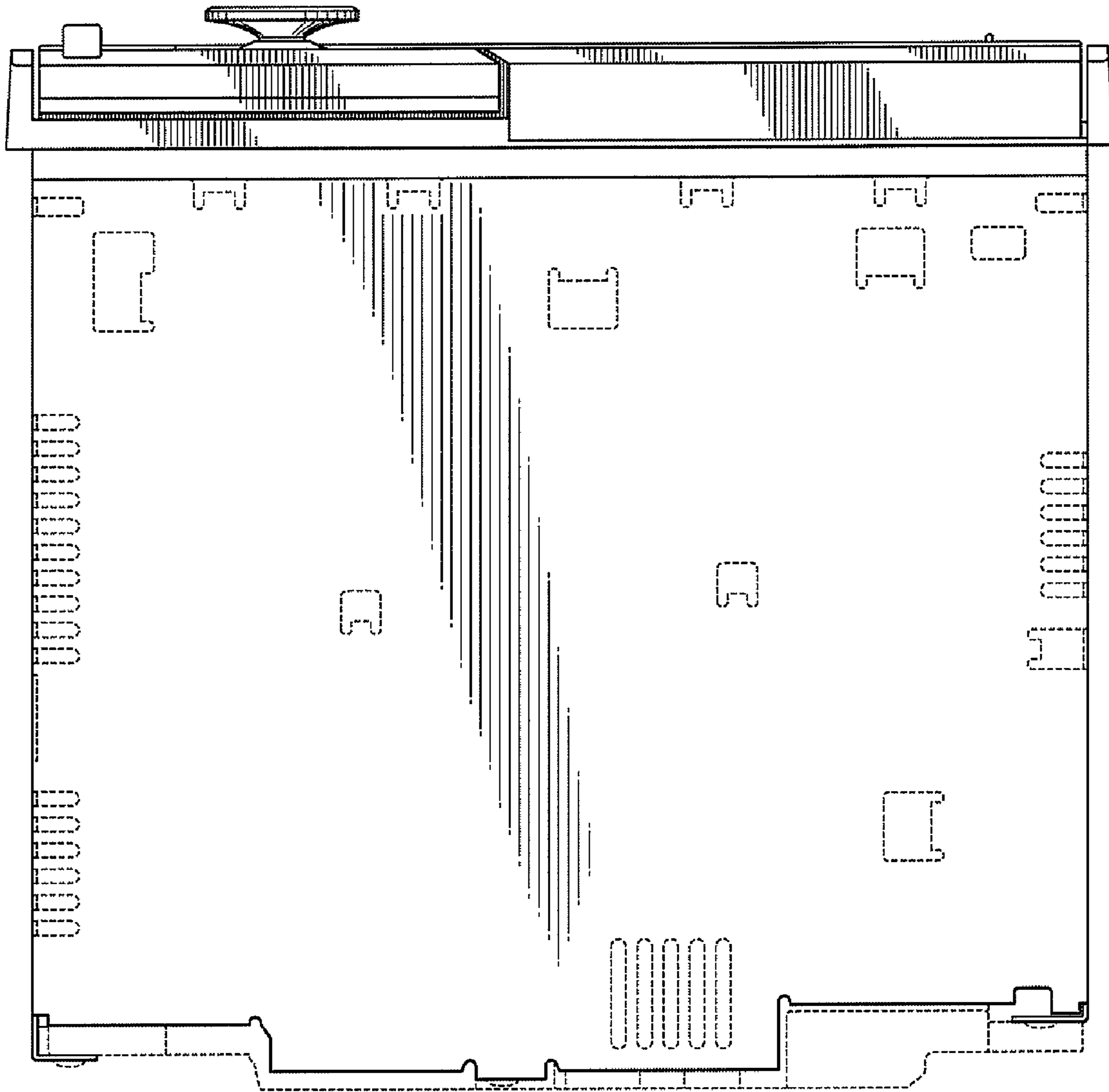
