(57) **CLAIM**

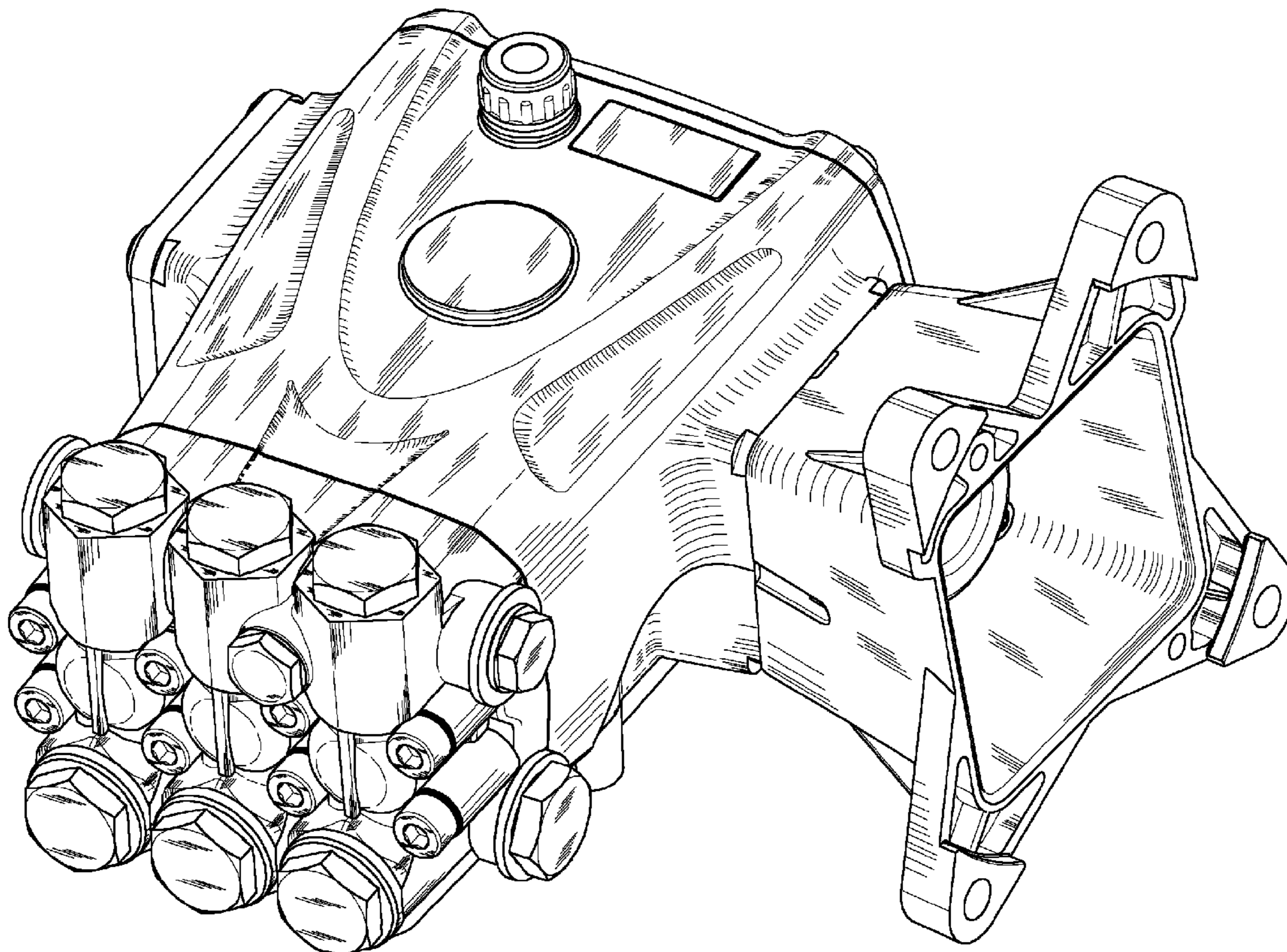
The ornamental design for “piston pump,” as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first embodiment;  
FIG. 2 is a rear view of the first embodiment;  
FIG. 3 is a view from the lower end of FIG. 1;  
FIG. 4 is a view from the upper end of FIG. 1;  
FIG. 5 is a view from the right end of FIG. 1;  
FIG. 6 is a view from the left end of FIG. 1; and,  
FIG. 7 is a perspective view of the embodiment.

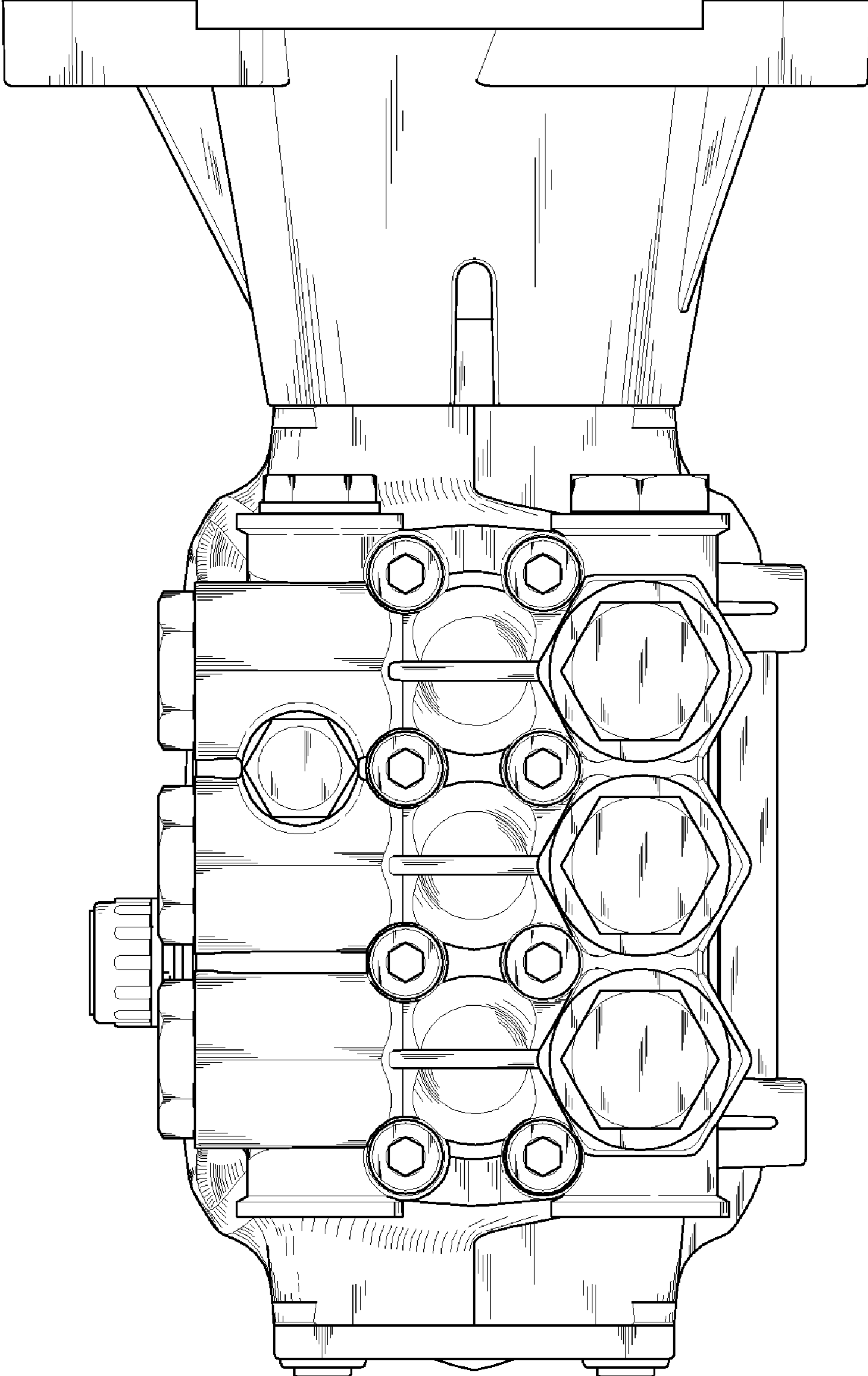

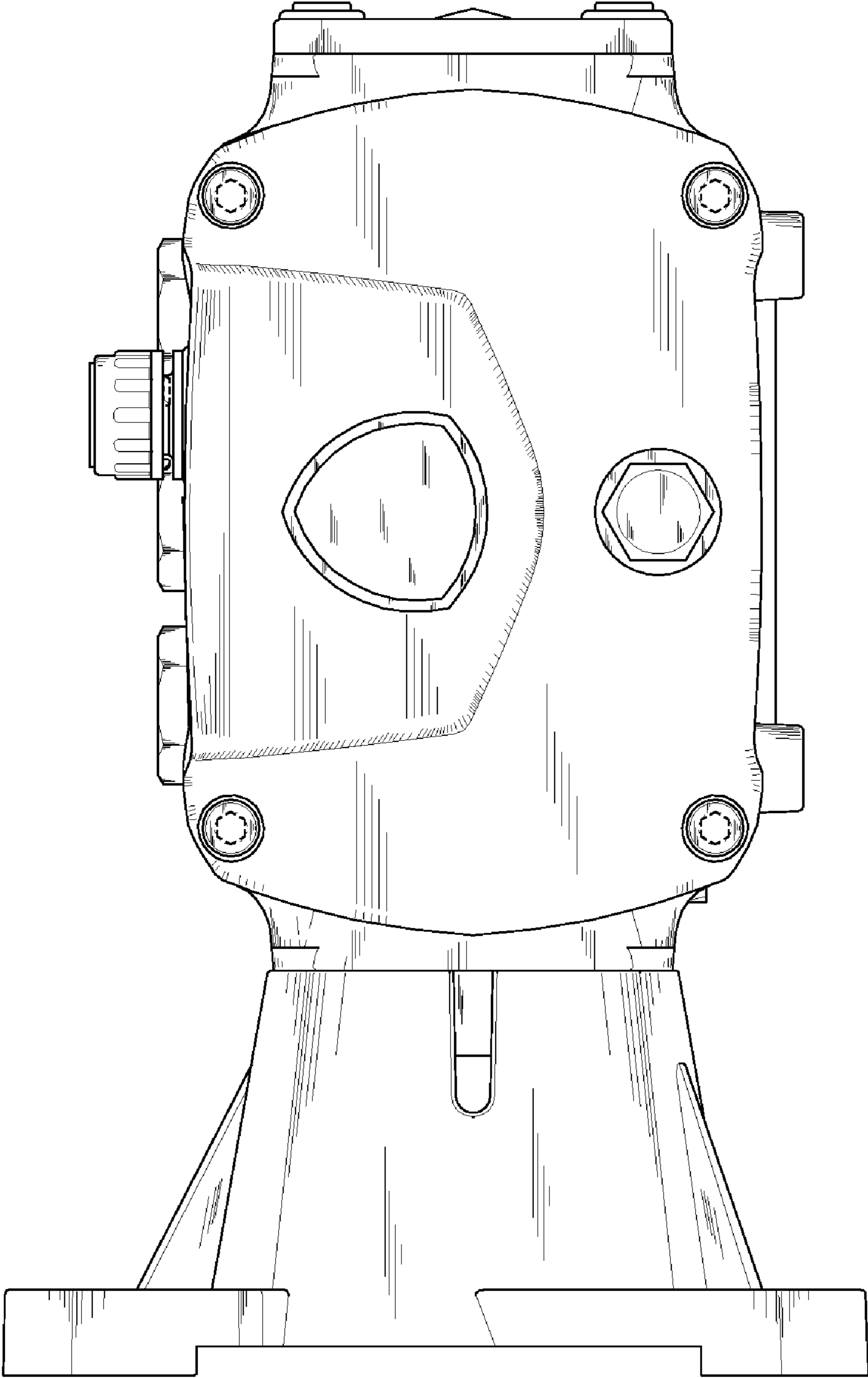

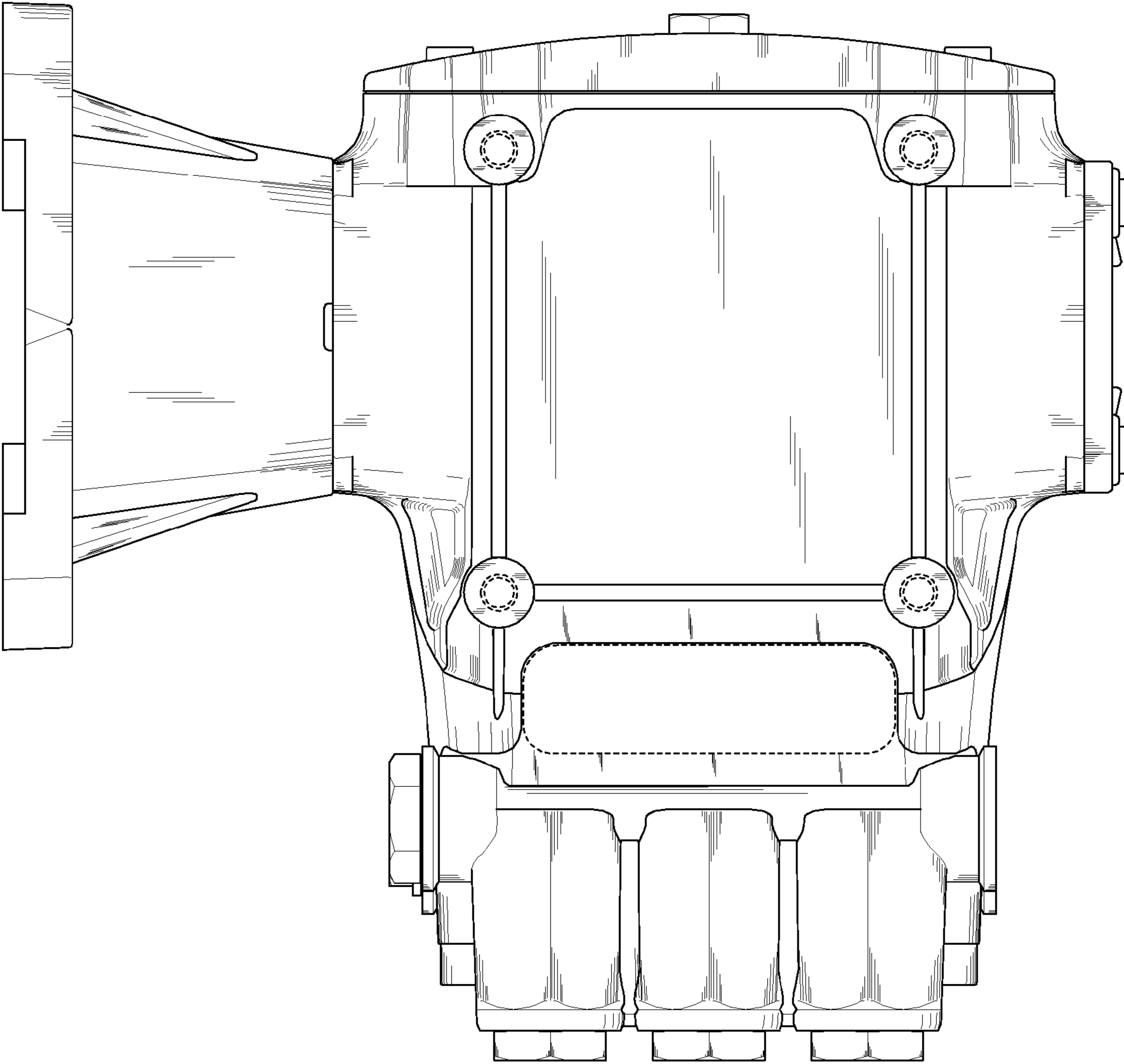

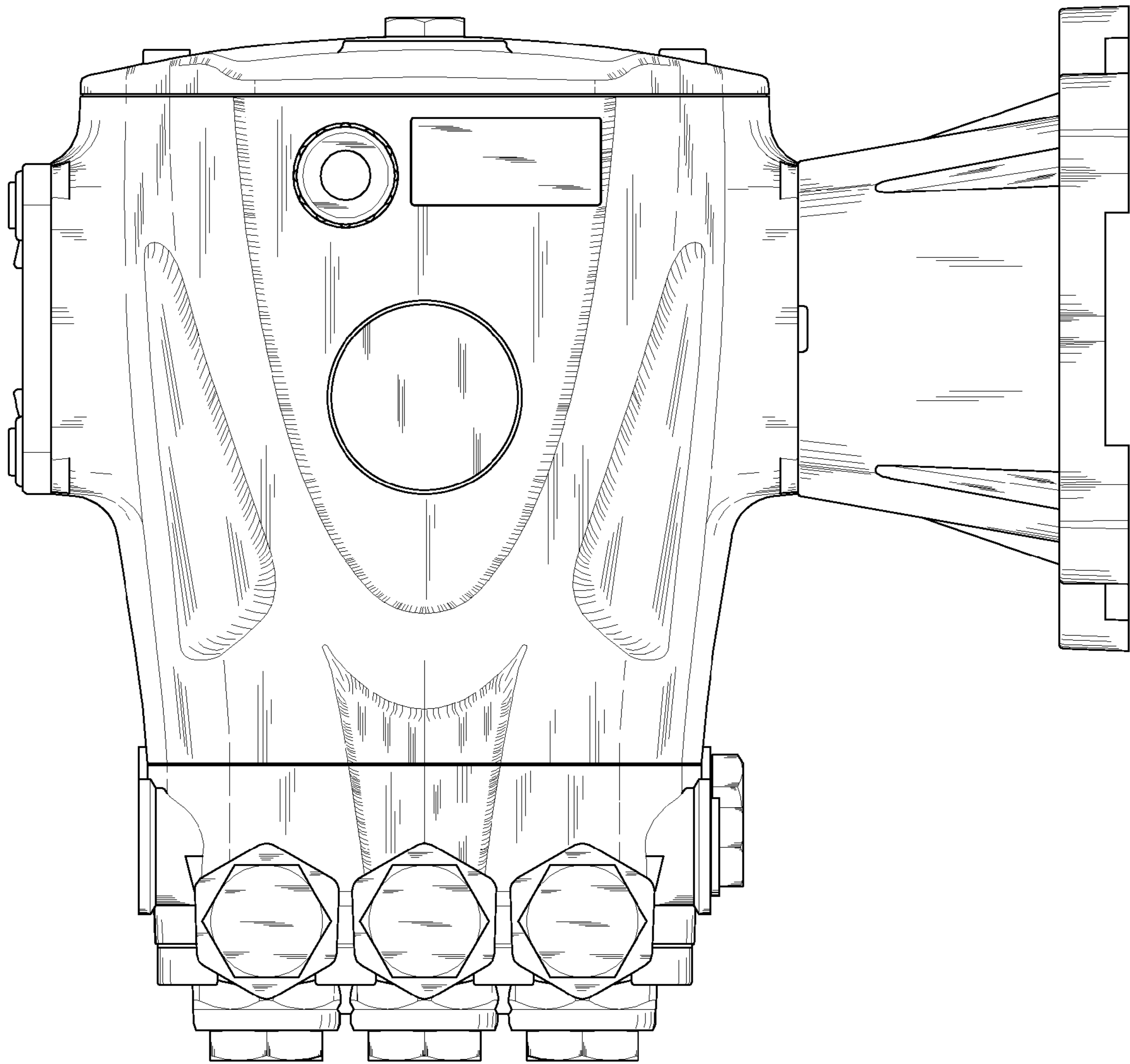

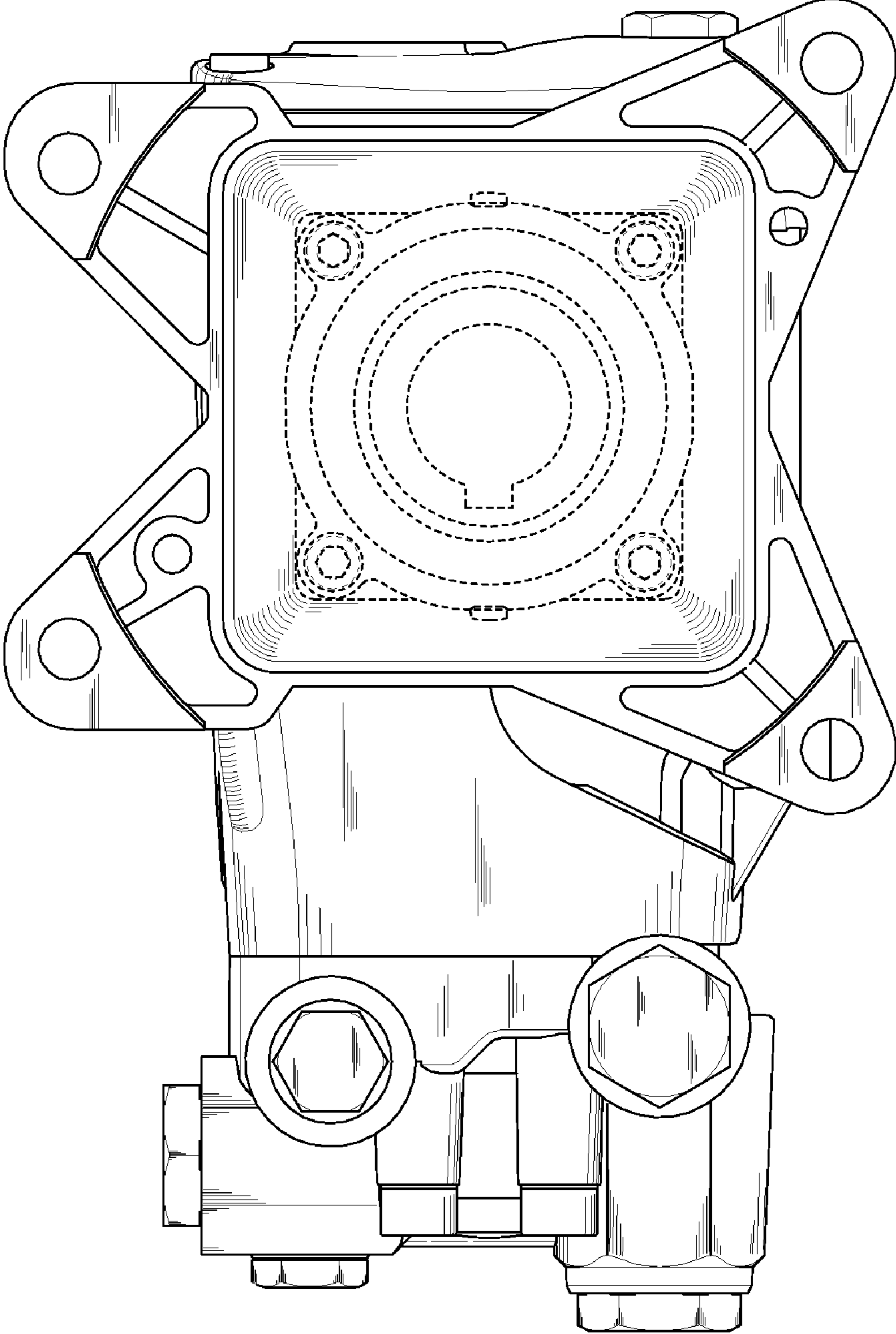

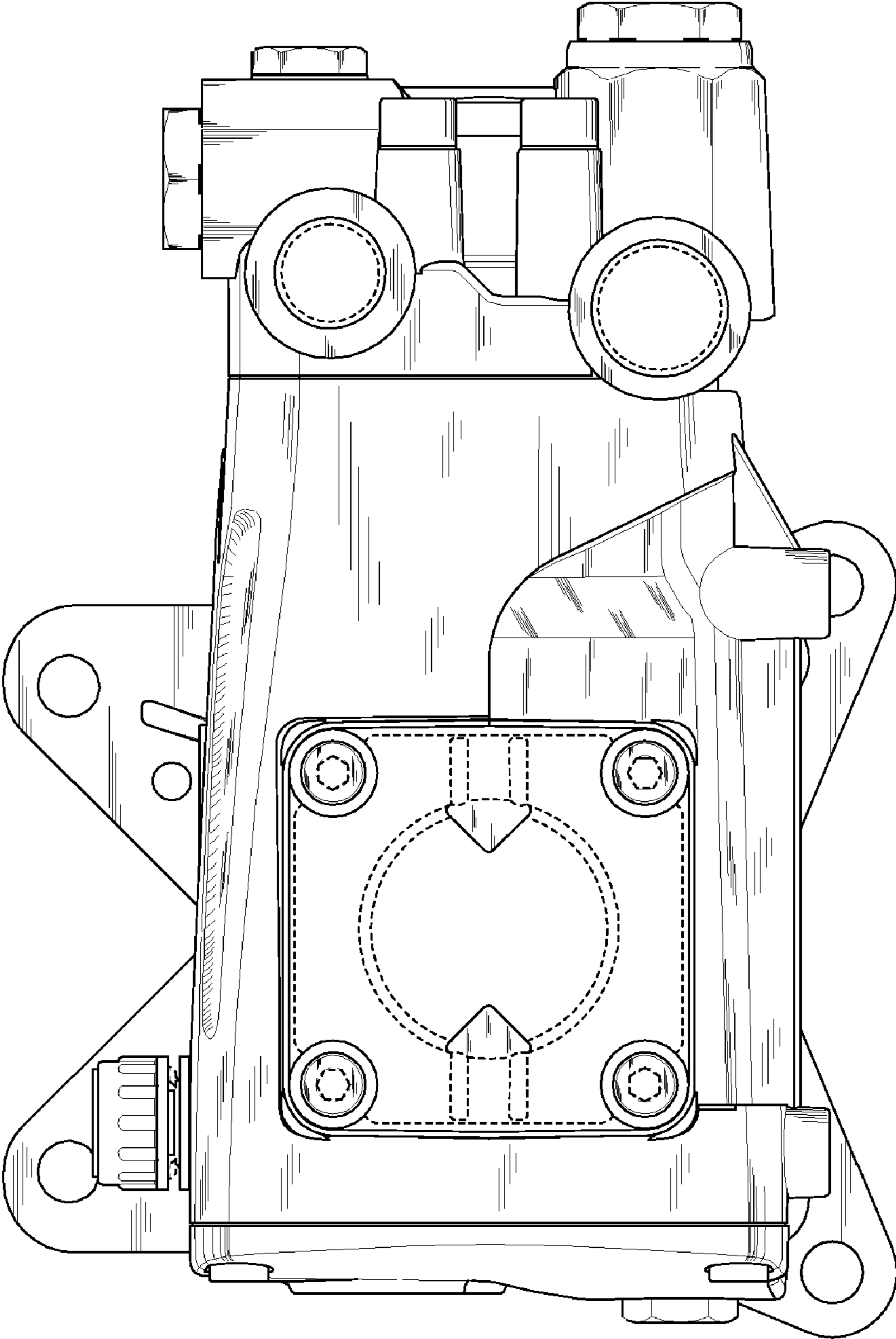

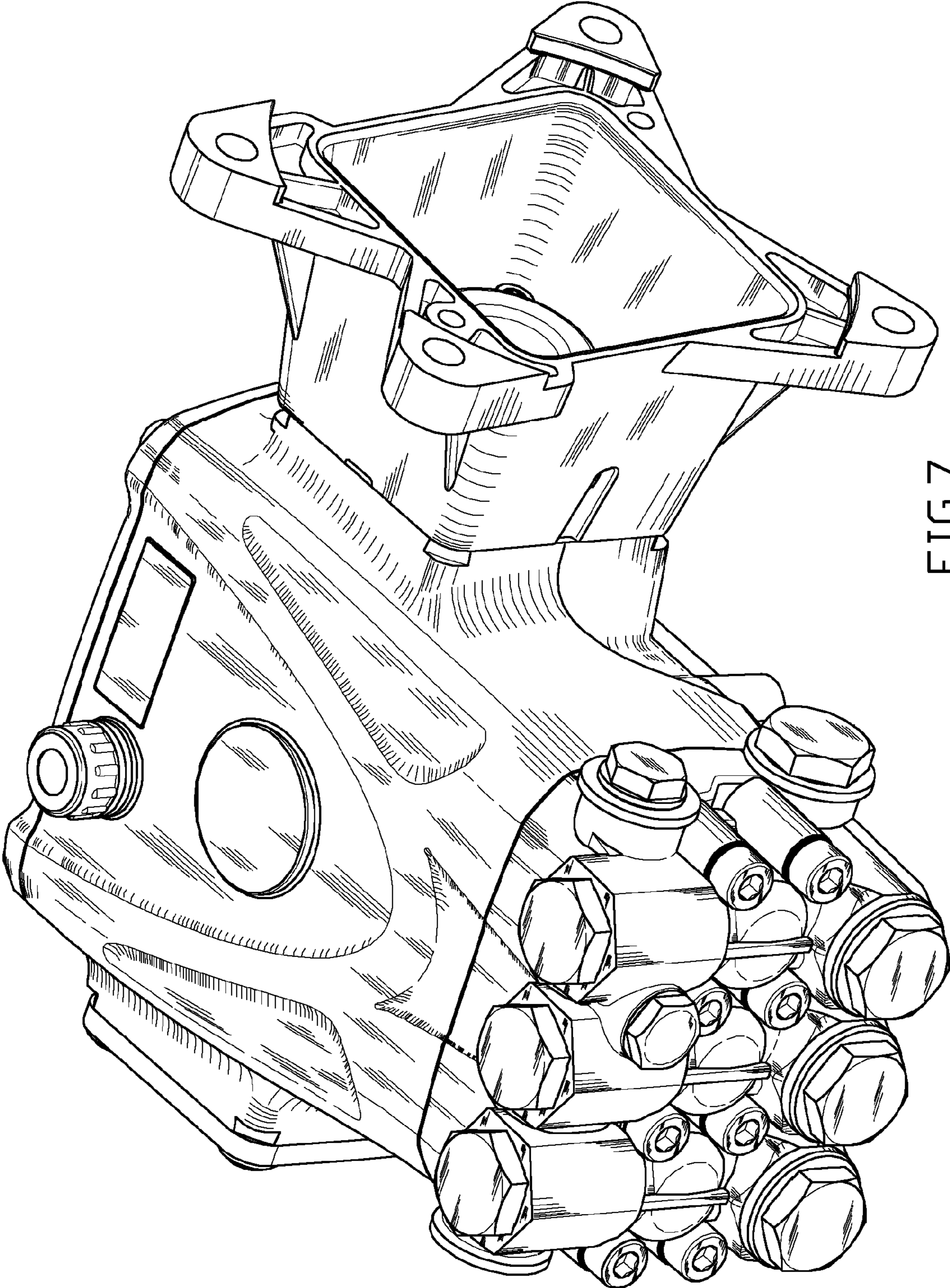
