FIG. 1 is a front elevational view of a cutting blade with a left side cutting edge;

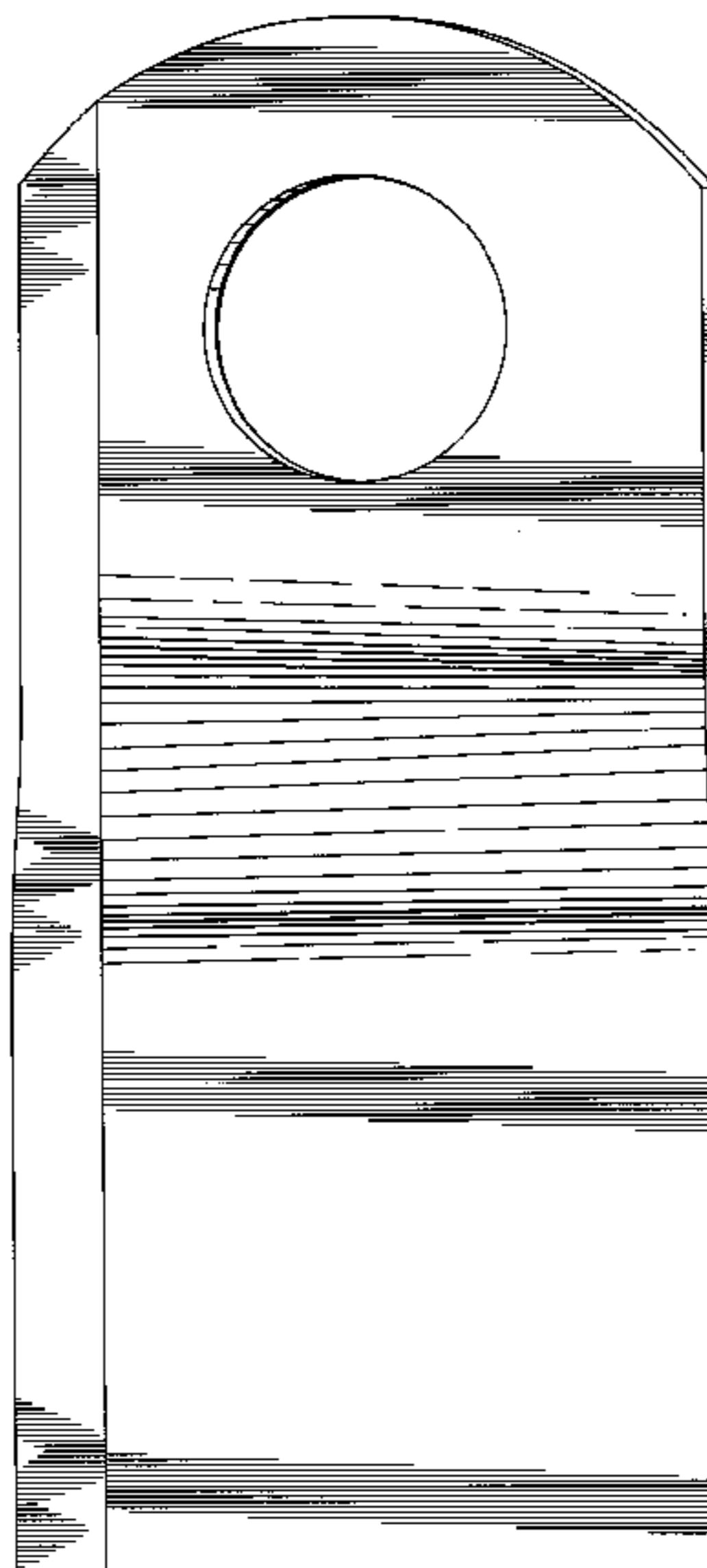
FIG. 2 is a rear elevational view thereof;

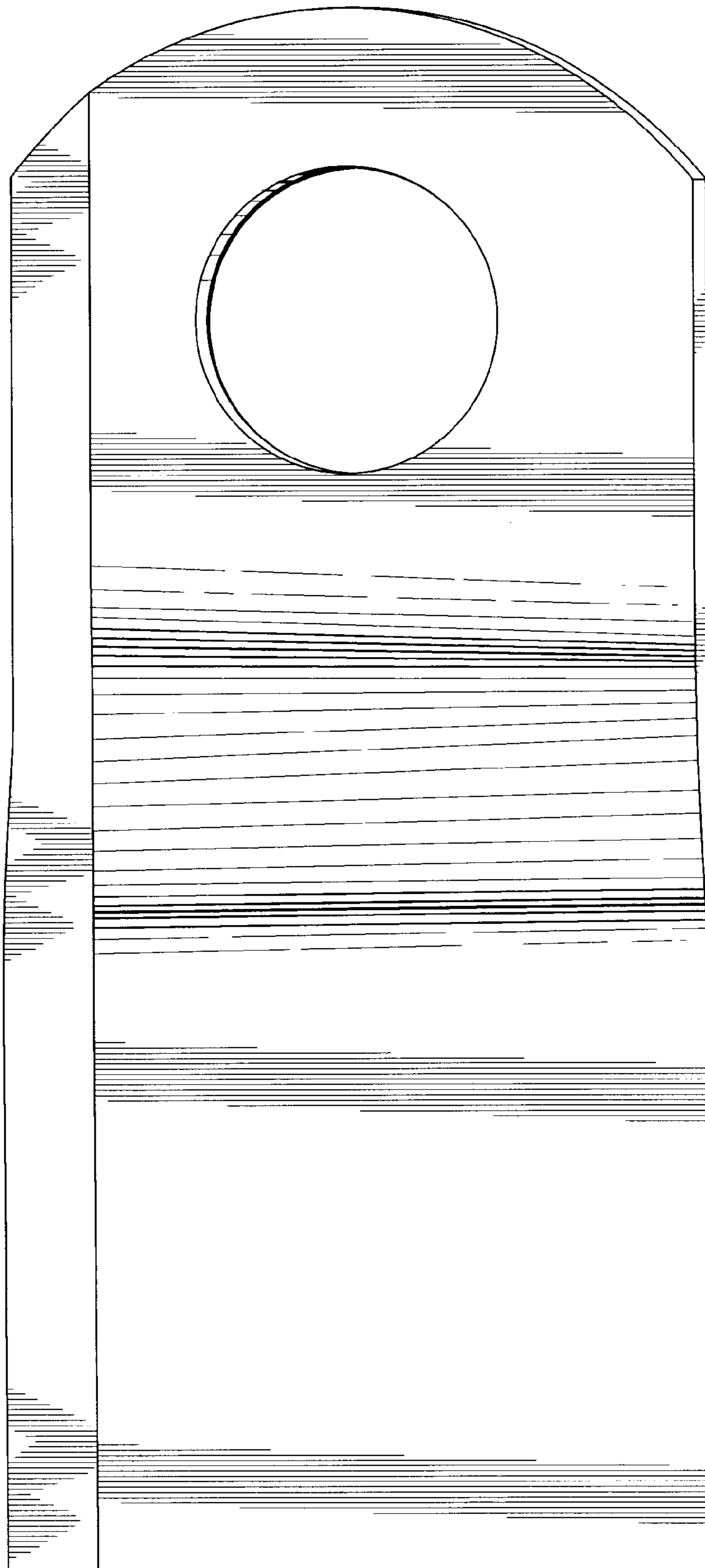
FIG. 3 is a left side elevational view thereof;

FIG. 4 is a reduced front, bottom, right side perspective view thereof; and,

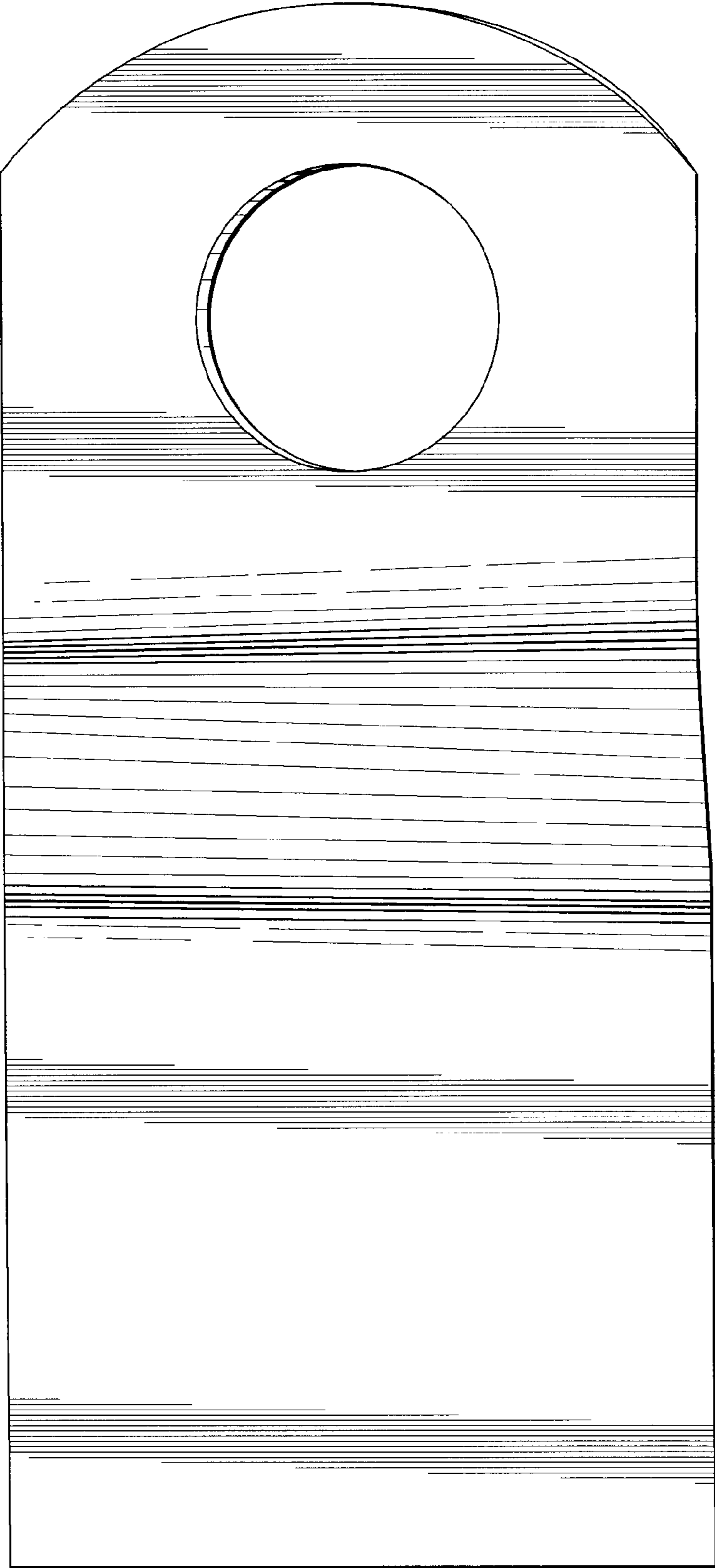
FIG. 5 is a reduced front, bottom, left side perspective view thereof.

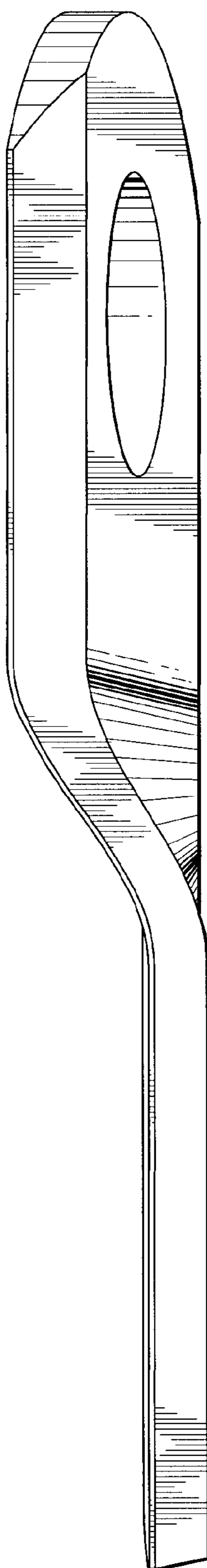




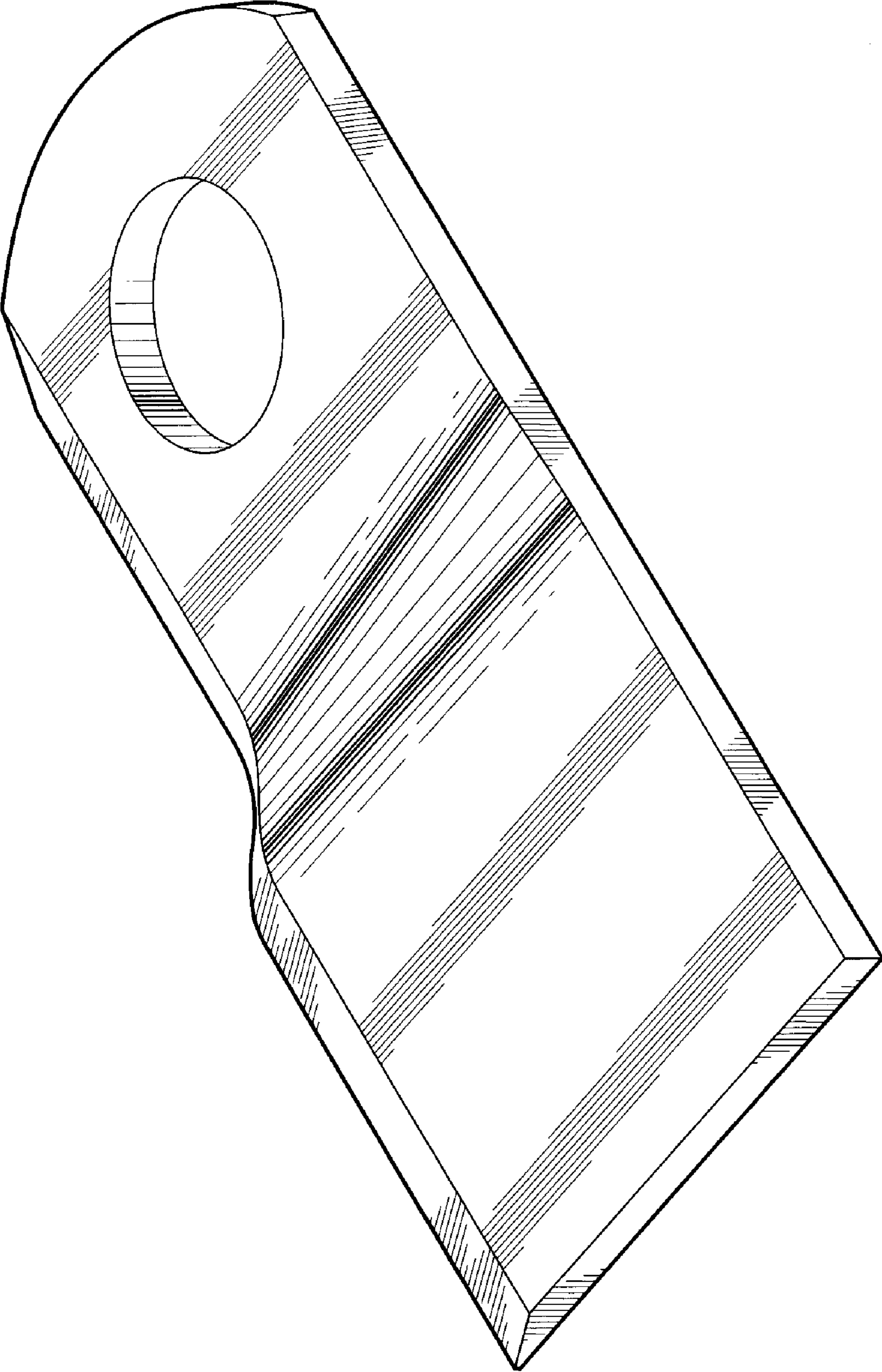

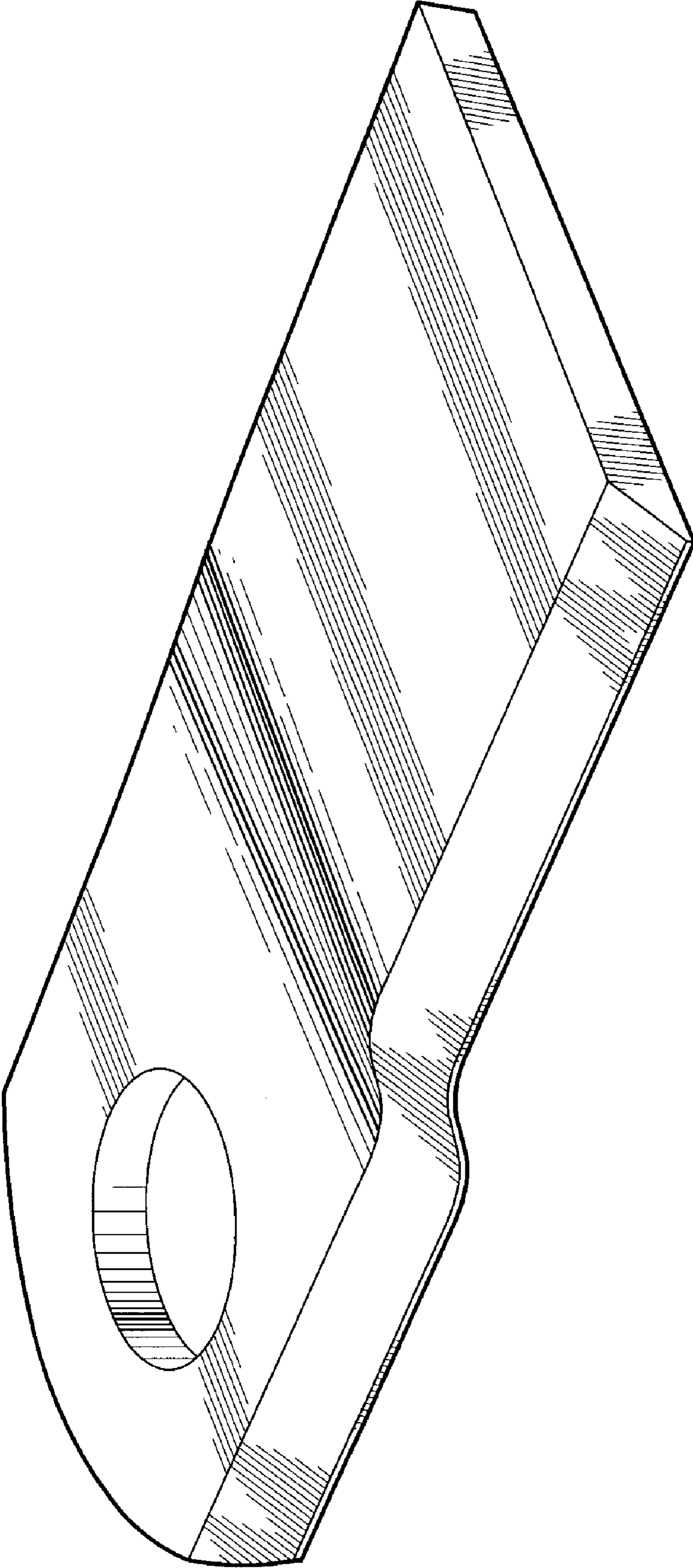
