(57) **CLAIM**

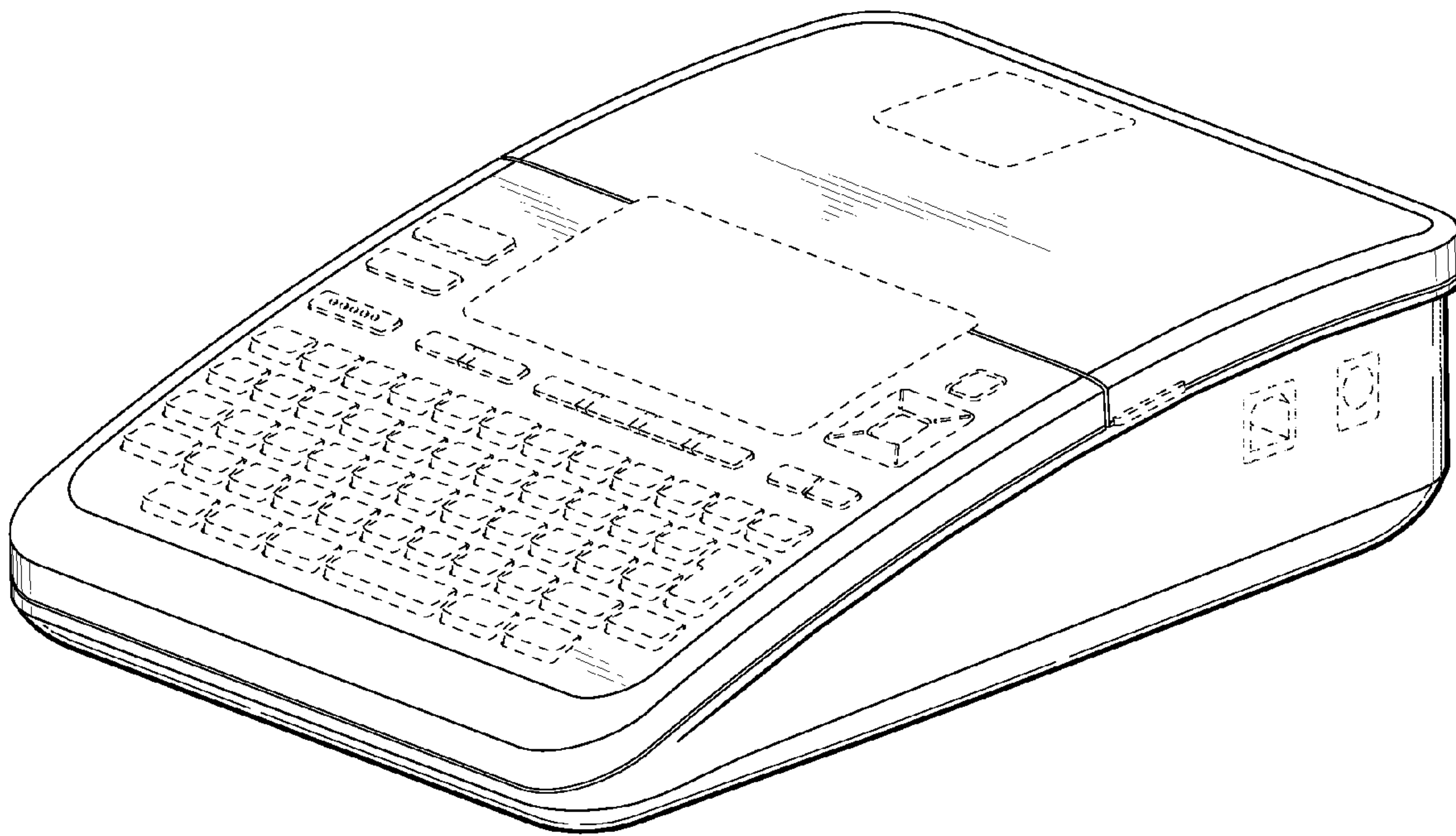
The ornamental design for a tape printing machine, as shown and described.

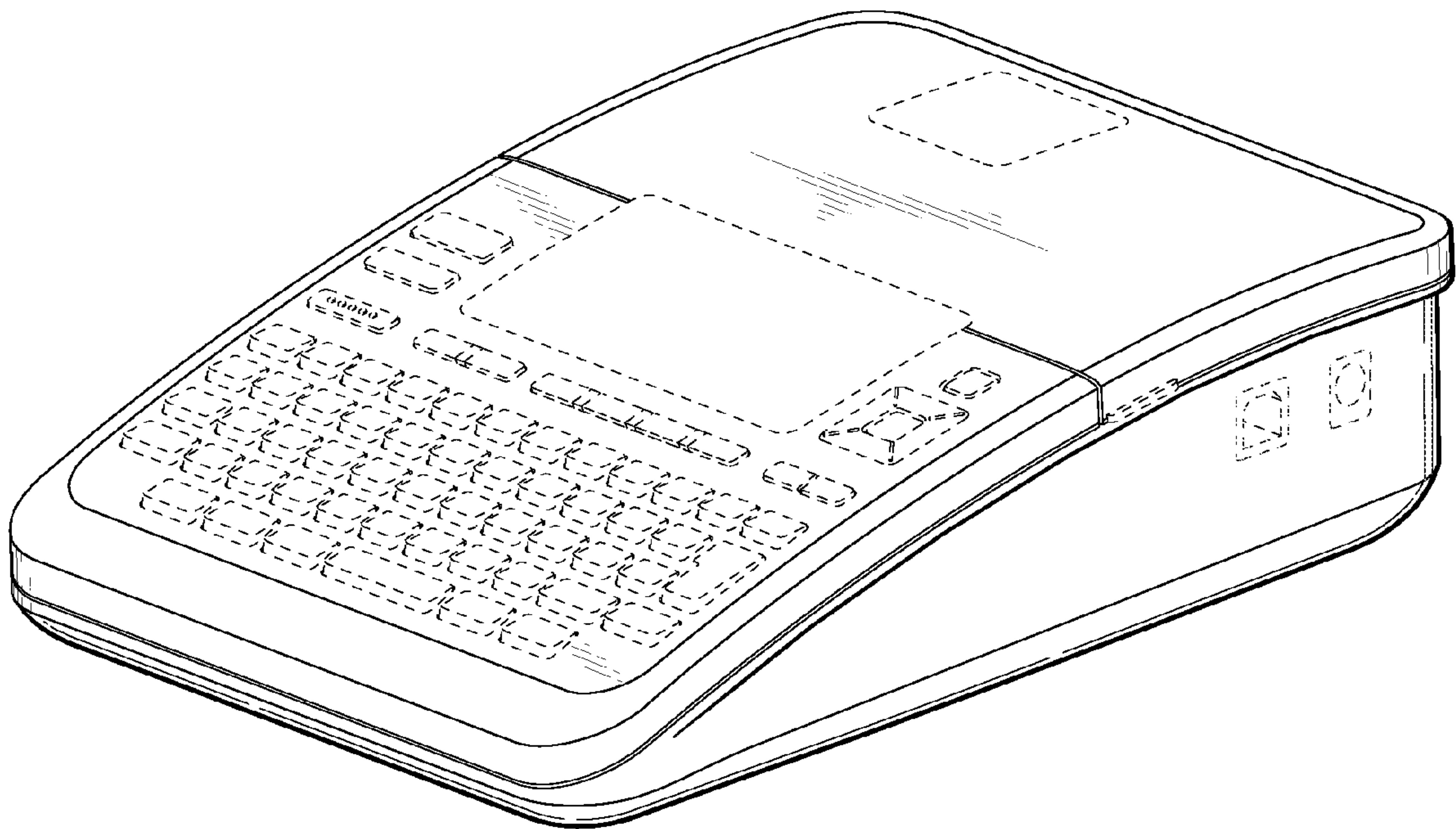

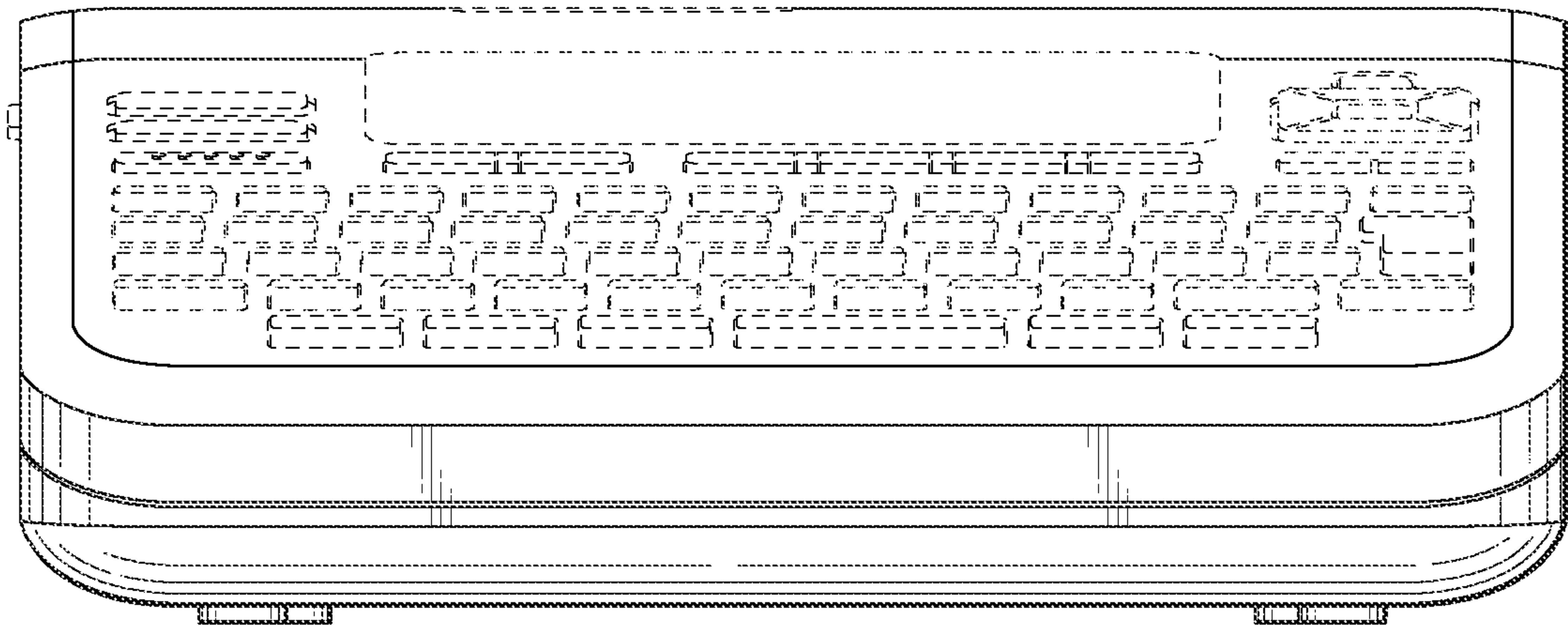

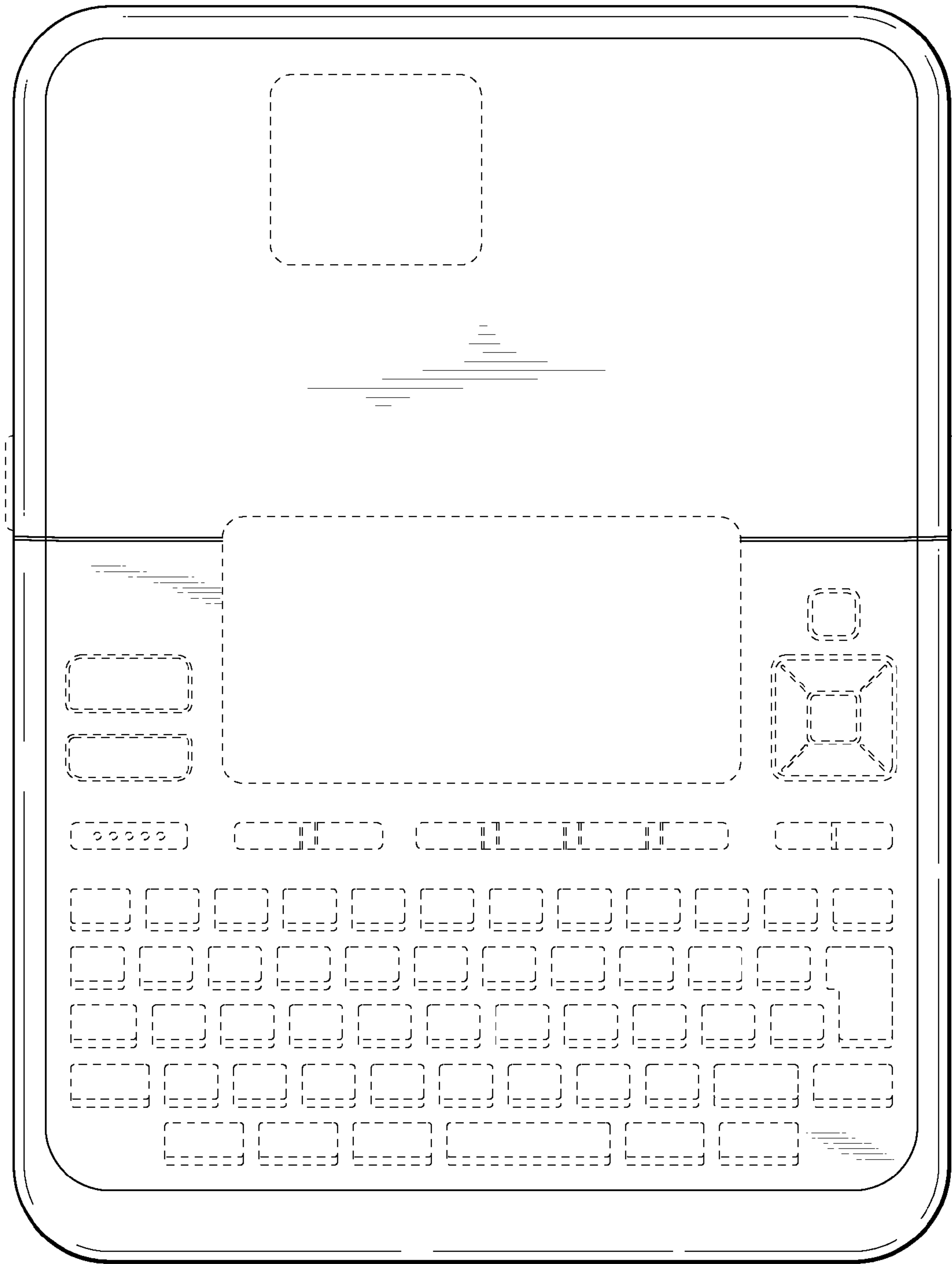

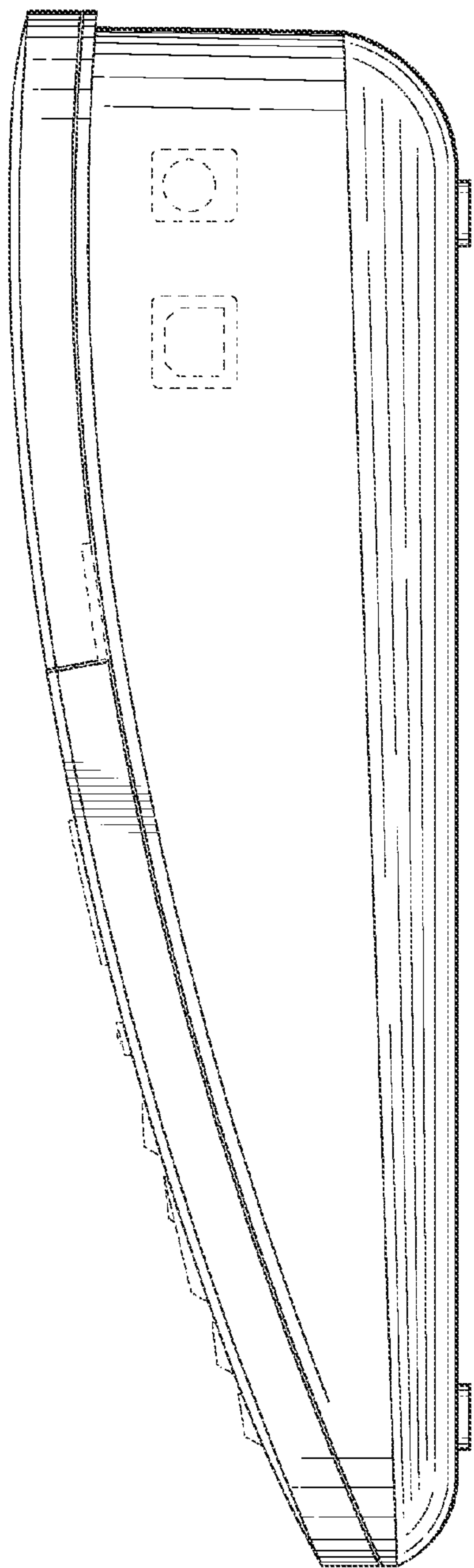

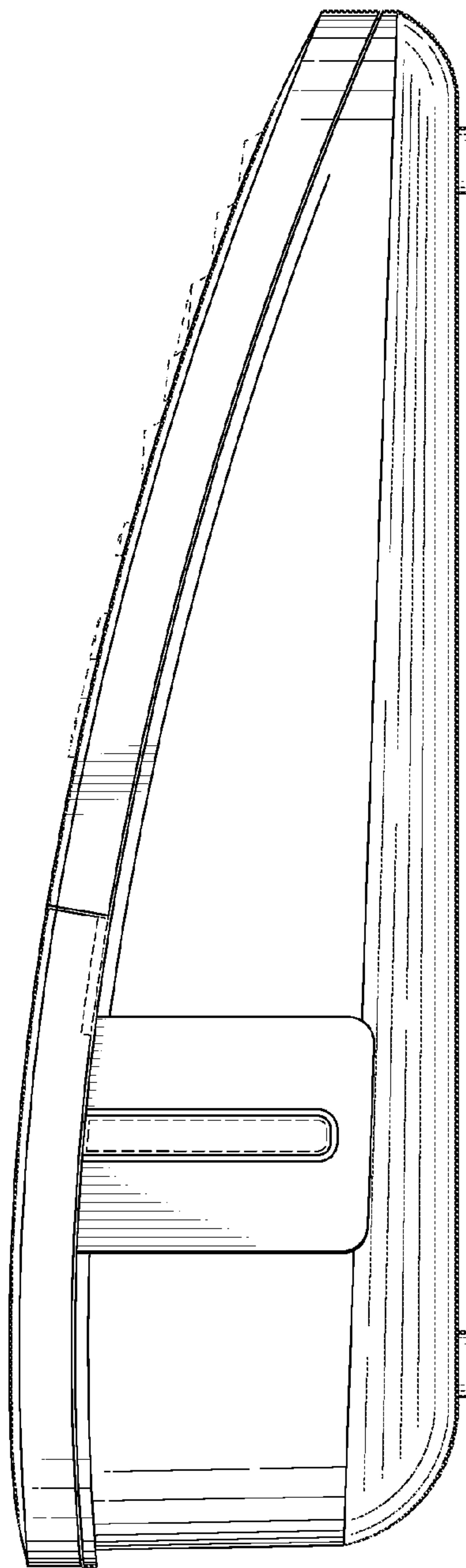

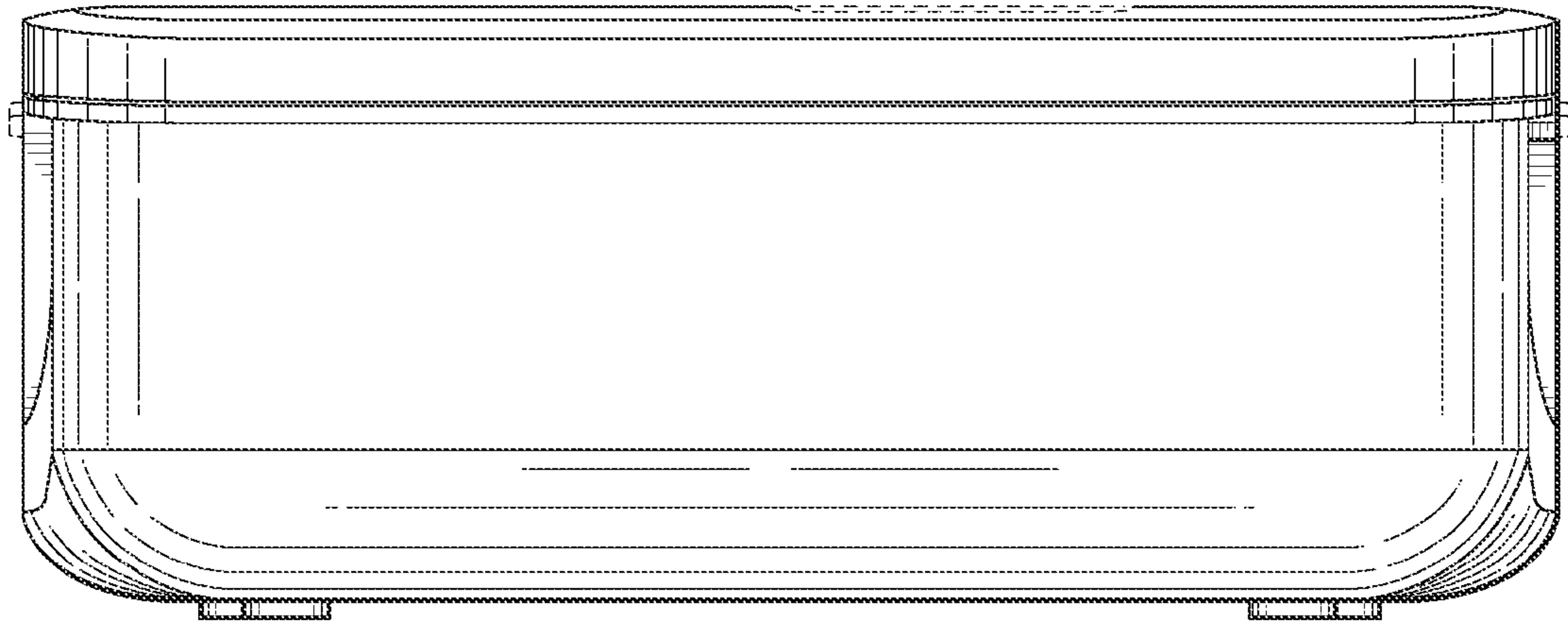

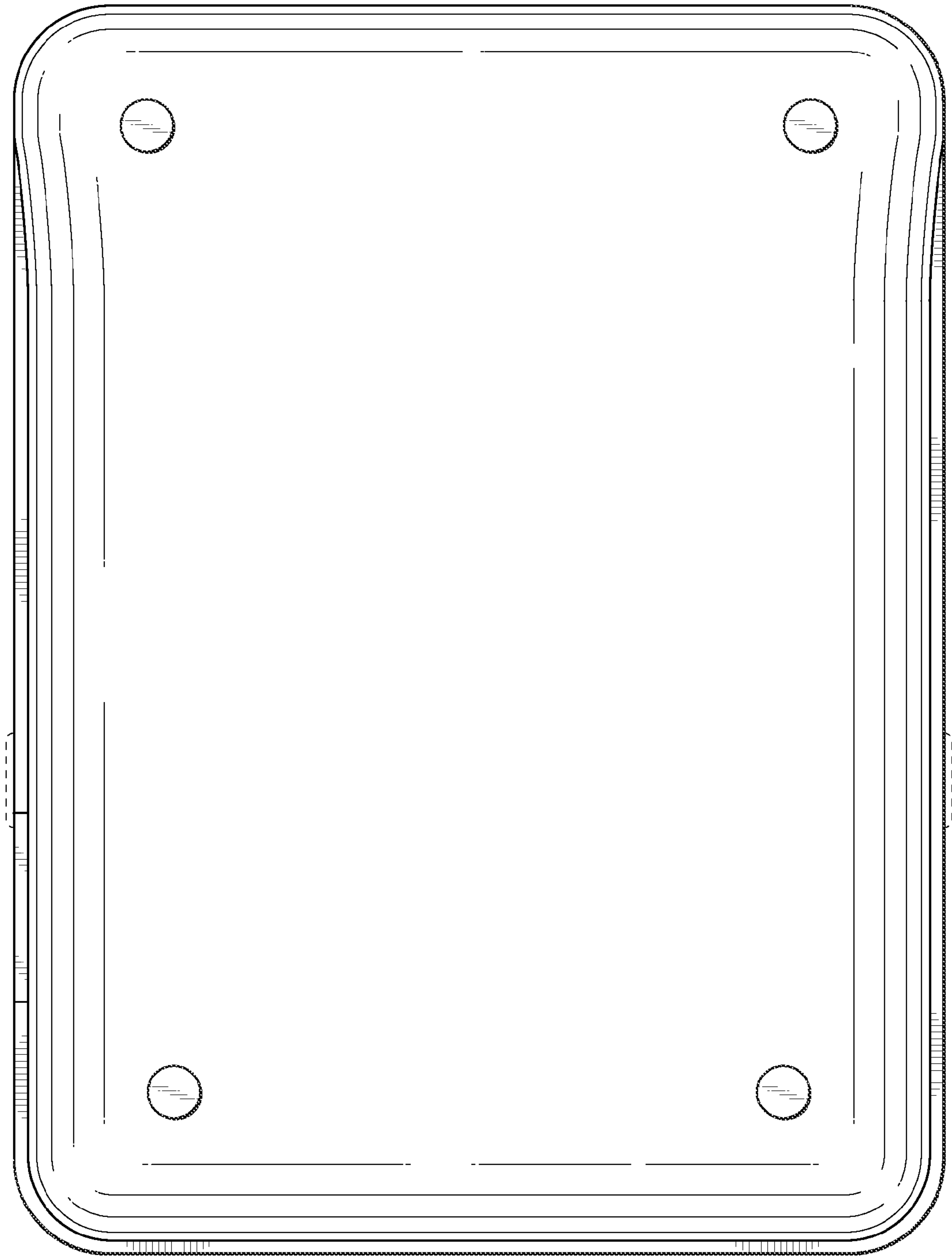
