FIG. 2 is a right side view thereof, the left side view being a mirror image;

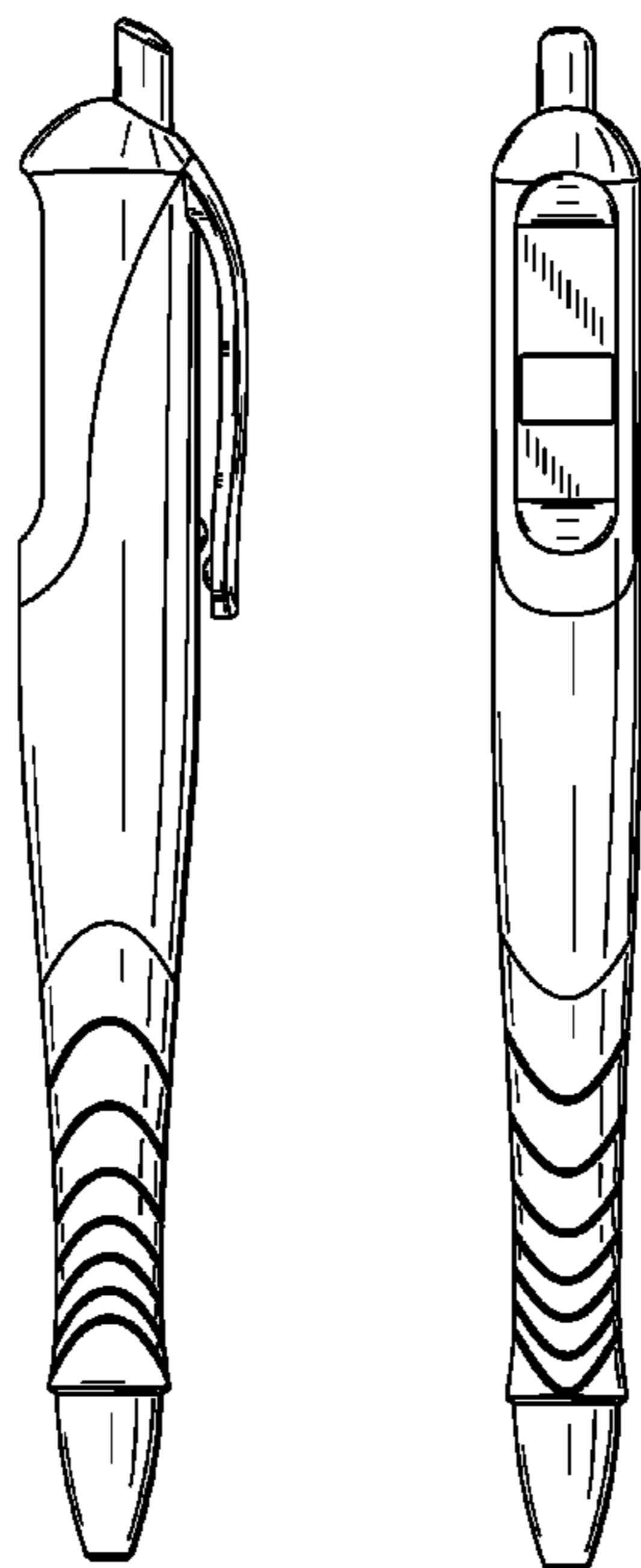
FIG. 3 is a bottom plan view thereof;

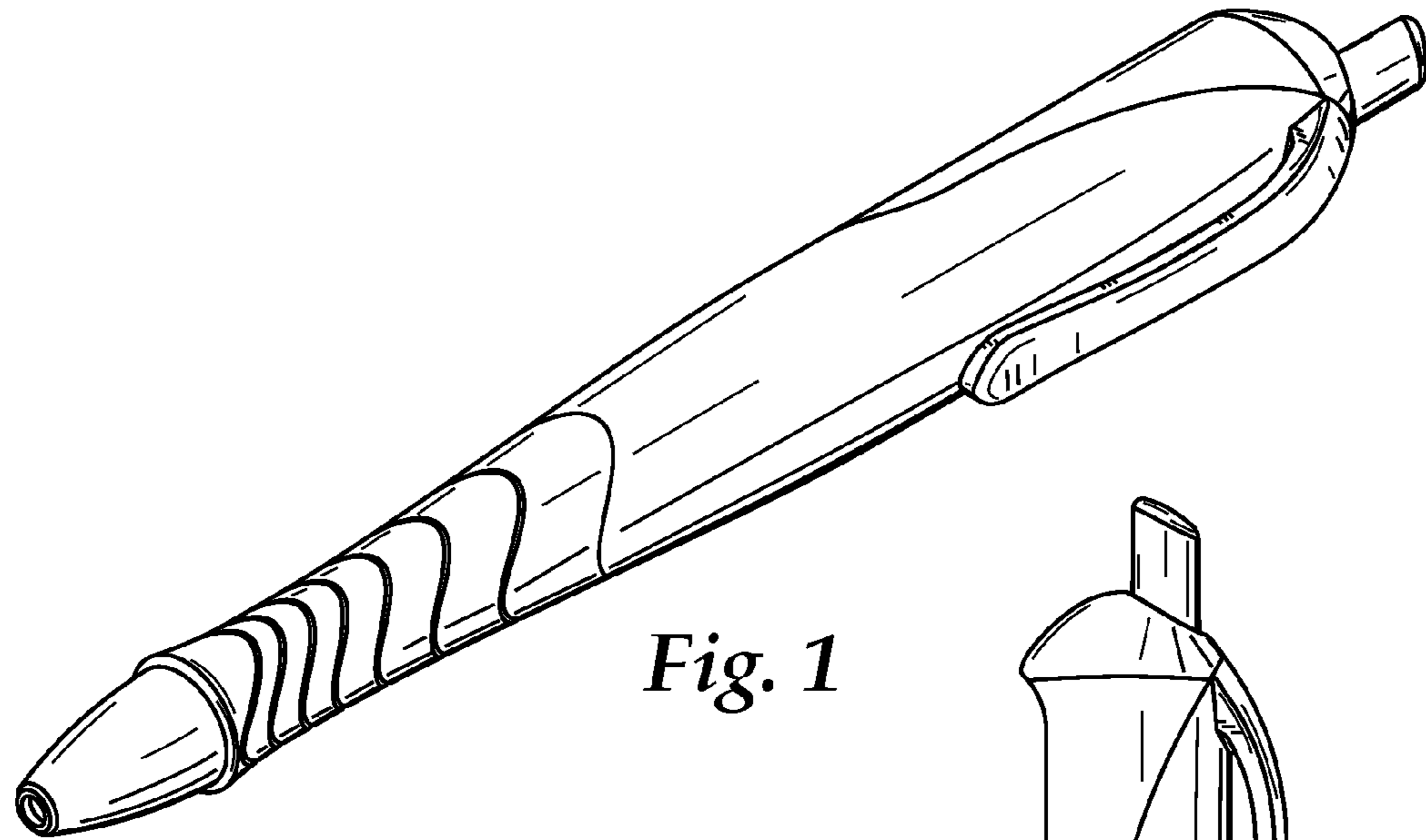

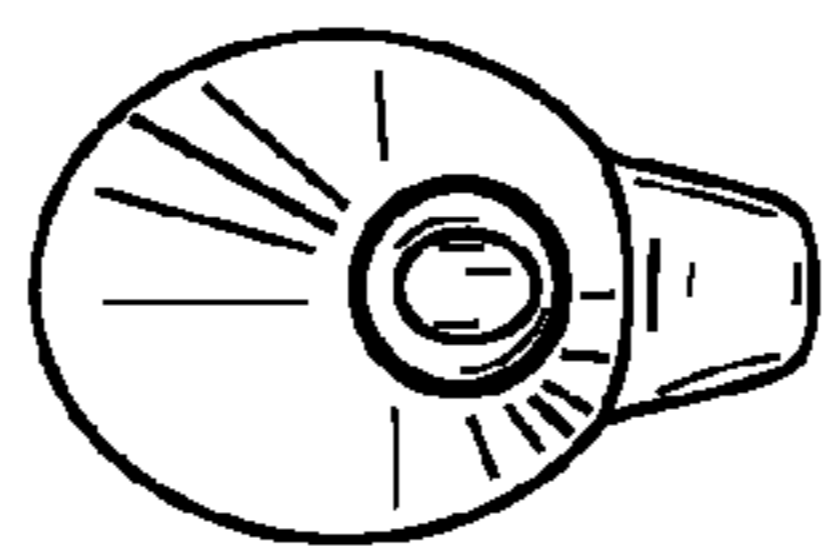

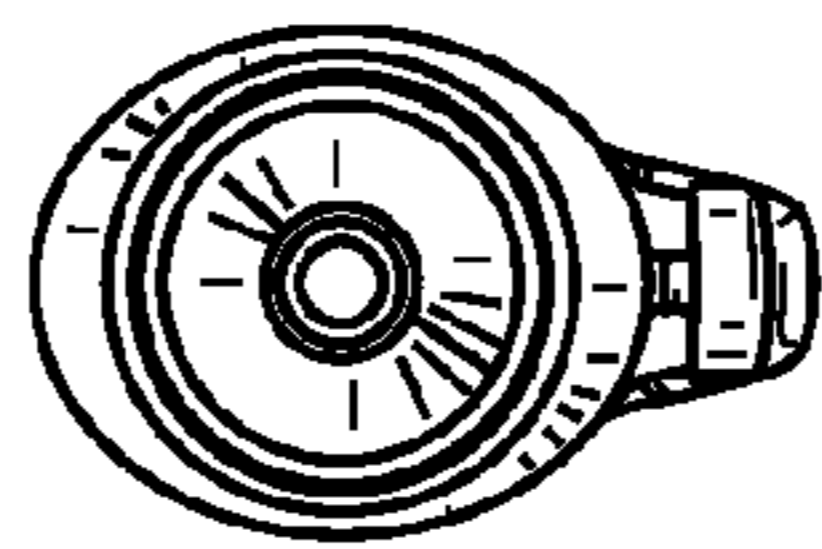

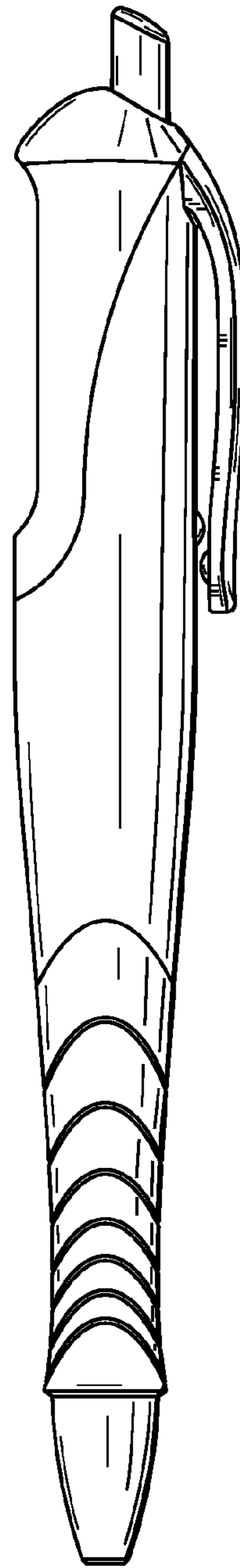

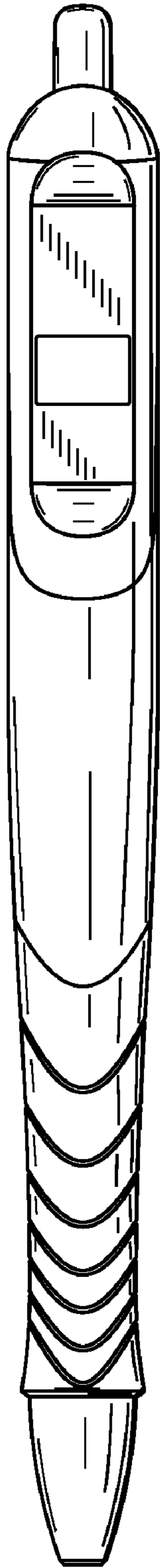

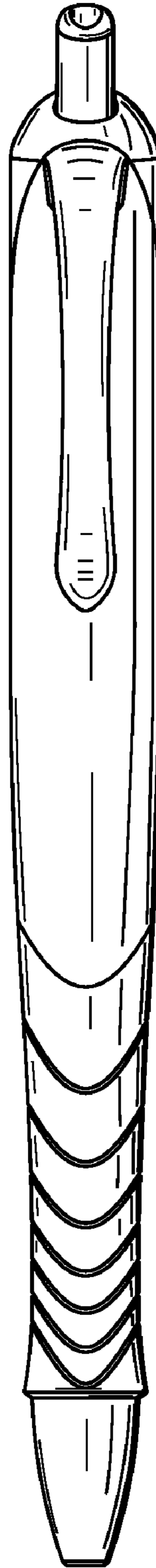
