The ornamental design for a paper punch, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a paper punch showing the new design;

FIG. 2 is a rear perspective view thereof;

FIG. 5 is a top view thereof;

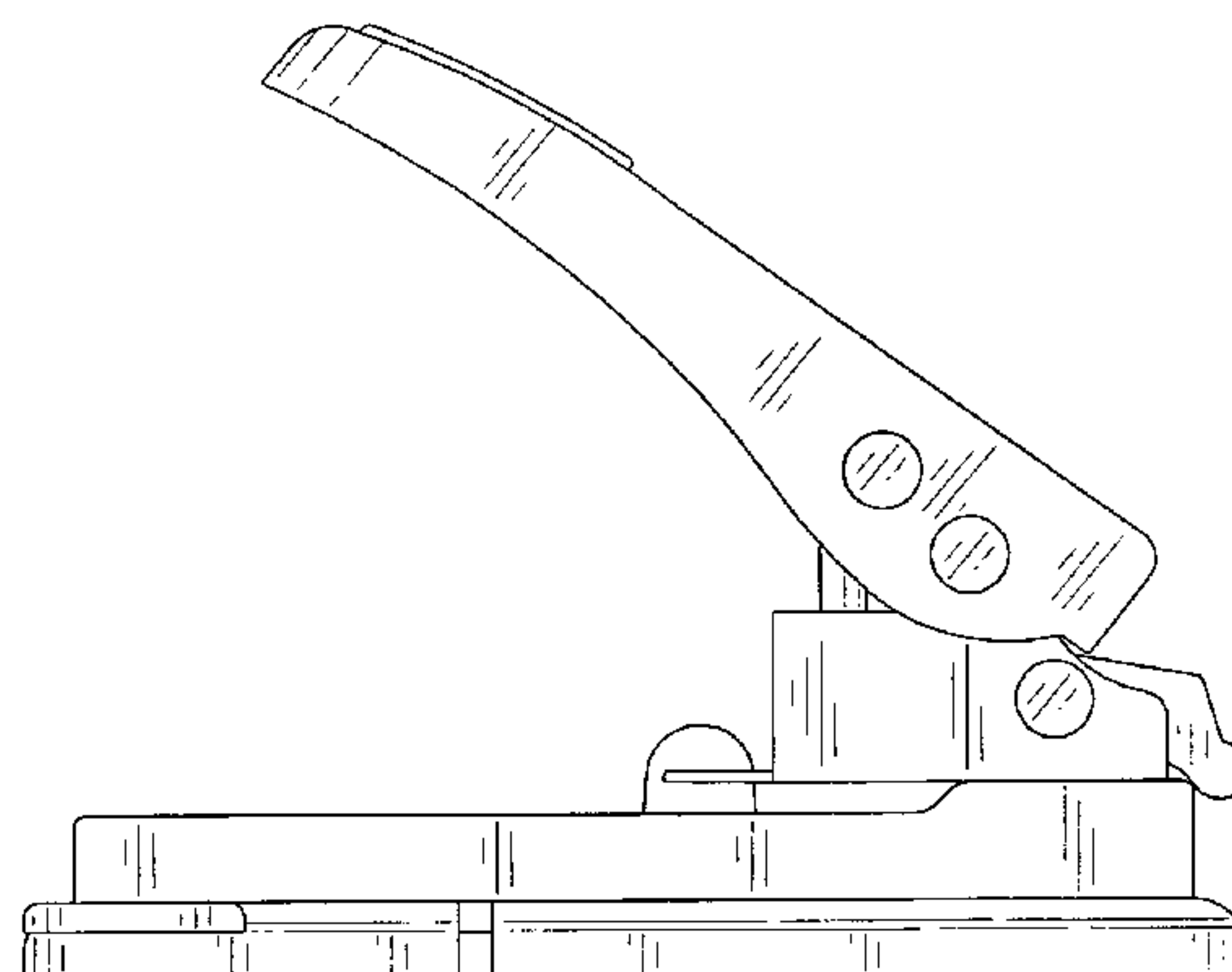
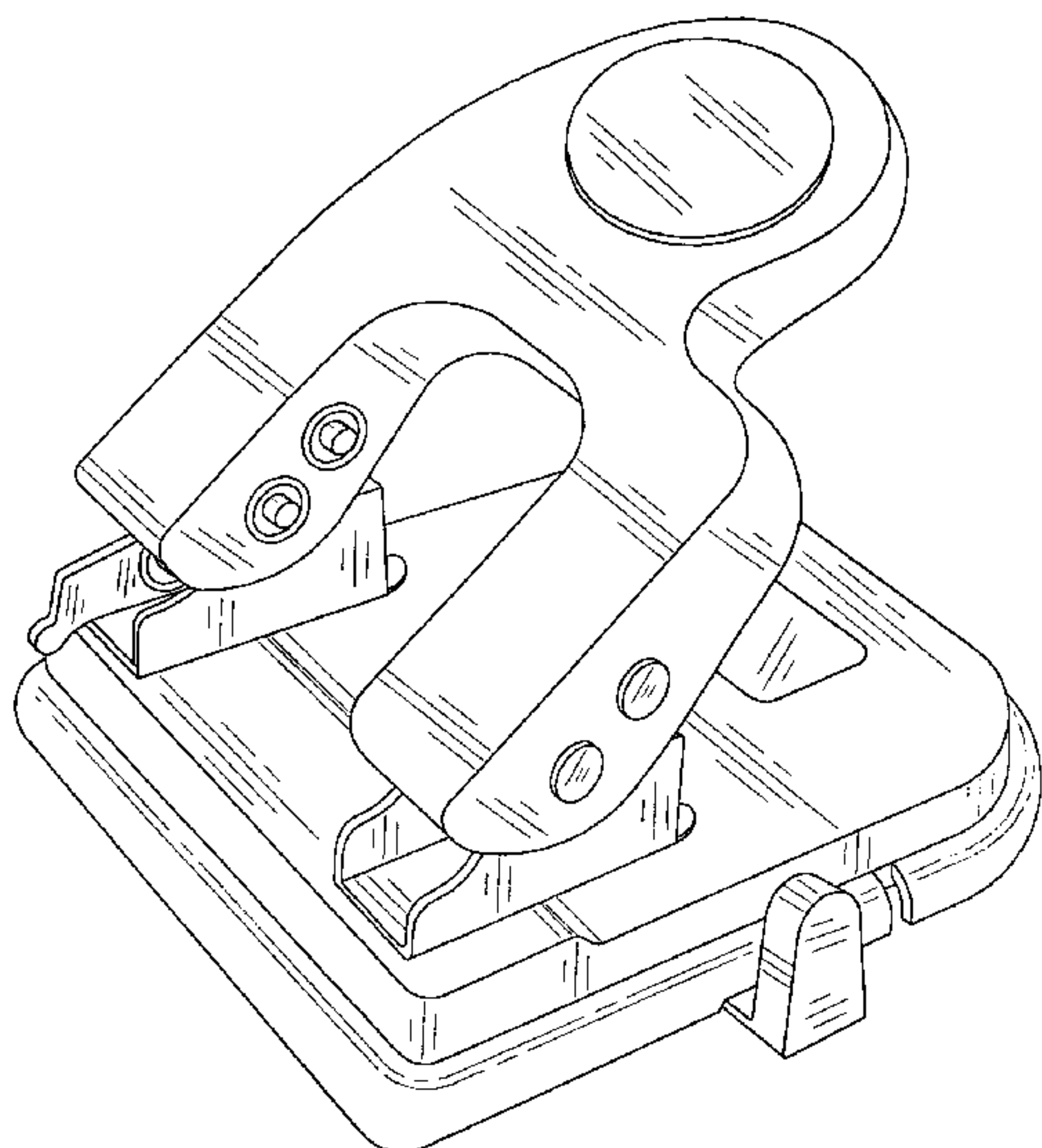
FIG. 6 is a bottom view thereof;

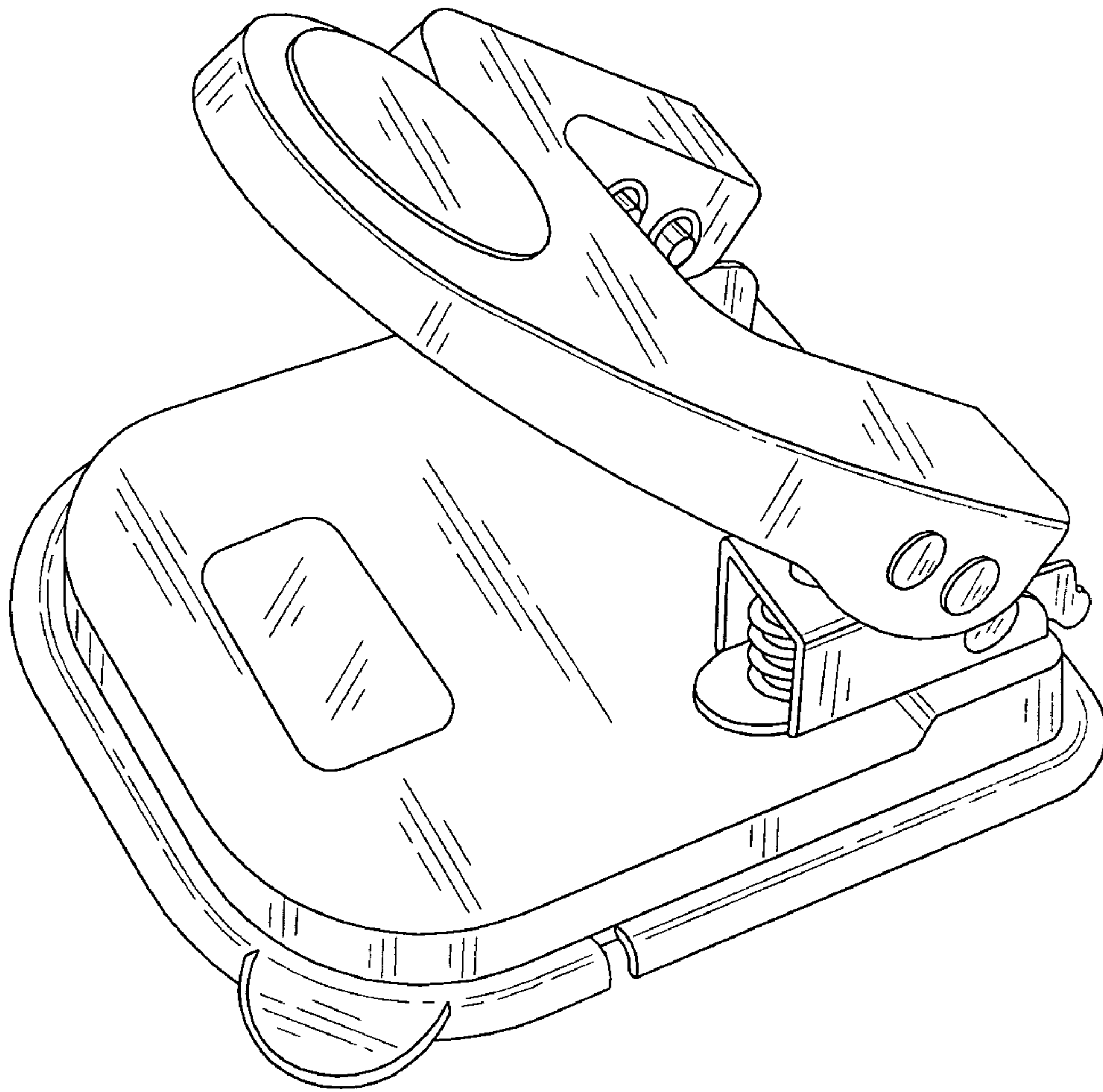

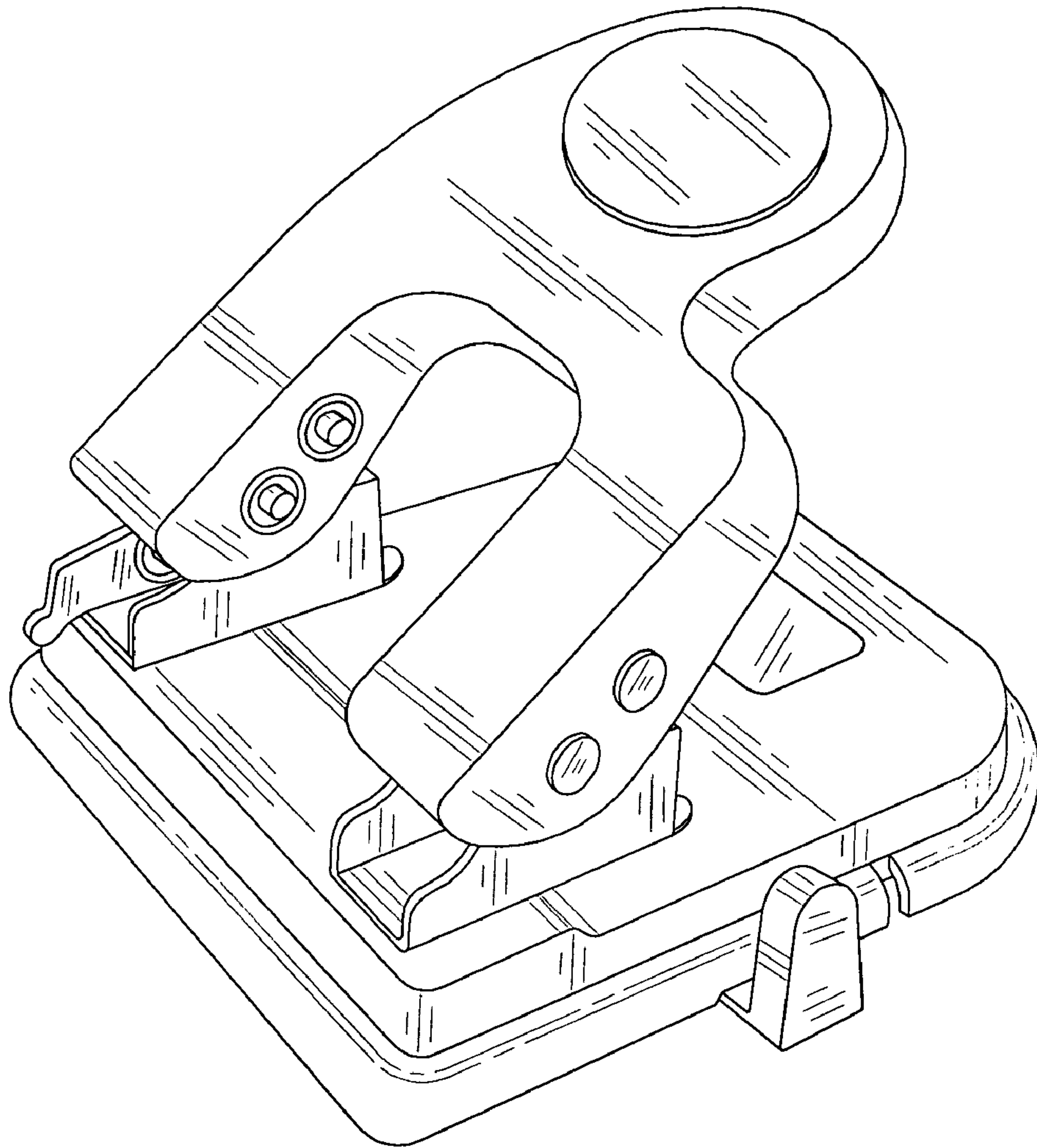

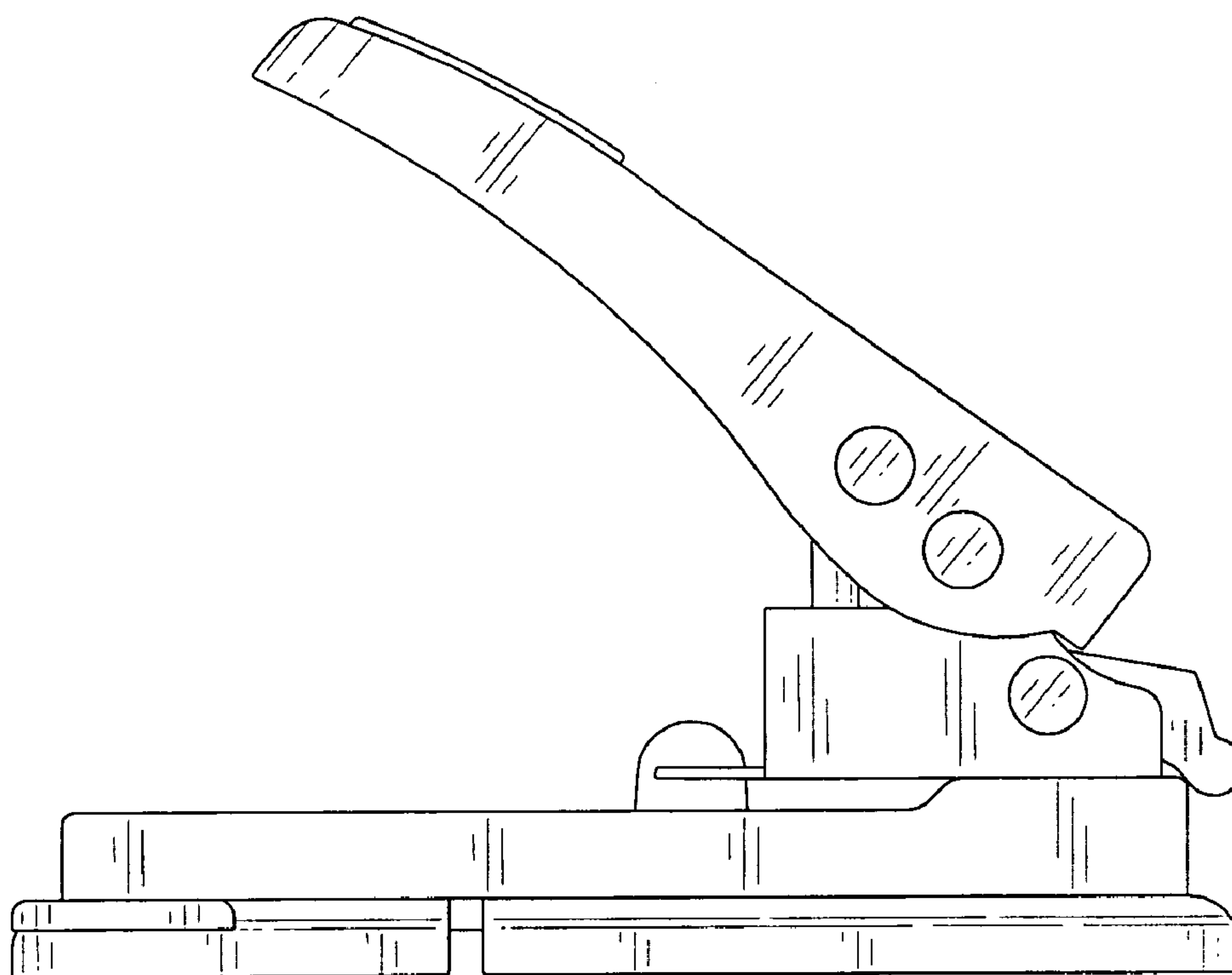

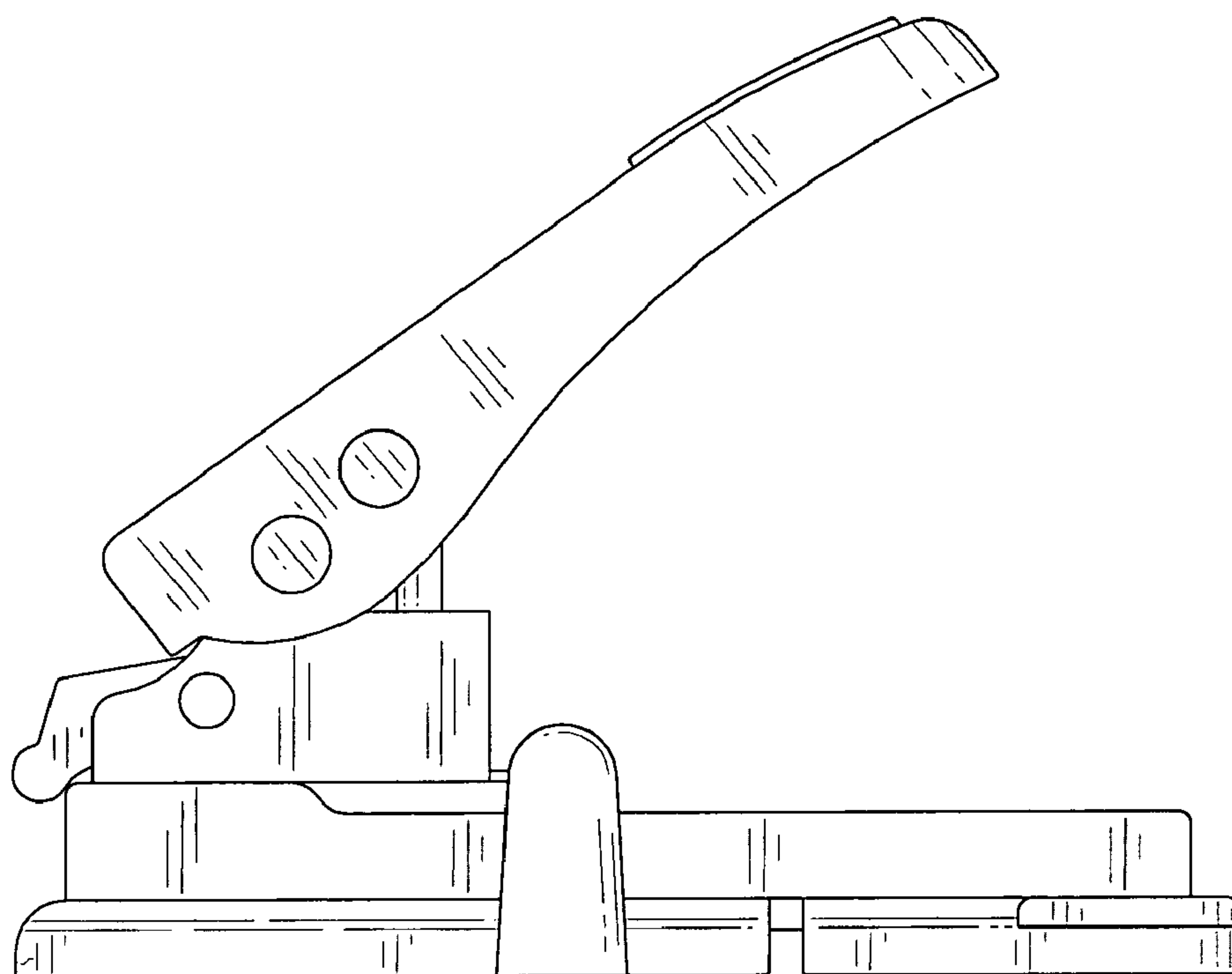

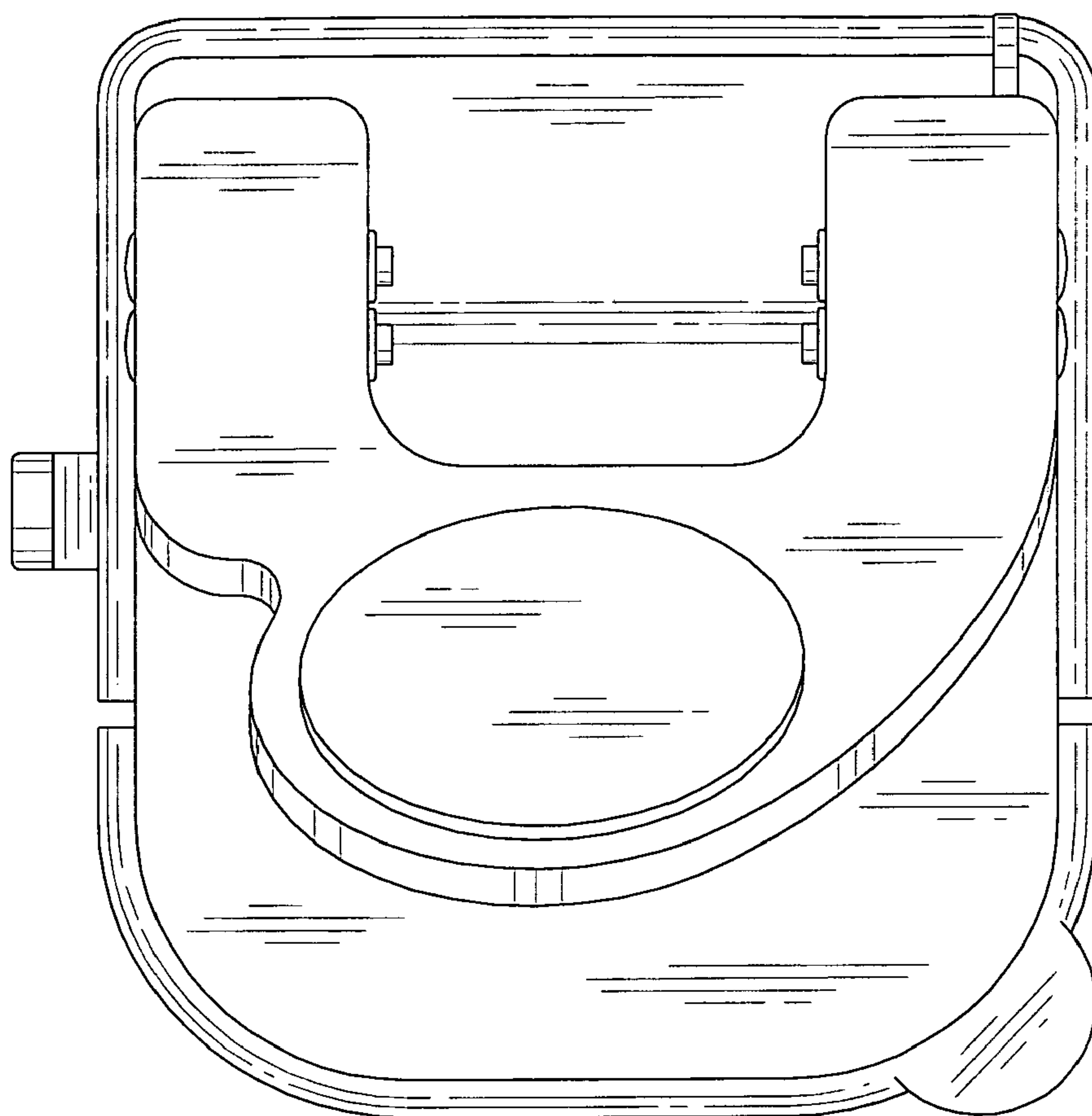

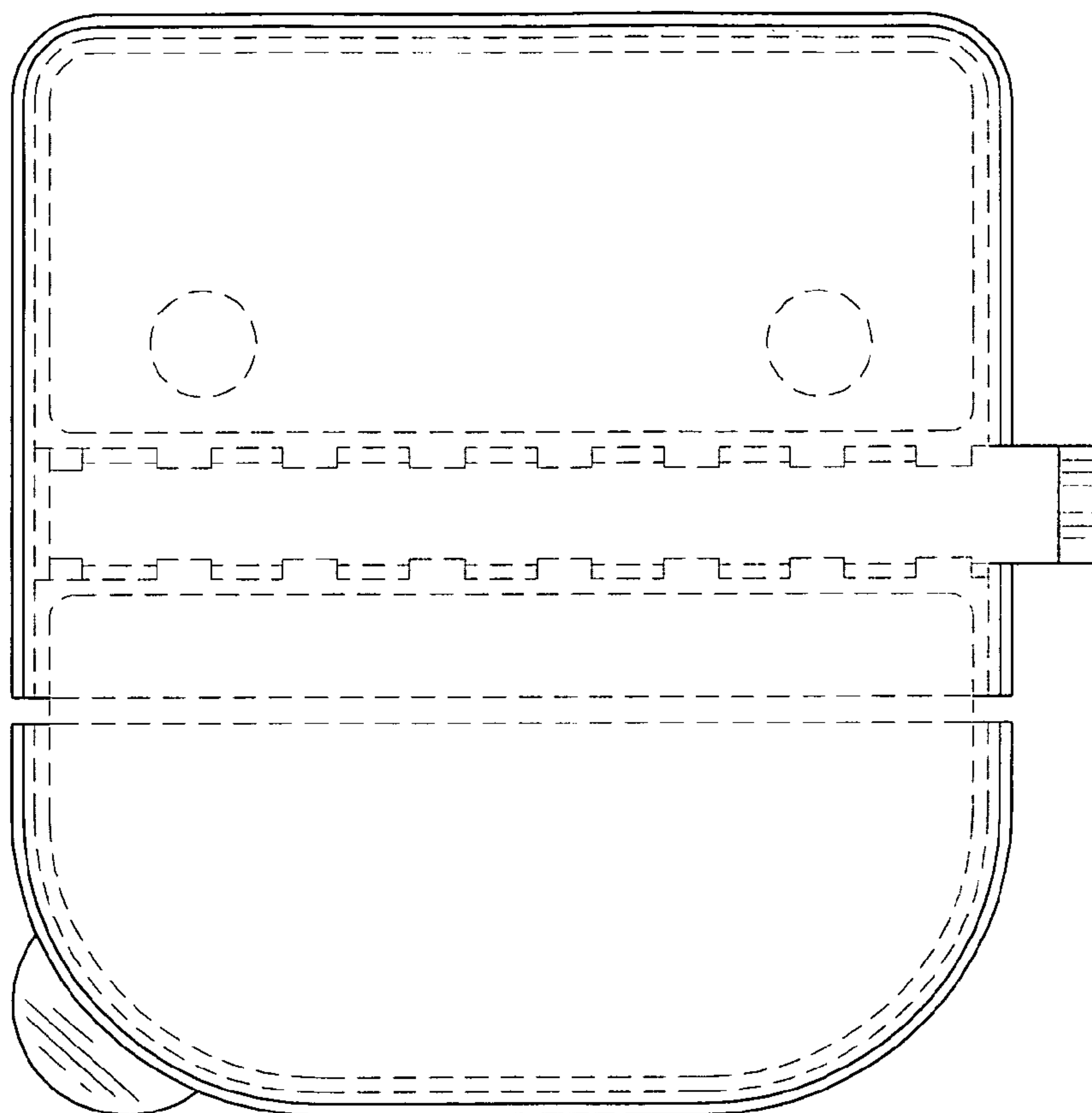

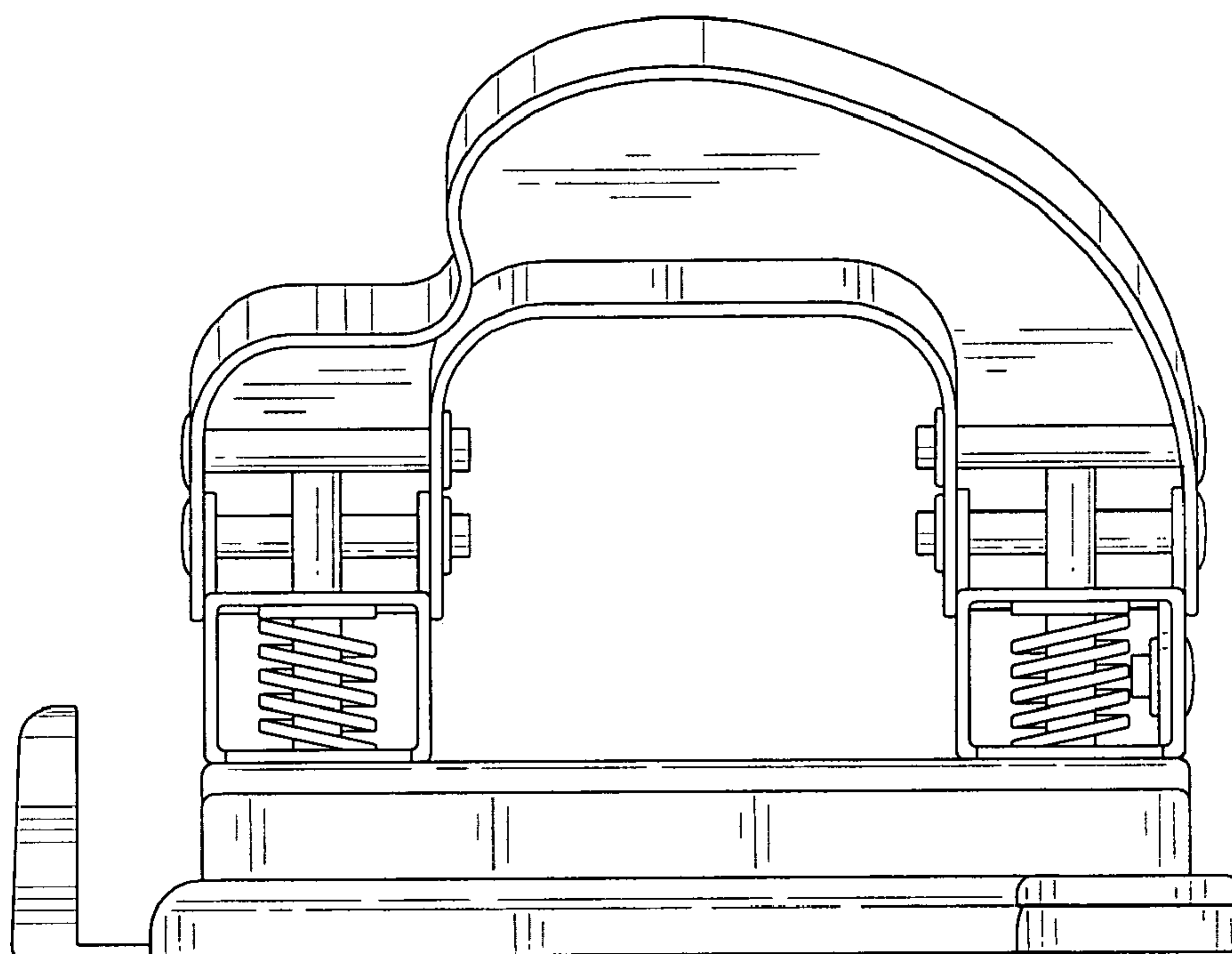

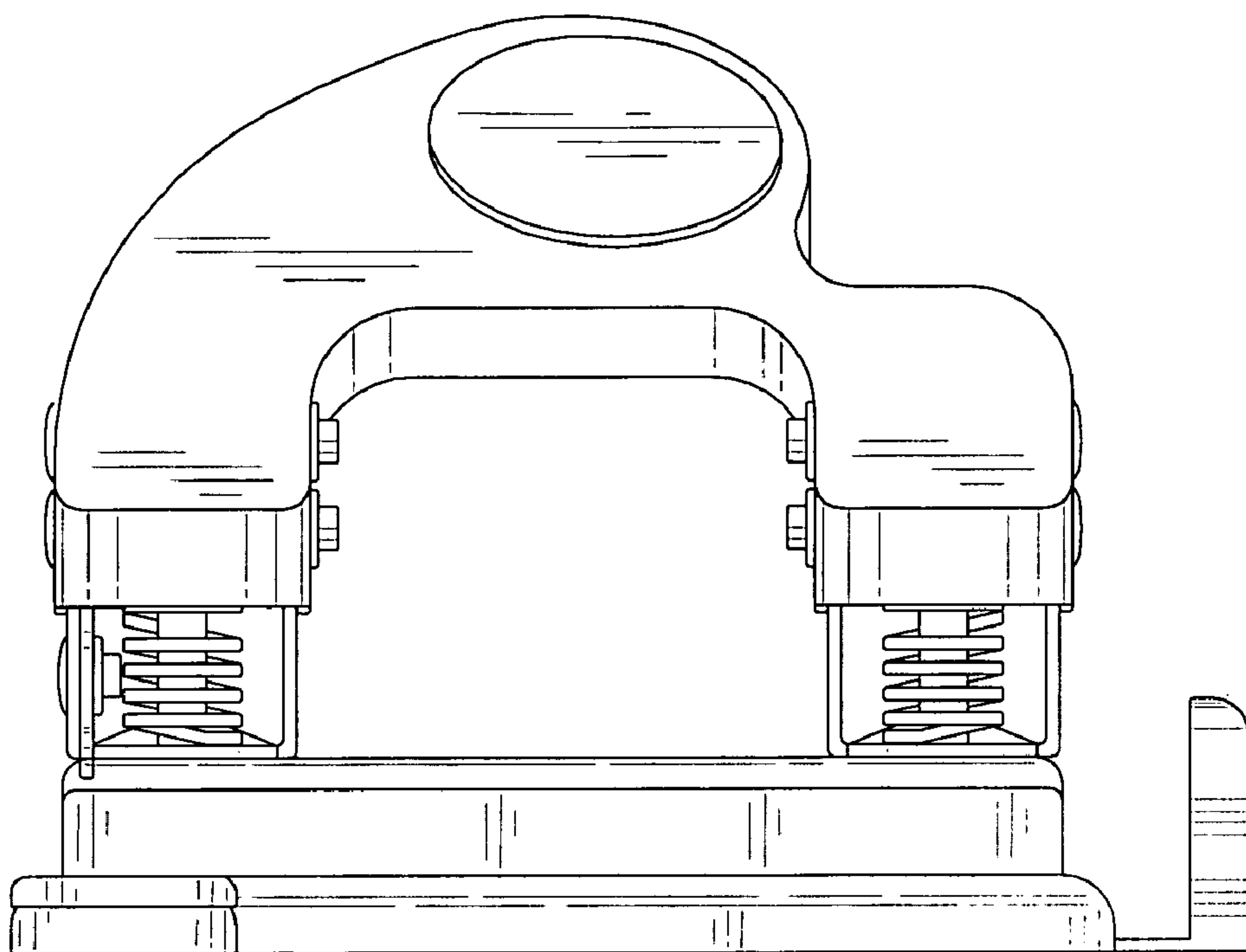
