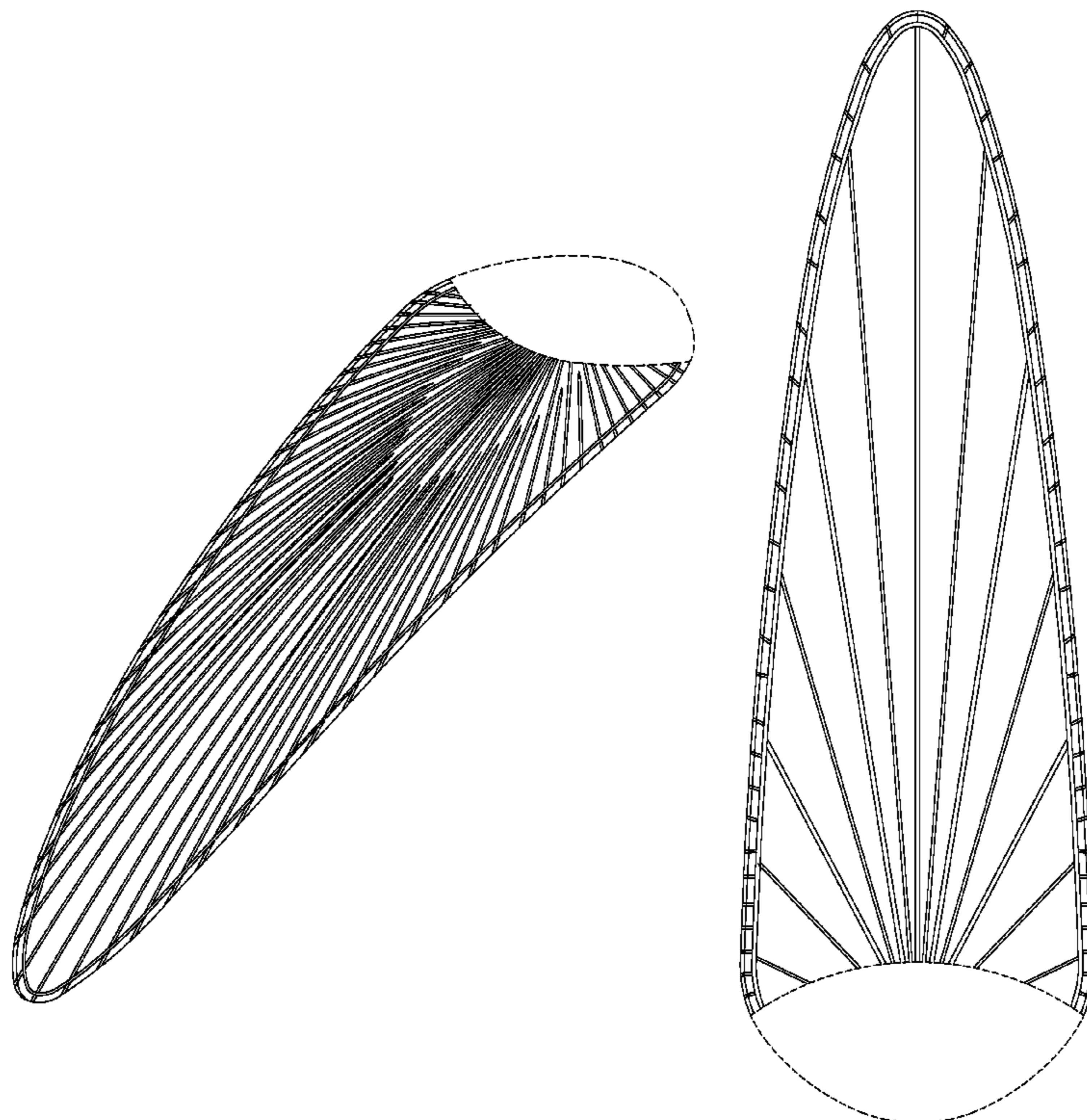
FIG. 5 is a right side elevational view showing the design for the fan blade of FIG. 1;

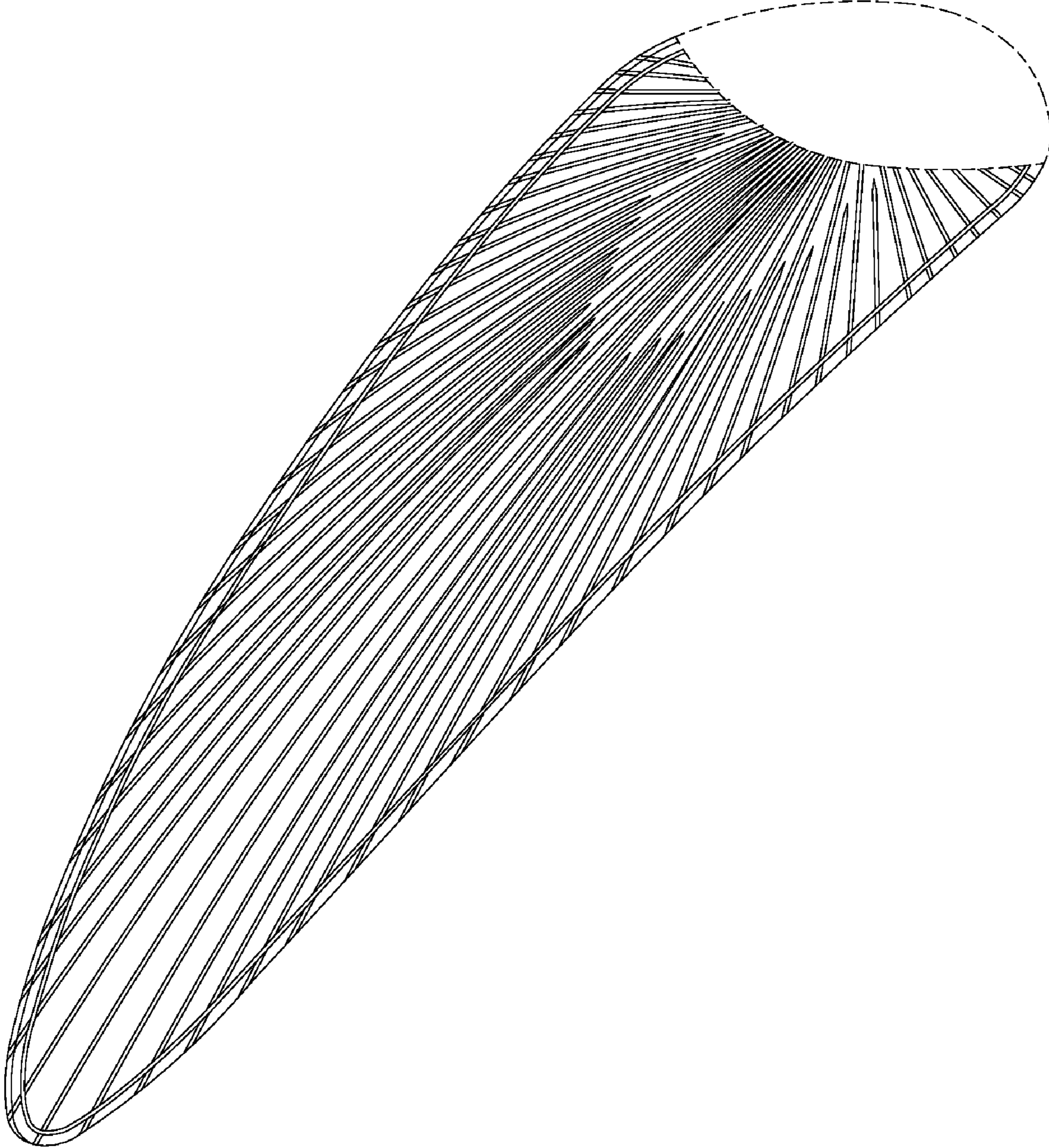

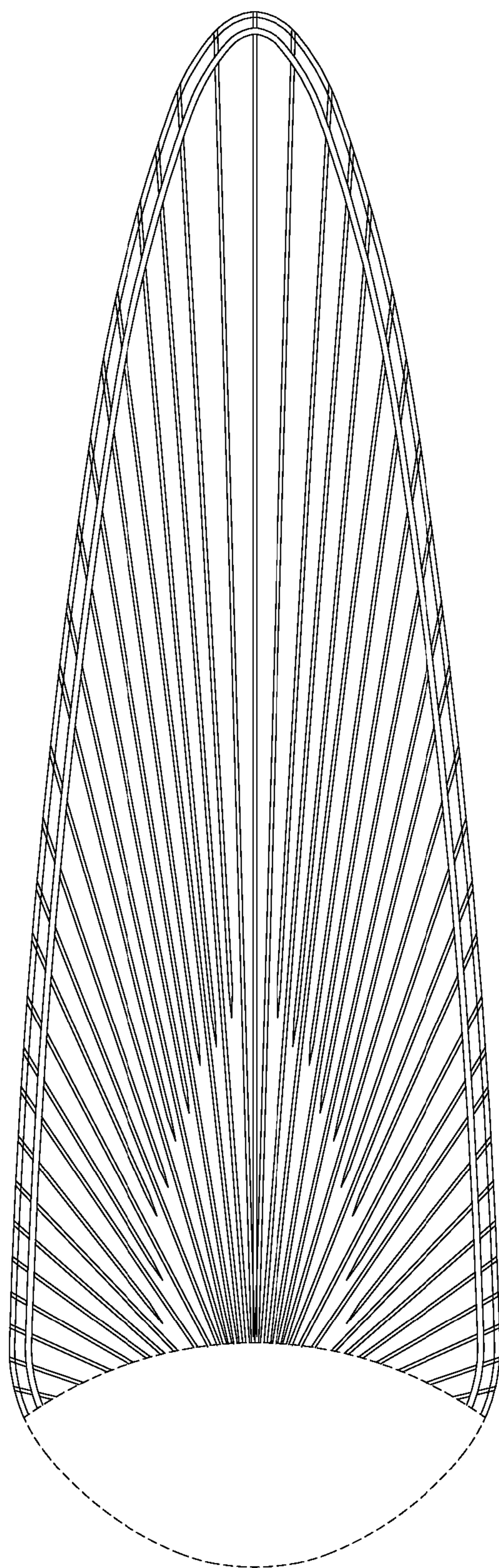

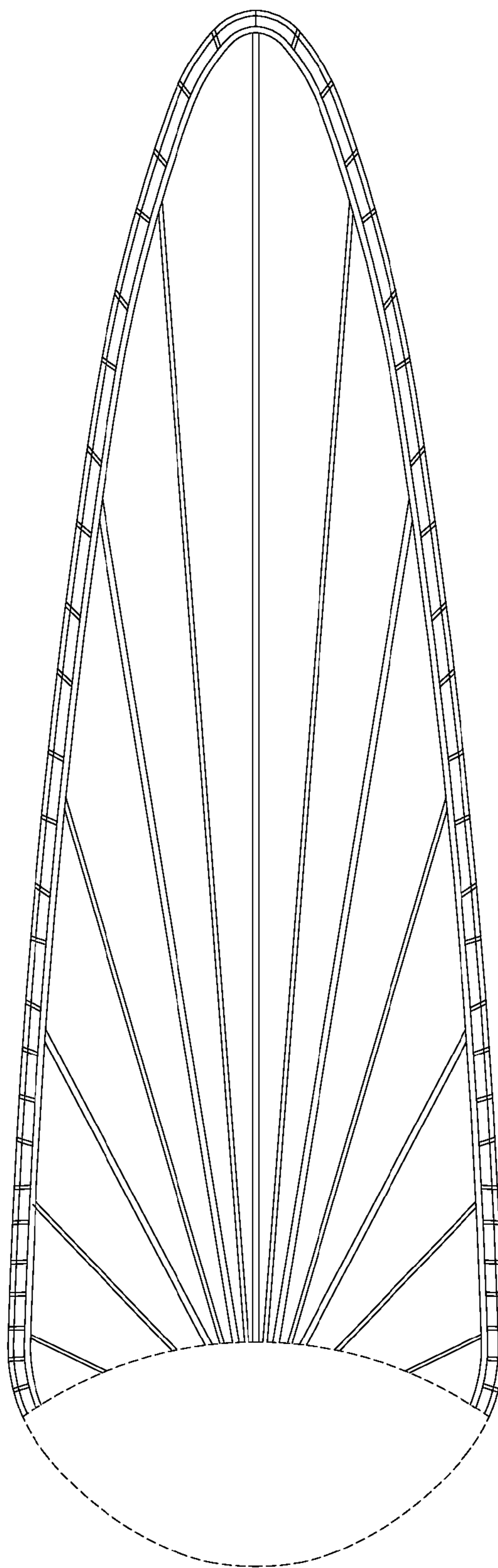

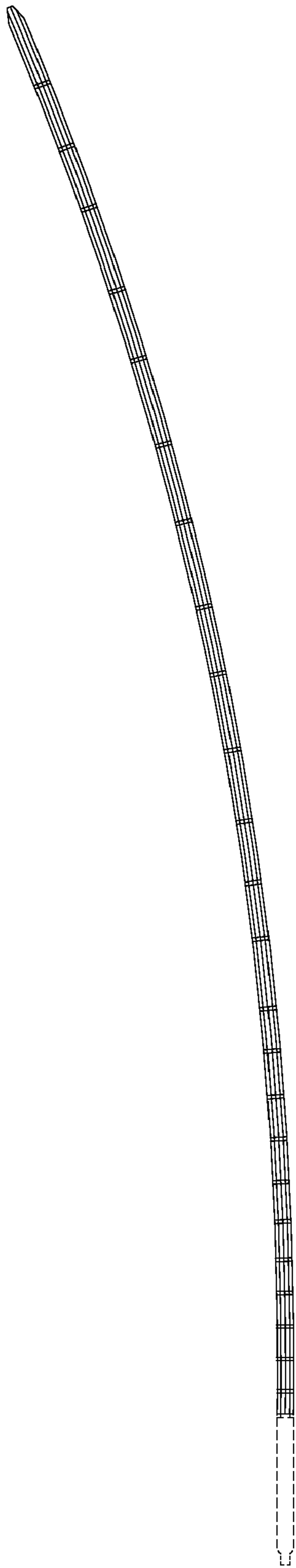

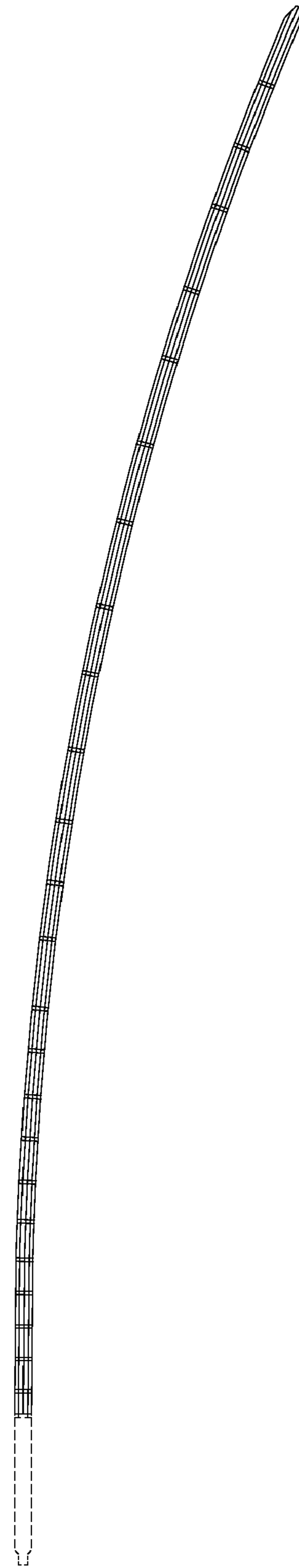

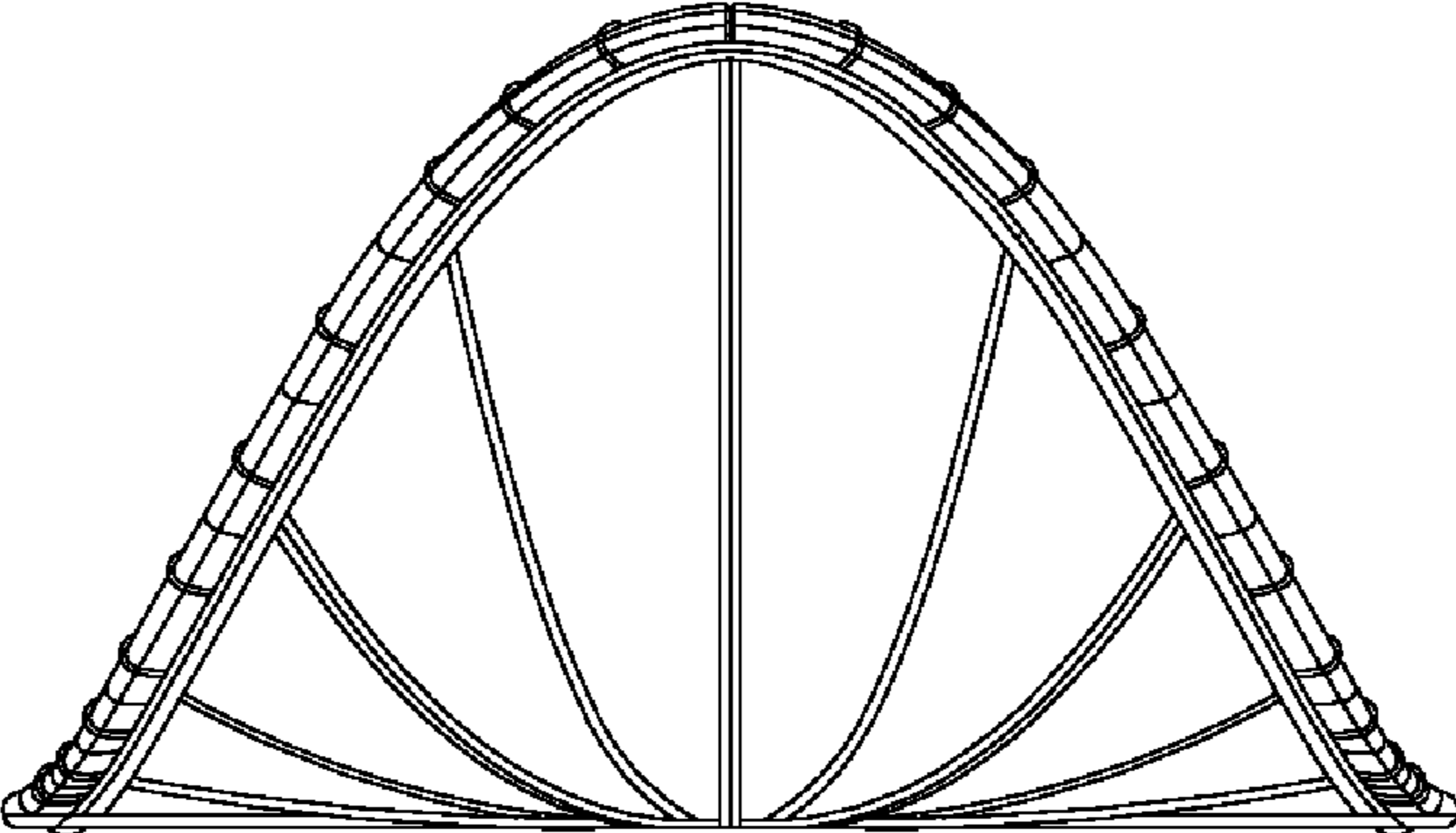

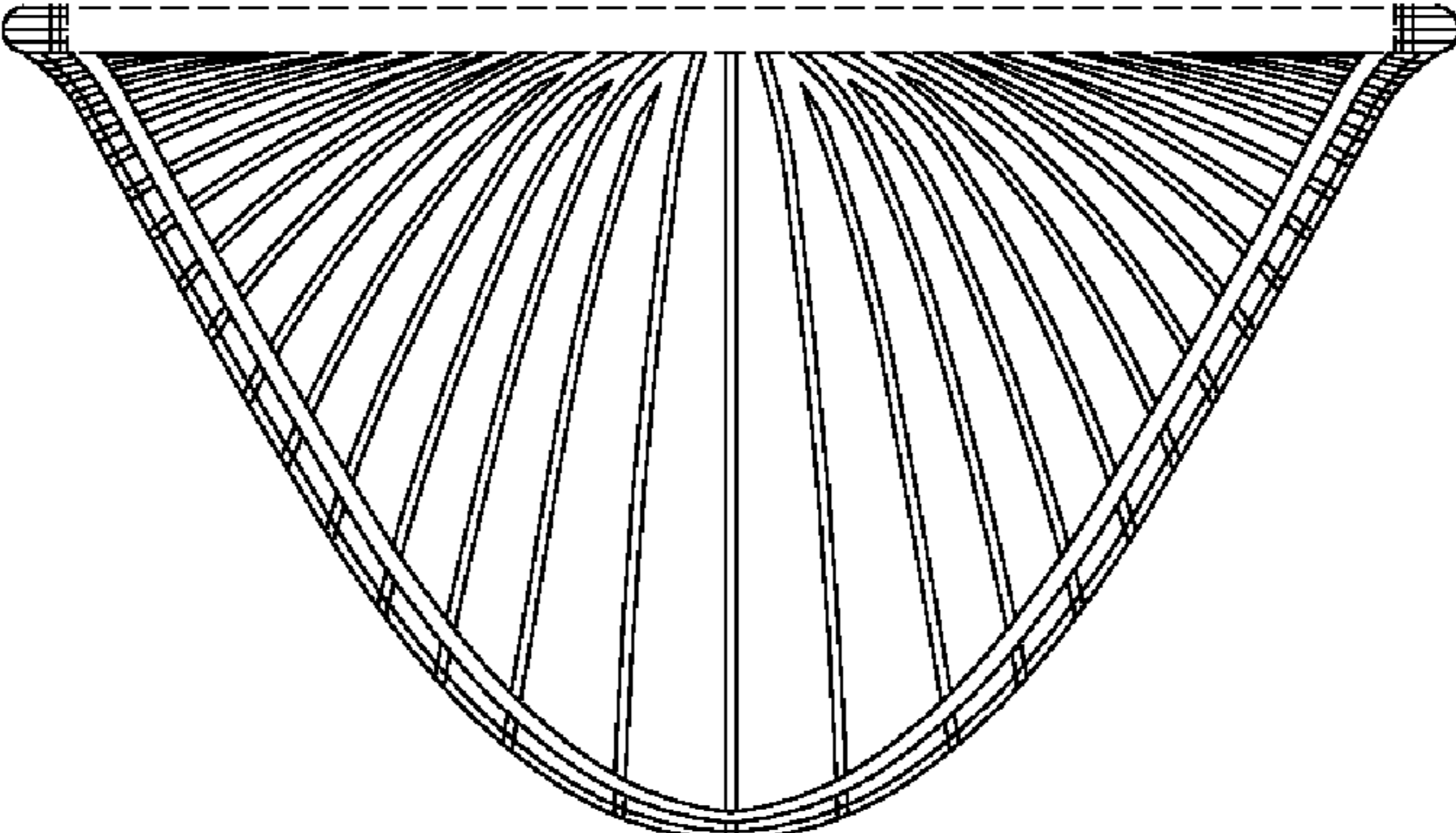
