FIG. 7 provides a bottom elevational view of a camouflage diaper.

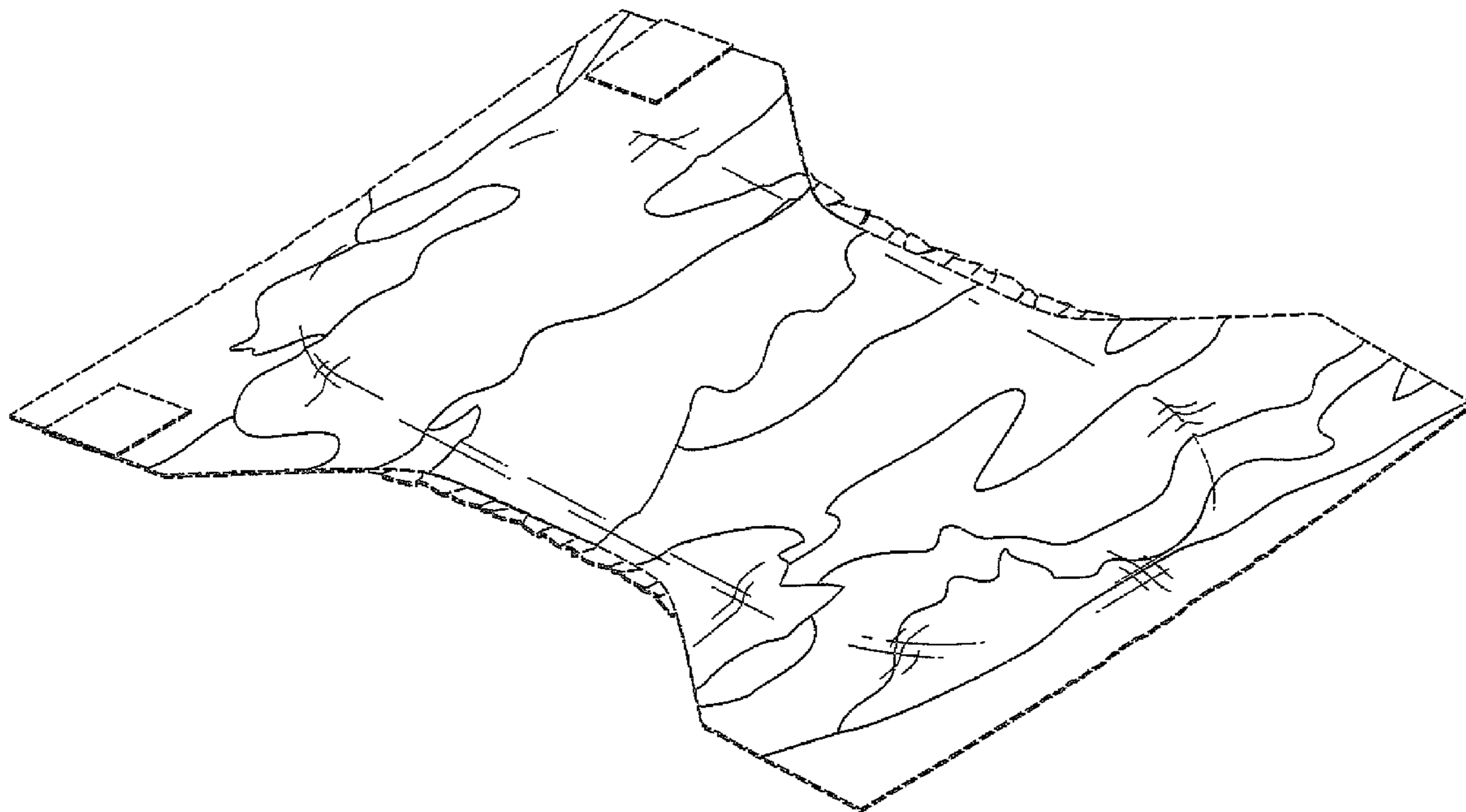

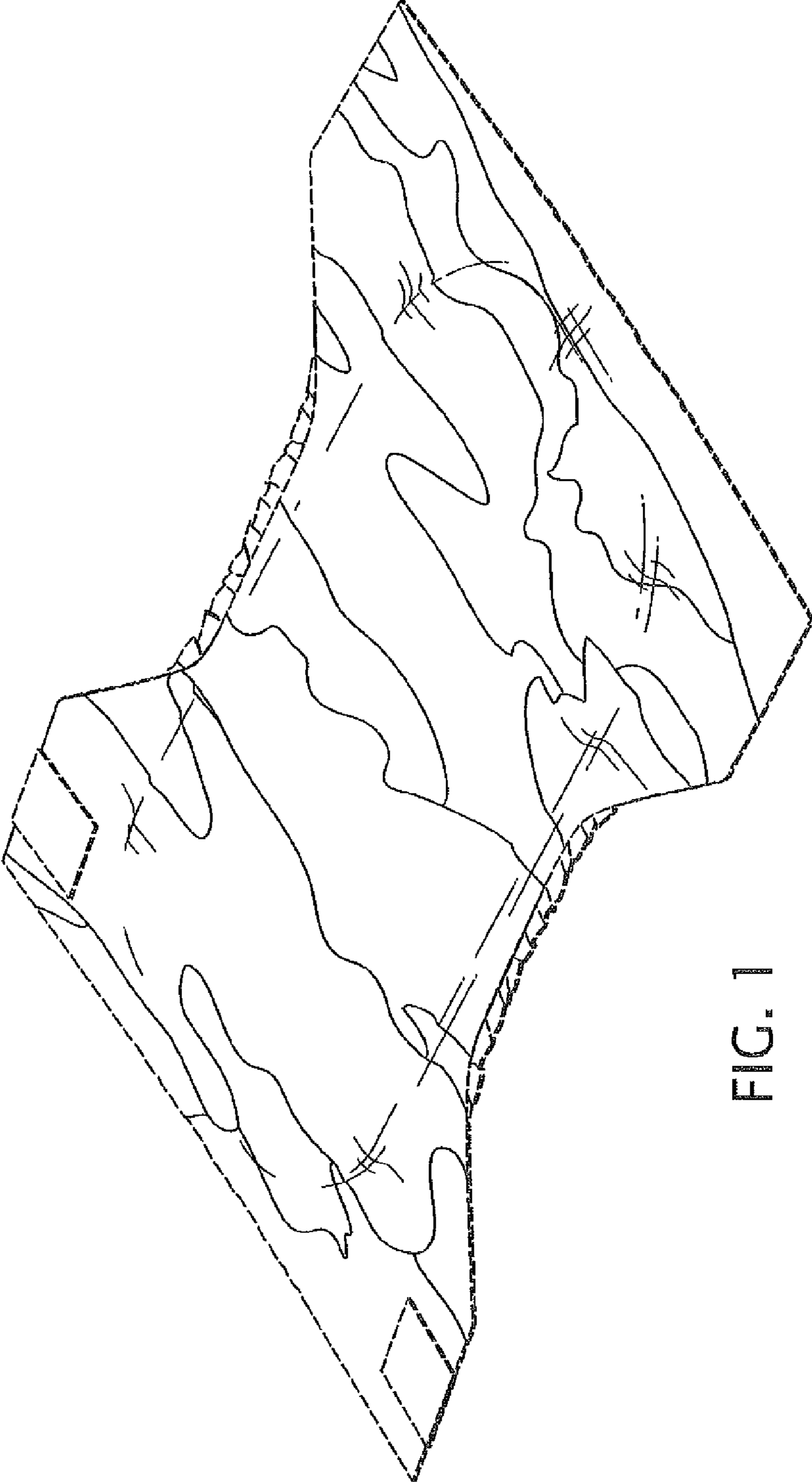

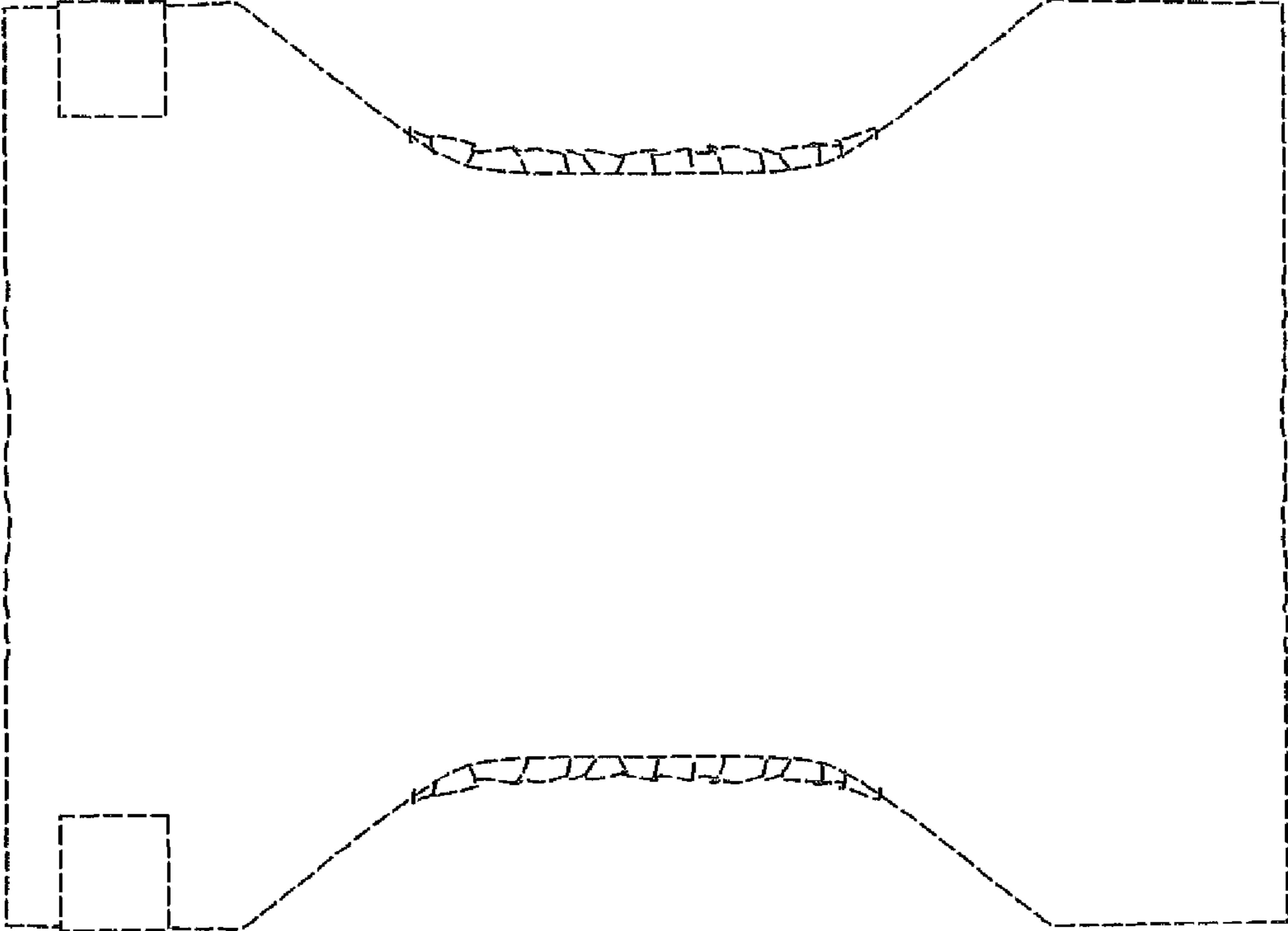

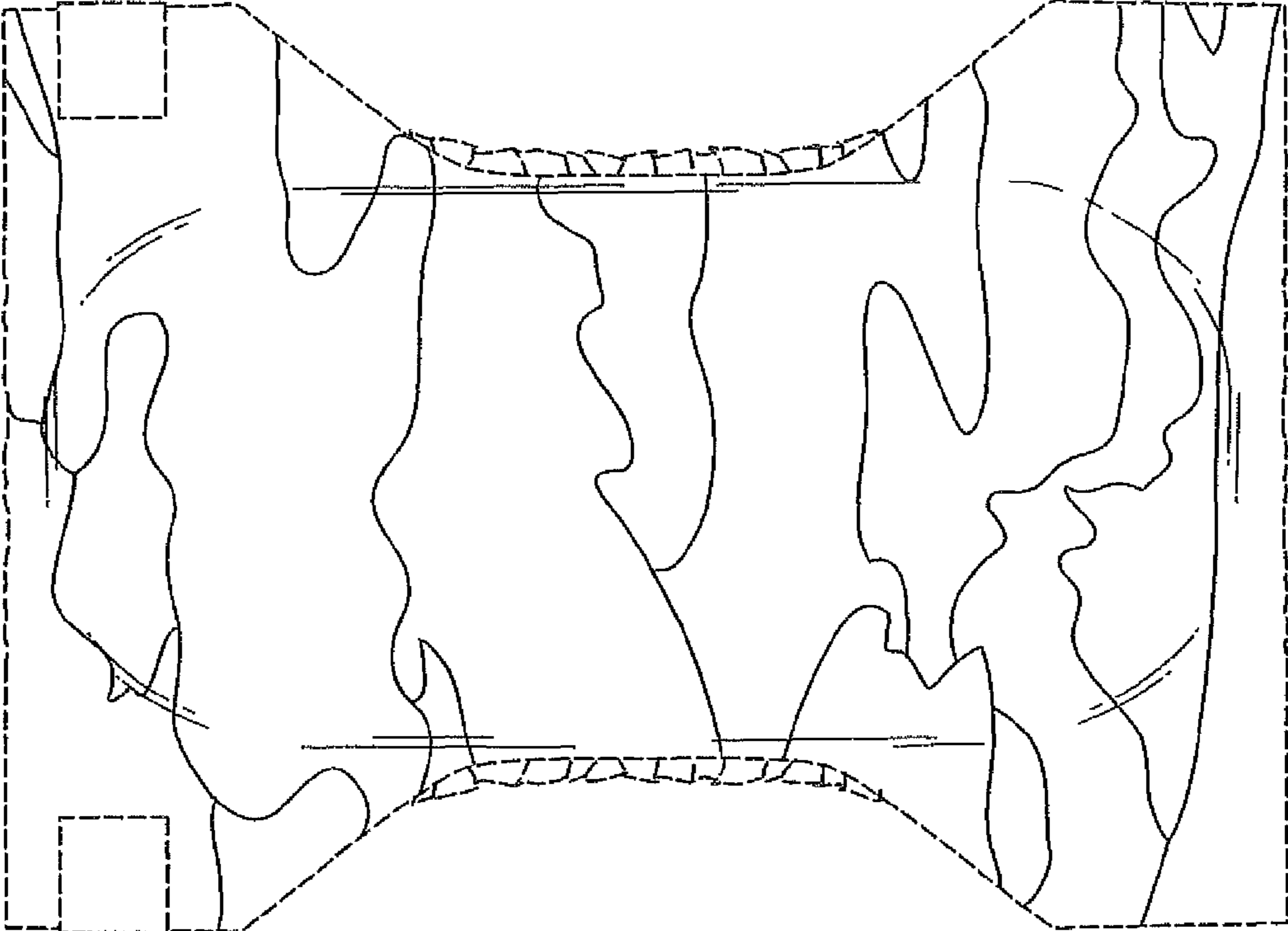

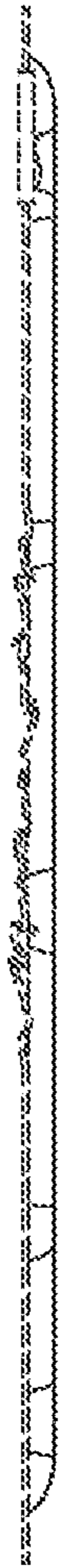

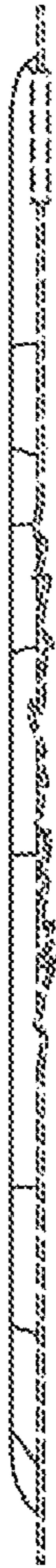

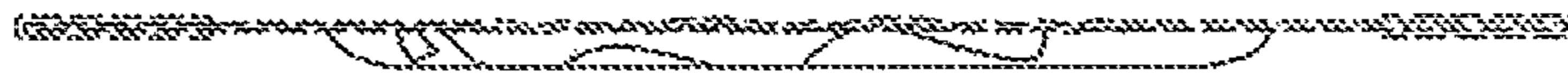

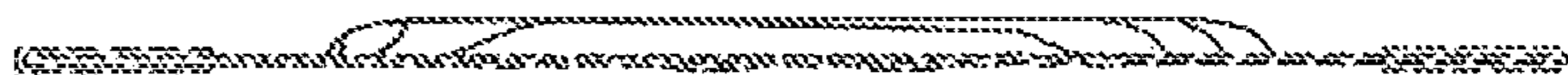
