FIG. 4 is a right side view of the prosthesis;

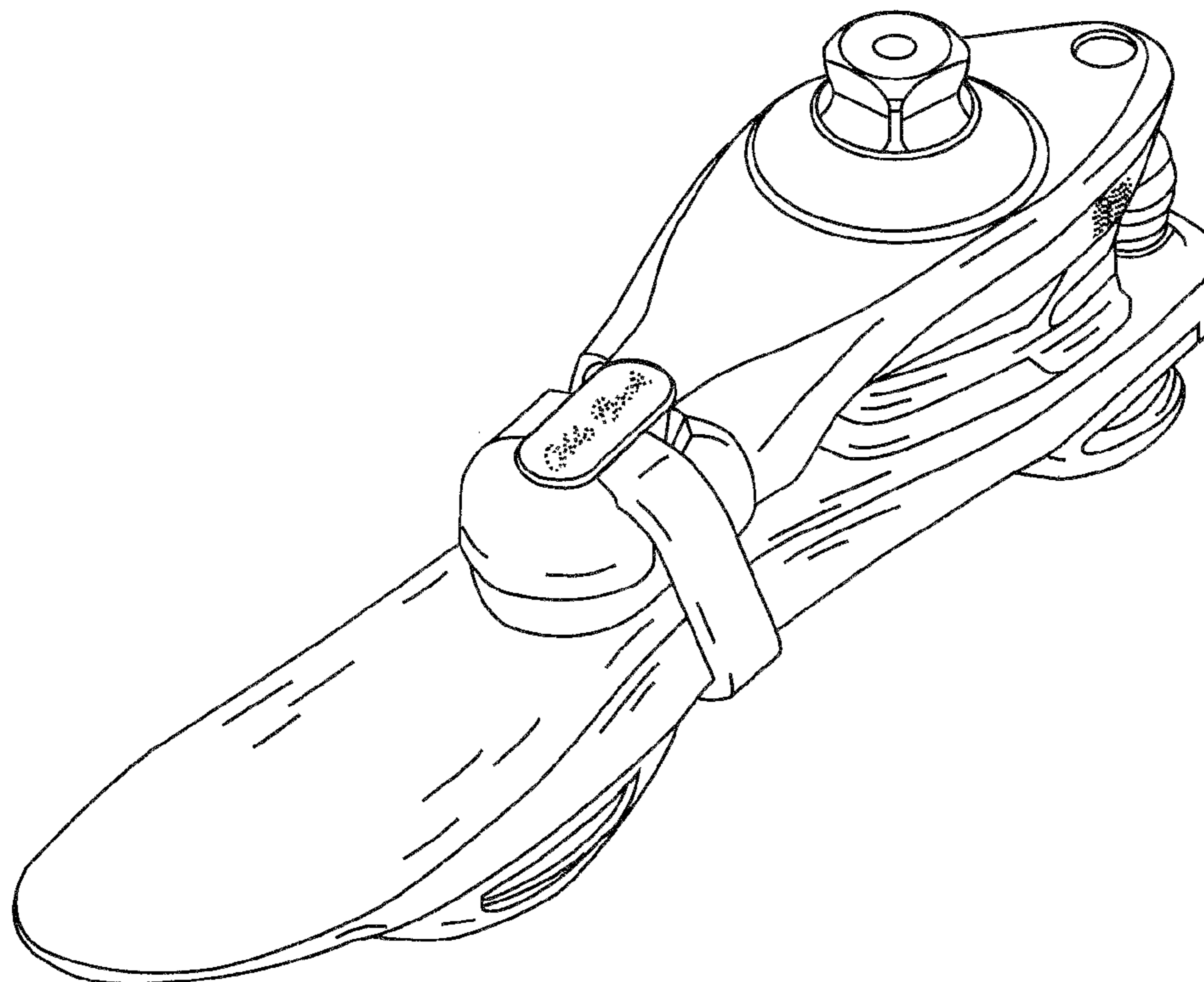
FIG. 5 is a front view of the prosthesis; and

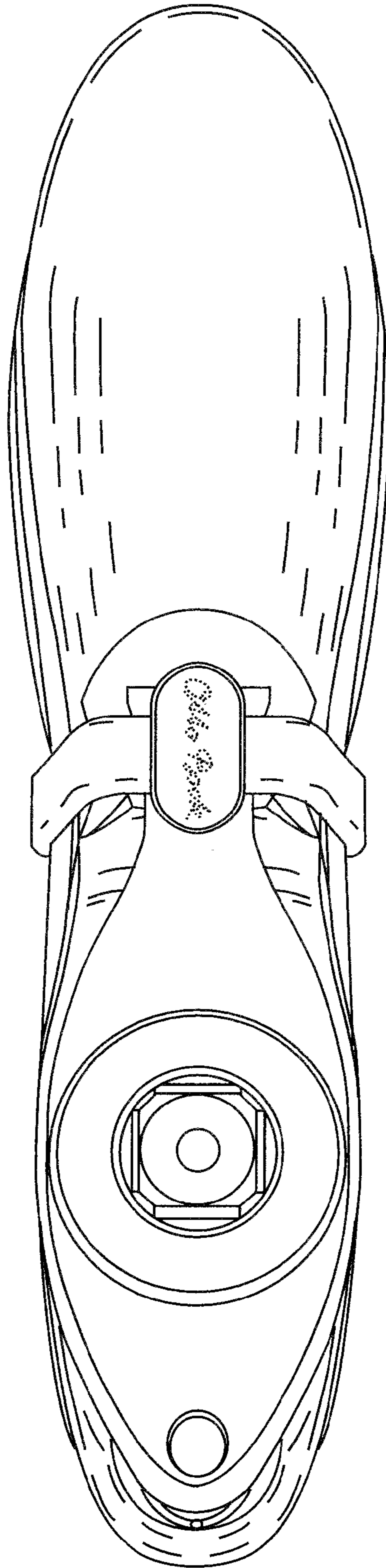

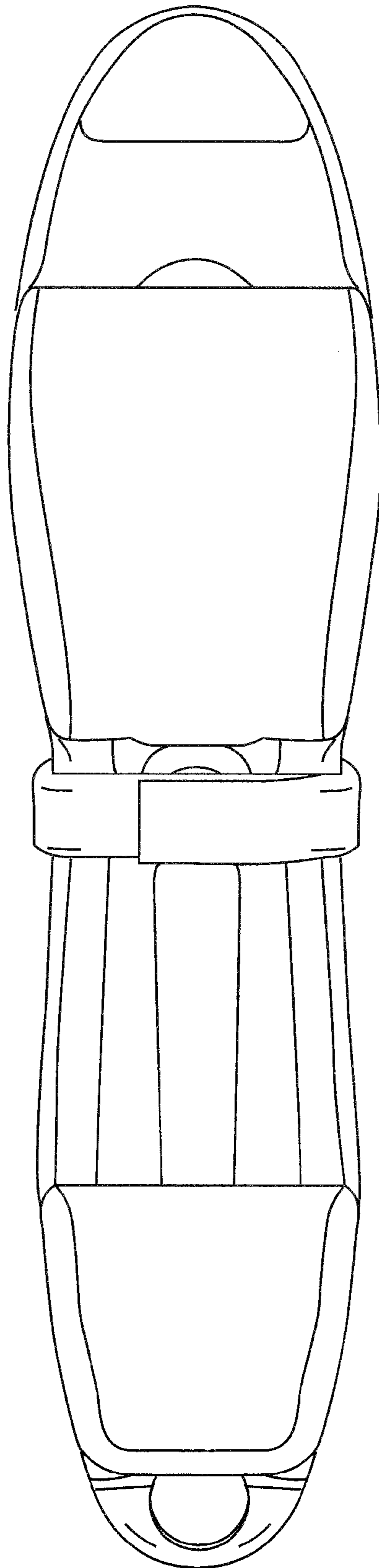

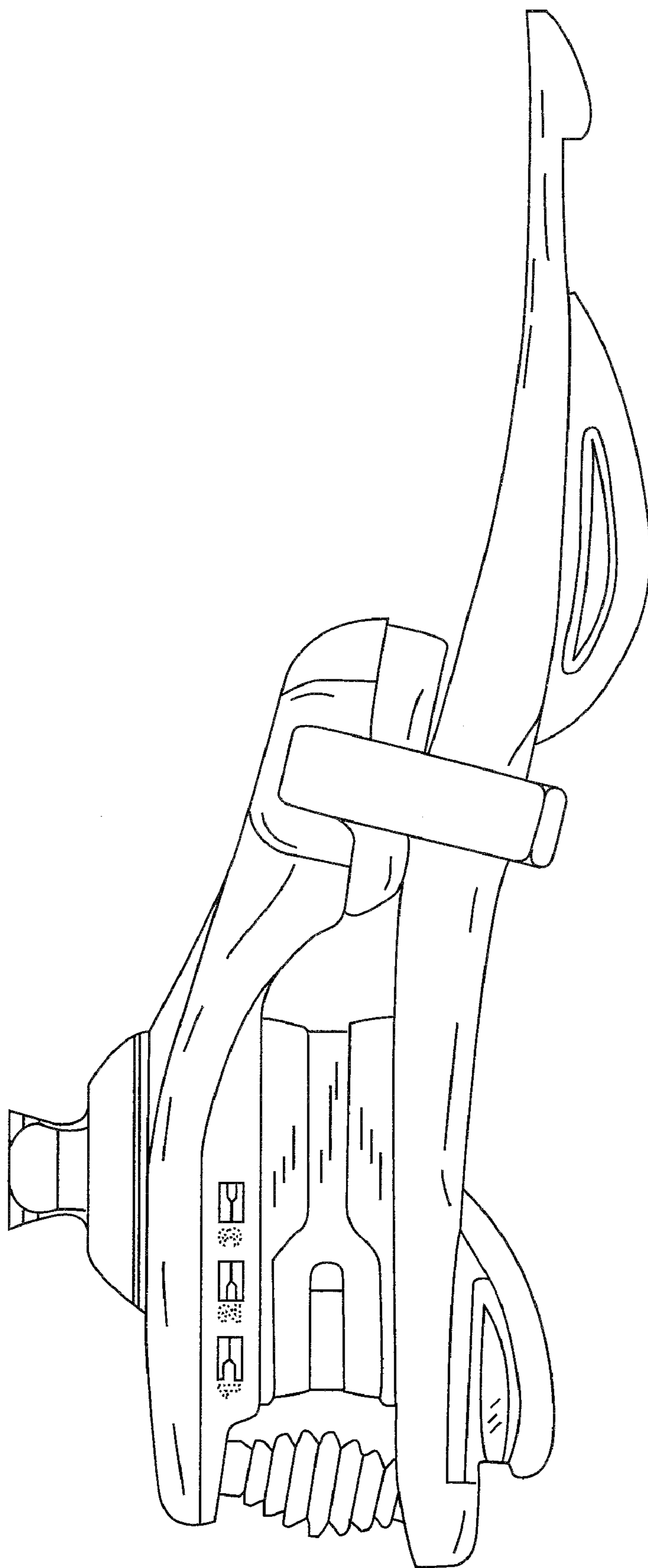

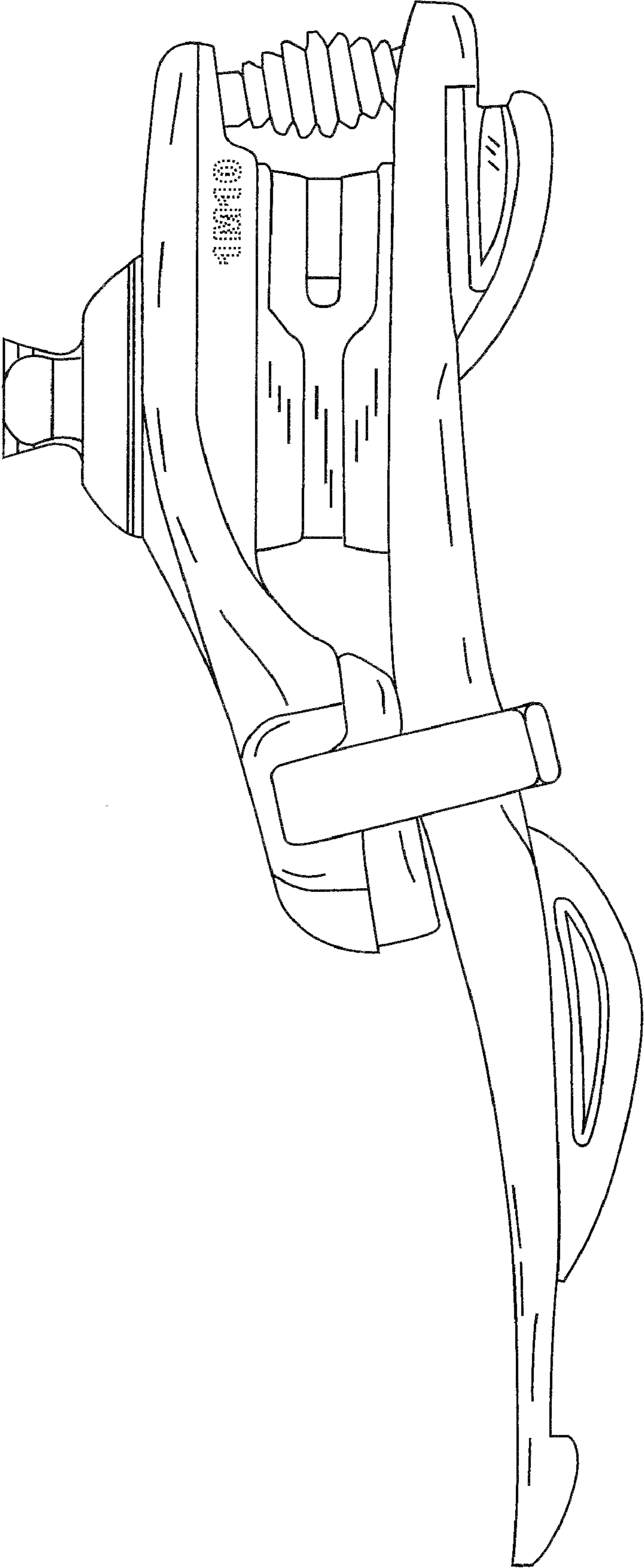

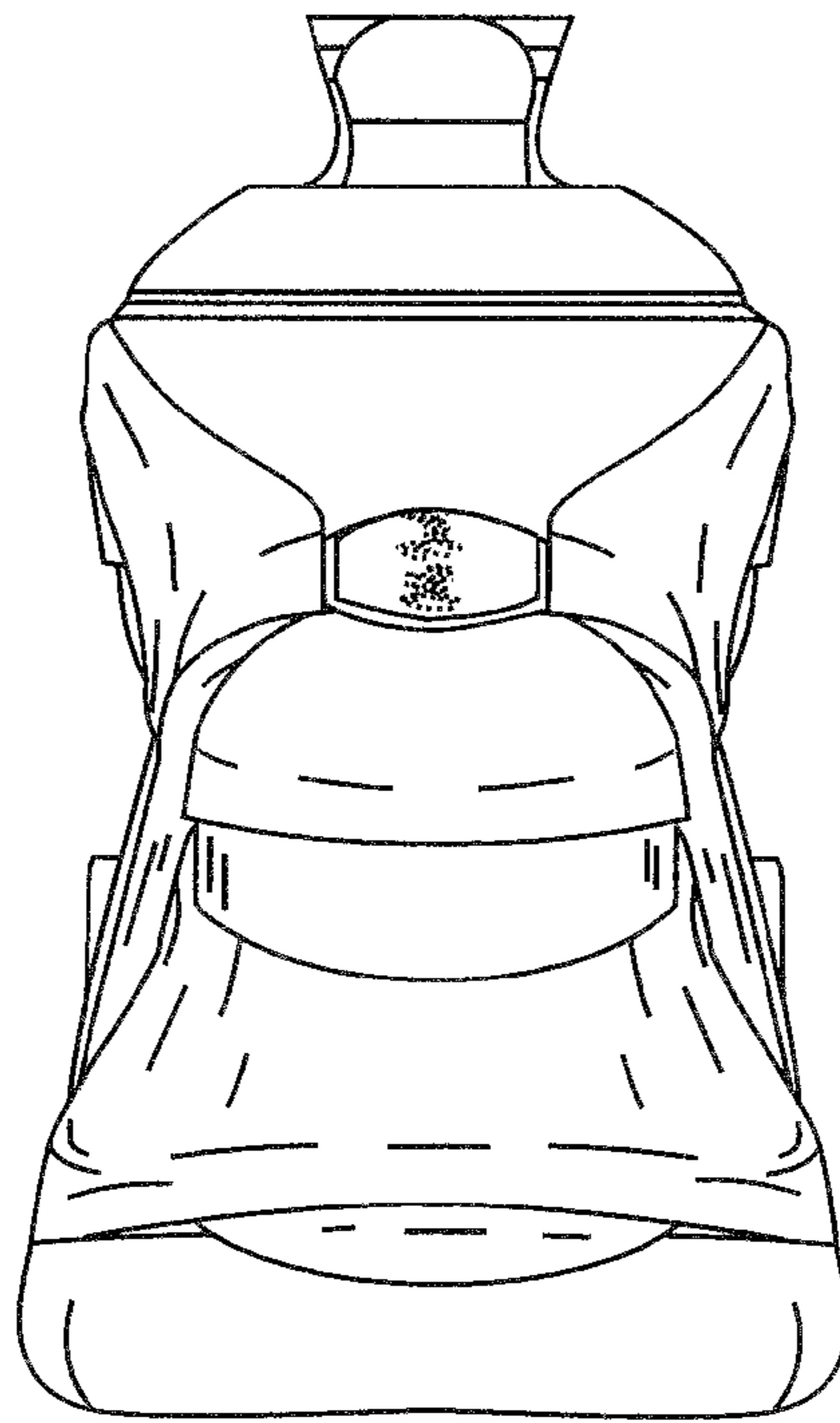

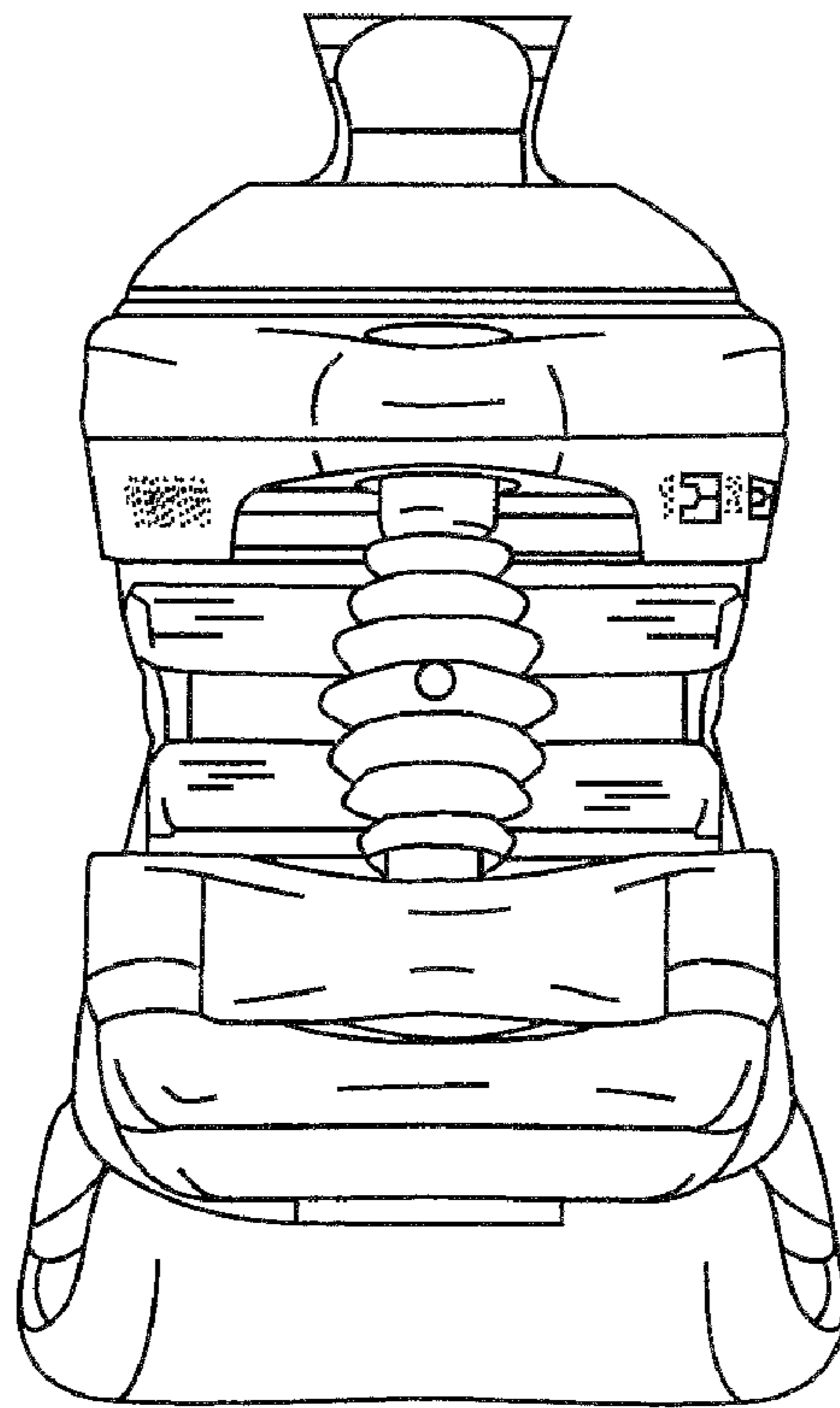

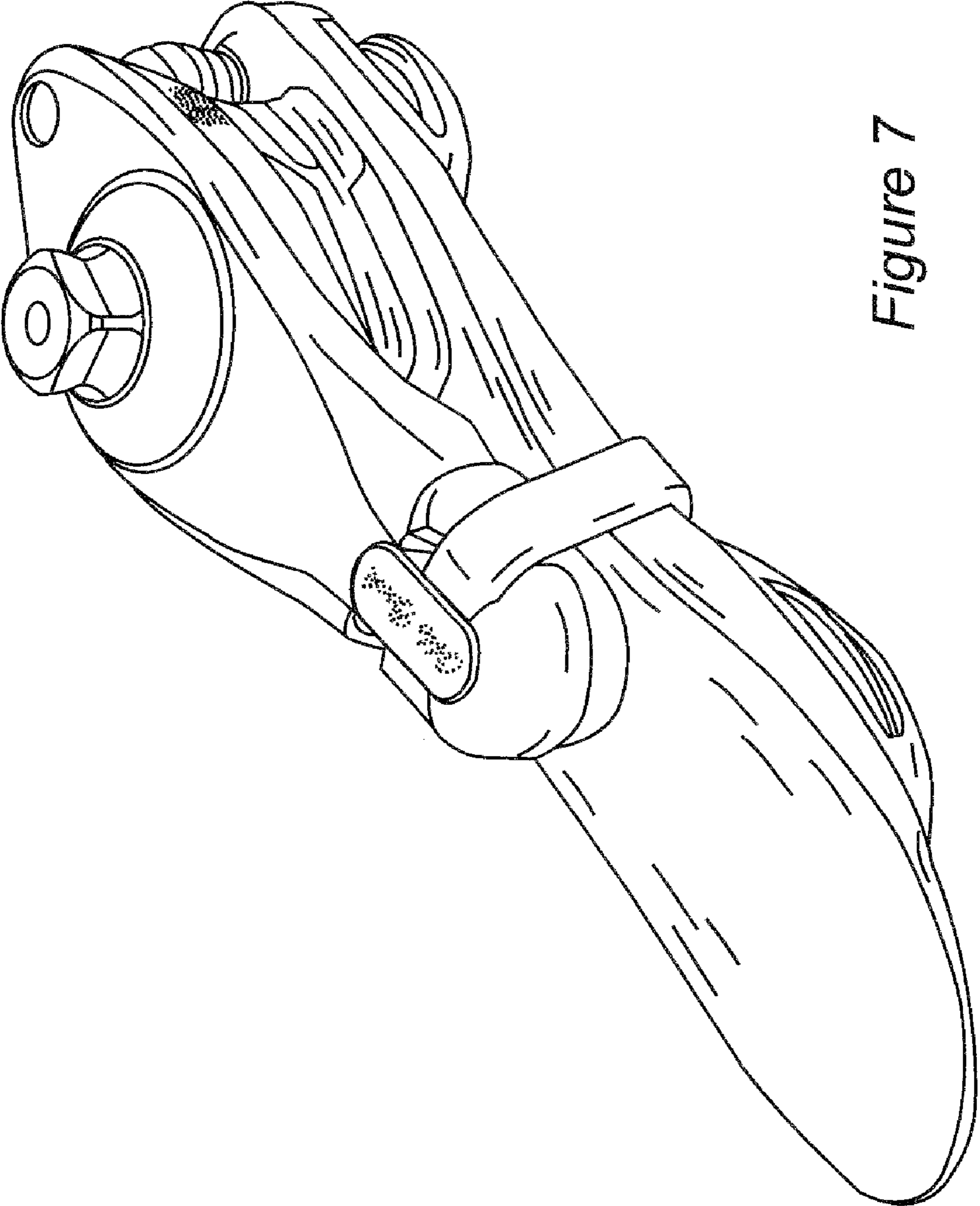
