(57) **CLAIM**

The ornamental design for a glove for holding a drinking container, as shown and described.

DESCRIPTION

FIG. 1 is a top, back, left side, perspective view of the glove for holding a drinking container of my new design showing the cuff in an unattached position for clarity of disclosure.

FIG. 2 is a top, front, right side, perspective view showing my new design as worn by a baby and holding a bottle;

FIG. 3 is a left side elevation view;

FIG. 4 is a top plan view;

FIG. 5 is a front elevation view;

FIG. 6 is a rear elevation view;

FIG. 7 is a right side elevation view; and,

FIG. 8 is a bottom plan view.

The broken lines showing a hand and a baby bottle in FIG. 2 illustrate environmental structure which forms no part of the claimed design.

It is understood that the broken lines within the claimed design indicates stitch lines, which form part of the claim.

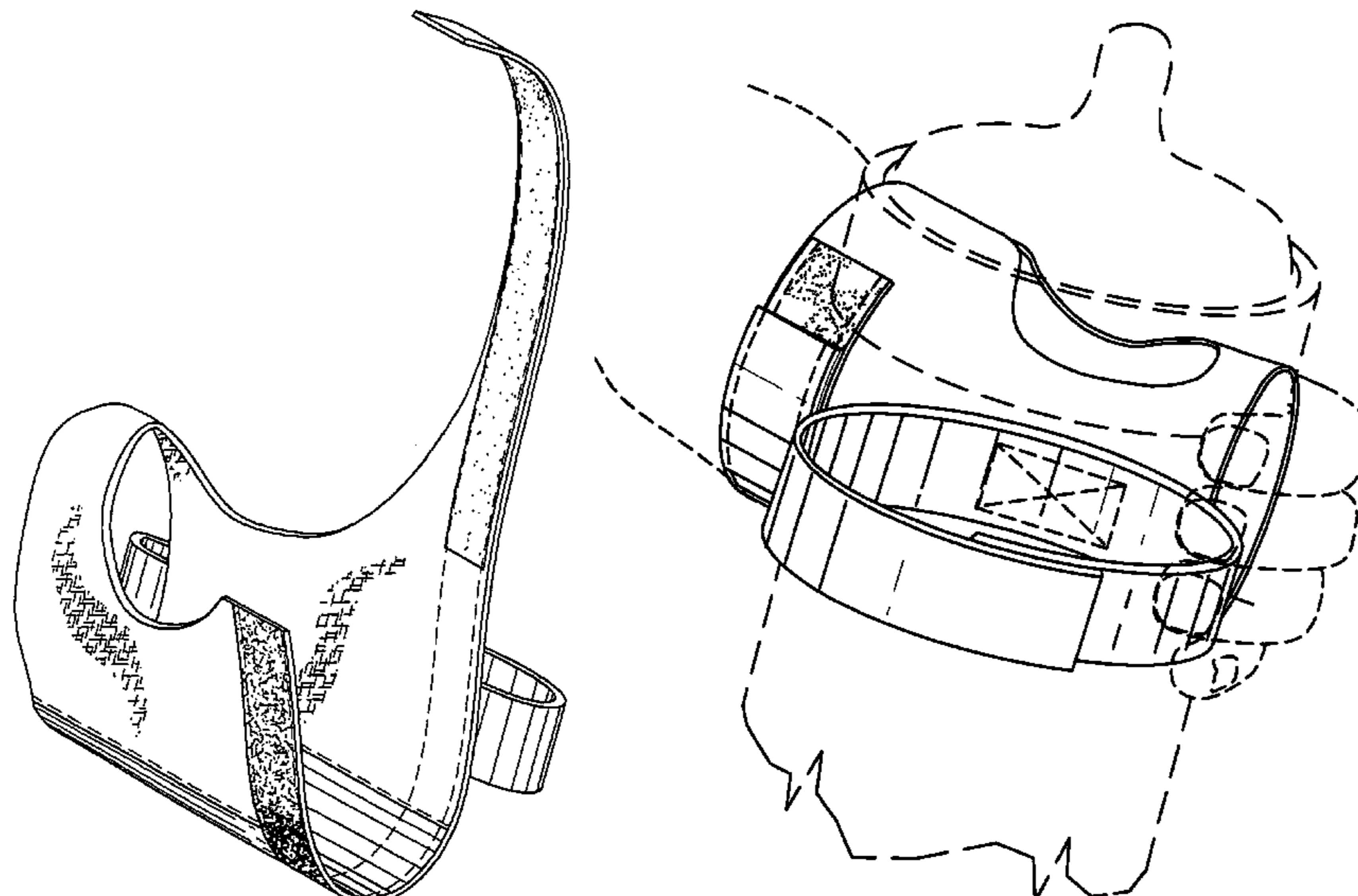

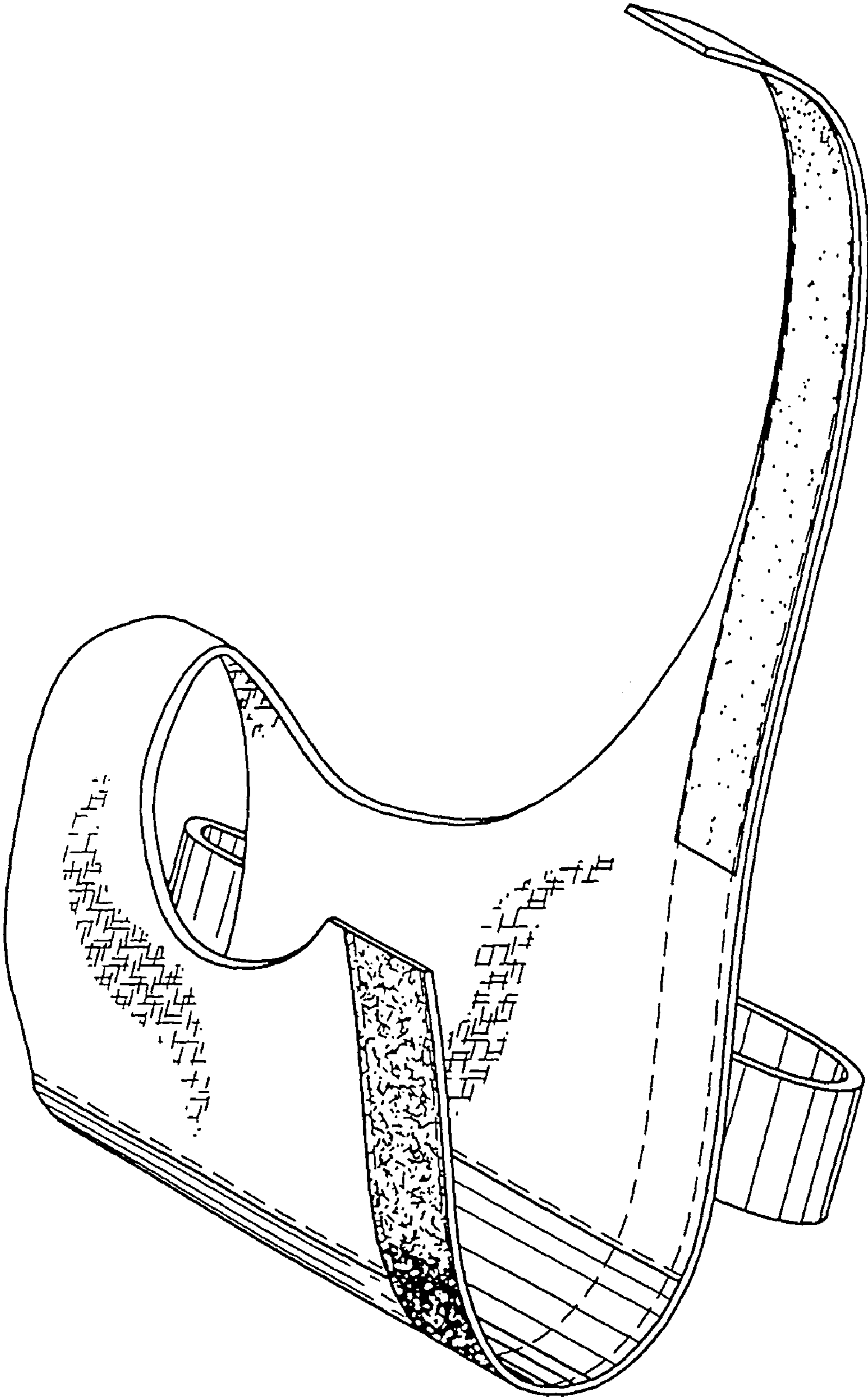
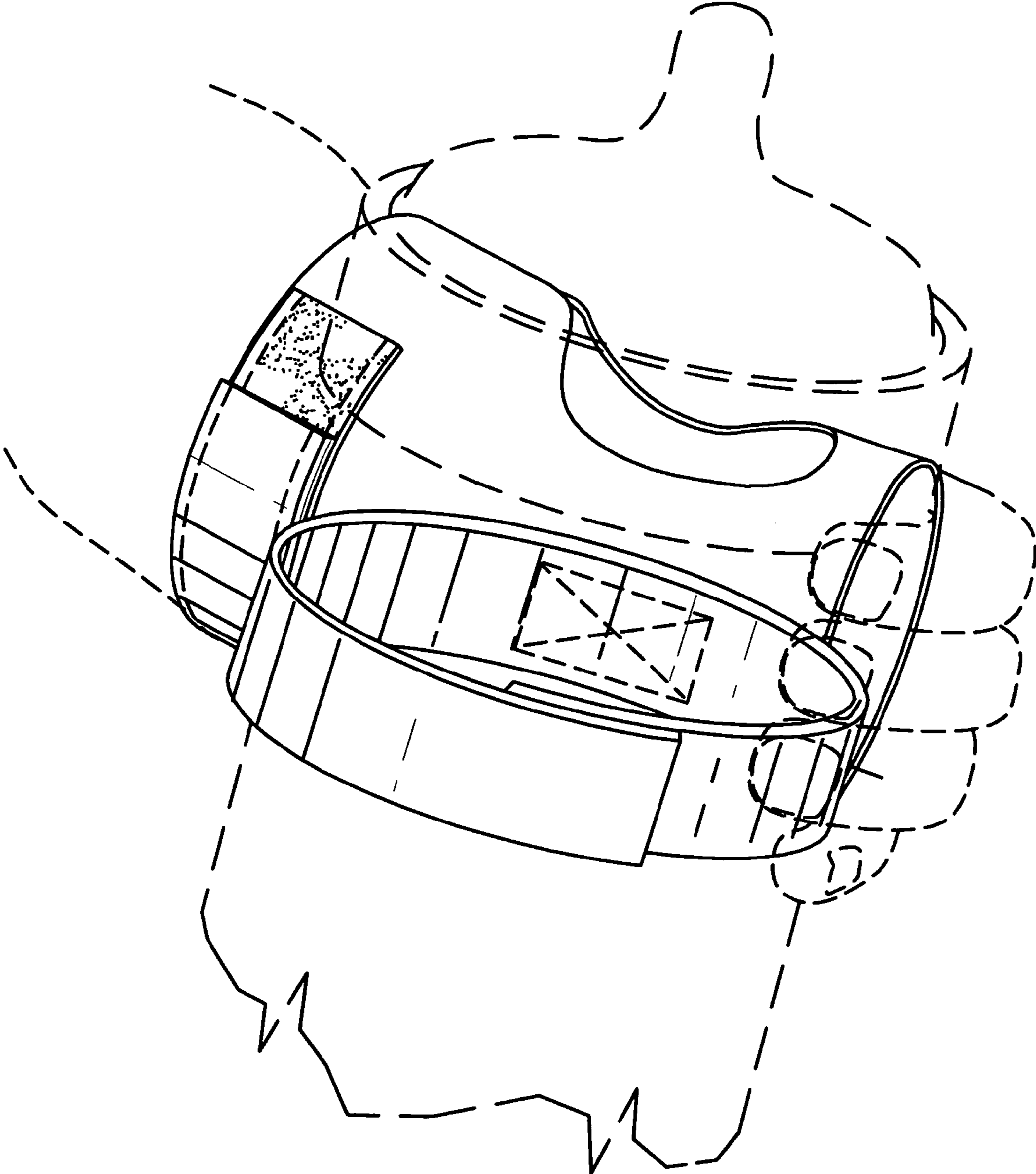

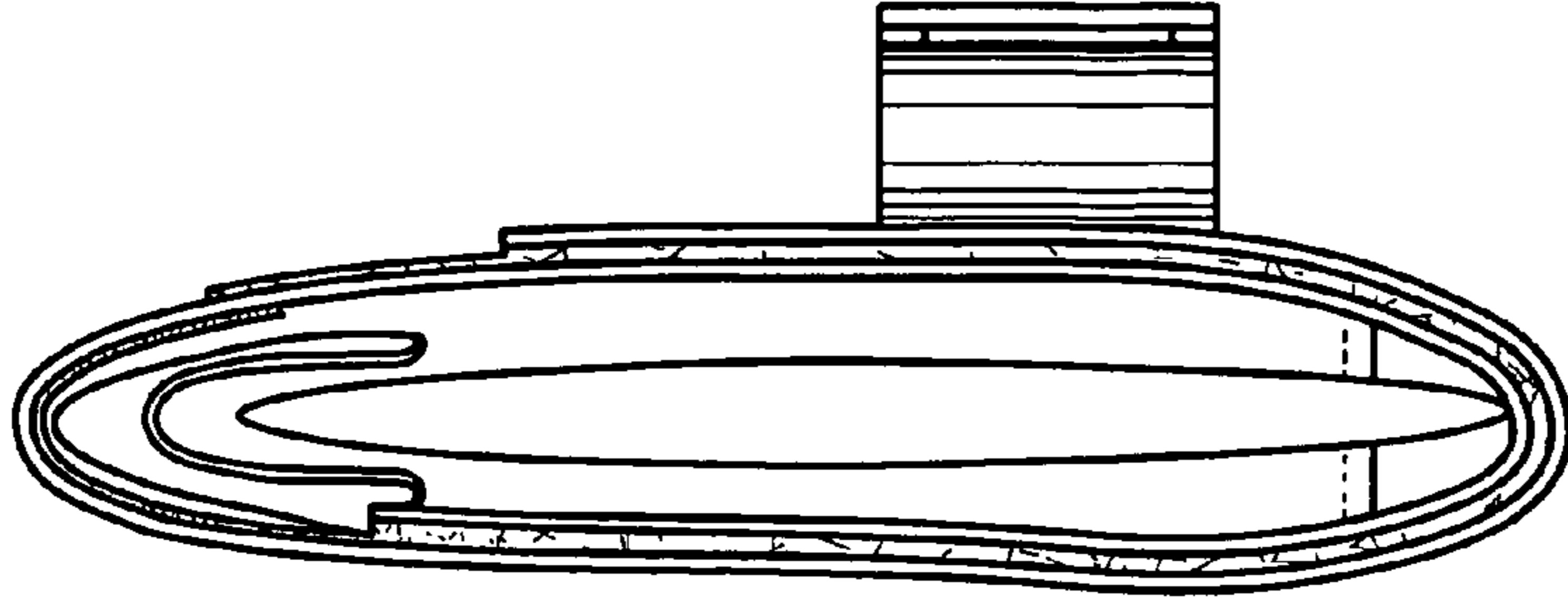

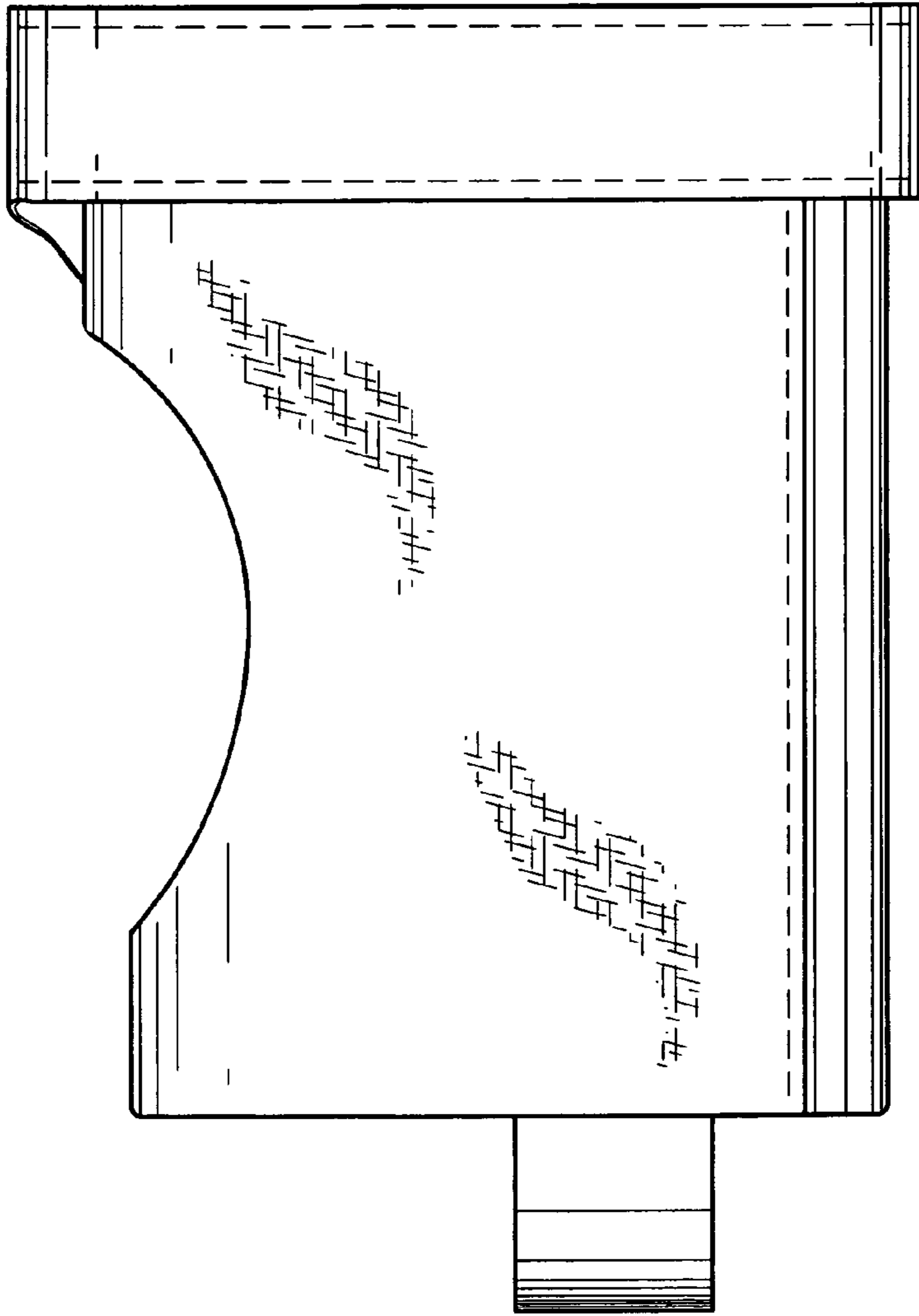

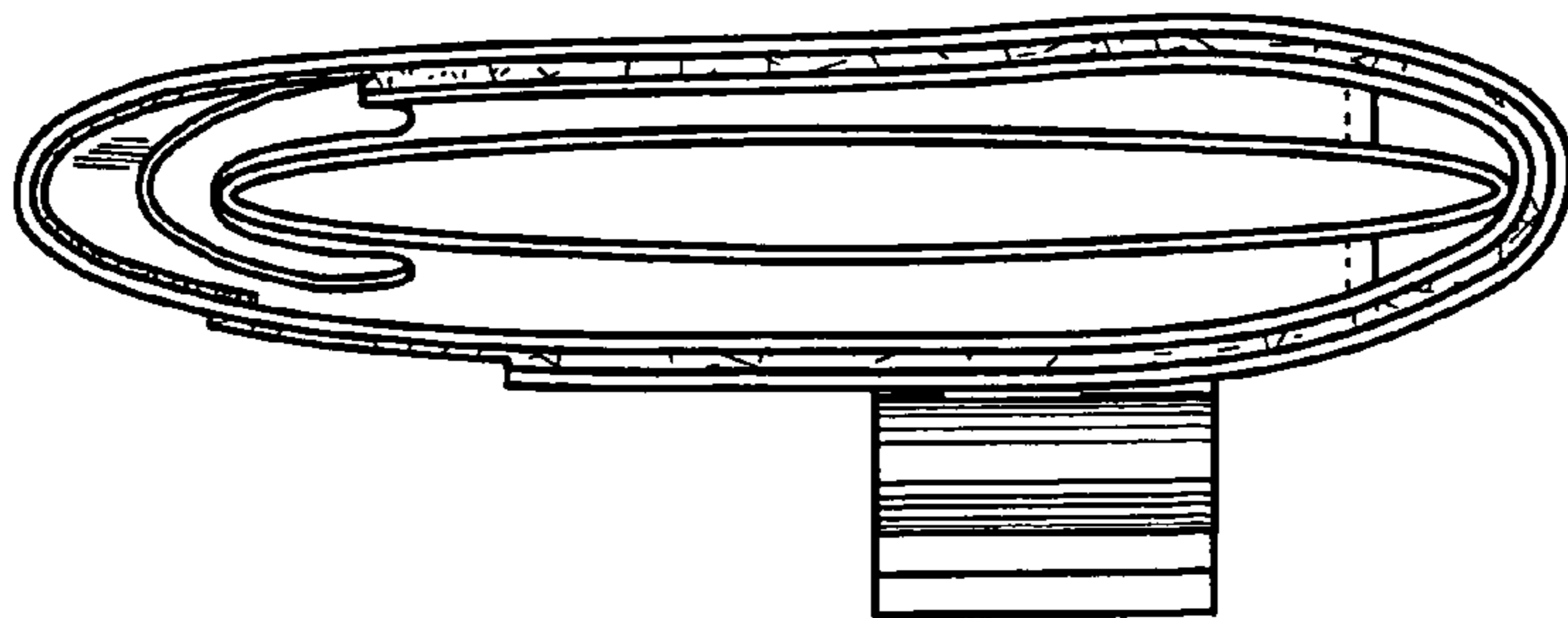

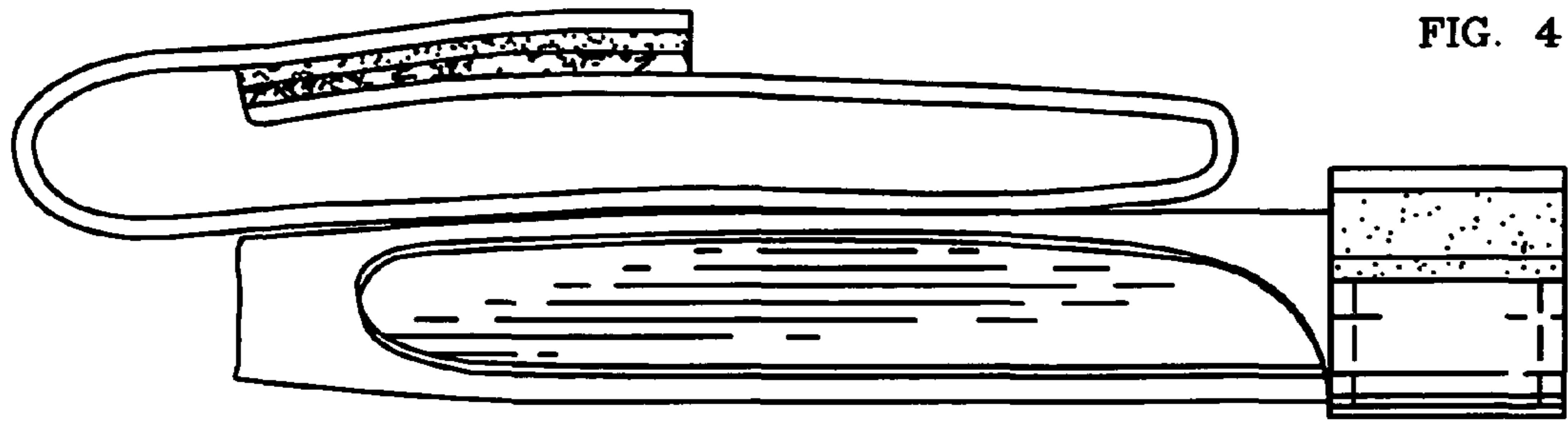

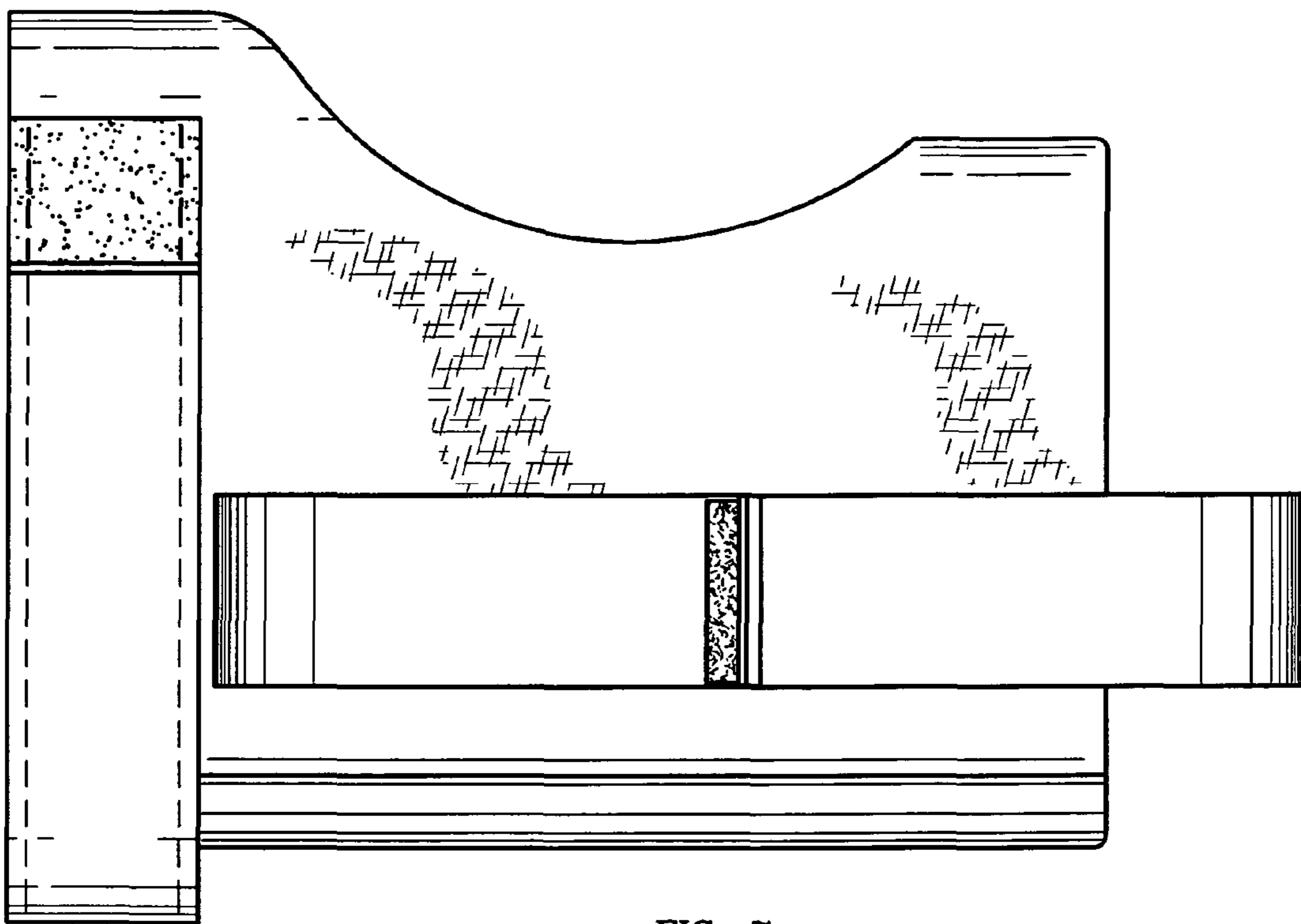

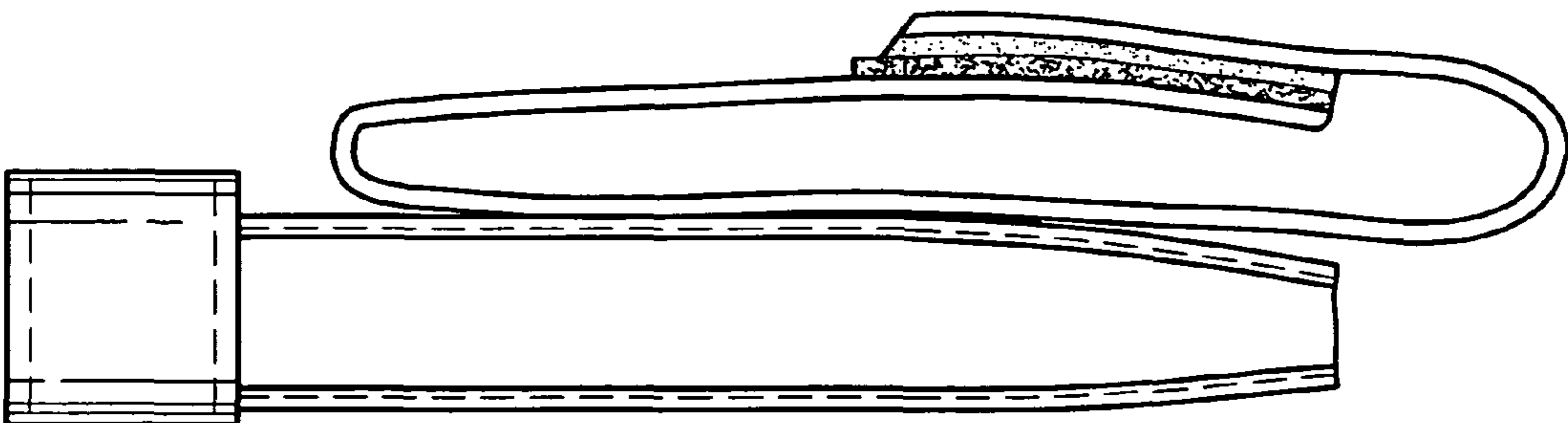
