The ornamental design for a popcorn sieve, as shown and described.

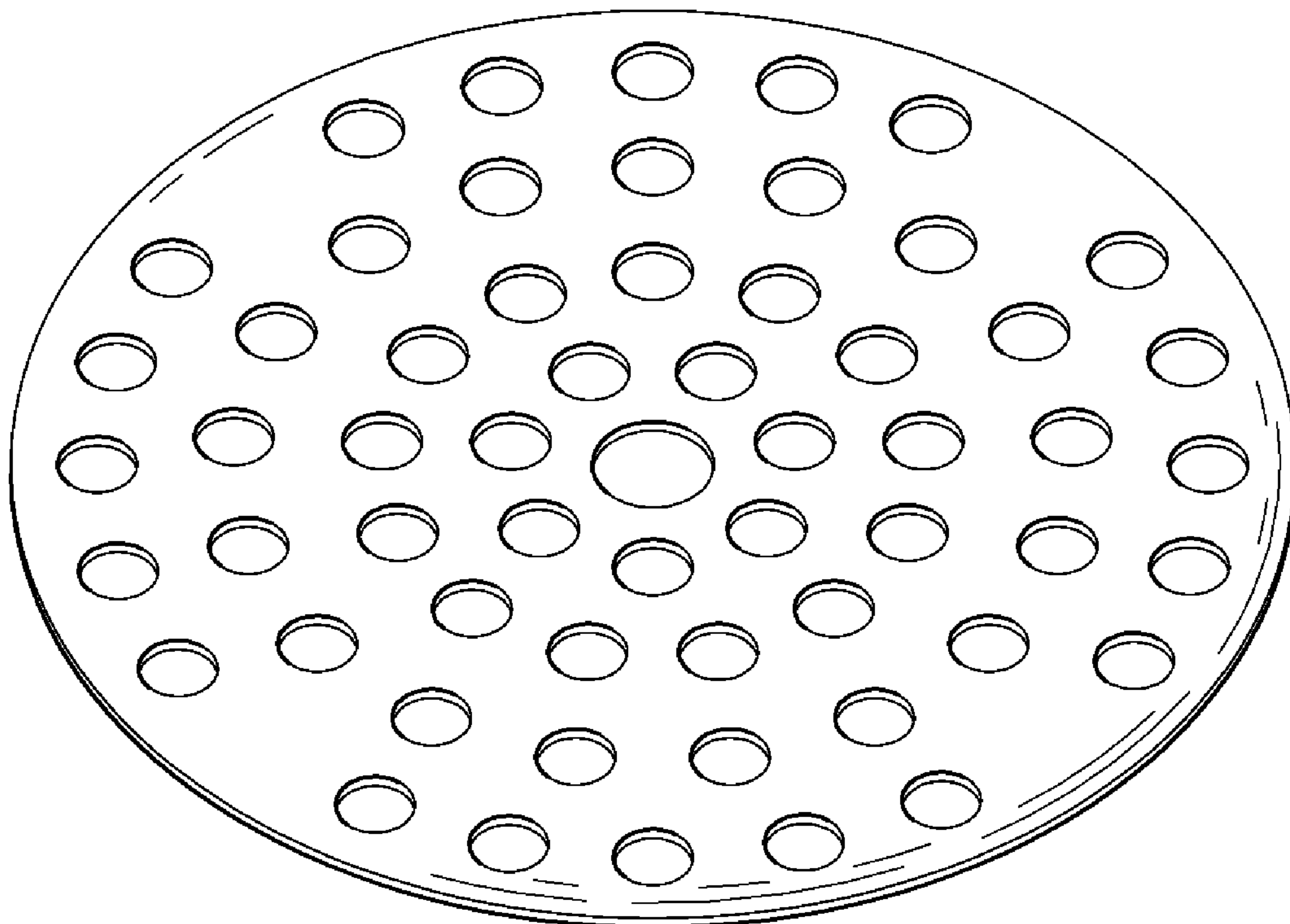
DESCRIPTION

FIG. 1 is a top perspective view of a popcorn sieve incorporating my new design;

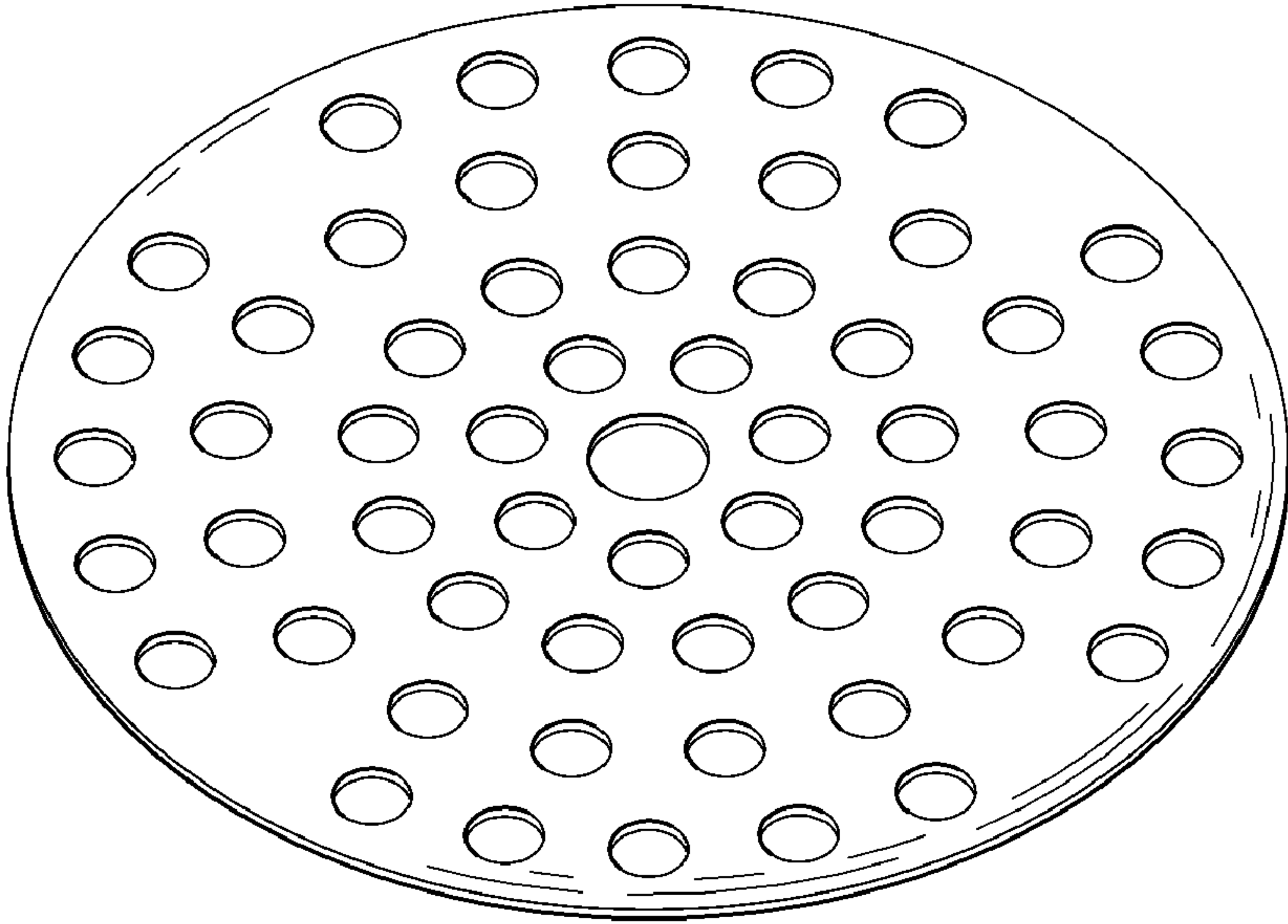

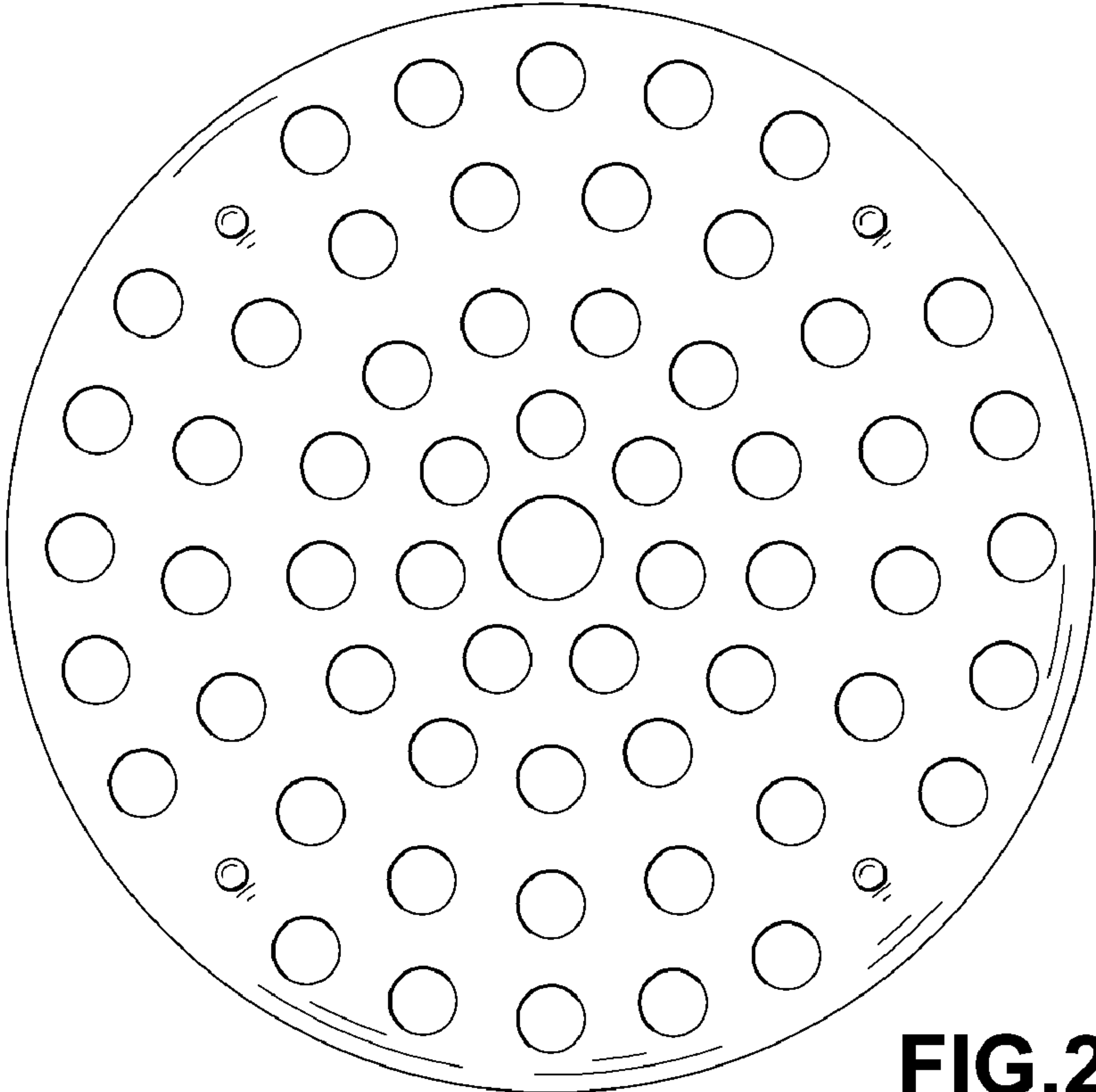
