(57) **CLAIM**

I claim the ornamental design for a chain saw, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the chain saw with a bar and chain;

FIG. 2 is a left side view of the chain saw shown in FIG. 1 without a bar and chain;

FIG. 3 is a right side view of the chain saw shown in FIG. 1 without a bar and chain;

FIG. 4 is a top view of the chain saw shown in FIG. 1 without a bar and chain;

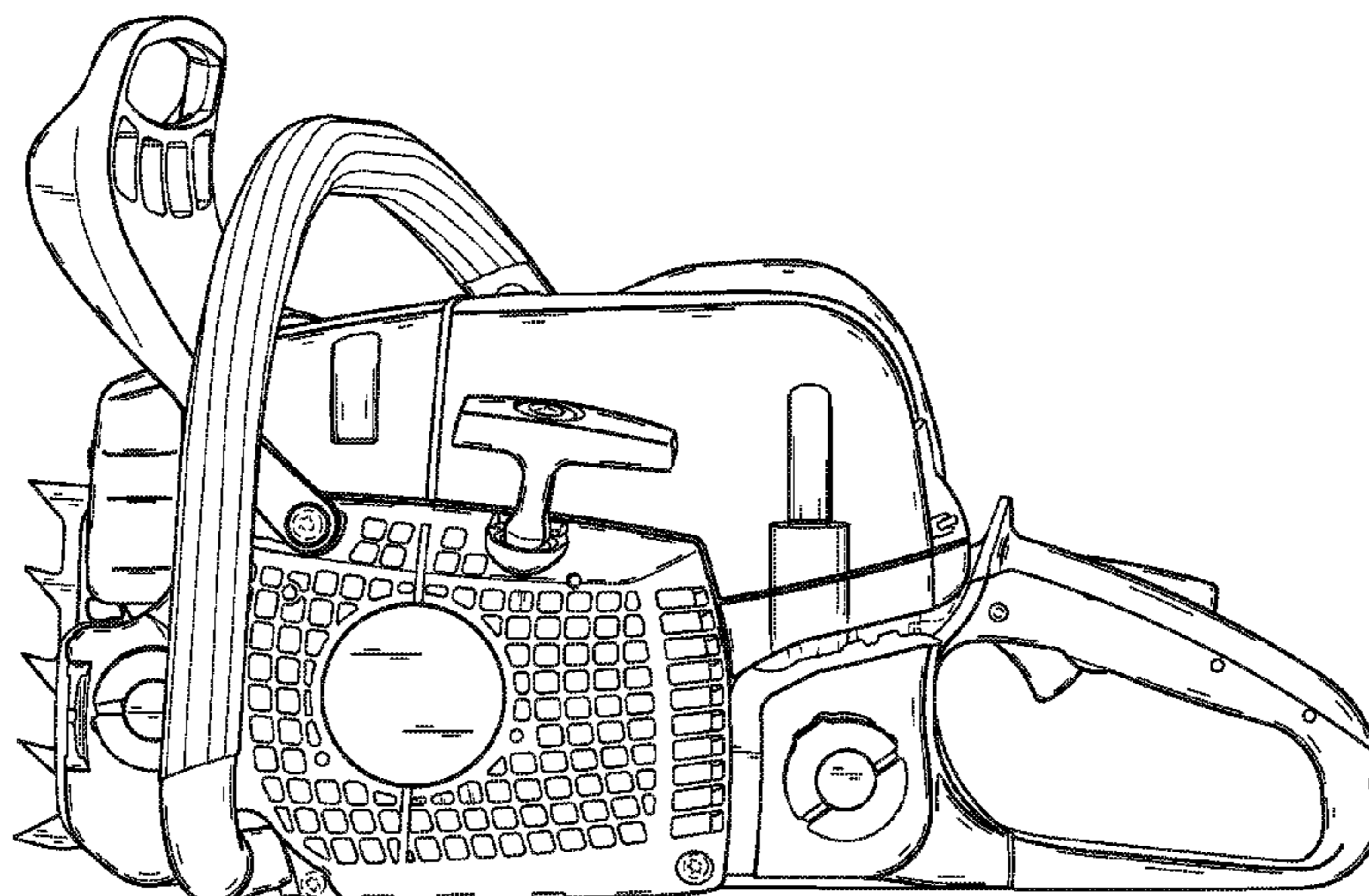
FIG. 5 is a bottom view of the chain saw shown in FIG. 1 without a bar and chain;

FIG. 6 is a rear view of the chain saw shown in FIG. 1 without a bar and chain; and,

FIG. 7 is a front view of the chain saw shown in FIG. 1 without a bar and chain.

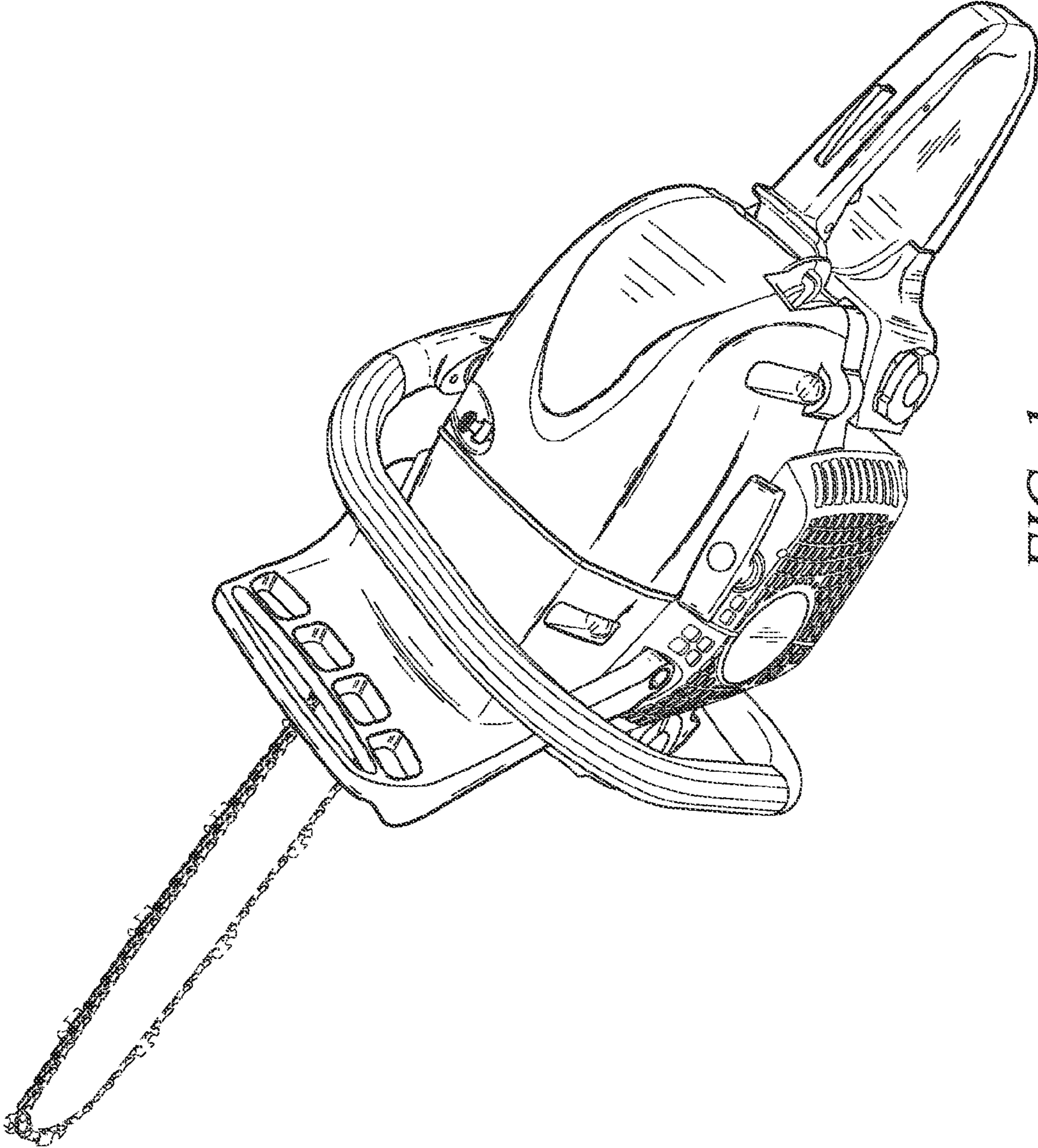

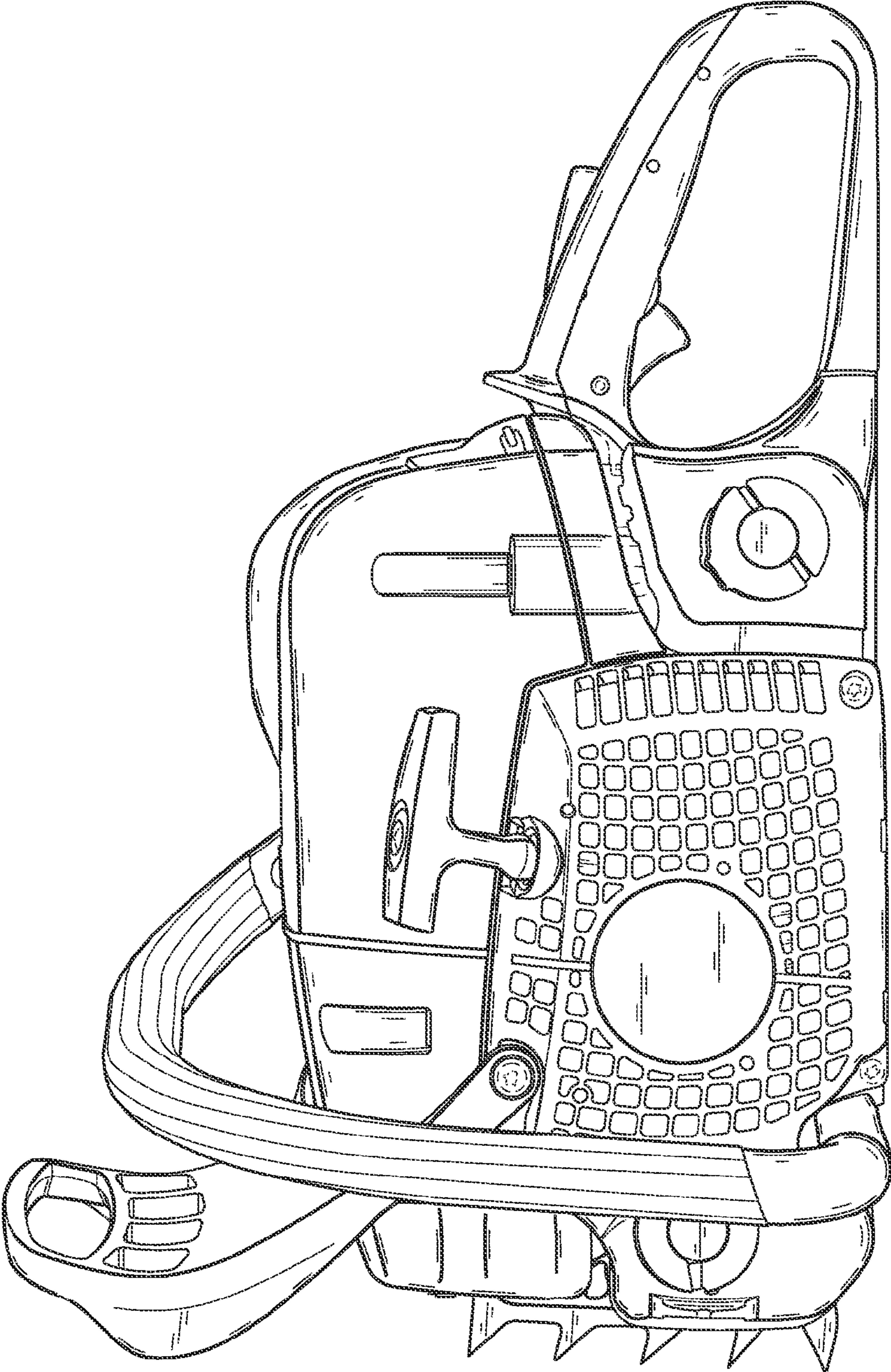

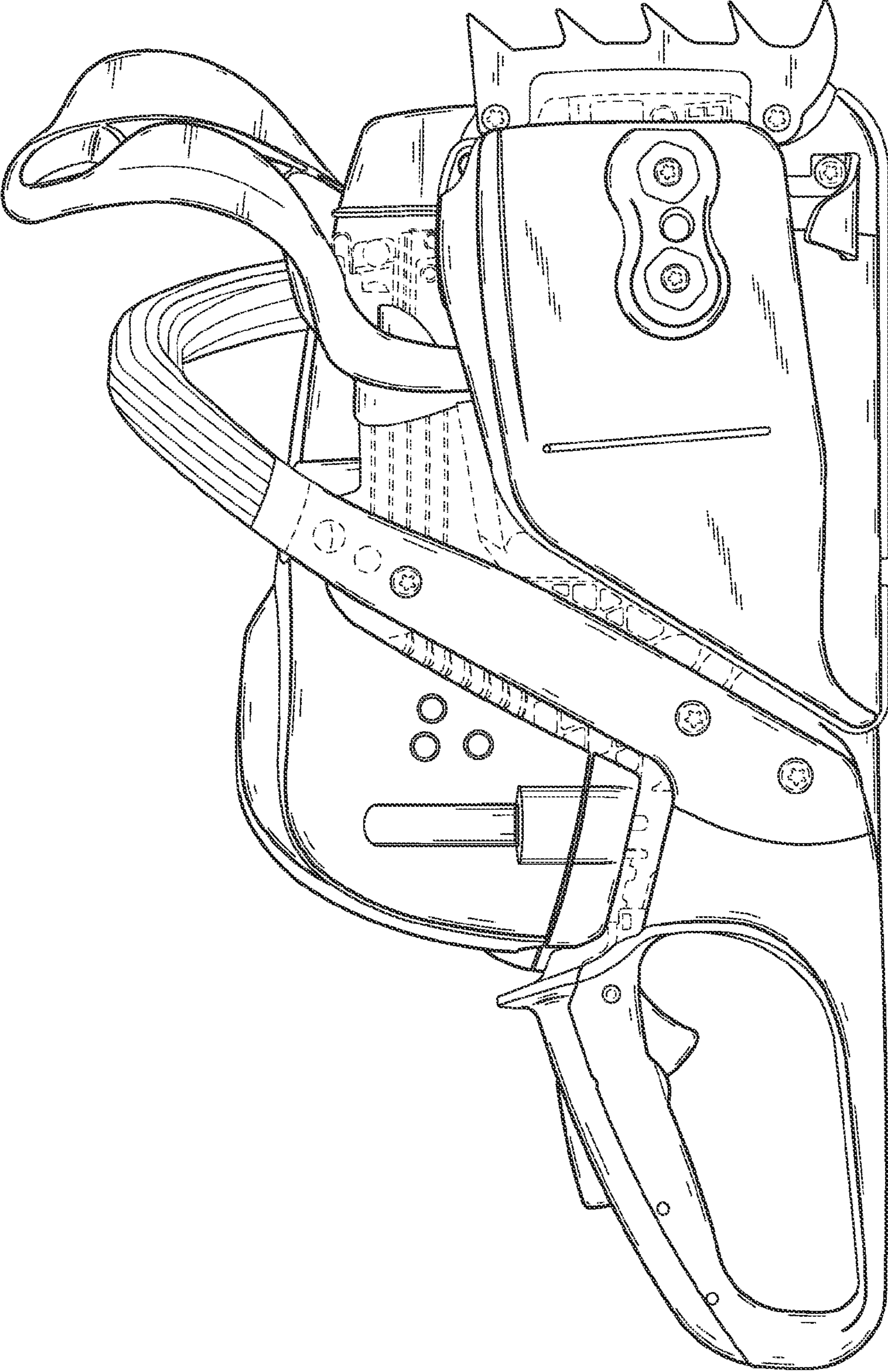

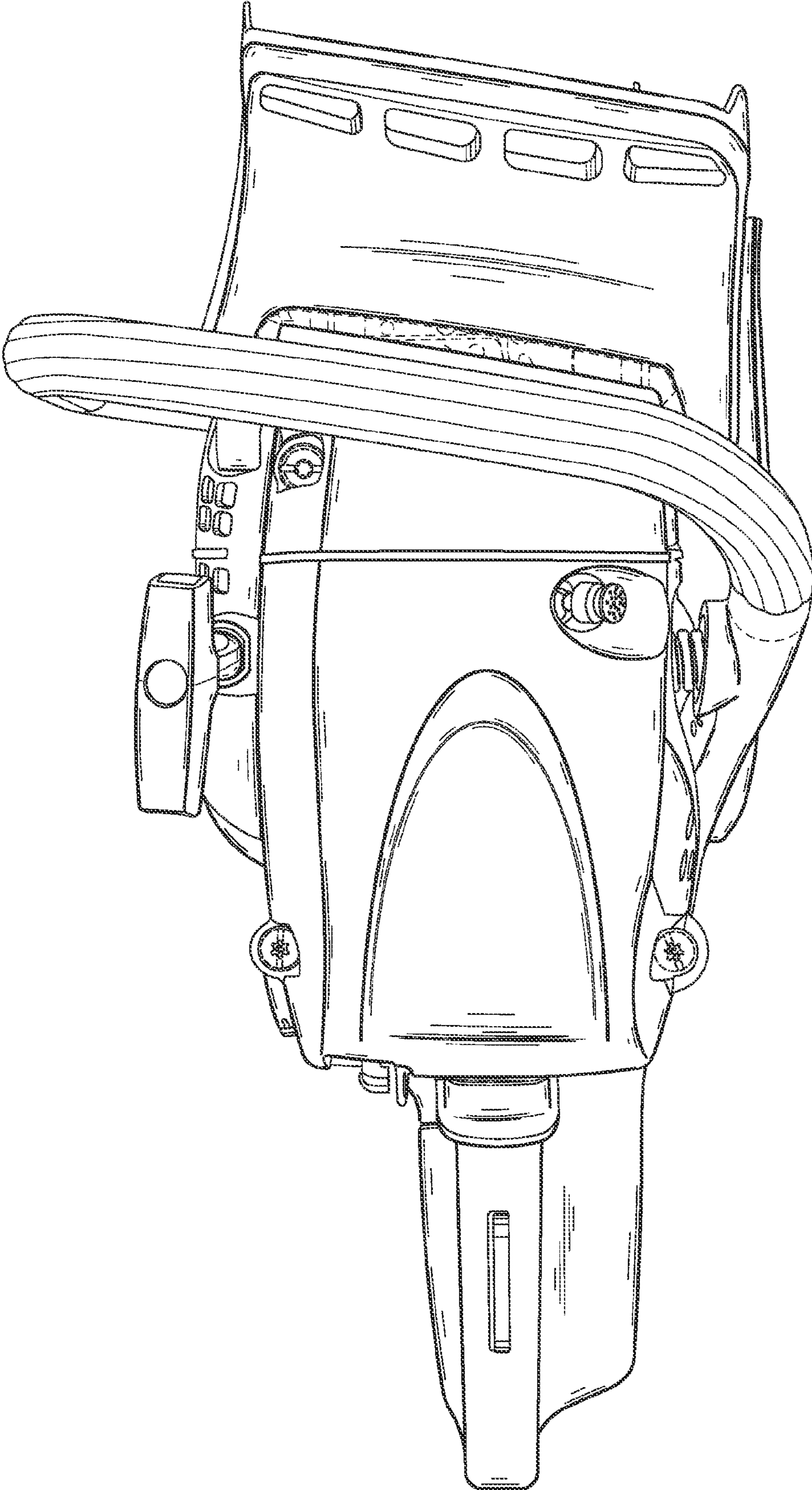

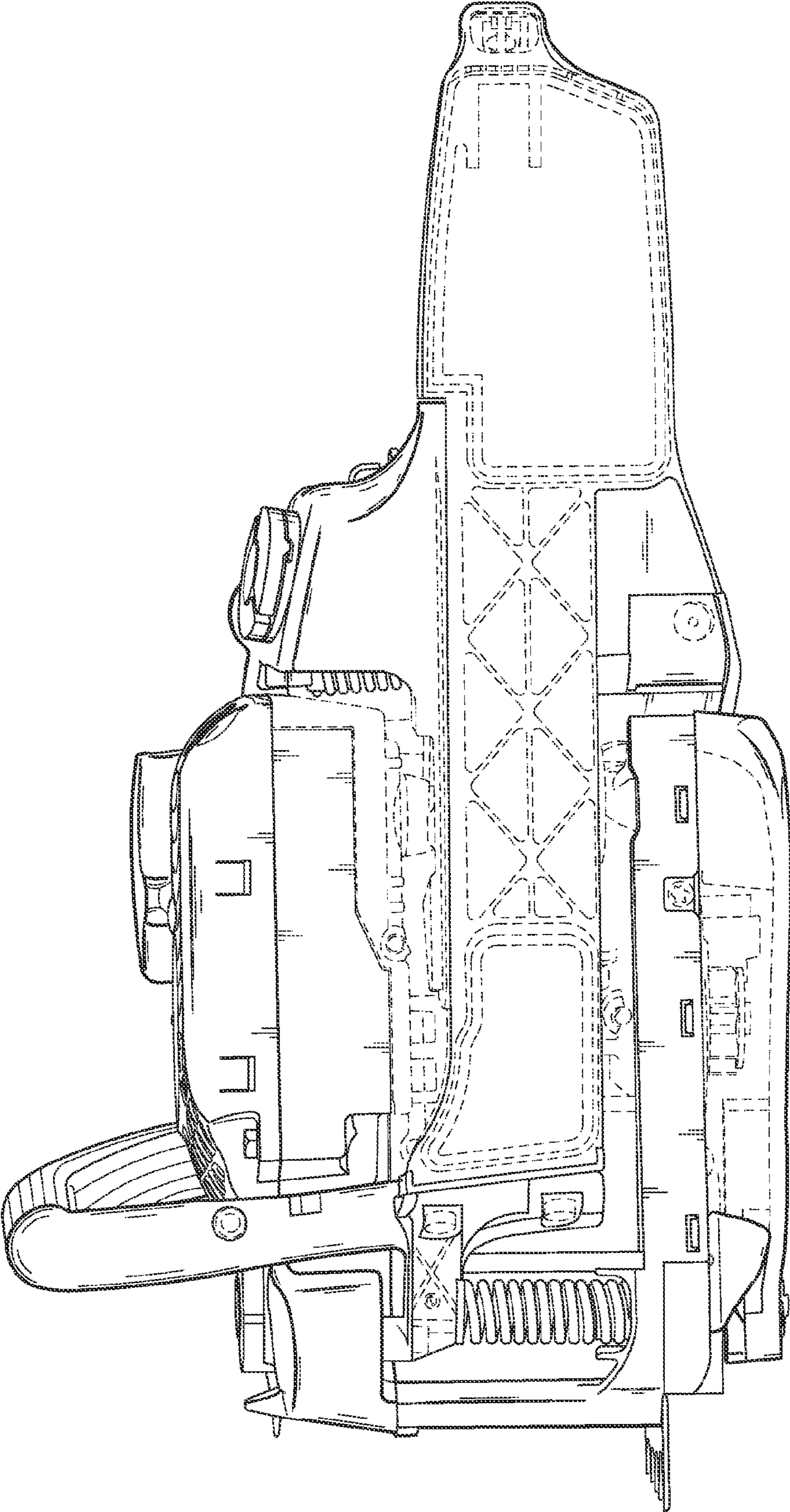

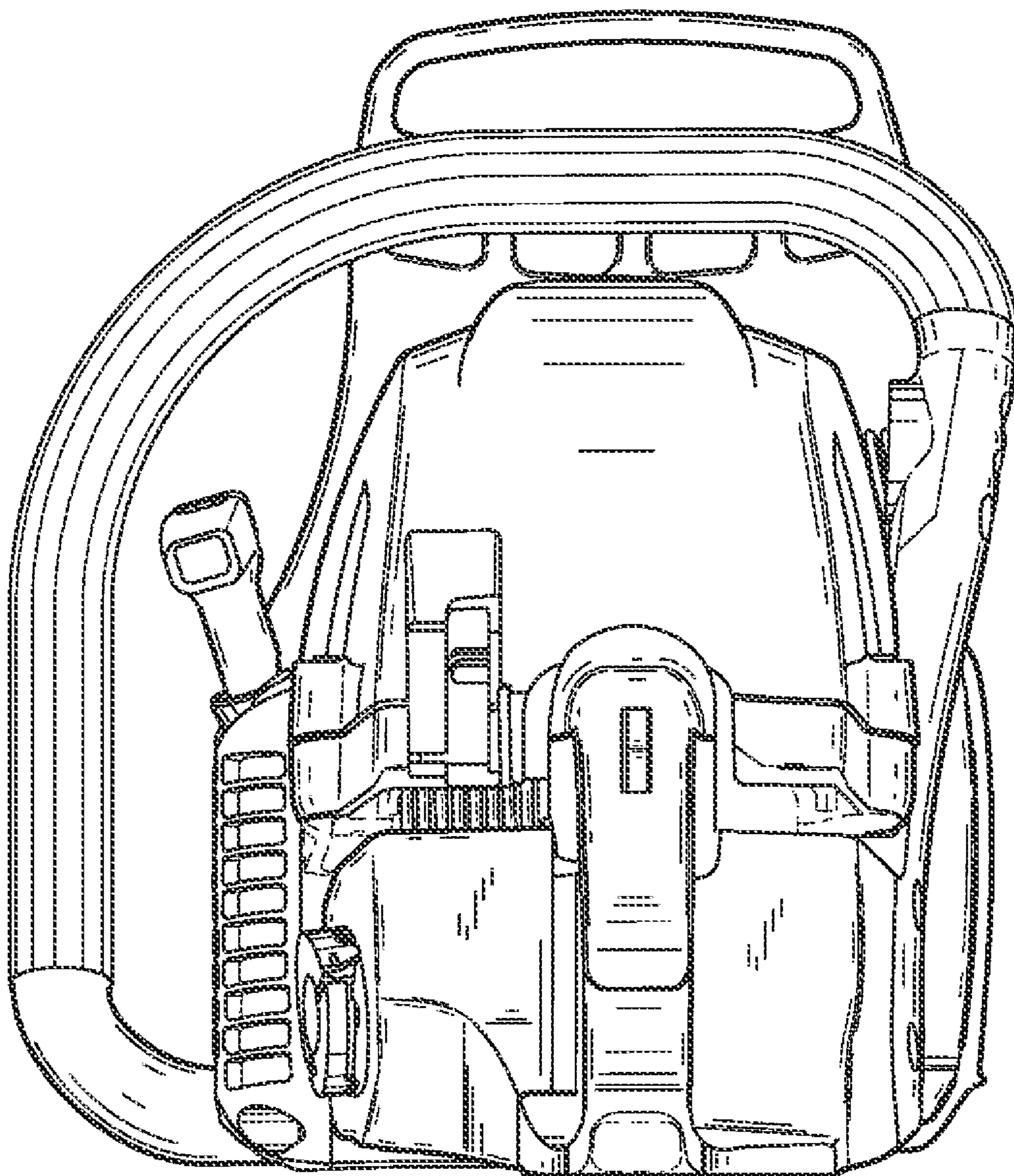

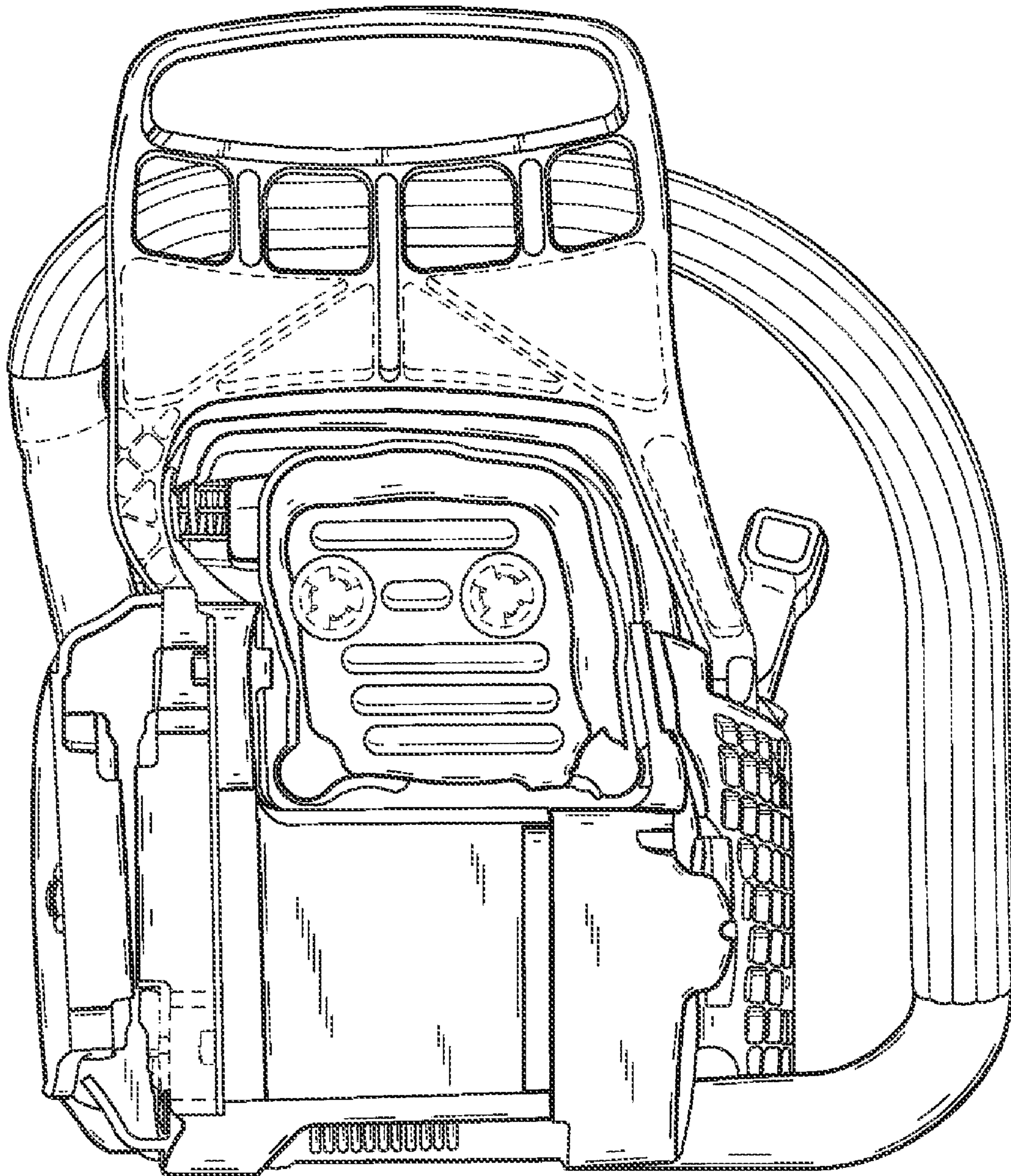
