(57) **CLAIM**

We claim the ornamental design for a locking bottle preform, as shown and described.

**DESCRIPTION**

FIG. 1 is a top-left perspective view of a locking bottle preform showing our new design;

FIG. 2 is a right-side elevation view of the locking bottle preform of FIG. 1.

FIG. 3 is a left-side elevation view of the locking bottle preform of FIG. 1.

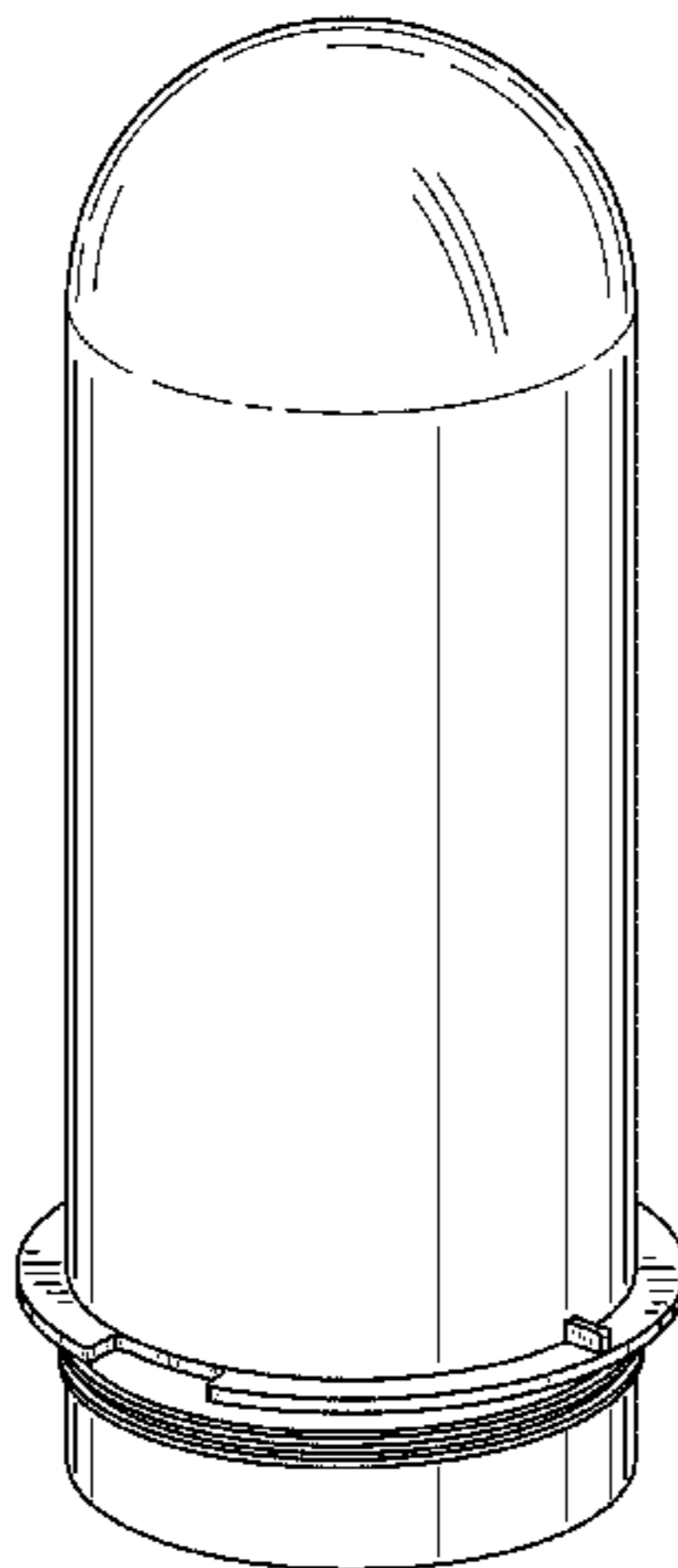
FIG. 4 is a front elevation view of the locking bottle preform of FIG. 1.

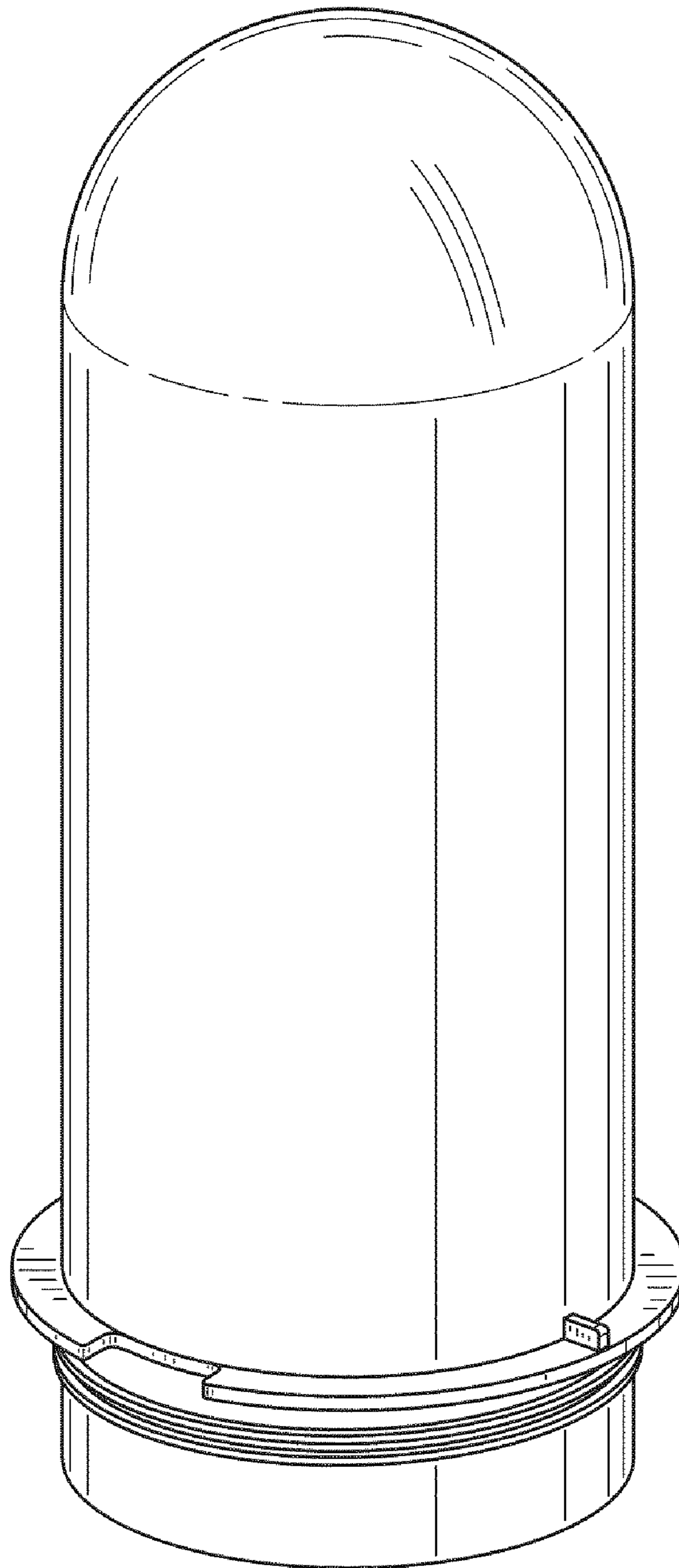

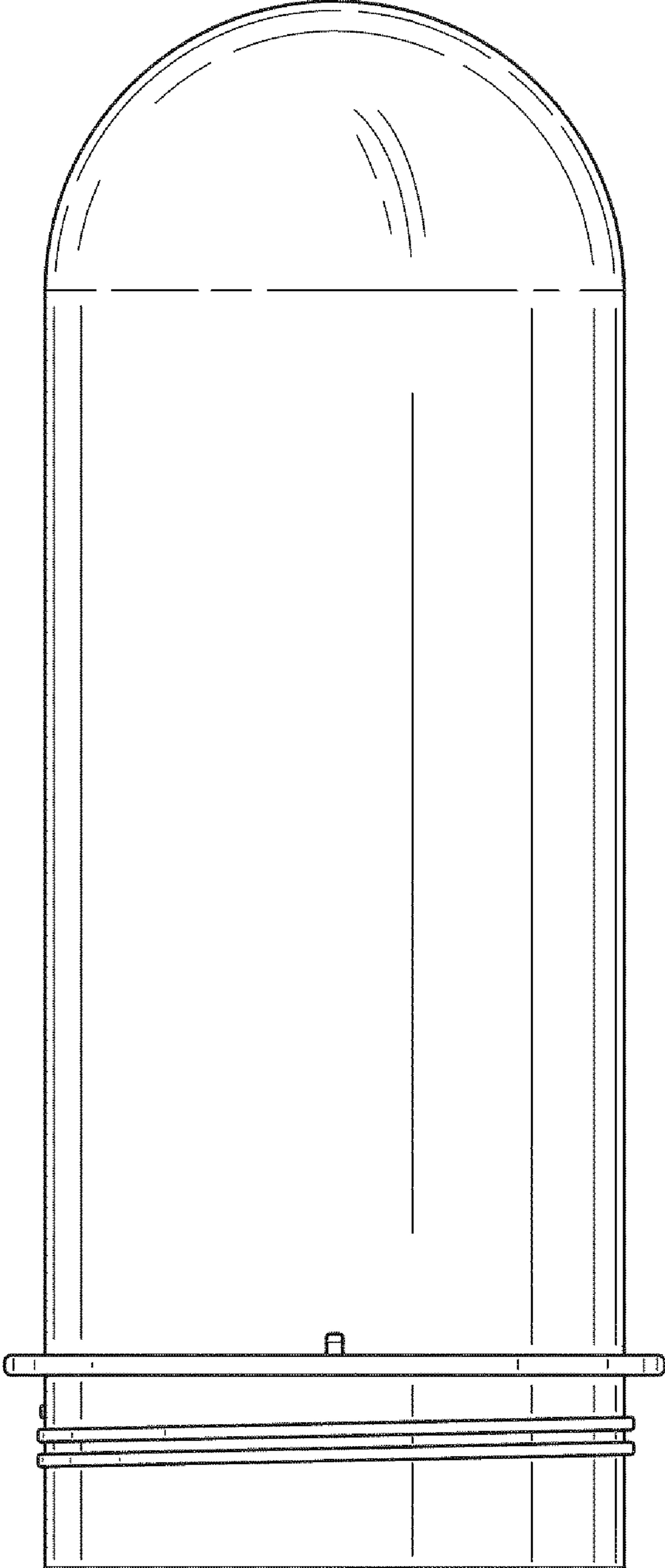

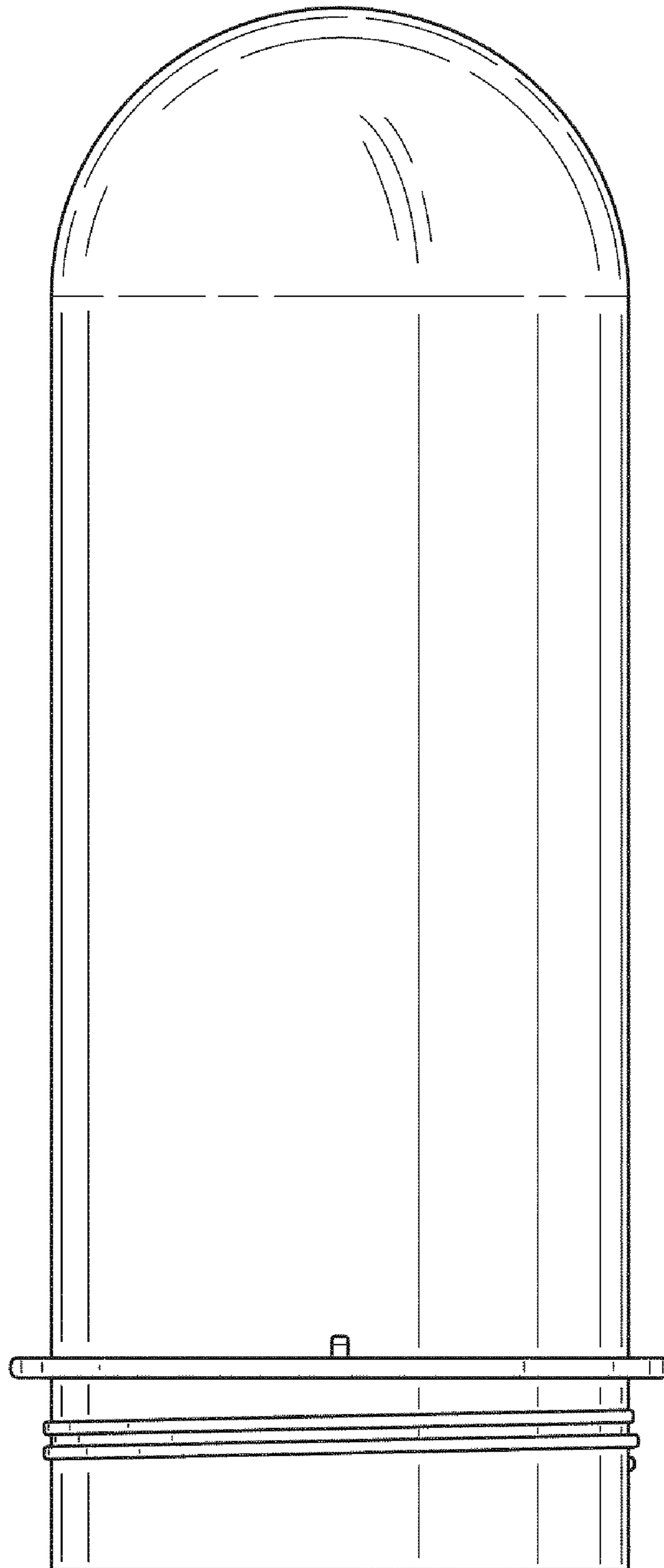

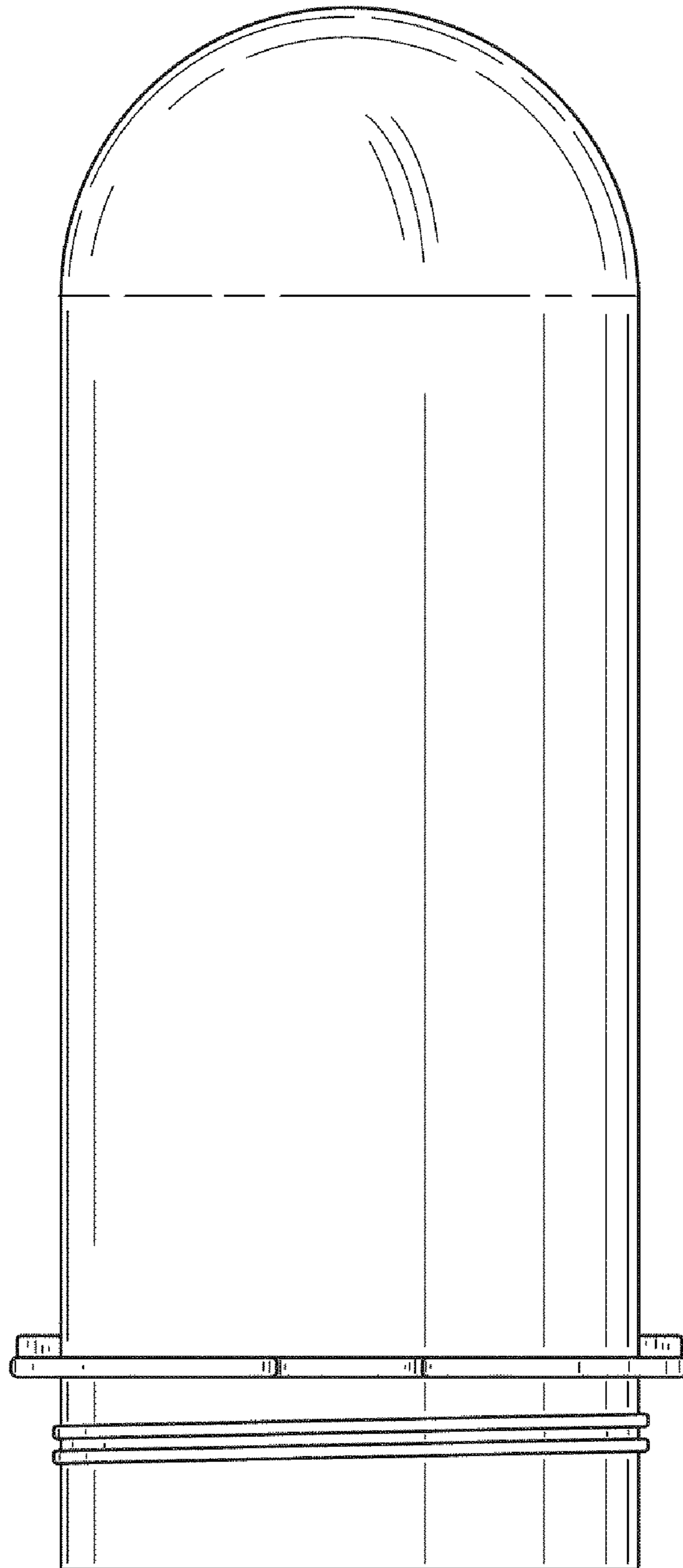

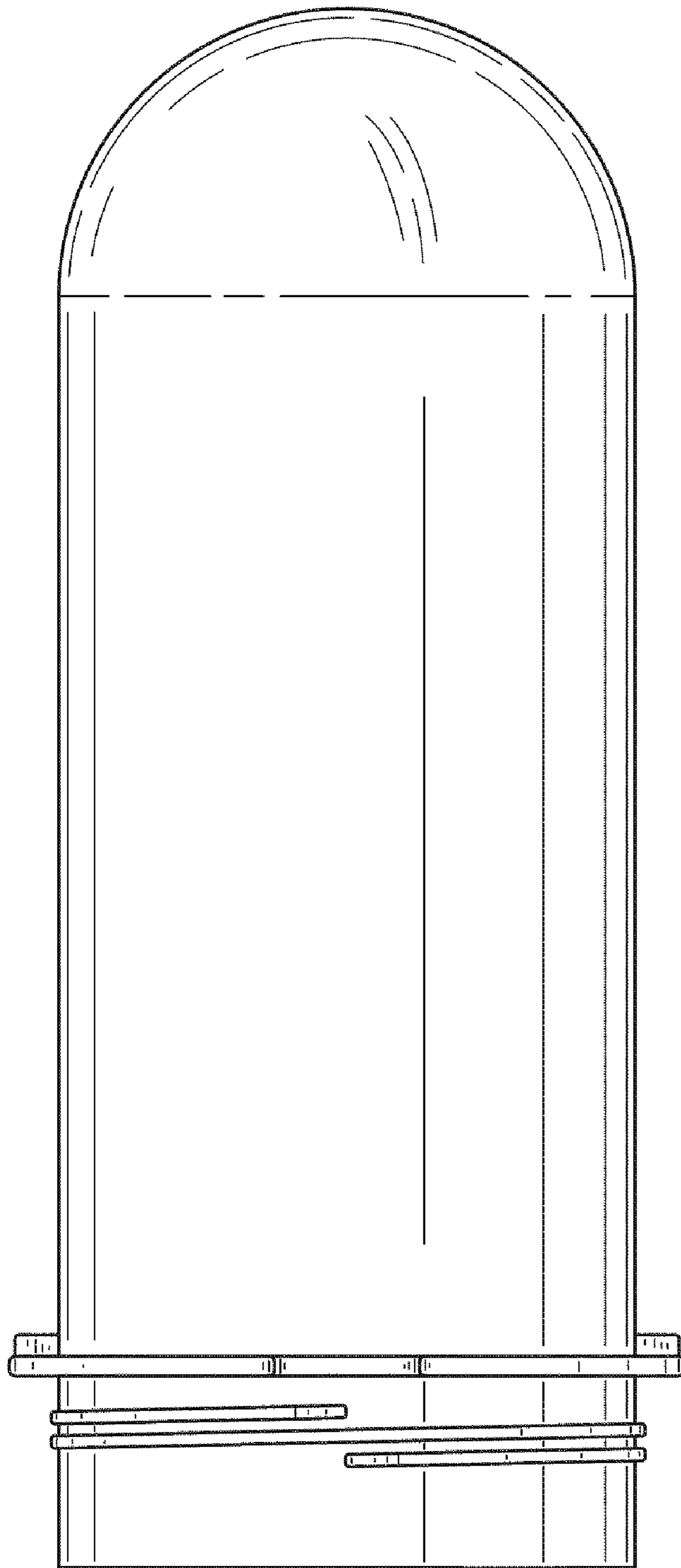

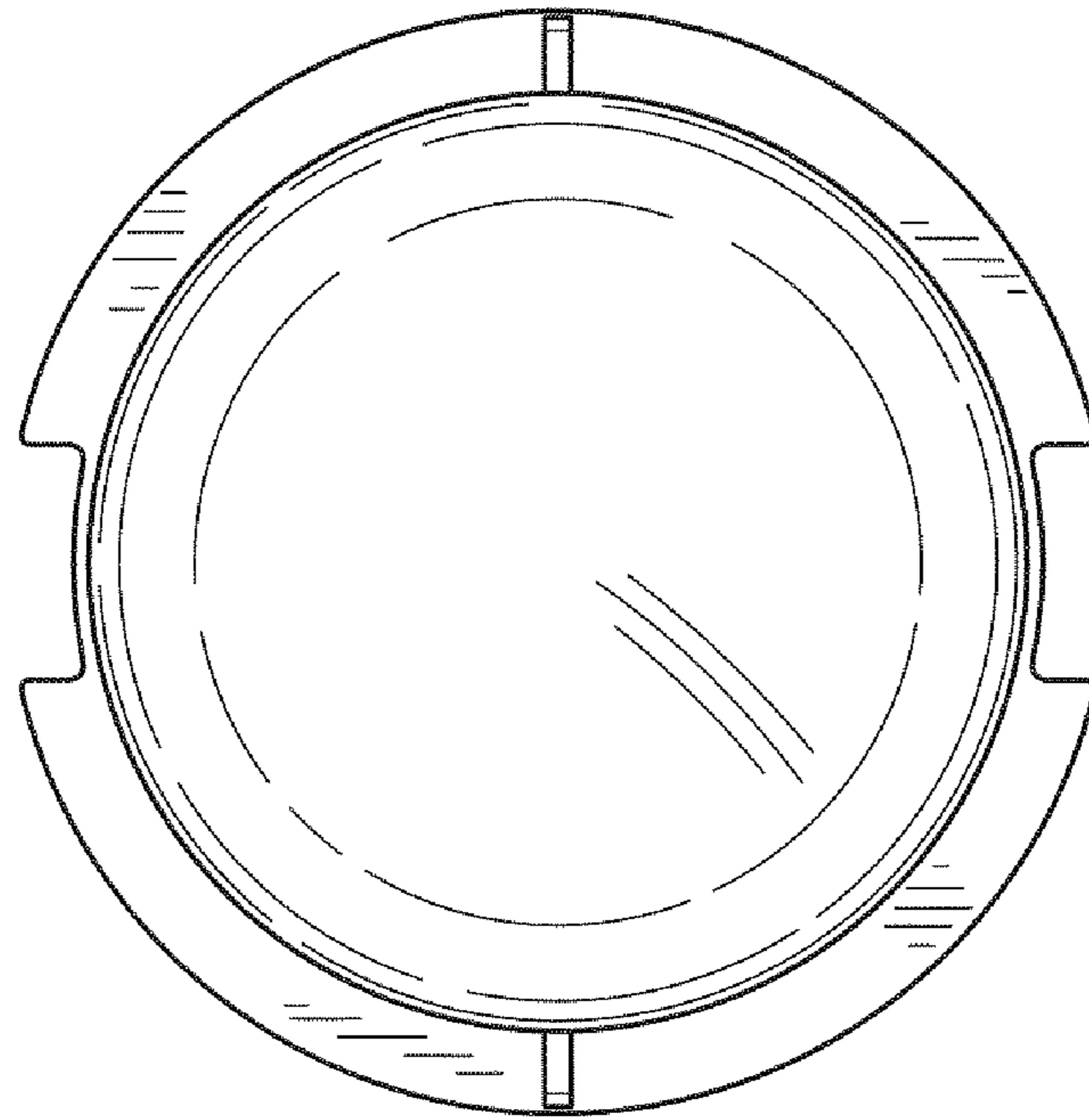

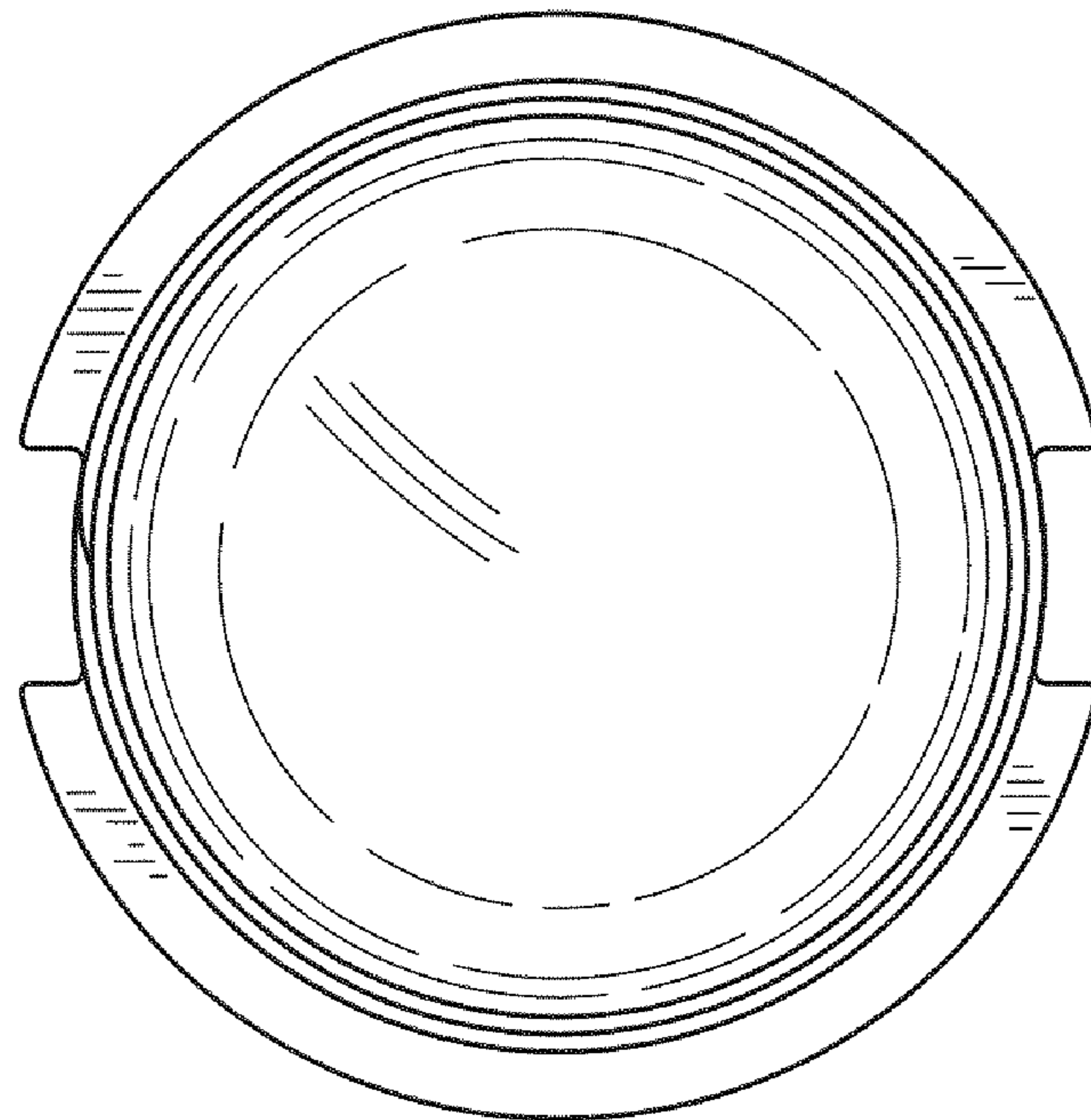
