(57) **CLAIM**

The ornamental design for a bracelet watch, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a bracelet watch showing my new design;

FIG. 2 is bottom view thereof;

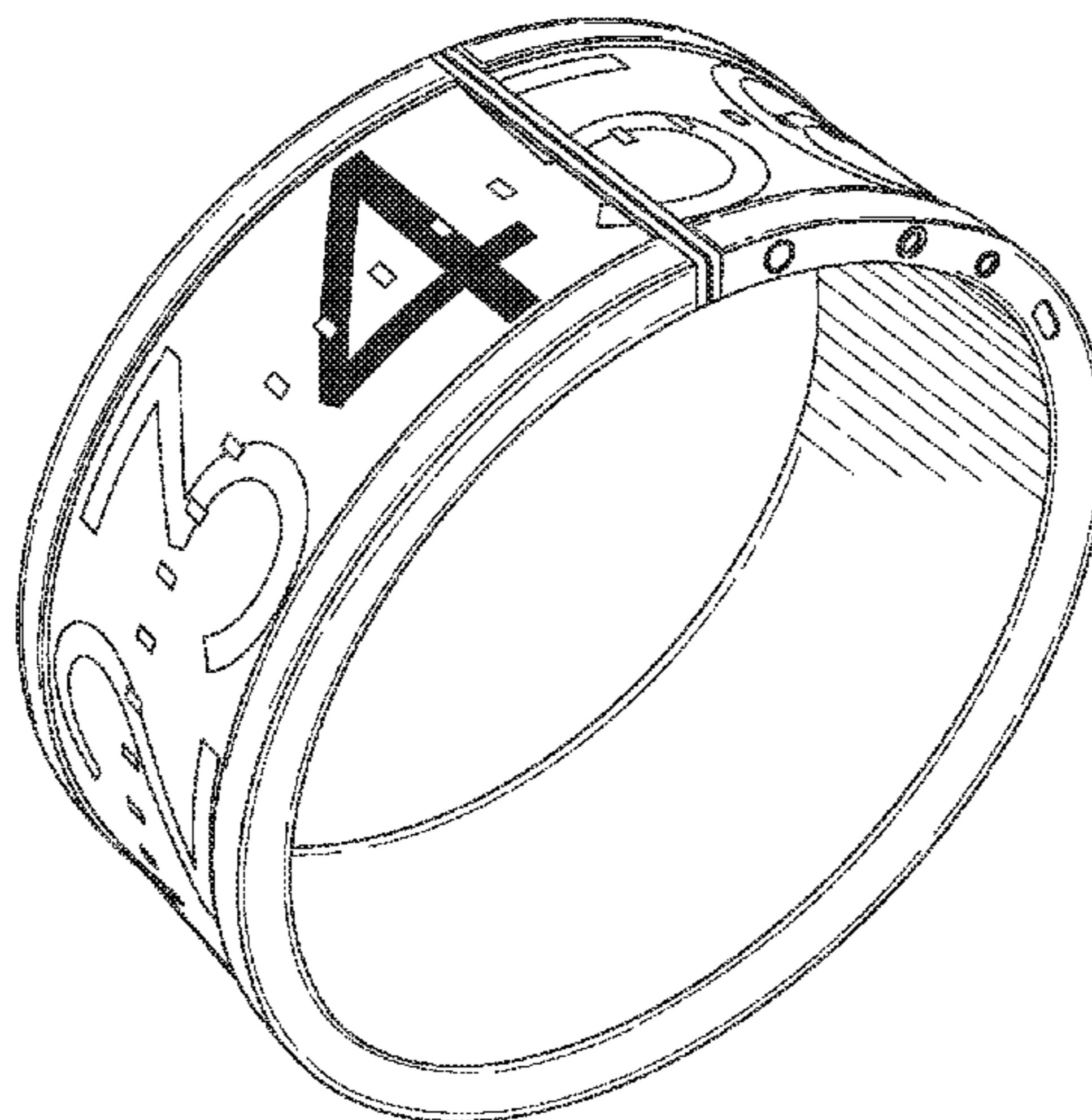

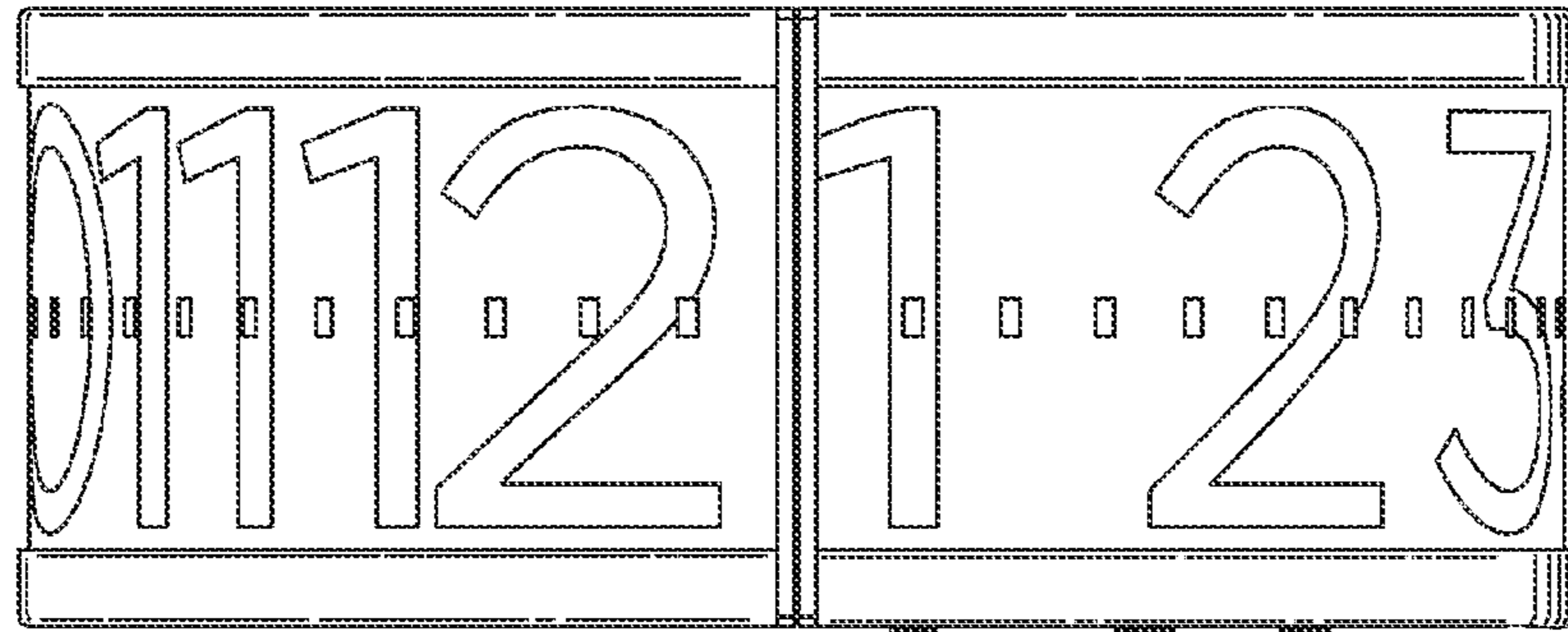

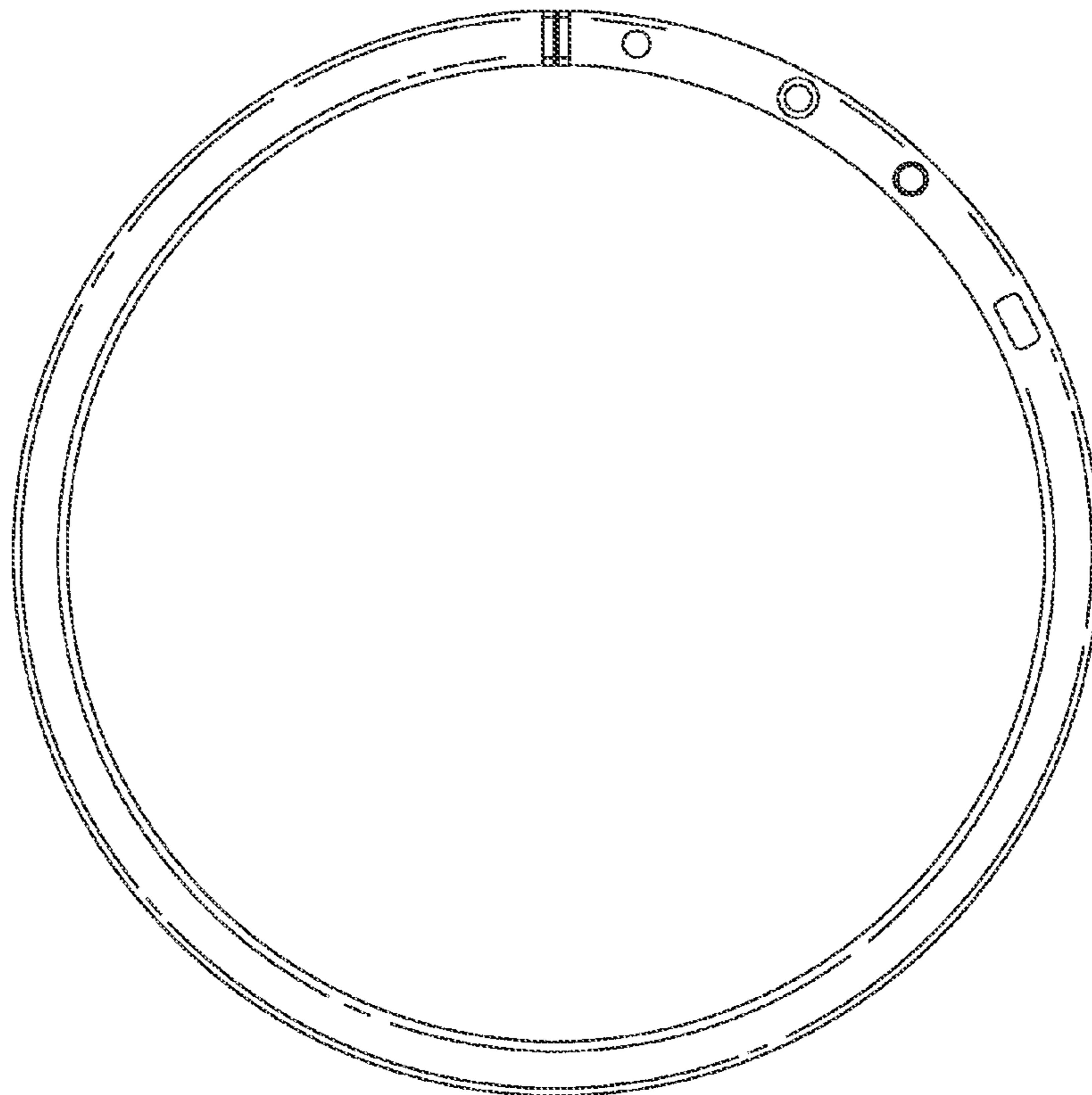

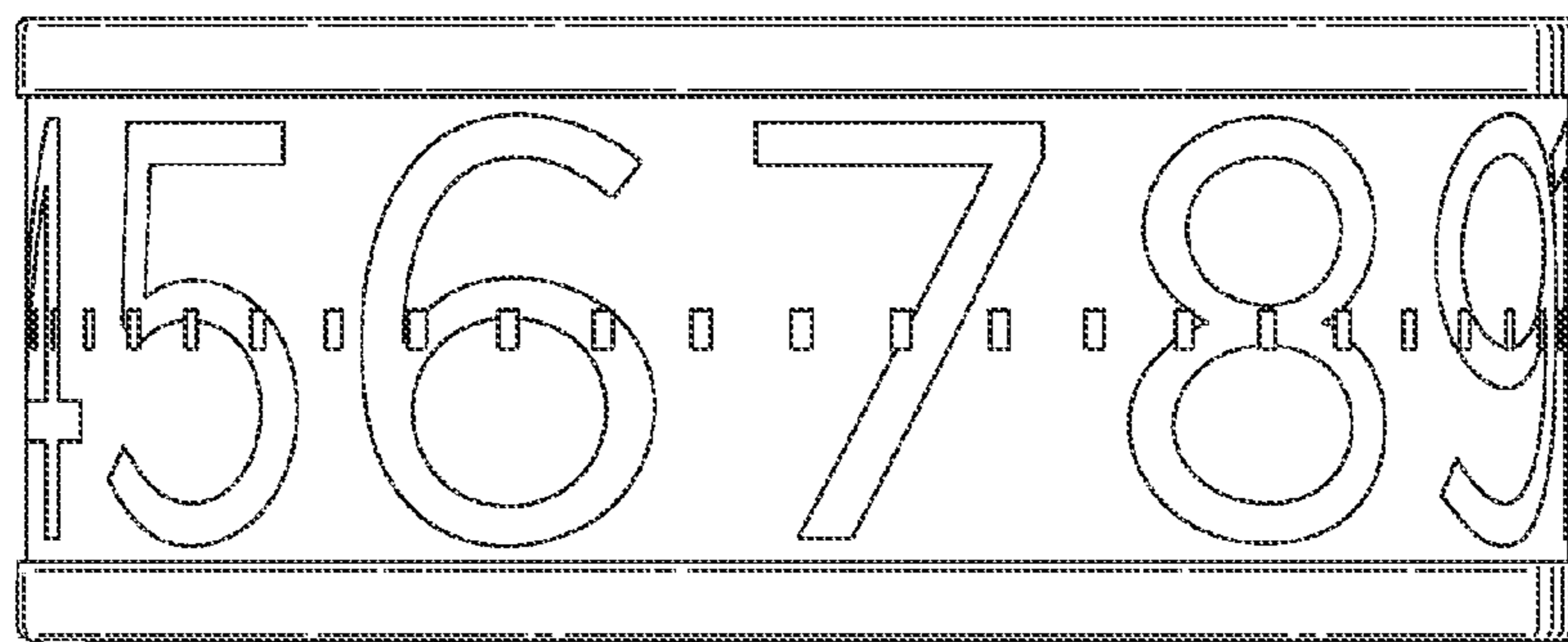

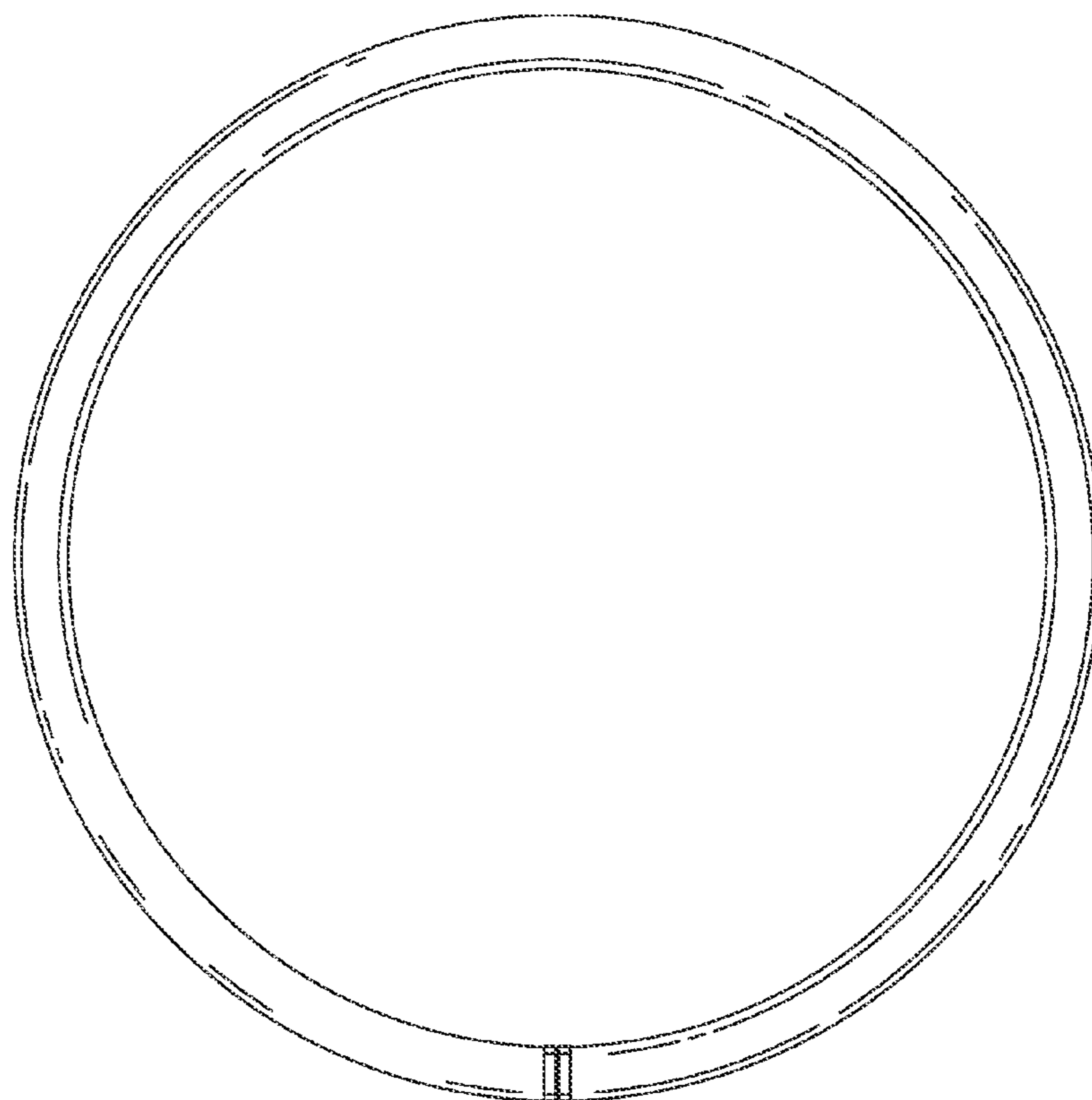

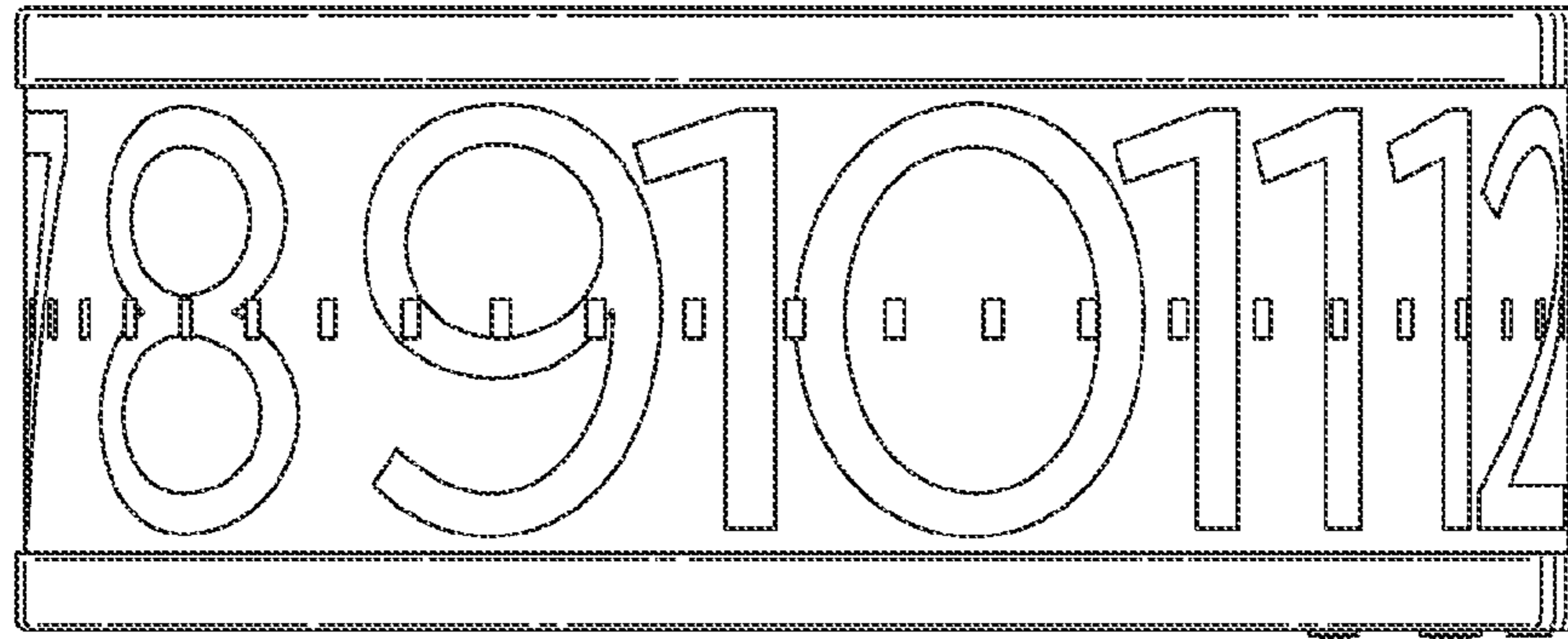

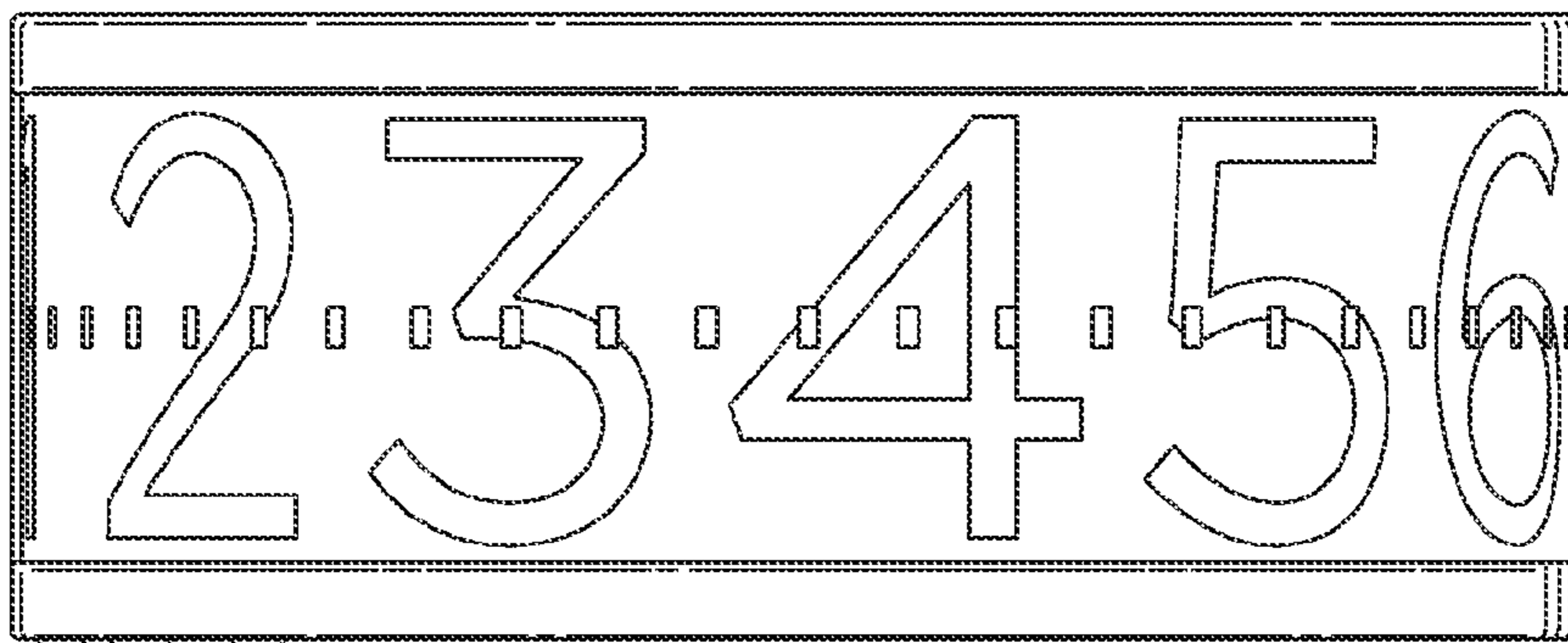

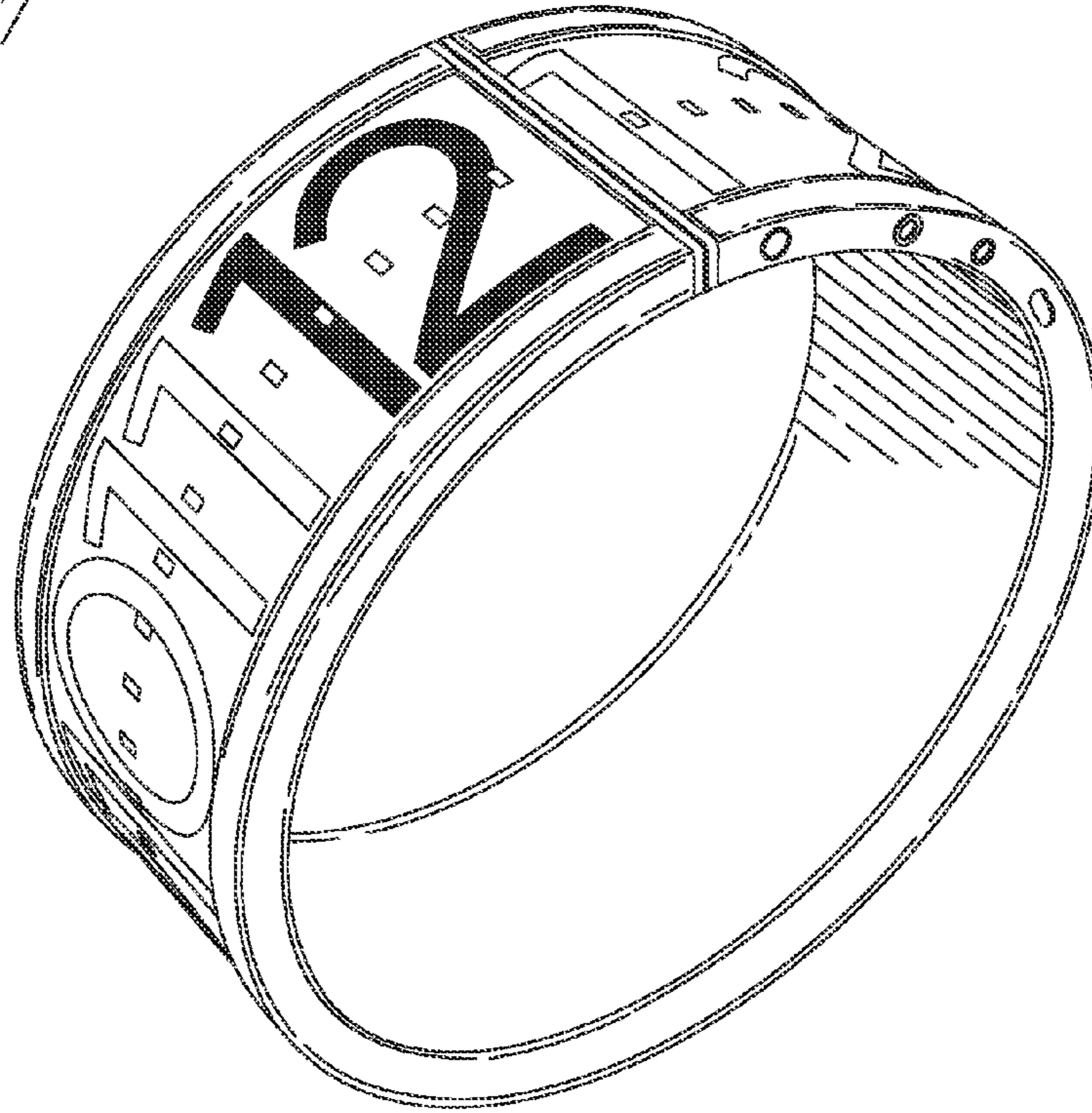

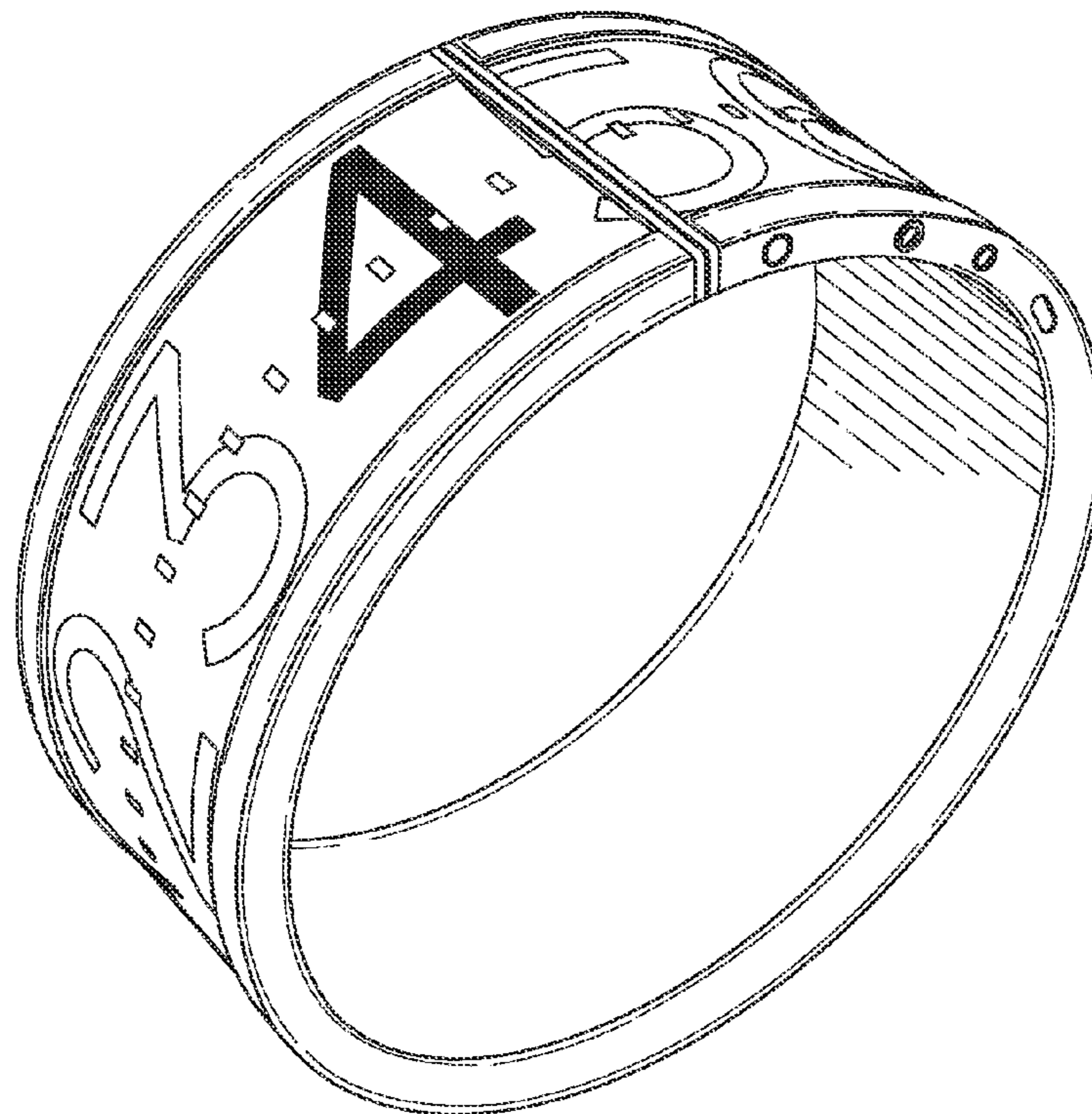

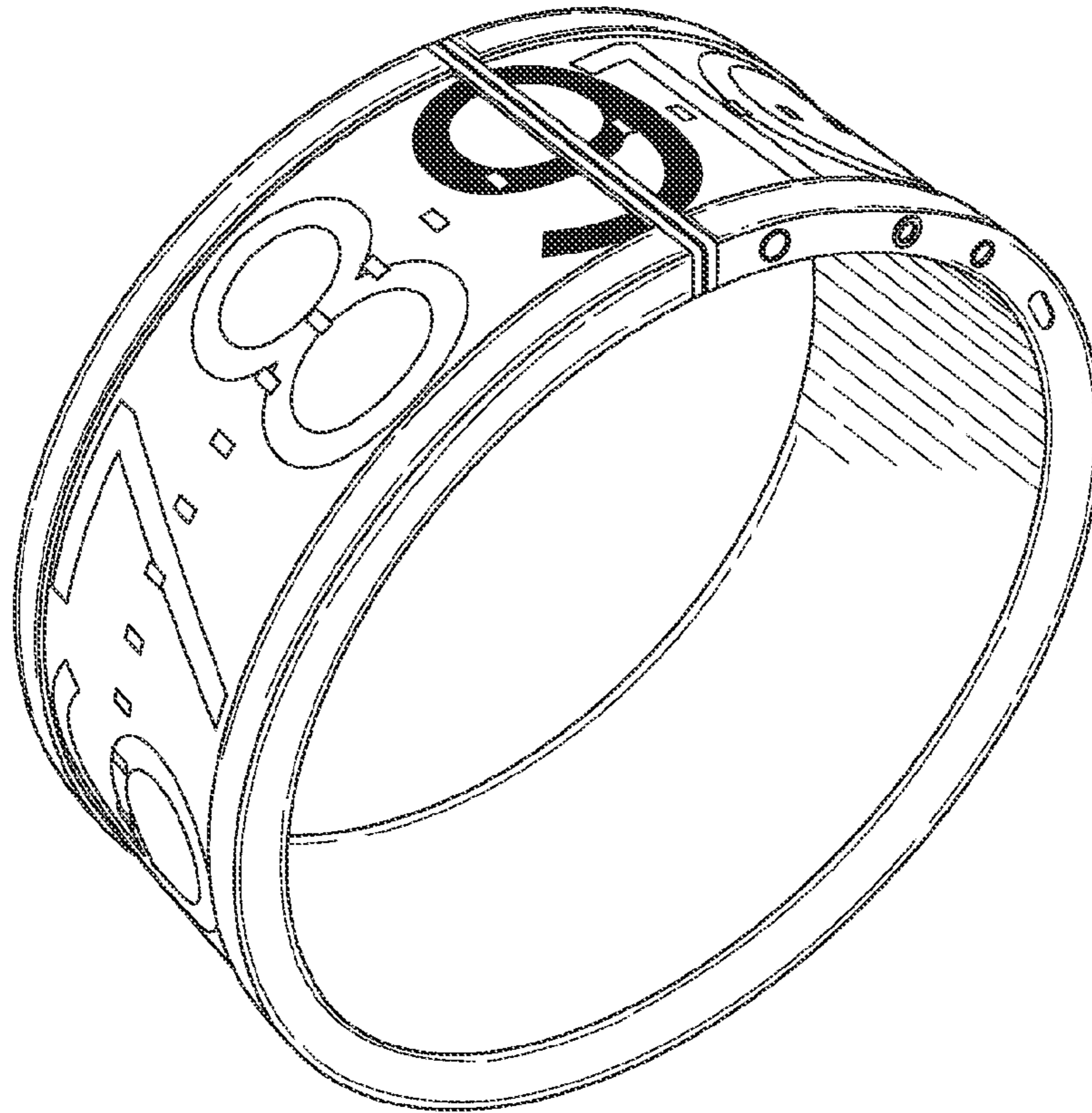

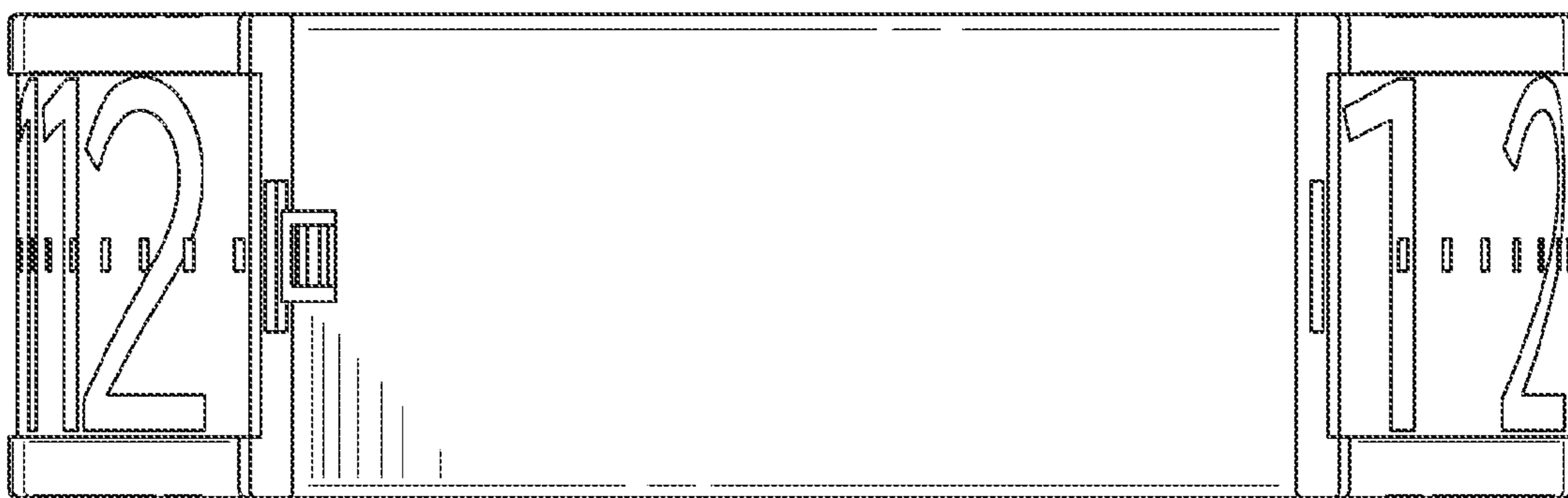

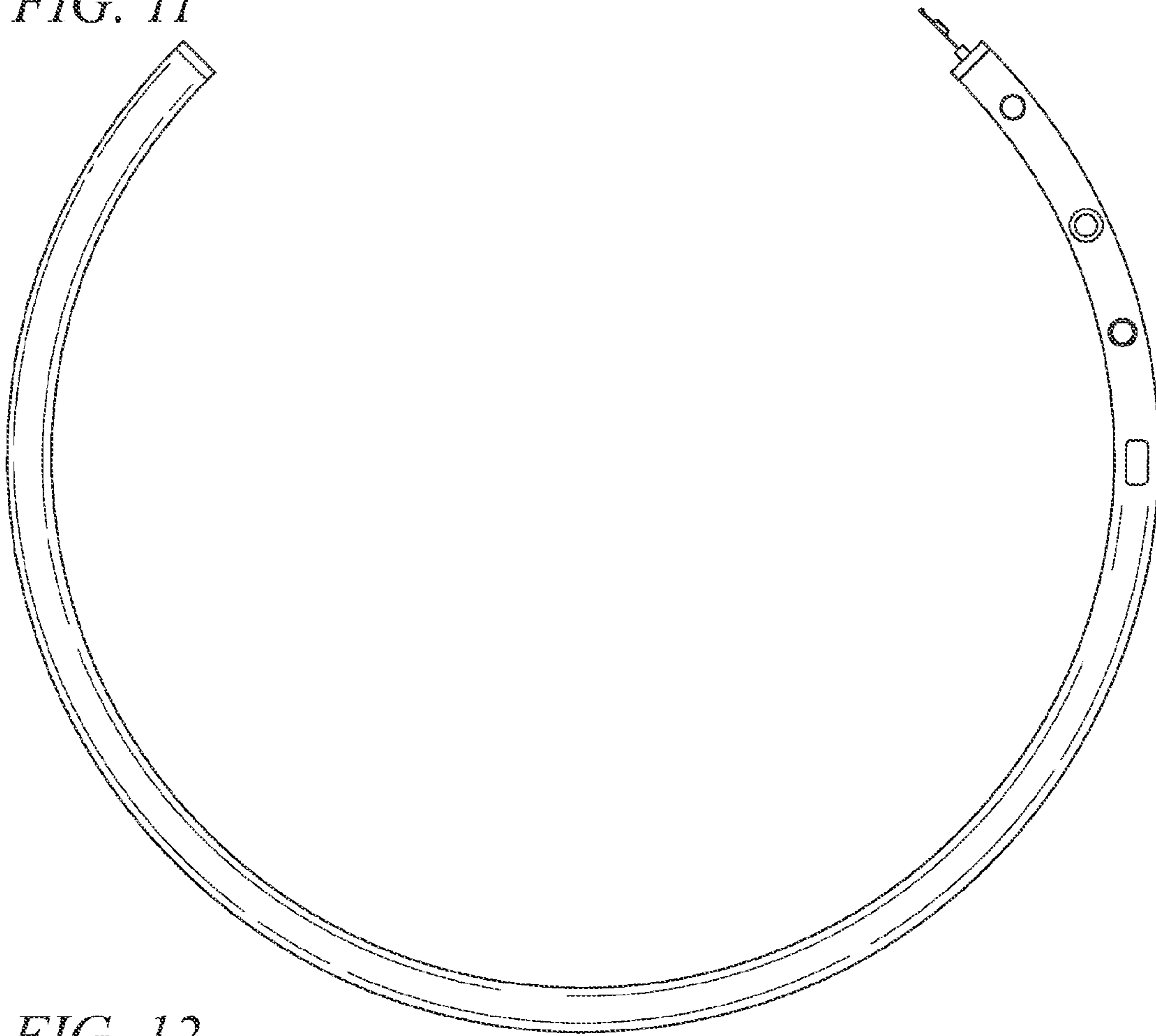

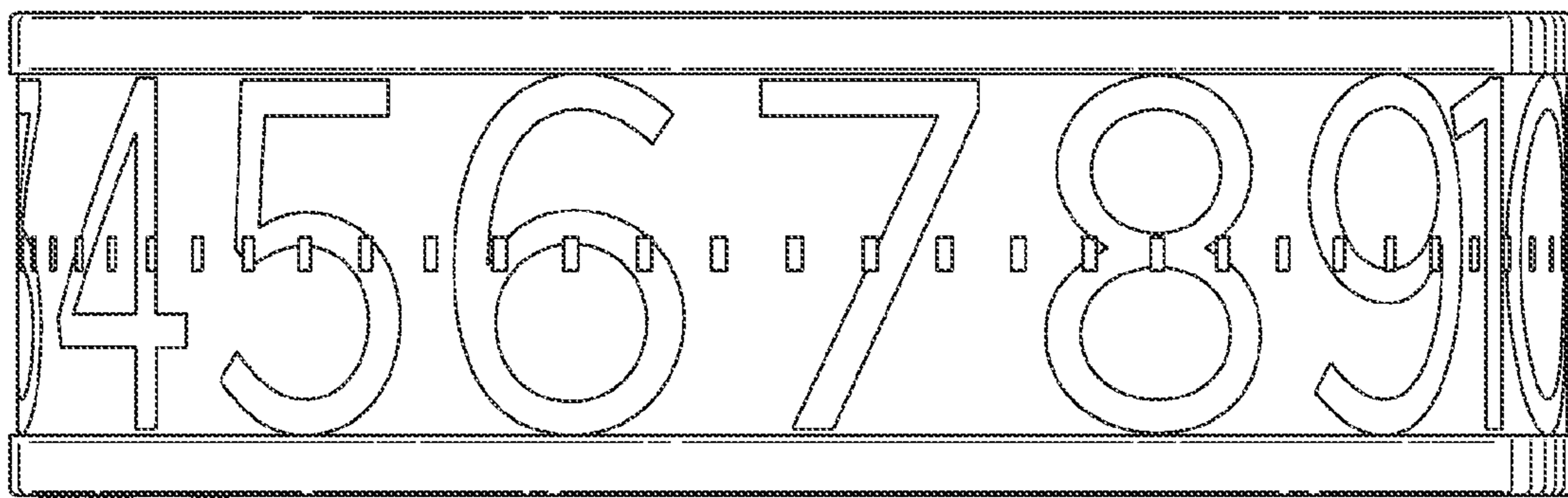

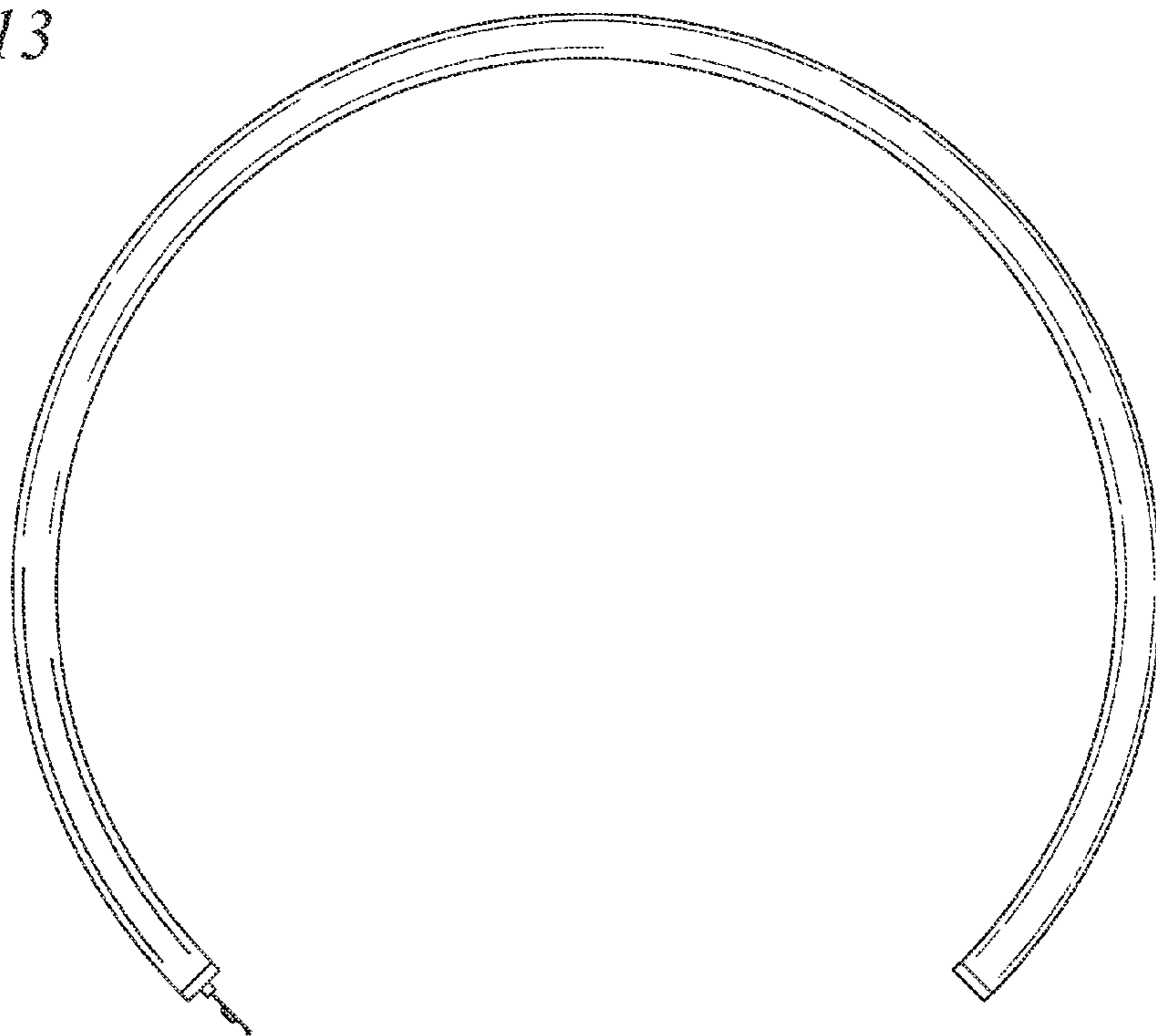
