FIG. 3 is a front elevational view of the center extender for rear of truck roof of FIG. 1;

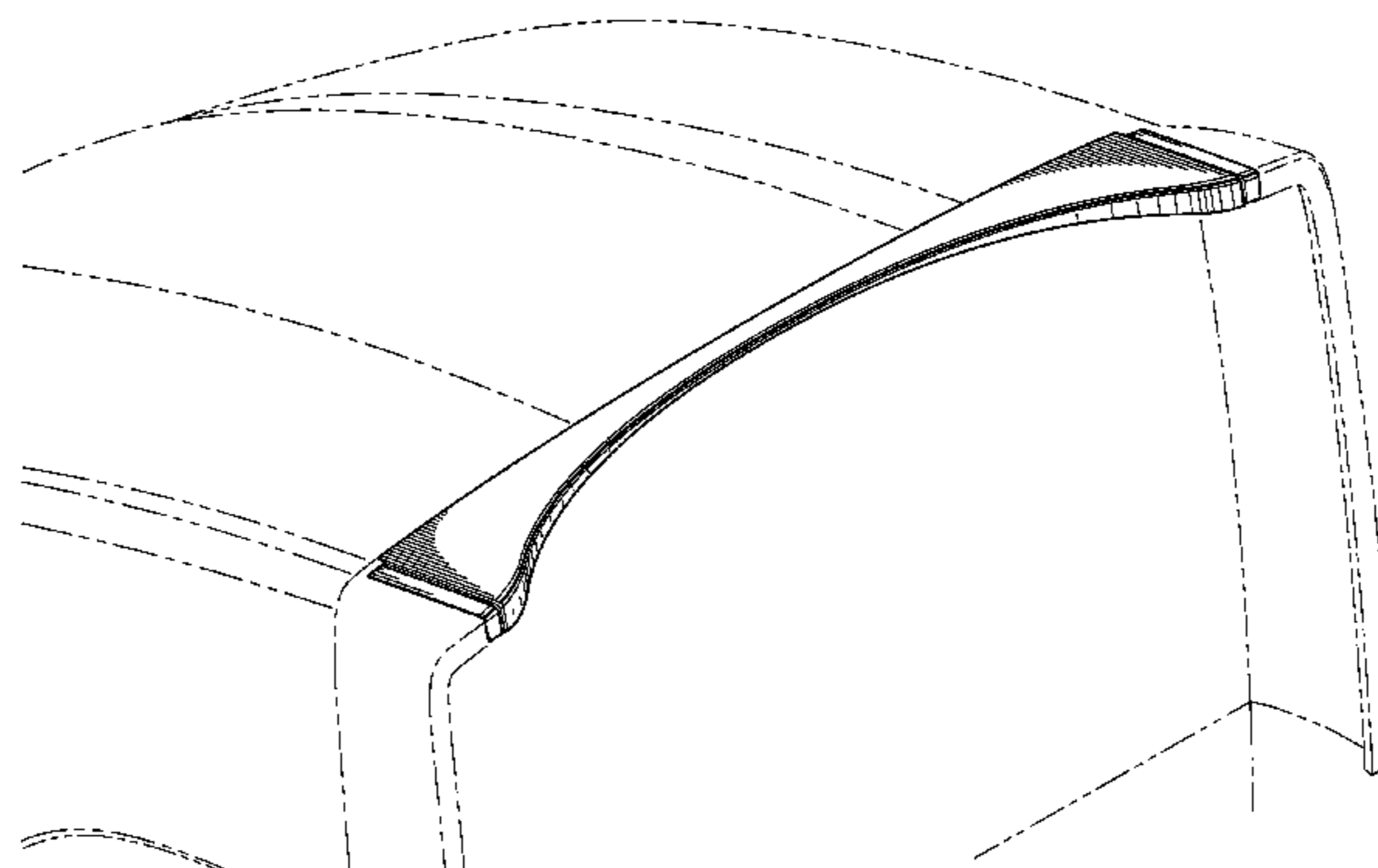
FIG. 4 is a top plan view of the center extender for rear of truck roof of FIG. 1;

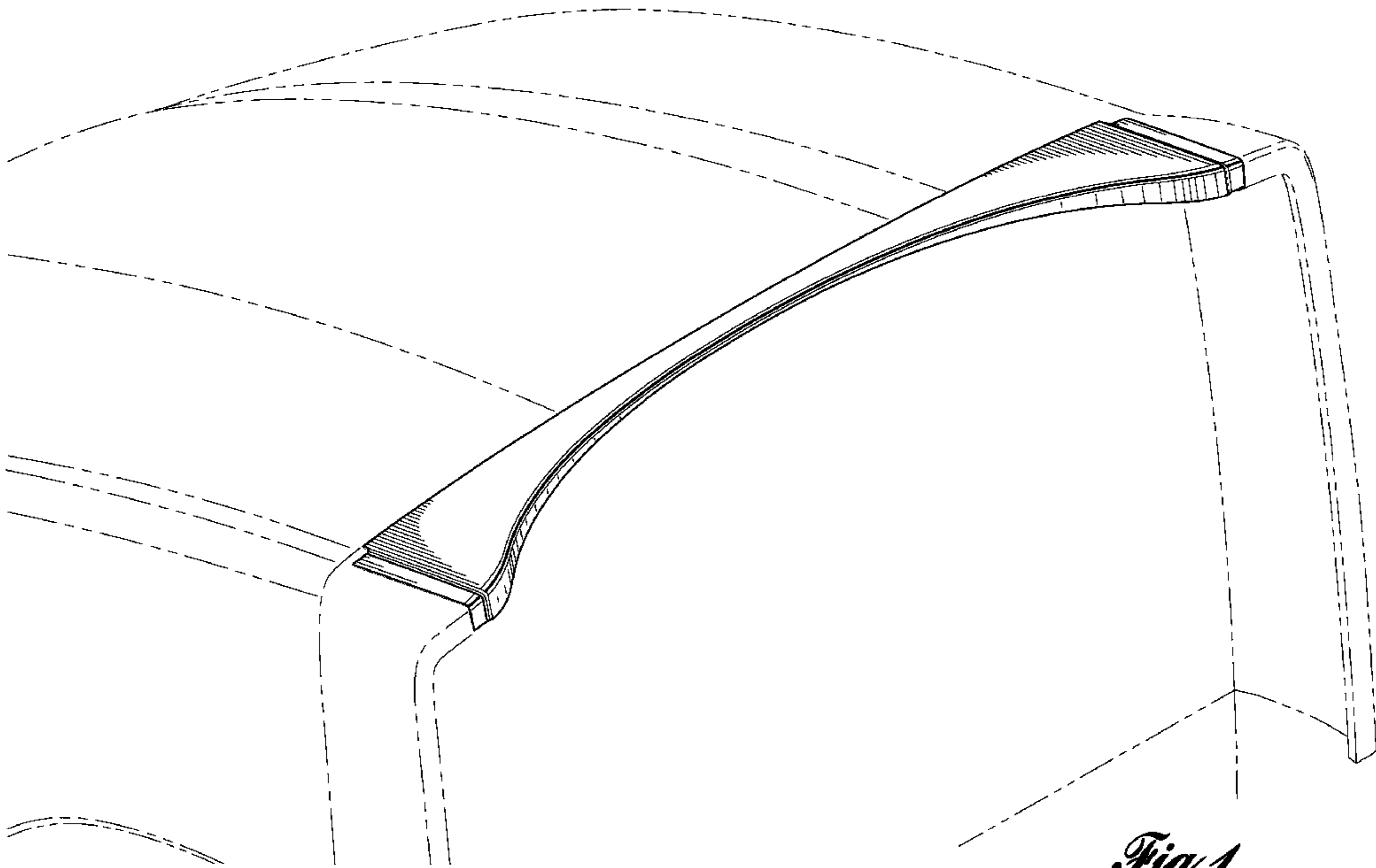

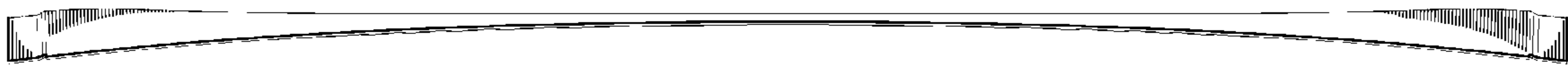

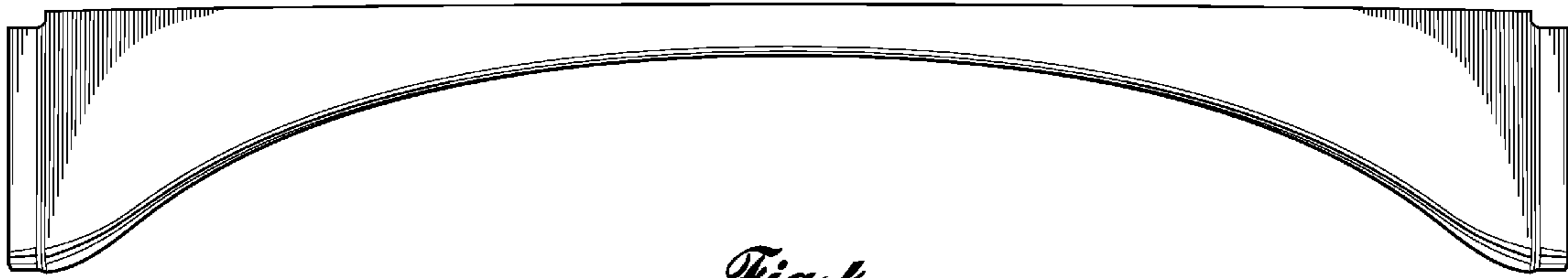

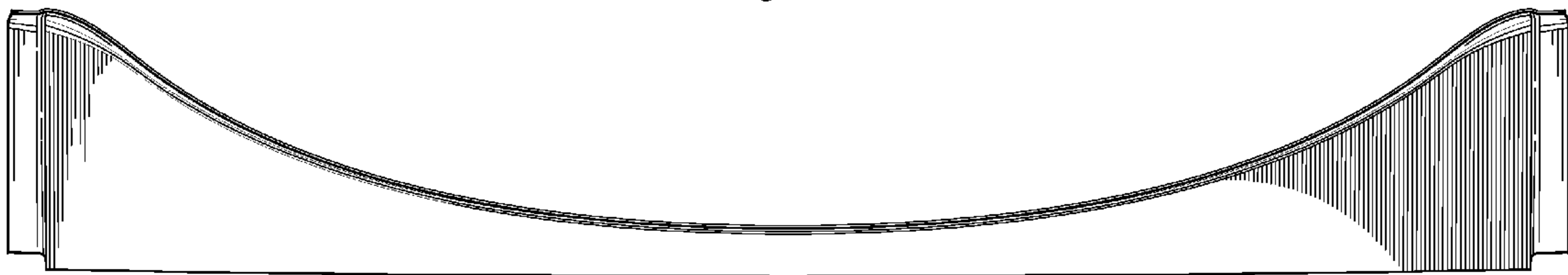
