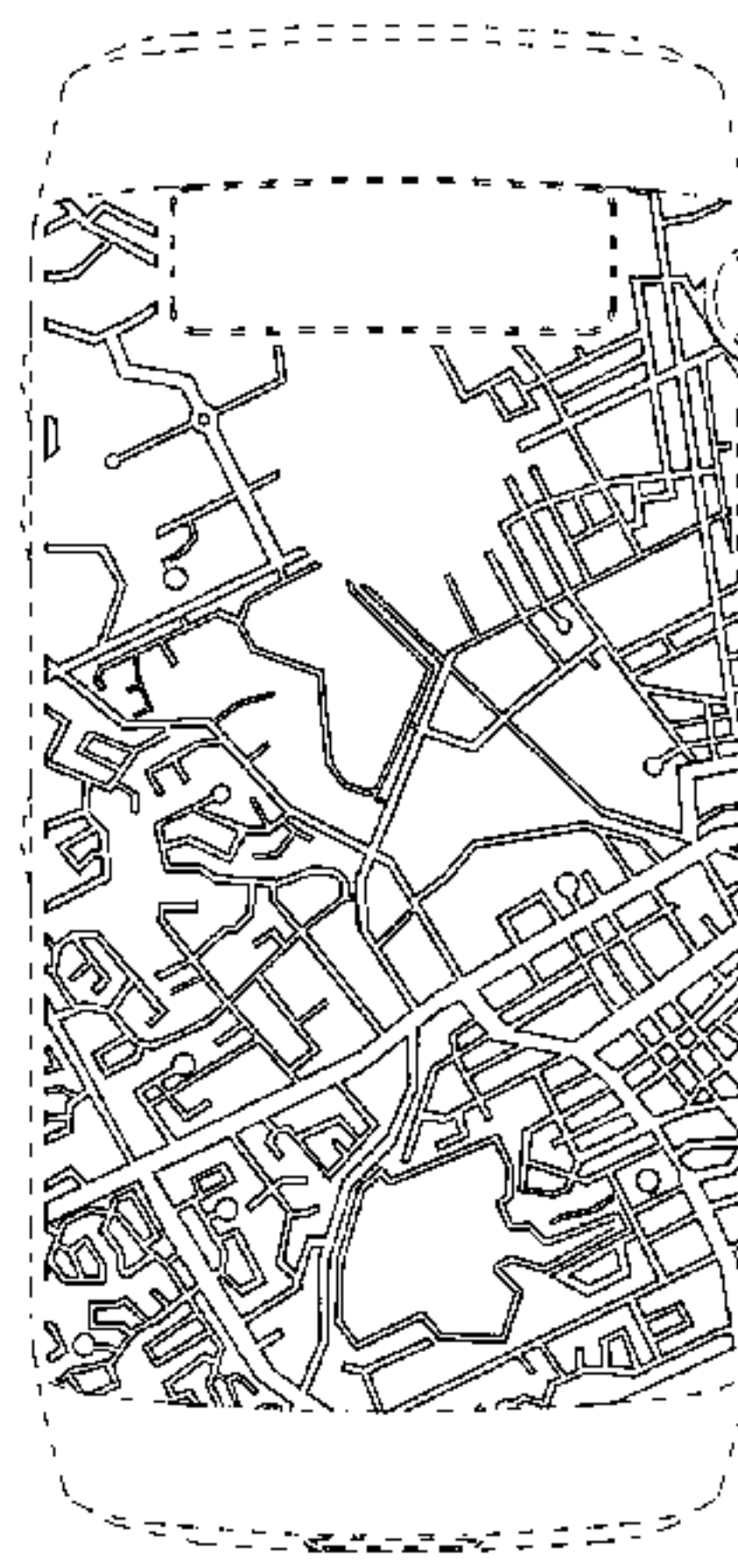
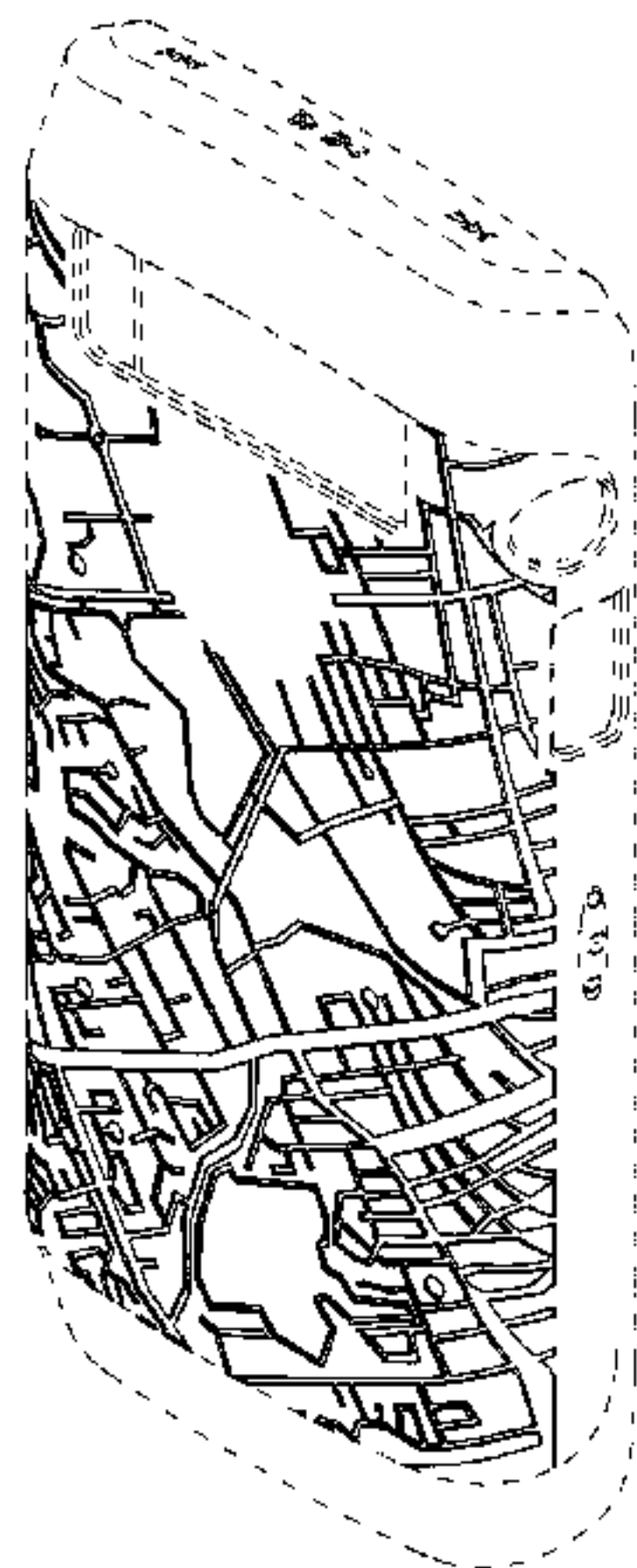
We claim the ornamental design for a handheld electronic device skin, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a handheld electronic device skin;  
FIG. 2 is a back perspective view of the handheld electronic device skin;  
FIG. 3 is a back elevational view thereof;  
FIG. 4 is a right elevational view thereof; and,  
FIG. 5 is a left elevational view thereof.

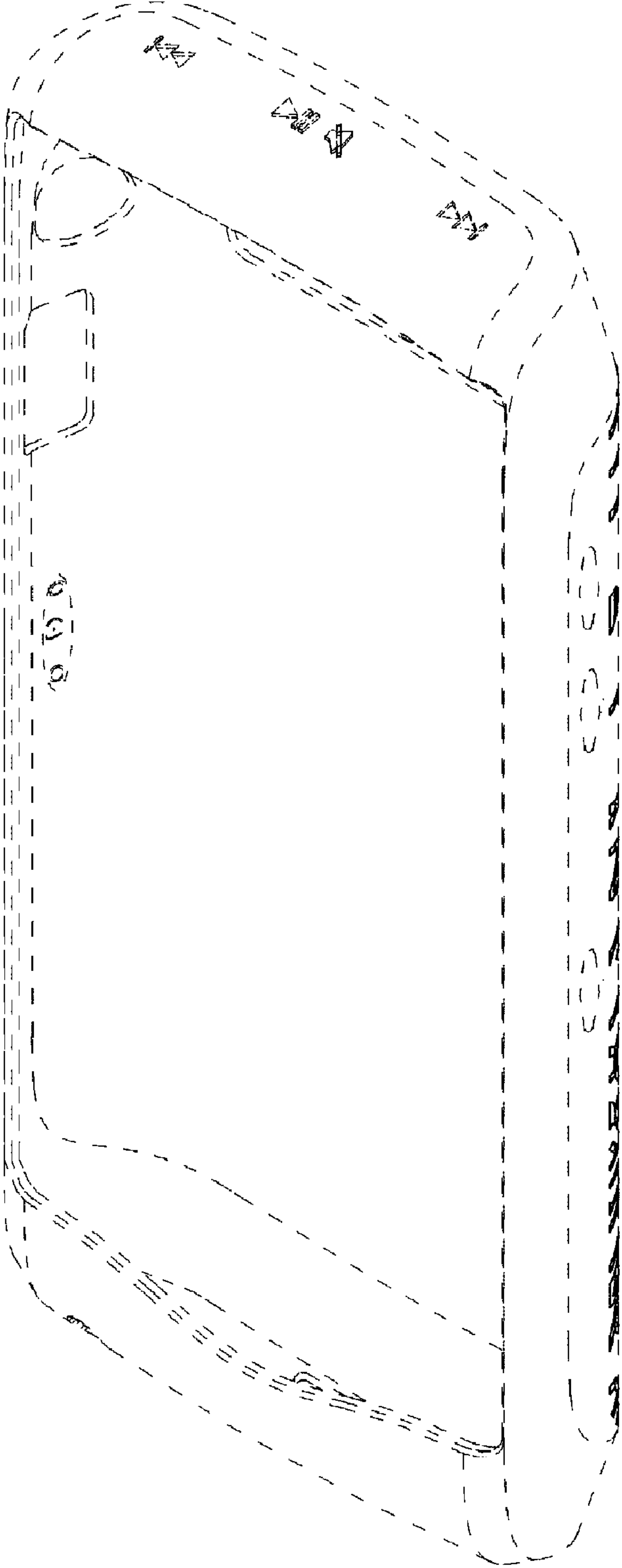

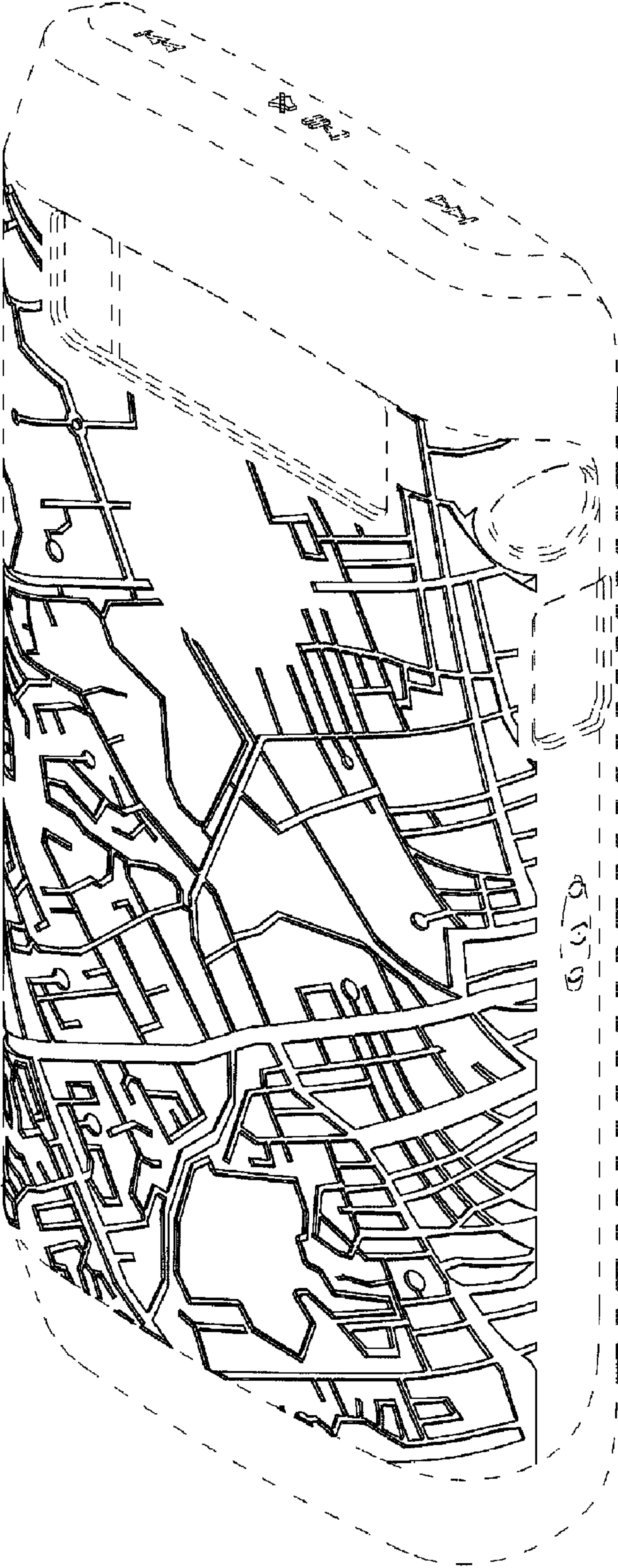

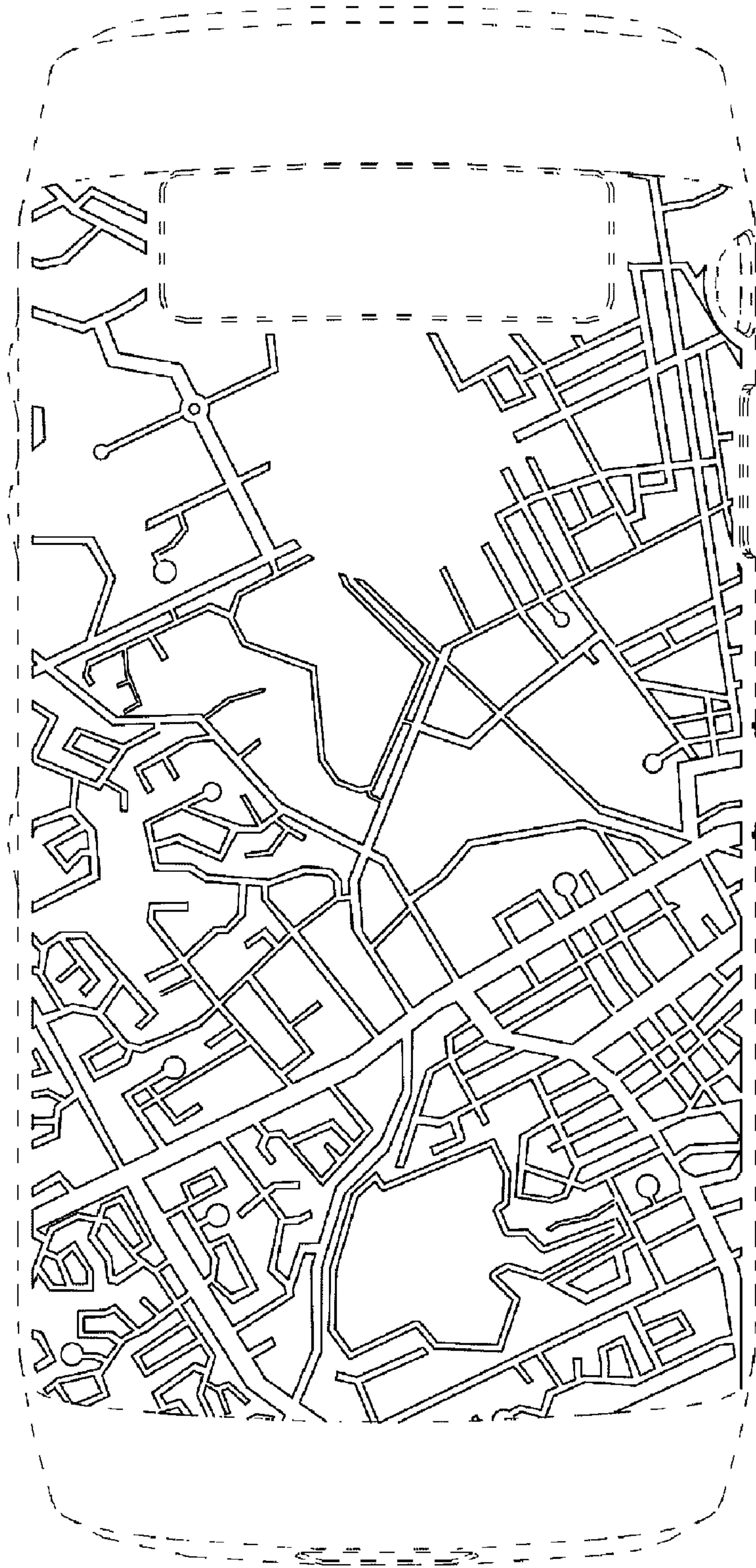

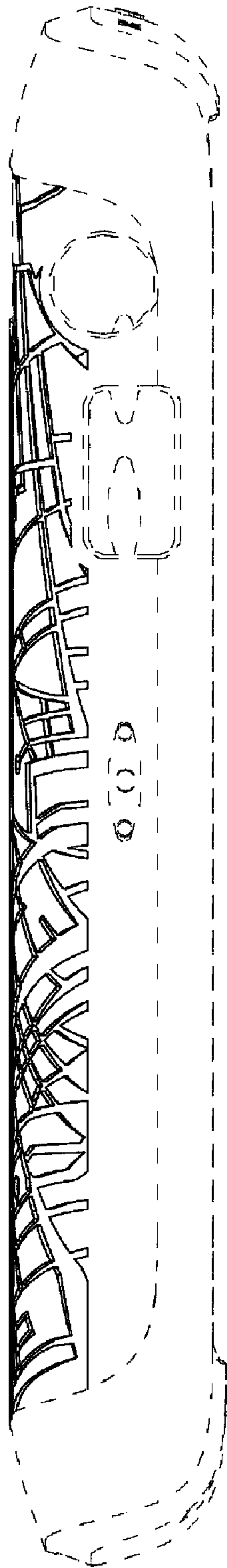

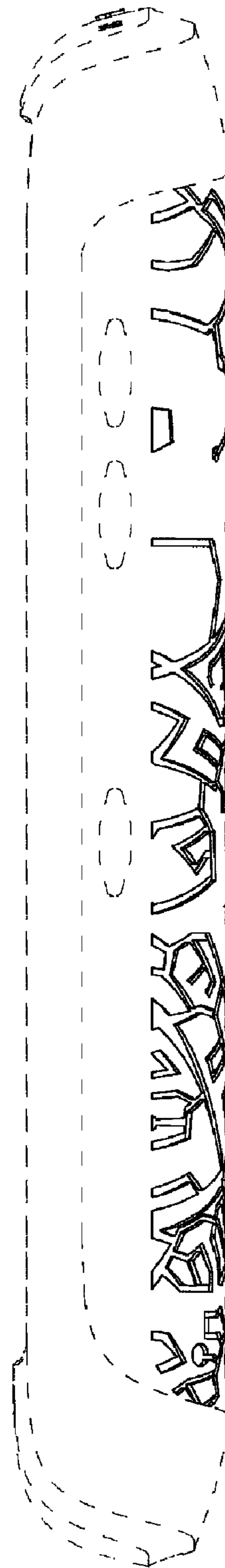
