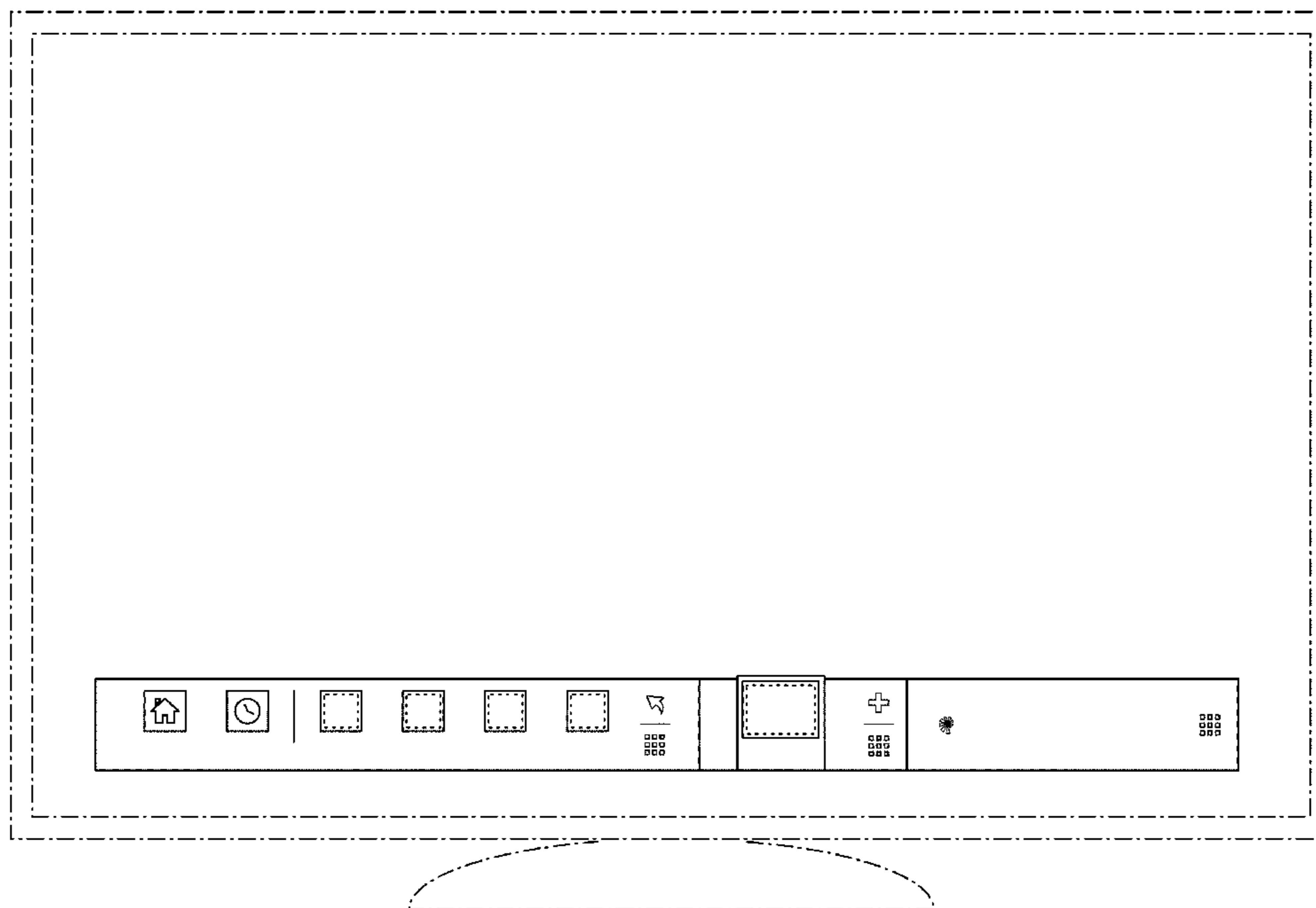
The ornamental design for a display screen with user interface, as shown and described.

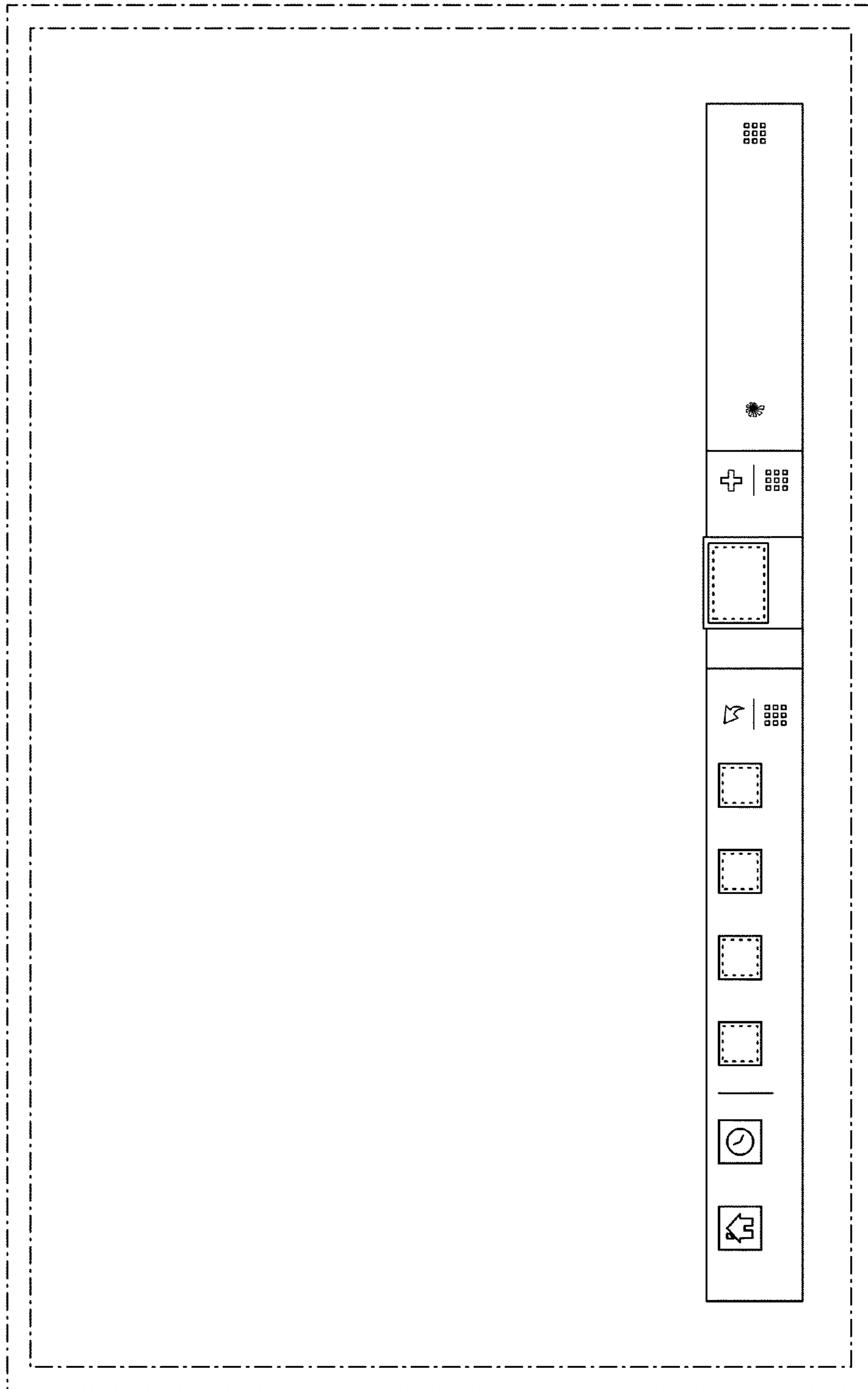
**DESCRIPTION**
