The ornamental design for an icon for a display screen, as shown and described.

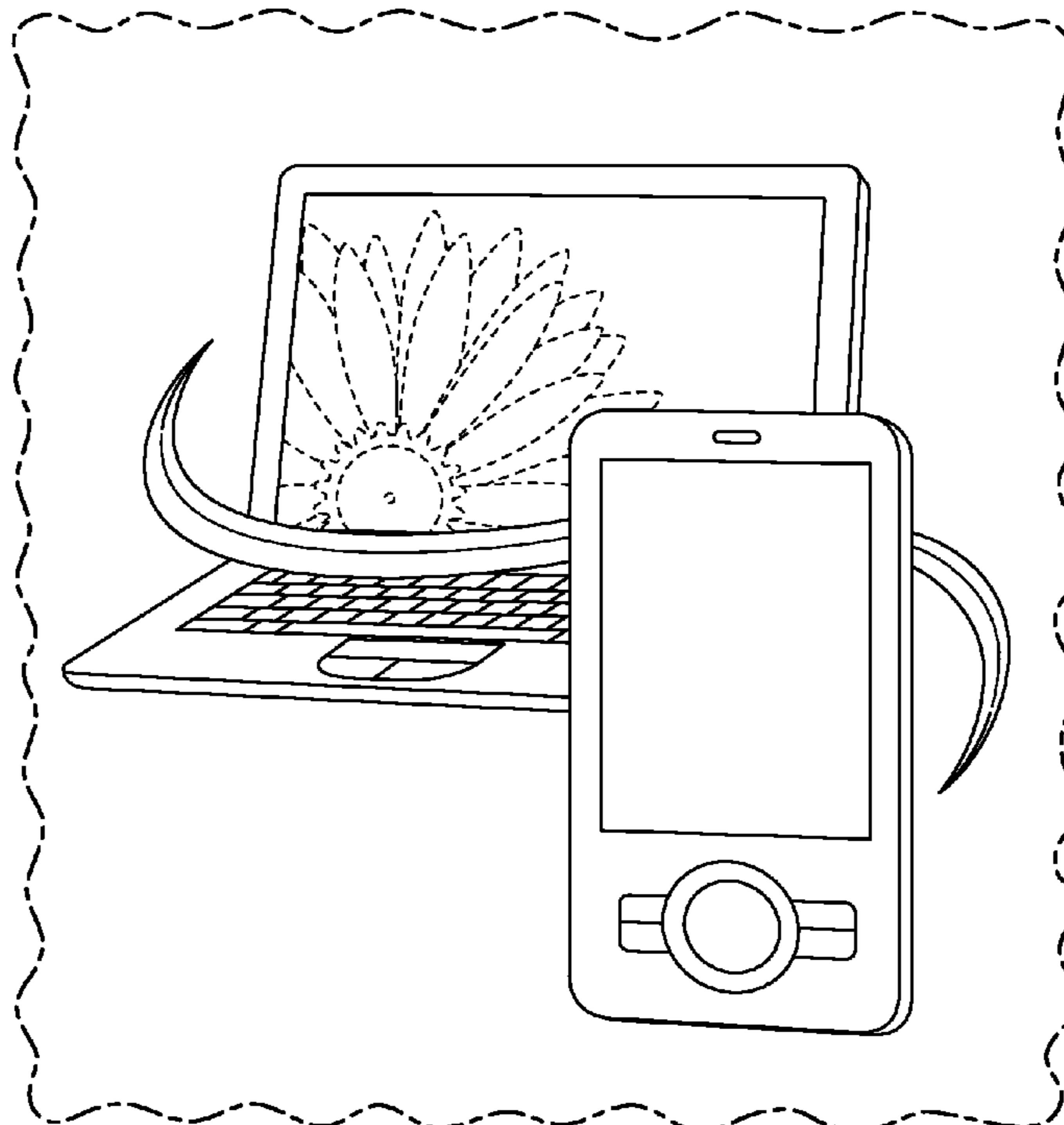
**DESCRIPTION**

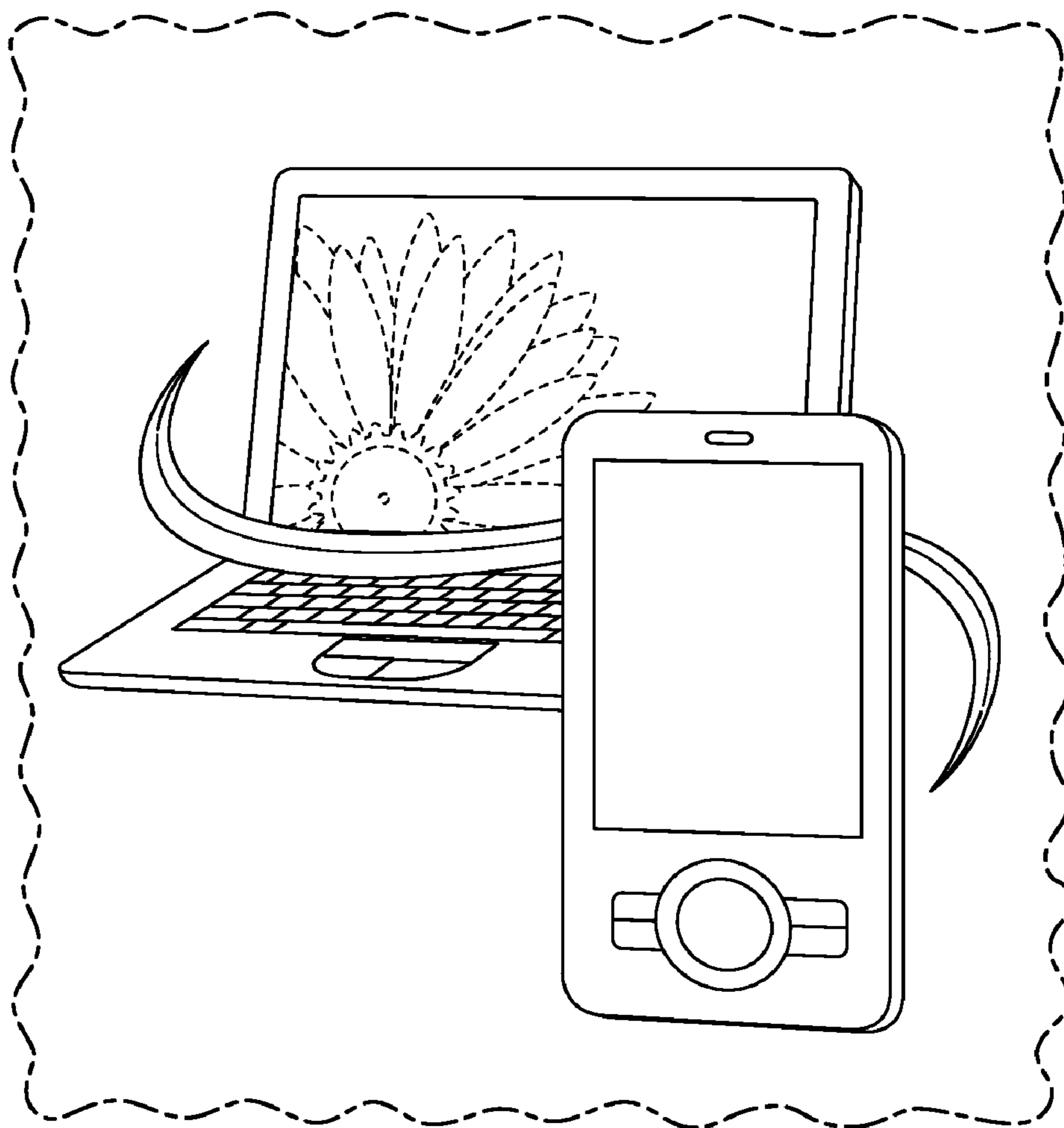
The FIGURE is a front view of an icon for a display screen showing the new design.
