(57) **CLAIM**

The ornamental design for a doll with pacifier, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a doll with pacifier, showing our new design therefor;

FIG. 2 is front perspective view of the doll with pacifier in FIG. 1;

FIG. 3 is front perspective view of an alternate embodiment of the doll with pacifier in FIG. 1;

FIG. 4 is a side view of the doll with pacifier in FIG. 1; showing the left side, the right side being a mirror image thereof;

FIG. 5 is a front view of the doll with pacifier in FIG. 1;

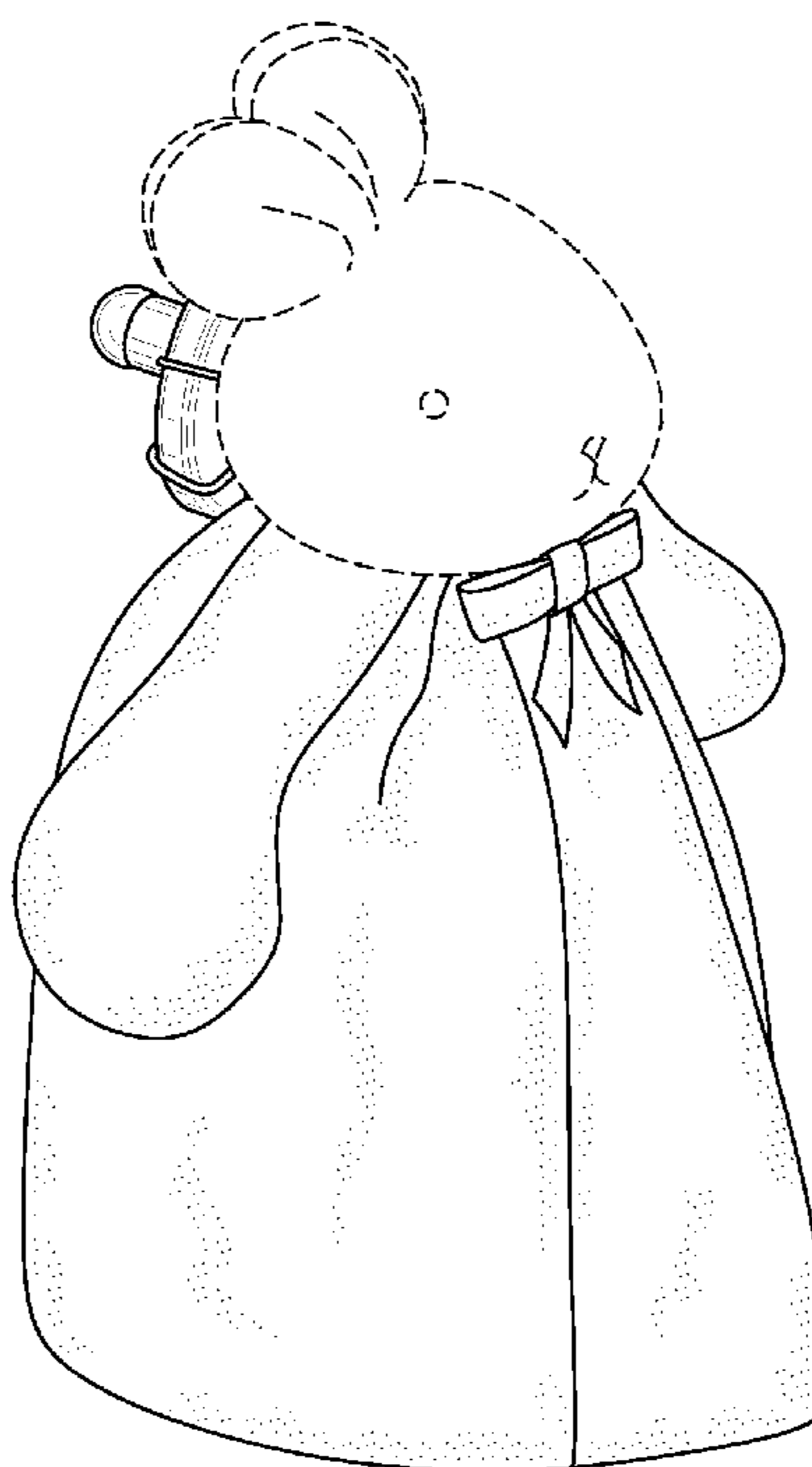
FIG. 6 is a rear view of the doll with pacifier in FIG. 1;

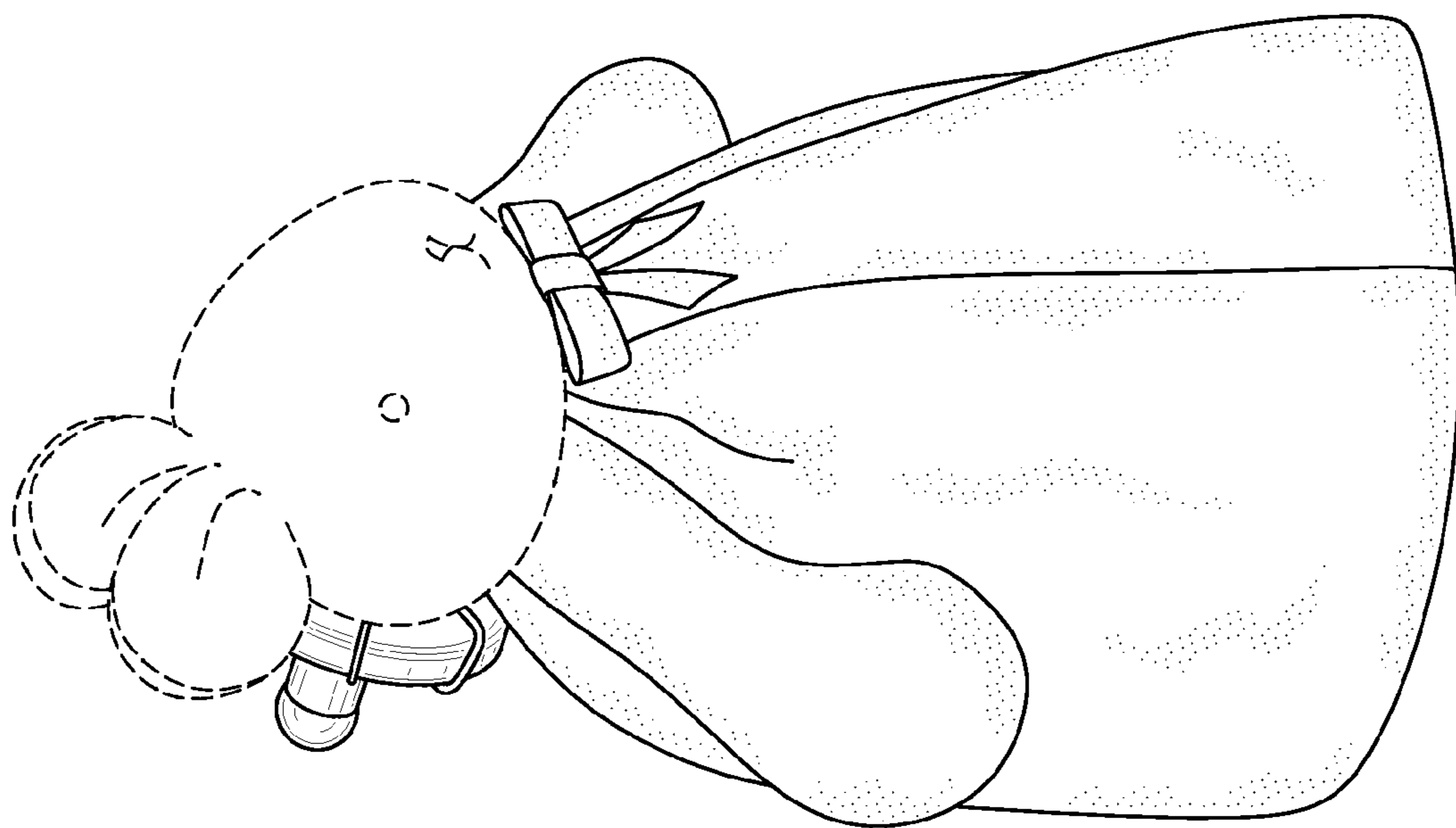

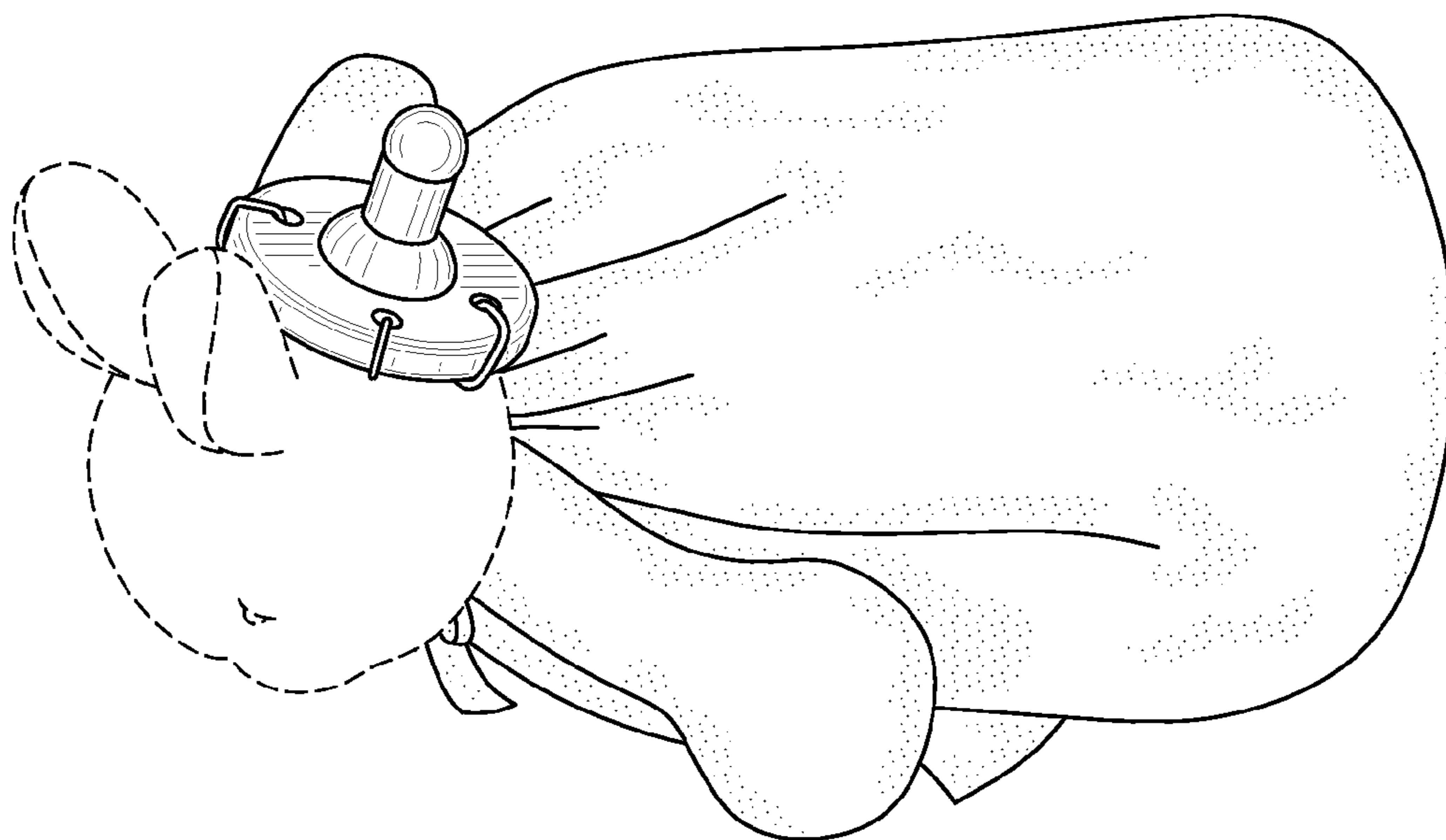

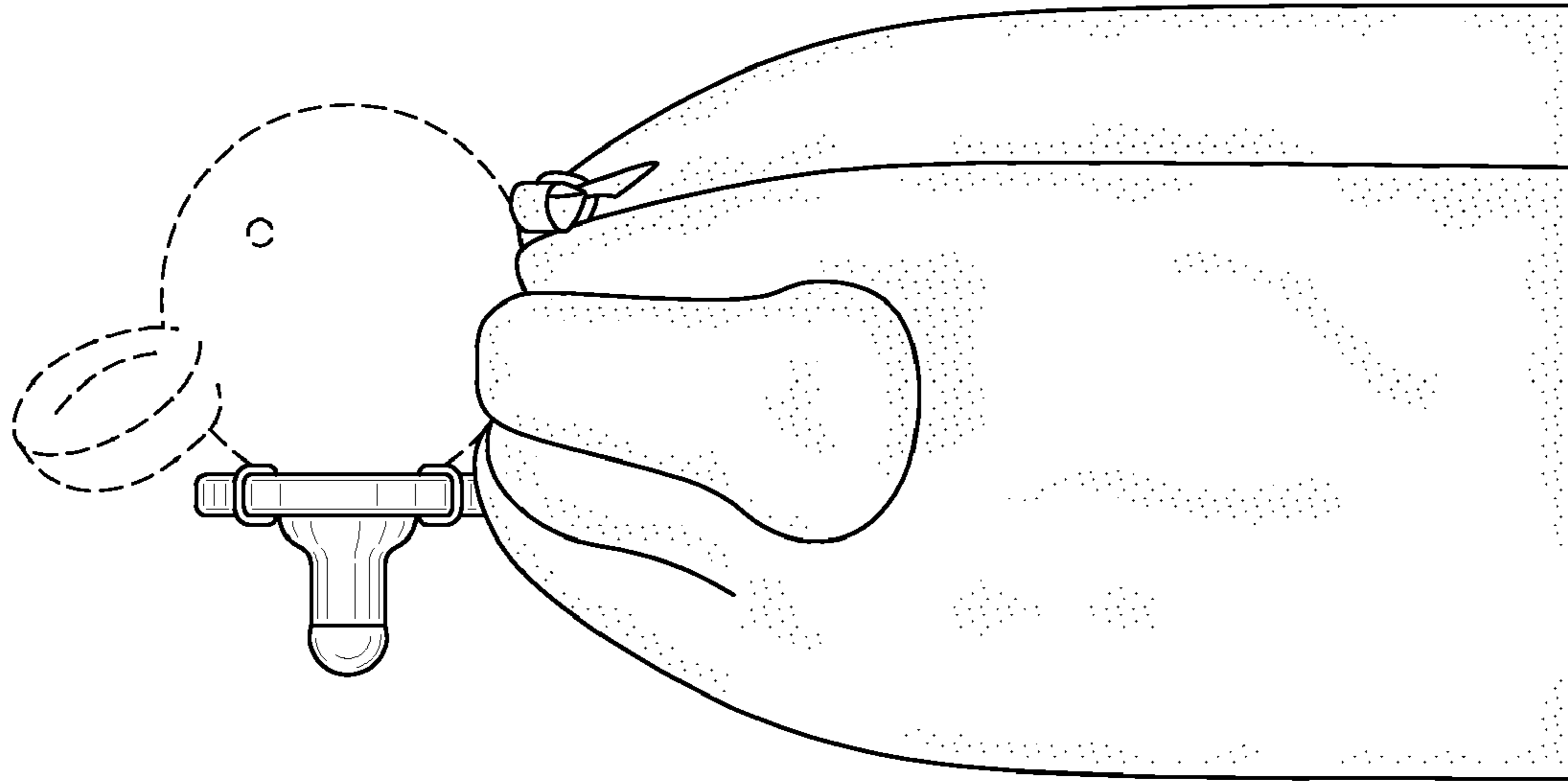

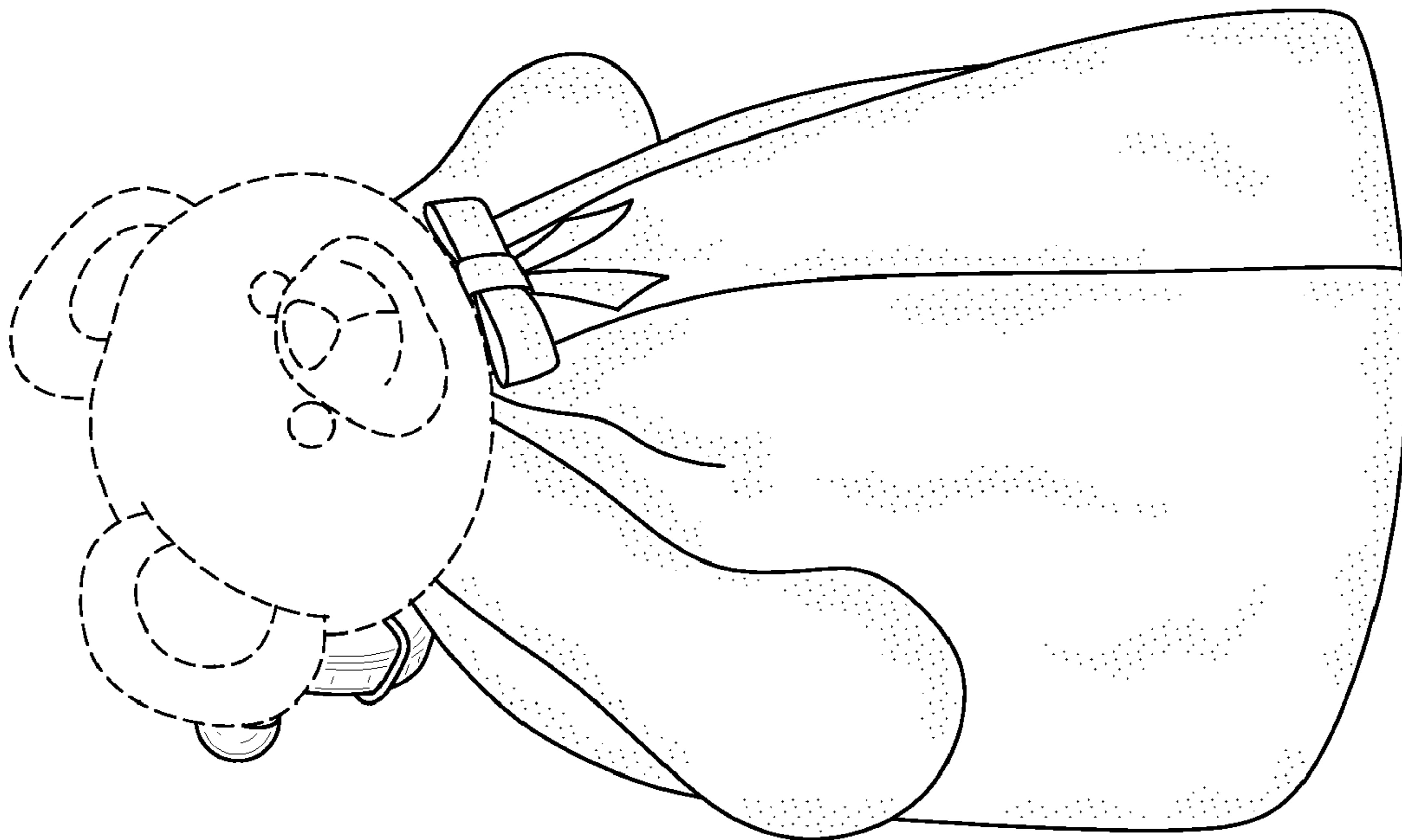

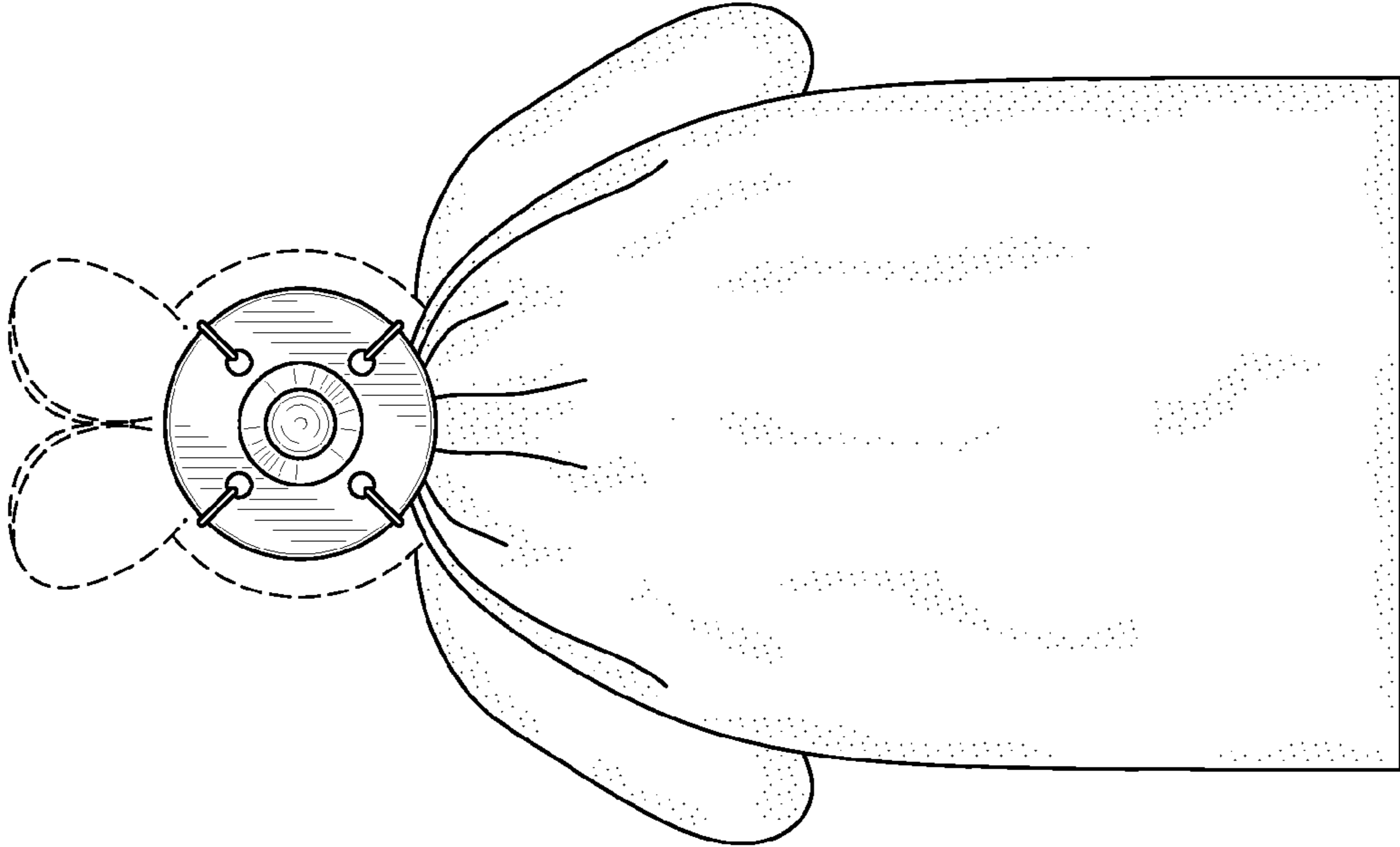

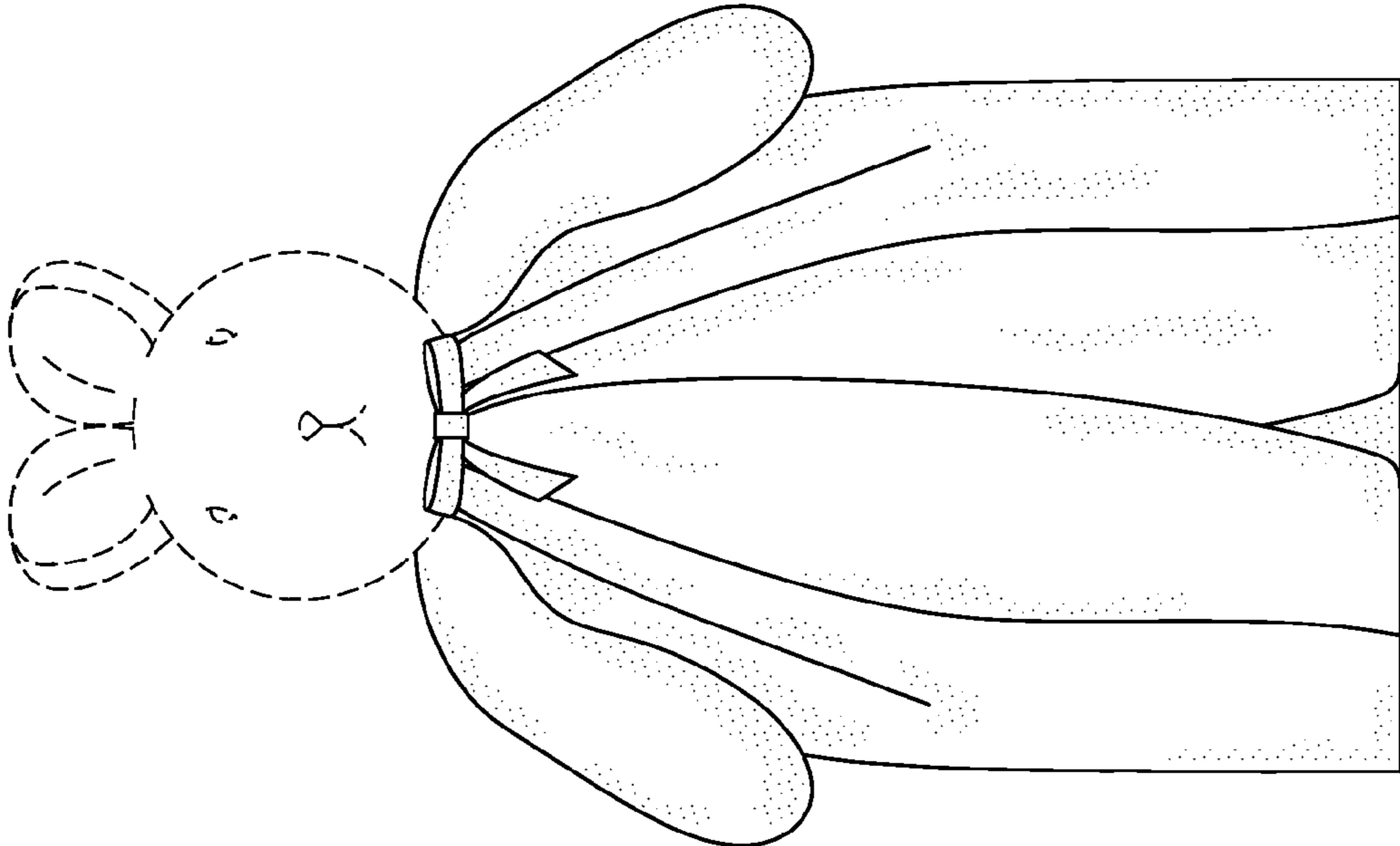

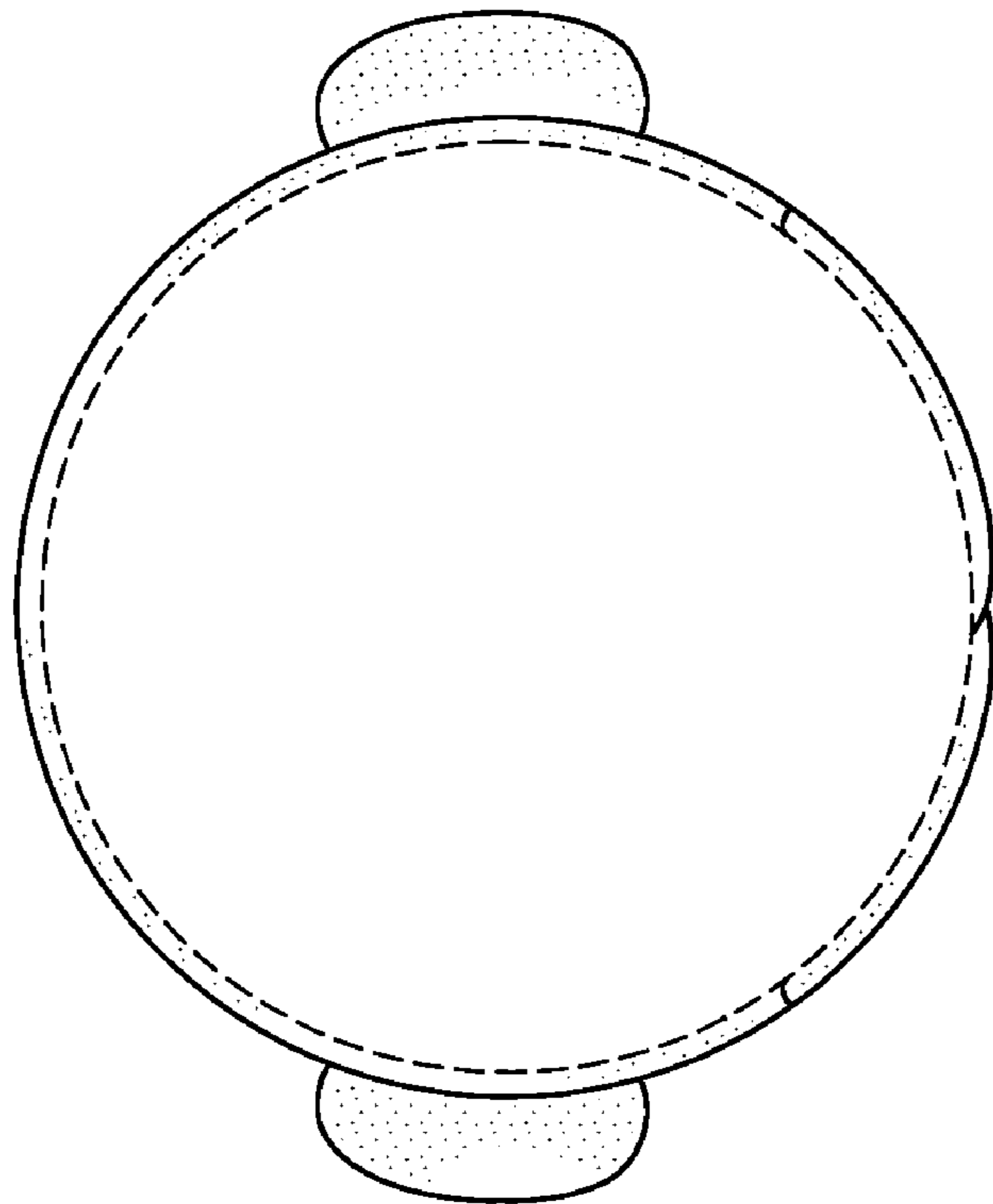

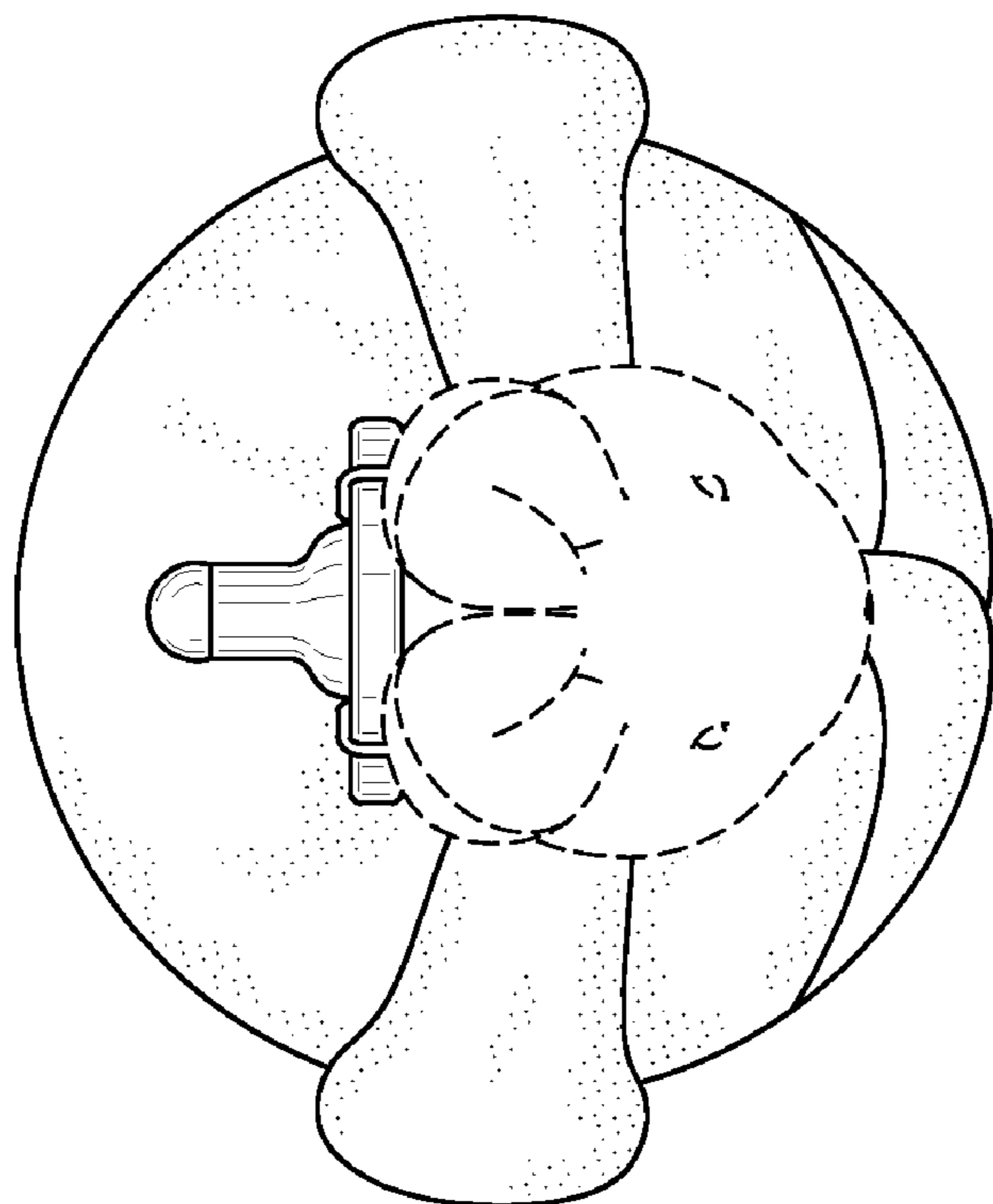
